Mr. Cobb stated that all four sales would start tomorrow morning promptly at 9 o'clock.

Mr. Cobb said that judging from the way tobacco was coming in today sales tomorrow would be in the neighborhood of a million to a million and a quarter pounds.

Tobaccoists of Greenville continue to be proud of the record which they established last season when they sold sixty million pounds of bright leaf in a period of sixty days.

While the movement of tobacco was slow yesterday and last night, it is expected to pick up today, and tonight will see hundreds of farmers place their offerings on the various floors in readiness for the voice of the auctioneers tomorrow morning.

All business and civic organizations of the city have combined to extend a cordial welcome to the myriad visitors to pay their annual visit to this market.

The police traffic department has completed plans for handling the enormous amount of traffic during the day, and as in recent years, the hundreds of vehicles are expected to come and go without the slightest kind of hitch.

Stress has also been placed on the fact that the grower may haul his tobacco as far as he wants to owing to the fact that the law regarding the 51 mile limit was declared unconstitutional by a judge sitting in one of the higher courts several days ago.

Chief of the celebrations was one at the beach under the auspices of the local American Federation of Labor officials and the sailing of the second annual joint outboard power boat Regatta between the Carolina Yacht club and the Flying Pan Power Boat club.

There were morning and afternoon games here between Wilmington and Fayetteville of the Eastern Carolina baseball league.

NATIONAL AIR RACES TO END DURING TODAY

Racers left Los Angeles Today in Competition for \$10,000 Stake

Cleveland, Ohio, Sept. 2.—(AP)—The National Air Races breezed to a conclusion today with the finish of the non-stop derby from Los Angeles, most spectacular of the distance flights, and a windup demonstration of flying skill by noted pilots.

With \$10,000 at stake, racers from Los Angeles today were led by Henry J. Brown, Cleveland-Navy air pilot, with a flying time of 13 hours, 15 minutes and seven seconds, according to the timing of the judges.

Brown landed yesterday afternoon better than half an hour ahead of the time established by Lee Schoenair, Los Angeles, who finished a week ago. One pilot remained in the race this morning, John P. Woods, of Wassau, Wis., stuck to his plans for the flight after Art Goebel, winner of the Doie prize race from San Francisco's Golden Gate, had withdrawn because of unsatisfactory condition of his plane.

The impromptu performance of Lieut. James A. Doolittle as the races drew to a close was hailed as one of the nerves feats of the races. Doolittle flew away from the airport to practice a routine of stunts for the crowd, stepped out of his plane when the wings came off, and landed with a parachute after diving 2,000 feet. A few minutes later he was stunting before the crowd in a new plane, without the rehearsal interrupted so graphically a few minutes before.

Eighty thousand spectators in the stands did not know that the looping pilot had forestalled what might have been one of the worst accidents of the races by his precaution, and returned to fly for them in spite of his experience. He had climbed to 4,000 feet to spiral to earth during his practice stunts.

"I put the nose of my ship down in a dive and at 2,000 feet I heard a 'pop' which sounded like the snapping of a wire," he said. "From then on I can't say exactly what happened. I had a definite recollection that the ship slowed down suddenly. When I was clear of the plane the parachute didn't open immediately. That gave me something to think about. I jerked again and it came open."

Doolittle became a member of the Naterpillar club, visitors forced to use their parachutes from a disabled plane, as a result of the accident.

Another star in the final stunts was Lieut. Alford Williams, Navy speed pilot. Williams performed the first dive of the races upside-down, straightened out 50 feet from the ground, and landed at the conclusion of a flight in which he established a new mark for distance flights on his back and executed two outside loops from that position before making the record.

Eric W. Wood, pilot of Roosevelt Field, made a new record for consecutive outside loops by turning 14 in a single flight.

Completion of the Los Angeles derby today will end the long distance races, nine of which, including the first for women, were flown.

Sinclair Assigned Special Duties at Washington Prison

Wilmington Architect to Draft Plans For \$50,000 Memorial Library Here

Leslie N. Boney, architect of Wilmington, N. C., will draft the plans for the \$50,000 Sheppard Memorial Library building to be erected in this city on the old Evans Street school site, according to announcement made by the building committee today.

The decision to employ the services of Mr. Boney was reached at a meeting of the library building committee Saturday afternoon. It was indicated at the time that the work in connection with drafting plans for the new building would begin immediately, and that the committee would in all probability be able to begin actual construction work within the next several weeks.

This week the architect, with Mrs. R. L. Carr, Mrs. J. B. Kitrell, of the library bond, and certain members of the building committee, will visit various cities of the state for the purpose of inspecting libraries and deciding upon the architectural type for the building here. It was not stated what cities would be visited, but it was understood that the tour would include the largest libraries of the state.

Giant Zepp On Her Way Back To Germany After Tour Around The World

New York, Sept. 2.—(AP)—Sailing over a smooth sea and from time to time reporting rapid progress, the Graf Zeppelin on her homeward journey to Friedrichshafen from Lakehurst, today continued to clip off the mileage towards the Azores.

Shortly after midnight the Graf, which rose from Lakehurst at 1:18 a. m., E. S. T., yesterday was more than 1,500 miles east of New York. Messages picked up in America and in Germany from the airship, as well as reports to the Associated Press from ships at sea reported the dirigible's rapid progress. The master of the steamship Portuano reported, the airship heading eastward in fine weather and apparently all well aboard.

Under present conditions the Graf should easily nose into its home hangar before Thursday morning in time to break its own round the world speed record, estimating the distance from Friedrichshafen to Friedrichshafen rather than from Lakehurst to Lakehurst.

Lakehurst, N. J., Sept. 2.—(AP)—Aided by favorable winds, the Graf Zeppelin was flying far out over the Atlantic today on her fifth crossing between the United States and Germany. She was bound for her own hangar at Friedrichshafen after touring the world.

Carrying 22 passengers, the airship was flying more speedily than on her first trans-Atlantic flight to Lakehurst less than a year ago. Radio advices indicating she was making about 80 miles an hour, virtually full speed for her five motors, strengthened the probability she would reach Germany before Thursday morning and lower her own round the world record of 21 days, 7 hours, 26 minutes.

The Graf Zeppelin's best time between Friedrichshafen and Lakehurst has been 53 hours, 24 minutes. Such a rate of speed on the present trip would have the dirigible home tomorrow afternoon and the Friedrichshafen-Friedrichshafen time would be less than the Lakehurst-Lakehurst time.

SAYS BRITAIN CAUSES STRIFE IN PALESTINE

Arab Leader Declares Policy of Making Country Home of Jew is Resented

Jerusalem, Sept. 2.—(AP)—Warning that Palestine and Arabia cannot regain peace until Great Britain abandons its policy of making Palestine a national home for Jews was given today by Amir El Hussein, Grand Mufti of Jerusalem, and president of the Moslem Supreme Council.

"This is a serious national revolution, the reverberations of which soon may be heard in every corner of Mosley Arabia," the grand mufti told C. J. Ketchum, Jerusalem correspondent of the London Express in an interview.

"We are faced at this moment with a grave national rebellion in which we have the sympathy and if need be, the support not only of Moslem Arabs of Syria, Egypt, and North Africa, but of the whole of Arabia with its sixty millions of people.

"There will be peace in the immediate future as far as we can preserve it. We will not oppose British bayonets, but what Great Britain must understand is that the grave events you have witnessed here have little really to do with the Wailing Wall.

"They go back much farther. They go back indeed, to the Balfour declaration (that which endorsed the Palestine national home idea) of 1917. You may suppress the present disorders and restore tranquility for the moment by force of British arms, but the ultimate peace of Palestine and Arabia will never be made while Great Britain continues the policy of the Balfour declaration.

"The whole of Arabia is aroused." The Grand Mufti's warning came as the British military seemed slowly but surely re-establishing peace throughout most of Palestine, where 200 have been killed and 300 seriously wounded in fighting between Moslem Arabs and Jews during the past nine days.

British military efforts were stressed along the borders of Trans-Jordan and Syria, where it was believed airplanes have kept invading Moslem detachments scattered and in such small contingents as to prevent material harm.

Sunday was quiet, but Saturday night Bedouins attacked nearly a dozen villages in northern Galilee, pillaging the houses and burning crops.

Thousand Attend Edenton Carnival

Edenton, N. C., Sept. 2.—(AP)—Perfect weather greeted homecoming relatives and friends as they poured into Edenton today for the annual Albemarle section water carnival and homecoming celebration.

Family reunions were the order of the day until 10 o'clock when there was a baseball game for the championship of Northeastern North Carolina. This was to be followed in the afternoon with speedboat racing and swimming and diving events.

Other highlights of the program were a twilight picnic and speaking for which hundreds of chickens and thousands of fish had been fried. A street dance and festival tonight closed the celebration.

Labor Day Quiet At Greensboro

Greensboro, N. C., Sept. 2.—(AP)—Labor Day was quiet here. Most workers went about their labors as usual. Banks and federal offices were closed or observed special hours. Many flags were displayed. There were no special exercises. A caravan of automobiles manned by members of various grades unions left the city early today carrying food supplies to the cotton mill strikers at Marion. A huge truck was requisitioned to carry food stuffs assembled at Labor Temple.

Authorities Attempt To Prevent Recurrence of Disorders By Strikers

No Organized Activity Reported among Strikers in preparation for Celebration of Labor Day; Mass Meeting Called for This Afternoon; Caravan of Automobiles Carry Food From Hickory to Strikers in Marion Zone

Marion, N. C., Sept. 2.—(AP)—Troop lines were doubled in the Clinchfield and Marion manufacturing company mills today as authorities sought to prevent any Labor Day recurrence of rioting by striking Textile Workers and strike sympathizers.

Since the guardsmen were ordered to the villages last Friday patrol duty has been divided into three shifts but today two shifts were decided upon in order to increase the number of men on active duty.

There was no organized activity among the strikers this morning. The formal celebration, a mass meeting called for this afternoon.

Alford Hoffman, southern organizer for the United Textile Workers, which called the strikes, and other union leaders, spent the morning in conference. There was no intimation from the conference room as to whether the union would attempt to hold a scheduled parade in the face of the anti-parading ordinance passed by the Marion board of aldermen. The county commissioners met this morning.

Except among the strikers there was no observance of Labor Day in Marion. The various mills and factories of the community ran as usual and tradesmen conducted their businesses.

Non striking workers at the Clinchfield mill went to work as usual.

Of the 79 persons jailed Saturday as participants in Friday's riot, only eleven remained in jail today. The others were out on bonds ranging from \$500 for Hoffman to \$50 for most of the others. All of those released waived preliminary hearing and the charges will go to the McDowell county grand jury next Monday.

Adjutant General Van B. Metts was expected here today to assume command of the troops. First of the truckloads of provisions being sent by organized labor throughout the state, arrived last night from Durham. It was brought by a labor delegation headed by W. C. Lindsey, Jr.

Hickory, N. C., Sept. 2.—(AP)—Formation of a caravan of automobiles laden with food for the Marion strikers was the outstanding event on a comparatively quiet Labor Day program here today.

The "On to Marion" motorcade, composed of more than 100 cars from Durham, Charlotte, Greensboro, Winston-Salem, Salisbury, Raleigh and other points was scheduled to leave here shortly before noon for the scene of the strike at the Clinchfield mills.

With the majority of industrial plants in this vicinity closed for the day, thousands of workers were enjoying a holiday in the country or planning to attend the celebration at Marion.

Marcus M. Sauls, secretary of the state federation of labor, was in charge of the motorcade which is carrying food to the Marion strikers.

BIG PAMLICO BEACH HOTEL BURNS DOWN

Two-story Wooden Structure Destroyed by Fire Late Sunday Afternoon

Pamlico Beach Hotel, located on the Pamlico river, about 30 miles below Washington, was completely destroyed by fire yesterday afternoon about six o'clock, according to information reaching Greenville today.

The two-story wooden structure is said to have burned to the ground within thirty minutes after it was discovered. Six guests were in the building at the time and all escaped without injury, although some of them lost their personal effects. Neither the origin of the fire nor the amount of the loss was determined.

The structure was the property of S. T. Hooker, well known Greenville property holder, and was operated by Ollie Clark.

The building contained 42 rooms and was liberally patronized by people from this and other sections of the state.

Lea Declines Post As U. S. Senator From Tennessee

Nashville, Sept. 1.—(AP)—The problem of selecting a successor to the late U. S. Senator Lawrence Tyson, of Tennessee still faces Governor Henry H. Horton today after the decision of Colonel Luke Lea, newspaper publisher not to accept the post.

While the governor has given no intimation as to whom he would name to serve until the next regular election in 1930, many political observers believe the new senator will come from East Tennessee the home of Senator Tyson.

Delegations from Chattanooga have appeared in behalf of their fellow townsmen, William E. Breck, candy manufacturer and Thomas R. Preston, president of the Hamilton National Bank of Chattanooga and former president of the American Bankers Association. The delegations have been supported by hundreds of telegrams. Brock is 58 years old and Preston, 61. Both are Democrats and Gov. Horton has announced he would appoint a member of his party to the post. Senator Tyson also was a Democrat.

The fact that Senator K. D. McKellar is from Memphis was believed to preclude selection of the new senator from West Tennessee.

Colonel Lea wrote the governor last night that "my interest and activity in public affairs have not been prompted by any desire for office," and that he believed he could be of more service to Tennessee "working in the ranks as a private citizen" than as senator.

Farmer's Wife Falls into Well and is Drowned

Gastonia, N. C., Sept. 2.—(AP)—James Kearns, wife of a farmer living near the Buster Boyd bridge, was drowned Sunday when she fell into a well head first it was learned today.

Kearns said that he missed his wife and noticed that the well rope had fallen from its pulley. Looking into the well the body was found.

Kearns said his wife was subject to dizzy spells and that this might have accounted for her having fallen into the well.

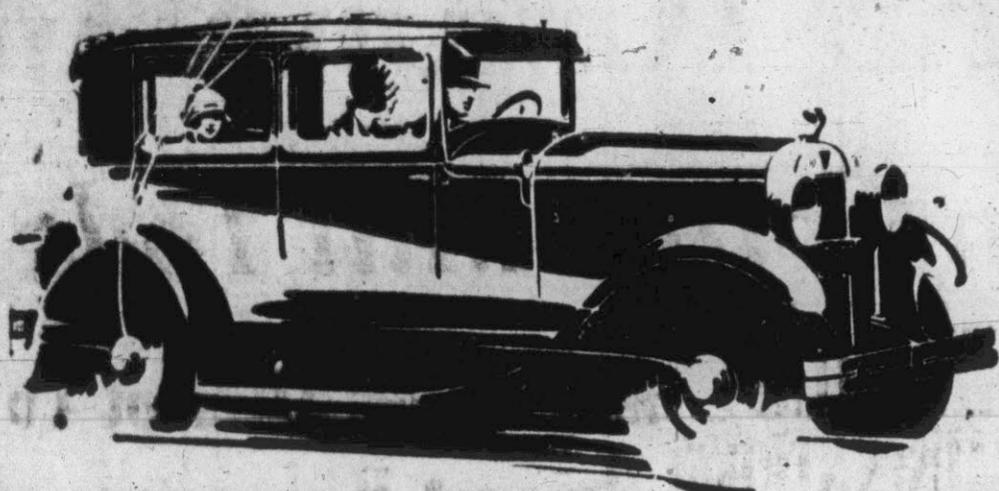

ket," declared a business man to-  
day.  
"Every firm and corporation will

Come,' and everybody will be made  
to feel perfectly at home.  
"The annual tobacco break is al-  
ways a big affair in the lives of the  
people of this section and it be-  
comes of greater significance with  
the passing of each season. Mil-  
lions of dollars have been spent in  
the development of the industry  
here, and the market unquestion-  
ably offers more conveniences than  
any other market in the country.  
"The visitors will find many  
changes this year. They are the  
same changes that have occurred

pounds. Greenville tobaccoists are

# BABE RUTH AGAIN HITS FOR CIRCUIT

With the Pirate bubble exploded. Major league teams swing into Labor Day and the stretch run with little to offer the fans except Babe Ruth's home run race against time. The Babe slammed his fortieth at Braves field yesterday as the Yankees paid a hurried visit to the rented Sabbath home of the Red Sox to win by 6 to 4. The game yesterday was Ruth's 125th, leaving him twenty-nine more in which to hit a sufficient number of circuit drives to earn an increase in his annual \$70,000 check.

The Babe's own record of sixty made two years ago is safe from any new advances at this moment, but another September such as the one he experienced in 1927 would give him about fifty-six for the season—easily enough for another handsome raid upon the Ruppert bank roll. And shrewd business man though Jacob Ruppert is in other lines, he will be pulling harder than anybody else for Ruth to hit his fifty-six and as many more as possible.

The Colonel is not altogether balm at that. With the Yankees going nowhere and the Red Sox already arrived at that destination, 23,000 Bostonese, the largest back bay crowd of season past through the gate yesterday, largely for the opportunity of seeing Mr. Ruth park one.

Billy Byrne had the honor of pitching Mr. Ruth's fortieth. Tony Lazzeri outdid the Babe with two over the fence, and these three blows made things rather easy for old Tom Zachary, who added his tenth victory of the season to a record showing no defeats.

After being cuffed about by the Athletics all season, the Senators turned yesterday to win by the generous score of 12 to 3. Sam Jones was right, and the Senators smacked everything that was served to them. Connie Mack availed himself of the opportunity to insert several of his second string for a bit of exercise.

In the west, Ken Holloway pitched the Indians to a 5 to 0 victory over the White Sox at Chicago, and Uhlie checked the Browns sufficiently for the Tigers to win by 7 to 4. The game was played at Sportsman's Park, which will be dark tonight.

Lumping home from their chastisement at Pittsburgh, the Cubs found 7,000 clamoring a welcome to them on the stands about Wrigley field. The Bruins responded by smashing Jess Haines and Carmen Hill for ten runs which defeated the Cardinals by 10 to 3. Sheriff Fred Blake officiated for Mr. McCarthy.

The Pirates treated themselves to a 9 to 7 victory over the Reds at Cincinnati in twelve innings. The game was notable, first because nobody but Red Lucas was the defeated pitcher, and secondly because Ervin Brame, the hitting pitcher reached the distant right field bleacher at Redland Field for a home run in the fifth with two on base. He had to have relief from Remy Kremer on the mound, however, and Kremer got credit for winning.

The Phillies won both games at Ebbets Field by 15 to 2 and 8 to 6. The opener was marked by the third straight victory of young Harry Smythe, recruit southpaw from Asheville, and by Chuck Klein's thirty-sixth home run. As Hack Wilson parked one at Chicago, Klein needed the blow to maintain his margin of two over the field in the National league.

Frank O'Doul gained just a shade on Babe Herman in the race for National league batting honors. The Philly outfielder got five out of nine in the two games as Herman picked up three out of seven.

Harry Benton cracked again, and the Braves defeated the Giants by 8 to 4 at the Polo grounds. Harry Seibold was the winner.

# L. C. SALTER IS SPEAKER AT SUPPER CLUB

## Marketing Specialist of Agriculture Addresses Local Farmers

L. C. Salter, senior marketing specialist of the State Department of Agriculture, was the principal speaker at the quarterly meeting of the supper club of the Pitt county Department of Agriculture Saturday night. He spoke on the marketing situation and showed the farmers a way whereby they might sell their crops to better advantage.

Aside from hearing the marketing specialists, the club also heard several interesting speeches by well known growers and business men of the county. They were J. T. Thorne, of Farmville, R. L. Little and Dr. R. L. Carr.

The Board of Agriculture voted to go on a sight-seeing trip through the Middle West sometime next year. No definite date was set for the pilgrimage to the great farm centers of the middle states, but this will be decided in plenty of time for all club members to get ready for the trip.

Mr. Salter saw the need for a mutual exchange among the farmers of this section, declaring that he thought they should derive great benefit from such an experiment. He told of the progress which farmers of other communities were making in this connection and urged the growers of this section to give the matter the serious consideration which it deserves.

Dr. Carr brought to attention of the club the importance of vocational education. He pointed out some of the benefits which had derived from the teaching of vocational education to the children in the rural communities and declared that the future of this great section demanded that some study of this kind be followed.

# Eleven Persons Burned to Death in English Town

Smethwick, Staffordshire, Eng., Sept. 2.—(AP)—Eleven persons, six of them members of one family named McDonald, lost their lives in a fire here today which originated in a confectionery shop and spread to a theatre and living apartments. Three others are in a hospital suffering from severe injuries. Several families were trapped in the burning building. Some occupants escaped by jumping from a third story window. Firemen searching the ruins found the remains of McDonald's family, father, mother and children huddled together.

Clyde Iverson, of Greenville, S. C., is in a Gastonia hospital, not expected to live as the result of a collision three miles from Gastonia. His car collided with that driven by C. J. Rouse, of Spindale. Mrs. G. W. Kirby, also of Greenville, and a passenger in Iverson's car, is in a Gastonia hospital, although her injuries are not as serious as those to Iverson, who is believed to have a fractured skull.
