## SHEARER CASE COMES BEFORE U. S. CONGRESS

### May Investigate Op- position to Plans for International Dis- armament

Washington, Sept. 10.—(AP)—The Senate naval committee today voted for an investigation of activities by American shipbuilding corporations in connection with international naval limitations conference.

The committee's decision must be approved by the Senate.

A resolution to authorize the inquiry expected to be offered by Senator Borah, Republican, Idaho, who first called upon the committee to inquire into statements by William B. Shearer, big navy advocate, that he was employed by shipbuilding corporations to represent them at the unsuccessful 1927 Geneva conference.

Another meeting of the committee was called for Thursday by which time it is expected the Senate will have authorized the inquiry.

Chairman Hale, of the committee, said he expected Shearer would be the first witness called.

Washington, Sept. 10.—(AP)—The case of William B. Shearer, who has been sternly and publicly rebuked by President Hoover for his methods of opposing international disarmament, today became the subject of formal consideration by a congressional committee.

At the instance of Senator Borah of Idaho, a staunch advocate of naval reduction, the Senate naval committee was called into session by Chairman Hale to determine whether or not it shall make an investigation of Shearer's activities. The sentiment of the committee was known to be strongly in favor of such an inquiry.

Meanwhile, President Hoover had made public a second utterance in connection with the storm aroused by the disclosures which Shearer himself revealed in firing his attack on these large shipbuilding corporations for back-pay that he claimed would be due him for acting as their agent in opposing disarmament.

This time, the chief executive, in a letter to Representative McClellin, a Democratic member of the House naval committee, denied that there had been any connection between Shearer and Rear Admiral Hilary P. Jones, now retired, who was one of the American delegates to the Geneva disarmament conference of 1927. Shearer also was in Geneva at the time of the conference and actively opposed any agreement that would place a limitation upon the American navy.

In the wake of the president's denial came denials as well from Admiral Jones and, indirectly, from Shearer. The retired admiral called at the White House for a discussion of the disarmament situation, and as he left, he told newspapermen that he spoke to Shearer "just once," during the Geneva conference. In New York, Shearer asserted that he had no dealings whatsoever with the participants in the conference.

Shearer also denied specifically that he had received confidential naval information from Rear Admiral Samuel S. Robinson, Charles C. Bennett, William V. Pratt and Henry A. Wiley.

Secretary Adams, late yesterday asserted his confidence that there had been no improper relations between Shearer and high ranking officers of the navy. He added that his department was cooperating with the department of justice in the inquiry directed by President Hoover and has extensive information regarding Shearer which it will be glad to turn over to the Senate naval committee.

Shearer is bringing to Washington with him what he says is a confidential file from the intelligence service of the navy department which was the source of information he gave to the press at Geneva. This, he asserted, was sent to him anonymously in an unstamped "official business" envelope of the navy department just before he sailed for Europe.

## Woman Dies After Being Hit by Ball

Waterloo, Ill., Sept. 10.—(AP)—A golf ball driven from the 15th tee of the Glen Flora Country club held responsible today for the death of the club champion, Mrs. Frank Watrous, 53 years old, but whose corner's office has continued the inquiry pending further investigation.

Mrs. Watrous was walking toward the 16th tee Sunday when Harry Jordan, manager of a tanning company, drove from No. 15. The ball struck Mrs. Watrous in the head and she was knocked unconscious.

The injury was not regarded at the time as serious, but she died yesterday.

Mrs. Watrous was women's champion of the Glen Flora club.

## SALES SHOW INCREASE ON LEAF MARKET

### Market Sold Over 600,000 Pounds Yes- terday; About 700, 000 Here Today

Sales on the Greenville tobacco market yesterday amounted to 699,748 pounds. It was made known today in the official report of market activities by K. W. Cobb, supervisor of sales.

The market paid out a total sum of \$125,106.73 at a general average of \$12.28 per hundred pounds. This was about a half cent higher than the average on last Friday's sales.

The report also indicated that there was about 700,000 pounds of leaf on the floors of the nine warehouses today with indications that sales would be completed about the middle of the afternoon.

It was stated that buyers representing two or three of the larger companies were buying more actively and that the competitive spirit was having a favorable effect on the price situation.

## Father and Son To Go On Trial For Murder Soon

Bishopville, S. C., Sept. 10.—(AP)—Trial of Willis J. Woodham and his son, Alva Woodham, on charges of murder yesterday was set for Thursday morning at 9:30 o'clock in the Lee county Court of General Sessions.

The two Woodhams, father and son, are charged with stabbing to death Maxcy McKenzie last March 9. The altercation is said to have been over the boundary line dividing the Woodham and McKenzie farms.

The case was called yesterday, arraignments waived and three days allowed for defense by law claimed. United States Senator Cole Blease will assist Solicitor Frank McLeod in the prosecution. Mendel L. Smith, of Camden, heads the defense counsel.

## ACCOUNT CASE BEING AIRED IN CIVIL COURT

Richmond Hardware Co., Suing N. L. Holton for Account of About \$2,000.

A one week term of Pitt county Superior court, for the trial of civil cases, opened in this city yesterday and immediately began hearing of the case of Richmond Hardware company against N. L. Holton of this city, a former salesman of the concern in this territory.

The plaintiffs contend that Mr. Holton owes them an account in the neighborhood of \$2,000 and that he failed to make settlement when they severed relations. The defendant on the other hand contends that he settled in full and considerable evidence to that effect has been brought to bear on the case.

It was indicated that the case in all probability would reach the jury sometime this afternoon.

There were about 25 cases on the calendar when court convened yesterday morning. Judge Garland Midyette, of Jackson, is presiding over the session.

## AGED CITIZEN PASSES AWAY NEAR SIMPSON

### John B. Galloway Died Early Today Following Illness of Several Months

John B. Galloway, 76 of the Simpson community, died this morning at 4:30 o'clock. He had been in declining health since the first of the year, and death was not unexpected.

Funeral services will be conducted at 3 o'clock tomorrow afternoon from his late home by Rev. J. F. Sterns, pastor of the Grimesland Methodist church, assisted by members of the Masonic order of Grimesland. Burial will follow in the old family burial ground at the Galloway homeplace.

Mr. Galloway was one of the oldest and most prominent farmers of the county, and a leading citizen of his community. He was a charter member of the Grimesland Masonic lodge and a member of the Simpson Methodist church.

He was born in the home where he died, and had spent all of his life there in the development of his extensive farm properties.

Mr. Galloway was the son of John Galloway and Sarah Chapman natives of Pittsboro, Chatham county. He was married to Miss Alice Rives, April 18, 1882. She died June 5, 1905.

He is survived by one son, J. C. Galloway, of Grimesland, and a daughter, Mrs. E. B. Thomas, of Greenville.

## Twenty Indicted In Chicago's War On Bucket Shops

Chicago, Sept. 10.—(AP)—True bills against 20 men and the forced resignation of an assistant state's attorney today marked "only the beginning" of the war against Chicago bucket shops, State's Attorney Swanson said.

Numerous raids may be expected immediately, the prosecutor said, to drive out firms which have caused an estimated loss of half a million dollars to investors in this territory.

An investigation also is under way to determine whether Arthur Carlsten, the assistant state's attorney, who resigned yesterday, conducted the inquiry into bucketeering properly. Carlsten had been in charge of the investigation.

The true bills returned yesterday followed testimony before the grand jury of 13 persons who said they had been defrauded in stock purchases recommended by the brokerage firms.

## LOCAL PASTOR GIVES UP WORK IN THIS CITY

Rev. L. R. O'Brian resigns as Pastor of Immanuel Baptist Church.

Rev. L. R. O'Brian has resigned as pastor of the Immanuel Baptist church of this city. His resignation will become effective September 30. It was stated today that a successor had not been tendered upon.

Mr. O'Brian tendered his resignation last Sunday, and the board immediately announced its acceptance.

While Mr. O'Brian has two or three pastorates in view, it was stated today that he intended doing evangelistic work for awhile before accepting any definite charge.

Mr. O'Brian has been pastor of the local church for over four years. He came here from the Mount Olive Baptist church where he served several years.

He has been actively associated with the Ministerial association during his stay here and sometime ago was elected to the presidency of the organization.

## Mill Organizer and Two Strikers Beaten During Demonstration By Mob

### Charlotte, N. C., Sept. 10.—(AP)—Exhibiting marks on their bodies as proof that they had been spirited away last night from Gastonia and beaten by the anti-communist mob, three men returned to Charlotte this morning.

The men, Ben Wells, textile mill organizer; C. M. Lell and C. D. Saylor, Gastonia strikers, said they had been taken to a lonely spot in Cabarrus county, eight miles from Concord, N. C., where they had been lashed and then left to find their way back to civilization.

They were seized, they said, by the mob which formed in Gastonia yesterday after the trial of the labor leaders and strikers, charged with the murder of Police Chief O. P. Aderholt, had been declared a mistrial after a juror became insane. Thirteen men and three women were on trial.

The mob not only made a demonstration in Gastonia but also visited Charlotte and Bessemer City, milling around outside the house of Tom P. Jimison, defense attorney in Charlotte.

According to the story told by the three men, they were carried to the lonely spot, approximately 30 miles from Charlotte, and while they were being beaten, a group of opossum hunters passed nearby, frightening the mob. The mob immediately dispersed leaving the men. Wells said he was in an unconscious condition for an hour.

The three walked to Concord where they notified police. They then caught a train for Charlotte.

Saylor said he could identify part of the mob.

## Open Hostility Exists On Manchurian Border; Heavy Fighting Occurs

Mukden, Manchuria, Sept. 10.—(AP)—An official communique of the Manchurian government tonight announced that the railway station, and the telegraph and wireless stations at Pogranichnaya, Northeastern Manchuria, had been destroyed in fighting over the weekend by Russian and Chinese troops. Forty Chinese soldiers and twenty railway employees were killed, mostly by airplane bombardment.

London, Sept. 10.—(AP)—Though there have been no formal declarations of war between Russia and China, dispatches both today indicated an apparent state of open hostility at points on the Manchurian border, northeastern Asia.

The dispatches told of serious fighting which has been in progress intermittently since Thursday of last week, assuming considerable proportions Sunday and Monday both at Manchuli and at Pogranichnaya, the western and eastern terminal of the Chinese Eastern railway.

Reports indicated a heavy loss of life and of property as result of air raids and bombings, heavy artillery fire and accompanying blazes. A Chinese report that the fighting extending along the entire Manchurian border, was taken to mean that clashes occurred between garrisons at other points along the 2,000-mile frontier.

There was a tendency in some quarters to regard the fighting as the heeded Russian offensive under General Blucher, new head of the Soviet far-eastern army. Chinese forces, Chinese dispatches indicated, opposed Russian movements vigorously, and were said to have recaptured Pogranichnaya after losing it earlier to the Soviet troops. The frontier city suffered heavily by fire and in the bombardment.

As in the past both Chinese and Russians sought to lay the blame of aggression on the other army, each describing his own actions as defensive and those of the other as offensive.

The Soviet government through the German ambassador protested both to the Nanking and Mukden governments against what were described as unwarranted attacks on Soviet territory by Chinese and Russian white guards. The Soviet note warned the Chinese that continuation of such attacks was likely to incur the gravest consequences.

The note stated that Soviet troops had been compelled to take firm retaliatory action for the protection of the Siberian frontier and its peaceful population. It was alleged that there had been 19 new attacks by Chinese and the white guards for which the Nanking and Mukden governments were fully responsible.

Tokyo, Sept. 10.—(AP)—Dispatches to Rengo, Japanese news agency from Manchuli today said heavy fighting broke out Monday afternoon near "Eighty Sixth Station." The casualties were not reported. Soviet airplanes flew over

## BRITISHER SETS NEW WORLD SPEED RECORD

Calshot, England, Sept. 10.—(AP)—Driving a blue and silver seaplane that shot through space like a comet, A. H. Orlebar, squadron leader and captain of the British Schneider Coup team, today sped over a marked course of three kilometers here to break all world's speed records. He reached a rate of 368.8 miles an hour on one run over the course and averaged 355-825 for four successive trials. It is this latter figure which constitutes the official record.

## Briand Returns To France Pleased With Outlook For United States Of Europe

Geneva, Sept. 10.—(AP)—Premier Aristide Briand of France delighted with the successful launching yesterday of his project for an European confederation or so-called "United States of Europe," departed this afternoon for Paris.

The French Premier felt that the most important part of his work at the tenth assembly of the League of Nations had been completed, but he may return to Geneva towards the end of the session, especially if the disarmament discussions appears to justify his presence.

M. Briand returned to Paris in order to have ample time for preparing the first meeting of the committee, appointed at the Brussels reparations conference to examine technical details of the Young plan and to complete important features of the work.

Geneva, Sept. 10.—(AP)—League of Nations circled speculation today on the form which Aristide Brand's "United States of Europe" would take.

Several factors in the speculation were particularly noticeable:

First, growing enthusiasm for the project, second, disinclination to foster a political union; and third, increasing belief its function should be solely economic.

It was felt generally years might be required to get the confederation into practical working order but earlier skepticism that it could ever function was disappearing rapidly.

No details of the French Premier's project have been worked out as yet but in the next week they will be given a touch of reality and when the representatives of the governments meet again in 1930 during the eleventh assembly of the League of Nations the plan should be rather far advanced.

Best opinion today was that such a confederation would begin its work by emphasizing the necessity of frequent meetings of the European states to tackle and solve past economic problems caused by division of the continent into 30 customs tariff frontiers.

## S. C. EDITOR TESTIFIES IN LAVARRE CASE

### Liabilities of the Spar- tanburg Herald and Journal Aired at Macon Georgia

Macon, Ga., Sept. 10.—(AP)—G. O. Heaton, editor of the Spartanburg (S. C.) Herald and the Journal, under cross examination in the Haall-Lavarre newspaper suit, was questioned insistently today as to the liabilities of the papers when they were purchased recently with money furnished by the International Paper company.

After a series of questions involving various items, Scott Russess, attorney for Harold Hall, asked: "Didn't \$47,500 in bonds and a \$68,000 item constitute a first mortgage against this property?"

"That is my understanding," Heaton replied.

A telegram from William LaVarre in April on the day the defense had brought out that Hall ordered Washington dispatches "killed," was read to the witness. Addressed to Harold Hall, it said in part, "Order everything killed."

"Would you say that telegram was inconsistent with LaVarre's subsequent instructions to you to 'Run the newspaper as you saw fit'?" the witness was asked.

"Yes," Heaton replied.

The witness said on re-direct examination that the \$400,000 received for the Spartanburg newspapers was "except for liabilities assumed by LaVarre, on a fifty-fifty basis as between W. W. Holland, co-owner and himself."

He had never heard Hall referred to as a partner, Heaton said. Under cross examination Heaton had identified a Spartanburg paper in which an article referred to its sale to "Messrs. Hall and LaVarre."

Hall is suing LaVarre for equal operating control of the Spartanburg papers, the Columbia (S. C.) Record and the Augusta (Ga.) Chronicle.

Hall contended he was a partner in the enterprise, which was consummated with \$870,000 furnished by the International Paper company.

When the hearing was resumed in Federal court here yesterday, LaVarre began his defense with the charge that Hall was fighting the paper company's battle. Hall answered by demanding an accounting and division of assets.

## PROBE WRECK OF AIR LINER IN NEW MEXICO

### Aeronautic Bureau to Make Report Public as Soon as Probe is Completed

Los Angeles, Sept. 10.—(AP)—Investigators of the aeronautics bureau of the Department of Commerce today were completing an investigation into the wrecking of a Transcontinental Air Transport's passenger liner City of San Francisco on Mount Taylor, N. M., with loss of eight lives.

Major Clarence Young, announced he will hold no hearings on the disaster in this city, but said he planned to make an exhaustive study of weather and flying conditions at all seasons of the year over the western flying routes, his findings in this regard, together with observations he made at the scene of the wreck, will be made public in Washington after the department has assembled all of its reports.

Major Young came here by plane from Albuquerque, N. M., Sunday.

Walter Parkin, head of the Los Angeles office of the department's aeronautics bureau, as soon as the big transport was reported missing, is conducting an intensive investigation of the wreck from Albuquerque and Gallup. Hazen also will report his findings to Washington.

Major Young explained that the principal purpose of the Department of Commerce investigation was to "find the cause and seek to eliminate it in future flying."

Gallup, N. M., Sept. 10.—(AP)—The placid quietness of the southwest, today reappeared in this little town after five feverish days, the result of an airplane crash in which eight lives were lost.

Identification was completed tonight of the seven men and a woman who were plunged to death in the City of San Francisco, Transcontinental Air Transport, Inc., plane, that crashed and burned on the precipitous sides of Mt. Taylor, 20 miles from here, in a storm last Tuesday. Seven of the bodies were identified by dental work, melted metal of jewelry, or general physical identification. The body of the eighth bore no tell tale marks, no metal, and it was agreed it must have been that of William H. Beers, of New York City.

The body of Harris Livermore was sent to Boston, C. E. Canfield's was sent to New York City, and Pilot J. B. Stowe's remains were on their way to San Diego. Others were being held pending word from relatives.

## Report Escape of Five Prisoners

Raleigh, Sept. 10.—(AP)—Five state's prisoners were reported as escaped by state's prison officials here.

George Harris, Mecklenburg county man, sent to prison in May, 1927, to serve 15 to 25 years for straggling and Alfonso Evans, Currierland county man, sent up in December, 1922, to serve five to ten years for assault and robbery, escaped early this morning from the Beleville camp in Wake county.

Robert Garrett, Buncombe county man sent up to serve nine to ten years in January, 1928, for larceny; Robert Rogers, Graham county, sent up in March, 1923, to serve four to eight years for manslaughter; and Luther Kirby, Buncombe, sent up in June, 1924, to serve seven to 31 years for larceny all escaped from a prison camp in Yancey county Monday afternoon.

Marsden Coleman, New Hanover convict, who escaped from the Yancey camp Sunday, has been recaptured.

## Negro Shot In Dispute Over Seat in Train

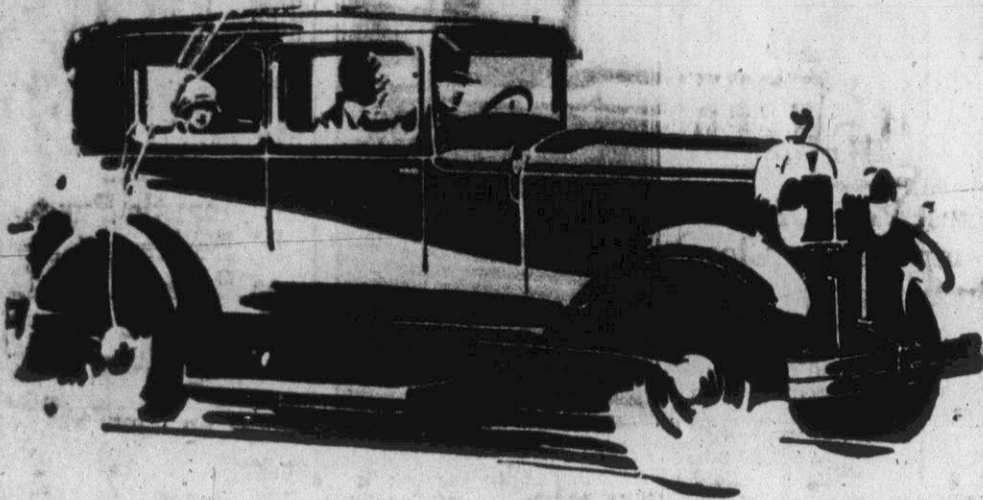
New York, Sept. 10.—(AP)—A dispute between a policeman and two negro college students over a seat in an elevated train resulted last night in one of the students being shot and seriously wounded.

The patrolman, Walter Lowe, who was off duty and in civilian clothes, said Ralph Baker, 24, and William Fontaine, 25, both of Moultrie, N. J., and students at Lincoln University, Chester county, Pa., crowded a seat in which he and a young woman were sitting.

An argument followed and when the students left the train at their station the patrolman followed to place them under arrest. He said as he started to the street with his prisoners Baker struck him in the face and both men ran. He fired four shots, wounding Baker in the back and then captured Fontaine. Baker was charged at St. John's hospital with felonious assault and Fontaine was held on a charge of acting in concert.

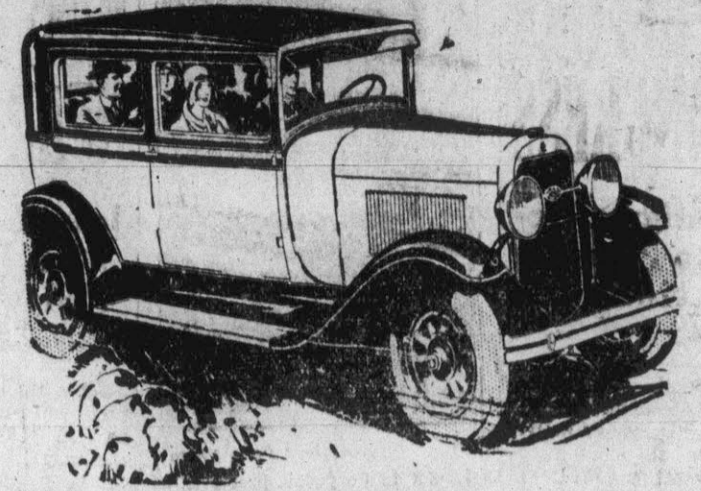

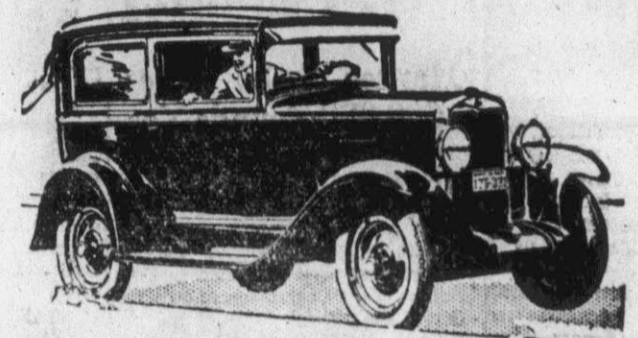

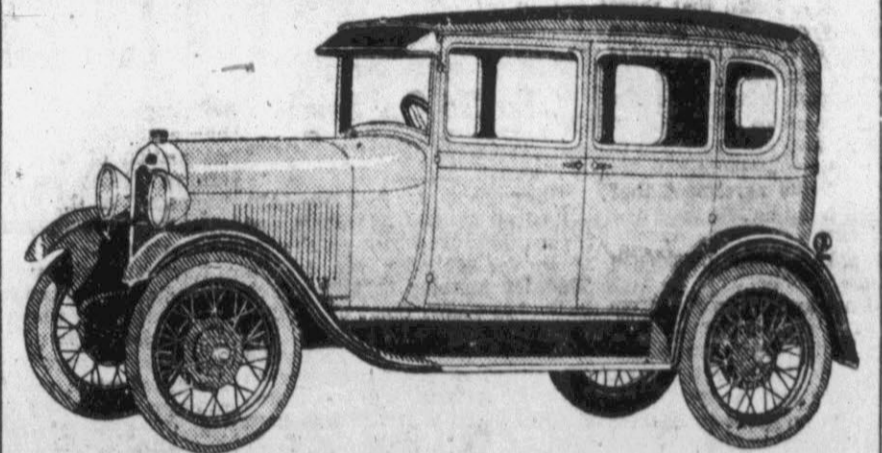

Give Headcoach Chuck Collins a center and an end and he will be all set to provide plenty of warm and unpleasant afternoons for any football team desiring same. Collins is feeling chipper about his outlook for the first time since he came to Chapel Hill three years ago. So is everyone else who has been watching more than sixty candidates go through two daily practice sessions on Emerson Field here.

Fifteen letter men were in the five teams which ran signals today. Nine of the monogram wearers were back.

The eight conference teams who play the Tar Heels can expect to see some of the dizziest air maneuvers they have looked at since the war. Every back in the Carolina menagerie is an expert passer. Two or three can fling them with either hand.

Backfield prospects are dazzling, but there are plenty of grief in the line. A coach can't lose two men like Harry Schwarz, Carolina's brilliant center, and Odell Sapp, an end, and still smile about it.

There are other line positions open, too. But Collins says he can plug these with veteran reserve material. Centre and end are his problems right now.

Libscomb, a freshman graduate, will play center. He isn't a Schwartz, but he is the best of several pivot candidates.

Fenner, a reserve, will step into Sapp's shoes. Holt, who played the other flank last year, is trying to make up his mind between football and business. ## STOCK MARKET

New York, Sept. 10.—(AP)—The stock market alternately blew hot and cold today as opposing speculative forces struggled for control of the price movement but the list generally was under pressure despite wild bullish demonstrations in a few high priced specialties. Fears of a mid-month credit pinch and a renewal of Federal Reserve pressure to force a reduction in brokers' borrowings had a chilling effect on bullish enthusiasm.

The drop of nearly 400,000 tons in the unfilled orders of the United States Steel Corporation took Wall Street by surprise, as earlier estimates indicated a drop of less than 300,000 tons, but steel common received strong support. The Ajax Rubber Company reported another large deficit in the first half of the year. The Marlin Rockwell Company, which has been mentioned in merger rumors in connection with the Timken Roller Bearing Co., started an extra dividend of 75 cents, the stock rising 4 points on the announcement.

Call money renewed unchanged at 8 per cent but advanced to 9 by early afternoon, due to heavy out-of-town withdrawals. Purchase of about \$2,500,000 in gold in London for shipment to New York was announced in London dispatches. Despite recent rumors that Federal Reserve authorities were discouraging further importations at this time, time money and bankers' acceptance rates held firm. Heavy federal income tax payments, due on the 15th, are likely to cause a temporary credit strain.

Some wide advances took place in a few issues which have what Wall Street now characterizes as "a scarcity value." J. L. Case ran up 25 points to 44. American Machine & Foundry ran up 18 1-2 to 238 and American Type Foundries 12 to 180, all new high records. Atlas Powder advanced 5 points to a new peak at 139 7-8 but DuPont broke nine points. Republic Steel which is expected to show improved earnings through its new welding process, was up more than 6 points to a new peak at 134 1-4.

Radio returned to the speculative spotlight with an early gain of 4 points. Standard Brands, Packard (old stock), and Joss-Menville, which led yesterday's late rally, all sold off sharply. General Electric dropped 9 1-4 points. Air Reduction
