CONTINUES AT
THE CAPITAL

Fourth Week of Battle Gets Under Full Swing at Washington Today

Washington, Sept. 30. — (AP) — With its first major controversy on the verge of a decision, the Senate today entered the fourth week of its tariff debate.

The issue, whether the President's power to raise or lower tariff rates upon recommendation of the Tariff Commission shall be continued or withdrawn, probably will reach a vote tomorrow or Wednesday.

On the one side, in favor of continuance, are the President and the Republican regulars of the Senate. On the other, are most of the Democrats and Republican Independents.

Leaders of both sides, after a week-end of vigorous efforts to bolster the voting strength of their respective positions, professed confidence in the outcome. They conceded, however, that a single vote might decide the issue.

The opinion was expressed in both camps that withdrawal of the flexible tariff power from the President would be generally regarded as a blow both to Mr. Hoover, in view of his declaration favoring the principle, and to the pending bill itself, since continuance of that principle enters so profoundly into its entire structure.

Evidence of a closer knitting of Democratic and Republican independent opposition to the flexible provisions was given today in the text of the reply issued by Democratic members of the finance committee to President Hoover's argument in favor of the policy they embody, which was established several years ago in the Fordney-McCumber act.

Attacking the principle as "tyranny," the statement indicated acceptance of a proposal by Senator Norris, Republican Independent of Nebraska, as an amendment to one sponsored by Senator Simmons of North Carolina, ranking Democrat of the finance committee.

The Simmons amendment would change the bill to provide that the President, upon receipt of a recommendation from the Tariff Commission should merely transmit it to Congress, restoring to the legislative branch exclusive power to make the alterations proposed. Under the Norris amendment, designed to prevent frequent reopening of the troublesome tariff question, Congress would be restricted in consideration of such recommendations to the rate or rates concerned.

The Simmons proposal is designed as a substitute for the amendment sponsored by Chairman Smoot of the finance committee, which would change the language of the flexible provisions of the House bill so as to continue with slight changes the policy as set forth in the existing law.

Visit to Washington of Mrs. Gann During McDonald's Visit Leading Topic

Washington, Sept. 30. — (AP) — The rights of precedence for his sister and official hostess, Mrs. Dollie Curtis Gann at the state dinner to be held at the White House in honor of Prime Minister Ramsay MacDonald.

Secretary Stimson in announcing this today said the vice-president had graciously waived his sister's precedence in favor of Lady Isabella Howard, the wife of the British ambassador, who will be the ranking British lady at the dinner.

Simultaneously Stimson disclosed that Prime Minister MacDonald had asked his daughter Isobel, who is accompanying him on the trip to visit President Hoover, not be regarded officials at ceremonial functions held while he is in the United States.

Stimson said he assumed that the arrangement, which he described as not permanent, would place Mrs. Gann in the next position to Lady Isabella.

Murder Charge Dropped
Against Nine Members
Of Union; 7 Face Trial

Charlotte, Sept. 30. — (AP) — Murder charges against three women and six men accused of having caused the death of O. P. Aders, chief of police of Gastonia, in a shooting growing out of the Lora cotton mill strike, were nolle prossed today. Seven other men will be tried on second degree murder charges, Solicitor John G. Carpenter announced.

Announcing the nolle prossing of the murder charges against nine of the defendants, the solicitor said that Fred Erwin Beal, of Lawrence, Mass., southern organizer for the National Textile Workers Union; George Carter, Mizpah, N. J., union member and tent colony guard; Clarence Miller, New York, communist party worker; Joseph Harrison, Passaic, N. J., union organizer and William McGinnis, Louis McLaughlin and K. Y. Hendricks, all union members of Gastonia, will be tried.

The charges were dropped, the solicitor announced, with the reservation that they might be renewed later if developments warrant.

The nine persons ordered freed of the murder charge are Amy Schoedter, Vera Buch and Sophie Melvin of New York; and Russell Knight, Delmar Hampton, N. F. Gibson, K. O. Byers, J. C. Huffer and Robert Allen, all Gastonia strikers.

The solicitor announced that charges of assault preferred against seven other persons not involved in the murder case also would be dropped.

Judge Barnhill then suggested that 100 veniremen be drawn since only 12 of the regular venire were present.

Defense attorneys announced they thought 100 insufficient.

The judge made the additional suggestion that since in the other trial the majority of the veniremen called who had formed an opinion

were from Charlotte, he would like to eliminate all names drawn from Charlotte township.

After the solicitor's announcement of the dropping of various charges, Judge M. V. Barnhill, presiding, ordered a special venire of 100 talesmen summoned. He then adjourned court until 9:30 o'clock tomorrow morning when the panel will be present.

The defense asked if the seven men still held for trial would be allowed bail. Judge Barnhill replied that the court could use its discretion in this matter and that he thought it best to hold them in jail as one of the seven might run away or be otherwise detained, causing a mistrial. The defense did not argue.

The judge's statement regarding bail recalled to court officials the fact that two weeks ago at Marion a case growing out of a strike there was declared a mistrial because one of the defendants broke out of jail. The man surrendered several days later.

The trial called for today is the third effort made to try murder cases growing out of the shooting of Chief Adershot when he and four other policemen went to a tent colony maintained on the outskirts of Gastonia by the National Textile Workers union and the World International Relief for Strikers from the Lora cotton mill. The police were investigating an alleged fight at the colony.

On July 26 the case against six men, thirteen men and three women, was called. The charge against the three women was reduced to second degree murder. Judge Barnhill then ordered a change of venue to Mecklenburg county.

On August 26 the case was called in Charlotte but after two weeks a juror became insane and a mistrial was ordered.

TESTIFIES AT
SENATE PROBESays He Had Nothing
to Do With the Failure
of Geneva Naval Conference

Washington, Sept. 30. — (AP) — William B. Shearer, the \$25,000 observer for American shipbuilders at the 1927 Geneva Naval Limitations conference, testified today before a senate committee that no member of the American delegation had wished to see the parley end in failure and that he did not claim he had broken up the gathering.

"Do you know of any one of our representatives who worked against arriving at any agreement?" Asked Chairman Shortridge.

"Only one," Shearer answered. "He introduced the political clause which was for another naval building holiday." He did not give this person's name.

Shearer said he himself was for the American program for parity with the British navy; that if he had not been he would have been with the British who wanted 750,000 tons of cruisers.

Agreeing with Senator Shortridge that he used his brains and ability to get out the facts, Shearer said he also used one other thing.

"That was the naval intelligence data giving the proposed plan of Great Britain and Japan; what they would attempt to do at the conference and did do," Shearer said.

"Then it isn't a fact that you sought to break up the conference?" pursued Shortridge.

"That is ridiculous to any one who read Ambassador Gibson's speech," the witness replied.

"You didn't claim you broke up the conference."

"No."

"Quite certain."

"You didn't write that."

"No. I said the conference broke up but you won't find it in front of that."

Before Shearer was called Rear Admiral Joseph M. Reeves, one of the American naval experts at the conference, denied the testimony of Drew Pearson, a newspaper correspondent in Geneva at the time of the gathering, that he had expressed the hope that the Geneva conference would fail.

The Admiral said all thinking, experienced naval men wanted naval limitation with parity for the United States with the largest navy because only by such an agreement could they have an equal chance in the event of war.

Two Men Killed
When Train Hits
Wagon in Wayne

Goldsboro, N. C. Sept. 30. — (AP) — Two men were killed instantly and another badly injured today when a wagon loaded with tobacco was struck by a Southern Railway train at Miller's crossing near here.

Lon Carraway and a young man named Ham, son of Luther Ham of near Snow Hill, died instantly. Luther Heath is in a local hospital with a fractured skull, a broken leg and a crushed arm and is not expected to live.

The three men were bringing a load of tobacco to Goldsboro. Witnesses said that a thick fog obscured the railroad track. Another truck just ahead of the one in which the men were riding crossed the track safely.

Delegation to Washington Tobacco Conference Left During the Morning

Members of a delegation representing the tobacco and business interests of Pitt county left this morning for Washington, D. C., where they will attend the conference of representatives of the Federal Farm Board, the Secretary of Agriculture, representatives of tobacco growers, the tobacco companies and the North Carolina delegation in Congress, to be held tomorrow morning at 10 o'clock.

The Pitt county delegation, named at a meeting of prominent planters and business men here Saturday afternoon, expect to arrive in Washington this evening. The delegation is composed of Judge F. M. Wooten, J. C. Galloway, Oscar Speight, Elias Crawford and Dave Turnage. Two other Pitt county men will attend the meeting as representatives of the delegation chosen at Raleigh. They are Dr. W. W. Gowan and E. G. Flanagan.

The conference has been called to discuss the tobacco situation existing in North Carolina at this time with a view of interesting the government to come to the relief of the planters. It has been proposed that the government make a refund of the tobacco tax to the planters, but whether this will be adopted by the conference is a matter of conjecture at this time.

Crashes in Pennsylvania While Flying Through Fog

Kane, Pa., Sept. 30. — (AP) — Flying in a dense fog, a six passenger plane, piloted by Harry Emery, 32, nationally known aviator, crashed near here last night, killing Emery, his brother Leon Emery, 47, Miss Ella Davis, 35, and Ellis Michaels, 35, mechanic.

The party was enroute to their homes in Bradford, Pa., after having visited an air circus at St. Mary's.

Farmers saw the pilot drop a flare and then crash. The ship was demolished and the passengers thrown from the cabin. Miss Davis died within a few minutes after being taken to a hospital. The three men were instantly killed.

STORM LOSS IN
BAHAMAS LESS
THAN THOUGHT

Only Six deaths Reported From Nassau; Communication Resumed Today

Miami, Fla., Sept. 30. — (AP) — Property damage and loss of life at Nassau, Bahama Islands, from the tropical hurricane that struck there last week, was not as severe as was first estimated, although it was heavy in isolated cases, according to a wireless dispatch received here today from the Bahaman capital of the Miami Daily News.

The message said only six deaths occurred in Nassau and that no loss of life in the other island group had been reported. Previous dispatches from Nassau placed the estimated dead at 20.

Most of the loss of life was in the negro settlement, the dispatch said. Thoroughfares have been cleared of debris and electric and water service reestablished.

All radio stations in the Bahama group, with the exception and Andros, having been heard from and none reported severe damage.

U. S. BALLOONS
CLAIM VICTORY
IN AIR DERBY

Two Bags in Bennett Classic Were Still Unreported This Afternoon

St. Louis, Sept. 30. — (AP) — With two foreign balloons unreported two of the United States entries in the sixteenth annual Gordon Bennett international balloon classic were claimed as winners, both landing in Ohio, showing only a few miles difference in air distances from St. Louis. They are Captain William E. Kepner, of the U. S. Army and Ward T. Van Orman, piloting the Goodyear VIII.

Captain Ernest De Myster, in the Belgica, and Lieut. George Schenstrom, in the Denmark, were the pair unreported at St. Louis, although the Belgica was reported to have hit a tree near Pauli, Ind., at 2 p. m. Sunday, tossed overboard the radio receiving set, some ballast and sailed on.

One accident marred the race. D. Eduardo Bradley, pilot of the Argentine balloon suffering a crushed knee when his balloon landed in a tree near aFibanks, Ind. He was taken to a Terre Haute, Ind., hospital for treatment as was his aide, Lieut. Francisco J. Cadaval, who was shocked and bruised.

Official measurements will decide whether Van Orman or Kepner covered the greatest distance from St. Louis as calculations made by the Associated Press showed Van Orman approximately 347 miles from the take-off and Kepner 388 and 343 miles, lack of knowledge as to actual landing spot causing the variance.

Kepner told of battling storms during his nearly 24 hours in the air while Van Orman said they encountered no difficulties and short-landed near here last night, killing Emery, his brother Leon Emery, 47, Miss Ella Davis, 35, and Ellis Michaels, 35, mechanic.

Hurricane Batters At
The Coast of Florida;
To Hit Near Pensacola

Pensacola, Fla., Sept. 30. — (AP) — The local weather observer at 11 a. m. today advised that the tropical storm now off the coast here would pass inland with Pensacola near the center about 2 p. m. and warned residents of the fashionable Bay Shore section to evacuate their homes as heavy seas might accompany the disturbance.

The wind had attained a velocity of 62 miles an hour over a five minute period with occasional gusts of 78 miles an hour recorded. The barometer had dropped to 29.32 at 11 a. m., and was falling at the rate of .01 an hour.

Little damage had been caused by the winds, as ample precaution had been taken. Ships in the harbor had dropped extra anchors and fishing smacks and other small vessels had moved into the lee of Santa Rosa Island for protection during the blow.

A few trees and telephone poles had been blown down and roofs had been ripped from two small hotels, but no one had been injured.

The weather observer said tides were running high and that if the disturbance passed to the west of Pensacola, breakers would run high in the bay, probably sweeping inland in the Bay Shore section.

Rey Safer, Associated Press correspondent, telephoned the News from Milton, Fla., that the train he left Jacksonville on for here last night was marooned there and that some of the passengers were seeking to reach Pensacola by automobile. He said no one had been injured and all passengers were safe.

The West Indian hurricane, with estimates of its intensity lowered by revised reports of damage to the Bahamas whirled northward across the Gulf of Mexico today and caused moderate gale winds to be

felt as far inland as Tallahassee, Florida's capital city.

The Washington weather bureau placed the storm at 8 a. m., about 75 miles southeast of Pensacola and warned that indications were that the disturbance would cross the coast line near that city this afternoon attended by winds of hurricane force. Storm warnings were changed to hurricane warnings along the Alabama and Mississippi coasts.

A wind which attained a maximum velocity of 53 miles an hour was reported at Pensacola at 8 a. m. today, but the absence of telephone or telegraph communications prevented the transmission of news regarding conditions at Apalachicola, fixed as the eastern terminus of the hurricane warned area in the weather bureau's advisory of yesterday. Gale winds, however, were reported at Apalachicola as early as midnight.

The Miami Daily News announced the receipt of a wireless dispatch from Nassau, capital of the Bahamas, saying that property damage wrought by the high winds of last week which were experienced over a 48 hour period was not as severe as was first thought; and that there were only six known deaths in Nassau instead of 20 as previous messages had said. Nassau utilities again were functioning normally, it was said.

News of the safe arrival in Nassau of the motor vessel Isle of Vane, which had been unreported since leaving Miami, a week ago, reduced the number of ships believed to be in distress to the Italian steamer Saltina, aground off Manzanillo reef, and the Danish steamer Scandia reported a total wreck off the Bahamas. At least one tug was going to the aid of the three men of the crew of thirty yet aboard the Dormira, British freighter which foundered in the Bahamas.

Down in the building set apart exclusively for Mr. Hog, the king of a new industry which Pitt county farmers have been trying out for the last several months, the Fair has assembled a wonderful display of the porker. Many hogs of the thousand pounds class are on display and their grunts as they battle the hot temperatures which the weather man dealt out for the opening day of the fair, may be heard the minute the building is entered.

Exhibitors in this department also come from afar. They are: J. J. Robertson, Jacksonville; T. F. Roberson, Jacksonville; W. F. Flowers, of Trenton; A. E. Smith, Robersonville; E. L. Rouse, Kinston.

The race track will offer a varied program each day, and lovers of this sport will have the opportunity of seeing horses from many states in action. The Honey family will have charge of free acts in front of the grand stand, and Basil's Madison Square band will furnish music from the bandstand in the main grandstand.

LOCAL PASTOR
PREACHES HIS
LAST MESSAGERev. L. R. O'Brian
Concludes Ministry
With Immanuel Baptist Church Here

Taking as his text the first verses of the first chapter of Revelations, Rev. L. R. O'Brian, pastor of the Immanuel Baptist church of this city, last night preached his final sermon to the congregation on the subject of "Our Lord's Return—or the Second Coming of Christ."

Rev. O'Brian resigned his ministry of the local church some time ago, to take effect on the first of October. No announcement has been made of his future plans.

Before beginning his sermon last night, the pastor stated that he wished to thank the members of his church for their co-operation while he has been here. He stated his appreciation of the co-operation received from the deacons, the various women's organizations, the Sunday school, and the young people's organizations.

"Some of you older people may not know it," he said, "but in the young people of this church you have the very foundation, the very back-bone of the church and its progress; and it is my earnest wish that you will stand by them, help them, encourage them, and lead them on to higher things." From the very first, Mr. O'Brian took a great interest in the young people of the church. Early and late, one would always find him on the job—with them in work or play—and the young people of the church never failed to call upon him for help with their problems, but that they found him ready and willing.

Beginning with a mere handful, the pastor watched each department grow until at the present there are approximately a hundred young boys and girls taking an active part in church affairs.

Not only in the young people's organizations has this growth been prevalent, but in the church as a whole. Through his untiring efforts the pastor has added upwards of two hundred members to the church roll during his nearly five years' ministry here.

The sermon last night was a fitting climax to the pastor's ministry here. He brought out many points of interest in connection with his subject, and showed conclusively that it is necessary for the Christian to be prepared for the coming of Christ. The speaker was dramatic at times, as he attempted to put across his message with additional forcefulness, and the audience listened in eager expectation to the Biblical interpretation of the second coming of Christ.

He urged his hearers to stand by the church and the teachings of the Bible, and to live lives of service so that they might be ready when Christ comes again. He showed them that a life of preparation is more essential than other things; and urged them to be alert at all times so that they might be in position to render a good account of themselves when the Saviour of man comes again.

The best wishes of the church and the city in general go with the pastor and his family for success in whatever field they may be led.

MARTIAL LAW
DECLARED AT
BORGER, TEX.Governor Sends
Troops to Disturbed
Center; Only Mayor
Remains in Office

Borger, Tex., Sept. 30. — (AP) — A trainload of troops of the Texas National Guard arrived here at 8:30 a. m. today. The special train, which came from Fort Worth, was composed of two box cars, a baggage car, two passenger cars, a caboose and four trucks. Gov. Dan Moody was expected to proclaim the town under martial law today.

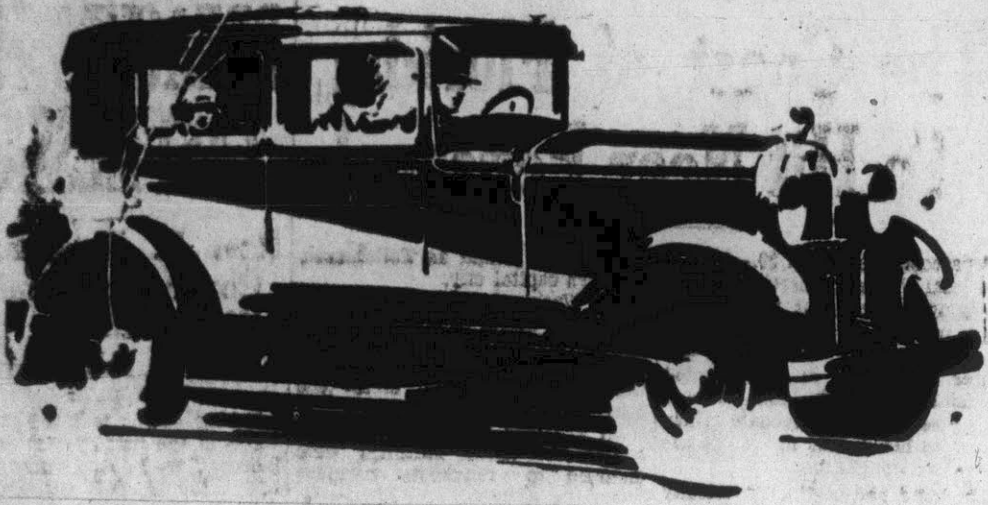
One minute after General Wolters lighted from the troop train, he read the proclamation of Governor Moody which stated that martial law had been declared for Borger at 3:30 p. m., September 29. He carried two proclamations from the state executive.

Governor Moody ordered all officers suspended except the mayor, the city attorney, the city commissioners and the justice of the peace and pointed out the lawlessness that has existed in Borger.

Eighty-four soldiers of the Texas National Guard were on the train, 14 of whom were officers.

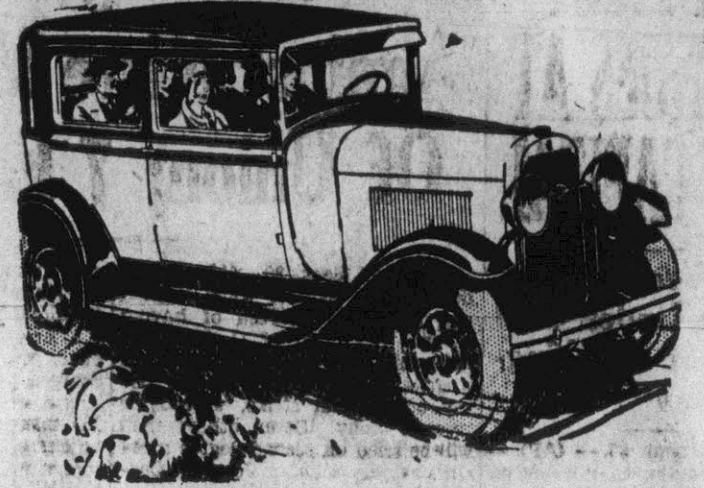

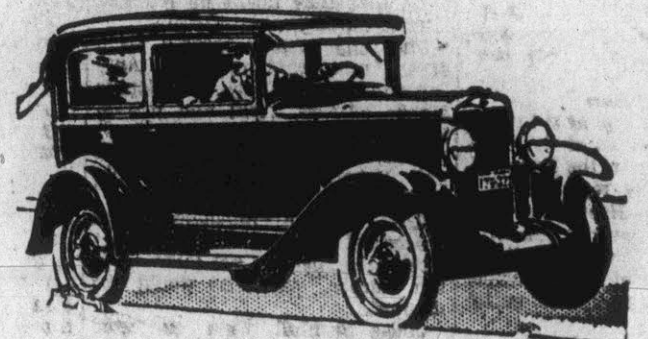

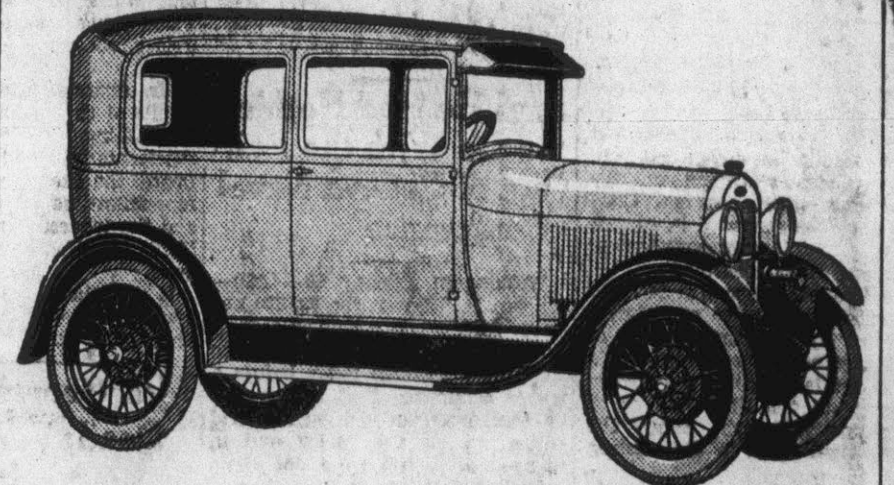

BLAME AS OPERATORS

Operators of the Pitt county Fair have come in day for their share of criticism because of the fact that any of the riding devices and concessions opened for business yesterday afternoon. It goes without saying that we do not sanction such an affair on Sunday afternoon, but criticism of the operators alone is a bit unfair. As is their custom, the people connected with the carnival went about their business of erecting their stands on Sunday in order to be ready for business tomorrow, but when the time came to test them out, there were many spectators who wanted to be the first to enjoy the rides, etc., that the operators saw some good business in view, hence, began operations as on a weekday. The eagerness of our people no doubt was an inspiration to the operators, and since no one attempted to put a stop to the proceedings, they went ahead with their business. The people of our community are as much to blame for what occurred yesterday as the people who operated the shows and riding devices.

BENEFITS OF
EXPLORATION

If farmers had any means of knowing whether the coming season ahead of them was to be wet or dry; if they could be warned of an early fall or a late spring; if manufacturers could be apprized of short summers or long winters, the economic saving would be inestimable.

No one knows how much can be accomplished in this direction, but the Byrd expedition in the Antarctic seems to be accomplishing something. Since air and water currents tend to flow from the polar regions toward the equator the possibilities of improved meteorological service as a result of the present research are great. The expedition may prove of inestimable value.

The public has been much interested in Commander Byrd's adventure. The romance of visiting unknown, frozen lands buried under thick sheets of ice, and facing the dangers of such a hostile region for the ostensible purpose of making known to civilization what is like, has stimulated the imagination of the public.

For several months the progress of the expedition as told by the radio has excited, entertained and thrilled the world, but more tangible and permanent benefits are expected from it before the explorers return home.

ABOUT
TOWN

"The Department of Education of Pitt county is attempting to safeguard the lives of the hundreds of school children by encouraging more efficiency among the scores of school truck drivers in the county," said a citizen today, speaking of the winning essay written by a truck driver which was carried in the columns of The Reflector last Saturday.

"The Department of Education this summer awarded free trips to the nineteen drivers who made the best showing during the year, and when the boys got back they were allowed to write essays concerning the trips.

"The plan ought to create more interest in the upkeep of the trucks and encourage the youngsters to aspire to better records with the passing of each school term."

"Credit is a valuable asset to the average citizen, and every effort should be made to protect it in every way possible," declared a Greenville man today, referring to the thirty day plan recently inaugurated by members of the Greenville Merchants Association.

"This plan will enable the merchant to determine when the credit customer is going to pay, and thereby eliminate much of the uncertainty existing in the slipshod way of doing business. Such a credit measure should have been adopted years ago. It has been the success of the large business houses and banks throughout the country and it should prove just as effective to the merchants of Greenville.

"When one goes to a bank to borrow money the first question the banker asks is about security and when the money is to be paid back. When the date of payment rolls around, the banker usually gets his money or finds out the reason why. Certainly the same privilege is due the merchant. His money is just as valuable as that of the banker and demands as much consideration."

"The Pitt County Fair gets under way tonight with one of the finest programs in years," asserted an official of the annual attraction this morning.

"Everything is in place and when the gates swing open to the public tonight every free act and amusement device will be ready to do its best to entertain the hundreds expected to be in attendance.

"Remember the excellent programs which the fair has put on from year to year and see to it that you turn out to see what is offered you this year. You will enjoy this opportunity of mingling with people from all sections of the county and learning what they have been doing all the year.

"We sold all of those registered bulls to Pitt county farmers last Thursday," E. F. Arnold, director of the farm department of Pitt county, said the latter part of last week. "It is evident that our people are becoming more interested in the possibilities afforded through purebred stock and that the next few years will see the industry undergo great development.

"This is what it is going to take to put this county on a solid financial basis and the sooner the experiment assumes a greater scope the sooner the section will get away from the lean season of the year experienced during the summer months."

"I wish they would fix that fire alarm system," declared a citizen today.

"The whistle has been cutting loose at different parts of the night when there was no fire, and it is becoming so frequent that it is proving quite annoying.

"I don't know what in the world is causing the disturbance, but I certainly wish it would be remedied."

"Greenville has hundreds of bargains to offer in this line and the shoppers are given a cordial invitation to come here and see what our merchants have to offer.

"This is an occasion set aside principally for the purpose of settling up old accounts and it is to be hoped the public will do everything possible to make it a success.

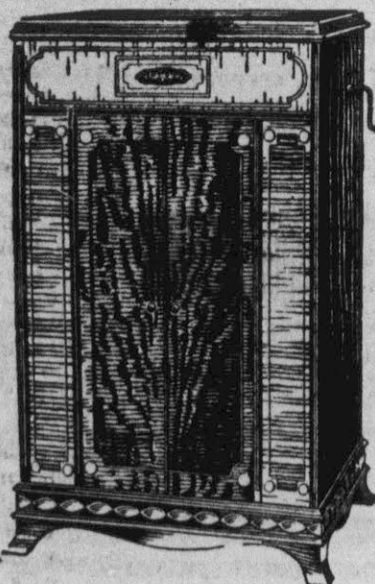

New York, Sept. 30.—(AP)—The cotton market opened steady today at an advance of 1 to 4 points on buying which was evidently influenced by the tropical storm situation which was reported heading for the Florida coast near Pensacola and threatened to cause further rains in the eastern belt. The buying was not active or aggressive but except for some southern hedging offerings were light and active months sold about 8 to 10 points above yesterday's closing quotations by the end of the first half hour.

A private report placing the condition of the crop as of September 23 at 52.7 and the indicated yield at 14,700,000 bales, no doubt contributed to the advance.

Liverpool cables reported that moderate trade calling had absorbed some hedging and liquidation in the market there and that there was a well sustained demand for cotton cloth from India.

STOCK MARKET

New York, Sept. 30.—(AP)—The liquidation of stocks was resumed on a broad scale in today's stock market after another unsuccessful attempt to bring about a general rally in the early trading. Scores of issues broke 3 to 10 points and Auburn Auto broke 38 to 40, or just 114 points below the recent high. Trading was in fairly heavy volume.

From the standpoint of operators for the advance, one of the most discouraging developments of the day was the weakness of the high-grade railroad shares, which heretofore have exhibited strong resistance to selling pressure. Norfolk & Western and Chesapeake & Ohio each dropped 6 points and Union Pacific, New York Central, Delaware & Hudson and Atchafalpa sold down 4 to 5 points, with several others off 2 to 3 points. Many of these issues are now selling at a ratio of only 10 times current annual earnings, or less, whereas many industrials are selling 20 times earnings, or more, and several of the public utilities more than 40 times earnings.

There was nothing new in the business news over the week-end to explain the selling movement, which appears to be a further correction of a heavily over-bought speculative position. Uneasiness over the credit situation appears to be the principal bearish factor although the fact that the fall expansion in some of the leading industries has been less marked than usual has aroused fears that heavy mid-summer activity has been at the expense of autumn business. Advices suggesting that Saturday's selling probably marked the completion of forced liquidation, and that a brisk rally was in order.

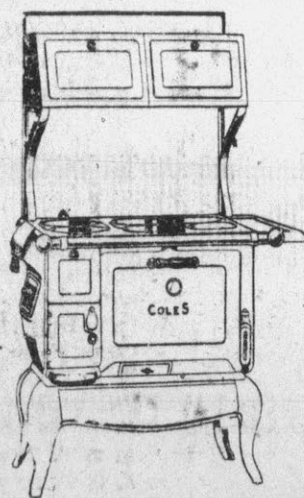
