## Hoover and MacDonald Gratified Over Result Of First Conference

### Declare All Questions That Might Cause Trouble Between England and America Had Been Reviewed

Washington, Oct. 7.—(AP)—President Hoover and Premier MacDonald joined today in expressing gratification over progress in discussing questions that might cause Anglo-American friction, and later the British statesman filled the Senate chamber with applause with the declaration that the Kellogg-Briand treaty renouncing war would stand out like a monument in history.

The heads of the two great nations expressed their views in a joint statement issued shortly after their return from a week-end at the rustic Hoover fishing camp in the Virginia mountains from which they announced a conference looking to further naval limitations would be called.

Shortly afterwards, the prime minister departed for the capitol. First he was received by the House where he spoke briefly. He then went to the Senate. The galleries of both chambers were filled. Foreign ambassadors and other members of the diplomatic corps in their brilliant uniforms, vied with fashionably dressed women, including Mrs. Dolly Curtis Gann, in adding color.

"There can be no more war; it is impossible if we make the peace pact effective that any arm of our forces, sea, land, or air, will come in conflict," the state MacDonald asserted as the Senators and those sitting on the floor applauded.

"We have come together and said that all this bother about parity," he continued. "Partly I take it, referring to the naval discussions, are destined ultimately to come before the Senate in the form of a treaty, MacDonald pronounced naval parity "heaped and flowing over."

Take it without reserve, heaped up and flowing over. That was the only condition under which competitive armaments could be made and we could create a public psychology which would pursue fruitful and successful avenues of peaceful co-operation.

"That is one of the results of this visit. Another result of the visit is that we have come to understand each other."

Again there was applause. As the prime minister spoke he occasionally referred to notes scribbled on several torn sheets of paper lying before him. He held his glasses balanced on his left thumb, and took hold of his coat lapels with both hands as he spoke.

The Senate listened intently. The British premier paid a glowing tribute to the late Gustav Stresemann, foreign minister of Germany, asserting he was "a quiet, heroic man, standing surrounded by envy not only abroad but at home, determined to play a perfectly straight game."

After again thanking the Senate for its hearty welcome, MacDonald was escorted to the front of the reading officers' dias by Vice-President Curtis amid another outburst of applause.

There the members of the Senate led by to shake the hand of the premier. Upon leaving the capitol he returned to the White House for lunch with President Hoover.

## NAME BOARD TO CONDUCT LOBBY PROBE

### Four Members of the Committee Belong to Forces Opposed to Tariff Bill

Washington, Oct. 7.—(AP)—A subcommittee of five headed by Senator Caraway, Democrat, Ark., was named today by Chairman Norris of the Senate Judiciary committee, to conduct the lobby investigation.

The four other members are Senators Walsh, Democrat, Montana; Borah, Idaho; Robinson, Indiana, and Blaine, Wisconsin, Republicans.

Four of the five committee members belong to the Democrats and Republican independent groups opposed to the pending tariff bill.

Reported lobbying activities in connection with this measure are expected to receive first attention. Inquiry into these reports undoubtedly would include the work of the Senate Finance committee which drafted the tariff bill. A number of independent Republicans recently have expressed dissatisfaction over the Republican membership of the committee, contending it has been made up of regular Republicans.

Caraway will call the committee together at once to organize it. Norris recommended it employ counsel and promised to obtain authority for this from the Senate.

The committee will investigate activities of those who have been seeking to influence the tariff legislation. He has singled out the southern tariff league and Joseph R. Grundy, Washington representative of the American tariff league, as among those to be called.

He said he had been informed the industries of Pennsylvania had been assessed from \$75 up to pay the expenses of a tariff lobby.

"I am infinitely more concerned," he added, "in where the dollar finally rests than where it came from. That's what we will try to find out."

Caraway will call the committee together at once to organize it. Norris recommended it employ counsel and promised to obtain authority for this from the Senate.

### SELECT JURY FOR TRIAL OF ALBERT B. FALL

Washington, Oct. 7.—(AP)—A jury of eight men and four women was selected today to try Albert B. Fall, former interior secretary, on bribery charges growing out of the Elk Hills Naval Oil Reserve lease to Edward L. Doheny.

Although his attorney had announced that his health would not permit him to stand trial, the former interior secretary today appeared in court.

Frank Hogan, Fall's chief counsel, said the former cabinet officer would not ask for a postponement despite his ill health.

Fall was helped to his seat by members of his family and Dr. H. T. Safford, his physician.

Members of the family said Dr. Safford had advised the secretary not to appear in court but he had refused to follow his recommendation.

Shortly after Fall's appearance Justice Hitz of the District of Columbia Supreme court overruled the former interior secretary's motion to dismiss the bribery indictment on the ground it constituted "double jeopardy."

Justice Hitz then said to Fall: "I understand you plead not guilty." "Yes," replied Hogan.

The trial judge immediately began filling the jury box.

Mrs. Fall and her two daughters were among the spectators and Edward L. Doheny, oil magnate, who is charged with giving Fall a \$100,000 bribe, sat inside the rail.

The termination of the present case will decide whether the oil man will be tried on the same charge, as an indictment charging bribery was also returned against him.

### SEN. SHEPPARD WOULD AMEND VOLSTEAD LAW

Washington, Oct. 7.—(AP)—An amendment of the Volstead Act to prohibit the purchase of intoxicating liquor for beverage purposes was proposed in a bill introduced today by Senator Sheppard, Democrat, Texas, the sponsor of the eighteenth amendment.

Senator Sheppard's proposal would make the purchaser equally punishable with the manufacturer or seller of intoxicants. He said the amendment was necessary because of a recent court decision which held that the purchaser was held not liable in connection with an act of transportation.

The Texas said he had been under the impression that the purchaser of liquor for beverage purposes was punishable in connection with an act of transportation but that the decision made it advisable to definitely prohibit purchase by the terms of the Volstead Act.

### Says Tobacco Prices Better

With approximately 1,200,000 pounds of tobacco on the local market today bidding was more brisk with the prices on medium and better grades apparently stronger than since the opening of the season. Observers on the sales this morning stated that today's bidding indicated highest average price so far the season.

### LINDBERGH VISIT EMPIRE MAYA INDIANS

Belize, British Honduras, Oct. 7.—(AP)—Colonel Charles A. Lindbergh, flying yesterday over the once broad empire of the ancient Maya Indians of the Yucatan peninsula, discovered indications of a large ruined city, hitherto unknown to science.

The ruins were located in an area in which no human habitation was seen, where there was no open water, and where for many miles on any side were to be found only impenetrable jungle populated by ferocious beasts, boa constrictors, and poisonous insects.

Radio messages received here from Colonel Lindbergh's plane gave only meagre details.

They saw the first Yucatan settlements, primitive villages and a primitive Indian race. As the giant plane circled above them the natives fled in all directions, seeking cover from the strange bird from another world—as strange to them, probably as were Cortez's sailing ships to the minions of Montezuma 400 years ago.

The territory in which the supposedly new city was discovered was in what is known as Northern Peten, a district on which it is believed here, no white man before has set his eyes.

Colonel Lindbergh completed a preliminary survey and it was thought those with him were able to take some pictures.

Upon leaving here yesterday morning Colonel Lindbergh flew up the Belize river on a general course to Cayo and Yaxha, and then directly north to Tikal, ancient empire city of the Mayas whose temples reach a greater height than any heretofore discovered.

The plane covered in one hour and three quarters a distance which land parties need seven days to travel.

The party left Tikal at noon. Fifteen minutes later they picked out the snow white temple at Uaxatun, grotesquely sculptured in its blanching beauty in the deep green of the surrounding jungle.

Dr. Oliver Ricketson, a scientist of the Carnegie Institute who is accompanying Colonel and Mrs. Lindbergh, spent five years in excavations here. He estimates one of the temples to date from the time of Christ or earlier.

The giant Sikorsky plane was stripped of all but its bare necessities for yesterday's trip. No one, not even Mrs. Lindbergh, carried any personal baggage. Mrs. Lindbergh, who sat beside her husband in the cockpit, had her regular duties to perform.

Dr. A. V. Kidder, head of the Archaeological department of Carnegie Institute, also was in the party.

### Four Killed In Airplane Crash

Leona, Tex., Oct. 7.—(AP)—A crumpled wing at an altitude of 1500 feet yesterday plunged to their deaths Lieut. Jack Brooks, 28, a Dallas contractor, and three passengers in his plane.

Leon Lynch and Allen Powell, of Centerville, and Marion Botter, of Teague, were killed with Brooks. Lieutenant Brooks was considered one of the best pilots at Love Field, Dallas, having spent more than 8000 hours aloft. Apparently the bracing of the left wing of the plane gave way, the wing folding back over the cockpit.

## GOVERNOR IS SILENT TODAY ON RIOT PROBE

### Statement on Marion Situation Expected Sometime During Today

Raleigh, Oct. 7.—(AP)—Governor O. Max Gardner continued silent today in regard to the request made of him Saturday night by a delegation of Marion labor leaders for an impartial committee investigation of the trouble at Marion and the causes of it.

Governor Gardner was in conference for several hours this morning with N. A. Townsend, his executive council, who he sent to Marion last week immediately upon receipt of word of rioting there.

At the conclusion of the conference neither had anything to say in regard to the Marion situation but it was indicated that Governor Gardner was studying the request and the law on the subject closely and that a statement would probably be issued sometime today.

Saturday night a labor delegation headed by F. J. Gorman, first vice-president of the United Textile Workers union, spent more than two hours with the governor. The delegation requested an impartial committee to investigate "the Marvyn massacre" with at least one of its members to be selected by the United Textile Workers.

Points which the delegation advanced for investigation were:

1. Character and past records of involved deputy sheriffs.
2. If the Marion Manufacturing company violated the agreement of September 11 which settled the strike.
3. Payrolls of the company showing actual working hours and the wages of textile employees.
4. A profit and loss statement of the Marion Manufacturing company over a period of years.

It was brought out at the conference Saturday night, it has been learned, that the union officials admitted that the strike which resulted in the fatal rioting of last week was not authorized by the union. Other details of the conference could not be learned.

### Says Statement Misconstrued

Washington, Oct. 7.—(AP)—Carl Williams of Oklahoma, cotton representative on the Federal Farm Board, said today he had no idea of conveying the impression in his testimony before the Senate agriculture committee last week that a fair price for cotton would be a cent to a cent and a quarter more than at present.

### NO MEETING OF STRIKERS HELD MARION TODAY

Marion, Oct. 7.—(AP)—Contemplated meetings of strikers at the Marion Manufacturing Company's plant have been called off by officials until after Judge W. F. Hardaway completes his investigation of killing of five men in a riot which followed the calling of the strike last Wednesday.

In the meantime Judge Hardaway heard no testimony during the morning, the sessions having been adjourned early Saturday until two o'clock today in order to allow court officials to attend to other duties.

Francis J. Gorman, first vice-president of the United Textile Workers Union, after conferring with other labor leaders here, announced that it would be the policy of the labor group to hold no meetings until after Judge Hardaway's hearing closes.

Gorman said that additional men walked out of the mill today but mill officials said that the statement was not true. The mill continues to operate, guarded by two companies of national guard.

John Peel, of the North Carolina Federation of Labor is remaining in Marion to assist William Ross handle strike relief. Gorman is leaving today for Toronto, Canada, where he reports on developments in the textile labor situation to the convention of the American Federation of Labor which began sessions in the Canadian city today.

## More Defendants Linked With Aderholt Slaying As Trial Moves Forward

### TWO KILLED IN GUN FIGHT

Charlotte, N. C., Oct. 7.—(AP)—The state continued today to present evidence intended to support its charges against seven men accused of the murder of Police Chief O. F. Aderholt of Gastonia during a fight growing out of labor troubles at the Lorry mills.

W. P. Upton, a deputy sheriff, testified that he had gone to union headquarters where the shooting took place and after finding five shot guns, cartridges and shells, had arrested Clarence Miller one of the defendants. It was the first evidence presented against Miller. The other six defendants, Fred Erwin Beal, George Carter, Joseph Harrison, William McGinnis, Louis McLaughlin and K. Y. Hendricks, have been implicated in previous testimony.

The first witness today was A. C. Little, a Gastonia merchant, and his wife. Mrs. Little testified that she had been struck on the leg by one of the bullets which penetrated the house of a neighbor where she was spending the evening. Little said that he had seen the police come to union hall, saw a fight start between a union guard and a police officer, and heard cries of "shoot him." He testified that he then went in the house where his wife and two daughters were screaming and did not return until just before 9:30 p. m.

"I saw two guards standing in front of the union building," Mrs. Little said, "and right after somebody shouted 'turn him loose,' one of them fired at Tom Gilbert."

Gilbert was one of the police officers wounded in the fight. Mrs. Little was unable to identify any of the defendants as the guards she had seen.

When Miller was arrested three shotgun shells and five or six pistol shells were taken from his pockets. Upton said that subsequent trips to union headquarters he found a shotgun and about fifty shells and several guns had been found in tents. In a cold drink stand near union hall, he said, was a gun and another was found in some nearby bushes. He said that he had opened the gun found at the cold drink stand and determined that it had been fired recently.

### 2 MEN VISITED APARTMENT ON FATAL NIGHT

A. J. Roach, special deputy with Chief Aderholt when he was shot took the witness stand immediately after the lunch recess.

When he did, he was struck in the leg with a full load of shot and fell. Another shot followed and he pulled his pistol from his holster and fired at the building where he could see gun flashes. Another load of shot hit him and he became unconscious.

Roach said his wounds showed 141 shot had struck him.

### Department of Justice Uncovering Facts in Mysterious McPherson Case

Washington, Oct. 7.—(AP)—Evidence that two men were in the apartment of Mrs. Virginia McPherson the night of her mysterious death is becoming clearer under the scrutiny of department of justice investigators.

Robert A. McPherson, Jr., 21-year-old estranged husband of the young woman, is facing a charge of strangling her to death, under an indictment brought against him after the police and a coroner's jury declared her a suicide.

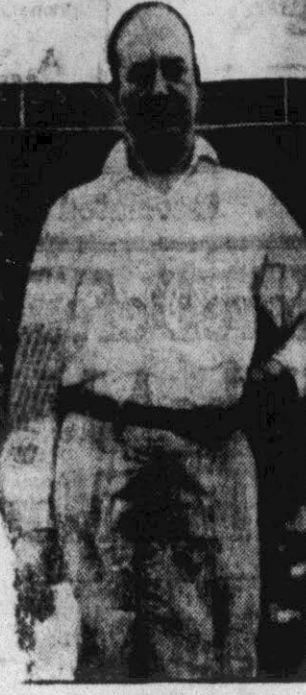

### COTTON MARKET

New York, Oct. 7.—(AP)—Cotton opened steady today at an advance of one to five points in response to relatively steady cables. Three more private crop reports were published, one of which made the condition of the crop 54.1 and the indicated yield 15,025,000 bales while another made the condition 54.5 and the indicated yield 14,971,000 bales. The third, however, placed the condition at only 51.4 and the indicated crop at 14,494,000 bales, and seemed to offset the effects of the larger figures on local sentiment.

Trading was moderately active and the market held fairly steady during the first half hour. The active months showed net advances of about 3 to 5 points on covering and trade buying. Liverpool cables reported that hedging and covering had been absorbed by Continental and Bombay buying but said the demand for cotton goods in Manchester was limited.

The market was quiet later in the morning. Southern selling continued but there was enough covering or trade buying to absorb it on moderate setbacks and the market showed a generally steady tone.

Prices at Midday were 2 to 5 points next higher with December selling around 18.85 and March 19.17.

Futures closed steady 2 to 8 points higher, spot steady; middling 19.00.

## FRENCH FLIERS ARRIVE SAFELY

Coste and Bellonte Set New Distance Record in Paris-Manchuria Flight

Tokyo, Oct. 7.—(AP)—Headon Coste and Maurice Bellonte, who had been missing a week. Today were safe in Manchuria after establishing a new world's non-stop flight record and after a series of hazardous adventures including their arrest by Chinese soldiery who thought they were Russians.

Advises received in Tokyo today placed the French fliers near Tsitsihar, northwest of Harbin, Manchuria were between 5,500 and 6,000 miles from Le Bourget, considerably better than the former record of 4,338 held by the Italian fliers Perrarin and Delprete.

Fragmentary accounts received by the Reno News agency from Harbin stated that the men landed because of a shortage of fuel in a village north of Tsitsihar. They were mistaken for Russian military aviators and were held in custody while General Wan Fu Lin, head of the Heilungkiang Provincial government telegraphed to Mukden announcing that his troops had captured an enemy plane and asking for instructions.

**Fortune in Jewels.**

New York—A pearl ring valued at more than \$250,000 was among the jewels worn by Jeanne Eagles, actress, at the time of her death. A police report also revealed a \$20,000 six-carat diamond ring, a wedding ring set with seven diamonds, a white gold guard ring and two strands of pearls. The total value of the gems were \$350,000.

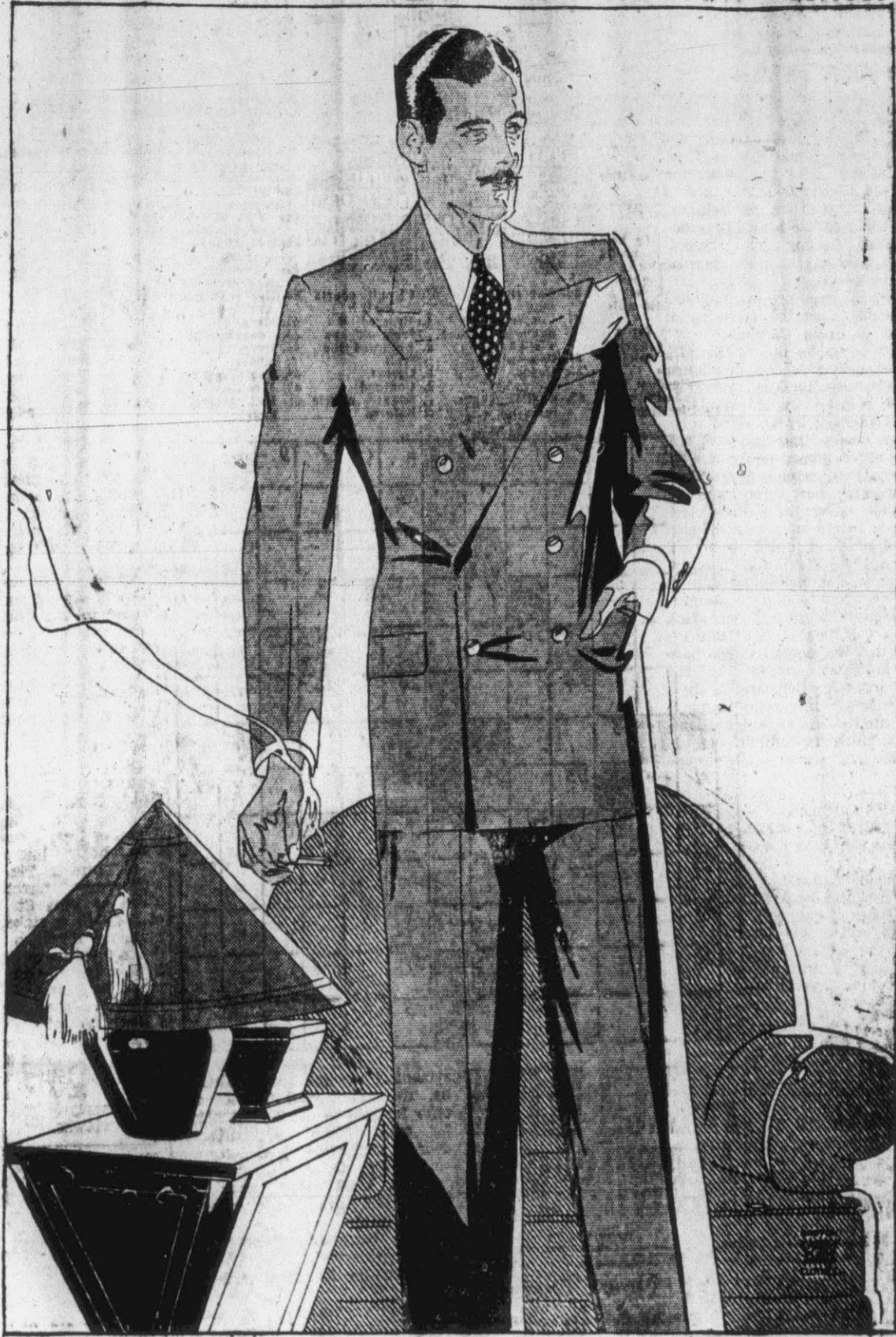
