PHILADELPHIA WINS FOURTH SERIES GAME

Athletics Score Ten Runs in 7th Inning to Give Them 10-8 Win Over Chicago Cubs

Shibe Park, Philadelphia, Oct. 12.—(AP)—Overhauling the Chicago Cubs with an amazing ten run rally in the seventh inning, the Philadelphia Athletics today battered their way to victory ten to eight before an hysterical home town crowd of 30,000.

They gave the American League champions their third triumph in four games, leading by three to one, the men of Mack need only the more victory to win the world's baseball championship. They can settle it in the fifth game scheduled here Monday.

Trailing by eight runs, going into the seventh with the Cubs seemingly headed for a one-sided win that would even the series, the Athletics let loose an attack that dwarfed anything in series records.

The battered four pitchers for ten hits, including four home runs by Al Simmons and George Haas as fifteen men went to the plate in an orgy that had the crowd wild.

MacDonald Ends Mission To America With Appeal To All Nations of World

New York, Oct. 12.—With a last appealing message not alone to the British and American people, but to all the nations of the earth, Prime Minister Ramsay MacDonald has brought to an end his peace mission to the United States.

His last public utterance on this trip in America—made at a dinner tendered last night by the Council of Foreign Relations and carried by radio over sea and land to the English-speaking people of the world—was even franker than those in Washington and in New York which preceded it.

In this talk, which continued for nearly an hour, the prime minister gave some intimate details of how he and the president carried on their personal negotiations in the wilderness of the Virginia mountains and in the Lincoln study at the White House.

More than that, he undertook to reassure the world that what took place was solely for the promotion of universal peace and the spread of the American people for balance, for understanding, for good will while the British people are replacing the old furniture of their minds with the new and more modern furniture of naval limitation and parity.

His message to the other nations regarding the conversations between President Hoover and himself was briefly, but earnestly delivered.

"I want to say quite definitely and clearly," he said, "I want the whole world to know it and I say it with-out any reserve and any withholding of any kind whatever, that during the entire course of our conversations there has never been an idea of an exclusive understanding between Great Britain and the United States.

"There has been nothing discussed which the two governments would not be happy to see discussed on the same basis with all the powers in the world. The understanding we have been trying to establish will always be incomplete and unsatisfactory until it has become the common possession of all the nations on the face of the earth."

The British statesman introduced his description of the conversations between himself and Mr. Hoover by saying they did not try to maneuver each other into position or out of position.

"We tried, as I have said, for no alliances and no balances of power," he asserted. "We did not sit down to play a creeping and waiting game. We did not watch each other as prize fighters study the faces of each other. We did not begin by offering little things, trying to best each other and then to advance step by step and stage by stage as the one forced the other. We did not examine statements meticulously in order to discover how we could put something over the other without his knowing it."

"The method was altogether different altogether. We knew what we were out for. We stated the difficulties of our respective countries. He told me his. I equally frankly told him mine. He told me what he thought he could do. I told him what I thought I could do. He told me what his opinion demanded of him. I told him what public opinion demanded of me."

"In that sincerity, in that simplicity, in that informality, we conducted our negotiations and that is the reason why in our brief days we came to conclusions that under the old diplomacy could have taken at least as many months to have achieved."

HOLD EIGHT IN PROBE OF STRIKE CASE

McDowell County Officers Held Under \$3,000 Bond in Marion Rioting

Marion, Oct. 12.—(AP)—Probable cause having been found against them, eight McDowell county officers, charged with murder as result of a strike riot on October 2 at the Marion Manufacturing Company's cotton mill here in which six strikers were wounded fatally, were under bonds of \$3,000 each today for their appearance at the next term of Superior court.

Judge Harding dismissed eight other officers against whom strikers had brought similar charges at the conclusion yesterday of a week's investigation of the riot. He ruled there was not sufficient evidence to warrant holding them for grand jury action.

Judge Harding, a Superior court jurist, made his investigation sitting as a committing magistrate at the request of Governor O. Max Gardner.

The eight held had admitted firing at strikers during the riot but contended the shots had been in self defense. Judge Harding held that a jury should pass upon whether they were justified in shooting."

"Some sixty strikers charged with rebellion against the state, rioting and resisting an officer previously had waived preliminary hearing and given bonds for appearance in Superior court."

MILL WORKER TESTIFIES AT STRIKE TRIAL

Floyd Rathbone Says First Shot Came From Place Two Men Were Scuffling

Charlotte, Oct. 12.—(AP)—The first shot of the Loray tent colony shooting the night of June 7 apparently came from a scuffle, Floyd Rathbone, textile worker, testified in the trial of seven National Textile Union members and leaders charged with the murder of O. F. Aderholt, chief of police of Gastonia.

Rathbone, testifying for the defense, said that Tom Gilbert, policeman, and a guard had a scuffle immediately after Aderholt and four other policemen entered the union headquarters ground. "Another fellow, Rathbone said, took the gun away from the guard and punched the guard on the shin with it."

Asked where the first shot came from Rathbone said "it appeared to come from the gun the fellow was using to punch the guard's shins."

"The other shots, he said, appeared to come from the woods and the officers."

"No shots came from the union hall," he said. Prosecution witnesses had testified that a number of shots were fired from the union hall. A. J. Roach, a special officer, who was wounded in the shooting, testified that he had fired at a man shooting from the hall.

Rathbone said 40 or 50 shots were fired and that when they "whistled around my head I ran away."

The witness asserted that some time prior to the shooting Tom Gilbert, a policeman, who also was wounded in the shooting, had told him and some other men that if they wanted to that they could go to union headquarters and raise as much hell as you want. If you haven't any liquor I'll see that you get it."

Rathbone said he did not join the picket line going to the Loray mill because he did not want to get into trouble.

Merie Husinger, 15, testified that she heard Fred Erwin Beal, one of the defendants, make a speech at the union hall and heard him tell pickets to go to the Loray mill. She denied that he had told them to "go into the mill" as prosecution witnesses claimed.

She said that she was in the picket line when it was broken up by police shortly before the shooting and that she saw officers drag a Mrs. McGinnis on the ground. She also said that she did not see William McGinnis, a defendant, with a gun at union headquarters when Aderholt was shot. Prosecution witnesses claim that McGinnis fired the first shot.

Miss Husinger, like Rathbone, asserted that the first shot came from the place where Tom Gilbert, policeman, was scuffling with a guard.

W. E. Ray of Charlotte testified that he was at a meeting on the union grounds before the shooting and that eggs were thrown at Fred Erwin Beal. He and Miss Husinger both testified that Patrolman Gilbert had threatened Mrs. McGinnis.

Labor Party Holds Lead in Elections Through Australia

Melbourne, Australia, Oct. 12.—(AP)—Early returns in the Australian general election today indicated a swing to the labor party, the official opposition in the last parliament.

E. C. Theodore, one of the outstanding labor chiefs, was elected. Sir Lytton Groom, speaker of the last house who declined to make a casting vote when the government was defeated, was at the bottom of the poll in Darling Downs in the early returns.

The labor party needs only six seats more than it held in the last house to have a working majority and control of government. In the last elections, held eleven months ago, 30 national party supporters of Premier Stanley Bruce were elected, to 13 county party members and 32 laborites.

Two Killed When Man Runs Amuck At Newburgh, N. Y.

Newburgh, N. Y., Oct. 12.—(AP)—Two persons were killed and three injured by Pasquale Parino, a chauffeur who ran amuck with a shot gun here last night, and who then shot and killed himself.

The shooting occurred in the crowded room of a home in New Windsor, on the outskirts of this city, members of two families were grouped together for their daily tasks of job sewing for a Newburgh manufacturing company when Parino, said to have been incensed by non payment of money he believed due him, burst in upon them and began firing.

The dead: Santos Massina, 50, and his wife, Mrs. Katrina Massina.

Two Tariff Commission Members Are Summoned In Lobby Investigation

Washington, Oct. 12.—(AP)—Chairman Marvin and commissioner Edger B. Brossard, of the tariff commission, were included today among witnesses summoned by the Senate Lobby Investigating committee for the opening hearing on Tuesday.

Chairman Caraway of the committee announced that H. A. Austin, representative of the United States Beet Sugar company, and H. C. Lakin, president of the Cuba company of New York city also had been called in connection with the inquiry into the tariff situation.

It has been decided to inquire first into charges of attempts to influence experts of the tariff commission in determining valuation. "Previously William Burgess of Morristown, Pennsylvania, a former public member of the tariff commission, had been ordered to appear Tuesday."

Calling of the sugar representatives today indicated early attention also will be given to the contests over the proposed increase in the sugar duties, provided by the pending tariff measure.

Caraway announced the two tariff commissioners were called in connection with the Burgess and Koch case which involves an alleged attempt to influence the commission or the valuation appraisal on potatoes.

Once the committee concludes investigation of this it will turn to the sugar controversy, the chairman explained. The proposed increase in the sugar duty is one of the main points of controversy in the tariff measure and for months there has been an active campaign by interested parties on each side of this issue outside of congress.

It also was announced that H. R. Wylie, of Marlinton, W. Va., had been asked to appear but that he had sent word he would be unable because of illness.

SENATORS TO TRY AND SAVE TARIFF BILL

Hope to Be Able to Bring About Action On Measure Before Session Is Over

Washington, Oct. 12.—(AP)—Efforts to save the tariff bill from the threat that the special session will expire before it can be passed today engaged the earliest attention of senate leaders.

Taking advantage of the week-end recess, given so members could attend the big three sporting event that lured them away from the capital for the day, Chairman Smoot of the finance committee, in charge of the bill, arranged to talk the situation over with Senator Robinson of Arkansas, the democratic leader.

Their conference added a new touch to the picture Senator Watson of Indiana, Republican leader, presented to President Hoover with his report that enactment of a bill at this session seemed unlikely.

Fears of Republican leaders that the administration would not favor a continuance of the tariff debate into the regular session beginning in December, meanwhile, have received neither confirmation nor authoritative denial.

A dozen more individual amendments still will confront the senate when it re-assembles Monday, to be disposed of before the rate schedules can be taken up. With that in view and only six weeks left for the special session to continue those working to get the bill out of the way within that time found cause for additional worry in the fact that two days were consumed in disposition of the amendment to modify customs bans against imported books.

Prices Continue to Advance On Greenville Leaf Market; Average Yesterday \$21.85

Prices continued to bound upward on the Greenville tobacco market yesterday and the highest average price of the season was the outgrowth of the day's activities, according to the official report of sales made public this morning by K. W. Cobb, supervisor of sales. The market's average for the day was given \$21.85 an advance of over \$5 per hundred pounds over the corresponding period last week.

The report of the supervisor also showed that the market disposed of a total of 3,853,522 pounds of bright leaf for \$752,571.16 at a general average of \$19.53 per hundred pounds. This reflected an increase of over \$5.00 a hundred pounds for the report covering the market activities for last week.

Sales for the season were estimated at 19,729,218 for a total sum of \$2,897,870.27, at a general average of \$14.69 per hundred pounds.

He also stressed the need of a new and larger chapel. There were 525 boys in the school up to July 1st, but the number has been reduced to 485 since the recent placing of them in homes and positions.

Bandit Convicted of Murder Charge

Lamar, Colo., Oct. 12.—(AP)—George J. Abshier, one member of the bandit quartet which terrorized this little city one day in May 1928, when two men were shot down in the First National Bank during a holdup, today stood convicted of a first degree murder, carrying the penalty of death. Two other men were murdered subsequently by the gang, which robbed the bank of \$219,000.

Abshier, first of three defendants to go on trial on the charge of slaying A. N. Parris, president of the bank, was convicted by a jury after slightly less than three hours of deliberation.

Howard L. Royston, another member of the bandit gang, will go on trial Monday. He will be followed by Ralph Fleagle, whose confession to participation in the holdup and killings led to the arrest of both Royston and Abshier. In return for his confession, Fleagle has been promised immunity from the death penalty.

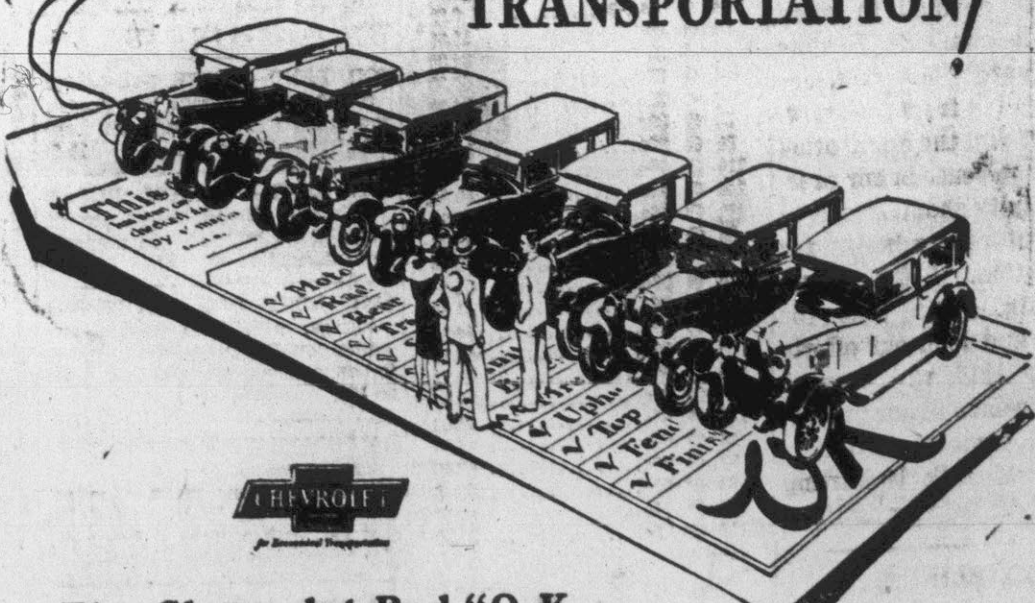

Despite all the hard times talk, our section is far from the starving point and the application of common sense in our present difficulty should result in better future conditions for our section. Let's forget about talking hard times for a while and lend our efforts to plans that will prevent the recurrence of our present financial troubles. All this hard times talk is hurting rather than helping matters.

Stimson Clears Up
Statement Made By
Visiting Britisher

Washington, Oct. 12. — (AP) —
David Lawrence, Washington news-
paper man, said in a statement to-
day he was glad Secretary Stimson
had explained the phrase, "main-
taining the peace of the world,"
used in a joint announcement by
President Hoover and Ramsay Mac-
Donald.

Stimson in a formal statement
said that Lawrence in asserting that
Great Britain and the United States
have in effect agreed to pool their
navies to maintain the peace of the
world, had completely misconceived
and misrepresented the actual
"spirit of our conference," as the
aim of understanding was a moral
one and not a military one. Noth-
ing, he said, could be further from
the truth "than to suspect that we
contemplated any jolinder of pooling
of our navies."

In his statement issued today in
reply Mr. Lawrence said:
"I have just read Secretary Stim-
son's statement and am gratified
that he has cleared up the use of
the phrase 'maintaining the peace
of the world,' as making the applica-
tion of moral and not physical
force which was the basis of the
misconception, particularly since
the phrase was embodied in an an-
nouncement of an agreement on the
equality of naval strength."

others were injured in the crash of
a roadster today into a string of
freight cars at the Illinois Central

of the automobile and Allen Lin-
bauer. One couple were seated in
the front of the auto and the other
in the rumble seat when the crash
came. The occupants were hurled
out in wild fashion and the dead
girl received her fatal injury by
landing on her head on the pave-
ment.

O'DOUL WINS BAT HONORS OF NATIONAL

New York, Oct. 12.—(AP)—Frank O'Doul of Philadelphia won the National League batting crown by a margin of nine points over his nearest regular rival, Babe Herman of Brooklyn, according to the final averages released today. The Philadelphia outfielder established a new league record for hits in establishing his winning mark of 400. In his 636 times at bat he cracked out 254 safe blows, four more than the former record, set by Rogers Hornsby in 1922. O'Doul also led in the number of singles with 183.

Hornsby also set a new record by scoring 155 runs as well as leading the league in total bases with 408. The former run mark was 144, set by Hazen Cuyler in 1925. Hornsby finished third in the batting race with an average of .380.

A third modern National League record went to Johnny Frederick of Brooklyn, who collected 53 doubles, three more than Paul Waner made in 1928. The all time record still belongs to Ed Deleahanty of Philadelphia who made 56 in 1896.

Lloyd Waner of Pittsburgh captured the crown for triples, getting 30 three-baggers, but left a gap in the record-breaking performance. Chuck Klein, the Phillie slugger, picked up the record, breaking the system again by getting 43 home runs. He beat Hornsby's old record, set in 1922, by one circuit clout.

Another of the Rajah's marks set in his great 1922 season went down when Hack Wilson of Chicago completed a record of 153 runs batted in. Hornsby drove home 152. The final run producing crown went to Hazen Cuyler of Chicago, who stole 43 bases.

Behind the three batting leaders, O'Doul, Herman and Hornsby came Terry, New York, .372; Stephenson, Chicago, .362; Cuyler, Chicago, .358; Klein, Philadelphia, .356; Travers, Pittsburgh, .355; Waner, Pittsburgh, .353; and Hendrick, Brooklyn, .352.

The Phillies took the team batting championship with an aggregate mark of .303 while Pittsburgh led with the champion Chicago Cubs for second place with a .303 mark. The rest will be under .300. The Cubs and the New York Giants tied for club fielding honors with an average of .975. Cincinnati had a .974 mark.

Charlie Root of Chicago led the pitchers with 19 victories and six defeats for a mark of .760 although Carl Mays of New York held a nominal lead, winning seven games and losing two to gain an average of .778. Guy Bush of Chicago was second to his teammate. His mark of .720 came from 18 victories and 7 defeats. Burleigh Grimes of Pittsburgh won 17 games and lost 7 to take third place with a .708 average.

LEW FONSECA IS AMERICAN WILLOW KING

Chicago, Oct. 12.—(AP)—Lew Fonseca, Cleveland's veteran first baseman, won the American League batting championship for 1929 with a .369 average, the lowest to win the crown since Ty Cobb turned the trick with a .368 mark way back in 1914, final unofficial averages revealed today.

Al Simmons of the Athletics finished second with .364 while Heinie Manush of the St. Louis Browns, runner-up last year, came in third with a .355 average, one point higher than Jimmy Fox, another member of Connie Mack's championship team.

Tony Lazzeri of the Yankees landed fifth, one point behind Fox. Other leaders at the finish were Fothergill, Detroit, .350; Ruth, New York, .345; Coombs, New York, .344; Hellmann, Detroit, .243, and Alexander, Detroit, .241.

It was the first odd year since 1909 that Hellmann failed to win the title. He won it in 1921, 1923, 1925, and 1927. Robert Moore Grove of the Athletics, was credited with the pitching championship of the National circuit. "Lefty" won 20 games and lost six, pitching 275 innings and allowing 278 hits. He is the 1923 strikeout king of the league too with 167 whiffing victims. Tom Zachary of the Yankees had a perfect percentage—12 games won and none lost—but the championship was given to Grove because of his greater number of games. George Earnshaw of Philadelphia was second with 24 victories and eight defeats with Ferrell of Cleveland third with 21 victories and 10 defeats.

Detroit won the team batting championship with a .298 mark; the team fielding crown went to the Athletics with a .975 average, one point higher than the St. Louis Browns. Cleveland turned in 162 double plays to top the circuit in that department.

In other individual batting departments, Simmons led in runs batted in with 143 and his hits ranked in the most total bases—371. Babe Ruth led again in homers, getting 46; Alexander got the most hit—214, while Gehring of Detroit scored the most runs, 130; rapped out the most triples—19, and led in stolen bases with 27. R. Johnson of Detroit bagged 48 two baggers to lead in that department.

Local Highs Win From Kinston

Yesterday afternoon Greenville took a close football game from Kinston at the new Greenville Heights field by the score of 12 to 6. Kinston threatened all thru the game, and gained approximately as much yardage as Greenville, but the scoring punch belonged to Greenville. Kinston was especially dangerous when they took to the air, completing five pretty passes for an average gain of 20 yards. They also gained eleven first downs to Greenville's fourteen, but the Greenville defense stiffened much more than the Kinston line when a score was threatened, altho Kinston once held for downs on the eighth yard line. Capt. Briley was called on for most of the Greenville plunges, and

as expected, came thru nobly for steady gains. Hodges and Smith both made consistent gains off-line and around the ends, and field general Joe ran his team with fine judgment. The most brilliant single play of the contest was undoubtedly Smith's interception of a Kinston pass on his own 20 yard line from which he dodged and maneuvered his way past and thru the whole Kinston team aided by splendid interference, to the Kinston 10 yard line.

Wilson and Johnson in the line were towers of strength on defense, and Vich was easily the outstanding player for Kinston. The Greenville team showed enough improvement over last week's fracas to warrant the characterization of a "reversal" and with a similar improvement, should make Roanoke Rapids step lively when they come here next Friday. The largest crowd ever to see a Greenville High School football game attended and thoroughly enjoyed the contest, and a still larger attendance for the coming game, which is a much larger one, will be expected.
