Ask Governor to Release Negro Freed by Fraud

Columbia, S. C., Oct. 14.—(AP)—Backed up by the state supreme court in his contention that a pardon, once given, even though obtained by fraud, cannot be revoked, Ben Bess, Florence county negro, who was freed then recommitted to prison by Governor Richards awaited freedom today. Governor Richards' signature on the release was deferred by the court after its study of the pardon given Bess and then recalled. The official order for the release of the negro was expected to be placed before the governor today.

Cottonseed Crushing Reflects Improvement

Washington, Oct. 14.—(AP)—Cottonseed crushed in the two-month period, August 1 to Sept. 30, was reported by the Census Bureau today to have been 610,715 tons, compared with 465,478 in the same period last year. Cottonseed on hand at mills Sept. 30 totaled 590,747 tons, compared with 567,828 a year ago. Cottonseed products manufactured in the two-month period and on hand September 30 were: Crude oil produced total 184,841,061 pounds, compared with 147,701,004 a year ago, and on hand Sept. 30 totaled 77,338,615 pounds, compared with 68,865,717 a year ago.

Parachute Fails to Open

Washington Court House, Ohio, Oct. 14.—(AP)—Estel F. Boyer, 21, of this city, fell to his death yesterday when a parachute failed to open after he jumped from an airplane at an aerial circus. Boyer was known in aviation circles as "Jumping Joe". His mother saw him fall.

Raleigh, Oct. 14.—(AP)—Illness of Governor Gardner, who is suffering from a severe cold, has caused postponement of formal dedication of the state fair grounds from Tuesday to Wednesday. Governor Gardner expects to deliver his scheduled address at the "home-coming banquet" to be tonight. Physicians advised against attempting both addresses.

Condemn Night Club As Vice Headquarters

New York, Oct. 14.—(AP)—Night clubs and speakeasies are condemned as the headquarters of commercialized vice in New York in the annual report of the committee of fourteen published today.

The committee, which is headed by Dr. James Pederson, was organized 25 years ago to combat vice.

Dr. Pederson said that though night clubs and speakeasies constituted only nine per cent of the committee's 14,399 investigations, they revealed 78 per cent of the violations.

Conditions in the drinking resorts in Harlem, New York's populous negro settlement, where the patronage is mixed white and negro, were described as the worst in the matter of social morality.

Employment agencies which supply female help, hostesses, check room attendants and cigarette vendors to night clubs were linked with the clubs in the course of the committee's investigation. Taxicab drivers were accused of being aides to the traffic.

After disavowing that it has never taken sides on "the vexed question of prohibition," the report says:

"Since the adoption of the eighteenth amendment it is the opinion of the general secretary and the counsel that a law forbidding the employment of women in speakeasies or other places where liquor is permitted to be sold or consumed would be such recognition of these places as to add one more step to nullification."

The report suggests that amendment to the law regulating restaurants might effect the desired result.

To Spend \$9,000,000 to Put Talkies Into Schools of Country

New York, Oct. 14.—(AP)—A program for the expenditure of \$9,000,000 during the next 26 years to put talking pictures into every school room, church and home in the country was announced today by William Fox, motion picture producer and theatre owner.

The announcement was made by Mr. Fox in connection with the celebration of the twenty-fifth anniversary of his entrance into the motion picture industry.

Another feature of his plan is the recording on talking picture films of major operations accompanied by a specialist in the use of medical students, doctors and surgeons.

Mr. Fox said that a system of visual-oral education made possible by films would cut the present six-hour school day in half.

"We shall try to install a talking picture projection machine in every class room in the country. We shall get the best available persons to record a series of lectures on celluloid and distribute them widely.

On the theory that one picture is the equivalent of eight words and that each word uttered by a proved educator is greater in effect than that which is easily understandable how valuable a lesson in geography or arithmetic would be to the student. This is easily appreciated when such men as President Butler of Columbia, President Lowell of Harvard or Dr. Hibben of Yale or any other greater educator lectures on a subject in which he is well versed.

FEDERAL TROOPS RESTORE ORDER AFTER RIOTING

Mexico City, Oct. 14.—(AP)—A Puebla dispatch to En Universal today said federal troops intervened in that city yesterday to restore order after a riot in front of the headquarters of the confederation of revolutionary parties.

Several hundred supporters of Jose Vasconcelos, president candidate gathered in front of the building protesting they had been fired upon while holding a public meeting in the Plaza De La Constitucion, and the disturbances started. No one was injured.

Russian Fliers Disclose Plans for Ocean Flight

Seattle, Wash., Oct. 14.—(AP)—Safe in Seattle after a hazardous flight from Moscow, four Russian aviators today disclosed that they were considering a trans-Atlantic flight as a sequel to their present undertaking, which will be completed when they reach New York.

Worn out by a 1,000 mile flight from Waterfall, Alaska, during which their plane, "Land of the Soviets," battled a 35-mile-an-hour head wind, the four aviators reached here at dusk yesterday. As they rested for the trip, S. A. Shestakov, chief pilot of the plane, revealed that a hop across the Atlantic was under consideration.

If the Russians cross the Atlantic they expect to continue on to Moscow from the west by air, thus making a complete round-the-world flight.

The hop from Waterfall took 10 hours and 10 minutes. Navigator Boris V. Sterlingov said. The plane glided into the air at Waterfall at 7:20 a. m., Pacific standard time, and reached here at 5:30 p. m. Most of the way the ship cleared the waves at an elevation of only 15 feet because of fog and headwinds. The maximum elevation was less than a thousand feet.

The plane followed the irregular shoreline all the way.

Would Junk Monument. New York—The Rev. William Norman Guthrie, Episcopalian, would sigh with relief if three quarters of the public monuments in New York could be junked. He said in a sermon at St. Marks-in-the-Bowry, "unless we make plastic art fit and relevant, make it keep pace with times, retire inspirations of horror from the reach of innocent eyes and employ the highest medium of artistic skill, there will be enacted a prohibition of plastic art."

FALL ACCUSED OF FEIGNING SICKNESS. Washington, Oct. 14.—(AP)—Albert B. Fall was accused in the Senate today by Senator Heflin, Democrat, Alabama, with "feigning sickness" at his trial on charges of bribery.

S. C. Road Bond Legislation Faces More Litigation

Columbia, S. C., Oct. 14.—(AP)—Declared constitutional by the state supreme court sitting en banc, South Carolina's \$85,000,000 road bond legislation apparently faces further litigation with its opponents threatening an appeal to the supreme court of the United States.

Harold Major, county attorney of Anderson county, followed the state supreme court's decision the measure is valid with the statement that an appeal to the nation's highest court would be taken. Later he amended his statement, explaining that further action would await a meeting to be held this week of the measure's opponents.

Passed over bitter opposition in the South Carolina legislature, the road measure had been in the courts continuously since. The state supreme court heard arguments last April. Thirteen judges held the measure constitutional with six dissenting in the opinion handed down Saturday.

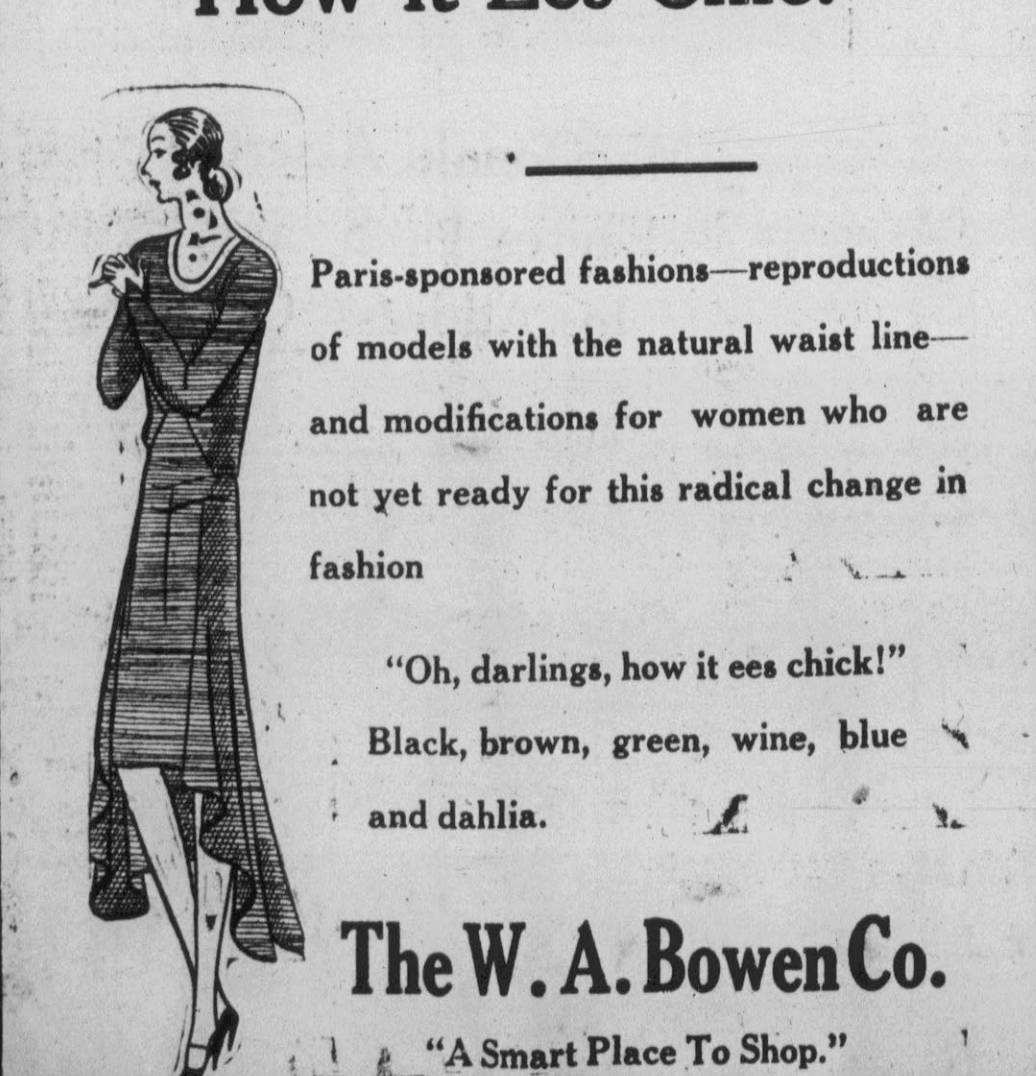
