MANY WANT TO ATTEND GREAT NAVAL PARLEY

President Has Long List of Those Who Want to Represent U. S. at London

Washington, Oct. 16.—(AP)—One of the longest lists of candidates that has confronted President Hoover is that of the prospects in the State Department for posts in the American delegation to the naval parley in London in January.

Since the naval conference became a certainty, the important affairs handled by the State Department have been interspersed with the one question which appears to interest everyone in the department: "Are you going to the arms conference?"

While there have been no indications from the White House regarding the composition of the American commission, the name of Secretary Stimson is the one most mentioned in connection with the position of chief delegate. To assist him, of course, there would be Ambassador Daves, who conducted with Prime Minister MacDonald in London the initial negotiations which culminated in the calling of the conference, and Hugh S. Gibson, American ambassador to Belgium, who has represented the United States at previous arms conferences.

One of the most important members of such a delegation, yet one of which little is heard or written, is the one who serves somewhat as a chief co-ordinator in a large field, holding the organization well together and seeing to it that its functions are well carried out. Actually, this official is the working assistant of the chief delegate.

Two persons have been most prominently mentioned for this position: Theodore Marriner, chief of the western European division of the State Department, who has intimately followed the London negotiations, and Pierre Boal, assistant chief of the division, who has worked closely with Secretary Stimson and Joseph P. Cotti, under-secretary of State in the London negotiations.

Under-Secretary Cotti is one of the few officials who have been dealing with the negotiations, who has held himself completely aloof from all speculation as to the membership of the commission. It is believed that if President Hoover chooses Secretary Stimson to head the American commission he would prefer that the under-secretary remain in Washington for the long consultations which will be necessary between the State Department, Navy Department and White House during the parley. For the same reason, it is doubted that the President would assign both Marriner and Boal to the delegation.

Strikers Wreck Street Car At New Orleans, La.

New Orleans, Oct. 16.—(AP)—Strike sabotage wrecked another street car early today on the Napoleon avenue line in Metairie. The motorcar was lacerated by flying glass but the passengers escaped unhurt. The windows were blown out by the explosion, one of a number of planted dynamites since the car system has been operated by public service with non-union labor since the union men left their jobs July 2.

Mayor Walker Out for Re-Election

New York, Oct. 16.—(AP)—After an old-fashioned Tammany rally of blaring bands and red fire, Mayor James J. Walker today was formally launched on his campaign for reelection on a platform of past performances with all "mud-slinging" tabooed.

At a rally at Tammany hall at which all the democratic candidates spoke and were roundly cheered, former Governor Alfred E. Smith was given probably the greatest ovation of them all when he urged retention of the Walker administration to fulfill the public improvement program started by it.

Small Prices Feature Sale of Heirlooms of Princess Victoria

Bonn, Germany, Oct. 16.—(AP)—When the auction of the heirlooms belonging to Princess Victoria, sister of the former Kaiser, was resumed today, exceptionally small prices offered yesterday were continued. A magnificent dinner service for 24 persons presented by Victoria's father by the city of Berlin on the occasion of his silver wedding brought only 30,000 marks (about \$7,500).

Million Pounds of Leaf Sold on Local Market Yesterday

The Greenville tobacco market disposed of approximately a million pounds of tobacco yesterday, according to the official report of K. W. Cobb, supervisor of sales, made public this morning.

It was stated that there was about a million pounds of leaf on the floors of the nine warehouses today with the price situation similar to that of yesterday.

HEAD OF CULT IS HELD IN JAIL IN CALIFORNIA

Mrs. May Blackburn Charged With Twelve Counts of Grand Larceny

Los Angeles, Oct. 16.—(AP)—Mrs. May Otis Blackburn, high priestess of "The Divine Order of the Royal Arm of the Great Eleven," was held in jail today in default of \$70,000 bail for trial in Superior court on twelve counts of grand theft brought by Clifford Dabney, wealthy oil operator and former member of the religious cult.

Mrs. Ruth Welland Blizzo, daughter of Mrs. Blackburn and second priestess of the organization, was released yesterday when a municipal court judge ruled the evidence against her was insufficient to warrant action.

Mr. and Mrs. William P. Rhoads, cult members held in connection with the death of Willa Rhoads, their foster daughter, were released on orders of Captain Ray Cato, the police investigator. Cato said there was no evidence tending to show that the girl, whose death was concealed for three years, died of unnatural causes.

The cult came under fire of city and county authorities recently when Dabney filed charges that Mrs. Blackburn and her daughter plotted him of nearly \$400,000 publication of "The Sixth Seal," a cult book under preparation, which they asserted would reveal all the secrets of nature, including the location of precious minerals.

Assistant Secretary Of The Interior Speaks At N. C. State Fair Today

Raleigh, Oct. 16.—(AP)—North Carolina has seen within its borders within the past 30 years the greatest changes for betterment of any state in the United States, Joseph M. Dixon, assistant secretary of the interior and United States senator of Montana, told an audience of several thousand persons at the state fair grounds today.

Mr. Dixon, a native of North Carolina, brought personal greetings to the State from President Herbert Hoover, who was invited to attend the home-coming week celebration but could not arrange his plans to be present.

The address of Mr. Dixon followed the dedication of the new state fair grounds and buildings with Judge N. A. Townsend, executive counsel, as the speaker.

The dedication of the grounds was postponed from Monday until today in hope that Governor O. Max Gardner, who has been suffering from a cold and sore throat several days, would be able to speak. The governor was up today at the mansion but was not able to attend the exercises at the fair grounds.

Tomorrow home coming and fair week will continue with the Wake Forest-N. C. State football game as the key attraction here. Friday the scene will shift to Durham for the Durham-Duke Day and Saturday it will shift to Chapel Hill for University of North Carolina Day.

Mr. Dixon, paying tribute to the industrial and mental progress of the State of his birth, said that the rest of the country, by common consent, has already awarded North Carolina the blue ribbon for the greatest achievement in the matter of road building in the whole union.

"During the past few years," he said, "we who now live in other states have heard much of what you, who stayed at home, have been doing in North Carolina."

"I have had the pleasure of enjoying your splendid roads," he continued, "but I have taken a greater pride in knowing what you have done in the matter of the

BRITISHER AND PARTY ON VISIT TO CANADIANS

Prime Minister MacDonald Attends the Convention of Federation of Labor

Toronto, Oct. 16.—(AP)—A visit to the convention of the American Federation of Labor in session here was the first engagement today for J. Ramsay MacDonald, British Premier.

Mr. MacDonald, with his daughter Ishbel and their party, arrived here yesterday from Niagara Falls for a stay of one day on their way to Ottawa.

At Ottawa the prime minister expects to take up with MacKenzie King, Canadian premier, discussion of the Dominion's part in the peace program which was the subject of Mr. MacDonald's talks with President Hoover.

The leader of the British labor party planned to address the American Labor delegates briefly. His chief speech of the day was arranged for the luncheon of the Men's Canadian club. Miss MacDonald accepted an invitation to speak at a luncheon of the Women's Canadian club.

After ceremonies at the University of Toronto which conferred an honorary degree upon Mr. MacDonald, he and his daughter planned to attend a reception arranged in their honor by the Ontario government.

A dinner at government house concluded the program for the visitors. A special train leaving at midnight will take them to Ottawa.

In an interview on the train from the American border, Mr. MacDonald emphasized that no "theatrical announcements" should be expected as a result of his visit to the United States. His informal discussions with President Hoover he said had created a proper atmosphere in which to conduct future negotiations.

Soviet Nationals On Hunger Strike

Tokyo, Oct. 16.—(AP)—A Rengo news agency dispatch from Harbin, Manchuria, today said approximately 2,000 Soviet nationals held in the Siben concentration camp near Harbin had begun a general hunger strike in protest at alleged unbearable conditions and inhuman treatment.

Mr. Dixon, recalling his visit to the State last year for the celebration at Guilford court house battle ground July fourth, and his trip for two days through half a dozen Piedmont counties, told of his amazement at the forward steps the section had taken. There were modern farm homes replacing dilapidated houses of olden times; pure-bred cattle where in former years there was only scrub "penny-rile"; modern cities where sleepy villages were 38 years ago; the whirl of industry could be heard on every side; and there were up-to-date school houses, churches and public buildings seen in every town and village.

"When I had finished my journey, I said, 'continued Mr. Dixon, "Surely the age of miracles has not yet passed!"

Another thing, aside from the material prosperity and which Mr. Dixon said gave him greater satisfaction, was a broader, more liberal, more tolerant spirit found in the minds and hearts of the men and women of North Carolina. With this broader spirit and with the natural advantages of North Carolina there is no limit to what North Carolinians can accomplish in the future, he added.

Concluding with an urging that North Carolina make its home coming week a permanent annual celebration, Mr. Dixon said that he felt certain that if Horace Greeley could be resurrected from the dead and again be permitted to survey the whole field of human opportunity in these United States, he would want to revise his famous aphorism from "Go west, young man," to "Go to North Carolina, young man."

Labor Federation Voices Opposition To Universal Conscription During War

Toronto, Ont., Oct. 16.—(AP)—Without dissent or debate the convention of the American Federation of Labor today expressed its opposition to measures pending before congress for universal conscription in time of war.

It adopted a resolution committee report declaring it to be essential as an evidence of good faith to the world that the American people shall, at least for the present, refrain from war-like preparations in the enactment of legislation.

Conscription of labor in war time, it added, would mean that "trades unions would be dissolved."

A traditional policy of American labor, committing the federation to a non-partisan political position, was re-affirmed by the convention without debate. It called upon "all trade unionists to prepare to participate in the next congressional election under the old plan of supporting 'candidates friendly to labor, and opposing its enemies.'"

It warned delegates that "if labor ceases to eliminate labor injunctions from the federal courts, it must have friends in congress," and called for "most energetic activities by unionists throughout the United States," in the 1930 campaign.

Expenditure of \$70,000 By Beat Sugar Company Written Into Records

Washington, Oct. 16.—(AP)—An annual expenditure of \$70,000 by the United States Beet Sugar Association with headquarters in Washington was listed today before the senate lobby committee by H. A. Austin, secretary and treasurer of the organization.

Appearing as a witness at the committee's second day of inquiry congress in drafting the tariff bill, he testified that during the first nine months of this year the association had expended approximately \$56,000, and that of this much had been contributed to publications and pamphlets relating to sugar production.

Senator Walsh, democrat, Montana, asked if "the real purpose" of the publications was not to spread the idea of high tariff, but Austin insisted this was "only incidental."

The witness also said a number of "press releases" had been sent to Washington newspaper correspondents and to newspapers throughout the country.

It was estimated by Austin that 90 per cent of the sugar production in the country was represented in the association.

Before turning to the sugar tariff lobby, the committee recalled Frederick L. Koch, tariff commission expert, to ask if the pottery industry had protected his testimony at a secret hearing of the republican members of the house ways and means committee when that group was framing the tariff bill. FOSTER BAIN TESTIFIES IN BRIBERY CASE

Former Director of Mines Says Fall Was Aware of Elks Hill and Harbor Leases

Washington, Oct. 16.—(AP)—H. Foster Bain, director of the Bureau of Mines in the Harding administration, testified today that Albert B. Fall had let his subordinates in the interior department understand that no final oil leases could be negotiated without his approval and that the Elks Hills and Pearl Harbor propositions had been submitted to him.

He said the Elks Hill-Pearl Harbor papers were sent to Fall at his New Mexico ranch by E. C. Finney, first assistant secretary of the interior.

The witness testified he had told all the Pan-American Petroleum and Transportation Company was the only firm which would bid on the whole contract. This, he said, was before Fall left Washington several days prior to the opening of bids.

Bain said before Fall went west the secretary showed him the contract awarding the Teapot Dome Oil Reserve to the Mammoth Company of Harry F. Sinclair. At a conference prior to the awarding of the main Elks Hill lease on December 11, 1922, the preferential right contained in the Pearl Harbor contract was awarded, Bain said.

On direct examination Bain testified that the actual contract had not been seen by Fall until he signed it and that Fall was not familiar with the terms.

The papers in the negotiations were sent to Fall after the bids were opened and before the contract was signed, he testified.

A. W. Ambrose, of the Empire Oil Company of Bartlesville, Oklahoma, formerly chief of the petroleum division of the Bureau of Mines, followed Bain on the stand. He corroborated Bain's testimony as to early Pearl Harbor negotiations.

Clear Up Mystery of Woman's Death At New Bern, N. C.

New Bern, Oct. 16.—(AP)—Mystery surrounding the discovery of the body of Mrs. Elizabeth Hinson, of Durham, in an abandoned automobile back of a New Bern garage was cleared up last night with confession of two young men of Bayboro that they left her there.

Roman V. and Frank R. Ewell, both married, told Coroner J. R. Latham that they had been riding with John W. Hinson and his wife, Hinson became abusive and attacked them with a knife, they said. Then, they related, they forced him from the car, but his wife refused to get out.

After riding a while (they said Mrs. Hinson agreed to get out of the car and they left her back of the garage. She was intoxicated, they said, but appeared to be rational.

Coroner Latham, after an examination of Mrs. Hinson's body, found yesterday morning, said she died of exposure and acute alcoholism. The two Ewells were released.

F. Aderholt, chief of police of Gastonia, and three other policemen.

He alleges that his fee was to be paid by the International Labor Defense and the individuals named in the suit.

Four Killed In Auto Accidents At Charlotte

Charlotte, Oct. 16.—(AP)—Automobile and automobile-train accidents in Charlotte late yesterday and last night took a toll of four lives.

SHOOTSWOMAN TO DEATH AND THEN SUICIDES

Bodies of Man and Woman Are Found in Room At Inn At Wallingford, Conn.

Wallingford, Conn., Oct. 16.—(AP)—Police were convinced today that Mrs. Anna Bryan Ayres, advertising expert who earned \$100,000 a year, had been shot to death by William Gaylord, a bookkeeper, who then killed himself. Their bodies were found yesterday in a room at an inn.

Mrs. Ayres, 41, was the divorced wife of Ernest Ayres, former Amherst professor, and mother of three children. Her home was in West Haven. Gaylord, 46, lives in East Hartford.

The bodies, with bullet wounds in their temples, were found by Robert Hyatt, manager of the inn, who broke down the door of the room after repeated efforts to get an answer from the couple had failed.

The tragedy climaxed an infatuation which had its inception last summer and which brought a proposal of marriage from Gaylord, who planned to divorce his wife. Letters to Mrs. Ayres from Gaylord found in the room indicated she had refused to marry him. She was advertising head of the Berger Brothers corset factory in New Haven.

Mrs. Ayres and Gaylord registered at the inn Monday night as Mr. and Mrs. W. S. Gray of New Haven. Dr. John H. Buffum, medical examiner, said murder and suicide had occurred four or five hours after the couple went into their room.

Mrs. Ayres' body was found in a chair. Sprawled at her feet was the body of her companion. Two empty shells were found in a revolver. The room contained numerous cigar and cigarette butts, but there was no evidence of a struggle.

The close of the defense case came without warning and found the State apparently unprepared. Attorney E. C. Cansler for the prosecution sought a recess until this afternoon in order to prepare for rebuttal but Judge M. V. Barnhill, presiding, refused but allowed 15 minutes for conference.

The defense closed without putting Clarence Miller, New York communist educator; Joseph Harrison, Passaic, N. J. union organizer; Louis McLaughlin, and W. M. McGinnis, Gastonia strikers and defendants on the witness stand. Of the defendants, only Fred Erwin Beal, of Lawrence, Mass., formerly a southern organizer for the national textile workers union, George Carter, Mizpah, N. J. union member,

Four Killed In Auto Accidents At Charlotte

Charlotte, Oct. 16.—(AP)—Automobile and automobile-train accidents in Charlotte late yesterday and last night took a toll of four lives.

Mrs. Ruth Pruitt and her mother Mrs. Margaret Wright, were injured fatally when their automobile was struck at a grade crossing in the rear gate of the mill when a sandwich truck drove up. Beal, he asserted, told strikers to turn the truck over to private property and did not touch it.

LEW FONSECA VOTED BEST 1919 PLAYER

New York, Oct. 16.—Lew Fonseca, Cleveland first baseman and new batting champion of the American league, is the "most valuable player" of the league for 1929, based upon the decision of a committee of baseball writers representing each city in the circuit.

At the request of the sports editor of the Associated Press, this committee named by the baseball writers covering the world's series, cast its ballots in the absence of an official selection by the American league, which abolished this year the award it had made annually since 1922. The National league makes its last official selection this year, to be announced later.

Fonseca won the unofficial contest from contenders in the ranks of the world's champion Athletics because he was rated high on seven of the eight lists prepared by the baseball experts.

Jimmy Dykes, whose all-around infield play was a vital factor in the success of the A's, was the favorite choice among the Mackinnon and finished second in the vote. Al Simmons, Jimmy Fox and Mickey Cochrane also figured high, causing "split ballots" that kept any one member of the champions from heading off Fonseca.

Fonseca, although receiving only one vote for first place, had three votes for second place, two for third and one for fourth to make up his total of 46 points. Dykes received three ballots for first place and one for second place, totalling 31 points. Simmons was the first choice of two experts, Fox and Cochrane of one each. Cochrane won the 1928 official award.

Henie Manush, St. Louis outfielder and runner-up to Cochrane last year, placed third with 26 votes. Charley Gehring, of Detroit, was fourth with 25 and Joe Judge, veteran Washington first baseman, fifth with 24.

Tony Lazzeri, second baseman, topped the Yankee choices with 22 votes but Bobo Ruth, 1925 winner, was just behind him with 19. Lou Gehrig, who won the official award in 1927, did not get a single vote. Twenty-one players figured in the voting.

The members of the committee casting ballots for the American league's "most valuable player" for another year through the Associated Press: Harry G. Salsinger, of Detroit; John B. Keller, of Washington; John C. Hoffman, Chicago; Fred C. Frick, New York; Gordon Cobblestick, Cleveland; Paul Shannon, Boston; S. C. Jeener, St. Louis; William Dooley, Philadelphia.

Brown, which uncovered a great passing combination in Fogarty and Edwards to nose out Princeton last week, takes on another "Big Three" team in Yale and may advance the 32-14 the Ellis-plastered on the Bruins last season. Yale's modernized offensive worked well enough against Vermont but got nowhere against Georgia.

Columbia trailed Dartmouth by two touchdowns in 1928 but the Lions feel their turn is about here. If Dartmouth has an Al Marsters, Columbia points with pride to a Ralph Hewitt.

Cornell, after some years of football dependency, is looking up and expects to hand Bill Roper's Princeton Tigers a beating to match the 3-0 reverse it suffered last season.

Washington and Jefferson, back in the limelight after an absence of a year, may jolt a Carnegie Tech team that does not look quite so strong as the one that turned back the Presidents 19-0 last fall with Howard Harpster chiefly responsible. Harpster has graduated.

DANCERS GIVE FINE PROGRAM IN THIS CITY

Isadore Duncan Dancers Please Audience in Appearance at the College

The Isadore Duncan Dancers, with Irma Duncan as the leader and ten young Russian girls, last night at East Carolina Teachers College, gave one of the loveliest and most artistic entertainments ever seen in this part of the state. Naturalness, spontaneity, vitality, as well as grace and charm, characterized their dancing. From the first dancer that stepped out in the first number "slow march" from Schubert, to the last one leaving the stage with the happy shout of "ras, dwatre," at the end of the last number the Russian Girls Scout Song, the audience was entranced. The central figure and guiding spirit throughout was Miss Tamara Duncan, who is worthy of the mantle of the great Isadora Duncan, whose work she is carrying on.

In the "Scenes from Childhood" the happy and joyous spirit of ten girls broke forth into natural play, as they skipped the rope, played "Blindman's Buff" and "Soldier's March." Again they danced with the same freedom and naturalness in the Russian folk songs, making one feel that children are children whether in Russia or America. Their beautiful singing added to the effect of the Russian groups.

In the groups of Schubert, Schumann, and Chopin numbers they danced through the range of all possible interpretations of waltzes, mazurkas, and expressed every kind of feeling through dance, but the greatest of these was the "Polonaise" by Chopin.

The climax of the evening was the group of "Impressions of Modern Russia," at the end of the program, and the finest of these was the work song. These seemed to breathe a spirit of optimism and hope that made the audience feel that young Russia would rise to greatness out of the old.

Maurice Shyne, the pianist, was the magician that seemed to bring the dancers to life and motion.

Irma Duncan richly deserves the tributes paid her. She is the gracious woman, the marvelous teacher the fairy god-mother to these girls. She said that they had been with her since childhood, some of them for seven years. The little Tamara, who is fourteen, has been with her since she was six years old. The girls are carefully shielded and looked after. They looked almost like children as they stepped off

the train, all dressed in grayish blue sport coats and tam caps, and modestly stepped together. They speak broken English, but are proud of the words they know. They seemed as delighted at their novel experiences as the college girls were at seeing them. They quickly adapted themselves to whatever came along. They managed their exits and entrances without a curtain as well as if they had never had one.

Three of the greatest groups of dancers appearing in America have appeared on the college stage, and no two the least bit alike and yet all expressing high ideals of the art. The most natural, the most spontaneous and perhaps the most genuine of all were the young dancers who appeared last night.

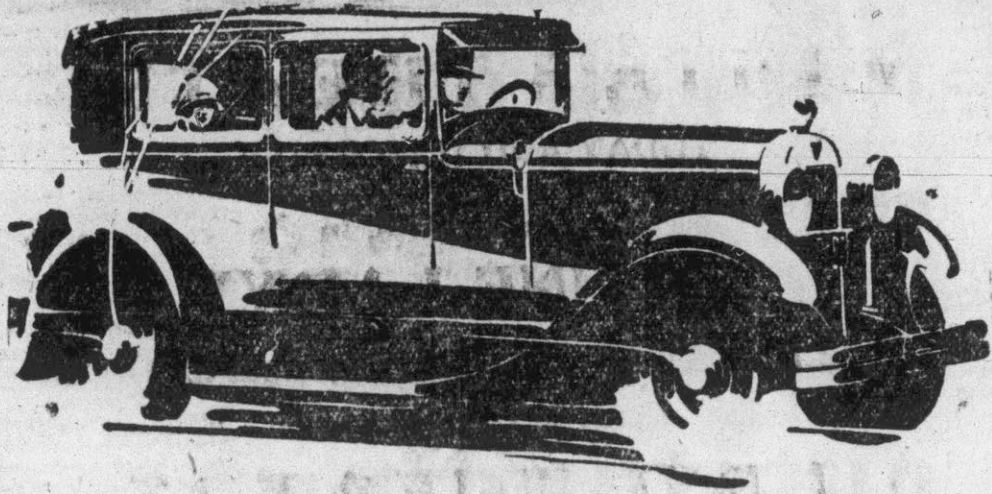

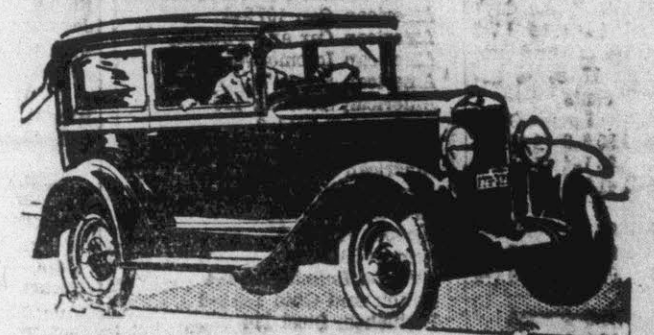

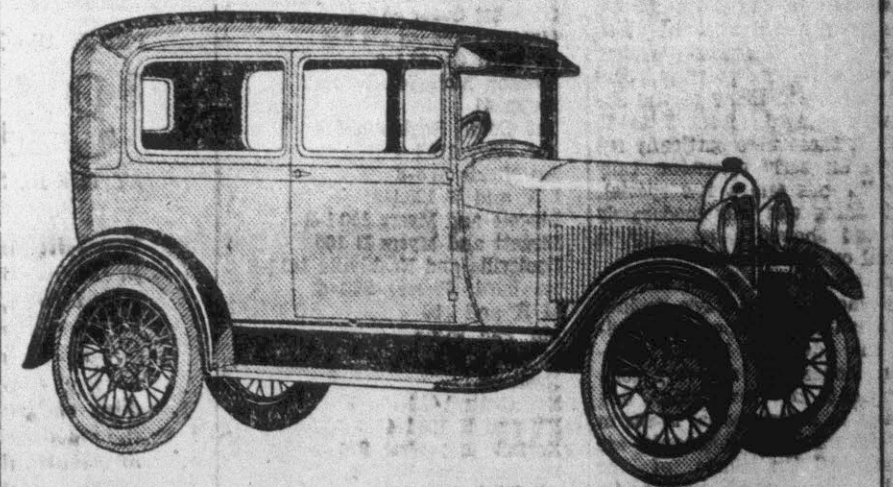

STOCK MARKET

New York, Oct. 16.—(AP)—The secondary reaction, which started yesterday in the stock market resumed today, with the steel and public utilities again feeling the brunt of selling pressure. Extreme declines in many of the active issues ranged from 3 to 15 points but these were particularly cut down in an early afternoon rally led by the oils and a few specialties. Trading was only moderately heavy and showed a tendency to turn dull on the rallies.

Short selling was again an important factor in the day's decline. Many small traders apparently followed the advice of leading commission houses in reducing long commitments or restricting new purchases to a few special issues in which favorable developments are pending until the course of the market becomes more clearly defined. Pools succeeded in marking up a few issues to new high records, including electric storage battery, corn products, Timken roller bearing and International Paper & Power A and B.

Call money renewed at 7 per cent, which rate is expected to be maintained all day, but time money rates held steady.

While the action of the Massachusetts Public Utilities commission in denying an application of a Boston company to split up its common stock has no direct effect on any securities listed on the "Big Board" the stingy nature of the commission's decision has had a bad psychological effect on all high priced public utility stocks.
