FARM BOARD CONFIRMED BY THE SENATE

Eight Men Fully Empowered to Go Ahead With Work of Helping the Farmers

Washington, Oct. 17.—(AP)—The eight men appointed to the Federal Farm Board by President Hoover today were formally and fully empowered to go ahead with their task of bringing prosperity to the American farmer.

Senate confirmation, the last obstacle to the administration's desire for a board of its own choosing to carry out a broad and significant program of its own designing had been successfully removed.

All were approved early last night after the senate had laid aside the tariff debate and devoted a full day to discussing their respective merits and qualifications for the important posts to which the chief executive had appointed them.

Opposition to the appointment of Mr. Hoover's appointees, Alexander H. Leeger, representing the office of finance and business, Samuel P. McKelvie, spokesman for the grain growing industry, and Carl Williams, cotton representative, developed but was unable to block the confirmation.

Democratic members for the most part joined the administration in supporting the Hoover appointees. Senator Robinson of Arkansas, the Democratic leader, voted for all of them, and expressed the attitude of his party. Leeger with an assertion that "responsibility must rest with the president" and "the president" gave the men he had asked to administer the act which he had sponsored.

Russian Fliers To Take Off for Oakland, Calif.

Seattle, Wash., Oct. 17.—(AP)—Weather permitting, the four Russian aviators flying the "Land of the Soviets" from Moscow to New York planned to take off today for Oakland, Calif., first stopping point of the final long hop across the United States.

The giant Russian monoplane, equipped with pontoons for flying across the Pacific, was converted here into a land plane and the take off for Oakland was delayed after dawn so a test flight might be made.

Officials of the Mackay Radio and Telegraph company announced they would broadcast the weather reports every 30 minutes for the benefit of the fliers during their trip to Oakland.

Seattle, which has served as host to the fliers since they landed here last Sunday from Waterfall, Alaska, bade them farewell last night at a public gathering sponsored by the friends of the Soviet union.

FLYING BOAT IS OFF FOR BUENOS AIRES

The "Buenos Aires" Leaves Washington On Maiden Voyage to South America

Washington, Oct. 17.—(AP)—The giant flying boat "Buenos Aires," of the New York Rio and Buenos Aires line, took off from the naval air station here shortly before six o'clock for the first stage of a flight of which Buenos Aires is the ultimate destination.

Lieut. William S. Grooch, first pilot, just before swinging the great craft out onto the Potomac for the beginning of its maiden voyage said he expected to make Charleston, South Carolina, shortly before 11 o'clock, refuel there, and take off immediately for Jacksonville, reaching the Florida city by night.

The 20-passenger flying boat with its load of four passengers, company officials, and extra gear will not attempt to maintain a schedule but November 10 has been set as a tentative date for its arrival in Buenos Aires.

The "Buenos Aires" was christened by Mrs. Herbert Hoover shortly after its arrival in Washington two weeks ago, at a ceremony in which the heads of the diplomatic missions of 21 Latin-American nations participated. It is the flagship of a fleet of 12 similar flying boats which are destined for passenger service between New York, Rio de Janeiro, and Buenos Aires within the next year.

TEN THOUSAND MINERS STRIKE IN BELGIUM

Brussels, Oct. 17.—(AP)—Twenty collieries employing 10,000 workers have been tied up by a strike of 3,000 miners in the Mons district whose demands for increased wages were not fully met. The miners obtained increases of 3 per cent and 5 per cent but they had asked 5 per cent and 10 per cent.

A serious coal shortage in Belgium is predicted unless difficulty is settled immediately, the coal stocks now being less than 300,000 tons.

Record Attendance for Thursdays Expected to Be Set At Raleigh Today

Raleigh, Oct. 17.—(AP)—With before noon crowds indicating that attendance at the State fair today would set an all time record for Thursdays, North Carolina's home coming celebration and fair week reached its climax in Raleigh today.

Though the State fair will continue in full blast, and with added attractions, through Saturday night the home coming will shift tomorrow to Durham.

Starting Sunday and continuing through yesterday home coming Religious services, banquets and addresses have held the center of the stage in the State capital but today the Wake Forest-North Carolina State football game and the fair itself were the centers of attraction.

Tomorrow will be Duke-Durham day at Durham with the home coming visitors guests of the city of Durham and Duke University and spending the day visiting the University and various industrial plants of Durham, including cigarette factories.

Saturday the center of home coming attention will shift again, going to Chapel Hill for University of North Carolina day. The dedication of the new \$625,000 library there and the North Carolina-Georgia football game will be the chief features.

Fair authorities at noon today reported that crowds had been pouring into the grounds all morning in almost unprecedented fashion.

All State, county, and city offices except the State Corporation commission, all banks and many business houses and offices observed the day as a holiday to allow employees to go to the fair and football game. Tonight there will be a boxing show with the participants in the main bouts all from North Carolina and Virginia. The feature bout will bring together Cliff Wellons of Fayetteville and George Rohanna of Norfolk.

The new features of the State fair today were the agricultural students fair of State college, "a fair within a fair," and the opening of the dog show.

With these continuing tomorrow and all of the other features, including the last day of horse racing, Raleigh city schools will give a full day holiday so that the children may attend the exposition.

Saturday automobile races sanctioned by the American Automobile association will hold the center of the stage.

Giant Rum Syndicate With Fortified Arsenal Nabbed Along The Atlantic Coast

New York, Oct. 17.—(AP)—A fortified arsenal equipped with emplacements for its battery of machine guns and used as headquarters for a \$1,000,000 rum smuggling syndicate was today after a surprise attack on the syndicate extending along the Atlantic coast from here to Atlantic City, N. J.

A mile from the armed base of operations at Highlands, N. J., the raiders found tunnels leading to underground vaults in which liquor was stored and where a quantity of small arms were hidden.

The vaults on top of the mansion were equipped with telescopes and apparently was used as a lookout tower from where the smugglers could watch for their craft.

One of the raids was made on what the agents said was the New York headquarters of the syndicate, in West 43rd street. Here, the federal men said, members of the organization met regularly to divide the profits of the business and discuss plans. The other raids were on landing stations, storage houses and distributing points.

Patrick Connors, a clerk at the Ambassador hotel in Atlantic City, was arrested as a contact man for the syndicate.

William J. Calhoun, prohibition administrator for New Jersey, who was in charge of the raids in his state, said the syndicate was a "million dollar outfit" which operated a fleet of six ships between St. Pierre and Bermuda and an auxiliary fleet of ten speed boats.

The ships passing close inshore along the New Jersey coast were met by the speedboats, which took off cargoes of liquor and ran them ashore. Unofficial estimates placed the amount of liquor brought in at 10,000 cases a week.

Alleged members of the gang were arrested by federal agents in several New Jersey towns and taken to Trenton for arraignment.

SEVEN BURN TO DEATH IN HOTEL FIRE

Seattle, Wash., Oct. 17.—(AP)—Trapped by flames, seven persons lost their lives and twelve others were burned or otherwise injured in a fire that swept through the Portland hotel here early today.

Firemen believed that all bodies had been recovered from the ruins. Several of the injured were in a critical condition and some were not expected to live.

The cause of the blaze was undetermined. Firemen said the seven who perished probably had suffocated while they slept. None could be identified at once. The building was an old brick structure.

The hotel was operated by U. Okada, a Japanese, whose wife was critically injured when she leaped from a third story window. The dead were all white persons.

TESTIMONY OF DENBY IS READ IN FALL CASE

Detailed Statement of Former Naval Secretary Placed Before Jury

Washington, Oct. 17.—(AP)—Testimony given by the late Edwin Denby, former secretary of the navy, taking responsibility for the awarding of the Elk Hills-Pearl Harbor contract to the Pan-American Petroleum and Transport company today was read to the jury hearing the bribery trial of Albert B. Fall.

Fall is charged with having accepted \$100,000 from Doherty for awarding the contract to the Pan-American.

Denby's testimony, as given in the Fall-Doherty conspiracy trial, was placed before the jury in its entirety. In it he had testified he asked the late President Harding to issue an order transferring jurisdiction over the naval oil lands to the Department of the Interior.

"I took the responsibility," Denby said, "and made the leases whether I wanted to or not."

LOCAL CASES DISPOSED OF AT RALEIGH

Lancaster Case Affirmed by Supreme Court; Townsend-Holderby Reversed

The supreme court at Raleigh yesterday handed down two decisions of more or less interest to people in this section, in that they were sent up to the higher court following verdicts obtained in Pitt county superior court several months ago.

The cases were those of the Town of Ayden against Lancaster and Townsend against Holderby.

In the first case the supreme court affirmed the opinion of the lower court with modifications. The modifications were said to involve only a description of the property which was omitted in the final summing up of the action.

In the Townsend case the court reversed the decision of the local court, in which Mrs. Townsend was awarded damages of \$17,500 for alleged alienation of affections of her husband by members of her family. This case held sway in the local court for several days, and its final disposition was received with general interest in the Farmville community where it originated.

The Ayden case involved condemnation proceedings of a piece of property for use as a cemetery. The property was owned by Mr. Lancaster, and it was contended that the price offered by the city commissioners was not sufficient. The town went out in the final hearing here sometime ago, the court holding that the price offered by the commissioners was reasonable.

Four Men Indicted for Flogging At Gastonia; Trial Opens at Concord

Concord, Oct. 17.—(AP)—Indictments today were formally returned by the Cabarrus county grand jury against four employees of Gastonia cotton mills on charges of kidnaping and flogging Ben Wells, British textile worker, and C. D. Sayers and C. M. Leil, Gastonia men. Trial of the case was expected to be started this afternoon.

The men indicted were O. G. Morehead, William Pickering, Carl Holloway, Dewey Carver, Smiley Lewis, Tom Carver and Horace Lane. These men were held after an investigation by Judge Thomas J. Shaw sitting as a committee magistrate. They were ordered to appear in the Cabarrus Superior court on Oct. 14 and in Gaston Superior court at Gastonia on Oct. 21.

Just before court recessed for lunch Solicitor Zeb V. Long told Judge A. M. Stack presiding, that he intended calling the flogging cases immediately after lunch. L. Z. Hartsell of defense counsel, told

the judge that he did not know whether or not the defense counsel could get ready as one of their important witnesses was tied up in the Aderholt murder case at Charlotte.

The judge told the defense to confer during lunch hour and ascertain whether or not they could get ready.

Seven men originally were held at the close of Judge Thomas J. Shaw's inquiry at Charlotte and Gastonia, Charlotte and Cabarrus county mob violence but the jury failed to find evidence sufficient to indict against William Pickering, Smiley Lewis and Tom Carver. True bills were found against O. G. Morehead, Carl Holloway, Dewey Carver and Horace Lane.

The seven men originally held were ordered by Judge Thomas J. Shaw at Charlotte to appear in Cabarrus Superior court on Oct. 14 and in Gaston Superior court at Gastonia on Oct. 21.

The indictments grew out of anti-Communist disorders starting in Gastonia and Charlotte.

Flood Waters Recede Around Miami, Florida

Miami, Fla., Oct. 17.—(AP)—The Flood waters, which for several days have covered Hialeah, Miami suburb and hundreds of square miles of out lying territory, were receding today.

While there has been no appreciable recession of the flood in Hialeah proper, other points, and acres of inundated lands out toward the everglades territory, have reported that gradual declines in water marks have been noted.

SAYS HOOVER WILL APPROVE NEW TARIFF

Borah Predicts Passage of Measure Acceptable to the President

Washington, Oct. 17.—(AP)—Senator Borah of Idaho said after a call on the White House today that he believed a tariff bill would be passed by Congress in a shape which would be acceptable to President Hoover.

"His conference with the President only lasted a short while. Borah later said at the capital that the President had indicated that he could not pass the tariff bill. It was recalled that it was Mr. Borah's first visit to the White House since before the debate on the tariff bill.

The Idahoan did say he thought the Senate would pass the tariff measure this session, perhaps by November 20, but believed final action on the conference report would be delayed until the regular session in December.

"We want to see a bill passed in the shape we want it and we think we can shape it," he asserted. "Do you believe it will satisfy the farmer?" he was asked.

"I think it will if it ever passes," he replied.

Borah reiterated that the western Republicans would do all they could to hasten action by the Senate.

Mrs. Richards was a native of Pitt county and had spent all of her life in the Grimesland community. She was a member of the Methodist church and took an active interest in church work.

Kvale Succeeds His Father to Seat in Congress

Willmar, Minn., Oct. 17.—(AP)—Minnesota will continue to have the only farmer-labor party representative in the lower house of Congress.

Paul J. Kvale of Benson, Farm-Laborite, was chosen Congressman from the seventh Minnesota district at a special election yesterday and will succeed his father, the Rev. O. J. Kvale, also of that party, who was burned to death in a summer cottage fire last month.

Kvale, who is 33 years old, defeated James C. Morrison of Morris, Republican, by more than a two to one vote, getting approximately 21,000 votes to 8,500 for his opponent in the 14 counties in the district.

The new Congressman will serve until March, 1931. He had been his father's secretary and campaign manager ever since Mr. Kvale was elected in 1922. Before that he had been editor of the Swift County News at Benson. Young Kvale served in France with the A. E. F. Kvale's father, a former minister, was the man who defeated Andrew J. Volstead, author of the prohibition enforcement act.

SEN. BINGHAM TESTIFIES AT LOBBY PROBE

Washington, Oct. 17.—(AP)—Senator Bingham, Republican, Connecticut, testifying today before the Senate Lobby committee, regarding his employment of an official of the Connecticut Manufacturers association, said he had never regarded that body as a lobby organization.

The official referred to, Charles L. Eyanson, was expected to be called later in the day. "As an employee of Bingham he appeared at the executive meetings of the Senate Finance committee at the time the tariff bill was under consideration.

At the outset of the day's session, Chairman Caraway asked Bingham if he desired to make a statement and the Connecticut Senator said the activities of the Manufacturers association chiefly had concerned manufacturing problems.

"The only time I know of the organization being in Washington was when the tariff bill was before the House Ways and Means committee," Bingham continued. "They had an observer present at the hearings in the House."

"Connecticut is vitally interested in the tariff, consequently, when I was put on the Finance committee I felt the great importance of having a knowledge of everything that the state needed in the way of tariff rates, not only for industry but for agriculture.

"Knowing some of our industries needed help I decided to get the best expert I could find to help me."

Bingham then read a letter he wrote to E. Ken Hubbard, president of the Connecticut Manufacturers association, asking him to "loan" a man to assist him on the tariff bill.

Bingham praised the work done on his part and said "if any one ever served a Senator loyally, it was he."

"Except he was serving two masters," observed Senator W. A. Dennis, Democrat, Montana.

"Senator Walsh, I don't think it is fair," replied Bingham.

"He worked as hard for the fisheries as for the manufacturers."

At the same time, he was your aid and assistant he was being paid by the manufacturers association."

"Certainly, there is no secret in that," Bingham said, adding if there is anything wrong with it the fault is mine."

"Well, do you think there was anything wrong with it?" asked Caraway.

"Possibly I made a mistake," said Bingham. "Had I known that it was considered proper for government employees who were hired to do one job to be used by Senators to help do another job, he probably would not have asked the manufacturers association to 'loan' a man."

AN EVER-GROWING PROBLEM.

Automobile accident legis-
lation fails to strike at the
root of the problem. Liability
insurance, which all should
carry, indemnifies but can-
not prevent accidents.

In most cases driving laws
are antiquated, inadequate,
and are laxly enforced. As
a result incompetent and
careless drivers crowd the
public highways, an ever-
present menace to the lives
of all of us.

Licenses to operate a mo-
tor car are usually granted
without examination, or
without inquiry into the fit-
ness of the applicant. Only
a few of our states surround
the issuance of licenses with
any restrictions. The compe-
tent and incompetent, the
reckless and careful, the
law-breaking and the law-
abiding, are treated alike.

It is no wonder that under
such circumstances the acci-
dent toll continues to mount.
We can never check this de-
vastating record until our
laws refuse the use of pub-
lic highways to drivers who
have been proven incompe-
tent or chronically reckless.

PRACTICAL TAX REDUCTION PLAN.

Governor Roosevelt of
New York, will place before
the next legislature a plan
for consolidation of local
units of government in the
state with a view to reduc-
ing taxes. He says that at
least 99 per cent of the
towns could save great sums
for the taxpayers if they
were reorganized along
modern business lines.

He plans to consolidate
small school districts which
will provide double advan-
tages of giving pupils better
educational facilities and re-
ducing cost of operation.

He proposed to substitute
county highway organiza-
tions, claiming it would "re-
sult in building more and
better town highways for
the same amount of money,"
and "would open up vast
areas which today, because
they are off a paved State
road, have shown no increase
in value and have shown
steadily decreasing popula-
tions."

Further savings may be
gained, he says, by enlarg-
ing health administrative
and tax collecting units from
town to county limits, esti-
mating that \$500,000 a year
may be saved by eliminat-
ing unnecessary town tax
collecting officials.

Better justice and a sav-
ing to the taxpayer would
result from reorganizing the
whole system of justice
courts, he declares, doing
away with justices of the
peace who often have no
legal training, and "retain-
ing possibly some individual

in every township who shall
have the jurisdiction of a
committing magistrate, but
placing the trial of both
criminal and civil cases in
the hands of qualified and
trained judges."

Naturally, Governor Roos-
evelt's plan will meet oppo-
sition from job-holders
whose offices would be abol-
ished. But his proposal is a
step in the right direction
and other states should re-
ceive the idea with favor.

ABOUT TOWN

"There will be a meeting of bus
operators in Raleigh Friday, and at
the time an improvement of sched-
ules in this section will be given
consideration," said a citizen today.

"This is a very important meet-

since bus schedules here are not

Russian Raiders Evacuate Central Manchuria Today

Tokyo, Oct. 17.—(AP)—Russian
forces apparently have withdrawn
from Central Manchuria after one
of the most extensive raids in his-
tory of the present Soviet-Chinese
conflict.

Rengo dispatches from Harbin,
Manchuria, today said the Soviet
troops had retired to the Russian
frontier after penetrating more
than 100 miles inland along the
Sungari river to near Han (Chang-
shen and Dudzin (also Fuchin).

Shen Hung-Lieh, commanding the
Chinese Sungari river forces, sent
the following communique to Har-
bin:

"The Soviet force which occupied
Linkianghsien on the night of Octo-
ber 13 ascended the Sungari in over-
whelming numbers, consequen-
tly gravely endangering Fuchin and
Hwachuan.

"The Russian invading force con-
sisted of seven gun boats and twelve
airplanes. Soviet marines looted
the granary at Linkianghsien before
withdrawing. We are maintaining
a vain watch to prevent repetition
of the invasion."

Senkiangrow, meantime mouths
of three rivers, doesn't appear on
available maps here but presuma-
bly is the Chinese name of the
town on the Russian side of the
Amur river. Since Admiral Shen's
report did not mention any fighting
military experts here believe the
Russians withdrew after practi-
cally unopposed raiding.

Six Men Held for Holdup of Armory

Detroit, Oct. 17.—(AP)—For a
hold-up of the naval reserve armory
and the theft of a machine gun
with which to hijack run runners,
six men were under arrest today.

Ray Bowles, 29, arrested at Am-
herstburg, Ont., confessed, waived
arraignment and was brought to De-
troit.

The police said Bowles and his
accomplices planned to equip a boat
manufacturing as a coast guard craft
in order to hijack run runners in
the Detroit river.

The arrest of Bowles resulted
from admissions by Elbert Sash, 18,
who was arrested as a suspicious

The police said Bowles admitted
he held the pistol at the point of

WAKE FOREST AND STATE TO CLASH TODAY

While North Carolina State college and Wake Forest are meeting in "mortal combat" this afternoon, in Raleigh, other gridiron teams of North and South Carolina will continue preparing for football games tomorrow and Saturday.

Deacon and Wolfpack will fight today for the right to remain in the race for the football championship of North Carolina. Thwarted in their first contest, a clash with University of North Carolina, at Chapel Hill several weeks ago, the Wake Forest eleven will be out to gain an even 500 rating, while a victory for State will put the Pack on an even footing with the Tar Heels.

Although there isn't any undue optimism in the camp of the Deacons, followers of Wake Forest team have expressed themselves as being hopeful of the outcome, and have passed out the word that the score will be a big surprise. State certainly hasn't displayed much to indicate a powerful pack this season, while Wake Forest has been improving with each game.

"Pat" Miller, coach of the Deacons, has welded a strong forward wall, and the failure of State to score against Clemson indicates that the Wolfpack can be turned back. State's attack lacks versatility, and the punch of the last two years isn't there, the Raleigh team feeling the effects of the loss of veteran material by graduation and the decision of "Bob" Warren, hefty fullback, to quit school and join the coaching staff at Virginia Tech.

Finishing touches will be put to the training of four teams in South Carolina today, as they go into competition tomorrow. South Carolina will meet Presbyterian, in Columbia, and Clemson will tackle Wofford, in Greenville. Both games are state championship affairs, but South Carolina and Clemson have such an edge that the size of the score is the problem worrying the boys, rather than the actual outcome.

Four other teams, Davidson, Citadel, Duke and Carolina today take part in their last scrimmage of the week, in preparation for Saturday clashes. Carolina has gone thru a rigorous week in getting ready for University of Georgia's invasion of Chapel Hill, Davidson is preparing for a contest against the Citadel which team invades Davidson, and Duke is rehearsing for the game with the Naval Academy, in Annapolis.

Big Three Off To Slow Start

New York, Oct. 17.—(AP)—Three years ago Harvard, Princeton and Yale fell from the football march during the first month of the season. The annihilation of the ancient triumvirate was accomplished by Geneva, the Navy and Brown. Princeton braced up in 1927 and 1928 only to stumble at the finish and already the current campaign holds an unkind beginning for the founders of intercollegiate football.

With the Tigers shaded and the Elis trounced, Harvard will take the field against the Army at Cambridge Saturday, a lone defender of the tradition of big three invincibility. The Crimson will be depending upon its forward wall and an upset to turn back the charge of Christian Kremer Cagle and the Cadets. Harvard is more nearly the Army's equal than many are willing to concede, but the Cantabs nevertheless remain second choice by a hair.

Arnold Howson will present a hard-charging front line defense against the Army thrust, a defense which may be alert enough to become a "passive offense", but the problem stopping Cagle remains. This largely will be a problem for tackles, ends and wing backs as the Wily Chris is far too slippery to be driven into the "pocket". The slow and conservative development of the Orange and Black for perfection in the big games of November and not until then. Although the Yale game always will remain, and properly, the Yale game to Princeton, this slow moving charge of the Tigers seems particularly futile this season with only an under-par Eli eleven to be met at the finish.

GIRL DECLARES MISTAKE MADE IN DEAD BODY

Paris Art Student Thinks Body Found in River Not That of New Yorker

New Orleans, Oct. 17.—(AP)—Nothing daunted by the working assumption of authorities that the body found on the levee below New Orleans with a bullet through the head was that of her companion, Jack Kraft, New York writer and adventurer, June Ord, Paris art student, today held a belief that the body identification was erroneous.

"I don't believe the body taken from the river was Jack's," she said in her prison cell, "and they won't let me see it. If it's not Jack's body then there's no use making so much fuss to find out whether he was shot."

The girl, held as a material witness in the investigation of Plaquemines Parish authorities into the puzzling disappearance of Kraft from the steamship Creole in the Mississippi river, 55 miles below New Orleans, since her detention has maintained that her companion either jumped or fell over the ship's rail.

Questioned about the bullet wound in the body washed up the river and assumed to be Kraft's, Miss Ord has countered every attempt to draw from her supporting information by her statement that as she recalled the disappearance no shot was fired.

Last night a deputy sheriff of Plaquemines Parish met the steamship Creole at the mouth of the river on its return trip to New York and attempted to remove from it Second Officer John McGouldrick, wanted by District Attorney Leander Perez for questioning in the matter.

When the deputy went on board the vessel from a pilot's launch, Captain E. W. Sandstrom declined to honor the warrant on the ground that the ship could not proceed without its second officer. He added that if McGouldrick were wanted he would have to be taken off at New York.

Miss Ord and Sam Epstein, the latter the steward of the Creole, are being held as material witnesses in the Orleans Parish prison.

According to their stories, they, with McGouldrick were on the deck of the ship late one night about a week ago when Kraft, with whom the girl was traveling from New York to New Orleans, came up and suddenly leaped over board.

New York, Oct. 17.—(AP)—The cotton market opened steady at a decline of 1 point to an advance of 1 point. Orders at the start seemed to be pretty well divided between southern hedging and trade buying but the demand tapered off right after the call.

Early cables from Liverpool were relatively steady but prices there eased off just before the local opening and there was some selling here supposed to be for both Liverpool and Continental account. According to Liverpool cable advices the market there was comparatively quiet with early buying by Bombay and trades calling supplied by scattered liquidation. Weakness in the stock market and favorable weather for picking and the movement were mentioned as factors on the local decline.

GRAIN MARKET

Chicago, Oct. 17.—(AP)—Fluctuating violently at a rapid rate and with trade assuming huge volume, wheat prices averaged lower most of the time today. March delivery touched a new bottom record for the season, 1.3-8c a bushel under any previous quotation for the 1929 crop. Selling out on the part of various speculative holders of wheat future deliveries continued today, but the market was much more two-sided than yesterday, although the Liverpool market today closed 23-4 to 33-8 pence lower, and Europe seemed little impressed by advices received here pointing to a greatly reduced wheat crop in the Argentina.

Wheat closed nervous at the same as yesterday's finish to 3-8c lower. Corn 1-4 to 1-2 cents advance, oats unchanged to 1-4c off and provisions unchanged to a rise of 10c.

N. Y. STOCK LIST

New York, Oct. 17.—Sharp recoveries took place in today's stock market after an early period of heaviness in which several of the leaders were hammered down 1 to 15 points. Short covering operations played an important part in the rally, which ran from 1 to 5 points in most of the active issues, and 6 to 15 points in a few specialties. Trading was fairly heavy in volume. Lowering of the call money rate from 7 to 6 per cent, coincident with the passing of the mid-month stringency, stimulated the recovery in prices. The money market was dull but showed an easier tendency. Some nervousness was apparent over the weekly Federal Reserve Bankers' loan statement to be issued after the close of the market. In view of the sharp rally and calling for payment of a large stock subscription in the period covered by the statement most observers looked for a moderate increase.

Except for placing of a large order for rails by the Pennsylvania Railroad, the passing of the International Combustion dividend, there was little in the day's business news to influence the price movement. International Combustion broke nearly 2 points to a new low at 28 1-2 and the preferred slumped 17 1-2 points to 70.

Motor Products dropped off six points and Murray Corp. sank more than 5 points to a new low at 54 3-4. Stone & Webster and Brook-

Bonus Paid to Mill Workers At Macon, Ga.

Macon, Ga., Oct. 17.—(AP)—A bonus of \$136,000 to 2,400 textile workers in mills of the Bibb Manufacturing Company was ready for distribution today, bringing the total bonuses the company has given its employes within a week to \$274,000.

The second gratuity if distributed equally would give each worker approximately \$110, but the allotment was on the basis of years of service, thereby assigning long term workers much more, while others receive less. All employes with more than two years' service were eligible to share in the bonus.

W. D. Anderson, president of the company announced the second bonus last night. The first gratuity of \$138,000 was given October 10. Both were in addition to regular bonuses inaugurated by the company some time ago.

Athlete Still Training

New York—Joseph A. Rnddy, 51, is training at the New York Athletic club for his 38th year of amateur competition. He has been a shot-putter, hammer-thrower, baseball player, discus-thrower, water polo-player and swimmer. In competition he has scored 1,560 points for the club. Interest Increases in Pantages Trial

Los Angeles, Oct. 17.—(AP)—Intimations by District Attorney Burton Pitts that perjury charges will be filed against more witnesses in the case of Alexander Pantages heightened interest today in the trial of the theatre magnet on charges of criminally attacking Eunice Pringle, 17-year-old dancer.

Pitts' statement came after a day of startling turns in the trial, featured by the indictment of Garland Biffle, first defense witness for Pantages, on a perjury charge. Biffle, who was arrested Tuesday after he testified he had overheard Miss Pringle say to Nicholas Dunav, a writer, just before she visited the theater man's office on the day of the asserted attack, that Pantages "would be sorry" if he did not book her vaudeville act. The state contends that Dunav was not in the theater at the time referred to by Biffle.

During a court room argument over the Biffle testimony Pitts asserted that in all his experience he had "never seen such cold blooded, deliberate attempts to suborn perjury as have been made by Alexander Pantages and his son, Rodney, in this case."

Continuation of defense witnesses had been a deliberate attempt by the prosecution to intimidate witnesses drew an order from the court that any future arrests should not be made in the presence of persons waiting to take the stand.

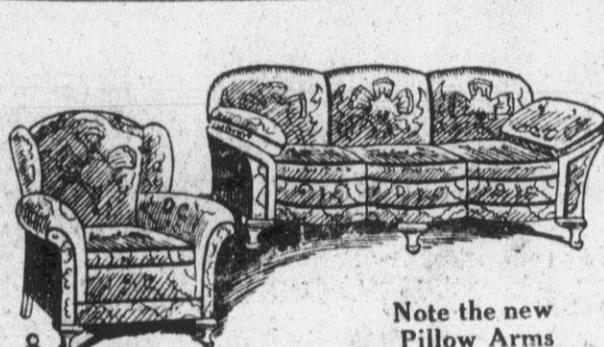

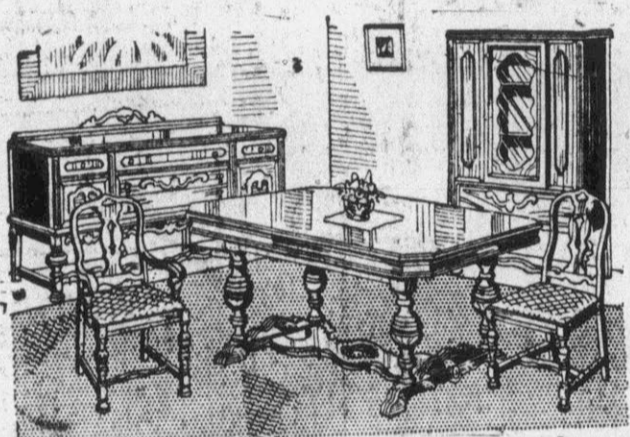

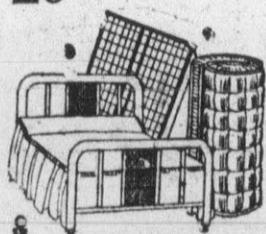
