PITT PROBLEMS CONSIDERED AT BANKERS MEET

Effort Made to Find Constructive Course of Business for Coming Year

At the Woman's Club building, officers and employees of banks in Pitt county held an interesting meeting last night. The meeting was presided over by Mr. George Prescott, cashier of the National Bank of Ayden. The meeting was at the conclusion of the four-year course in banking under auspices of the American Institute of Bank-

Four men, J. H. Waldrop, cashier of Greenville Banking & Trust Company, Miss Martha Lee Cowell, assistant cashier of the same bank, Mr. Virgil N. Whitehurst, of Bethel Bank & Trust Company, and Mr. A. F. Rowe, assistant cashier of National Bank of Ayden, were presented diplomas, having successfully completed the four-year course in banking. The diplomas were presented by Professor A. D. Franks, of East Carolina Teachers College. Mr. Franks, in presenting these diplomas, stressed the importance of efficiency in service; efficiency that would meet the needs of changed and improved business.

Pitt county's problems for 1930 were considered in an effort to find a constructive course for business. Dr. W. W. Dawson, one of the county commissioners, urged economy in personal and family life and urged a closer home-life in which the members of the family should cooperate to solve the family problem.

Mr. J. L. Little, president of the National Bank of Greenville, Pitt county's venerable banker, reflected on problems of the past, all of which have been solved by determination of the people "to go forward" guided by dependable character and sound business energy.

Mr. R. B. Turnage, director of the National Bank of Ayden, urged that the people meet squarely and openly their problems and maintain courage and a spirit of hopefulness. He urged that it is a far-reaching nature to lose hope in the future and surrender to present conditions; that what appears to be a misfortune following excessive rains may be a blessing in disguise.

Mr. W. H. Woodard, vice-president of Greenville Banking & Trust Company, urged that we learn to live at home, analyze our own business and depend less on borrowed money.

Mr. F. J. Forbes, cashier of the National Bank of Greenville, urged the production of more home supplies and the development of better farm life; that we should not continue to depend on so-called money crops as in the past.

Mr. J. R. Hargy, director of the Bank of Grifton, urged that the people generally plan carefully to meet the human needs during the coming winter; that the supplies of the people should in no sense be wasted.

Mr. S. C. Ives, cashier of the Bethel Banking & Trust Company, urged that indebtedness be reduced as much as possible and that particular attention be given to payment of taxes.

Mr. F. M. Wooten, of Greenville, urged that banking be considered as the primary duty of banking institutions and that money lending be done without over-head expense loan money at six per cent interest; that banks with over-head expense are charged to six per cent on loans, therefore, should devote themselves to the banking business as a profession. He urged that the best interests of the banking business and business in general in Pitt county can be served by holding to Pitt county as our unit of business; that the banking business of Pitt county should best serve Pitt county by being united under one management and centralized in the county seat with branches in the different towns as may be needed to conveniently serve the business interest of the county. That the banking resources, intellectual, moral and financial, should be merged or united under one charter for the primary purpose of serving safely and progressively the business interest of Pitt county. That such move would make the banking business more useful, less expensive and reduce to the minimum uncertainty in return.

The conclusion a beautiful bunch of flowers was presented to Miss Martha Lee Cowell as evidence of appreciation for her accomplishments in the banking business on the course she has just successfully completed.

Diphtheria Shows Greater Gain in North Carolina

Raleigh, Oct. 18.—(AP)—Diphtheria showed another gain during the week ending October 12 when 245 cases of the disease were reported in the State as compared to 229 for the same week last year, the bureau of epidemiology of the State Board of Health reported today in its weekly summary of contagious diseases. Whooping cough showed an increase of 63 cases of the preceding week with 166 cases last week and only 103 the week ending October 5 and only 70 for the same week last year. Scarlet fever showed a decrease from 122 the week ending October 5 to 116 last week as compared to 129 the same week last year. There were 14 cases of typhoid, a decrease from 29 the preceding week; six of smallpox, an increase of 4; and four of measles, the same numbers as the preceding week. Wake county led the State in diphtheria cases reported with 11 while Nash and Wilks each had 10. Haywood county reported 32 cases of whooping cough; Halifax 21 and Onslow 13. Henderson county reported five of the six cases of smallpox.

NATIONALISTS BEGIN LOOTING CITY OF WUHU

All Foreigners Evacuate City Following Mutiny of Government Troops

Shanghai, Oct. 18.—(AP)—Japanese press dispatches from Nanking said today that Wuwu, Anhwei province, that Nationalist government troops there had mutinied at 3 A. M. and had begun looting. The mutiny had the looting was continuing.

The dispatch added: "A naval force from the Japanese warship Fushimi landed and is protecting the Japanese consulate and Japanese residents but owing to interrupted communications there are no further details."

"However since there are two Japanese warships at Wuwu it is believed they are meeting the situation. The Japanese gunboat Hotsu is coming down the Yangtze River now to Wuwu to render further assistance."

It was authoritatively learned that the foreigners including about six Americans evacuated the city and went aboard the Japanese and British gunboats. The foreigners included 70 Japanese and 30 other nationalities.

Mr. and Mrs. Doheny Give Testimony at Fall Trial; Tell of Note For \$100,000

Washington, Oct. 18.—(AP)—Mrs. Carrie Estelle Doheny, wife of Edward L. Doheny whom the Government charges bribed Albert B. Fall with \$100,000 to obtain the Elks Hill, Calif., naval oil lease testified today Fall's signature had been torn from a note for that amount so that the former interior secretary would not be embarrassed if anything happened while she and her husband were en route home. Wearing a black dress, trimmed in white, she said her husband had told her to keep the signature carefully so it would be available when the time came to present the note for payment. She added she had taken the signature from New York to Los Angeles and put it in a safe deposit box. Today Mrs. Doheny produced the signature in court. She already had identified the note. Frank Hogan, chief defense counsel, put them together and presented the complete note to the jury which examined it carefully.

She was on the stand only a short while before her husband was called. Regarded as the most important witness for the defense, Doheny has said the \$100,000 was a "loan to an old friend in need" and not a bribe as charged by the prosecution. Doheny said he first met Fall in Kingston in 1886 when Fall was a miner at the Gray Eagle Mine.

E. C. PYTHIANS HOLD SPLENDID MEETING HERE

Several Distinguished Members of Organization Spoke Here Last Night

With John C. Rodman, Jr., of Washington, presiding, the Pythians of Eastern Carolina met last night in the local Pythian Hall in one of the best, most interesting and most enthusiastic meetings ever held here. The meeting was opened with prayer offered by Isaac Wayne Hughes, Grand Prelate, of Henderson. In a few words Dr. John C. Rodman, Sr., of Washington, introduced Leonard Vyne, Grand Chancellor for the Domain of North Carolina, who explained the principles of Pythianism and called on all Pythians to lend their aid to their country at this time. He explained in detail his 3-1-3 plan which calls for a donation from every Pythian in the state this year of one cent a day for the 313 working days to create an endowment fund for the Pythian Home. Richard Meares, Supreme Master of Exchequer, introduced Colonel Walker Taylor, Supreme Representative, of Wilmington, to the meetings. In a very pleasing manner Mr. Taylor stressed the need of fraternal cooperation, loyalty to government and obedience to law, also explaining that the Supreme Lodge Knights of Pythias is composed of the finest type of manhood in the nation.

R. S. McCain, of Henderson, chairman of the board of trustees of the Pythian Home, gave a very interesting talk on conditions at the home and stressed the need for loyal support to that great institution.

Rev. Isaac Wayne Hughes, of Henderson, Grand Prelate, and Mr. George Lovell, Grand Keeper of Records and seal both gave very interesting talks. The district deputies for the different districts gave short talks on conditions in their districts. We were treated to a burst of laughter by the ever witty Silas R. Lucas, of Wilson, for a concluding paragraph of article 21 of that treaty.

"2. My government attach the highest importance to the same procedure being followed by the Japanese and British governments, in order to ensure agreement between them on various questions that are to be laid before the conference. The success of the forthcoming conference doubt depends in a large measure upon the satisfactory issue of such preliminary discussions, and my government confidently trust that the informal conversations between the British government and myself on questions of special moment will be carried on and completed before these questions are presented to the conference for final adjustment."

"4. In your note under review, it is intimated that the British government propose to communicate to me in due course their views as to the subjects for discussion at the conference. The Japanese government are looking forward to such a communication with keen interest and, on their part, they will be glad to furnish the British government with a corresponding communication as desired."

"5. With regard to the four points of principle mentioned in your note as the subject of provisional agreement between the British and American governments, the Japanese government hope to be able to submit their observations in the course of the informal conversations which I shall shortly permit myself to hold with the British government. They would, however, make use of this occasion to answer you of their cordial support of the principle that the treaty for the renunciation of war, signed at Paris in 1919, should be taken as the starting point for all discussions on disarmament. They feel confident that the sense of national security inspired by the provision of that treaty in the mutual relations of the contracting powers will pave the way for the final settlement of the outstanding questions relative to naval disarmament."

The visitors were welcomed by S. O. Worthington, grand vice-chancellor of North Carolina, who was instrumental in bringing the meeting to Greenville. He expressed appreciation of the presence of so many of the high officers of the lodge and assured them that the city extended them a cordial welcome.

Under rapid examination the witness covered a span of years during which he achieved success in business and Fall rose high in political life. Doheny said he had nothing to do with President Harding's transfer of the naval oil reserves to the jurisdiction of the interior department but told of receiving a letter from Fall in 1921 in which the latter asked him to get the Pan-American company to relinquish rights to part of Elks Hill. He said he replied his company would be glad to do anything to help the government. Fall later told him, the oil man said, of his desire to purchase an addition to his ranch property and spoke of trying to borrow \$100,000 from Edward B. McLean, Washington publisher. Doheny said he offered to let Fall have the money but the cabinet member did not immediately accept the offer, but asserted if he did he would give Doheny a mortgage on the ranch property.

On November 29, 1922, Fall telegraphed him asking for the loan. Fall, he said, explained the difficulty of handling checks in New Mexico and asked for cash, which Doheny sent the next day by his son. When the son returned he gave the witness Fall's note, which did not contain the rate of interest, his son saying Fall had left it blank, as he thought Doheny should set the rate.

Japan Approves Hoover's Naval Reduction Policy; To Attend London Confab

Washington, Oct. 18.—(AP)—Full support of President Hoover's announced policy of naval reduction, as contrasted with limitation, was expressed by Japan in accepting the British invitation to the five-power conference to be held at London in January.

The Japanese note of acceptance was transmitted to Secretary Stimson by the British foreign office and a copy was delivered by Ambassador Debutch here. The text was made public today by the State Department. In addition, the Japanese government expressed complete willingness to engage in negotiations with Great Britain prior to the conference in order to facilitate the work of the parley itself. The Japanese attitude toward the provisional agreement between the Washington and London governments, the note said, will be communicated to the British foreign office in the course of the discussions to precede the January conference.

The text of the note was as follows: "1. I have the honor to acknowledge the receipt of your note dated October 7, informing me of a provisional and informal agreement reached between the Prime Minister and the American Ambassador in London on the subject of Naval Disarmament, and inviting the Japanese government to participate in a conference which it is proposed to summon in London, to consider the categories of ships not covered by the Washington Treaty, and to arrange for and deal with the questions covered by the second paragraph of article 21 of that treaty."

MACDONALD TO CONFER WITH OTHER NATIONS

British Prime Minister to Hold Conversations With France, Italy and Japan

Ottawa, Oct. 18.—(AP)—Conversations with France, Italy and Japan, in the same informal manner which characterized his talks with President Hoover, will be Premier Ramsay MacDonald's next step in his crusade for world peace. He disclosed this last night in an address before the political leaders of the Dominion at a dinner at parliament building.

Describing his mission to the United States as merely one of good will with no intention of entering into any agreements, he pointed out there is a world outside the United States and Great Britain and that neither country desired to impose its will on this world.

He said pessimistic friends advised against calling of the five-power naval limitation conference, saying all nations would not accept the invitation.

"But," he said, "I was never pessimistic and I am glad to say that every power that was requested to send representatives there has now replied that it will be happy to be represented. And so the next stage in this dream is the five-power conference, and I go back to London to begin conversations with France, with Italy, with Japan, in the same frank and free and open way that has characterized the conversations between the United States and ourselves."

"And I hope and pray, indeed I believe that we shall have the support of the rest of the world all the time, and that as a result of these conversations, when we shall attempt to understand each other, an agreement will become to some time next spring which will be the biggest and most substantial advance toward world peace which has been known in the history of civilization up to the present time."

ARGUMENT TO END TODAY IN STRIKE TRIAL

E. T. Cansler, Sr., Pictures Radical Labor Movement for Prosecution

Charlotte, Oct. 18.—(AP)—A background of falsehoods and a structure of flimsy personal ambitions was a picture of the radical labor movement in North Carolina which E. T. Cansler, Sr., arguing for the prosecution, held up to the jury in the Adcherolt murder case in Mecklenburg superior court today.

"Fred Erwin Beal called this false strike in order to bolster up a fading cause," he declared. The speech was vigorous and forceful. Tom Jimison followed Mr. Cansler in addressing the jury. He devoted the major part of his address to an effort to riddle the state's witnesses and testimony. He closed in a moving appeal to the jury to disregard prejudice in the case and to disregard a blot on the fair name of North Carolina.

J. Frank Flowers was to make the closing defense speech this afternoon and Solicitor John G. Carpenter was to close for the state.

Judge M. V. Barnhill this morning was still considering the plan of adjourning court after the arguments today until Monday morning, when, under that possibility, he would deliver the charge to the jury.

"The state, through Mr. Cansler, took the position, in addition to the conspiracy phase, that the police, in their purpose to quell disorder, had a legal right to use the strike, and that when the armed guard pointed his gun at Officer Gilbert that in itself was assault. His opinion was that the defendants were guilty of murder in the second degree on the admitted facts."

The lawyer's next proposition was that there was no element of self-defense in the case. "All this talk about self-defense has no place in the trial," he insisted. At that point he turned from the legal argument to the argument of fact before the jury. The lawyer said he had been allotted two hours and ten minutes of the state's remaining time, leaving one hour for Solicitor John G. Carpenter.

"The lawyers for the defendants have taken the cue from their clients," the speaker told the jury, "and have placed cotton mill owners in a class little better than murderers."

"The defendants should have let the light in gentlemen," he continued. "If they want you to consider their grievances against the cotton mills, I intend to you there never was a legitimate strike at the Lory mill."

Much Common Leaf Offered for Sale in City Thursday

Owing to a large amount of interior tobacco, the general price average of the Greenville tobacco market remained almost stationary yesterday according to the official report of K. W. Cobb, supervisor of sales. The market sold a total of 884,178 pounds of leaf for a total sum of \$195,452.14 at a general average of \$22.10 per hundred pounds. There was a considerable amount of leaf on the floors of the nine warehouses today with the price situation showing little change over the preceding day.

REPUBLICANS PLAN TO RUSH UP ON TARIFF

Leaders of the Senate Map Out Program to Expedite Through Senate Soon

Washington, Oct. 18.—(AP)—Mindful that President Hoover wants the tariff out of the way when the regular session begins, Republican leaders mapped out a program today to expedite the measure through the Senate at the earliest possible moment. Three steps were agreed upon: First, the finance committee Republicans to meet daily and decide on what amendments might be accepted without debate. Second, to propose night sessions beginning tonight. Third, to convene the Senate at 10 instead of 11 o'clock each morning if night sessions should not be possible.

The conference was called unexpectedly. It included Republican members of the finance committee and a large group of regular Republican Senators. "The meeting was for the purpose of deciding some means to expedite the bill," Senator Watson, the Republican leader, said afterward. He added that the finance committee majority at its daily meetings would determine why new amendments offered by the opposition coalition of Democrats and western Republicans and the regulars, could be accepted, thus obviating debate.

Chairman Smoot, of the finance committee, has arranged to seek agreement on night sessions later in the day. Both Democratic and western Republican spokesmen have expressed vigorous opposition to the evening meetings.

BANK RECORD SHOWS SCOPE OF RUM RING

Syndicate Captured On Atlantic Coast Earned \$2,000,000 Profit in 6 Months

New York, Oct. 18.—(AP)—Entries in a small black account book showing \$2,000,000 profits in six months, huge sums paid for bribery, ships and liquor, revealed today the proportions of the syndicate which federal officials charge monopolized liquor smuggling along the Atlantic coast. The account book was seized with other records at the mansion in Highlands, N. J., headquarters of the ring, when federal and state officers made 32 raids along a 200-mile front in a preconcerted drive against the syndicate Wednesday.

William J. Calhoun, prohibition administrator of New Jersey, said the little book, about five by ten inches, contained, in addition to notations showing the profits which were divided in ratios of seven to 23 per cent among the members, closely written memoranda of large sums paid to local officers for protection.

Notations showed, he said, that last March the syndicate spent \$700,000 in Montreal "for ships, the purchase of liquor and operating expenses."

Calhoun said that seven banks in New Jersey, Manhattan and Brooklyn with which the ring did business, would be called upon to produce their records of the transactions. James E. Wilkinson, assistant U. S. attorney, declared that the three banks in New Jersey where the smugglers had accounts were obviously aware of the nature of their clients' business. He also denounced lawyers who he charged gave legal advice to the syndicate.

"When banks lend their palatial offices as a rendezvous for bootleggers," he said, "and finance bootlegging operations with accounts carried in code to prevent their identification and when supposedly respectable lawyers sit in bootleggers' conferences in their own offices, I consider it is about time for the public to begin to consider a new code of ethics for the business world."

New York, Oct. 18.—(AP)—Further unsettlement developed in today's stock market as a result of the uneasiness created by the sharp rise in brokers' loans last week to within \$3,000,000 of the record high. Extreme delinquency in many of the active issues ranged from 1 to 10 points but recoveries, running as high as 4 points, took place in some issues in the early afternoon as a result of short covering. Trading showed a tendency to turn dull on the rally and speed up on the declines.

While short selling was again an important factor in the public utility group, the size of the short interest in some of the industrials has reached unwieldy proportions, leading to occasional hurries of buying as bears rush to cover. Leading commission houses continue to advise their customers to lighten commitments and exercise extreme care in the making of new purchases until the market has given a definite indication that it has touched bottom.

With nearly \$200,000,000 in new financing called for payment this week, including the Marine Midland and Texas Corporation issues, Wall Street was faced with the possibility of a further increase in loans next week to another new high record unless heavy liquidation should develop before next Tuesday. Meanwhile, credit conditions continue to ease. Call money dropped today from 6 to 5 per cent as banks sought to employ surplus funds over the week-end and the time money market continued quiet.

BOB SHAWKEY NEW MANAGER N. Y. YANKEES

New York, Oct. 18.—(AP)—Unconditionally released by the club two years ago, Bob Shawkey, an ex-saylor, has been named manager of the New York Yankees, leaderless since the death three weeks ago of Miller J. Huggins.

A great right-handed pitcher in his day, coach of the Yankees during the past season, Shawkey never has had any managerial experience, either in the major or minor league. He signed a one-year contract to manage the club several days ago but announcement was withheld by Colonel Jacob Ruppert, club president, until yesterday. Shawkey now is in Quebec on a hunting trip but is expected back in New York next week.

Shawkey's selection surprised the experts who had anticipated either Arthur Fletcher, Yankee coach, or Bob Conner, President of the St. Paul club of the American association, would be named to the post.

It turned out, however, that Fletcher had been offered the job but had declined.

"I do not want to manage the Yankees or any other club Fletcher said when the offer was made. 'If the club wishes me to continue as coach I will be satisfied'.

The offer then was made to and accepted by Shawkey.

Col. Ruppert said the new manager had been selected solely on the basis of advice given some time ago by Huggins. Some five years ago, Col. Ruppert said, he and Huggins had discussed possible successors of the "Mite Manager" in the event of his retirement or disability. Huggins recommended Fletcher, then manager of the Philadelphia Nationals, and Fletcher later came to the club.

After Shawkey's days as an active player were over, Huggins advised his addition to the payroll as a coach, especially of pitchers. "Bob the Cob" became Huggins' second choice as a successor and when Fletcher turned down the job Col. Ruppert simply continued to follow where Huggins had showed the way by offering it to Shawkey.

Shawkey began his professional baseball career with the Harrisburg club of the old Tri-State league in 1911. He came up to the Philadelphia Athletics the following year but was optioned to Baltimore for that year and most of the next. He rejoined the A's in 1913 and then was traded to the New York Yankees in 1915 from Jack Warhop. E. Conner and a sizeable amount of cash. He remained with the Yankees through the season of 1927, pitching in five world series, one in 1914, with the Athletics and four with the Yankees.

He was unconditionally released in November, 1927, and went to the Montreal club of the International League as a pitcher and coach. He came back to the Yankees as a coach at the start of the season just closed.




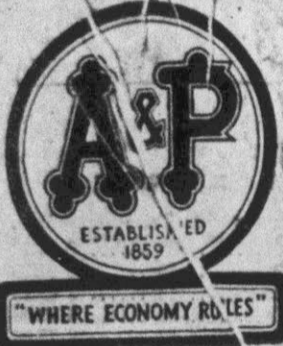

House met and adjourned without transacting any business.

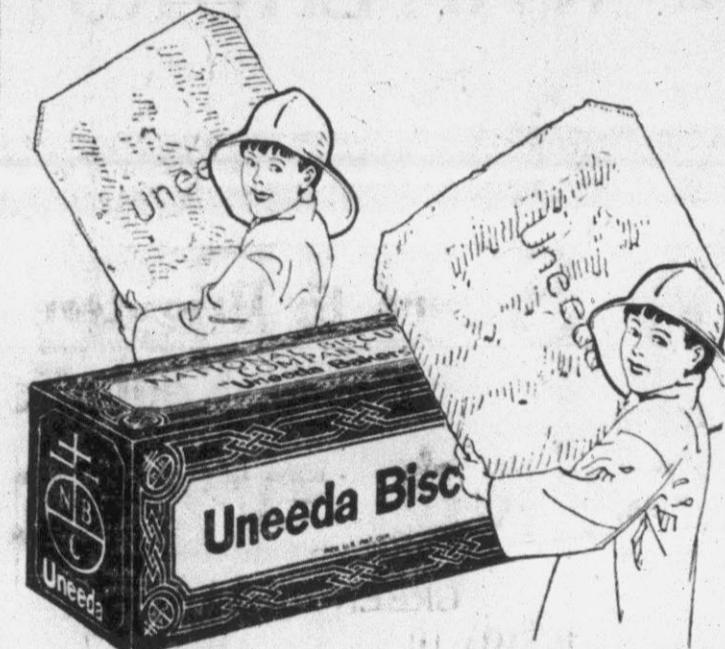
