## GREAT LAKES ARE SWEEPED BY HEAVY STORM

### Illinois, Wisconsin Indiana Suffer Property Damage From Gale and Water

Chicago, Oct. 23.—(AP)—The worst lake storm in a year. A storm with high waves against the Illinois-Wisconsin-Indiana shore of Lake Michigan—swept eastward today, cold, raw and snowed.

In Chicago it left crumpled sea walls, flooded basements, water-logged boulevards; in Gary, Ind., cars deserted by families fleeing menacing seas; in Michigan City, Ind., a \$300,000 property damage on the Wisconsin shore, crippled traffic and property loss; in Ontario shipping fought the anger of the waters.

An unidentified freighter was grounded in Lake Erie just off Leamington, Ont., and life saving crews had been unable early today to reach her because of the pounding sea.

The Lak: Frugality, a Ford Motor Company barge with a crew of six, was adrift in Lake Superior. The steamer Maple Court of the Medina Steamship Lines was grounded on Magnetic reef in Lake Erie. Taking a severe pounding in no immediate danger; 2 tug boats.

Air mail service was halted and land and lake transportation was seriously crippled; but these effects of the storm were incidental to the physical damage done as far north as Green Bay and around the Chicago curve of the lake up to Michigan City, Ind., and beyond.

A barge that broke away from its tug sank in Lake Michigan and its crew of two were saved after being drift for hours. Small boats moored in the comparative safety of harbors were driven to shore and sank.

So spectacular damage was done to the electric shore line and system of Chicago, extending from North Shore suburbs to the extreme south side. Even the inner drive in Lincoln Park was under water in many places. Because the outer drive, skirting the edge of the lake, was impassable, the heavy northward traffic was compelled to plash through two feet of water. Parallel arteries further inland were fluted with traffic, causing a tie-up unequalled since the great jams of Eucharistic Congress.

Fire apparatus spent most of the night pumping water from the boulevards so they might be ready to meet the morning's inevitable traffic.

Snow began falling shortly before 6 o'clock last night over the entire town area, and the temperature all within two degrees of freezing.

At Michigan City, Ind., two homes, each valued at \$30,000, were swept into the lake, and other costly summer homes at the Long Beach resort were endangered as the lake lashed against the dune lands.

Gary, Ind., families living near the lake began evacuating their homes last night amid the roar of the water and the howling of a wind that at times attained a velocity of 50 miles an hour.

## Buncombe County Education Board Under Indictment

Asheville, Oct. 23.—(AP)—All five members of the Buncombe county board of education were under indictment today on the charges of irregularity in office. The indictments, returned by the grand jury yesterday, charged the board members with accepting monthly pay checks from which deductions for meetings not attended as required by statute, had not been made.

The members indicted were Albert Teague, chairman; M. J. West, John A. Goode, Claude Felmet and J. T. Roberts. Two indictments were returned against West, the second charging him with violating the statute forbidding public officers to trade with themselves. He is alleged to have sold merchandise to the school department.

## L. B. WHICHARD LAID TO REST NEAR STOKES

### Funeral for Well-Known Man Conducted Yesterday Afternoon at 1:30

Funeral services for Ernest B. Whichard, 45, who died Monday at his home near Stokes, were held yesterday afternoon at 1:30 o'clock followed by burial in the family cemetery. Services at the home were conducted by Revs. B. A. Cowan and L. R. O'Brien, while those at the grave were in charge of the Stonehill Masonic lodge, of which he was a member.

Mr. Whichard was a native of this county and had spent most of his life near the scenes of his childhood. He was the son of Mrs. Mary Amanda and the late Willis R. Whichard. On October 22, 1907, he married Miss Ida Moore of this county, with six children, surviving him. While his principal interests have been in agriculture, Mr. Whichard has for a number of years also been connected with the postal service at Stokes, which position he held at the time of his death. In addition to his capacity in fraternal circles and community affairs he has also served his county in the capacity of county commissioner.

He was of the type that readily made friends and the esteem in which he was held was emphasized by the large attendance and the beautiful floral tribute at his funeral.

Those surviving are his mother, Mrs. M. A. Whichard; his wife, two daughters, Misses Ida and Mary Whichard and four sons, Willis G., Ernest B. Jr., Herman and Benjamin; one sister, Mrs. S. M. Jones, of Bethel; and four brothers, C. L. W. R.; and H. W. Whichard, of Norfolk; and L. R. Whichard, of Whitehall, N. C.

## Tar River to Reach 20-Foot Stage Sunday

Tar river is expected to reach a 20-foot stage Sunday, according to information given out this afternoon by B. T. Clark, local weather observer. Rapid rise in the river has already been reported from further up the state, and from now on the stream is expected to spread far over the low grounds in this vicinity. Mr. Clark said the heavy rainfall Monday night registered 4.30 inches. This was slightly under the record precipitation recorded here one time ago. The record high water mark on Tar river at this point is twenty-four feet.

## BEGIN PLANS FOR FORMING NEW CABINET

### French President After Ministry to Take Place of Premier Briand

Paris, Oct. 23.—(AP)—President Doumergue today began the difficult task of finding a cabinet with an adequate majority behind it to take the place of the Briand ministry which fell last night by a close margin and immediately resigned.

The president began receiving various political leaders but it may be days before his problem will be solved. Two who were received today were Paul Doumer and Fernand Bouisson, president of the chamber.

Premier Briand's overthrow by factions that differed among themselves on the Young plan, Rhineland evacuation, the Saar Valley and Naval policy indicates that his defeat was due more to political dissatisfaction with the cabinet's composition than vital differences over foreign policies.

The character of the new cabinet may possibly cause some shift of sentiment on big foreign policies; but as M. Briand himself expects the new cabinet to be sympathetic there was not much to indicate a serious threat to the Young plan. As far as the Saar Valley is concerned it was pointed out that technical negotiations have barely begun.

It also was said that France's naval policy is well defined as favoring submarines on which there is agreement among the party. The early evacuation of the Rhineland is in dispute but the left wing favors it and just at the moment stock of partisans of the left seems higher than that of the right.

Several dozen witnesses were on hand when the inquiry started shortly before noon and it was said that the jury probably would not make a report until late today or tomorrow morning.

Bills of indictment also were presented the grand jury this morning against A. G. Morehead, Dewey Carver, Carl Holloway and Horace Lane, textile mill officials and employees, charging them with kidnapping, false imprisonment and assault in connection with activities of the alleged Anti-Communist mob in kidnaping Ben Wells, C. M. Lell and C. D. Saylor, national textile union organizers on the night of Sept. 9.

## Daring Aviator Believed To Have Perished in His Effort to Span Atlantic

The slim flying margin allotted the midjet monoplane Golden Hind was reached today, and when it passed the craft and its pilot was believed to have been added to that long list of sky adventurers who braved the North Atlantic and failed.

When Urban F. Diteman, Jr., took off at Harbor Grace, Newfoundland for London at 10:45 a. m., yesterday he carried 165 gallons of gasoline which he estimated would keep him aloft 25 hours or longer than the period he would require to cover his course of about 2,350 miles. The 25 hours ended at 11:45 a. m., today and only negative reports of the flier and his craft came from the sea and England. Other estimates were that Diteman's fuel would have kept him in the air but 20 hours. Meanwhile he had not been reported or sighted.

Billings, Mont., Oct. 23.—(AP)—After a sleepless night Mrs. U. F. Diteman, whose husband yesterday roared away from Newfoundland on an ocean-spanning attempt, waited eagerly today for news of the little plane and again expressed confidence in her husband's ability to "make it."

Throughout the night she stood steadfastly confident, reiterating the lone aviator was no novice in flying and already had come through supreme tests in flying.

Mrs. Diteman was hoarse from an all night vigil at a jangling telephone. Everybody, it seemed, telephoned a good word of cheer and messenger boys called incessantly with telegrams. As all this was going on her two sons, Jack, 7, and Eddie, 4, slept.

As the day wore on more information regarding Diteman's ability as a flier became known. It was revealed instead of being "green" at the game, he had 200 hours solo, September 16 he flew to Billings from Dearborn, Mich., in the face of the most adverse weather and warnings at the Ford Field not to attempt the trip.

On a recent flight between Missoula and Billings, Montana, gales whipped his ship mercilessly and he was forced to land in the shelter of a high mountain. He negotiated his hazardous descent without damage to his plane.

Diteman had been preparing for the Atlantic hop since last summer. Mrs. Diteman said. He would not have attempted it, she declared, had he not been positive of accomplishment.

Portland, Ore., Oct. 23.—(AP)—While a brother-in-law maintained a vigil in a newspaper office here today, the sister and aged parents of Urban F. Diteman, Jr., Billings, Mont., cattleman and aviator, who is attempting a solo flight across the

Atlantic, refused to sleep and waited reports of the progress of the venture. Warren A. Erwin, the brother-in-law, maintained an attitude of confidence.

"When we hear that Urban has succeeded—and I'm sure that will be the news—then we'll sleep," declared Urban F. Diteman, Sr., the flier's father. Mr. and Mrs. Diteman, Sr., were not advised of Diteman's flight until last night. Erwin having planned to keep the news from them until today, when the best—or the worst—news was expected.

## FOUR CASES OF DIPHTHERIA IN PITT PAST WEEK

### Health Department Is Waging Hard Fight Against Spread of Disease This Section

With diphtheria reported near the epidemic stage in some communities of the state, Dr. Clem Ham, director of public health work in Pitt county, stated today that only four cases had been reported in Pitt county during the past week.

The work of immunizing school children and the general public against diphtheria has been continuing in this county over a period of several weeks, and Dr. Ham stated that this was largely accountable for the small increase in the number of cases reported to his department.

It was stated that a total of 68 cases of diphtheria had been reported in the county during the year and that 42 of this number had been among children under six years of age.

Dr. Ham said the greatest difficulty experienced in their campaign against diphtheria was among children under school age. Although inoculations are given free of charge by the Department of Health, parents neglect having their children immunized until they become of school age, and are caught by the compulsory vaccination law.

He declared that his department was making an effort to impress upon the parents the necessity of inoculating children under six years of age, believing that this would play an important part in reducing the spread of diphtheria in the county.

Public health workers have been conducting clinics in the various schools over a period of several weeks, and Dr. Ham expressed the opinion that good results were being obtained. The diphtheria toxin-Antitoxin is the only way to successfully combat the spread of the disease, and the department is making an effort to get the public to cooperate with them in every way possible.

At a meeting of the society of friends (Quakers) yesterday, a letter from Robeson was read, which complained that he had been excluded from the grill although the entertainment had been planned in his honor.

James Marley, labor M. M. who called the meeting particularly to consider the subject, cites the case of a Chicago negro newspaper publisher, who was refused admission to 30 London hotels last summer. A negro in the audience, at the hope Premier MacDonald would not close of the discussion, voiced the return from the United States with "The American prejudice" against negroes.

The friends society probably will call a conference for further discussion of the subject. The annual invasion of American tourists is blamed by some of the exclusion of negroes from hotels and restaurants recently.

## BULLETS HOLD NO TERROR FOR MAN AT CHICAGO, ILL.

Chicago, Oct. 23.—(AP)—Ben Friedman was shot in the face, lost three teeth, swallowed the bullet, and didn't even suffer indigestion. Things like that happen, but are hard to believe. Friedman, however had evidence. The teeth were gone and the bullet was in his stomach.

Friedman, 42 years old, was stepping out of a West Madison street restaurant last night. A man rushed at him, pushed a pistol into his face and pulled the trigger. Then the fellow ran away and never did get caught.

Friedman yelled, the ambulance arrived, he was taken to the hospital. Doctors began looking for the bullet and finally found it in Friedman's stomach. The bullet had taken three teeth from Friedman's lower jaw and then, its force spent, had gone harmlessly—the doctors said—down the Friedman esophagus.

## MRS. EVERETT WINS VERDICT IN COURT HERE

Beaver Dam Woman Awarded \$1,960 Against Executor of Cornelius Joyner

Mrs. Artimissa Everett, of the Beaver Dam community of this county, was awarded judgment for \$1,960 in her suit against Calvin Joyner, executor of the estate of the late Cornelius Joyner, by a jury sitting in the civil term of Pitt county Superior court in this city yesterday.

The case was the first taken up at the opening of court Monday morning, and is expected to be one of the longest drawn out of the present week term. The case was completed late yesterday afternoon and the jury was out only about twenty minutes.

The suit centered around service which the plaintiff is said to have rendered the late Cornelius Joyner during the final days of his life. She said Mr. Joyner made her a verbal promise to leave her a farm and a beaver dam community, but this claim was denied in the final settling up of the estate and Mrs. Everett later filed suit in the local court.

There are numbers of cases awaiting consideration this week, and from now on indications were that more progress would be made than during the first two days. The remainder of the cases are not expected to require quite so much time in disposition and lawyers and court officials were hopeful of making a great deal in the calendar before the term is over.

## Three Killed in Wreck at Capital

Washington, Oct. 23.—(AP)—Three men were killed and four injured early today when a railroad motor car was struck by a locomotive engine on the Baltimore and Ohio railroad near Rockville, Md.

The dead are: Marion Selby, 24, son of Charles Selby, superintendent of the Metropolitan branch of the B & O; Millard Mobley, 20 both of Gaithersburg, Md., and Thomas Poole, 22, of Rockville, Md. William Thompson, 28, of Gaithersburg, is in a Washington hospital in a serious condition and Frank Pool, Rockville, William Coleman, 55, foreman of the crew on the motor car and his son, Leonard Coleman, were also hurt, but their injuries are not thought to be serious.

## WOMAN GOES ON STAND IN CATTS CASE

### Leah Burwell Describes Threat to Implicate Governor in Counterfeiting Ring

Tampa, Fla., Oct. 23.—(AP)—Her threat to implicate former Governor Sidney J. Catts in the activities of alleged \$100,000 counterfeiting ring unless he posted bond to effect her release from prison on charges of passing fraudulent bills was described by Leah Burwell at the trial of the former governor in Federal court here today.

Catts is charged by the government with aiding and abetting operations of the alleged ring. As she resumed the testimony that occupied all of yesterday's session Miss Burwell said that she made the threat in a letter to Julian Diaz, Tampa attorney, whose secretary she was and who was held in jail with Miss Burwell in connection with her attempt to pass three fraudulent \$100 bills. Diaz, now serving a Federal sentence for counterfeiting conviction, had made the bills, she testified.

Under cross examination by defense Attorney C. J. Harde, the Burwell woman said that she made the threat in a letter to Julian Diaz, Tampa attorney, whose secretary she was and who was held in jail with Miss Burwell in connection with her attempt to pass three fraudulent \$100 bills. Diaz, now serving a Federal sentence for counterfeiting conviction, had made the bills, she testified.

The witness identified a statement she had made to George Brodnax, government operative, after her arrest, she testified that the statement was true but that all of her knowledge of the counterfeiting project had not been included.

She bowed her head as Attorney Harde read from the statement a paragraph telling how she had wanted Diaz to keep out of any counterfeiting project but that he had exercised an influence over her for eight years which she was unable to resist.

## Compile Reports for Delegates to Naval Conference

Washington, Oct. 23.—(AP)—Secretary Stimson and state department officials are compiling technical reports for the use of America's delegation to the London Naval conference.

Actively assisting the secretary are Joseph P. Cotton, the under-secretary of state, and J. Theodore Marriner, chief of the western European division, both of who dealt intimately with the Naval question while Ambassador Dawes and Prime Minister MacDonald held preliminary discussions this summer.

Stimson has ordered that all information pertinent to the London meeting which may come into the hands of any in the department be made available to Marriner, who has been prominently mentioned as Stimson's chief coordinator and advisor at the conference.

Sonnenberg to Tackle Lewis in Bout Tonight

Los Angeles, Oct. 23.—(AP)—"Dynamite" Gus Sonnenberg, who trained the world wrestling championship by his rough-and-tumble flying tackle, faced a title bout with Ed "Strangler" Lewis tonight handicapped by a split lip and bruised nose received in a street encounter with a Los Angeles bond broker. Sonnenberg, bleeding profusely, appeared at a police station yesterday and said Pete La Dione, bond broker and amateur wrestler, butted his without warning during discussion of a possible bout between them. A battery warrant, sworn to by Sonnenberg, was issued later by City Prosecutor Lloyd Nix.

The mat champion said La Dione's head struck him in the face, causing the cut lip and bleeding nose, but that the result of the encounter would not interfere with his title match tonight.

Lewis, in preparation for his attempt to regain the crown, has trained with the University of Southern California football team in an effort to develop a defense against the flying tackle which lost him the championship to Sonnenberg. Sonnenberg is a former Dartmouth football player.

Sees Less Work for Laborers

Hanover, N. H.—Five-hour days, five-hour weeks and both summer and winter vacations for the masses of workers are in the firing line in the opinion of E. A. Flene, Boston merchant. He made the prediction in an address to Dartmouth students, saying mass production necessitates that the masses be able to buy what they want and be encouraged to want more.

Postpones Sentence of Mrs. Pantages

Los Angeles, Oct. 23.—(AP)—Superior Judge Carlos S. Hardy has decided to postpone indefinitely pronouncement of sentence on Mrs. Pantages, recently convicted in a manslaughter charge, when she appears for a hearing on her probation violation Friday.

Judge Hardy said today probation officers had not completed investigations of her case and should be allowed sufficient time to make the "most minute search." He pointed out that a delay would give the wife of Alexander Pantages, who is on trial charged with a statutory offense, time for recuperation from nervous excitement.

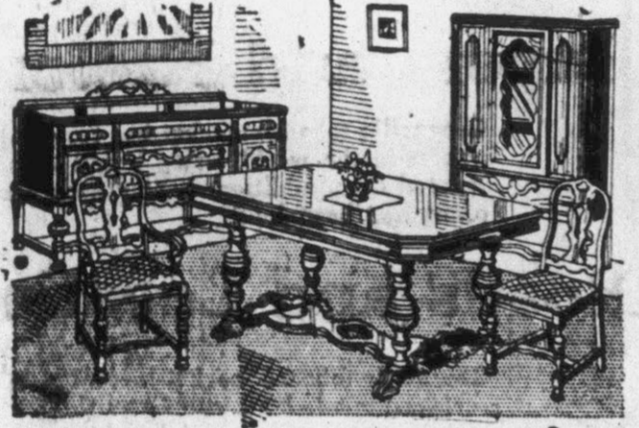

der school age against diphtheria,"  
said a member of the Pitt County  
Department of Health today.

"This is one of the most import-  
ant phases in connection with the  
campaign against diphtheria in this  
county. Out of the 68 cases of  
diphtheria reported in the county  
during 1929, 42 were among chil-  
dren under six years of age.

"This shows conclusively that the  
greatest danger lies not in the child  
of school age, but those who do not  
come under the compulsory inocula-  
tion legislation.

"While the diphtheria situation is  
much better in Pitt than in some  
other counties, it is highly import-  
ant that the public should consid-  
er the importance of immunizing  
themselves through inoculation.  
Only four cases were reported in the  
county last week."

This fund is one that was started several years ago by the late Mrs. Cotton to be used for college training of girls who borrow from the fund—the money to be replaced by the borrower after she begins work.

An achievement program will be held by the Home Demonstration club members in November. The date will be announced later.

A home lawn tour will also be made in November in order to see the lawns that have been improved in the county.

## GRAIN MARKET

Chicago, Oct. 23.—(AP)—Prices today gave distinct evidence of being affected by weakness of the stock market. In addition, overseas demand for North American wheat was of fair volume only, and there were bearish estimates current as to world import requirements. Total import needs of all countries were placed at but 896,000,000 bushels, compared with actual exports last season of 890,000,000 bushels.

Wheat dropped rapidly at the last and closed shaky, at the day's lowest level, 3 7/8 to 4 3/8 cents a bushel under yesterday's finish; corn 2 1/4 to 2 3/4 cents down; oats 2 3/4 to 1 1/8 off, and provisions ranging from 170 decline to a rise of 10 cents.
