SAYS INDUSTRY WILL BE AIDED BY COMMITTEE

Felker Tells Cotton Manufacturers Of Work of President Hoover's Comm.

Boston, Oct. 31.—(AP)—The industries of the country will be aided by the work of President Hoover's committee appointed to study problems of distribution, Frederick M. Felker told the National Association of Cotton Manufacturers today.

Mr. Felker, chairman of the committee, explained the relation of its work.

"A profitable business appears today to be one in which the management has secured some control over supply and demand through advance knowledge," he said.

"The coming census of distribution which is to be taken up by the government," he continued, "will have its primary value in setting up a basis of facts which will aid in the control of demand."

Marked improvement in the quality of cotton goods now obtainable over that of two years ago was noted by Ephraim Freedman of R. H. May and company of New York, speaking as a representative of the retailer.

"Unfortunately, however," he continued, "many manufacturers are debasing their products to sell at a price and many retailers are buying on this attitude is becoming self-evident through the falling off in sales and loss in profits."

Speaking from the standpoint of the manufacturer of shade marked goods, Ernest N. Hood, treasurer of the National Steam Cotton company of Salem, described sales difficulties.

Federal Reserve Discount Rate Cut Believed Imminent

Washington, Oct. 31.—(AP)—The decrease of one half of one per cent in the Bank of England discount rate today was accepted as the treasury as an indication that a decrease in the New York Federal Reserve Bank discount rate is imminent.

For the last seven or eight years there has generally been a spread of about one per cent difference in the Bank of England rate and the New York rate.

The decrease in the Bank of England rate today was dropped to 4 per cent while the New York rate now stands at that figure.

The increase in the Bank of England rate together with a tendency to easier money rates in this country was believed by treasury officials to be indicative of a lowering of the New York Federal Reserve rate.

Odd-Lot Buying Doubles On N. Y. Stock Exchange

New York, Oct. 31.—(AP)—Purchases of stock by odd-lot brokerage houses have, for the first time since last Saturday, doubled the sales as a result of orders from small investors.

For the second day in succession, transactions by the odd-lot houses are estimated to have passed the \$100,000,000 mark, but where on Tuesday selling orders were double the purchases, yesterday the reverse was true.

Flood of Buying Causes Sensational Advance On New York Stock Market

New York, Oct. 31.—(AP)—Heavy profit taking halted a wild stampede of buying in today's stock market after scores of issues had been marked up \$5 to \$30 a share, and gains of \$75 and \$95 a share had been registered by a couple of high priced specialties.

A mad scramble to buy stocks, influenced by the belief that the selling crisis had definitely passed, brought about a sensational advance in prices when the exchange opened for business. Initial transactions in many of the leading issues ranged from 10,000 to 70,000 shares.

President Hoover Urges Senate Leaders to Speed Up On Tariff Schedules

Washington, Oct. 31.—(AP)—A statement was issued at the White House today explaining that President Hoover in a conference with senate leaders last night urged the expedition and early completion of the schedules in the tariff bill so the revenue measure could be sent to a conference with the house within two weeks.

"The president was visited yesterday by a number of senators, all of whom called at their own suggestion, and presented to him the grave situation that has arisen by delays in tariff legislation."

"He called attention to the fact that the senate has had the tariff bill since June, with fifteen schedules to work out, and has not yet completed schedule one. It was pointed out that a large amount of important legislation must be undertaken at the regular session which would be prevented by carrying the debate into the next session."

"Some of the senators considered progress hopeless as it appeared that the coalition intended to delay or defeat legislation, or did not give adequate protection to industry. Others felt that some understanding should be attempted among senate leaders by which the bill could be sent into conference with the house at an early date."

SEN. NYE ASKS FOR PROBE OF STOCK MARKET

Senator Would Provide Way to Remedy Speculative Operations on Wall Street

Washington, Oct. 31.—(AP)—A resolution was introduced in the Senate today by Senator Nye, Republican, N. D., proposing appointment of a special committee to investigate speculative operations on all stock exchanges.

The resolution went over for future consideration as required by Senate rules, without any discussion.

It would have the special committee recommend remedial legislation by next February. Another resolution by Senator King, Democrat, Utah, advocating a sweeping investigation of the credit situation is now before the Senate Banking committee with little prospect of consideration before the regular session in December.

The committee would include in its membership Chairman Norris of the Judiciary committee and Chairman Norbeck of the Banking committee, as well as the respective ranking minority members of these committees, Senators Overman of North Carolina, and Flynter, Fla.

The resolution says the speculative operations of the stock exchanges "threaten the stability and integrity of the entire industrial life of the country; and it is necessary that legislation be enacted to regulate purely speculative operations in the securities representing the physical equipment of the industrial structure of the nation."

CANCER CLINIC DESCRIBED AS SUCCESS HERE

Total of 96 Persons Examined for Cancer at Local Hospital Yesterday

A total of 96 examinations were made at the cancer clinic conducted at Pitt Community hospital in this city yesterday, according to information given out this morning by Dr. Clem Ham, director of Public Health work in Pitt county.

The clinic was conducted under the auspices of the American Society for Cancer Control, assisted by the State and county health departments and the staff of the local hospital. Examinations were conducted by Dr. H. H. Bass, of Durham, North Carolina, chairman of the Society for Cancer Control.

It was stated that 110 persons reported for examination, but only 96 were examined despite the fact that the clinic remained open until about 9 o'clock last night. Those who failed to be examined were requested to report at the hospital the early part of next week when their cases will receive attention.

The examinations were a revelation of the cancer situation in this part of the State. Thirteen positive cases were discovered, three of which were described as inoperable.

Thirty-five persons were found to be in a pre-cancerous condition, or have cancer in an incipient stage. Forty-eight examinations were negative.

Dr. Ham said they were highly gratified at the splendid results of the clinic and the co-operation of the public in helping make it the success it was.

S. S. Marquette and the Senator Run Together Thirty Miles Off Port Washington; Senator Sinks Almost Immediately With Only Two or Three Members of Crew Saved; Badly Crippled Marquette Makes Way Toward Sheboygan

Milwaukee, Wis., Oct. 31.—(AP)—Two freight boats, the S. S. Marquette of the Cleveland Cliffs Iron company, and the Senator of the Nickolson Universal Steamship lines were in collision 30 miles off Port Washington this morning. The Senator sank almost immediately with 33 reported lost.

Two of the crew of the Senator were picked up by the Marquette, which is standing by. A dense fog covered the lake this morning.

The Senator carried automobiles, wireless reports from the Marquette said that despite damage she would be able to make Sheboygan.

The first S. O. S. was picked up by the Wright Steamship company of Sheboygan. It was sent by the Marquette at 10:45 A. M., five minutes later Sheboygan Coast Guardsmen left for the wreck.

Coast Guardsmen under Captain William Kincaid and four tugs left Milwaukee harbor also.

At 11:30 A. M. the Marquette wireless that she was listing badly. Four fishing tugs from Port Washington also put out to join the rescue fleet. In view of the dense fog, one of the wisest that has enveloped the lake in years, it was thought the various boats would have difficulty in locating the Marquette. The Marquette is an operator.

TIGERS TIED FOR NATIONAL GRIDIRON LEAD

Atlanta, Oct. 31.—(AP)—The Clemson Tigers are tied for the national football lead in games won, but the South Carolina Pongal lost the Southern Conference scoring leadership last week to Louisville.

By scoring 53 points against Louisiana Poly while Clemson was defeating South Carolina, 21-14, the Louisiana Tigers hopped into the top position, where Clemson has been holding forth ever since hostilities began.

In five games Coach Russ Cohen's eleven has rolled up 223 points. Clemson runs second with 263 points in six games and Tulane is third with 167 in five games.

Other Conference teams which have scored more than 150 points are North Carolina, 159; Tennessee, 157 and Kentucky and Alabama each with 151.

So far Kentucky has presented the stoutest defense. In four contests only six points have been tallied against the Wildcats.

Duke and the University of Mississippi are staging a hot race for consolation honors. Mississippi has had 169 points marked against it in five games while Duke's defense has permitted 161 points in four games. All but six of these were scored by eastern teams.

The Mississippi A. and M. eleven packs the weakest punch in the Conference. So far the Aggies have rung up but 19 in four games. Auburn and North Carolina State are almost as bad with 21 to 20 points each.

HEELS EXPECT BIG FIGHT WITH WOLFPACK FOE

Chapel Hill, Oct. 31.—Underdog or underdog—which is favored psychologically in a football game? The answer may be seen, partly at least, when North Carolina's Tar Heels engage N. C. State's Wolfpack here Saturday in the 22nd renewal of a 35-year old grid rivalry.

For, of 21 meetings between the ancient rivals, the Tar Heels have won 13, tied five, and lost but three.

The important question just now is will underdog or underdog philosophy prevail Saturday?

The ancient rivalry began in 1894, and it took the Wolfpack exactly six seasons, and seven games to cross the University goal line.

The first score for State came in a 11 to 11 tie game in 1899. The next time a red-jerzed ball carrier passed the Tar Heel goal was in 1919, following the renewal of relations after the World War.

Each season from 1894 until 1931—the Tar Heels won by large scores ranging from 16 to 0 to 44 to 0.

In 1902 and 1905 the Wolfpack worked out a scoreless tie, but a break in relations followed the 1905 meeting, and the Tar Heels had to wait until after the World War for their first win.

The Tar Heels barely won the first post-war game 13 to 12, and Dick Gurley, now coach at Lenoir-Rhyne, accounted for Wolves to victory in 1920 by a 13 to 3 count.

Kuntz Lows booted a field goal that day to save the Tar Heels from a shut-out, but the following year Lowe fumbled and gave State a chance to win the 1921 game 7 to 3. Runt Faucette, Raleigh boy and State college quarterback, recovered Lowe's fumble and sprinted half the field for the winning touchdown.

"Monk" McDonald, "Red" Johnson, Emmett Underwood and other Tar Heel stars renewed the winning habit. "Monk" McDonald ran 95 yards for a touchdown to feature the 14 to 9 victory of 1922. For four years the Tar Heels blanked the Wolves.

The great Jack McDowell upset the count in 1927 to lead the Wolves to a 19 to 6 win. The Tar Heels were doped to win by two touchdowns last year, but a great Wolfpack held them to a 6-6 tie.

Season records favor the Tar Heels this year, but the traditional Wolfpack fight has many supporters predicting one of the Tar Heels' narrowest nights for Saturday.

On October 23, 1907, during one of the severest panics in the market's history, he issued a statement expressing confidence and began to buy round common stocks. His action, taken a day previous to the formation of a \$25,000,000 pool by J. P. Morgan, had a stabilizing effect on the market.

Noted Actor Dead

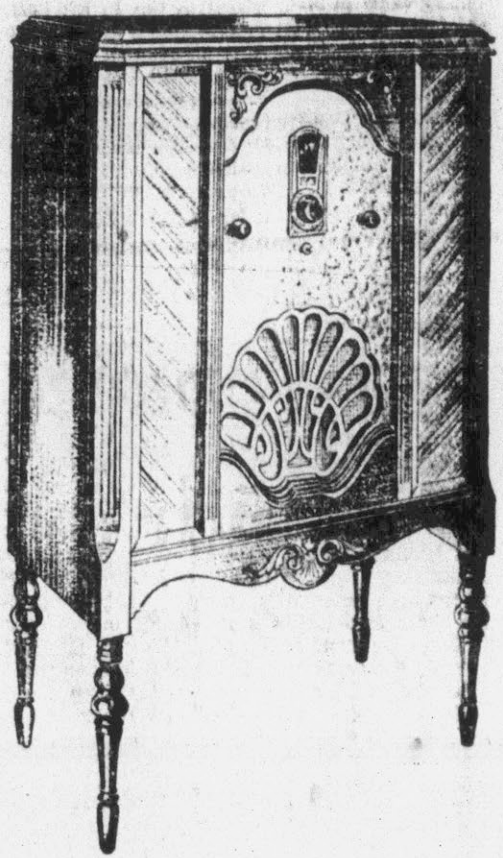

"Nobody can doubt but that they need it. The sessions of the exchange have been the most exciting and upsetting in years, and the strained nerves of the hundreds of employees unquestionably need rest and complete relaxation. "With the price situation a little nearer stabilization than it has been in several days, the entire country will feel more at ease, especially that great number of people whose fortunes were involved in the bear trading."

S. C. DOWNS BULLDOGS AT ORANGEBURG

Fair Grounds, Orangeburg, S. C. Oct. 31.—(AP)—Through the power, speed and deception of their phantom backs, the University of South Carolina downed the Citadel Bulldogs, 27 to 14, in their annual game here today. A crowd estimated at 9,000 spectators witnessed the game. Long runs by "Bru" Boineau accounted for two of the touchdowns made by the Birds. A pass, Rhame to Stoddard, resulted in another touchdown while the other score was made on a line plunge after the ball had been advanced down the field on a series of end runs, passes, and penalties. The Citadel touchdown, the first of the game, was the outcome of Wilson's 57-yard run down the field followed by an end run for 13 yards by Whittington. Outstanding in the attack of the Gamecocks, which was spotty and hardly ever sustained, was L. C. Neal, who ran in scores of touchdowns, and Hugh Stoddard. The latter blocking and tackling, as well as his offensive thrusts were always in prominence. The Citadel found some offensive strength in its backfield combination, Wilson being the most conspicuous ground gaining performer, but because her line was out charged and her blocking indifferent at crucial stages, the Cadets were forced to bow again to their ancient rival.

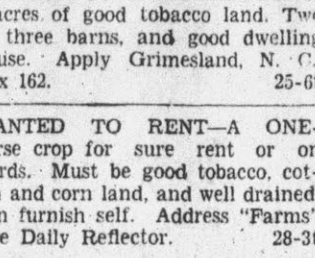

Judge Frank Daniels, law partner and associate of Governor Aycock for years, will make the address of the occasion. He will be introduced by Captain Nathan Oberry, state treasurer.

The tablet, designed by Gutzon Borglum, famous sculptor, was presented to Wayne county by the Aycock Memorial committee of Raleigh, in recognition of the service rendered by its citizens in making possible the Aycock monument on Capitol Square, Raleigh. Dr. J. Y. Joyner, chairman of the Raleigh committee, will present the tablet, which will be accepted for Wayne county by W. A. Dees, of Goldsboro.

Misses Lucile Aycock and Jean Pos, granddaughters of Governor Aycock, will unveil the tablet. Rev. George T. Watkins, Durham, N. C., former pastor of Governor Aycock, will render the invocation, and Rev. Peter McIntyre, Goldsboro, will pronounce the benediction.

(Canberra, Australia, Oct. 31.—(AP)—James Henry Scullin, premier, announced today Australia would be represented at the naval conference to be held in London in January.

Mortgage Bankers to Close Meeting At New Orleans

New Orleans, Oct. 31.—(AP)—Delegates to the annual convention of the Mortgage Banker's Association of America planned to wind up general discussion and routine matters today prior to adjournment. The meeting opened here Tuesday, attended by leading financiers and officers of the nation's mortgage houses.

The bankers last night heard F. M. Bass, attorney of Nashville, Tenn., urge the adoption of a uniform mortgage law by all the states, to accomplish what he said would be vast savings to be passed down to the borrower and to make the mortgage a more liquid security.

Mr. Bass, who is general counsel of the Mortgage Bankers association, said a model uniform law had been drawn up, attested, and was ready for submission to the 48

state legislatures subject to the association's approval.

Philip W. Kniskern, vice-president of the Continental Mortgage Guarantee company of New York also spoke at the night session, dwelling upon the view that the American public today is more interested in capital appreciation than in return on capital investment. He asserted industry is raising its money by junior securities in the form of common stocks instead of by the insurance of bonds.

GOVERNOR GARDNER TO FIND HIMSELF IN DILEMMA SATURDAY

Chapel Hill, Oct. 31.—Governor O. Max Gardner, may find himself in a football dilemma Saturday. North Carolina and North Carolina State, ancient rivals, clash here in a game that will make and break championship hopes for two undefeated members of the Big Five. Governor Gardner played at both schools, when athletes could do such things. Both institutions claim him. Who will he root for Saturday?

Rioting Occurs In the Streets of Bucharest

Bucharest, Rumania, Oct. 31.—(AP)—Rioting took place in the streets of the capital last night following a stormy meeting of General Averescue's Liberal Party which demanded the resignation of the present Maniu government.

The police activities enraged the Liberal Party leaders who telephoned to the secretary of the interior that they would chastise him if he ventured on the street.

Later General Averescue sent a deputation to the regency repeating the demand for deposition of the present government.

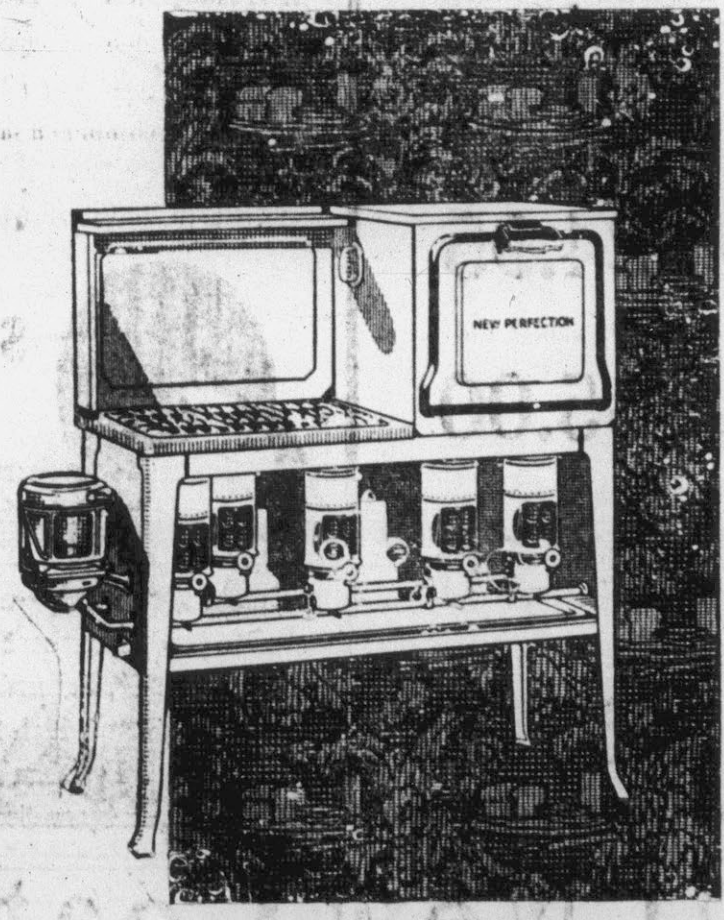

France Enters Her Tenth Day Without Cabinet

Paris, Oct. 31.—(AP)—As France entered its tenth day without a government, Etienne Clementel, today went about the task of recruiting a ministry. Those in close touch with the situation believed the veteran political leader would have a tentative cabinet list ready this evening to submit to President Doumergue.

Clementel already has assured him of the collaboration of Aristide Briand, premier-resigned, in the foreign office portfolio, and according to reports, has persuaded Henri Cherax and Louis Loucheur to continue in the finance and labor ministries.

Following announcement of failure by Edouard Daladier, a fellow radical socialist, to perfect a government, Clementel was asked by President Doumergue to form a cabinet.

It was expected Clementel's list would bear a close resemblance to the last cabinet of Raymond Poincare, and in effect would be a center government with a strong left tinge. M. Clementel himself was said to intend to hold the commerce ministry, and to allow his radical socialist party to fill the important interior portfolio.

Begin Battle for Custody of Boys

Knoxville, Tenn., Oct. 31.—Prospects of a bitter and lengthy court battle for custody of two young sons of Mrs. Franklin Hardinge, wealthy Chicagoan's bride of six months, increased today as attorneys prepared summonses for more than 200 witnesses. Neither litigant would reveal the purpose of the long list called by each side.

Norman and Troy Weens, Jr., 6 and 8 years old, were placed for the time being with their mother under temporary writ of habeas corpus. Hearing of her application for a permanent writ will begin on Monday, and will be contested by her divorced husband, Sergeant Troy Weens of the United States Army. He arrived here yesterday from Fort Benning, Ga.

Two criminal cases resulting from the dispute are scheduled Saturday. Mrs. Hardinge, her sister and her mother, accused the boys' grandparents, Mr. and Mrs. Joseph Weens, of assault in a visit to the Weens home near here, the Weens retaliated with charges of trespass against Miss Nell Eatherly, Detroit, and Mrs. Rebecca Eatherly, Nashville, sister and mother of Mrs. Hardinge. J. Arthur Atchley, attorney for Mrs. Hardinge, announced he would leave today for Chicago to confer with Franklin Hardinge, manufacturer.

Mrs. Hardinge divorced Sergeant Weens there two months before she gave up a waitress' job to marry Hardinge.

Chemical Analysis of Woman's Body to Take 3 Weeks

Anderson, S. C., Oct. 31.—(AP)—Chemical analysis of Mrs. Clemmie Garrison Tucker's vital organs is expected to consume from two to three weeks. Dr. B. F. Robertson of Clemson college, who was given the task of determining whether poison caused the woman's death 13 years ago said work upon another examination would prevent him from completing it in a shorter time than that.

Dr. E. Scott, chemist; Samuel E. Murrell, attorney, James Venable and Thomas B. West, all of Atlanta, who secured the permit for disinterment of her body continued today to conceal details of its purpose, although it is known they wish to determine whether poison was the cause of the death. Mrs. Tucker was born and reared in Anderson, but was living in Atlanta when she died. She is understood to have left an estate valued at \$300,000.

Conservatives Win In Canada Election

Toronto, Oct. 31.—(AP)—Retained in power by the biggest plurality ever given a government in Ontario, the conservatives today saw vindication of their policy of government control and sale of liquor. Insituated three years ago by the government of Premier G. Howard Ferguson, the government control act was the principal issue in yesterday's general election with the progressives demanding bone-dry legislation and the liberals a plebiscite.

The conservatives, holding 75 of the 112 seats at the dissolution of the last legislature, increased their number by 15 with four seats still doubtful today. Premier Ferguson, whose government was returned to power for the third time, was himself returned with a majority of more than 2,000 votes over his progressive opponent, the Rev. T. H. Bradley.

GRAND JURY FINDS COUNTY AFFAIRS O. K.

Report to Judge Midyette Shows Each Department Functioning Efficiently

Declaring they found that the affairs of the county were being well cared for, members of the six month grand jury yesterday presented their report to Judge Garland Midyette, of Jackson, presiding over the one week's term of Pitt county superior court which convened in this city last Monday morning.

The report stated that the jury had visited all of the county offices and had found that they were being efficiently managed. Only one recommendation was mentioned and that pertained to the condition of an inmate at the county home.

The report follows: Report of Grand Jury October Term, 1929, to His Honor G. E. Midyette, Judge Presiding:

The Grand Jury of this the October Term 1929, of Criminal Court has to submit the following report:

The Grand Jury carefully considered and passed on all bills submitted, that they had witnesses for and presentments have been made in all cases, when the evidence so justified.

The Grand Jury has visited the various offices of the county as follows:

Clerk of the Superior Court, Register of Deeds, Board of Education, Tax Supervisor, Auditor, Treasurer, Sheriff, Welfare Department and the County Farm Agent. It has found in each instance that the affairs of the county are well cared for and that the officers are efficiently managed.

The Grand Jury visited the following institutions: The County Home under the management of Mr. Corbett, was found in good condition. The inmates appeared to be well satisfied with the care and attention received.

The Grand Jury found one inmate, a Mr. Cambell with bed sores on his body, and a few bad bugs on his bed. The Grand Jury believes this old man should receive as close attention as possible for the few remaining days of his life, as they do not think he will live much longer.

The County Jail was carefully inspected by the Grand Jury. The prisoners appear well provided for and the sanitary conditions of

the building was found to be good. The Road Camp was also visited by the entire Grand Jury. The cages and grounds were well kept. The sanitary conditions are excellent and the physical and mental conditions of the prisoners seen at the camp is very good.

We commended the Presiding Judge for the manner in which he conducts his court and express our appreciation to the Judge, the Solicitor and all court officers including the grand jury officer for their pending co-operations. Respectfully submitted, this 30th day of October, 1929.

Union of Churches Affects Thousands

Raleigh, Oct. 31.—(AP)—Union of the Congregational and Christian churches will affect 50,000 members of the two denominations in North Carolina, Dr. J. Edward Kirby, pastor of the united church here, estimates.

Final steps for union of the two churches which together have a membership of more than one million persons were completed at the general conference of Congregational Churches of America, held at Piqua, Ohio, this week. The Christian denomination approved the union last June.

Nationalist Leader to Direct Campaign Against People Army

Hankow, Oct. 31.—(AP)—Chiang Kai-Shek, head of the Nationalist government and General Lissimo of its military forces left today aboard an armored train for a northern destination.

Chiang presumably will take command of the Nationalist forces at Chengchow, important railway center in Honan Province, where civil war is in progress. The nationalist leader is expected to personally direct an offensive against the "people's army", which is in revolt.

Three Officers Shot in Raid

Erwin, Tenn., Oct. 31.—(AP)—Somewhere in the forested fastnesses of the Unaka range, a hidden rifleman who wounded three officers was believed concealed today. The officers were prepared to "shoot him or arrest him", while one of the victims lay near death at a hospital here.

On a raid for whiskey yesterday, Deputy Sheriff W. M. Barnett of Erwin was shot through the abdomen. Doctors said he had little chance of recovery. Seeking Bar? next's assailant, Sheriff Sam. Coon of Unicoi county and Sheriff J. B. Worley of Washington county were "hot down" near the same spot. Neither was believed seriously hurt.

Carter county officers joined Washington and Union deputies. Their only guide was Sheriff Coon's statement that he saw Cass Atkins, escaped state convict, run through the woods just after the second shooting. Atkins escaped recently from Brush Mountain penitentiary, where he was imprisoned for wounding another Unicoi county officer last year.

North Carolina officers were asked to guard against escape across the nearby state line.

American Actress Answers Criticism of Her Sisterhood

London, Oct. 31.—(AP)—Lillian Foster, American actress, has answered in the original and striking manner the complaints of all her American sisterhood against adverse British theatrical criticism.

The Daily News said today that Miss Foster yesterday saw Hanner Swaffer, prominent English dramatic critic, in the smart luncheon room of the Savoy hotel, and slapped him publicly in answer to his recent critical remarks of her role in "Conscience", which has just opened here.

The writer had likened Miss Foster's voice to that of a ventriloquist's doll, taking exception to her American accent, noticing him in the luncheon room of the Savoy. Foster walked up to his table and asked if he knew who she was.

He answered "no", whereupon she mentioned her name and added: "I am going to repay in an American woman's way the compliments you paid me." She then slapped his face twice, and told him if he continued to say "such un-called-for things" she would slap him again. "Conscience", written by Don Mullally, was produced in New York in 1924. Miss Foster's performance as a waitress "who married to give her feet a rest" was acclaimed generally, and brought her promotion to stardom.

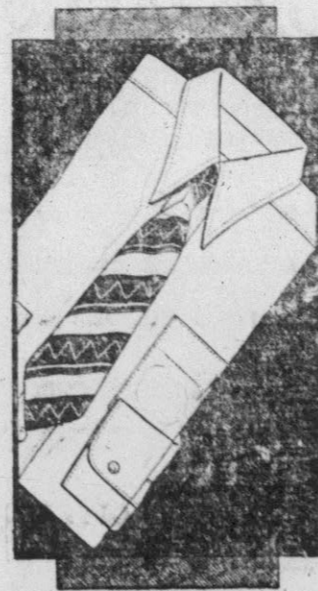

STOCK MARKET

 New York, 31.—(AP)—The rally in stock prices, which started yesterday when powerful buying support was supplied by leading financial interests, was resumed with considerable violence at the delayed opening of today's market. Prices of scores of issues bounded upward 5 to 30 points at the start, and one stock jumped 75 points above the previous sale, but the wild advance attracted heavy profit-taking which quickly carried many stocks down 7 to 10 points below the opening quotations.

Reduction of the Bank of England discount rate from 8 1/2 to 6 per cent, which was expected to be followed by a reduction in the New York Federal Reserve discount rate after the close of the market, coupled with the statement of John D. Rockefeller, Sr., that he and his sons were buying sound common stocks, and the announcement of several special dividend distributions, all contributed to the revival of confidence in the market.

The call money renewal rate was fixed at 6 per cent before the market opened.

Several favorable dividend announcements developed during the day, directors of the Consolidated Gas company raised the annual dividend from \$3 to \$4, and United States Dairy products on the class-A stock extra payments were announced by the Standard Oil Co., of Indiana and the New Jersey Zinc company and initial disbursements were authorized on the common stocks of the National Public Service corporation and the Bufova Watch company.

Sharp opening advances in many stocks indicated an absence of nearby bids, many of which had been withdrawn overnight. Auburn auto jumped 75 points, Underwood Elliott Fisher 6, Standard Gas & Electric 26 1/2, North American 24 1/2 and Atchison, Westinghouse Electric, Fox Film, National Biscuit, Norfolk & Western, Brooklyn Union Gas, Eastman Kodak, International Harvester, Chesapeake & Ohio, Sears Roebuck, International Telephone and American & Foreign Power 15 points, or more.
