

TARIFF HEAD TESTIFIES AT LOBBY PROBE

Tells of Proposal to Send Men to Congress to Vote for Protective Tariff

Washington, Nov. 1.—(AP)—General Arnold, vice-president and general manager of the Southern Tariff Association, testified before the Senate lobby committee today that the organization had suggested that "men be sent to Congress" to vote for a protective tariff.

Under questioning, Arnold said this was the only way to obtain protection.

"Do you help elect or try to elect Congressmen in any districts?" asked Senator Walsh, Democrat, of Montana.

"I can't say that we have," the witness answered.

Arnold testified members of the tariff association had discussed the pending tariff bill with some Senators.

"What did you do?" asked Walsh.

"I spoke to the Florida Senators and we presented a memorial to Senator Watson of Indiana (the Senate Republican leader), he replied adding a committee of which he was a member, talked with Senators Connally of Texas, Black of Alabama, and Harris of Georgia, all Democrats.

Walsh produced a letter written to Brown White of San Benito, Tex., by Arnold on October 9, which referred to "whispering friends."

"Who was referred to?" Walsh inquired.

"I suppose it referred to Congressman Garner of Texas," Arnold said. Garner is House Democratic leader.

Another letter read by Walsh written by White to Arnold, referred to "our friend, whispering Johnny," which Arnold said also referred to Garner.

Walsh read again from White's letter, which said he was glad of "the help of Del Rio, Texas, was rendering for Congress."

"Is he a Democrat or Republican?" Walsh asked.

"I don't know," Arnold previously had testified it made no difference to him what party a man belonged to.

Another letter from Arnold to White said "our whispering friend" was "running a big bluff down there," and added that Senator Watson asked Arnold to appear before the Senate finance committee.

The letter added "Here is an instance in which the whispering Congressman is put out of the room."

Arnold explained he meant that the Democrats in the House were not permitted to participate in writing the tariff bill.

The committee added that White was having "quite a problem" in "exposing" Garner, and said "But you are making progress and conviction, I am sure, as you go along."

A letter from Arnold to Chairman Smoot of the Senate finance committee then was read by Walsh. It asked permission for a Mr. Wilson of Jacksonville, Fla., to obtain a "private hearing" with Smoot regarding rates in the tariff bill.

"Why did you ask for a private hearing?" Walsh demanded.

"Because they were not holding public hearings," Arnold said, adding Senator Fletcher, Democrat, of Florida, made an engagement with Smoot for Wilson.

The suggestion was made in another letter from Arnold to Wilson to "flood Senator Smoot with telegrams" urging removal of the seasonal clause on gulf coast products.

Arnold did not know whether the suggestion was carried out. He said the provision discriminated against Florida.

AGRICULTURE SAID TO BE IN BETTER SHAPE

Department of Agriculture Says Conditions Better Than Last Year This Time

Washington, Nov. 1.—(AP)—The Department of Agriculture announced today that its November reports showed agriculture to be in a strong position this year than a year ago largely on account of lower production and higher prices.

Since early summer, the department said, prices of practically all groups of farm commodities with the exception of eggs, animals had increased.

The total output of principal food and feed crops this year, it continued, would be somewhat below that of last year although the acreage harvested would be about the same. Hay was listed as the only important crop which substantially exceeds production of last year.

Notwithstanding favorable weather in September the department added, crops of grain, potatoes and tree fruits would be smaller than last season and it now seemed probable that yields per acre of all crops combined would average 7 per cent below yields last year and 4 per cent yields of the preceding two years.

Bootlegger Held for Peddling Rum in Senate Office

Washington, Nov. 1.—(AP)—Arrested at the entrance of the senate office building, George L. Cassidy, once known as "The Man in the Green Hat," was at liberty today on a \$3,000 bond, posted on charges of transportation and possession of intoxicating liquor.

Cassidy was prominent in the news several years ago when he was identified as the man who had, when accosted by an officer in the house office building, dropped a brief case containing a bottle of liquor and fled. The policeman in question remembered only the color of Cassidy's hat and a search was instituted for "the man in the green hat," which finally resulted in his arrest.

The second arrest came yesterday, police had followed him from his home to the senate office building, where he left his automobile and entered. A few minutes later he emerged, took a package from the car and started again toward the entrance. Then he was arrested.

The police said the package he carried contained a bottle of whiskey and that two more were found in the machine. A search of his home, they said, disclosed a stock of 366 quarts of assorted liquors.

Republican Says Prosperity Statements Had Nothing to Do With Market Break

Washington, Nov. 1.—(AP)—Senator Robinson, Republican, Indiana, characterized as "unfair and unjust," in the Senate today the statement by Senator Robinson of Arkansas, the Democratic leader, blaming the stock market collapse on the prosperity statements of President Hoover, former President Coolidge and Secretary Mellon.

The Indiana Senator said he was hesitant to reply to the minority leader's statement, because of his absence from the chamber, but added he felt such a charge could not go by unchallenged.

Senator Blaise, Democrat, South Carolina, interrupted to say the reply should not be made in view of the fact that Robinson was quoting the statement from a newspaper. The Indiana replied if the statement was not correct, the Arkansas Senator could reply to his remarks.

Notwithstanding recent conservative warnings of an impending crash in stocks, Robinson said, people continued to buy, and that President Hoover, former President Coolidge, nor Secretary Mellon "have encouraged speculation of this kind."

"None has been known as a speculator," he added, "and none has suggested that the people should gamble in the stock market in New York or elsewhere."

The Indiana Senator stated that Raskob had made his fortune as a stock "plunger" and described his feat as "lucky plunging." MacDonald Returns Home; Believes Trip To America Furthered Peace of World

Liverpool, Nov. 1.—(AP)—Ramsey MacDonald, debarking at dawn today from the steamship Duchess of York which brought him back to Britain from an American visit, declared he believed his trip had furthered the interests of world peace and had been a success.

"I believe sincerely that my meeting with President Hoover and my conversations with him and with other United States statesmen have brought our two peoples much closer together and improved enormously their mutual understanding," he said in a formal statement to the press.

"My mission has also, I am convinced paved the way for more efficient cooperation with the other powers in maintaining the peace of the world. Strong in this conviction I feel that thus far the purpose of my mission has been fulfilled and that the way is now cleared for the next steps."

He said the exchange of views he had had with Prime Minister MacKenzie King of Canada, both on his United States mission and on Imperial affairs, was also most advantageous and timely.

"Throughout my visit I have endeavored as best I could to voice what I believed to be the peaceful aspirations of the British people in all parts of the Empire and to that I have met with nothing but the most welcome response."

"I am encouraged in this confidence by remembering that I have been accompanied throughout by representatives of the press of all shades of opinion and that the press of this country, the United States and Canada, has been most uniformly favorable and helpful to the ends I have had in view. I should not like to say goodbye to those who have been with me without this expression of thanks."

The British Prime Minister, returned today to an England coated with frost, but as warm in his welcome as his weather was chilly.

It was just dawn as his ship, the Duchess of York, reached the landing stage on the Mersey here and Liverpool civic officials boarded her to bid him and his daughter, Miss Isabel, welcome before their departure an hour afterward for London.

On the dock, while with frost, a few hundred friends and well-wishers had gathered to cheer his arrival. Crowds of workmen shouted, "Good Old Mac" and "Glad to see you again, Mac" as his party debarked and made for the train shed where a special car was attached to the regular boat train.

Lord Derby, Lord Myer Miller of Liverpool, and delegations of city councilors and labor organizations were among those who went aboard the Duchess of York to greet the returning premier.

Prior to meeting his reception committee Mr. MacDonald gave to the newspapermen who accompanied him from Quebec a formal statement in which he said his mission to America and to Canada had been successful and that he believed his conversations with President Hoover would further the ideal of world peace.

The Prime Minister, refreshed by one long last full night's sleep, assured his well-wishers he was in the best of health and overjoyed to be back on British soil. He seemed buoyant and jovial, and was hearty in his greetings.

His return was just more than a month after his departure on Sept. 28, aboard the Berengaria for New York and Washington, where he conferred with President Hoover on matters of naval disarmament and British American relations.

SEVENTEEN GREENSBORO PEOPLE KILLED IN WRECKS DURING PRESENT YEAR

Greensboro, Nov. 1.—(AP)—Seventeen Greensboro citizens were killed and 274 injured by automobile accidents in Greensboro during the year ending September 30, the statistical report of Chief of Police George P. Crutchfield revealed today.

Fatalities during the last year numbered five more than during the preceding year, while motor car accidents for the last year totaled 601 as compared with 572 for the preceding year, the report showed.

Mr. Mett, who is chairman of the board of directors of the bank, announced late Thursday that approximately \$800,000 of the bank's money had been misused by employees, but that the loss was covered by insurance.

Fall Given Year In Jail And Fine of \$100,000; Also Denied New Trial

Washington, Nov. 1.—(AP)—Albert B. Fall, former cabinet officer convicted of receiving a \$100,000 bribe, today was sentenced to one year in jail and fined \$100,000 after a motion for a new trial had been denied by Justice Hitz in the District of Columbia supreme court.

Fall, found guilty last week of receiving a \$100,000 bribe from Edward L. Doheny, oil operator, was granted bond pending an appeal.

Under the law the maximum sentence that could have been given for the former cabinet member was three times the amount he received or a \$300,000 fine and three years in a federal prison.

The defense attorneys made a brief and formal motion and the proceedings were over in a few minutes.

Justice Hitz said had Fall been in good physical condition he would have imposed full sentence but that in view of his health he would have suspended sentence if it were to take effect once.

The court let defense counsel understand that if the appeal were dropped he would suspend sentence as long as Fall's physical condition was such as it is now.

Doheny, accused of giving Fall the bribe in return for a lease on the navy's Elks Hills, Cal. oil reserve, was not in court when the former secretary of the interior was sentenced. And in contrast to the tumultuous scenes in court when Fall was found guilty, there were no demonstrations today.

Fall showed no signs of emotion. Mrs. Fall sat beside him and his two daughters were among the spectators. Mrs. Fall leaned forward over her husband's right shoulder and talked with him and patted him on the left shoulder.

Fall said he had no statement to make. He waited for fifteen minutes for his new bond of \$5,000 to be prepared for his signature. It was signed by the National Surety Company.

While he was waiting to sign the bond his daughters, Mrs. C. C. Chase and Mrs. J. Elliott, stepped to his side and Mrs. Chase, sitting on the right arm of his chair threw her arms around his shoulders.

Fall's three attorneys were present, including Mark Thompson, who collapsed in the courtroom when the jury returned its verdict.

Defense counsel, headed by Frank Hogan, based their plea for a new trial largely on Justice Hitz' charge to the jury which they contended was prejudicial and on the admission of evidence regarding the lease of the Teapot Dome naval oil reserve to Harry F. Sinclair.

In his plea for a new trial Hogan merely outlined the grounds on which he based his motion and they were overruled without government counsel having to make a reply.

Just before sentence was pronounced Thomas E. Norris, foreman of the jury which convicted Fall, and Miss Virginia Cooper, 23 year old stenographer, a jury member, took their seats in the audience.

As soon as his bond had been signed, Fall, accompanied by his physician and members of his family, returned to his hotel.

J. W. CRAFTON FOUND GUILTY IN COURT HERE

A jury sitting in the criminal term of Pitt county superior court in this city today returned a verdict of guilty in the case of J. W. Crafton, local traveling salesman, charged with manslaughter in connection with the death of J. L. Yandell, of Tarboro, who was killed in an automobile wreck last April. The jury recommended mercy of the court in announcing their verdict.

Sentence will be passed tomorrow morning at 9:30. Judge Midyette intimated following decision of the jury.

After disposing of forty or more cases, the criminal term of Pitt county Superior court which convened here last Monday morning with Judge Garland Midyette, of Jackson, presiding, was today considering the case of J. W. Crafton, Greenville traveling salesman, who is charged with manslaughter in connection with the death of Rev. J. L. Yandell, of Tarboro, who was killed when his car was hit by an automobile driven by Crafton during the early part of last April.

The case came up for consideration yesterday afternoon and indications were that it would reach the jury sometime today. Final arguments were completed during the morning hours, after which Judge Midyette was scheduled to deliver his charge to the jury.

The case is one of the outstanding of the present session and considerable testimony has been presented by both the State and defense. Crafton was bound over to Superior court following preliminary hearing a short time after the wreck happened. The crash occurred on the Greenville-Bethel road when Crafton attempted to pass another car. Mr. Yandell was thrown from his car and died a few minutes afterwards.

Several other cases were disposed of yesterday before court started to work on the Crafton case. Ermine Johnson, colored, charged with assault with a deadly weapon, had judgment suspended on payment of cost.

Lionie Bright, charged with manufacturing home brew, paid a fine of \$25.00 and cost.

Jarvis Whichard paid a fine of \$50 and cost, and was ordered not to drive another car in three months after being adjudged guilty of driving while drunk.

TARDIEU WILL TRY TO FORM NEW CABINET

French Moderator Formally Accepts Invitation to Select French Ministry

Paris, Nov. 1.—(AP)—Confident that he would be able to form a stable government for the weeks of crucial international negotiations, which face France until well into the new year, Andre Tardieu today formally accepted President Doumergue's invitation to form a new ministry.

The body announced today that he would handle his program, which observers agree is a very difficult one, by selecting individuals capable of maintaining a solid republican government rather than by consulting political parties.

Paris, Nov. 1.—(AP)—Tardieu promised President Doumergue a prompt answer to his invitation to form a cabinet and become France's next premier.

Taking the mandate returned to the president yesterday by Senator Tienne Clementel, radical socialist, the brilliant former high commissioner in the United States set out to build a government of the center and right center where M. Clementel and Edouard Daladier had failed to construct one from the left.

Like those two, the new premier-designate today had the promise of Aristide Briand, to serve as foreign minister in a new government. Political circles regarded the promise as conditional upon M. Tardieu's not going too far to the right—M. Daladier in going too far to the left—angered the former premier who then withdrew his support.

M. Tardieu's efforts today to get together his cabinet and end France's eleven days minus a government was hampered with passing of All Saints' Day, which in France is a public holiday. It was not believed he would be able to announce his list of ministers—if at all—until Saturday.

In that event the decrees would appear in the official journal Sunday and parliament would resume at the beginning of the week, which is essential if the national budget is to be voted before the end of the year.

It is sufficient for me at the moment to say that every statement of fact and every implication of fact contained in that article is untrue and in my opinion gravely injurious to public interest not only in this country but throughout the empire."

Other cities on the itinerary tentatively prepared by the association's executives are Winston-Salem, Asheville, Wilmington, Goldsboro and Durham at each of which the touring bankers will meet in conventions with North Carolina bankers from adjacent sections.

This tour, the second to be held by the association, will be limited to one week.



MR. TYDINGS AND PROSPERITY.
 "The stock crisis," says Senator Tydings of Maryland, in a statement issued through the Democratic National Committee, "belongs to the party in power. A Republican President, together with an overwhelming Republican majority in the House and Senate, was elected. The whole machinery of government is in their hands. If things have gone awry, they must take the responsibility." This statement is nonsensical. Given reasonably responsible government, whether by Republicans, Democrats or Socialists, and prosperity will take its own sweet course, rising, ebbing and rising again without reference to the decisions that are made in high places.
 If this could only be remembered by our voters, discussion of matters political might become appreciably less silly, parties might fix their attention on things that ought properly to engage them and cease concerning themselves with things over which they can have no more control than they have over the tides of the sea.—N. Y. World.
