## MAYOR WALKER VICTORIOUS IN N. Y. ELECTION

### Democrats Win Outstanding Victory on All Fronts in Largest City in Nation

New York, Nov. 6.—(AP)—Democracy was more firmly entrenched than ever in the country's largest city today as the result of a smashing victory all along the line in the quadrennial municipal election yesterday.

Mayor James J. Walker defeated Congressman Fiorella H. La Guardia; the Republican Fusion candidate by a plurality of 497,165. Tammany Hall was a bit disappointed in the figures for John F. Curry, the Tammany chieftain, officiating for the first time in a mayoralty campaign, had estimated the margin at 550,000.

The total vote was: Walker 865,549; La Guardia, 265,384.

But Walker, after his mark of about 40 years ago when he defeated D. Waterman.

Other than the Democratic tide wave, the feature of the election was the heavy vote polled by Norman Thomas, Socialist. Although only 4,000,000 registered as Socialists he received 174,311 votes, which represented the peak vote of his party here. The previous record Socialist vote was 145,532 by Morris Hillquit in 1917.

Many reasons were advanced for the Socialist showing. The one most generally accepted was that it was a personal tribute to the former clergyman, who last year carried the Socialist banner in the Presidential campaign. Another contributing factor, it generally was agreed, was that many Republicans of the conservative wing, who were hostile to Major La Guardia, cast their vote for Thomas. La Guardia and he were elected to Congress on a Socialist ticket and it is an open secret that many old-line, dyed-in-the-wool Republicans did not regard him as a member of the party.

Only in the case of Fred Queens did the Republican borough president, who fought his own organization for the nomination, was triumphant over Edward W. Cox, Democrat, by 26,560 votes. The vote was: Harvey, 142,219; Cox, 116,659.

Heretofore, Queens, like the other four boroughs comprising the Metropolitan, had been a Democratic stronghold. The upheaval started there last fall after the conviction of Maurice E. Connolly, Democratic Borough President, of graft in connection with a sewer construction scandal. Harvey was then elected for the unexpired term.

The Republicans swallowed a bitter pill in the contest for district attorney in New York county. Frederick H. Coubert, Jr., the Republican nominee, had violently assailed the Tammany administration for its failure to solve the murder of Arnold Rothstein, gambler. Thomas C. T. Crain, a veteran Tammany man, had stepped from the Supreme court bench to accept the Democratic nomination. District attorney, Jacob H. Benton had declined to run. The vote was: Crain, 214,967; Coubert, 118,194.

## Mill Workers Ejected From Marion Houses

Marion, Nov. 6.—(AP)—Sheriff Oscar F. Adkins today began removing twenty families of strikers from houses of the Marion Manufacturing Company. There has been no disturbance. Execution of ejection papers followed judgment given yesterday in Magistrate T. B. Conley's court. Through their attorney, D. F. Giles, the strikers gave notice of appeal to McDowell superior court, but so far have failed to post the appeal bond, one year's rent, required by the magistrate. One dollar per room per week was held reasonable rental by Magistrate Conley.

The North Wilkesboro unit of the National Guard, which relieved a Winston-Salem troop November 1, is still on duty in the mill village.

## SOCIALISTS AGAINST NEW GOVERNMENT

### Plan to Make Onslaught On Policy of Andrew Tardieu Tomorrow

Paris, Nov. 6.—(AP)—The newly completed ministry of Andre Tardieu, who will present his ministerial declaration to the Chamber of Deputies tomorrow, will face a determined onslaught to unseat it. The Radical-Socialists, without waiting for the ministerial outline of policy today decided unanimously to vote against the new government and emphasized its position by making such an adverse vote a matter of party discipline.

This action has stiffened the opposition and narrows the premier's already scant margin of safety as it has been hoped he might have the benefit of a few abstainers.

The Conservative press meanwhile highly approves Tardieu's refusal to let the party conventions dictate to the government and warns the political leaders that parliament will force the solution if a majority cannot be mustered.

The cabinet held a lone discussion today on the ministerial declaration and in the terms of an official communique found itself "in perfect unanimity on all points at issue." This included a demand for immediate discussion of the government's general and foreign policy.

Among the decisions taken this morning was that ministers will decline all invitations to banquets, luncheons and other gatherings as long as vital questions still remain to be decided.

## Democrats Win Sweeping Victory Through Virginia; Pollard Elected Governor

Richmond, Va., Nov. 6.—(AP)—Additional unofficial returns trickling in today served to increase the majority of Dr. John Garland Pollard, overwhelmingly elected governor in the state Democratic landslide yesterday. With only 57 of the state's 1,683 precincts missing, Dr. Pollard, in the light of tabulation compiled by the Associated Press, had a majority of more than 67,000 votes. The ballot stood: Pollard 163,268; Dr. William Moseley Brown coalition standard bearer, 95,531.

Richmond, Va., Nov. 6.—(AP)—Virginia was in the Democratic "Solid South" again today with John Garland Pollard, college professor, as her governor-elect.

Pollard, until the opening of the campaign, dean of the Marshall-Wythe School of Government and Citizenship at the college of William and Mary, led the victorious Democratic party to a surprising triumph over the coalition of anti-Smith Democrats and Republicans in yesterday's election. Veteran politicians in both camps were astounded at the Democratic majority, which reached 62,450 when unofficial returns from 1,531 of the state's 1,683 precincts have been tabulated. Pollard registering 149,013 votes to 86,563 for Dr. William Moseley Brown, coalition candidate.

Indications early today were that the total vote would fall approximately 50,000 short of the record breaking 306,000 cast in the presidential campaign last year when Virginia, for the first time since reconstruction, was carried by the Republican party. ## SEN. HOWELL WILL ATTACK WET FORCES

### Mid-Western Senator to Assail Administration of Dry Laws at Capital

Washington, Nov. 6.—(AP)—Following closely upon Smith W. Brookhart's thunderous denunciation of prohibition enforcement agencies and "Wall street booze parties," another mid-western senator prepared today to assail the administration of the dry laws in the nation's capital.

Robert B. Howell, Republican of Nebraska, was drafting an address for delivery from the Senate floor in the very near future as a sequel to his speech of more than a month ago in which he made charges of non-enforcement and said the responsibility lay with the President.

Brookhart, a Republican of Iowa, in the meanwhile, was called before a Federal jury, which is investigating liquor conditions in Washington for a recital of his story of a dinner given for new members of the Senate by a New York broker here three years ago, at which, he said, liquor was served.

In his speech of yesterday, the Iowa deal primarily with this dinner. He said it was given by Walter J. Fahy, and each guest was provided with a flask of whiskey. A crowded chamber and thronged gallery were disappointed that he named no Senators as having partaken of the intoxicants. He said, however, that Senator Smoot, Republican, Utah, and the late Senator Gooding of Idaho, were present but did not drink.

With respect to prohibition enforcement conditions in general, Brookhart expressed the opinion that they had improved somewhat since the re-narrated President Hoover, Vice-President Curtis and Sir Esme Howard, the British ambassador, upon their stands on the liquor question.

Secretary Mellon, he asserted, should be removed as head of the Treasury Department, and there enforcement agencies, and "a Smedley Butler or somebody like him who means business" appointed in his place. Butler, at present commanding the Quantico marine barracks, gained nation-wide renown several years ago as director of public safety in Philadelphia.

## STREAM SNUFFS OUT FLAMING GAS WELL

Spiro, Okla., Nov. 6.—(AP)—Steam today had snuffed out a flaming gas well near here after it had burned out of control since Monday, when it was ignited by friction.

The well, the property of the Red Bank Oil company of Tulsa, was fed by 35,000,000 to 40,000,000 cubic feet of gas daily. It is the largest in the southeastern part of the state.

## Tobacco Sales Continue Heavy On Market Here

The Greenville tobacco market yesterday sold 890,182 pounds of tobacco for \$208,844.78 at a general average of \$23.46 per hundred pounds, according to the official report of sales given out this afternoon by K. W. Cobb, supervisor of sales.

It was said there was approximately a million and a quarter pounds of leaf on the floors of the nine warehouses today.

## Three Hundred New Prisoners Received At State Prison

Raleigh, Nov. 6.—(AP)—There were 301 new prisoners received at the state prison during August, September and October to start serving prison sentences and of the number 179 were white men or women, George Ross Pou, superintendent of the prison, announced today.

Mist of the prisoners received were in their early twenties in age.

There were 82 admissions in August, September set a new high record for all time for admissions in one month with 132 and there were 87 in October. Larceny in its various forms was responsible for 123 being sent to prison. There were 22 who began terms for first and second degree murder, and 28 for manslaughter.

## Three Men Identified As Members of Mob in Bessemer City Rioting

Gastonia, Nov. 6.—(AP)—More evidence was piled up against Horace Wheeler today as Judge P. A. McElroy pushed his inquiry into the shooting of Mrs. Ella May Wiggins, Bessemer City textile union member.

One witness testified he saw Wheeler fire the shot that killed the woman on September 14, while two others testified they saw Wheeler nearby soon after the shooting.

Julius Fowler, an occupant of the truck which had been turned back at Gastonia after an attempt to attend a Communist meeting in South Gastonia, testified that just before he truck collided with an Essex parked on the highway, Wheeler fired and Mrs. Wiggins screamed.

The witness was quizzed for more than an hour by A. L. Bulwinkle, defense attorney, and admitted he had worked little in the last few years and that he had served 60 days in prison for non-support.

The other men, testifying this morning were Charles Shope of Bessemer City, who identified Wheeler, Fred T. Morrow, and L. H. Thompson as being members of the mob and Wes Williams also of Bessemer City, who said he saw Wheeler "pretending to be investigating."

Judge McElroy, who is sitting as a committing magistrate, on orders from Governor O. Max Gardner, has issued warrants for sixteen on the charges of murder and conspiracy to murder in connection with the shooting. All are at liberty under bond.

One witness this morning, J. W. Thomas, told of the ride on the truck to Gastonia from Bessemer City and that when they halted for a traffic light and the truck choked, a "fat man" came up and told the driver "it will be easier on you if you don't start this car."

Wes Williams, who hired the truck, said 22 people were on the truck when it went to Gastonia. He said they were halted in Gastonia and had started back to Bessemer City when the collision occurred.

Just as the truck struck the automobile, Mrs. Wiggins fell crying, "Oh, Lord, he has shot me and I'm dying."

He saw two men fleeing and three shooting. About five minutes later Horace Wheeler came up "pretending to be investigating," Williams said. He said Wheeler asked him who was driving the truck.

Williams also said that after the raid of September 9, armed guards were kept around the union headquarters at Bessemer City when night meetings were held. He asserted that guns were never left in union headquarters.

## Says Democratic Victory In New York and Virginia Indicates Political Trend

Washington, Nov. 6.—(AP)—The Democratic victories in Virginia, New York and elsewhere were interpreted today by J. Bennett Shouse, chairman of the executive committee of the Democratic National committee today as "symbolic of the political trend" and as meaning the "country is with the Democrats in their smashing of the Smoot-Hawley tariff infamy."

Calling attention to his party's success in a number of municipal contests, Shouse in a statement said that "ordinarily municipal elections might not have a great deal of bearing on the national situation, but in yesterday's election in nearly every case national issues were brought in and the appeal was made on behalf of the Republican national policies and the endorsement of the Hoover administration was involved in the contest."

"In brief," he added, "the Democratic elected mayors in a dozen New York cities, most of them counted as Republican strongholds, in Indiana, which is even more remarkable, while in Kentucky they won both houses of the legislature, which insures Democratic control of the redistribution of the Congressional districts, as well as the redistricting of the state for legislative offices."

"In no section where the Demo-

crats were accorded anything like an equal chance did they fail of success. In addition to all of this they carried cities that had been Republican for years, as for example Springfield, Mass., Bridgeport, Conn., and Ithaca, N. Y., which is Democratic for the first time in 15 years."

Chairman Shouse classified the Kentucky election as possibly the most significant after the Virginia contest.

"Hoover's landslide there" last year," he said, "had filled the Republicans with the hope of making Kentucky permanently Republican. For years it has been a barometer state whose shift from one political party to the other has been a fairly reliable index of the national trend."

Referring to the Democratic landslide in Virginia, he said "the frank purpose" of the Republican campaign was to retain Virginia in the Hoover column and a Democratic governor was elected in the face of the coalition of Republicans and Hooverites by a majority greater than that by which any previous election in Virginia's history was won, presidential, senatorial or state."

"After this," his statement added, "nobody will listen to any political hypothesis predicated on the idea of the Republicans permanently lifting the solid south."

## New Bridge At Wilmington Will Be Opened Soon

Raleigh, Nov. 6.—(AP)—The new million and a quarter dollar bridge now rapidly nearing completion at Wilmington will be formally opened and dedicated December 10, according to R. A. Doughton, chairman of the State Highway commission.

The bridge, which is in reality two bridges spanning the Cape Fear and North Rivers with a causeway between, will be dedicated to the soldiers and sailors of the State in the Confederate war, the Spanish-American war, and the World war.

Governor O. Max Gardner will be invited to take part in the dedication. Mr. Doughton said, and all veterans will be especially invited.

The bridge was built with funds from a bond issue provided by the 1927 General Assembly. It will be a toll bridge until the bonds have been paid for after which it will be a regular part of the State Highway system.

## Mann to Address Cotton Growers At Farmville

M. G. Mann, assistant general manager of the North Carolina Cotton Growers Association, will speak at the town hall in Farmville on Thursday evening at 7:30 o'clock. ## HOOVER ASKS AMERICA TO GIVE THANKS

### President Stresses Prosperity in Thanksgiving Proclamation Today

Washington, Nov. 6.—(AP)—The American people were asked to give thanks for blessings bestowed upon them during the last year in a Thanksgiving proclamation issued today by President Hoover.

In the first document of this kind he has issued, the President said assurances of peace at home and abroad had been strengthened, that the harvest had been abundant and that both capital and labor had enjoyed "an exceptional prosperity."

The proclamation set November 28 as the day of thanksgiving. The text follows:

By the President of the United States of America:  
A Proclamation:—  
"At this season of the year, when the harvest has been gathered in, the thoughts of our forefathers turned toward God with thanksgiving, for the blessings of plenty and provision against the needs of winter. They came by custom to look to the chief magistrate to set apart a day of prayer and praise, where on their thanks as a united people might be given with one voice in union. God has greatly blessed us as a nation in the year now drawing to a close. The earth has yielded an abundant harvest in most parts of our country. The fruits of industry have been of unexpected quantity and value. Both capital and labor have enjoyed an exceptional prosperity.

"Assurances of peace, at home and abroad, have been strengthened and enlarged. Progress has been made in provision against preventable disasters from flood and pestilence. Enlightenment has grown apace in new revelations of scientific truth and in diffusion of knowledge. Educational opportunities have steadily enlarged. Enduring advances have been gained in the protection of the public health. Childhood is measurably more secure. New experience and new knowledge in many fields have been recorded, from which a deeper wisdom may grow. We should accept these blessings with resolution to devote them to service of Almighty God.

He Voted Alone  
New York—It is absolutely certain now one New Yorker voted in all respects. George Schrader was the lone person registered in his election district and it cost \$240 to keep the polls open for him, with four clerks and a policeman on duty. The district went solidly Democratic.

## Brookhart Tells Grand Jury About Wall Street Party

Washington, Nov. 6.—(AP)—Senator Smith Wilman Brookhart of Iowa, today appeared before a District of Columbia grand jury to tell of the "Wall Street booze party" given for a number of members of Congress, the details of which he has given in the Senate in demanding an improvement in enforcement conditions throughout the country.

The senator today had nothing to say to newspapermen about his appearance at the court house, having announced in his Senate speech that he contemplated such action.

Brookhart remained before the grand jury about 15 minutes, when he left he likewise had nothing to say.

Prior to his appearance before the jurors he had conferred with District Attorney Rover. The two were photographed together.

## STOCK PRICES AGAIN BREAK IN NEW YORK

### Fresh Flood of Selling Orders Caused a Pronounced Downward Trend Today

New York, Nov. 6.—(AP)—A sweeping decline in prices, which ran from \$5 to \$15 a share in most of the leaders, and much more in a few specialties, took place in the abbreviated three-hour session of the Stock Exchange today. Final quotations showed little recovery from the day's low levels, with the tape nearly an hour late at the close. A sprinkling of issues broke through the low levels established in the drastic reaction last Tuesday, and much of the ground recovered in the closing sessions of last week was lost.

## YOUTH TELLS OF MURDER OF TWO PERSONS

### Says Clyde Thompson Killed Two Oil Field Workers Just to See Them Kick

Eastland, Texas, Nov. 6.—(AP)—While the youth he accused murdered unintelligently to himself in the prisoner's chair, Woodrow Davis in Clyde Thompson, 17-year-old school boy, shot and clubbed to death two oil field workers "just to see them kick."

For more than two hours yesterday the boy described the killing September 3, 1928, of Lucian and Leon Shook, brothers, and stuck to his story under cross-examination. He admitted that although he was a companion of Thompson at the time of the slaying he had been promised immunity in return for his testimony.

Young Davis said that he, Thompson and Woodrow's brother, Thomas, were hunting when he saw a pistol in Thompson's belt. He said he asked what the gun was to be used for.

"I'm going to kill Lucian Shook," Davis said his companion responded.

"I asked him what he had against Lucian, and he said 'Nothing,' that he was going to shoot him to see him kick."

The three boys induced Lucian and his brother to accompany them on the pretext they had cornered a wolf. They walked single file, Leon and Lucian in the lead.

"A little way from the house," said Davis, "I heard a shot. I saw Clyde Thompson shot each of the boys three times and beat them on the head with the pistol while they yelled."

Then, Woodrow related, the three returned to the Shooks' cabin and rifled it of clothing, a banjo and a gun. When they returned to the bodies, he said, Leon still was groaning.

The following morning, he testified, Thompson said he now had two notches on his gun, and if Woodrow or his brother told of the killings he "would have two more."

He added, Woodrow testified, that when he was 21, he would have 21 notches on his gun.

By a ruling of the court, Thompson's sanity is an issue in the case. He was given the death penalty in a former trial, which a higher court reversed. Thomas Davis also received the death penalty. His appeal is pending.

## Last Chancellor of Germany Dead

Constance, Baden, Germany, Nov. 6.—(AP)—Prince Maximilian von Baden, last Imperial German Chancellor, and heir to the Grand Duchy of Baden, died here today at 5:45 a. m. He was 62 years old.

Prince Maximilian had been suffering for a year from arterial trouble. About three weeks ago he had a fall indoors and broke two ribs, necessitating removal from Salem Castle, his home to the Municipal Hospital, where his condition grew rapidly worse.

His wife, Marie Louise, nee the Duchess of Brunswick-Luenburg, a royal princess of Great Britain, was summoned to his bedside Saturday with their two children, 23-year-old Berchold and 25-year-old Marie Alexandra. The latter is married to Prince Wolfgang von Hesse.

He was unconscious then but Sunday rallied and seemed better until last night when he collapsed.

Prince Max, as he was more widely known, was called to the Imperial Chancellery on October 5, 1918, during the closing days of the world war.

At that post he negotiated with President Wilson and the allied leaders the terms under which an armistice finally was granted, and he announced to the German people the abdication of the former Kaiser.

## Legion Arranges Final Plans For Celebration In City Armistice Day

Final plans looking to the observance of Armistice Day here next Monday were outlined at a meeting of the executive committee and members of the Auxiliary of the Pitt County Post of the American Legion in the office of the secretary of the Merchants Association last night. The session was presided over by D. C. Moore, Jr., commander of the post.

The program provides for one of the most outstanding celebrations held in the city in years, including a parade, speaking, barbecue, football game between Greenville High and Tarboro, and a war picture at White's theatre. Thousands of people are expected to attend the exercises, and former service men of all wars have been urged to participate. The day's program will open with a magnificent parade from the Atlantic Coast Line Depot to the East Carolina Teachers college and will be concluded with the football game and showing of the war picture at White's theatre.

The parade will be led by members of the district Highway Patrol and the city police department, followed by the high school band, members of the Spanish American Legion, the local military unit, and Boy Scouts, in uniform.

At the auditorium of the East Carolina Teachers College, Dr. J. B. # PLAN TO RAISE FUND FOR POOR IN DECEMBER

## Merchants Association to Carry Christmas Cheer Into the Homes of Destitute

The annual campaign to raise funds for carrying Christmas cheer into the homes of the destitute people of Greenville will be started by the Greenville Merchants Association December 1st, as was stated at the office of the secretary today.

The campaign last year resulted in the raising of a considerable sum for the poor, and it is planned to start the drive somewhat earlier this year in an effort to increase the amount of donations.

The statement issued from the Merchants association follows: After our successful campaign of last December in which we solicited funds for wearing apparel for the unfortunates of the community, we are prompted to render a similar service again this year. Through the efforts of the Merchants Association Christmas cheer was carried to many homes last year that otherwise would have been without.

Pitt county, and especially the section that is within close proximity to Greenville has been hit hard this year. And because of such there are hundreds of homes that will be without necessary food, and an equal number there will be suffering for lack of clothing to protect them from the cold of winter. In many cases the people will not be able to provide raiment to hide their nakedness. Such conditions as these should arouse the humane part of our being to the extent that we will be willing to sacrifice our own necessities to offer nothing of the leasures in order that at least partial comfort may be provided.

Of course there are various agencies that have contributed much to alleviate the suffering of the unfortunates of this section. But not having engaged in special solicitation of funds and clothing they have been only able to serve a small portion of the hundreds of cases deserving of attention. Knowing these to be facts, our Association last December took the initiative in operating a help campaign on a campaign on a larger scale. And the

results were gratifying, so much so that we have accepted the responsibility for this Christmas, and with the support of general public we are hoping to accomplish even more than what was done last year.

Besides several hundred dollars worth of clothing and many articles of food left at our office to be wisely distributed there was over seven hundred dollars in money donated by business establishments and individuals. A special committee of two ladies from the city as named who gladly serve as purchasing committee, and they did the buying of clothing and provisions. The county welfare department working jointly with us at the families, and while we failed to reach some cases of dire circumstances of which there were many taken care of, and many a poor soul was made happy because of our efforts.

This year the campaign will begin about December 1, which is some earlier than last year. And each day we hope to carry in the local paper the names of those making donations whether it be cash or articles of clothing or food.

## Creamery Route to Be Established in Pitt County

Some twenty farmers met in the county agent's office yesterday with Dr. W. R. Bass, manager of the Farmers' Creamery of Louisburg, and his butter maker to consider establishing a cream route in Pitt county.

Dr. Bass offered to establish cream stations at Fountain, Farmville, Ballards Cross Roads, Greenville and Bethel and pick up cream placed anywhere on the route once each week—the cream to be weighed and sampled taken at each station—the farmer to receive check on the 10th of each month for the total amount delivered. Dr. Bass offered to pay 42c net per pound for butterfat.

This is the first real honest-to-goodness proposition the farmers of Pitt County have had to go into the dairy business. Good cows and plenty of good home grown feed will net the farmer a good profit and at the same time build up the soil, according to E. F. Arnold, county agent.

Dr. Bass said he was ready to start the route as soon as the farmers were ready to deliver the cream. He did not demand any certain amount but rather took the

position that the amount would increase as the farmers learned more about the business.

Any farmer who is interested in milking three or four cows should get in touch with the county agent's office. The route will probably be started between now and December. With a monthly cream check added to the pig and poultry checks coming in would go a long way towards financing the next crop and help the farmer get on a "cash and carry" basis.

Every farm should have its own home grown supply of dairy and poultry products along with hog and hominy. With the present marketing arrangements for the surplus of the products, it is an easy matter for any farmer to have enough surplus of these products to take care of these products on the farm.

## SEVEN KILLED IN ENGLISH PLANE CRASH

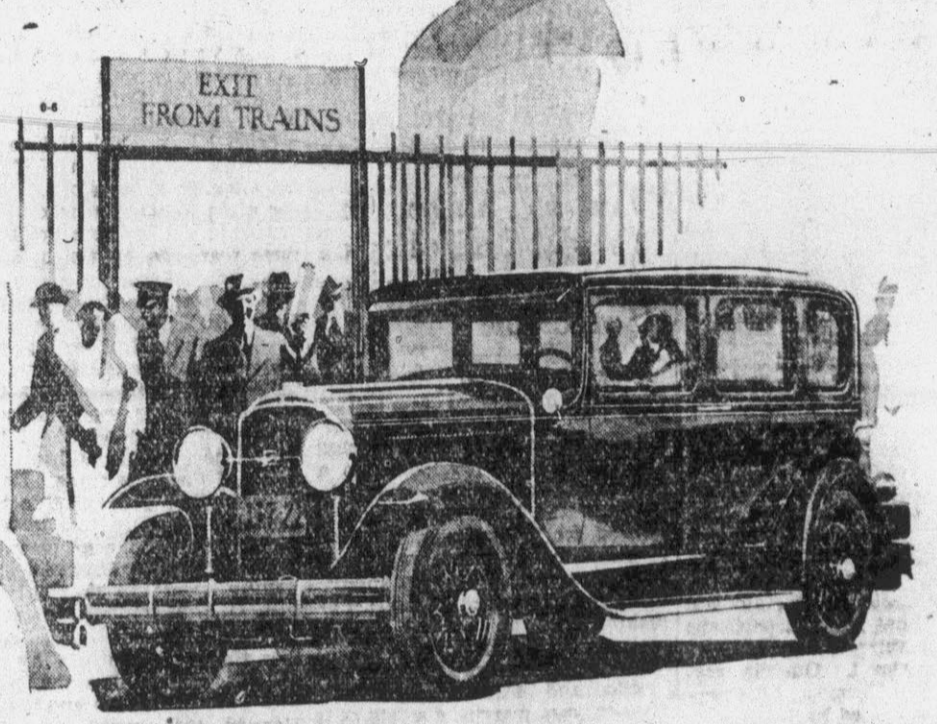

# ABOUT TOWN

"The people of Pitt county will mourn the passing of A. G. Cox, founder of the town of Winterville," said a man prominent in the life of the county, commenting on the active part which the veteran business man and land owner played in the development of the community where he spent his entire life.

"Lives such as that of Mr. Cox always count largely in moulding the sentiment of a community, and the things he did for Winterville will be a lasting monument to his name.

"Mr. Cox was a life-long Democrat and prohibitionist. He hated whiskey as he hated the devil, and was instrumental in having incorporated in the charter of the town of Winterville a provision preventing a whiskey dealer from holding title to any town property. The charter is to hold good for a period of five hundred years, and was followed out completely by the man who caused it to be drafted for the welfare of the community he chose to serve.

"The life of A. G. Cox will have a lasting effect upon the citizenship of Winterville and the passing of time will not detract from the luster and brilliance of his achievements in behalf of humanity."

"You can tell the boys that we want all of them to come to the Armistice Day celebration to be conducted in Greenville next Monday," Dave Moore, commander of the Pitt County Post of the American Legion, told the writer of this column this morning.

"Effort is now under way to make the celebration outshine all other gatherings of the kind, and we earnestly hope every ex-service man will be here to participate.

"The program will be one of interest for everybody, and there is no reason on earth why men, women and children should not get much out of it. Dr. James Turner, pastor of the Hayes-Barton Baptist Church, of Raleigh, will be here to deliver the principal address. Most of the boys know Jim. He is one of them, having been a chaplain during the world war. He knows the ambitions and aspirations of the former soldiers and his message undoubtedly will be timely and vitally interesting.

"Arrange your plans to attend the exercises, and in that way help the former service men celebrate the ending of the greatest conflict ever known to humanity."

"Thursday night will be annual Ladies' night with the local Pythians," said a member of the organization today.

"This is an occasion which every member looks forward to with interest, and that this year is no exception. All members have been invited to bring along their wives and sweethearts, and these will be augmented by visiting state officials who will be on the program for short addresses.

"All members have been urged to attend and help make the occasion the greatest success it should be."

"That balmy weather we enjoyed all last week has at last given away to winter time," declared a business man as he came up Evans street this morning with his overcoat collar pulled closely about his neck.

"I knew all that warm weather couldn't last, but I dreaded to see it go. I'll take summer all the time, every day of the year, but we have always had a mixture of hot and cold weather and I guess we will continue to have it until the end of time, or until a million years passes when the world will be entirely cold, as predicted by a German scientist."

"The board of directors of the Merchants Association in regular session Thursday, October 24, voted unanimously in recommending to its membership that they close their places of business November 11 in observance of Armistice Day," informed an officer of the organization today.

"The board also recommended that all ex-service men be permitted to take off a portion or all of the day in order to take part in the observance here.

"It is only proper and fitting that the business men should join the former service men in observing the ending of the greatest conflict in the history of the world, and it is hoped practically every store will be closed while the celebration is in progress."

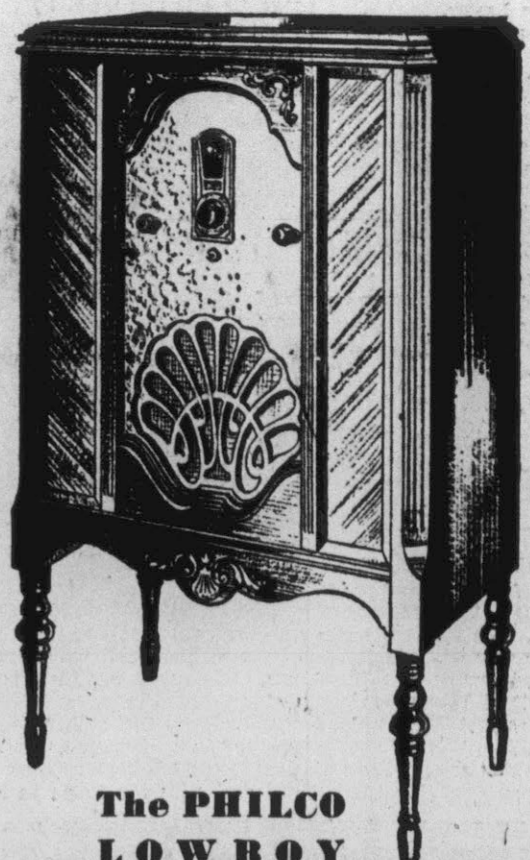

## COTTON MARKET

New York, Nov. 6.—(AP)—Cotton opened steady today at a decline of 11 to 19 points. There was considerable buying at the start, but selling was heavy and prices soon weakened further with December selling off to 17.44 and March to 17.36, or about 22 to 36 points net lower. The weakness in New Orleans and Liverpool, while the New York market was closed yesterday, seemed partly to account for liquidation. There was also considerable early southern hedging. Prices were within a point or two of the lowest at the end of the first hour.

Three more private crop reports were published, one placing the indicated yield at 15,079,000, another at 15,003,000 and the third at 15,000,000. The trend towards slightly increased estimates of the crop was probably a factor on the decline.

## GRAIN MARKET

Chicago, Nov. 6.—(AP)—Wheat values suffered sharp breaks in the late trading today after violent fluctuations earlier. Persistent downturns in stock exchange prices, together with word that the Canadian growers' pool still has part of the 1928 wheat crop unsold proved finally to be much more than a counterbalance for all stimulating factors in sight. Buying power gave out completely at some late stages of the day's wheat trading here, especially after December delivery of wheat at Kansas City was shown to have dropped below the figure at which the Federal Farm board had announced it would loan money on wheat.

Wheat closed extremely nervous 11-8c to 11-2c a bushel under yesterday's finish.

Corn closed unchanged to 1-4c off. Oats 11-4c to 1 1-2c down, and provisions showing 10c to 20c decline.

## STOCK MARKET

New York, Nov. 6.—(AP)—A steady stream of liquidation poured into the stock market today and prices rapidly melted away with no sign of a rally as the market entered the last half hour of the abbreviated three-hour session. Trading was fairly heavy in volume with the ticker running 40 minutes behind the market at 12:30 P. M.

Except for the publication of a disappointing weekly freight traffic report for the week ending October 26, there were no new developments over the election day holiday to account for the renewal of selling pressure. Several increases, and extra dividends were announced during the day, and most of the leading chain store systems showed substantial increase in their October sales reports made public today.

Call money renewed unchanged at 6 per cent and the time money market was dull with 6 per cent the ruling rate for all maturities.

The close checking up of accounts over the week end apparently has disclosed a number of additional weak spots which were being cleaned up today. Wall street also believed that some support stock bought last week was being liquidated, and that there was heavy selling by traders who bought stocks at the opening Monday in anticipation of a big rise that day as a result of widely published reports that there had been a huge accumulation of buying orders over the week-end.

Auburn Auto broke 51 points, and more than two score other leading issues and rails sold down five to 25 points. The largest declines were in such issues as American Telephone, U. S. Steel common and Allied Chemical. American Tobacco issues, Westinghouse Electric, So-lumbian Carbon, Air Reduction, General Electric, Burroughs adding Machine, DuPont, J. I. Case, Atchinson, Union Pacific and American Machine and Foundry all of which lost ten points or more.

## Seeks Employment for State Prisoners

Raleigh, Nov. 6.—(AP)—George Ross, superintendent of State's prison, left Raleigh today to go to Salisbury and negotiate for the placing of about 30 prisoners at work there in stone crushing.

With the need for employment for prisoners acute, Mr. Pou expressed hope before leaving Raleigh that he would be able to get the camp at Salisbury and also said that he might visit other places before returning here in his hunt for employment for the many surplus prison residents.

Mr. Pou said before leaving that Wilbur V. Sutherland, director of the motor vehicle bureau of the South Carolina Highway department, had visited the prison automobile license tag making plant and that the sale of North Carolina prison-made license plates to the South Carolina Highway commission next year had been discussed. As a result of the conference Mr. Sutherland told Mr. Pou he would have bids for licenses called for in April 1930 instead of in June as in previous years so that in case the North Carolina bid was successful the manufacture of the South Carolina tags would not interfere with the making of those of North Carolina.

## Durham Contractor Proves Helpful At N. C. State Prison

Raleigh, Nov. 6.—(AP)—State's prison officials wish they had in every state prisoner as well-trained and capable man as W. Herbert Lawrence, Durham contractor serving a 30-year sentence in State's prison for second degree murder.

The reason for the desire became known today and if there were more like Lawrence the prison officials and board of directors could quit worrying over an impending serious

Mr. Lawrence replied that he would be glad to use about a score provided he could get his brother to do the bidding. Mr. Pou told him

he could get the regular prisoners at \$2.50 a day but that the services of Lawrence, specialist, would cost \$10. The brother agreed and hired his prisoner.

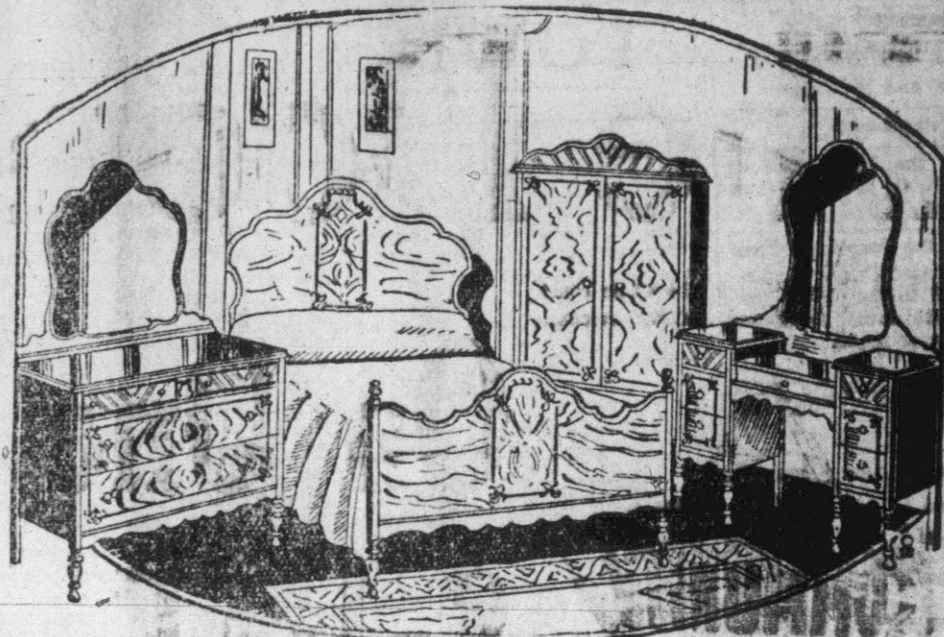
