PROMINENT WINTERVILLE MAN BURIED

Funeral for A. G. Cox Held at Winterville Yesterday Afternoon at 2 O'clock

A. G. Cox, 74, founder of the town of Winterville, Pitt County, and one of the most prominent business men of the locality, was laid to rest in the Winterville cemetery yesterday afternoon. He died Monday night at 11 o'clock following an attack of heart trouble. He was confined over a period of eight weeks and death was not unexpected.

Funeral services were conducted from the Winterville Baptist church yesterday afternoon at 2 o'clock by Rev. W. H. Covert, pastor of the Winterville Baptist church, assisted by Rev. W. L. Bilbro, of Greenville, Rev. C. W. Blanchard, of New Bern, and Rev. M. A. Woodard, pastor of the Free Will Baptist church at Winterville. Burial was made in the cemetery at Winterville. Members of the Baptist Sunday school, of which he was superintendent for 30 years, attended in a body.

The final rites were attended by hundreds of relatives and friends from different sections of the state and the floral tribute was one of the largest of any funeral ever before held in the Winterville community, mutely attesting the high esteem in which the dead civic and religious leader was held.

During the services at the grave an aged negro, a former employee of the dead man, requested that the colored people of the community be allowed to pay a tribute to the dead by singing the last song. A choir of twenty-five members of the choirs of the various negro churches of the community, then began singing, paying their last respects to the man who had done so much in behalf of the colored race during his long years of ministry in his section where his life's work was centered.

In addition to being the founder of the town of Winterville, Mr. Cox was also founder of the A. G. Cox manufacturing company, Winterville Oil company and the Bank of Winterville. He was prominent in affairs of the county and for forty-five years served as chairman of the county Board of Education, this post having been relinquished a few years prior to his death.

He was also a member of the board of trustees of Meredith college, treasurer of the Neuse-Atlantic Baptist association, senior deacon of the Winterville Baptist church and superintendent of the Sunday school, a former chairman of the Democratic Executive committee, and a member of the draft board during the World war.

He was a native of the Winterville section, having been born near the spot where the town of Winterville now stands. Always maintaining an active interest in development of farmer and the farm, he invented several farm implements now in use on hundreds of farms throughout the country. His father, John Cox, was inventor of the Cox cotton planter, one of the most successful of his inventions, and most widely used farm implements of the present day.

Tremendous Outburst Of Selling Produces Rally On Stock Mart

New York, Nov. 7.—(AP)—A spectacular rally in stock prices took place on the New York Stock Exchange today after prices of many leading issues had plunged downward \$3 to \$15 a share on a tremendous outburst of selling at the opening of the market. Most of the early losses were cut down, and a number of issues, including U. S. Steel common, rallied \$1 to \$6 a share above yesterday's final quotations.

Blocks of 5,000 to 75,000 shares of stock, believed to represent the completion, at least temporarily, of the forced liquidation which has been overhanging the market, were thrown into the market regardless of cost at the opening. So great was the rush of selling that nearly 2,500,000 shares changed hands in the first half hour. The ticker was running nearly a half hour behind the market at the end of the first hour. U. S. Steel common converted an early loss of \$7.50 into a gain of \$6 by closing at \$175 a share. Johns

Manville converted a loss of \$7.50 into a gain of \$5. American Telephone regained all of an early loss of \$9.50 and sold \$4 above yesterday's close. American Can made up a loss of \$12. Westinghouse Electric rallied from \$117, off \$11.75, to \$129.

Montgomery-Ward changed a loss of \$6 into a gain of \$2. New York Central recovered practically all of its decline of \$5.12 before the end of the first hour. No meeting of the banking group, headed by J. P. Morgan and Company, which was organized October 24 to assure an orderly market, was planned for today.

In the opening break, General Electric, Johns Manville, New York Central, U. S. Industrial Alcohol, Chesapeake and Ohio, and Public Service of New Jersey sank to new lows for the year, while U. S. Steel common and numerous others broke through the low prices established in the record-breaking 16,000,000 share session of October 29.

Annual State Convention Of Disciples of Christ Concluded At Farmville

Farmville, Nov. 6.—With ideal weather prevailing since the opening session Monday night, the 85th annual state convention of the Disciples of Christ came to a most successful close tonight.

Great interest has been manifested in all of the sessions, at each one of which the three following keynotes have been sounded and emphasized—the missionary task, the educational work and the penitential work.

The theme, "Working Together With God," echoes through every service held and interwoven into every address delivered during these two days.

The convention has been honored with the presence of many of the notable and outstanding leaders of the denomination in America today and has had the privilege of hearing messages of exceptional merit and worth of the widest attention. The problems of the church and aims of the brotherhood have been presented in a fine statesmanlike manner throughout.

Attendance has far exceeded the most sanguine hopes of the state leaders and officers of the convention, the register showing that 602 delegates and visitors outside of Farmville were present, with as many as 1,000 in all. These figures show the high attendance record made at the Golden Jubilee celebration in Kinross in 1927, when attendance and registration were made points of stress and emphasis.

The Farmville church, her beloved pastor, Rev. Russell S. Tandy, and the entire community gave to the convention a warm welcome and fulfilled their promise of hospitable entertainment to the letter.

The convention got down to business this morning at 9:45 with the religious education period, during which Dr. M. E. Sadler of Indianapolis, secretary of the religious education department of the National Missionary Society, made a splendid address on "The Reason Why the Church Should Teach Religion." His most telling statement being that, "No generation can afford to ride in high powered automobiles and permit its children to walk the highway of ignorance." Dr. Sadler's brother, Rev. Lee Sadler of Richmond, was also on the morning program, with an address on "The Antecedents of Pentecost." This was decidedly one of the best speeches of the convention, based as it was on the Pentecostal experience of the original Disciples, and having to do with the great Pentecostal celebration in Washington in October 1930. Mr. Sadler is one of the fifteen members appointed as a committee by the general church to promote this event, and he thrilled his hearers with the plans of the celebration, and bespoke the great benefit to be derived from attendance, both to the church and the individual, if the proper preparation is made beforehand.

"The Materials of Religious Education" were outlined by Dr. Marion Stephenson of St. Louis, editor-in-chief of the department of Church School literature of the Christian Board of Publication. To illustrate the two contrasting theories of religious education the speaker told the story of Nicodemus and Jesus with the former representing "transmissive education" and established religion, and Jesus representing personality as the end of religious education, and gave the definition of religious education as the nature and direction of the spiritual personality unto full spiritual maturity.

Dr. H. H. Harmon from Indianapolis, who has been associated for

the past two years with the builders committee of the National City Christian church, told of the first church of the Disciples in Washington, in which President Garfield worshipped, traced its growth and told of the movement started for creating a representative building and of its progress.

Rev. H. T. Holroyd, missionary of Buenos Aires, brought his second message at the afternoon session, telling of the mission work in Argentina and Paraguay, and of the effort being made to give the students of the schools spiritual and moral education. He also explained the unique type of service which is winning recognition for these schools throughout the Republic.

In a business session held at 3:00 Raleigh was selected as the convention city for 1930, the meeting to be held during the week of November 5, in the Hillier Memorial church. Dr. Abram E. Corey of Kinross will preside. W. C. Foster of Rocky Mount was elected corresponding secretary. L. J. Chapman of Grifton was elected treasurer. Chairman of the Board of Managers, W. C. Manning, of Williams, new members added to the board include: W. H. Brunson, of Ayden, W. C. Manning and L. J. Chapman.

The committee on appropriations to mission points recommended favorably the consideration of the executive board the missions at Wilmington, Rosemary, High Point, Winston-Salem, North Side, Durham, Ahoskie, Elizabeth City, Lumberton and Wenoona.

Pension fund group consisting of county chairmen for each of the counties in which Disciples are located designated Sunday, December 1, as the day to sign churches simultaneously in supporting 8 per cent payment on past salaries in the fund to become operative January 1, 1931. If the minimum number of 2500 churches in America will sign.

The new trustees selected to the Atlantic Christian College board are: John Askew of Raleigh; Geo. P. Cuthrell, Raleigh; A. W. Howard, Kinross; L. A. Tart, Dunn; C. V. Cannon, Ayden; E. C. Hillier, Raleigh; and C. L. Hardy, Maury.

The committee of examination and ordination recommended that A. C. Barden, W. T. Minshew, Nixon A. Taylor, J. T. Forrest, and F. W. Weigmann, students of A. C. C. be ordained to the ministry by the Wilson church, assisted by H. S. Hilley, J. W. Shockey, Richard Bagby and C. W. Hockaday; that S. L. Jones be ordained by the Farmville church and be taken under the tutelage of the minister, R. S. Tandy.

New preachers coming into the church within the year were introduced by W. B. Quarles of Spray; E. H. Jones, of Goldsboro; L. B. Scarborough, Walsenburg; Malcolm Penny and Mrs. Penny of Elizabeth City; Ray N. Moses, A. C. C. Wilson, and F. C. Zimmerman, of Ahoskie.

A special committee appointed to review and draw up resolutions concerning issues in Western Carolina reported as follows:—We deplore the recent and present strife in North Carolina. Our state, we feel, must stand condemned in the eyes of the world if the same mad strife is permitted here that was endured in other textile states a quarter of a century ago. Our economic, political and social leadership is blind to improved methods if a better way cannot be found than the strike. The strike in industry is nothing but war with increasing loss on both sides.

ARNOLD STILL UNDER FIRE IN LOBBY PROBE

Letters Dealing With Sugar Tariff Read Before Investigating Committee

Washington, Nov. 7.—(AP)—J. A. Arnold's activities in connection with the tariff bill were again under scrutiny today at the Senate Lobby committee's investigation. Letters the general manager of the Southern Tariff association wrote in an effort to eliminate the seasonal clause, which permits the free entry of foreign vegetables at certain seasons, being introduced into the record.

One, written to Lorenzo A. Wilson, of Jacksonville, Florida, said the "whole thing swings around" the votes of Senator Fletcher and Trammell, Democrats, Florida, adding "no other influence is needed."

The letter added that he talked with the Florida senators and they talked with Senator Watson of Indiana, Republican leader.

"Were you trying to make a deal," asked Senator Blaine, Republican, Wisconsin.

"No, but we wanted as many Senators with us as possible," the witness added he talked with Senator Watson "a few times."

In a letter to D. A. Burgin, New Orleans sugar man, Arnold said he had talked with Senator Smoot of Utah, Senator Watson and others in regard to getting some one to "take the place" of the late Senator Gooding, of Idaho. He added that they designated Senator Watson "to contact with us."

The witness said he had later conferred with Senator Watson, and Blaine asked:

"You don't characterize that as lobbying, do you?"

"No," Arnold answered. "I think we have a right to present our opinions."

SEN. ASHURST ASKS TARIFF ON MAGANESE

Tells Senate Big Steel Corporations Making Big Profits On Sale

Washington, Nov. 7.—(AP)—A demand for a tariff on manganese, a raw material used in the manufacture of steel, was made in the Senate today by Senator Ashurst, Democrat, Arizona, who said statistics in tax returns of the big steel corporations showed they had made a net profit of \$930,181,059 since enactment of the present tariff law.

Ashurst referred to the profits of eight steel corporations. Total profits were given as \$931,684,318. After deducting losses, net profits were \$90,181,059.

TEXAS JUDGE ACQUITTED IN MURDER CASE

R. H. Hamilton Found Not Guilty of Killing Son-in-Law By Jury Last Night

Weatherford, Tex., Nov. 7.—(AP)—Judge R. H. Hamilton, former member of the State Supreme Court Commission of Appeals, was free today, a jury having decided he acted in self-defense when his son-in-law, Tom Walton, Jr., the bridegroom in a secret marriage, was shot and killed in Hamilton's Amarillo law office.

The jury, after listening to seven days of testimony and eight hours of argument, required only one hour and 46 minutes to acquit. Four jurors voted for conviction on the first ballot and one on the second. The verdict came on the third poll of the jury.

The defendant was asleep in his hotel room when the verdict was read. He dressed quickly, however, when informed of his acquittal and came to the lobby to meet his friends.

Theresa, his 18-year-old daughter, whose secret marriage to Walton while the two attended the University of Texas, was indirectly responsible for the shooting threw her arms around his neck.

"Oh, daddy," was all she could say, and she fell back to watch others congratulate him.

"My conscience was clear," Hamilton said to the only newspaperman who broke through the cordon of friends which surrounded him. He added the information "I'm going home tomorrow," before friends closed about him and shut off further interviews.

The state sought to show that Hamilton, knowing or suspecting his daughter had married Walton, whose home was in Amarillo, deliberately shot the young man when Walton came to his office to make a clean breast of the affair.

The defense pictured Hamilton as a kindly father, aware of Walton's intentions toward his daughter and willing to bless the couple, once he was satisfied of Walton's desirability.

MANY LIVES CLAIMED BY BIG VOLCANO

Property Damage Estimated at \$1,000,000 Results From Eruption

Guatemala City, Nov. 7.—(AP)—The Guatemalan Ministers of Promotion have informed the government after a visit to El Palmar and the zone affected by eruption of the volcano Santa Maria, that the eruption has ceased. Heavy showers fell over the entire area yesterday.

He was not able to estimate loss of human life or property damage since many localities were still surrounded by molten lava.

The Red Cross, the Boy Scouts, and women of the district have begun active relief work.

One newspaper said authorities calculated as many as 45 deaths from the disaster, with as much as \$1,000,000 loss to the farms through the molten lava. Twenty-one bodies have been recovered at El Palmar. There are 25,000 inhabitants in the affected area.

Members of Grand Jury Summoned Before Court Probing Riot Disorders

Gastonia, Nov. 7.—(AP)—Members of the Gaston county grand jury today were called into court to permit a witness in the committing magistrate inquiry into the death of Mrs. Ella May Wiggins (a) whether he could identify a man he said looked like one who had been with the mob that chased a truck in which the woman was riding at the time she was shot and killed.

Two members of the inquisitorial body came into court within an hour after Charles Shope, a distant cousin of the dead woman, had been recalled to the witness stand and told of an incident in the grand jury room. He said that during the time Shope was before the grand jury the foreman asked him if he could identify any of the men in the mob if he saw them.

Howard Pasour, a member of the grand jury, was standing at the time Almond testified. Shope looked around the jury room and pointed to pasour:

"That man looks like one of them."

Pasour explained to the jury, Almond continued, that he was attending a funeral the afternoon of September 14, when Mrs. Wiggins was killed. This closed the incident in the grand jury room.

Solicitor Carpenter explained to Judge McElroy that the two grand jurors happened to be in the building and that he wanted to clear up the matter as soon as possible. He also told the judge that a deputy sheriff had been sent for Pasour and had found him in a field. He said that Pasour would be in court as soon as he could change clothes and come in.

Prince Humbert to Marry in Rome

Rome, Nov. 7.—(AP)—Indications today were that Crown Prince Humbert and Princess Marie Jose of Belgium would be married in Rome, at the Pauline Chapel in the Quirinal Palace.

The Crown Prince, who has been in Rome for several days yesterday received the Papan Nicola, Monsignor Borzogni Duca, or a 20-minute conversation, while Queen Elena came incognito from San Rocco to discuss the wedding plans with her son.

The chapel, which was named after Pape Paul V, was chosen because it is now a private chapel in the royal house and can be policed with ease and credentials of guests controlled. The choice will mean a more intimate family function than had been planned previously.

Certain other edifices have not been definitely excluded from the arrangements. These included the National Church, St. Mary of the Angels, in which the Prince's parents were married, and Santa Maria in Araceli, on Capitoline Hill, near the statue of Victor Emanuel II.

Tobacco Market, Banks and Business Houses to Close Here During Armistice Day

A general closing of the tobacco market, banks and business houses will mark the observance of Armistice Day in this city next Monday, and the entire town will join in one of the most complete celebrations since the signing of the armistice.

There was some indecision concerning the closing of the tobacco market because of the report that other markets in this section of the state would remain open, but this fact was definitely settled this morning when members of the Tobacco Board of Trade voted unanimously to close for the day regardless of what the other markets did.

It was the sense of the meeting that the business interests owed this courtesy to the men who crossed the ocean to fight that civilization might be saved and when the matinee came up for vote, the tobacco men voted in favor of closing with a dissenting vote. This means that hundreds of people employed in the tobacco industry will have an opportunity of taking part in the celebration along with myriad other men and women from other walks of life.

While a few stores may remain open during the day, it was stated today all former service men would be relieved of all their duties and permitted to take part in the observance of the day when they laid down their guns and returned to home soil to take up their duties as citizens again. Along with the tobacco market banks and business houses, D. J. Whitchard, owner and manager of the Daily Reflector, stated that the paper would suspend publication for the day in order that its employees, several of whom are former service men, might devote the entire day to activities in connection with the local observance.

D. C. Moore, Jr., commander of the Pitt County Post of the American Legion, said this afternoon, that plans for the celebration were continuing without the slightest letup. All committee members assigned to various tasks have reported splendid success, and will have everything in readiness when the celebration actually gets under way.

Observance of the occasion here calls for a magnificent parade, speaking, barbecue dinner, football game and war picture at White's theatre.

The principal address of the day will be delivered by Rev. J. B. Turner, pastor of the Hayes-Barton Baptist church, Raleigh, a former chaplain in the World War. Mr. Turner is a former commander of the Pitt County Legion Post, and his return to Greenville to deliver the principal address is greeted with widespread interest by members of the Legion and the public generally.

The parade will be one of the most colorful pageants staged in this city in many years. It will form at the A. C. L. depot and move down Dickerson Avenue and Fifth street to the East Carolina Teachers College where the principal part of the program will take place.

The parade will be headed by members of the District Highway Patrol, followed by members of the police department, High School band, veterans of the Civil and Spanish American wars, all ex-service men of the World war, members of the local unit of the 113th Field Artillery, and Boy Scouts in full uniform.

After the exercises at the college, the public will be treated to a football game at the new school grounds on Third street between Greenville High and Tarboro. A picture, "The Flying Boat," will be shown at White's theatre both afternoon and night.

48 Fatal Cases in N. C. Accidents for 4-Month Period

Raleigh, Nov. 7.—(AP)—Forty-eight fatal cases were among the 13,330 accidents reported to the North Carolina Industrial Commission up to November 1 during the four-months the commission has been in existence. David Easterling, statistician, reported today.

There had been 2,023 awards to November 1, with the amounts not definitely known until the cases are definitely closed.

There have been 5,309 cases closed so far and 5,030 remain open. Of the total awards 1,746 of the agreements received the approval of the commission and modifications were made in 286.

ROBINSON IS NOT GUILTY IN LIQUOR CASE

Fifty Cases Disposed of in Two Days' Sitting of County Court This Week

Louis Robinson, operator of a filling station across the river from Greenville, was found not guilty of possession of whiskey for sale by a jury sitting in the regular weekly session of County court yesterday. The jury was out only a short time.

The charges against Robinson grew out of a raid made by county officers last August in which nine pints of whiskey were found back of the filling station building. Robinson was away at the time, and did not return until a short time ago when the warrant was served upon him.

Robinson said he did not know anything about the whiskey, and contended that it belonged to somebody else who had hidden it behind the filling station without his knowledge. The evidence produced by the prosecution was purely circumstantial, and the jury deliberated only a short time before returning a decision.

The docket for this sitting was one of the heaviest in some months, and after remaining in session all day Tuesday and Wednesday, Judge W. L. Wheebree pronounced sentence in the "final two cases this morning at 10 o'clock. Approximately fifty cases were handled during the two days court was in progress and resulted in defendants paying over to the county coffers about \$1,000 in fines and costs.

Every charge in the criminal category was represented in the fifty cases considered, ranging all the way from the giving of worthless checks to violations of the prohibition law. Numbers of the defendants were permitted to pay fines but a great number found their way to the roads. Only about four outright acquittals featured the session.

Sam Hardee and Daniel Randolph, colored men of the Alpine section, arrested in a raid of their still several days ago, were sentenced to the county roads for a period of eighteen and twelve months, respectively.

Ed Cox, negro, of the Ayden community, received a total of 270 days to the roads on charges of possessing liquor for sale, assaulting his wife and whiskey for sale. He was given 90 days in each case.

Isiah Cox, colored, charged with transporting and selling whiskey, drew six months on the roads.

Tom Whitehurst and Chue Terry, of Martin county, paid fines of \$100 each and cost and were given 12 months suspended sentences each to the roads for violation of the liquor laws.

Carl Moore paid a fine of \$25.00 on a charge of assault. W. H. Stocks, involved in the same case, was permitted to pay one-half cost.

T. C. Swindell, charged with driving while drunk, paid a fine of \$50.00 and cost and had his license revoked for 90 days.

Sandy Williams, colored, whiskey for sale, was sentenced to six months on the roads.

Pearl Joyner, colored, possession of whiskey, judgment suspended upon payment of one-half cost.

George Carr, transporting whiskey, 90 days on the roads.

Wash Mayo, possession of liquor, \$25.00 and cost and 12 months' suspended sentence to the roads.

D. A. Wingate, worthless check, paid cost and check.

Lily Ruth, colored, larceny in two cases, was permitted to replace the stolen goods with a 12 months' suspended sentence hanging over her head. A similar sentence was meted out to her daughter, Annie Ruth.

M. E. McLawhorn, driving while drunk, \$50.00 and cost, and license revoked for 90 days.

Isaac Tyndall, illegal possession of whiskey, \$25.00 and cost, and six months suspended sentence to the roads.

W. N. Pitt, worthless checks, permitted to pay check.

John Cannon, colored, larceny, \$25.00 and cost and six months' suspended sentence to the roads. He was also required to make restitution of the stolen goods.

Claude Thrower, abandonment of wife, required to pay \$30.00 a week to his wife, and six months' suspended sentence to the roads.

James Dixon, larceny, 90 days on the roads.

E. L. and R. W. Jackson, illegal possession of whiskey, \$25.00 and cost each.

COTTON MARKET

New York, Nov. 7.—(AP)—Cotton opened barely steady today at an advance of 9 points to a decline of six points with most of the active selling higher on trade buying and covering, while offerings were comparatively light after the heavy selling of yesterday. The initial demand was quite readily supplied, however, and selling soon became more active owing to the continued weakness of the stock market, with prices easing off to 17.09 for December and 17.52 for March, by the end of the first half hour or about 1 to 3 points net lower.

Liverpool cables reported general liquidation and hedging in the market there with a poor offtake but said there was rather more business in cotton cloths for shipment to Indian and China.

GRAIN MARKET

Chicago, Nov. 7.—(AP)—Spectacular buying ascribed in a great degree to a widely known eastern trader rushed wheat prices upward today. Stock market advances likewise counted as decided stimulus, as did also new export business in North American wheat of 1,250,000 bushels or more. The fact that wheat values had dropped to about 10c a bushel under last week's top point was regarded as a further buying incentive, together with increasing attention to the circumstance that the market was near to the level at which the Federal Farm Board has agreed to make loans to Farmers' Cooperative organizations.

Wheat closed strong at the day's maximum figures, 23-4c to 31-4c a bushel higher than yesterday's finish.

Corn closed 13-8c to 15-8c up. Oats 11-2 to 13-4c advance, and provisions varying from 5c setback to an equal gain.

STOCK MARKET

New York, Nov. 7.—(AP)—The stock market went through another trying period of force liquidation, which carried many issues down 5 to nearly 2 points in the early trading today, and then rallied impressively as strong buying support appeared.

Trading was again in unusually heavy volume. Opening blocks of 5,000 to 75,000 shares were followed by long strings of smaller transactions, with the result that the ticker fell more than an hour behind the market in the last hour of the abbreviated session. Total sales crossed the 5,000,000 share mark before mid-day.

Little attention was paid today to the money market. Call money remained unchanged at 6 per cent, with time money in supply at the same rate for all maturities. Publication of the weekly report of the New York Federal Reserve Bank this evening is expected to disclose another huge reduction in brokers' borrowings.

While some uneasiness has been created as a result of the falling off in railroad traffic in the latter part of October, and the reported slackening in steel buying, bankers and business men look for no general recession in business, except possibly in merchandise of the luxury class.

repealing the case against the murderers of Ella May Wiggins in his condemnation that even handed justice be given to criminals on both sides of the issue. We also wish to comment the fairness of the following papers among others in their stand for social and economic justice in the state: News and Observer, and the Greensboro Daily News.

3.—We feel that the blame for the present situation is to be shared by all; first of all we feel the church has been too anxious about her own institution and her own ecclesiastical interests and has largely lost the primary passion of our Lord in seeking to save that which was lost. We feel the church has bowed to Mammon in that she has by her own neglect and pride alienated the working man from her membership. We call our own church to repentance and to a new and firm stand for the sanctity of all personality, and to put first the Kingdom of God even if other things are never added.

We believe also that this state has wronged her laborers in advertising that this state will give cheap and docile labor to industry as an inducement for them to move to North Carolina. We are convinced that cheap labor will cheapen the lives of workers and finally lead to hard and bitter class distinctions.

We believe further our legislature has been derelict in not carrying them a survey of industry in the state, so that more intelligent and progressive labor laws may be enacted.

These resolutions were adopted at the last session tonight.

The "Youth Banquet" presided over by Miss Catherine Ware of Wilson, and held at 6 o'clock was delightful from every angle. A special program of pop songs and cheers was led by Mrs. R. S. Tandy followed by a symposium of short talks on "What the North Carolina Conference for Young People Meant to Me" viewed as a boy, as a girl, by a faculty member and a pastor.

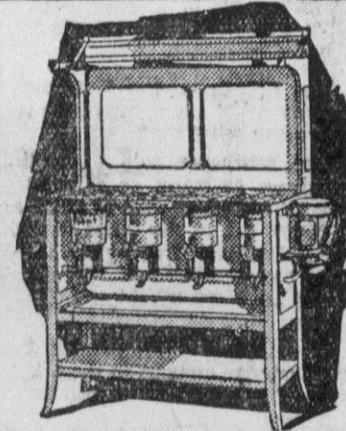

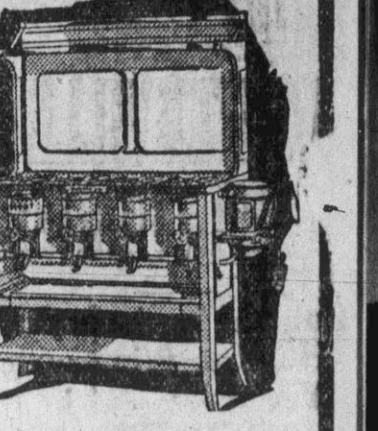

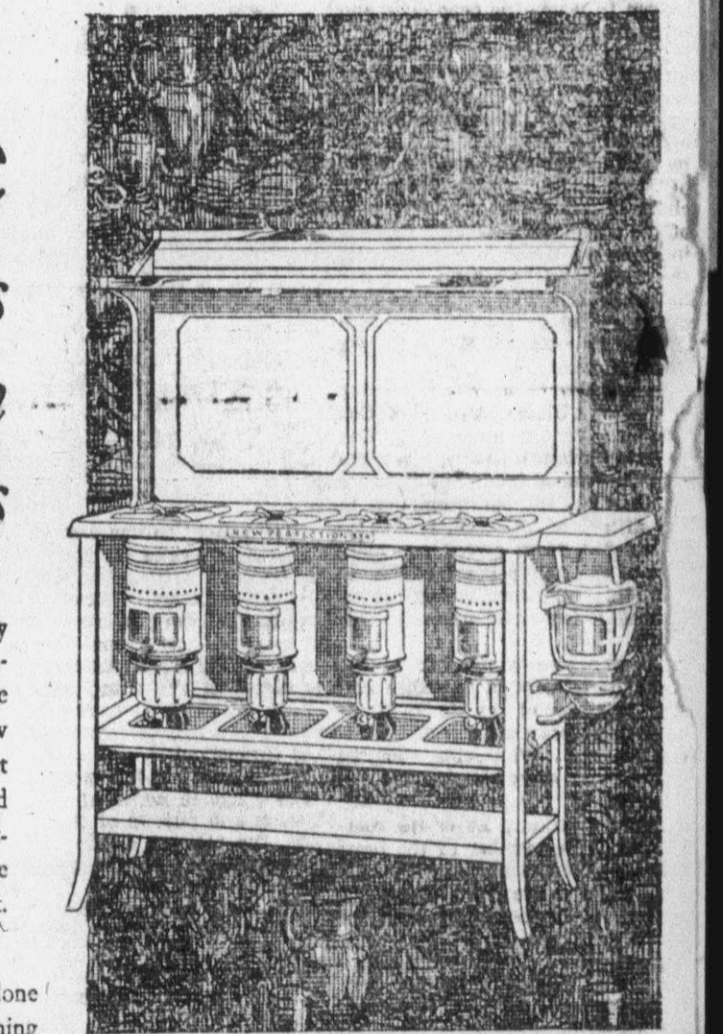

ABOUT TOWN

"This is the first real honest-to-
goodness proposition the farmers of
Pitt county have had to go into the
dairy business," E. F. Arnold, direc-
tor of the Pitt County Farm De-
partment, said today in discussing
the offer to establish a creamery
station at Fountain, Farmville and
Ballard's Cross Roads.

"Good cows and plenty of home-
grown feed will net the farmer a
good profit and at the same time
build up the soil. Dr. Bass said he
was ready to start the milk route
as soon as the farmers were ready
to deliver the cream. He did not
demand any certain amount of milk,
but rather took the position that
the amount would increase as the
farmers learned more about the
business.

"Any farmer who is interested in
milking three or four cows should
get in touch with the county agent's
office. The route will probably be
started between now and the first
of December.

"A monthly creamery check added
to the pig and poultry checks
coming in would go a long way to-
wards financing the next crop and
help the farmer get on a 'cash and
carry' basis.

"Every farm should have its own
home-grown supply of dairy and
poultry products along with hog
and hominy. With the present
marketing arrangements for the
surplus of the products, it is an
easy matter for any farmer to have
enough surplus of these products
to take care of his current expenses
on the farm."

Information from the Merchants
Association yesterday was to the
effect that the annual campaign to

"The drive is started earlier than

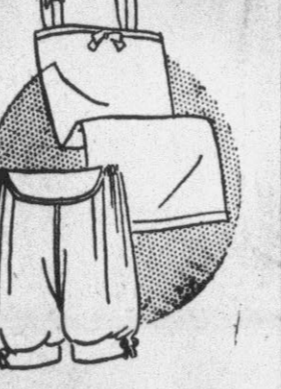

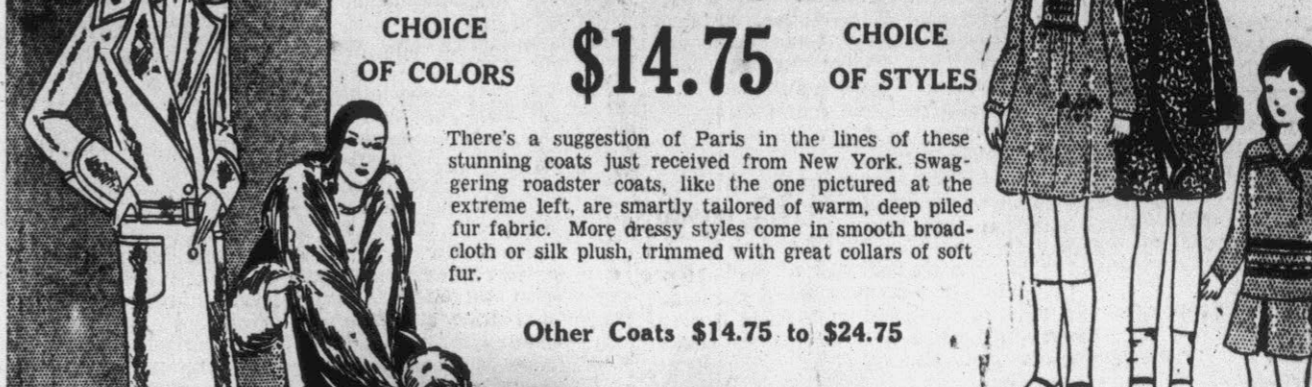

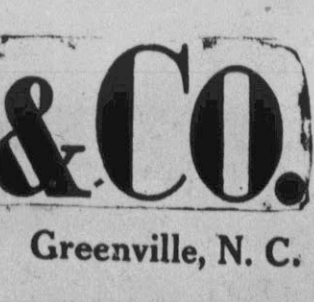

PEACE POLICY OUTLINED BY NEW PREMIER

Conciliation Abroad and at Home Also Set Forth by Andrew Tardieu

Paris, Nov. 7.—(AP)—The Ministerial Declaration of the new Tardieu government presented to the French Parliament today outlines a policy of peace and conciliation abroad and prosperity and security at home.

In general Premier Tardieu's reading of the declaration got a good reception. The center and the right applauding in some cases frantically and even some on the left showing polite approval.

The demonstration of applause, however, indicated that the premier must look above all to the more conservative elements in the chamber for a majority.

The new government assured the Chamber of Deputies that it will enter the London Naval conference

in the friendliest spirit, but keeping in mind, the attitude of its predecessors. That general disarmament must include that on land and in the air as well as on the sea.

The declaration says that security will be gained by effective organization of the national defenses and that domestic order will be maintained by the exclusion of violence and the maintenance of liberty of conscience within the laws of the land.

An extensive program of economic development involving expenditure of \$200,000,000, maintenance of the "traditional equilibrium" between agricultural and industrial production and the protection of the "four great products—wheat, wine, livestock and beet—with equitable remuneration to the cultivator" will form the basis of the program of prosperity.

Encouragement to a large birth rate. Aid to large families, improvement in the condition of the humbler classes, important reduction in taxes and the constant improvement of care for war victims and wounded combatants are some other major points of the new ministry's platform.

Washington, Nov. 7.—(AP)—Herbert F. Sewell, of North Carolina, was nominated by President Hoover today to be a member of the board of tax appeals.

Pantages to Get Another Hearing On Next Saturday

Los Angeles, Nov. 7.—(AP)—Affidavits by three women jurors that fear of radio utterances by the Rev. D. P. Schuler and alleged coeditor by a fellow juror had influenced them to return a verdict of guilty against Alexander Pantages were on file with District Attorney Byron Pitts today.

The affidavits were filed yesterday in connection with the vaudville magazine's plea for a new trial to be heard in Superior court Saturday.

Pantages was convicted of attacking Eunice Pringle, 17, a dancer, and is liable to a sentence of from one to fifty years in San Quentin penitentiary.

The women jurors, whose statements were included among seven affidavits produced by counsel for Pantages to support a motion for a rehearing of the case, are Mrs. Christina D. Ulrich, Mrs. William Ingles and Mrs. Letta C. Steiner. They swore they were influenced also in switching their early votes for acquittal by the inclusion of the words "with clemency" in the verdict, under the impression that such a notation would make it mandatory that Superior Judge Charles Fricke pronounce a sentence of only one year in the Los Angeles county jail.

The women also stated they knew that Garland Biffle, a defense witness, had been arrested for alleged perjury before deliberation began, and that a discussion of the incident among the members of the panel influenced their decisions.

Mrs. Ingles said in her affidavit that Juror William Vellage "threatened to tell Bob Schuler how this affiant acted and voted unless she joined with him in a verdict of guilty; and further stated that he would see that Schuler made a statement over the radio in reference to it."

Mrs. Ulrich supported Mrs. Ingles in another affidavit, asserting that Vellage not only had threatened to tell Schuler but also to inform the grand jury and the board of supervisors.

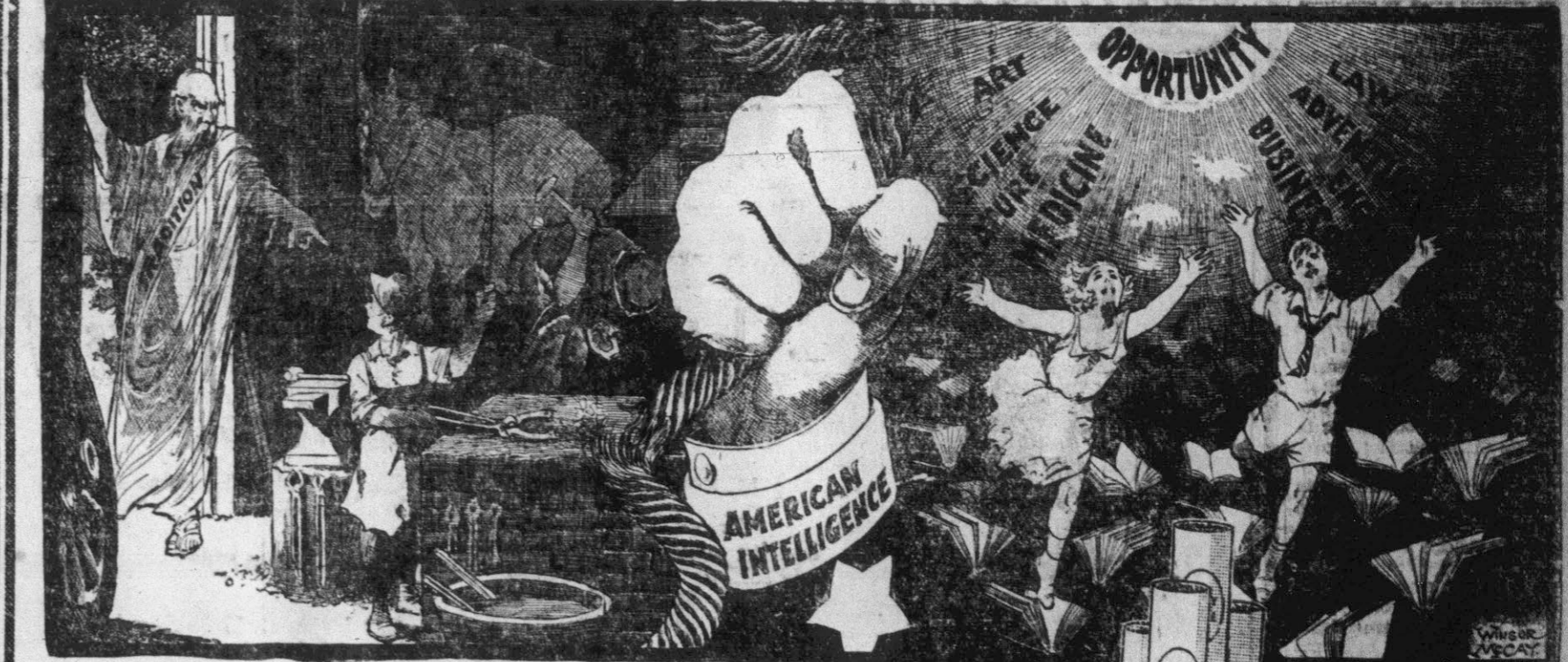

COMMUNISTS CELEBRATE IN RUSSIA

Observe Great Upheaval of 1917 Which Ushered Bolshevism Into World

Moscow, U. S. S. R., Nov. 7.—(AP)—Communist Russia today observed in traditional revolutionary fashion the twelfth anniversary of the 1917 upheaval which ushered Bolshevism into the world and destroyed the ancient Russian government.

To bring the event closer to the hearts of the people, the government gave bread and meat at cost price to every member of the population holding bread cards.

With one million of yards of red bunting, huge flaming placards, symbolical wooden floats, numerous speakers' stands and large portraits of Lenin, Mark Anistalin, historic Red Square was transformed into a mighty theatrical stage for the passing of a twelve-mile-long military and civilian parade led by the commander of the Moscow garrison.

Favored by perfect weather this singing, shouting mass of humanity carrying banners, flaming flags and chanting the international march through the Gates of Resurrection where formerly stood the famous Chapel of the Siberian Virgin. Over the portals of the gates today appeared a gigantic Red Anti-Religious placard reading, "Down with the deceit of Popes! give us books instead of religion!"

Over the slender steeples and the battle mottled towers of the Kremlin fluttered huge red flags which, illuminated by a brilliant noonday sun, had the appearance of great flaming sheets of fire. Within the shadow of Lenin's now empty tomb an enormous red banner was flung to the wind reading: "Proletarians of the world! stand under the banner of the Communist International! forward to new battles and to new victories!"

The drone of scores of Red Army airplanes overhead mingled with the strains of military bands, the rumbling of dozens of military tanks and the staccato steps of marching soldiers imparted distinctive martial touch to the scene.

While the Kremlin batteries boomed out successive salutes to the October revolution, workmen's delegations from various parts of the Soviet Union presented train loads of iron, steel, coal, grain, potatoes and textiles as gifts to the government.

Nearly Four Hundred Given Jobs Last Week

Raleigh, Nov. 7.—(AP)—There were 383 persons placed in jobs during the week ending November 2nd, by the seven Federal-State employment bureaus out of 740 persons that applied for work, Frank D. Crist, State Commissioner of Labor reported today.

Winston-Salem led the bureaus in placements with 71; Greensboro had 70; Wilmington 68, Asheville 63, Charlotte 61, Raleigh 47, and Basin three.

There were 173 women and 210 men placed. Unskilled workers were given 145 jobs and domestic labor 136 with skilled workers being put in 84. Only 14 industrial workers were placed.

New Invention Helps Plane to Keep its Course

Washington, Nov. 7.—(AP)—Army aviators were enthusiastic today over the demonstrated efficiency of a newly developed "robot pilot" which keeps a plane flying straight and true to its course with no attention from the flier at the controls. It consists of two gyroscopes, one vertical and one horizontal, which maintain a constant position and by automatic electrical contacts bring the airship back to level flights and point it again on its course when disturbed by the wind,

passing gusts, or downward air currents. The whole device fits into a box, small enough to be placed under the pilot's seat, and weighs about fifty pounds. The electrical power necessary for its operation is derived from a wind driven generator. The new "robot" was given an exhaustive test yesterday in a trimoored Ford plane flying from Cleveland to this city. Once in the air the gyroscopes were put to work and the manipulation of the plane was given no more attention until, within thirty miles of Bolling Field here, the propeller operating the generator failed, and Lieutenant Albert F. Hegenberger, remembered as the partner of Lieutenant Lester

J. Maitland in their flight from California to the Hawaiian Islands, took the controls for the remainder of the flight. It was pointed out that the device is meant to control a plane only in level straight flight, and that when turns or landings must be made the human pilot must replace the mechanical one. Its value was explained as lying in night flying and operation through fog and in decreasing the strain and tension of the pilot. The robot is the invention of Elmer A. Sperry, an experimenter in gyroscope devices. Lieutenant Hegenberger is in charge of the Army experiments.

WEST POINT CADET WEDS COLONEL'S DAUGHTER

West Newbury, Mass., Nov. 7.—(AP)—An ex-West Point cadet and colonel's beautiful daughter are honeymooning here. Strict rules at the United States Military Academy at West Point say that cadets "shall not have a horse, dog, wife or mustache." Last year, however, while only a plebe, a first year man, Paul Capron, Jr., fell in love with Miss Marguerite Gillespie, daughter of Colonel Alexander Gillespie, instructor in ordnance and gunnery. Capron's own father is an instructor at the Navy Academy at Annapolis, Md., with a summer home here. Time for romantic aims is small

at West Point but the romance continued and the 20-year-old lad, who had attended Harvard two years, planned a secret marriage. During the recent Yale-Army football game at New Haven, while his cadet mates saw Albie Both upset the Army team, Capron met Miss Gillespie at a hotel there. New Haven failed to yield a clergyman who would wed a couple so hastily, or one could not be found, but a speedy roadster took them 50 miles away to Brewster, N. Y., and a Justice of the Peace tied the nuptial knot. Returning to the Connecticut City, Capron rejoined his mates before the next formation. Mrs. Capron returned to the Gillespie family residence. Capron's ambition is to become a

newspaper reporter. He tried one newspaper immediately after he was married but his application was turned down. With the bride's confession to her father the elopement became known and Major General William R. Smith of the academy summoned Capron before a board. On being told that he had made a "grave mistake," he resigned from the academy. The parental blessing, of course, was forthcoming.

Whooping Cough Shows Increase in N. Carolina

Raleigh, Nov. 7.—(AP)—Whooping cough and scarlet fever new cases both showed increases in the state for the week ending November 2, the Bureau of Epidemiology of the State Board of Health reported today. There were 138 cases of whooping cough reported last week and 107 the previous week with 142 cases of scarlet fever last week and 138 the preceding day. Diphtheria cases numbered 268 last week compared with 278 the preceding week. There were eight cases of smallpox last week, 15 of typhoid fever and one of measles.

Not only did Dartmouth ocean the fate which deprived them of the brilliant player whose heat had been set on being chosen All-American quarterback this year.

Countless thousands of fans who have jammed stadia throughout the east to see the elusive big green senior play regretted his passing from the gridiron.

According to Dr. John S. F. Gile, Dartmouth physician, Marsters has a fracture of the right transverse process at the third and fourth lumbar vertebrae. Dr. Gile said the injury would have no permanent effect on the player but will keep him either in the infirmary or on the sidelines for the remainder of the season. He will be allowed to

Britain in Favor Resuming Relations With Soviet Russia

London, Nov. 7.—(AP)—Britain's labor premier, J. Ramsay MacDonald, has been upheld by the Commons in the first major question of foreign policy to reach a vote.

A poll of 324 to 199 last night favored resumption of diplomatic relations with Soviet Russia on terms agreed upon by Arthur Henderson, minister of foreign affairs, and Valerian Dvoglevsky, Soviet ambassador at Paris.

The Liberals supported the government solidly, while three Conservatives, including Lady Astor, American-born peeress, deserted their leader, Stanley Baldwin, to back Mr. MacDonald.

The vote followed an acrimonious debate in which Mr. Baldwin offered an amendment deploring the "failure" of the new labor government to maintain the conditions which the preceding prime minister—himself—and foreign minister had laid down for resumption of relations.

The amendment was rejected by the same vote, 324 to 199 before the

vote was taken on the motion of Arthur Henderson for re-instatement of the Soviet Union in Britain's good graces.

Diplomatic ties with the Soviet were severed in 1927 after a raid on the London headquarters of Arcos, Ltd., Soviet trade organization, which was said to have proved charges of espionage and propaganda by Russian Communist agents in Great Britain.

Exchange of ambassadors will be the next step in fulfillment of last night's vote, and is expected to follow immediately. Negotiations will then be begun for settlement of outstanding questions between the two nations, probably including drafting of a new trade agreement.

Labor's victory in the Commons in this matter represented its first real test of strength with the Conservative opposition, and shaped up even more favorable than had been expected, although a favorable vote had been taken for granted since recognition of the Soviet has been a Liberal tenet also.

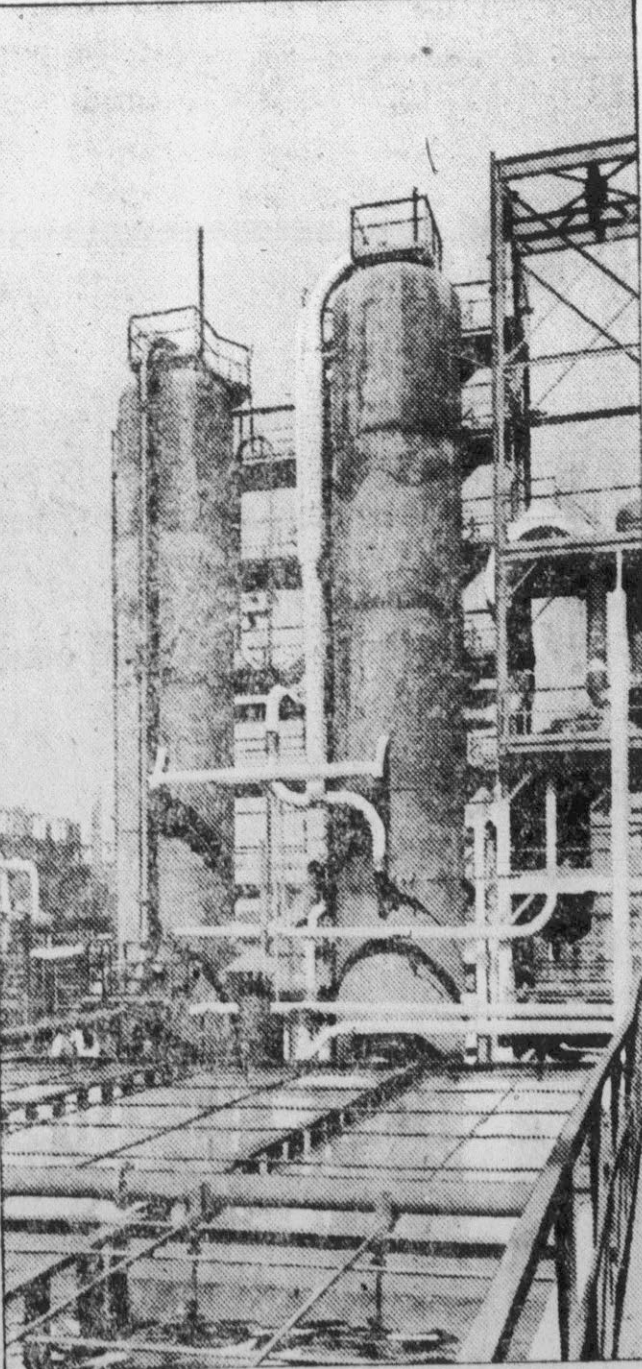

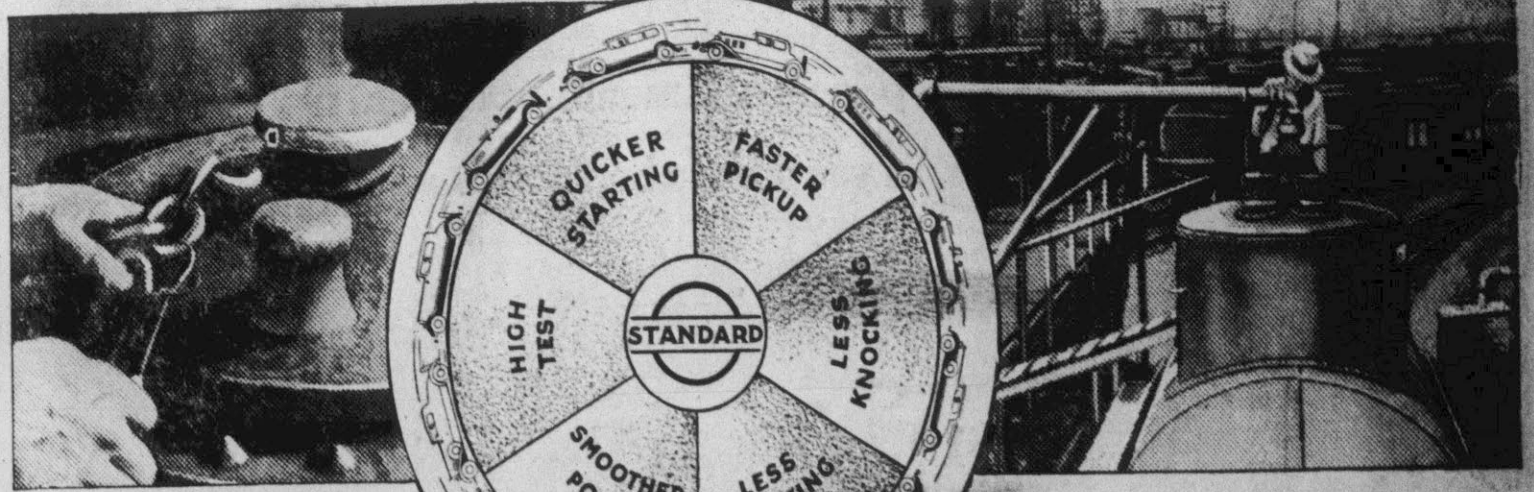

Yale apparently is in no danger from Maryland this week, but it may be recalled that in a similar situation last year Maryland escaped from New Haven with a 6-0 victory.

Cornell takes on Western Reserve as final preparation for its game against Dartmouth a week from Saturday.

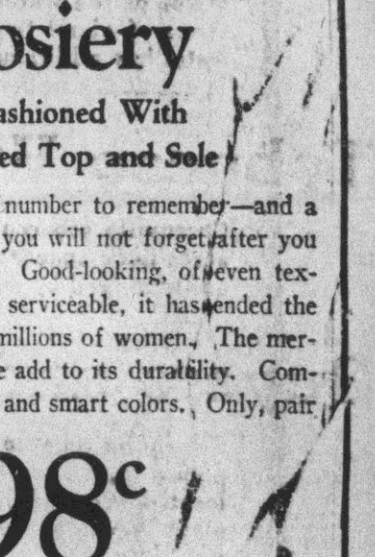

DEMOCRATS WINELECTION IN KENTUCKY

Party Also Wins Out in Chicago, But Republicans Claim New Jersey

Democratic majorities in both branches of the Kentucky General Assembly convention in January were indicated today on the basis of returns from yesterday's election. Republicans sought to gain control of the state legislature to strengthen the administration of Governor Flem D. Sampson, Republican, two years of whose four-year term remain. The governor and all appointive state officers are Republican. All elective officers except the governor are Democrat.

Unofficial returns point to the usual Democratic majority of approximately two-thirds of the lower house, and control of the Senate.

The Republicans, however, made a clean sweep of Louisville and Jefferson county. William B. Harrison, Republican, was elected mayor by an unprecedented majority of 30,000. In the Legislative races, the Republicans gained four seats by electing all eight candidates in Jefferson county. The one state Senate election in the county also went to the Republicans.

Almost complete returns from Chicago's municipal election indicated a decisive victory for the entire Democratic coalition ticket consisting of ten Republicans and twelve Democrats for Superior and Circuit court judges.

The Democrats were victorious in the mayoralty contest in Indianapolis, electing Reginald S. Hean, and another Democrat, James M. Curley, was elected mayor of Boston, in a race with two other Democrats running on party and non-party tickets.

In the bitterly contested election in Detroit, Charles Bowles defeated John W. Smith for Mayor in a contest conducted on non-party lines. Charles H. Kline was elected mayor of Pittsburgh in a Republican sweep of that city and Allegheny county.

Continued Republican control of the New Jersey legislature was indicated by slow returns from the elections in that state while the Democrats gained three votes in the New York state assembly.

"But brains weren't the fashion when dinosaurs lived in the world!"

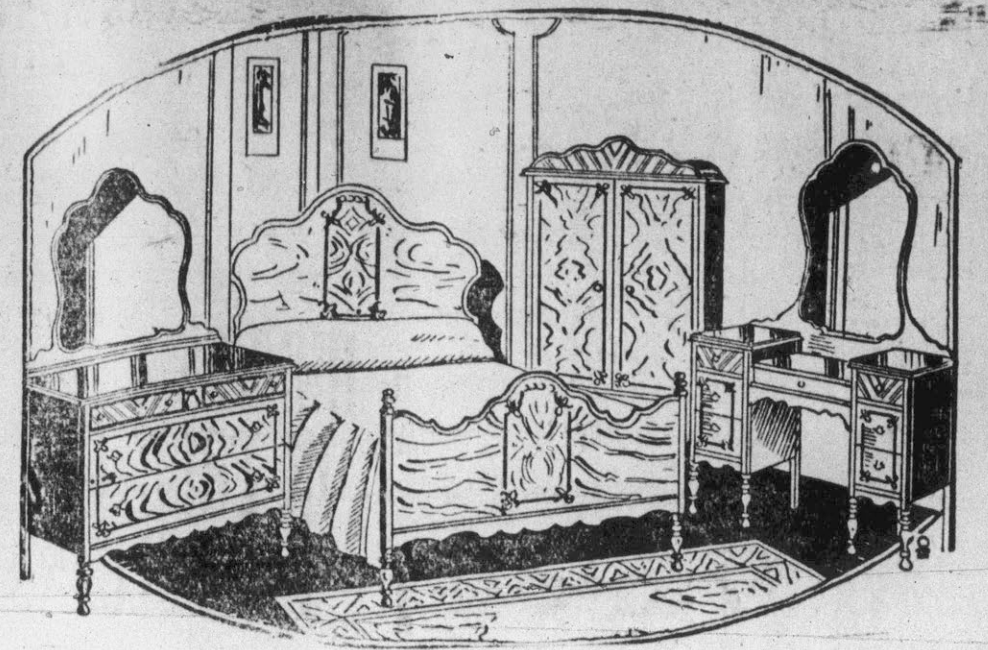
