FIVE KILLED IN EXPLOSION AT ELYRIA, O.

Several Also Injured By Blast Which Demolished the Timms Manufacturing Plant

Elyria, Ohio, Nov. 9.—(AP)—Five men were killed and four men and three women probably fatally injured today in a gas explosion that ripped out the walls of the Timms Ring Company here.

Three of the dead, positively identified, are: John Raple, 38; Louis Butcher, 40; Mike Swetz, 50.

The two others dead are believed to be W. H. Simpson and Louis Keas.

A flaming column of gas spurted more than 100 feet into the air and the walls of the plant crumpled like paper when a workman entered a gas-filled room in the building and struck a match to light a cigarette.

The detonation, heard for several miles, rocked buildings within a wide radius and all surrounding structures were splintered by flying brick and timbers.

The explosion occurred as the men were going to work at 7 o'clock this morning. Husted said he noticed the smell of gas as he stepped inside and noticed a man pulling on a cigarette.

"Don't light that match!" the foreman shouted, but he was too late with his warning. The blast followed instantly.

"There was a terrific roar and everything seemed to collapse around us," he said.

Husted collapsed after his brief account and was taken to Elyria Memorial hospital along with the other injured.

W. B. Timms, owner of the plant said the main loss would be the valuable tools and equipment destroyed. He said he was unable to estimate the damage.

Surrounding homes were threatened by the flames for a time. Windows were reported shattered within a radius of half a mile.

The ruins were searched for other bodies. The plant employs 30 men, but it was not known how many of them were inside at the time of the explosion.

The blast occurred when one of the employees lighted a cigarette in a room filled with gas, according to Sam Husted, foreman, who was one of the injured. The men killed were so badly lacerated that identification was difficult. The injured were painfully burned.

Tools and equipment of the plant, a one-story building, were scattered about. Some of them lodged in nearby trees, and the detonation was reported heard as far away as a mile.

Nationalist Begin Offensive Against the People's Army

Shanghai, Nov. 9.—(AP)—Dispatches from Hankow received by Rengo, Japanese news service, today stated the Nationalists had ordered the launching of a general offensive against the Kuomintang, or "people's army," now in revolt in Honan Province.

The Nationalist said Ching Kai-Shek, head of both the civil and military forces of the Nationalists, would be personally in command.

Chiang ordered the first and second Nationalist divisions, his favorite units, to take a position on the Mishien front, where the government army is said to have won a victory in the fighting yesterday.

The Japanese dispatch said shock troops were driving the rebels westward.

Other dispatches from Hankow stated that the dead at Mishien were "piled mountain high."

Ransom for Furrier's Release

Tientsin, China, Nov. 9.—(AP)—A second letter received today from Brenner, kidnapped New York furrier, said "For God's sake pay out this ransom."

Shortly afterwards telephonic communication which Brenner's brother had been maintaining intermittently with those who purported to be his abductors ceased.

It was believed the kidnapers had become alarmed and were desperate. Previously they had reduced their ransom demand from the \$500,000, Mexican, which had been asked at first.

Police and American consular authorities said at noon they had examined the beautiful Russian blonde who had been in Brenner's company prior to his disappearance thoroughly but that she had thrown no light on the identity or whereabouts of the kidnapers.

Plan To Adjourn Senate Until 20th of November Fails At Capital City

Washington, Nov. 9.—The Republican Independent-Democratic coalition in the Senate was started today by a proposal from Chairman Smoot of the Finance Committee that adjournment be taken until November 20, to enable the group to agree on tariff rate changes but the suggestion came to naught as coalition spokesmen voiced vigorous opposition.

Such a move would have necessitated unanimous consent unless arranged for by a vote. Smoot did not seek a ballot on the proposition and voices raised in protest precluded the possibility of obtaining a unanimity of agreement.

Senators Borah on Idaho, Republican-Independent, Simmons North Carolina, ranking Democrat on the Finance Committee and Walsh, Montana, acting Democratic leader, assailed the suggestion, asserting the coalition had accepted responsibility for the tariff and intended to write its own rates in the open and not in a secret session of a committee.

"We owe it to the country," shouted Simmons, "to discuss this bill publicly. If the Senators who proposed this legislation are not willing to enter upon that discussion then we will enter upon it by ourselves for the enlightenment of the people."

Senator Borah, said the coalition had taken over the responsibility for the tariff legislation in the Senate and asserted the group accepted that responsibility.

"In my judgment," he added, "it is incumbent upon us to dispose of the bill as rapidly as possible. What the country wants is speed."

The Smoot recess proposal was unexpected and apparently a surprise to the coalition leadership. Borah said he thought most of the Senators already had made up their minds as to how they would vote on most of the rates in the bill, adding he did not wish to see the bill fail.

Some provisions of the bill are of vital moment to the American people," he asserted. "If by our inaction or delay or neglect we shall lose some of its provisions we would be doing a substantial injury to the American people."

"While I am interested in the rates," he went on "I am more interested in the administrative features of the bill as they relate to the executive and legislative bodies."

This referred to the flexible provision of the tariff act which the coalition amended to take from the president and give to Congress authority to raise or lower duties fifty per cent on recommendation of the tariff commission.

Smoot's proposal was made shortly after the Senate convened. It was preceded by Senator Norris, of Nebraska, a Republican Independent, offering an amendment designated to prevent radical pyramiding of the tariff on imported goods by the imposition of a tax of 99 per cent of the retail price after allowing for duty, freight, insurance and a profit of 25 per cent.

Hoover Administration to Spend \$3,830,000,000

Washington, Nov. 9.—(AP)—The Hoover administration has drawn up its first budget and plans an expenditure of \$3,830,000,000 in the fiscal year of 1931, a total \$111,000,000 less than that appropriated by Congress for disbursement in the corresponding fiscal period ending next June.

The figure, however, is \$158,000,000 greater than the budget submitted by the Coolidge administration for the present fiscal year. This called for an expenditure of \$3,672,000,000 and to this was added nearly \$300,000,000 in deficiency appropriations. Neither the amount appropriated for this year nor that planned for the next, however, includes appropriations for the Federal Farm Board, which this year has been given \$150,000,000 by Congress to finance its activities. Its need for the year ending in 1931 have not yet been ascertained.

The additional \$10,000,000 for waterways includes \$5,000,000 to be devoted to actual waterway improvement and a like amount for a continuation of flood control work in the Mississippi Valley. In addition, about \$5,000,000 will be available for waterway improvement as the Ohio river development program was completed at a cost approximately that much less than had

Business Houses Will Close Here On Armistice Day

Virtually all business houses of Greenville will be closed all day Monday in observance of Armistice Day, it became known this morning. While a few of the stores may remain open a few hours to accommodate their patrons, they will be closed, however, between 10:30 and 1:00 o'clock in order that their employees may have an opportunity of taking part in the local celebration.

The closing will be more general than any previous year since the signing of the armistice, and will make it possible for the people in every walk of life to witness the exercises which the American Legion has provided on the anniversary of the signing of the armistice eleven years ago.

The tobacco market, banks and courthouses will also be closed the entire day, and it was expected other organizations would join the closing movement before Monday.

PANTAGES IS SENTENCED TO SAN QUENTIN

Los Angeles, Nov. 9.—(AP)—Alexander Pantages, vaudeville magnate, today was sentenced by Superior Judge Charles Fricke to a term of one to five years in San Quentin penitentiary for a statutory offense against 17-year-old Eunice Pringle.

Los Angeles, Nov. 9.—(AP)—With his wife at liberty under probation from her manslaughter conviction in connection with the death after an automobile collision of 3-pro Rokumoto, Japanese gardener, Alexander Pantages is to appear before Superior Judge Charles Fricke today to be sentenced for an attack upon Eunice Pringle, 16-year-old dancer.

The wealthy showman will ask for a new trial on grounds of irregularities in deliberations of the jury.

Mrs. Pantages yesterday was released from the custody of the sheriff by Superior Court Judge Carlos Hardy, who ordered her \$50,000 bond exonerated and demanded that she report once each month for ten years to the county probation department. During that time she must refrain from drinking intoxicating liquors and must obey all laws. Violation of any of the probationary orders would result in her being ordered to serve the manslaughter term of from one to ten years in prison.

In addition, the theatre man's wife was deprived of her automobile drivers license for the period of her probation, and was ordered to satisfy immediately a judgment of \$78,500 awarded the survivors of Rokumoto.

Block Effort To Get Probe Cotton Marts

Washington, Nov. 9.—(AP)—An attempt by Senator Heflin, Democrat, Alabama, to obtain authority for an investigation by the Federal Farm Board, of speculative transactions on the New York, Chicago and New Orleans cotton exchanges, was blocked in the senate today by Senator Jones, of Washington, acting Republican leader.

Heflin presented the measure at the outset of today's session and asked its immediate consideration. Jones objected. Under Senate rules it cannot be considered again before Monday when Heflin said he again would seek its consideration.

The Alabama asserted that transactions on the New York Stock Exchange had an adverse effect on prices on cotton exchanges.

"The situation in the cotton producing states is grave," the Alabama Senator said, "Cotton is selling below the cost of production." He added it was "unfair" to permit the exchanges to "hammer down" the price.

In making a report of its investigation to the Senate the board "thorized to say whether, in its opinion, the cotton exchanges ought to be closed and to recommend legislation "it feels would be helpful."

Washington, Nov. 9.—(AP)—The announcement at the treasury that the 1931 budget estimate of \$3,830,000,000 was \$111,000,000 less than the 1930 budget of \$3,941,000,000 was described today by Representative Byrns, of Tennessee, ranking minority member of the house appropriations committee, as "misleading information."

Byrns asserted the total expenses for the next fiscal year, including postal expenditures, farm board appropriations and prospective deficiencies, would bring the total nearer \$5,000,000,000 than \$3,800,000,000.

"President Hoover," he said, "has deliberately followed the policy of the past five or six years of preventing the public from knowing the actual requirements for government expenses. He has resorted to the old policy of juggling figures with the plain purpose of misleading the people of the country as to the government's exact fiscal situation."

He added that while the "1931 budget estimates are \$111,000,000 less than the final estimates for 1930, including deficiencies amounting to \$275,000,000 they are actually \$132,000,000 in excess of President Coolidge's original budget estimates."

ACCEPT PLANS FOR SHEPPARD LIBRARY HERE

Plans for the Sheppard Memorial Library have been completed and were tentatively accepted at a meeting of the building committee and members of the library commission last night. It was stated today that contract for erection of the building would probably be awarded around the first of December.

The new library building will cost \$50,000. It is a gift of Mr. Harper D. Sheppard, shoe manufacturer of Hanover, Pa., as a memorial to his father, a native of Pitt county. The architect is George Boney, of Wilmington, who has been working on the plans over a period of several weeks. Members of the library building committee and Mr. Boney visited other libraries in this part of the state before the drafting of plans for the local structure actually got under way.

The new library will be a thing of beauty. It will be situated on the old Evans street school site where the present library building now stands. The location was donated to the library commission by the Greenville School Board and was accepted by the city aldermen at a meeting several weeks ago. The transaction must be ratified by the legislature to insure its legality.

The plans which Mr. Boney presented to the commission last night call for a building of semi-colonial type of architecture, two stories high with basement. The building will be constructed of Virginia brick and will be ornamented with marble trimmings around the doors and windows.

The ground floor of the building will consist of a room devoted to boys' activities, receiving and locker rooms. The room for boys' activities will fill a long felt need of the boys of the town, in that here they may hold any kind of meetings in connection with work of their organizations.

Entrance to the first floor of the structure will be made through a colonial portico and vestibule. This will lead directly to the main library room and stairways to the second floor. On either side of the library room may be found a children's reading room and adults' reading room. Open fireplaces have been provided for each of these rooms and these will be lighted in such way as to furnish an atmosphere of peace and tranquility.

Back of the library room is the librarian's office, storage room for books, work room, and private reference rooms where those desiring reference works may find quiet and peace for their studies.

The second floor consists of a balcony surrounding the open space above the main library. The balcony is flanked by an assembly and story hour room. This room will have a stage, speaker's platform and dressing room, and will be open to small public gatherings and entertainments. On the other side of the building will be found an historical room. This will be used as a local museum where relics of county-wide interest will be placed on display. There will also be a lecture room for the accommodation of small gatherings.

The library has been arranged to take care of approximately 28,000 volumes, but provisions have been made to increase its capacity to 45,000 volumes.

The building has been arranged so that activities in either section will not interfere with the main library. This will be accomplished through a scientific process of reducing sound to a minimum and making it possible for work to continue in the main library free from noise in other departments.

Must Earn \$50,000 to Pay Brokers for Stock Market Loss

New York, Nov. 9.—Her \$900,000 inheritance wiped out by the stock market crash, Miss Margaret Shotwell, concert pianist, hopes to earn \$50,000 in her profession in order to pay what she owes a broker.

Miss Shotwell, who is 22 years old, was known as the cigarette heiress after she received \$1,000,000 from the estate of John Neal, district manager for the R. J. Reynolds Tobacco company. He died in 1923. Part of the fortune was in stock of the Reynolds company.

"I was just one of the suckers," she said.

"I lost every cent I had in the world. That was \$900,000 and I owe \$50,000 to my broker besides."

"But it isn't smart to be rich anymore. I've lots of company now, you know."

Woman Declares Her Dead Brother Promoted Bombing

Bellaire, Ohio, Nov. 9.—(AP)—A statement by Mrs. George Monroe, a resident of the mining section near here, claiming that her dead brother was responsible for the 1916 Preparedness Day bombing in San Francisco instead of Tom Mooney, was before authorities today.

Mrs. Monroe said Lewis Smith, her brother, in a death bed statement in Cleveland seven years ago, "confessed" that it was he who planted the bomb which took the lives of ten persons marching in the San Francisco parade. He declaration corroborated a letter from Frank O. Stevens, inmate of the Dayton, Ohio, National Military Home, to Senator Thomas D. Schall of Minnesota.

Mooney, now 46, is serving a life sentence in a California prison. He at first was sentenced to be hanged, but Governor W. D. Stephens commuted this to life imprisonment in November 1918.

Mrs. Monroe. Located on Steven's information, agreed with his story that Smith admitted he planted the explosive on the promise of being "well paid." Smith, however, said he received nothing for the outrage. His sister said she swore that Mooney had nothing to do with the bombing. She did not press him for further details, she said, because she did not wish to become involved in the case which has attracted nationwide attention.

In a statement supplementing his letter to Senator Schall, Stevens told of first becoming interested in the case when he and Smith worked together in a mine at Pipe Creek, Belmont county, Ohio, in 1919. "Tom Mooney is not doing his own time; he is doing some one else's," Smith said then, according to Stevens. But would give no further details.

Later, Stevens recounted, Smith moved to Wheeling, W. Va., and finally to Cleveland, where he died July 4, 1922.

GIVE VOTE OF CONFIDENCE TO CABINET

Paris, Nov. 9.—(AP)—The French Chamber of Deputies in the hours before dawn today, twice voted confidence in the new government of Andre Tardieu, according to an even greater majority than its fondest friends had hoped.

The poll was 327 to 256, a majority of 71, on the first ballot, when the Socialists sought to amend the government's motion of confidence; the majority was increased to 79 by a vote of 322 to 253 when the confidence motion itself was put before the chamber.

The two votes followed an impassioned speech, seldom matched in the chamber for oratory, by Aristide Briand, foreign minister and former premier, and a lucid discussion of cabinet policy, bristling with facts and figures, by Tardieu himself.

The ovation accorded M. Tardieu was only slightly less than that given M. Briand, who closed his defense of his foreign policies with the shouted peroration:

"The French nationalists have attacked me. The French Huguenots have wished to overthrow me. Erzberger, Rathenau, and Stresemann were likewise suspected in Germany because they sought to improve Germany's relations with France."

Erzberger and Rathenau were assassinated, Stresemann died at his task. And then he ended dramatically as the deputies applauded: "Must I die to prove my sincerity?"

Where M. Briand generalized the new premier was specific. M. Tardieu, addressing himself particularly to the right and center, which applauded while the left remained silent, promised evacuation of the Rhineland by June 30, 1930, would not occur unless the Young plan for reparations was in full operation.

TITLE HOPES AT STAKE ON THE GRIDIRON

Atlanta, Nov. 9.—(AP)—Title hopes of two major contenders for the Southern Conference gridiron championship were at stake today as Vanderbilt and Kentucky, boasting unblemished records, clash with Georgia Tech and Alabama.

Three other events, unranked within the circuit, also risk their flag aspirations but only the struggle of upsets could halt their winning stride. Several inter-sectional combats and a series of engagements having strong sectional interest round out the day's program.

However, the battles of Nashville and Montgomery overshadow all others. At the Tennessee capitol the Golden Tornado of Tech endeavors to assume the giant killer role again and destroy Vandy's plans of snatching the bunting.

At Montgomery, Alabama, twice thwarted in attempts to block the forward marches of Tennessee and Vanderbilt, places its strongest machine in the field against Kentucky.

Critics experts insist there are no favorites in these games.

Kentucky, hampered by injuries and by the absence of its star Sophomore halfback, "Shipwreck" Kelly, has been reduced to even terms with Alabama's Crimson Tide. Should Kelly, by any chance, leave the bedside of a sick grandmother and arrive in Montgomery, the odds would shift to the Blue Grass entry.

Of the other undated squads, Louisiana State is slated to find the stoutest opposition. The Tigers mix it with the Duke Blue Devils, Tennessee and Tulane expect to continue their mad rush through Carson-Newman and Auburn.

Georgia's invasion of New York for a crack at the New York university headlines the inter-sectional schedule. Maryland attempts to stop Albion Booth and company at New Haven and Mississippi battles Purdue at Lafayette, Ind. Oglethorpe entertains Manhattan college at Atlanta and the Mississippi Aggies are hosts to the Michigan State Spartans at Jackson.

The remaining conference tilts send Clemson against Virginia Military, North Carolina against South Carolina and Virginia Poly against Virginia.

Sewanee and North Carolina stage play Southwestern and Davidson both non-conference foes.

The Chattanooga-Howard and Citrus-Furman debates to the Southern Intercollegiate Athletic association program.

MONDAY IS ARMISTICE DAY.
 By JAMES W. GOOD
 (Secretary of War)

Eleven years ago, the guns that for four years had clamored their dreadful chorus from the North Sea to the Swiss Alps, were silenced. The greatest war of all history, a vast and desperate struggle reaching to the roots of human life, had come to an end.
 We, with other peoples, had made a solemn sacrifice for the amelioration of the world and each passing year has brought a deeper appreciation of the nobility and significance of that sacrifice.
 No words we speak, no monuments we build can pay adequate tribute to the devotion, the heroism and endurance of those who gave their lives and all that life means in order that we might achieve victory, but as each succeeding November brings another Armistice day we keep faith with them by re-consecrating ourselves to the establishment of lasting peace.
 Since we celebrated this day of human triumph a year ago much progress has been made along definite lines to insure international amity. The outlawry of war and the proposed disarmament conference are palpable evidence that we stand with all our moral and material strength on the side of peace.
 We are true to our trust with the dead and as, with the coming of this day, we look backward down the lengthening vista of the years, we gratefully remember their heroic spirit and derive new inspiration and courage to meet our obligations as beneficiaries of their sacrifices.

ABOUT TOWN

Monday is Armistice Day, a day when Greenville and Pitt county people will turn out to celebrate the signing of the Armistice that brought to an end the most bloody conflict in the annals of the world.
 We have had many celebrations since the armistice was signed, but none like that scheduled for Monday. It will be more than a celebration. It will be a gathering of the people of this great locality to pay tribute to the men who crossed the broad Atlantic to fight a foreign foe and win world-wide fame for their intrepidity.
 It is nothing but proper and fitting that we should set aside this one day for this purpose. We have other days commemorating other events, but none is more important than that involving the lives of millions of men of virtually all nations of the world.
 Just think what a few more minutes required to sign the armistice would have meant. It might have cost the lives of thousands of brave men who are at home today to help us celebrate the armistice—men who offered their lives upon the altar of their country and were saved from a foreign grave by the quick ending of the war.

It matters not how much you have forgotten the keen thrill of pleasure—the moment of ecstatic delight that tingled throughout your entire body, when the news was flashed throughout the world that the armistice was signed—go out to the exercises Monday and let the boys know that you are at least appreciative of the sacrifices they made and the imperishable glory which they shed upon the name of the great nation they represent through their acts of heroism upon foreign battlefields.
 It is the least you can do to show that you really believe in the great cause for which they fought—the cause of life, liberty and the pursuit of happiness.

Marvin Horton, of Farmville, the game warden of Pitt county, is of the opinion that the majority of farmers are confused regarding the buying of hunters licenses.
 He says the tenant farmer is about the worst confused of anybody else. He not only hunts on the land he rents, but he seems to think he can hunt all over the countryside without licenses.
 This is a mistaken impression, the game warden said. A tenant can hunt only on the land he rents, and must have license when he goes beyond the confines of his own boundaries. The same is the case with a landlord. He may hunt on his own property, but he can not go beyond his boundaries without license.
 Mr. Horton also said that trappers were confusing hunting and trapping licenses. There are two separate and distinct licenses. The trapper must have license to trap and the hunter to hunt, and when caught without them somebody is going to get prosecuted.

The public should give the hunting laws more attention and in that way save themselves from violation of the legislation with the flimsy excuse that ignorance caused them to violate the law.
 Don't forget to attend services at some church tomorrow.
 The ministers of the city have been asked to set aside a few moments of their services in behalf of the signing of the armistice that brought to an end the great World War.
 Just what the form of service will be has not been definitely ascertained, but each of the churches will celebrate the occasion as it sees fit.
 The service should be among the most inspirational of the year. Everybody remembers November 11, eleven years ago, when news was flashed across the Atlantic that the war had come to an end—that the belligerent nations had signed an armistice concluding hostilities.
 You can readily recall the thrill of joy that surged through your being in the knowledge that soon some loved one would be returning to your fireside to take his accustomed place in the joys and sorrows of the household.
 Or, perhaps, you may have been one of the countless thousands who bent with grief and sorrow because of the loss of a husband, brother or sweetheart, yet lifted your face to heaven in a spirit of thanksgiving for the salvation of the loved ones of other homes.
 Whichever side of the picture you represent, be sure to be among the hundreds to attend services tomorrow and in that way pay tribute to the heroism of the thousands who crossed the ocean that civilization might be saved from the ruthless heel of German autocracy.

Today you will have an opportunity of buying a forget-me-not—a tiny flower symbolic of the sufferings of the men who crossed the ocean to fight in the World War.
 The little flowers were offered for sale along principal streets of the city today and numbers of people bought, realizing as they did that whatever they gave for the flower would be devoted to relief of the suffering of disabled veterans who receive no compensation from the government.
 It may be you missed your forget-me-not; it may be the salesman did not come in contact with you, but in either case do not let the day pass without buying. Wear it tomorrow and Monday, and let it speak for you in telling the world that you are truly appreciative of the sacrifices made by those heroes who gave so freely of their life's blood that you might enjoy peace and happiness and prosperity.

A community-wide prayer service will be held tonight in the Modern Woodmen hall on Evans street. The meetings are to be held every Saturday night at 7:30 o'clock, providing enough interest is manifested on the part of the public, conducted under the auspices of the laymen of the various local churches. Rev. W. S. Harden, of the Presbyterian church, will have charge of the first meeting tonight. Rev. Harden is an able speaker and a real inspiring message is assured all who attend.
 There is nothing that will help to cement the people of a community any more than united religious meetings, and it is hoped that these meetings each Saturday night will prove a success from every point of view. The public is cordially invited.

HELD AT HOSPITAL ON MURDER CHARGE
 Spartanburg, S. C., Nov. 9.—(AP)—Rhee Gault, 27, is being held under police guard at a hospital here on a technical charge of murder growing out of the death of Bernice Pennington, 23, of Drayton, who was killed in an automobile wreck on the outskirts of the city early this morning.
 A coroner's inquest is scheduled for late today.
 The automobile, operated by Gault is said to have plunged into a ditch and collided with the front of a filling station. Miss Pennington thrown clear of the machine and died almost instantly of a fractured skull. Gault left shoulder was crushed and he received bad body bruises.

Dismiss Church Members Result Marion Strike

Marion, Nov. 9.—(AP)—Although admitting this morning that twelve members of the East Marion Missionary Baptist church had been "given their letters," A. R. Black, church clerk, denied their dismissal from the congregation was the result of membership in the union.
 Rioting and disorders in connection with the strike at Marion were given as the reason by the clerk.

Marion, N. C., Nov. 9.—(AP)—Letters of dismissal, the issuance of which A. R. Black, clerk of the East Marion Baptist church, said was prompted partially by activities in behalf of a textile union during strikes here, have been sent to members of the congregation.
 The clerk, and S. J. McBee, moderator or chairman, were authorities for the announcement of the dispatch of the letters. The church has no regular pastor.

Mr. Black said "lawlessness in connection with the strike and disregard of church discipline on the part of the members was the reason for the step."
 Asked specifically if the union activities of the members had any bearing on the action, Mr. Black replied they did.
 Various estimates are current as to the number of dismissals, the figure running from twenty to more than a hundred. It is said there are 140 members on the church roll.
 Mrs. D. V. Elliott and her husband were among those dismissed. R. Elliott was a member of the board of deacons and the teacher of a Bible class in the church. Another of those dismissed was G. A. Brady, a merchant and property owner in the mill town. Both of the men own their own home and were not among those who are being evicted by the mill authorities.

A series of disorders followed the calling of strikes at the Clinchfield and Marion Manufacturing company mills here by the United Textile workers. In the last disturbance eight were fatally wounded. State troops continue on guard.

SERVICE FLAG TO FLY FROM CAPITOL MONDAY

Washington, Nov. 9.—(AP)—The same sort of flag that mothers displayed in their homes during the World War to indicate the number of loved ones in the nation's military service will fly above the capitol throughout Armistice day.
 An enlargement of the little service flags that were so numerous during the war will be unfurled by the American War Mothers to commemorate the services of the men of the American forces.
 Instead of a blue star for each living son in a service and a gold one for that made the supreme sacrifice, the enlargement will carry in blue numerals the total number who served and in gold the number who gave their lives. One large gold star and one of blue will serve as reminders of the significance of those colors.

Market Report Cotton--Stocks--Grain

COTTON MARKET Stock Exchange At New York Is Closed Today

New York, Nov. 9.—(AP)—Cotton opened steady today at a decline of 7 to 7 points under some murmur of liquidation and southern selling. Some local selling was also reported on the relatively easy showing of Liverpool, but the offerings were light and prices rallied to about yesterday's closing quotations during the last few minutes on trade buying and covering. New Orleans was relatively steady and bought some cotton here, but the selling continued and prices dropped off again with active months showing net losses of about 5 to 8 points at the end of the first half hour.

Cable advices from Bombay reporting damage to the Yoomra crop by hot winds came in for some attention but seemed to be offset by the earlier ruling of Liverpool. It was also reported that American buying and trade calling had been supplied by liquidation and hedge selling in the English market. The amount of cotton on shipboard awaiting clearance at the end of the week was estimated at 182,000 bales against 140,000 last year.

New York, Nov. 9.—(AP)—The stock market was closed today after ending its week with a session of normal trading which in the opinion of bankers indicated a return of stability.

The stock exchange and the curb market will be opened Monday, Armistice Day, with a two-minute suspension of business at noon in recognition of the day. Three-hour sessions from 10 A. M. to 1 P. M. will be continued next week with the exchange closed on Saturday.

Total sales on the stock exchange yesterday were 3,214,660 shares. The turnover for the week was 22,516,490 shares. The ticker was 37 minutes late at the close.

Readjustments after the frenzied trading of the last two weeks resulted in an irregular market which showed the general level of prices lower at the close although several issues made net gains for the day. The group of bankers who organized to stabilize the market at the beginning of the collapse said they planned no meetings over the week

and. They pointed to the orderly character of the trading, the reduction in volume and the absence of selling pressure as indications of improved conditions.

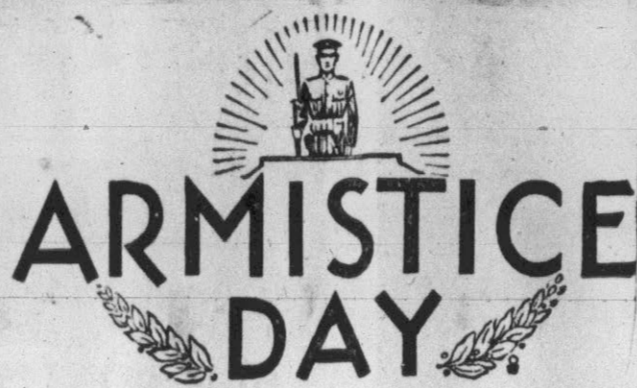
German Dramatist Sent to Prison on Murder Charge

Berlin, Nov. 9.—(AP)—Peter Marin Lampen, German dramatist was snatched to a Silesian prison today charged with murder, and himself the center of a situation matching in interest any that his pen has produced.

Police in holding him believed the 8-year-old mystery of the death of Fritz Koehler, soldier of the "Black Army" or Oberland Free Corps, a Nationalist organization, who disappeared mysteriously while stationed at the estate of Baron von Richthofen in Silesia in 1921.

The arrest was said to be due to information of a fellow member of the organization named Muller, who said he and the dramatist were members of the party designated to execute the man in accordance with the sentence of a secret court, his court was illegally self-empowered to put to death "traitors" within the organization it represented.

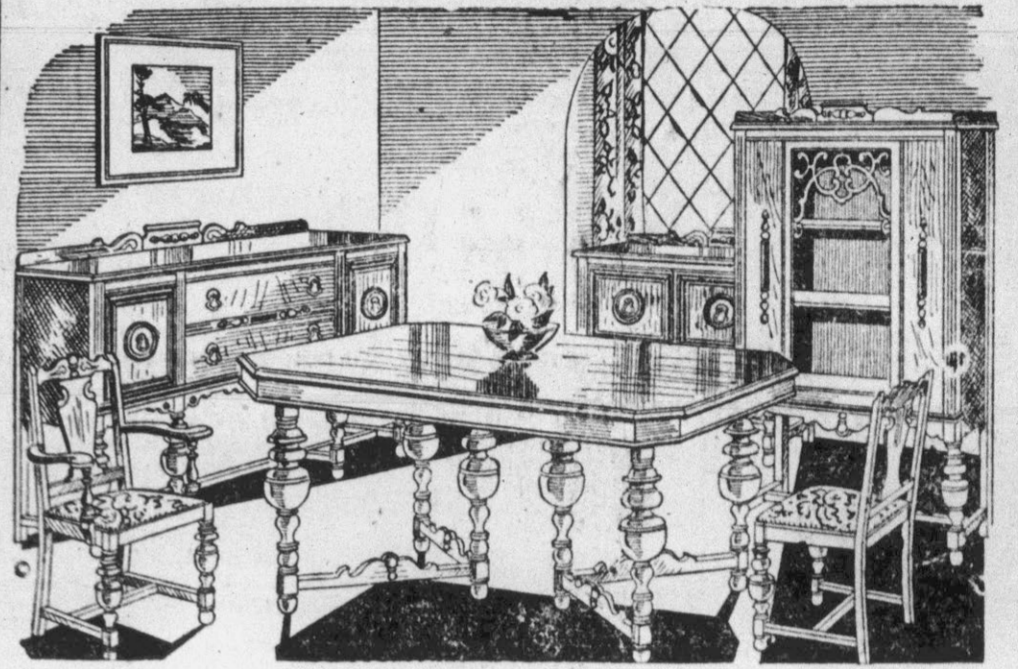
