COLLEGE MEN FACE ARREST IN RUM CASE

Big Haul of Liquor Made in Raid of Fraternity House at Illinois University

Urbana, Ill., Nov. 18.—(AP)—A liquor raid by county officers on the Gamma Eta Gamma Fraternity house yesterday has brought 35 University of Illinois students face to face with the prospect of arrest and expulsion from school.

Twelve gallons of alcohol, gin and whiskey were confiscated at the fraternity house which officers said was being used as headquarters for a ring of student bootleggers who they believe had been operating all fall.

State's Attorney Cline and Sheriff Shoaf said padlock action would be started to close the place as a public nuisance.

Three students were arrested. William Sherman of Crown Point, Ind., a sophomore, was held by officers to have been the leader in liquor sales. Alfred J. Withers of Hibbing, Minn., a freshman, and Ernest Longbons of Marion, Ill., a junior, were the other two.

Preliminary action led the sheriff to believe that bootlegging had been going on since school started in September, alcohol being purchased at \$12 a gallon and sold for \$32.

It was believed that only a few students were actually involved in the sale of liquor, but officers regarded the entire fraternity as implicated.

J. D. Lewis, of Orchardville, Ill., president of the fraternity, pledged all members would be present whenever the state's attorney wanted to question them.

The raiders said a truck owned by Withers yielded a five gallon jug of alcohol, and that two gallons of whiskey were found in Longbons' trunk. The other liquor was found in various caches about the house.

B. W. Hoare, a student of the school of engineering, admitted, under questioning, that he had made liquor purchases at the house, police said. He was released on his promise to hold himself ready to testify.

Three Buildings Burn As Fireman Hunt for Wrench

PLAN TO PUSH FOR ACTION ON TARIFF ISSUE

Hoover Regulars to Outline Concerted Plan of Attack

Washington, Nov. 18.—(AP)—The Senate's newest faction, the "Hoover Regulars," who have dedicated themselves to keeping the Senate at work on the tariff bill, even in opposition to the wishes of the duly constituted party leaders, will meet tonight to lay out for the first time a concerted plan of campaign.

Dining together between the afternoon and evening sessions of the Senate, this group, composed primarily of the younger—in point of service—Republican members, will discuss ways and means of keeping the Senate in session and the tariff measure before it, in an effort to reach a final vote on the bill before the close of the special session.

The "Younger guard" as it has come to be called, disclaims any rivalry against the "old guard" chiefs, in spite of the fact that it went counter to Senator Jones of Washington, the acting Republican leader, last week in voting against it.

It does claim, however, a close relationship with President Hoover and a determination to carry out the policies of the chief executive.

Senator Allen of Kansas, described it as a group of fellows helping the Republican part by getting the tariff bill in the best shape possible, and said the meeting was for the purpose of "passing a tariff bill within a reasonable time."

Another senator who has allied himself with the "young guard," Robinson of Indiana, characterized it as a "real Hoover bloc."

The rise of the "Hoover regulars," leaves the Senate's Republican majority divided three ways. There is the regular, "old guard," group under the leadership of Senator Watson of Indiana, now resting the tie south; the Independent faction, led by Borah of Idaho and Norris of Nebraska, and the new faction, apparently led by Vandenberg of Michigan, and Allen, an intimate friend of the president.

TEN RICH PEASANTS CONDEMNED TO DEATH

Caucasia, Nov. 18.—(AP)—Ten Kulsaks, or rich peasants, have been condemned to death for Anti-Soviet agitation, profiteering and opposing the government's grain collection campaign. A number of others were sentenced to imprisonment for from three to ten years.

While all of its coast is in the Mediterranean area, the Italians, as their view is understood in Washington, insist that they must have naval parity with any other European Continental power because they must depend upon unobstructed sea lanes for necessary supplies due to the limited land boundary and the rugged nature of the north country.

Nineteen Persons Killed In Nation-Wide Rioting During Mexican Election

Mexico City, Nov. 18.—(AP)—Nineteen persons were killed and more than 50 wounded in nationwide rioting Sunday which accompanied overwhelming election of Pascual Artiz Rubio to the Mexican presidency. Obtainable figures showed eight killed in Mexico City, and six in other parts of the republic, with five policemen killed at Toluca when the truck in which they were riding was wrecked. The wounded, some of them seriously, passed 50, of whom 25 resided in Mexico City.

Headquarters for Jose Vasconcelos, candidates of the anti-re-election party, charged supporters of Ortiz Rubio had taken charge of voting booths; and through force and intimidation prevented tens of thousands from voting.

Headquarters for the Revolutionary Party, which supported the candidacy of Ortiz Rubio, today denied they had taken charge of voting booths under the Mexican law which says the first nine voters arriving at a booth shall control it.

The successful candidate who has been civil engineer and soldier as well as politician, spent election day in the village of Uruapan, Michoacan, where he formerly was governor and where his family lives.

Vasconcelos was said here to have passed election day at San Blas, Sinaloa. There was no confirmation that he would carry into effect frequent threats of himself and partisans to set himself up as a rightfully elected president, maintaining his claims by force.

Despite the bloodshed and rioting Mexican officials professed to be satisfied at what was called "comparatively quiet election day." Cavalry and infantry contingents paraded streets of the principal cities, rushing quickly in answer to frequent emergency calls, probably, it was said, preventing worse conditions.

The principal rioting in Mexico City occurred within a few blocks of the National palace, at the junction of La Avenida Madero and La Calle Bolivar. Several trucks of Artiz Rubio clashed with Vasconcelos listening to speeches from their campaign headquarters.

In an exchange of shots and rain of stones and pieces of asphalt from the pavement two persons were killed outright and many wounded of whom two died later. Two hundred police intervened and restored order. Outside the capital one was killed and 12 wounded at Villa Cecilia, near Tampico, four killed in fighting at Vera Cruz, and one killed at Cordoba.

CAROLINA TO LIFT EMBARGO ON FLA. FRUIT

Commissioner Graham Says Ban May Be Lifted Within Next Week

Raleigh, Nov. 18.—(AP)—The embargo placed on Florida fruit due to presence of the Mediterranean fruit fly will be lifted in North Carolina, probably within a week, William Graham, state commissioner of agriculture, announced today.

Commissioner Graham returned to Raleigh late last night from a conference in Washington where he and commissioners of other representative states appeared before the Federal Plant Quarantine Control Board relative to lifting the embargo.

The federal authorities agreed to lift the ban until the first of February, Commissioner Graham said, and in all probability the shipments to North Carolina will continue until March 1. Should infestation of the fly be found in Florida or any of the other states involved the shipments of fruit will be discontinued at once.

Mr. Graham said that a few details remained to be agreed upon at the conclusion of the conference, making it impossible to announce the exact date the ban will be lifted, but added that he thought everything would be ready for full announcement of details this week, probably today.

The commissioners were told by Dr. Marlett and other members of the Federal Farm Board that shipments would be allowed of fruit which had been sterilized by heating to 110 degrees. The fruit will be carefully inspected at shipping sheds by government inspectors and each container will bear a government inspection stamp. The fruit will be shipped in carload lots only and agricultural officials of the states to which shipments are made will be notified.

Under this arrangement, Commissioner Graham said, it will be safer to receive fruit from the infested zones than from the non-infested zones where such a close check is not made.

Commissioner Graham said he acquired to the desire of the other states to lift the embargo upon the assurance of the Board, which is made up of experts in such matters, that there is no danger of infestation from fruit handled under the regulations planned by the Board.

STOCK PRICES DRIFT LOWER IN NEW YORK

Steady Stream of Selling Orders Today Causes Downward Trend

New York, Nov. 18.—(AP)—A steady stream of selling orders poured into the New York stock exchange today and prices generally drifted lower, declines ranging from \$1 to nearly \$16 a share. The announcement of the failure of a New York stock exchange house, made just five minutes before the market closed, failed to bring out any unusual volume of liquidation, although a few high priced specialties broke sharply on the offerings of floor traders.

Prices had been slipping steadily downward from the opening on what appeared to be profit-taking following the sharp advance in the two closing sessions of last week. Some short selling also made its appearance, but it was rather cautious in character because of the inquiry still under way by the New York stock exchange to determine the character and source of the recent bear selling.

U. S. Steel common opened 75 cents a share lower at \$163.50, traded at \$164.50, broke to \$159.87 in the last few minutes of trading and closed at \$160 for a net loss of \$4.25. Allied Chemical closed \$4 a share higher at \$234 after having sold as high as \$240.

General Electric dropped \$8 a share to \$190 and rallied \$1.50. American Telephone closed nearly \$4 a share lower at \$246, after selling slightly below that figure.

Mandeville, Brooks and Chaffee, the latest brokerage house casualty, was a comparative newcomer to the stock exchange, with its principal office in Providence, and branches in other Rhode Island cities. It was the first stock exchange firm to suspend, as a result of the recent break, although two members of the New York stock exchange and one member of the New York produce exchange previously had announced their inability to meet engagements.

GREENVILLE MAN AND BETHEL WOMAN INJURED IN ACCIDENT ON BETHEL HIGHWAY

W. L. Thompson, traveling salesman of Rocky Mount, was fatally injured in an automobile collision on the Greenville-Bethel highway, about four miles from Bethel, yesterday afternoon and died while on the way to the local hospital. The top of Thompson's head was almost completely shattered.

Clifton James, of Greenville, driver of the other car, and Miss Nora Lee Burnette, of Bethel, his companion, received painful but not serious injuries. Miss Baker lost three teeth and suffered cuts and bruises about the face and head. James' injuries consisted of cuts and bruises about the head and shoulders.

Thompson was on his way to Rocky Mount and James and Miss Burnette were returning to Greenville. The accident occurred on a straight stretch of highway, and an investigation by County Coroner E. S. Williams and Sheriff Whitehurst showed that Thompson was responsible for the wreck.

Both cars were almost completely demolished by the impact. Passing motorists brought Thompson to Greenville for medical aid, but he died before reaching the hospital. James and Miss Burnette were carried to Bethel for medical attention.

Thompson's home was in Washington, and the body was sent to that place for burial.

Oxygen Administered In Final Desperate Effort To Save Sec. Good's Life

Washington, Nov. 18.—(AP)—The end of a long and valiant fight for life against the inroads of general blood poisoning that followed closely upon an emergency operation for gangrenous appendicitis was imminent today for Secretary James W. Good, of the War Department.

Physicians, encouraged so long by their patient's general vitality, today virtually had given up all hope, and in a last desperate effort to prolong the stricken cabinet officer, oxygen was administered.

Meanwhile, Mrs. Good and their two sons waited in a room close by. The elder of the boys, James, Jr., arrived in Washington Saturday night from Evanston, Illinois, where he is a student at Northwestern university. So serious has been his father's condition that he has been unable to recognize his son.

President Hoover was denied a second visit to the bedside of his cabinet advisor. After returning from church, the chief executive was asked if he could see Mr. Good, but was told by the attendant physicians that in view of the patient's condition, such a visit would be inadvisable.

Mr. Hoover kept in close touch with the sick room. Any change was communicated to him at once through his secretaries, and it was not until late last night that the patient retired.

JAILER STILL ON STAND AT MARION TRIAL

Marion, Nov. 18.—(AP)—Ben Hendley, deputy sheriff and jailer of McDowell county, this morning continued his story in the trial of the five charged with insurrection and rebellion against the state, telling of threats made by a crowd of strikers in the Clinchfield mill village here on August 30.

In addition to yells of "to hell with the laws. To hell with the courts," Hendley testified that members of the crowd shouted: "We don't have any law anyway. The law is too one-sided."

The jailer was recalled to the witness stand this morning to testify against Alfred Hoffman, organizer for the United Textile Workers of America; Del Lewis, Wes Fowler and Lawrence Hogan, strikers, and J. Hugh Hall.

Hendley's testimony principally was to corroborate that of Sheriff Adkins concerning disturbances at the Clinchfield village and the East Marion village, where strikes were in progress.

Cause of the disturbances, he said, was an attempt by the sheriff and his deputies to return to a mill house the furniture of a strikebreaker that strikers are said to have moved out.

Hendley sang from the witness stand a song he said was being sung by some of the crowd as others yelled and cursed: "Old Oscar Adkins, the little fat man, the little fat man. His breath smells like a sardine can."

Textile labor disturbances here followed strikes called by the United Textile Workers of America, branch of the American Federation of Labor, in the Clinchfield and Marion Manufacturing Company mills.

The blaze was brought under control only after a fourth alarm had been sounded and a large part of the city's firefighting forces had responded.

Pola Negri Named in Three Tax Liens

Los Angeles, Nov. 18.—(AP)—Pola Negri, screen actress, has been named in three income tax liens filed in Federal court by Internal Revenue Collector Galen H. Welch.

The Government alleges Miss Negri listed too many tax deductions during the years 1924-25-26, and neglected to include some of the profits she realized as a movie star and business woman. The Treasury Department asks the additional payment of \$15,958.80 for 1924; \$13,491.74 for 1925, and \$39,319.56 for 1926.

PLAN RELIEF OF BUSINESS CONDITIONS

President Hoover to Confer With Business Heads This Week

Washington, Nov. 18.—The nation's foremost bankers, industrial leaders, labor spokesmen and farm representatives will journey to Washington this week at the call of President Hoover to assist the chief executive in devising plans for stabilizing American business and expanding its activities.

Abandoning his original scheme of one small conference to include representatives of all these fields, the chief executive has arranged a series of meetings to be held from day to day, each attended by men prominently identified with some particular phase of economic endeavor.

Tomorrow, Mr. Hoover will confer with the presidents of the great eastern railroads; on Wednesday, officials of the United States Chamber of Commerce and leaders of industry and manufacturing will be called in; on Thursday, spokesmen for the leading farm organizations will assemble with the president; and later he will meet with the leaders of American labor.

As an important result, the chief executive hopes to dissolve and banish all foolish pessimism as to business conditions, which he considers emphatically sound, to obviate any ill effects that might arise from the recent and extensive decline in security prices and to stimulate into high activity those few fields of business that fell behind during the boom and collapse of the stock market.

The president expects to accomplish this purpose by working through existing and recognized agencies, and sees no necessity for creating some "super-organization" to put its shoulders behind the project. To coordinate the plans evolved by the group conferences, general meetings such as he planned at first can be held.

Mr. Hoover looks to organizations such as the United States Chamber of Commerce, the American Federal of Labor, the American Railway Association, the American Bankers' Association and the various farm organizations to make full use of their present machinery in achieving the results he has outlined.

Because of the shortness of time, only the heads of the eastern railroads are to attend tomorrow's session. Later in the week, however, the American Railway Association is to hold its annual meeting in Chicago and the transportation executives who attend the White House conference will take to the Chicago meeting the ideas advanced for general discussion there.

Secretary Lamont and other officials of the Commerce Department will attend Wednesday's conference of industrial leaders, which is also to include representatives of the financial and public utilities fields.

AN ORDINANCE. To declare all streets within the fire limits of the Town of Greenville, N. C., a congested district, and to regulate traffic thereon.

Be and it hereby is ordained by the Board of Aldermen in regular session assembled, on the 7th day of November, 1929:

1st. That all of the streets, avenues, alleys and sidewalks within the fire limits of the Town of Greenville, N. C., are hereby declared to constitute a congested area and district.

2nd. That no person, firm or corporation, engaged in the sale of any merchandise whatsoever whether from trucks, push-carts, wagons or other vehicles, shall stop on the said streets for a longer period than five minutes from the purpose of selling or bartering said merchandise.

3rd. That no person, firm or corporation shall sell or display for the purpose of sale, any goods,

wares or merchandise, upon the sidewalks within the said congested area.

4th. That this ordinance shall be in full force and effect on and after the 18th day of November, 1929.

5th. That any person, firm or corporation violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and shall be fined \$50.00 for each and every offense. Each violation of this ordinance, or any part thereof, shall be deemed a separate offense.

Thousands Visit  
Miracle Cemetery  
In Massachusetts

Malden, Mass., Nov. 18.—(AP)—  
The famous Catholic shrines of Our  
Lady of Lourdes and Sainte Anne  
De Beaupre are recalled here with  
the ever-increasing pilgrimage of  
thousands to the 60-year-old grave  
of a young priest, Rev. Patrick J.  
Power.

Two hundred thousand were es-  
timated to have visited the Holy  
Cross cemetery yesterday. Promi-  
nent in the throng was Mayor-elect  
James M. Curley of Boston, who  
prayed for the recovery of his sick  
wife and later returned with her to  
kneel at the tomb in a drizzling  
rain at nightfall.

For years occasional cases of  
the healing of physically afflicted  
who visit the grave have been re-  
ported but no great demonstrations  
started until a few weeks ago. A  
young Boston girl was reported to  
have been healed of her affliction  
and publication of her picture in  
various newspapers is believed to  
have started this latest pilgrimage.  
On the first Sunday of the month,  
10,000 visited the grave and since  
that time the crowds have become  
larger and larger.

All day yesterday and late into  
the night two lines of visitors,  
among them blind and crippled men  
and women, invalids on stretchers,  
diseased persons both young and  
old, filed slowly by the grave. More  
reputed cures were reported. The  
behavior of the supplicants differed.  
Some placed their hands on the  
grave; others touched their lips to  
the marble slab, and some scooped  
up the earth and wiped their faces  
with rain water collecting in the  
creeper.

Notre Dame, if it continues along the unbeaten football trails, may have to share a full portion of the National Championship honors of 1929 with at least one other team, Pittsburgh, but the dramatic laurels of the season already belong to the Ramblers and Rockne.

Football has witnessed few such illustrations of inspiration, few such examples of magnificent team spirit as that manifested so far in the all-conquering march of the stalwart of Notre Dame while their guide, Knute Rockne, has been fighting a battle of his own against a badly injured leg.

Rockne has been able to direct personally only three of the seven games won thus far, but so sound is the "Rock" system, so dynamic his influence even under handicaps and so capable his corps of assistants led by Tom Lieb that Notre Dame has swept on with relentless determination. This year that "Rock" "Rock" predicted the boys would through and if they make it a clean sweep, as they seem likely to, it will be one of the greatest tributes of all time to an football coaching skill.

If "Rock", bundled in a cot on the sidelines, needed a tonic Saturday he got it in the spectacular 13-12 victory his pupils scored over the Trojans of Southern California. It was the first time since the Carnegie game three weeks previous that Rockne was able to be on the field.

## GRAIN MARKET

S. wheat visible supply total today showed by 529,000 bushels decrease, a disappointingly small amount compared with 2,394,000 bushels decrease a week ago. Late set backs in wheat prices also were ascribed to the fact that the market at today's top showed as much as 12c a bushel advance above last week's bottom level, and that this circumstance provoked a big broadening out of pressure to sell.

Wheat closed unsettled 3-4 to 11-16c per bushel under Saturday's latest figures.

Corn closed 3-8 to 7-8c off, oats, 1-8 to 3-4c down, and provisions varying from 7c setback to a rise of 12c.

## STOCK MARKET

New York, Nov. 18.—(AP)—Disregarding favorable week-end business and financial news, including the calling of a series of conferences by President Hoover to stimulate business, stock prices turned reactionary today on what appeared to be a heavy volume of profit-taking, and some short selling. Net declines of 1 to 5 points were quite general with a few larger declines and also a sprinkling of net gains.

Trading showed a reduction of about one-third in volume from last Friday's session, and a much larger reduction from the levels of earlier last week. The ticker kept fairly well abreast of the market, the longest delay reported being less than 20 minutes.

In view of the sharp advance in the two closing sessions of last week, today's setback was regarded more as a correction of a temporarily top-heavy condition, than the beginning of a fresh decline. There were no signs of any large volume of distress liquidation, although many brokers feel that the backwash of the recent drastic decline will continue for some time to come.

Credit conditions were distinctly easier. Call money renewed at 5 1-2 per cent and dropped of 5 when funds became available in the outside market as low as 4 per cent. The recent drastic decline in broker's loans has released a large volume of credit, part of which has been made available in the call market.

Several favorable dividend developments made their appearance today. Directors of the DuPont Company declared an extra dividend of 70 cents, as contrasted with an extra 50 cents in the previous quarter. Calumet and Hecla authorized a dividend of \$1.50 against the previous payment of \$1. The annual rate on International Printing Ink was raised from \$2.50 to \$3 and an initial payment was authorized on Lerner Stores.

Failure of a New York stock exchange house, the first as a result of the recent drastic break in prices, was announced just before the market closed.

Some of the fluctuations in today's market were rather erratic in character. U. S. Steel common opened fractionally lower at 153 1-2, rallied to 154 1-2 and then dropped back to 150. Allied Chemical dropped 8 points and rallied 10; A. M.

## Violent Deaths

Raleigh, N. C. Nov. 18.—(AP)—Fifty-eight persons met violent death in North Carolina during October in automobile accidents, to contribute more than one-third of the total of 163 fatalities by violence in the State during the month. In addition six others died as the result of train and automobile collisions.

The bureau of vital statistics of the State Board of Health also listed 34 homicides in its October report and seventeen deaths from burns.

Other causes of violent deaths the number from each were: drowning 16, suicides 13, railroad accidents 7, gunshot accidents 6, and gunshot cause unknown 5.
