STATE RESTS CASE IN TRIAL OF DEPUTIES

Judge Denies Motion for Dismissal of Case Against the Marion Deputy Sheriffs

Burnsville, N. C., Dec. 13.—(AP)—The state rested its case at 11:30 a. m. today in the trial of eight McDowell county deputy sheriffs charged with murder.

The state rested after introducing 26 witnesses most of whom were strikers at the Marion Manufacturing Company mill where six men were killed in a labor disturbance October 2. Most of the witnesses testified that they saw the defendants fire as the crowd of strikers ran from tear gas bombs released by the officers.

Shortly after the state had rested its case, the defense introduced a motion for dismissal of the case which was denied by Judge G. V. Cowper, presiding. He said the case should go to the jury.

Judge Cowper announced that the infant grandchild of one of the jurors, John H. Ayres, had been found dead in bed today. After consulting attorneys, the court said Ayres would be permitted to attend the child's funeral during the week-end adjournment of court.

The state ended its testimony today after introducing three witnesses during the morning session. They were L. S. Long, Spurgeon Bradley and Michael Moore, textile strikers who said they were at the mill on the morning of the disorders.

The defense immediately began presenting its testimony. The first witness called was A. L. Stockton, managing editor of the Greensboro, N. C. Daily News, who said he went to Marion on the evening following the disorders. He said he saw a number of window panes broken in the mill building.

He said there also were bullet marks on the mill building which were behind the place the officers had stood in the mill.

Long, the first state witness, said under cross-examination that he had not seen a bullet fired from the hands of the strikers.

The defense asked long if he had seen a striker standing at his side fire at Sheriff Oscar Adkins. He said he had not.

Bradley said the officers "shot un-til every man was run away. They shot as long as there was anybody to shoot at."

Under examination by defense attorneys, Bradley admitted that he had "paid no attention" to a court injunction against his picketing activities. He said:

"I was the main picket."

He said he had resigned as an officer of the law.

W. S. Jones, master mechanic at the Marion Manufacturing Company, also followed Stockton, the editor, on the stand.

Jones said he telephoned the sheriff's office on the night before the disturbance and left word that the "workers were going to strike and had threatened to shoot up the place. I told the lady who answered the telephone to tell the sheriff to come down to the mill."

Shortly after midnight he said he saw the sheriff and one of his deputies, Webb Fender, in the watchman's tower near the mill gate. Fender, with B. L. Robbins, Dave Garrett, Jim Owens, Charles Tate, Taylor Green, William Twigg and Robert Warren were on trial for second degree murder here on a charge of venue from Marion. Jones said he told the sheriff of the reported threats and of the strike situation.

Traces of unrest in the mill were reported by Jones. He said there was a tenseness in the situation in the mill as the hour for the strike, 1 a. m., approached.

"Many of the workers told me they wanted to work but they were afraid of violence. Some of them told they were afraid the mill would be blown up. I told them the officers were out in front, protecting the mill and that it would not be blown up."

Tobacco Market to Close for Holidays Next Wednesday

The Greenville tobacco market will close for the Christmas holidays at the completion of sales next Wednesday afternoon, December 18, according to decision of the tobacco Board of Trade yesterday.

Definite opening date after the holidays has not yet been decided but will be announced within a few days, according to information today.

Despite a crop shortage in this immediate territory, that has cut the total sales here this year, the market has made many new friends in the outside territory, and, according to warehousemen, tobacco from sections never before patronizing this market, has been sold on the floors of the Greenville warehouses this season.

Continue Case of Discharged Hiway Patrolman Reed

Raleigh, Dec. 13.—(AP)—The appeal case of James A. Reed of Nash county, only state highway patrolman who has been discharged since he was organized July 1, was continued yesterday afternoon until an undetermined date upon the request of Reed and Captain Charles D. Farmer, commandant of the patrol.

Reed requested a hearing before Judge N. A. Townsend, executive counsel, and R. A. Doughton, chairman of the highway commission, on the grounds that he should not have been discharged. The man was hurt in an accident July 13 and was discharged in September.

SPECIAL TERM OF COURT WILL TRY RIOTERS

Make Haste to Bring to Trial the Leaders of Auburn Prison Mutiny

Auburn, N. Y., Dec. 13.—(AP)—With state officials making haste to bring to trial surviving leaders of Auburn prison's second mutiny, search went on today for ten guns which disappeared in Wednesday's outbreak. Every effort also was being made to identify three convicts who took part in the riot and then regained their cells before being identified.

A special term of Supreme court, to convene in Cayuga county, in which this city is situated, was ordered by Governor Franklin D. Roosevelt. Dr. Raymond F. C. Koch, state commissioner of corrections, and his investigators will remain at the prison over the week end, conferring with Warden S. Jennings, and his aids and collecting evidence.

"It is time that the handful of incorrigible criminals in the state prison realize that the continuation of acts of violence against the state will be dealt with immediate and drastic severity," Governor Roosevelt declared.

Referring to the special term of court, the executive said: "I do this in justice to the family of Principal Keeper George A. Dunford, who was killed, and to the guards who were wounded, and to the other guards, who, with the state troopers and militia, acted with such conspicuous bravery in the riot."

District Attorney Benjamin A. Kenyon of Cayuga county said immediate action would be taken by his office to prosecute "every one concerned in the killing of the principal keeper." Among the men charged of prosecution are Max Clarence Schreiber in for 21 years. They were wounded in Wednesday's revolt.

Adjutant General Franklin W. Ward will represent Governor Roosevelt at the funeral tomorrow of Principal Keeper Dunford. Dr. Kieb and other officials high in the service also will attend the simple ceremonies for the man who was killed trying to rescue Warden Jennings from the hands of the group of desperadoes who held him as their hostage.

They bargained for their freedom.

U. S. Ambassador Arrives in France

Havre, France, Dec. 13.—(AP)—Walter E. Edge, new United States ambassador to France, and Mrs. Edge with their three children, arrived here today from aboard the Ile De France. They immediately took a boat train for Paris.

City and government authorities, with representatives of Premier Briand and Foreign Minister Herriot, went aboard the steamer to greet the former New Jersey Senator who succeeds the late Myron T. Herrick at the American embassy.

The Edge cabin filled rapidly with flowers. A small company of infantry saluted him as he walked down the gang-plank. He stood at attention while a band played the Star Spangled Banner.

The new ambassador gave French newspapers a prepared statement which read:

"I am delighted to reach your country. It is with genuine enthusiasm that I will undertake the responsibility entrusted to me by President Hoover of maintaining and perpetuating the deep friendship that has existed always between France and the United States. I clearly recognize the difficulties of following my old friend Mr. Herriot, whose labors and memory we all revere. Our problems however, are never so difficult that clear understandings cannot be evolved. I know I will have the generous co-operation of you all."

ESCAPED PRISONER IS STILL AT LARGE TODAY

Raleigh, Dec. 13.—(AP)—Granville A. Deitz, who escaped from Caledonia prison farm early yesterday, was still at large today, so far as officials at Central prison here knew.

Deitz was serving a 25 to 30-year sentence for second degree murder after having been convicted of killing Policeman J. C. Kelley of Southern Pines last March. Deitz, after the killing, got away and was caught six weeks later in Bangor, Maine.

Revive Ducking Stool

Scientist Announces The Successful Isolation Of Germ That Causes the Flu

Chicago, Dec. 13.—(AP)—A 30-year-old scientist, Dr. Isadore S. Falk of the University of Chicago, has announced the successful isolation of the germ that causes influenza.

Dr. Faulk, professor of Hygiene and Bacteriology, began his search for the influenza germ a year ago yesterday, and succeeded in isolating it September 30. During the course of the experiments, it was learned, the 13 co-workers, as well as Dr. Falk himself, were victims of the disease they sought to conquer.

With the announcement of isolation of the germ, hope was expressed that vaccine or anti-toxin might be developed that would bring influenza and certain types of common colds and bronchitis under control.

The influenza germ, Dr. Falk said, is of the pleomorphic streptococcus type, resembling a string of pearls not well matched, such as "might have been strung by a child." The germs colonized in clumps are the more virulent, Dr. Falk said. The smooth ones, he believes, produce common colds of the sore throat type.

Some of the germs he designates as "smooth" are to be found in showed. Samples of the blood and throat culture of one of his assistants, Miss Ruth A. Kinney, were used at the start of the experiments. These revealed many varieties of germs. After continued investigation suspicion centered upon one, and experiments were conducted with it, convincing Dr. Falk that this was the germ responsible for the disease.

The germ, Dr. Falk said, will not prove fatal in itself, but the disease for which it is responsible weakens the patient in many cases so that he falls victim to other, deadlier, germs. With the isolated germ Dr. Falk and his associates conducted experiments on small animals, producing in them a disease similar to the influenza that attacks human beings.

Dr. Falk was careful to point against too great hope from the discovery. "In research for specific for some diseases, isolation of the germ is 75 per cent of the battle," he said. "It remains to be seen whether that is true in this fight. Experiments in quest of such a specific are now being carried on."

LION'S CLUB HOLDS MEET First Regular Meeting Since Organization Was Held Here Last Evening

The first regular meeting of the Lion's Club since its organization meeting last week, was held at the Woman's Club building at 6:30 p. m. last evening. While the meeting was brief the program was filled with inspiring talks with Lily Ormsby, of Chicago, as the principal speaker. Other visiting Lions on the program included Robert Raspberry and Thomas M. Woburn, of Kinston. Following the addresses by the visitors there were several brief talks by the members of the newly formed club. The meeting was presided over by the club president, S. T. Carson.

Negroes Draw Ten Years for Wrecking Train

Watson and Linn Carter, negroes charged with malicious destruction of railroad property, were sentenced by Judge R. A. Nunn in Wake Superior court today to serve 10 years each in state's prison.

The men were found guilty of having caused the wreck of a carnival train near Raleigh the morning of November 11.

Then men had confessed their guilt, according to witnesses at the trial, but the defendants repudiated the confessions. It was testified the negroes said they planned to wreck a Southern passenger train to rob the mail coach but the passenger train was late and the carnival train preceded it and was wrecked.

North Carolina To Pay Off Bonded Debt by 1966

Raleigh, Dec. 13.—(AP)—With the third largest gross bonded debt in the United States, the State of North Carolina will have taken up all of her present outstanding bonds by 1966, provided the state is able to meet her obligations as the bonds mature and provided the state's debt is not increased to any great extent in the interim.

The Raleigh Times, in a story based on figures compiled for it by W. F. Moody, deputy state treasurer, and O. M. Jones, senior accounting clerk in the office of the state treasurer, says that bonds now outstanding against the State of North Carolina total \$165,340,000, and that this indebtedness is only exceeded by the states of New York and Illinois.

If bonds authorized, but not yet issued, were added to the authorized and issued bonds, the state debt would reach a total of \$182,297,000. The bonds authorized but not issued total \$16,957,000.

The huge debt of the state was brought about in the main by the issuance within the past ten years of \$111,000,000 in highway bonds—money which was used to build in this state one of the finest networks of good roads to be found in any state in the Union. The last General Assembly authorized the issuance of \$4,000,000 in highway serial bonds, to mature from 1942

to 1948, but this issue has not as yet been issued. With the exception of \$45,000,000 of the bonds, the state sinking fund will retire \$65,000,000 of the highway bonds along with bonds authorized for other state purposes. Mr. Moody said. The \$45,000,000 in bonds that have no sinking fund provision will be retired as they mature from funds collected by the Highway Commission.

State sinking funds on December 1, last, amounted to \$7,690,947.02, but this fund will be decreased on January 2, when the state meets a payment of \$1,350,000 on bonds maturing at that date. In July, 1930 there will be \$2,098,000 more bonds that will mature.

FRIDAY 13TH IS LUCKY DAY FOR CONVICTS

The Governor Orders Month's Credit for Each Year of Good Behavior

Raleigh, Dec. 13.—(AP)—Friday the thirteenth—traditional, an unlucky day as the superstitious say—today was a lucky day for all convicts in North Carolina state's prisons who have for the last twelve months or longer been of good behavior.

Gov. O. Max Gardner, in an executive order issued today, granted an additional credit of 30 days for each 12 continuous months good behavior which any prisoner may have served on may in the future serve.

The order, which Governor Gardner said will be effective each December while he is in office, was "not a Christmas gift," the Governor said, but only continued his policy of recognizing those convicts who observe the rules and regulations of the prison.

The order said "That any prisoner in the state's prison who has for the period of the past 12 months or longer been of good behavior, who has worked diligently and has respected the rules and regulations of the institution, be given an additional credit of 30 days for each 12 continuous months good behavior which he may have served or may in the future serve."

The addition of 30 days credit on the sentences of prisoners will make "A" or honor grade prisoners who work on Sunday get 183 days taken off of each year of their sentences. Honor grade men get 164 days off for good behavior, 52 days off for Sunday work and the added 30 days. The total annual credit to "B" grade prisoners will be 160 days. The added 30 days will not be allowed "C" grade prisoners. The governor said.

Former President Mexico Sought in Murder Conspiracy

Laredo, Texas, Dec. 13.—(AP)—Sheriff A. C. Condon of Webb county, today held a warrant for the arrest of Plutarco Elias Calles, former president of Mexico, charged here with conspiracy in the murder of General Lucio Blanco and Colonel Aurelio Martinez seven years ago.

Liners Reach Port After Battling Heavy Storms

New York, Dec. 13.—(AP)—After crossings which their skippers said were the worst in their long experience, the French liner France and the two Cunard liners Derwentaria were in port today two days late.

Both ships ran into the storm a few hours after leaving the coast of France and battled it for several days. A blinding snow storm, accompanied by a wind that reached 100 miles an hour, caused seas estimated at fully fifty feet high.

The Derwentaria had eight windows smashed on the upper promenade deck (two ventilators carried away) and a steel bulkhead sixty feet above the water line bent. Upon her arrival at repair a crew of 100 men was put to work to place the ship in condition for sailing at midnight.

MOTHER AND SON SHOT TO DEATH TODAY

Charleston, W. V., Dec. 13.—(AP)—Mrs. John Gann and her son, Richard Gann, 65, were shot and killed at their home here early today. Police said the woman's husband, John Gann, had been arrested at Newport, Ky., as a slayer. According to the police, the Ganns were estranged and Gann had threatened the life of his wife and their two children.

NO REPORT YET ON PERCY MILLER CASE

Raleigh, Dec. 13.—(AP)—Judge N. A. Townsend, executive counsel, had not early this afternoon made his report to Governor O. Max Gardner in the Percy Miller case. Miller is under sentence of electrocution and has twice been reprieved. Judge Townsend will make recommendations in the case before he gives over his office to Odus Mull effective Sunday.

Two Raleigh Men Get Four Months In Liquor Cases

Rocky Mount, Dec. 13.—(AP)—L. W. Hamilton and George Brannon, of Raleigh, were sentenced to four months on the roads and the automobiles they were driving were ordered confiscated in police court here today after they were convicted of hauling 25 gallons of whiskey, alleged to have come from the Bear Grass section of the state near Williamston.

The men were detected by police detectives Zimmerman and Henry and caught after a 12 mile race. Unable to make a sharp curve near Elm City on highway 40 the Raleigh men were forced to drive their car into the woods and were captured by officers before they could escape.

Doheny Trial On Bribery Charge Set for March 10

Washington, Dec. 13.—(AP)—The date for the trial of Edward L. Doheny, oil magnate on a charge of bribery was set for March 10 today by Justice Hitz in the District of Columbia Supreme court.

Doheny's attorney, Frank Hegan, had asked that the trial begin on March 17 and government attorneys requested January 13 as the date.

The indictment against the wealthy oil man is one of the series growing out of oil leases made during the Harding administration and the charges is that Doheny accepted a bribe of \$100,000, in connection with the lease of Doheny's company of the Elk Hills naval oil reserve in California.

Fall was recently convicted on the charge of receiving the \$100,000 from Doheny and was fined \$100,000 and given a suspended sentence of a year in jail.

Washington, Dec. 13.—(AP)—Assurance was given in the Senate today by Senator Watson, of Indiana, the Republican leader, that he would favor consideration of legislation for disposition of the gigantic Muscle Shoals, Ala., power plant after the Senate finishes the tariff bill.

Watson made this statement on the floor to Senator Black, Democrat, Alabama, who previously had blocked consideration of the tax reduction resolution until he had an agreement for a place on the calendar of the Muscle Shoals legislation.

Senator Norris, Republican, Nebraska, the author of the government ownership Muscle Shoals resolution, now on the calendar, announced he would move to take up his measure as soon as the Senate concluded with the tariff.

Major Stedman Not to Be Candidate For Re-Election

# AL SMITH GETS BIG HAND AT WASHINGTON

Former New York Governor Seeking Mooring Mast Atop 85-Story Bank

Washington, Dec. 13.—(AP)—Al Smith's return to the political campaign last year, former Governor Alfred E. Smith of New York, arrived at the Navy Department this morning to discuss with Secretary Adams the feasibility of placing a dirigible mooring mast on the 85-story building which his company is constructing in New York City.

Virtually the entire personnel of the Navy Department lined the corridors of the huge building and gave the former Democratic presidential candidate a tremendous ovation.

With shouts and cheers ringing in his ears, "Al" smiling as usual, and accompanied by several guards, he had to fight his way up the steps to the secretary's office.

He found the experience gained by pushing through mobs of people from the Atlantic seaboard to the Rockies today was much to his advantage.

Hundreds, mostly women, crowded about him endeavoring to shake his hand.

The shout of "Hello, Al," once given by thousands in the campaign days, against was heard.

"Al" like New York City's affable Mayor Jimmy Walker, usually does, arrived late.

The crowd, however, waited in a circle outside and was there to give a welcome.

He reached the department on his taxi driver made a mistake and had put him out at the State Department, several blocks distant from the Navy building.

After his conference with the secretary, at which Assistant Secretaries Jahnicke and Ingalls and Rear Admiral Moffett in charge of Navy aeronautics, were present, the former governor said Mr. Adams had indicated a desire to help and had turned technical consideration of the proposal over to Admiral Moffett for study.

# BEGIN HEARING ON TAX BILL IN SENATE TODAY

Plan for One Percent Cut in Income Tax of Corporations Draws Fire

Washington, Dec. 13.—(AP)—The administration's proposal for a one cent cut in the corporation income tax rate drew fire in the Senate today but both Republican and Democratic leaders rallied to its defense as the Senate set down to consideration of the House resolution to carry out the program for a \$160,000,000 reduction in individual and corporation income taxes.

The Republican Independents, led by Senators Norris, Nebraska, and Borah, Idaho, assailed the proposed cut in the corporation levy on this year's income, contending the corporations already had passed their tax on to the consumers and

the tax cut would amount merely to a bonus.

Norris argued it would be better for the county, anyway, to apply the \$160,000,000 treasury surplus to the reduction of the war debt.

Chairman Street of the Finance Committee rused to its support and Senator Simmons, North Carolina, and Copeland, New York, both Democrats, joined him.

Simmons said it was his understanding the tax resolution was proposed in the thought that "if the surplus was returned to the taxpayers it would tend largely to remove a psychological situation that threatened serious consequences." He argued that this purpose would be defeated if the proposed cut nor the corporations was eliminated.

Norris had insisted that the tax resolution was proposed to relieve those who have suffered in the recent collapse of the stock market.

The Destroyers Grain Elevator Minneapolis, Dec. 13.—(AP)—Fire following an explosion in a large grain elevator destroyed approximately 300,000 bushels of wheat owned by the Sterling Grain company last night. Nearly all of the city's fire apparatus was called to prevent spread of the flames to adjoining grain bins.

The loss total \$500,000, firemen estimated.

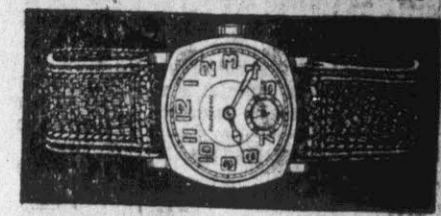

Grover Cleveland Alexander, Cardinal hero of the 1928 world series, did return to the scene of his earliest major league conquest—Philadelphia—in a deal more sentimental than important. Harry McCurdy, former university of Illinois star, also became a Philly with Old Alex the Great, and young Homer Peel became a Cardinal again in the same transaction. The only other swap returned Wally Schang to the Athletics in exchange for Sammy Hale, who became a Brownie.

The joint meeting at the Biltmore yesterday saw the chain-store system of baseball ownership discussed at length. Sam Breadon, the most extensive dealer in live and dressed "Ivory," produced telegrams from presidents of a wide range of minor leagues endorsing major league ownership of the smaller clubs. ## DISCUSS NEW GRID RULES

By EDDIE BRIEFZ (Associated Press Sports Writer)  
Baton Rouge, La., Dec. 13.—(AP)—There will be no fight over the old question of splitting the Southern Conference at the current annual meeting which gets down to business here today, but there are likely to be a couple of warm skirmishes over two proposals Dr. S. V. Sanford, president of the conference, intends to lay before the conference tonight.

First, Dr. Sanford will recommend that the conference adopt a uniform opening and closing date for the football season.

Second, he will ask the conference to agree on an eligibility rule that will render any student with more than one scholastic condition ineligible for athletic participation.

Old heads among the representatives of the 23 institutions present do not think a suggestion to split the conference into a northern and southern division will be officially presented and they predict that if

it is it will meet with the usual speedy and violent death.

In recommending that the conference adopt a uniform opening and closing date for the football season, Dr. Sanford thinks that the south should follow the lead of the Western and Pacific coast conferences which have already "taken that progressive step." Dr. Sanford suggests the Saturday before Thanksgiving merely as a basis to work on. Supporters of the movement, he says, would be quite willing to accept a compromise date, probably Thanksgiving day or the Saturday after the holiday.

Incorporated in this recommendation will be a clause to have each conference team play at least six of its eight games inside the conference.

Considerable opposition is looked for on the proposal for a uniform eligibility rule, some athletic officials taking the stand that the college prefer to administer their own affairs along academic lines.

At present each institution defines its own eligibility rules. Some permit athletes with two conditions to participate. Others have placed a ban on those with more than one.

The conference executive committee met this morning, with the first business session scheduled for this afternoon. It is planned to adjourn at noon Saturday.

The coaches held forth at Riverside Lodge, 12 miles from here, in their annual pow-wow last night.

Besides election of new officers they named the coaches for the all-

star teams from the northern and southern divisions of the conference which play a charity game at Atlanta on New Year's day.

Major Bob Neyland of Tennessee, will direct the northern team, with Major Charles Bachman of Florida in charge of the southern eleven. Bachman was unopposed, but Harry Gammag, youthful Kentucky mentor, was in the running for the job of coaching the northern team until he withdrew in favor of Major Neyland.

Dan McGugin, veteran director of the Vanderbilt Commodores, was succeeded to the presidency by William Rafferty, head coach at V. M. I. Walter Johnson of Presbyterian College, Clinton, S. C., is the new vice-president and John (Red) Floyd, head coach at Auburn, secretary and treasurer.

## STOCK MARKET

New York, Dec. 13.—(AP)—Friday the 13th provided plenty of thrills for both "bull" and "bear" traders on the New York Stock Exchange today as prices swung up and down in erratic fashion. In some quarters the increase in brokers' loans was construed as the return of a weak speculative.

"Bear" traders, who sold stocks heavily in the last hour of trading yesterday, and resumed their selling in some of the specialties at the opening, went to cover by the appearance of strong buying support soon after the opening with the result that a long line of issues were carried up several points.
