## CREAM ROUTE IS OPENED IN PITT COUNTY

### Over Two Hundred Pounds of Butterfat Collected On First Trip Yesterday

Pitt county's first creamery route became an actuality yesterday when a truck representing the Farmers' Creamery of Lenoir, N. C., passed over the Fountain, Farmville and Greenville route yesterday afternoon. The first day's receipts were given at 210 pounds of butterfat, which netted the producers something like \$80.00.

The truck made a stop in Greenville last night and continued along the route to Bethel today, and from there to the creamery plant at Lenoir.

While the first offerings were not as large as County Agent E. F. Arnold expected they would be, he said it was a good start and that he hoped to be able to build up the production to at least five hundred pounds of butterfat during the next two or three months. Numbers of farmers who had signed their intention of placing their offerings on the route yesterday failed to do so, but Mr. Arnold said they would do so later on and in that way greatly increase the output.

The truck made six stops to pick up butterfat yesterday, and other stops were to be made between Greenville and Bethel today. The truck will make one trip each week, passing along the Fountain, Farmville route during Friday, and continuing toward Bethel after spending the night in Greenville.

Mr. Arnold said he thought the outlook was very bright for development of the creamery route in this county, and urged farmers to get busy and help build up the industry. It is a direct source of increasing annual revenue, he said, and will greatly relieve the period of depression occurring during the summer months.

Persons interested in taking advantage of the opportunities offered through establishment of the creamery route are urged to get in touch with Mr. Arnold at the office of the farm department on the court house square. He said he would be glad to furnish all information in this connection and cooperate in every way to build up the industry.

## No Evidence of Foul Play Found In Woman's Death

Jan. 4.—(AP)—No traces of foul play were found about the body of Mrs. Evander Ward, which was disinterred for the second time yesterday and examined by three physicians.

Mrs. Ward died under mysterious circumstances December 4. A suicide verdict was first returned, but later the body was exhumed and examined and Ward was arrested and held for a grand jury investigation January 20.

Ward's story of his wife's death is that he found smoke pouring from his house and the doors latched from within when he returned home from an errand. He broke into the house to find it filled with smoke. He said he seized an object lying on the floor and dragged it into the open to discover it was his wife's body wrapped in a large mattress.

## Negro Woman and Four Daughters Burned to Death

Birmingham, Ala., Jan. 4.—(AP)—A negro woman and her four sons died to death in a fire which destroyed their home here early today.

Bessie, Annie, Jane and Emma Marshall and their mother, James Marshall and his three brothers awakened in time to escape.

## Class Work Again Resumed at College

Class work began today at East Carolina Teachers College. Enrollment is not yet complete but the number will probably run around 900. Fourteen graduated at the close of the fall term and 27 of those on the waiting list were accepted for the winter term.

## SEVEN KILLED AS TRAIN HITS BUS IN OHIO

### Members of the High School Basketball Team Are Crushed to Death in Storm

Wadsworth, Ohio, Jan. 4.—(AP)—Helpless victims of a speeding train which cut through the night and a blinding sleet storm to crush their bus while they laughed and talked their basketball games, seven youths were dead and eight other high school boys and girls were in hospitals today.

The dead boys, all of them between 14 and 18 years of age, were members of the high school basketball team of Burbank, near here. They were on their way home, happy over defeating their old rivals at Big Prairie, another nearby village, when a Pennsylvania Railroad train struck their bus at a crossing near Shreve, ten miles south of here last night.

The dead are: Wilbur and Forest Grubb, brothers, Claude Repp and Emil Tlinic, Wayne Lehman, Eugene Talley, Willard Baker.

The most seriously injured were: Edith Repp, who suffered fractures of both legs and may die; and Lola Talley, sister of the dead boy, who received a broken leg. The others injured, most of whom suffered nothing more serious than cuts and bruises, are: Alice West, Ellen Cowlick, Grace Ficy, Maurice Lenz, Joseph Eaker, 50, driver of the bus.

The crumpled bus was carried down the track 100 feet and bodies were strewn four times that distance as the banner and gaiety of the youngsters was changed to shrieks and the smashing of steel and the splintering of wood. Ambulances were called from Wooster and raced perilously over the ice-covered highway to take the injured to Wooster's two hospitals.

## PRES. HOOVER ENCOURAGED OVER FUTURE

### Effort to Improve American Industry Boosted by \$4,700,000 Budget

Washington, Jan. 4.—(AP)—President Hoover contemplated today—and found encouraging—the results of his drive to boost construction and improvement work in an effort to absorb unemployment.

Three major lines of American business were submitted a budget of \$4,700,000 for 1930. This, with many items still to be added, gave promise that the total to be expended during the year would be larger than that for 1929.

The largest amount was that of public utilities and telephone companies, but the total of public works continued to grow with 19 states untouched in the survey and 13 others only partially covered. Sixteen states were complete.

The public utility and telephone groups fixed their estimate at \$2,100,000,000; public works, including those of the Federal government, reached \$1,550,000,000 and railroads reached a total of \$1,050,000,000.

Surveys for the states move toward the white house daily and the president said he expected they would be completed by the middle of this month.

In addition to these, Mr. Hoover pointed out that this total did not include industrial and factory improvements or building construction.

## Royalty Injured By Explosion of Balloons at Party

Rome, Jan. 4.—(AP)—Several members of the Italian nobility were burned slightly this morning when a patent lighter exploded toy balloons which were part of the decorations at a party given by the Princess Jane Di San Faustino.

Those injured were the Princess Marina Ruspini, daughter of Count Volpi, former minister of finance, the Prince and Princess Del Drago, the Baroness Elena Campagna, Lieutenant Cottafavi and a waiter.

The explosion occurred at the Ambassador's Hotel in the course of a brilliant dance heralding the forthcoming week of royal wedding festivities.

The woman suffered greatest injuries when the burning rubber fell on their bare necks and arms.

## Heflin Threatens to Carry Fight to Polls in Alabama

Birmingham, Ala., Jan. 4.—(AP)—Removal before February 1 of the restriction excluding as candidates for the 1930 party primary those who opposed the Democratic presidential nominee in 1928 has been asked of the Alabama Democratic executive committee.

Attending a mass meeting last night at which the request was made, Senator Thomas Heflin said: "If this is not done the voters will be given their chance to act."

A resolution calling upon the committee to rescind its action, drafted and read by Ben F. Ray, a member of the committee, who protested the ruling, was adopted. Several thousand persons were present. "I am not seeking to organize an independent party," Heflin declared. "I am asking the committee as a Democrat to meet and rescind its action and if it does not we will have a chance to fight it out at the polls."

Hugh A. Locke, who has announced for governor, expressed views similar to those voiced by Heflin. Both Locke and Heflin spoke in 1928 for President Hoover.

## AUTOMOBILE SHOW OPENS AT NEW YORK

### Three Hundred Latest Creations of the Automotive World On Display

New York, Jan. 4.—(AP)—The thirtieth annual national automobile show opens today in Grand Central Palace with 300 of the latest creations of the automotive world displayed by 46 American and two foreign manufacturers.

Each of the four floors of the palace has a color scheme of its own in the decoration plan for the show. The first floor is in Cardinal red, the second in golden brown, the third in mignonette and the fourth in tropical blue.

The trend toward eight-cylinder motors in emphasis in this year's exhibition in which approximately half of the cars on display have power plants of about a dozen-horsepower as compared with a dozen last year. A 16-cylinder model is exhibited by Cadillac and the front-wheel drive cars built by the Cord and Ruxton companies are being shown.

Other features outstanding are a silent transmission, eliminating the growling noise of second speed, and a general tendency to make bodies still lower, to carry stream-line effects farther, to blend three hues in body colors and to employ the classic lines of ancient pottery in headlights and hubcaps.

Two taxicab companies have models on the floor and 185 accessory and ship equipment companies are represented. The foreign cars on display are Mercedes-Benz and Voisin.

The show will be closed tomorrow and reopened Monday to continue throughout the week.

Several manufacturers are holding private exhibits in hotels and a number of trade dinners and other functions will be held during the show.

Opening of the exhibit will be broadcast through WEAF and associated radio stations at 5 P. M. Eastern Standard time, today.

## Noted Cartoonist Dead at New York

New York, Jan. 4.—(AP)—Clare Briggs, who caused many a chuckle by his newspaper cartoons depicting the human side of American life, died last night at the medical center of pneumonia. He was 54 years old.

He had been ill for the last month with bronchial pneumonia but until a few days ago he seemed on the road to recovery. Yesterday he took a sudden turn to the worse and died before members of his family could reach his bedside.

Some of his most widely known cartoon features were, "When a Fellow Needs a Friend," "Ain't it a grand and glorious feeling," "The Days of Real Sport" and "Mr. and Mrs.". He started his newspaper career in 1896 as a cartoonist on the St. Louis Democrat at \$10 a week. At the time of his death he was on the staff of the New York Herald Tribune and his work was syndicated throughout the country.

## COUNTRY CLUB WRECKED BY FIRE AT SPARTANBURG

Spartanburg, S. C., Jan. 4.—(AP)—The one-time handsome Spartanburg Country club, valued at \$35,000, today was a pile of ashes and charcoal. Flames, fanned by a heavy wind, yesterday destroyed the structure in less than an hour. The loss practically was covered by insurance.

## LEAF SALES WILL RE-OPEN NEXT TUESDAY

### Sales Will Probably Suspend for the Season on the 21st Day of January

The Greenville tobacco market will re-open Tuesday, January 7th, Cobb, supervisor of sales. The market has been closed since about the middle of December in observance of the holiday season, and when sales get under way Tuesday morning every man will be found at his post of duty ready to receive the remainder of the premier crop of this section of the state.

It was stated that the market in all probability would close for the season on January 21st, although this fact had not been definitely established today. This will leave slightly over two weeks for the farmers to dispose of the remainder of their crop, and warehousemen today urged that planters get busy and market their offerings as rapidly as possible.

Three sets of buyers will be on the floors of the warehouse when sales get under way Tuesday morning, and all of the buying companies will have a full representation of buyers ready to purchase the last of the offerings of this locality.

The market closed for the holidays following completion of sales on December 18th, and since that time the several hundred men employed in the industry here have been confining their attention to celebration of the holiday season.

Many of the tobaccoists spent the holidays at homes in other sections of the country, but they will be on the floors of the various warehouses when the shrill voices of the auctioneers get sales under way next week.

First sales will be at the Star, Forbes & Morton and Joyner's at 9:30.

## American Cotton Bales Not Neat, English Declare

Washington, Jan. 4.—(AP)—From Manchester, England, today came complaint that American agricultural cotton is not neat as to its cotton.

H. Robinson, secretary of the Canechester Cotton Association, Ltd., set forth the counts of uncleanliness in a letter to the United States Department of Agriculture.

In used in marking the bales runs into the cotton, said Robinson. The cotton is in a hazardous manner, and has not shown improvement in spite of agitation for a neater package.

"The neatly packed bales received from every other cotton growing country are in striking contrast to the American bale," he said.

The Department of Agriculture answered that it is making studies in this field, and believes that an improvement in the American bale may be hoped for in the future.

## Mount Vernon Railway to Be Abandoned Soon

Alexandria, Va., Jan. 4.—(AP)—After 37 years of service in carrying pilgrims to the national shrine of George Washington at Mount Vernon, the little electric railway between this city and the peaceful estate beside the Potomac is to be abandoned.

Abandonment has been made necessary, not because fewer pilgrims visit Mount Vernon, but in order that more may go there.

Part of the line's roadbed is to be used by the government for the \$4,500,000 George Washington Memorial boulevard between the National capital and the home of its first president. The road is to be opened for the 200th anniversary of the birth of Washington in 1932.

Millions of persons have traveled on the cars of the little electric line and gleaned from accompanying guides intimate details of the life of George Washington as they passed over the ground he trod in earlier years.

On this line, too, many pilgrims, especially those from northern and western states, have made their first acquaintance with the "Jim Crow" laws of southern states, as the Virginia statute requiring segregation of negro passengers; always has been rigidly observed.

Negotiations for sale of the roadbed right of way to the government have been going on some time. After permission for abandonment is obtained from the Virginia public service commission, the rails will be scrapped. The line was purchased at auction some years ago for \$750,000 and in recent times have been operated at a loss.

## U. S. Capitol Damaged By Spectacular Blaze; Loss Given At \$3,000

Washington, Jan. 4.—(AP)—The tongues of red flame that leaped through the roof of the southwest wing of the capitol last night and licked at the side of the high white dome had left today only a small blackened spot on the side of the building.

The vividness of the flare; the shrieking sirens of fire apparatus; first thought that century old records, possibly the nearly nation-old structure itself, might be endangered, had faded this morning and fast were becoming a part of the bulging history of Capitol Hill.

Officials were more concerned over the cause of the blaze than the damage wrought. They said the loss would amount to about \$3,000; that the fire in no way interfered with the convening of Congress Monday night on the holiday recess; and that such documents and papers as were charred or water-soaked were not a part of the permanent files.

The blaze, far more spectacular than that which destroyed part of the executive office of the White House Christmas eve, originated in a room occupied by Carl Moberly, an artist who has decorated many of the long corridors in both the Senate and House wings.

Moberly was rescued from the room in a partly suffocated condition. He was administered first aid in the office of Representative John Garner of Texas, the House Democratic leader, and later taken to a hospital.

Today he practically had recovered and from him capitol officials hope to obtain some light on the cause of the fire. Several capitol employes suggested the possibility that a cigarette or a cigar started the blaze.

David S. Lynn, the capitol architect, and Joseph G. Rodgers, the House sergeant at arms, reiterated this morning that they proposed to investigate carefully into the cause. Both were at the capitol last night before the flames were extinguished and obtained all information there available.

The fire was discovered at 7 p. m. Capitol police turned in the alarm. They sounded a five call notice that brought every engine in the business and near-in residential districts.

Firemen on apparatus which had to travel over Pennsylvania Avenue were spurred forward by the sight of the flames, leaping and glowing brightly above the hundreds of electric lights that illuminate the building.

Reaching the capitol a multitude of difficulties delayed the firemen. Most of the doors were locked. Some companies threw ladders against the structure to fight inward while others smashed the thick plate glass in the revolving door opening from the rotunda to the east plaza—the entrance through which thousands of tourists pass annually.

A fireman strove to reach the flames thousands of Washingtonians swarmed to Capitol Hill. Many of the city had missed the White House fire and last night as word spread over the city that the capitol was burning men, women and children hastened to the scene.

Police reserves were rushed to "The Hill," as the site of the capitol is known in Washington, to assist the hastily mobilized capitol police force in holding back the crowd that surged over the broad east plaza.

So quickly did the crowd assemble, that hundreds were on hand before the last of the fire companies arrived and there were narrow escapes in several instances as the fire trucks reared into position.

On the west side still another crowd gathered on the sloping hill. Those who raced to this position had the best view of the flames piercing toward the sky.

Of the thousands obtaining information about the fire over telephone was President Hoover. It was only a week ago that he stood on the west balcony of the White House dressed in evening clothes and watched the fire in the executive offices. Last night he instructed White House aides to obtain all information and they immediately had a White House phone connected with the office of Representative Garner.

After firemen had smashed the east rotunda door, they carried hose lines through the rotunda—the walls of which are decorated with many valuable oil paintings of events of early American history, among them the landing of Columbus and the surrender of Cornwallis—to reach the narrow, winding stairway to the fourth floor.

Other lines of hose were carried up the stairway opening just to the north of Statuary hall, once the chamber of the House of Representatives. Later it was ascertained that no damage from water or smoke had resulted in either the hall or the rotunda, and within a short time after the blaze was out, charwomen had swabbed up the water pools on the floor.

The artist's room opened off a document room used to store principally bills, resolutions and committee reports. Some damage to these resulted but practically all were copies. More valuable records nearby were not marred.

In Moberly's room, the artist had a plaster model of the capitol building. It was a duplicate. The original model is in Spain, having been sent there for the Seville Exposition. Water and a fallen beam damaged the duplicate while other debris damaged to some extent models of several other public buildings. Some portraits of justices of federal courts likewise suffered from the water and smoke.

Firemen had the blaze under control in slightly more than 10 minutes after they put their first hose in action, but considerable time had been lost in reaching the fire because of the winding stairway—just across the building from that used by tourists who climb to the top of the dome. The inconspicuous entrance to the first group of firemen could not locate the door.

The fire was out within 45 minutes from the first alarm.

## NEWS BRIEFS FROM THE TWO CAROLINAS

New Bern.—Using grappling hooks searchers located the body of Allen Smith, who was drowned in the Neuse river while fleeing from a blocking charge.

Monroe.—J. E. Henderson, 74, mill executive and community leader, is dead from a heart attack.

Columbia, S. C.—F. H. Daniel, president of the Credit Bank and the Federal Land Bank here, says that loans totalling \$6,000,000 were made to farmers in the Carolinas and Georgia last year.

Murphy, N. C.—Dr. Richard Mcronney, Murphy physician, whose automobile struck and killed Miss Ruth Mallonee, is awaiting trial in Cherokee county court.

Salisbury.—Rev. Milton Whitener, financial agent of Catawba college, was taken to a hospital after an automobile collision here. He is not seriously injured.

Spartanburg, S. C.—The new Fair Forest Finishing plant here, erected at a cost of \$1,000,000, will begin operations January 15.

Ashboro, N. C.—Thomas Millikan, who disappeared after leaving a note in his car saying he would never be seen again, walked into his home a day later, but declined to explain his actions.

## GOV. GARDNER TAKES STEPS TO HELP POOR

### Formulates Plan for Each County to Aid in State's Charitable Activity

Raleigh, Jan. 4.—(AP)—Gov. O. Max Gardner, taking cognizance of the reported increases of distress of persons in many sections of North Carolina, has had plans formulated for the formation in each county in the state of a committee to enlarge and aid the state's charitable and welfare agencies in caring for the needy families.

The plan was announced following a conference with the governor yesterday at which were present: Mrs. Kate Burr Johnson, commissioner of public welfare; Dr. E. O'H. Laughlinhouse, state health officer; Mrs. Thomas O'Brien, of the State Federation of Women's clubs; Mrs. Jane S. McKimmon, State Home Demonstration agent; and Mrs. Raymond Binford, of the State Parent-Teachers.

It was decided, a statement from the governor's office said, for the governor to immediately appoint some outstanding citizen in each county of the state to head a "county relief committee," composed of the local welfare officer, the president of the Woman's club, the local farm demonstration agent, the county health officer and heads of other welfare and charitable organizations.

The purpose of the county committees will be "to coordinate the relief work of existing organizations and provide such material assistance in individual cases as may be found necessary."

A report on conditions in 85 of the 100 counties of the state, Mrs. Johnson said, showed "while no grave emergency exists, conditions are nevertheless worse than usual in many localities and concerted action is necessary to prevent actual suffering before the coming of warm weather."

## Durham Minister Shot By Negro; Injuries Serious

Durham, Jan. 4.—(AP)—The Rev. E. Frank Lee, prominent minister, fired upon at his home here by an unknown negro, sustained wounds that doctors early today feared might prove fatal.

The Rev. Mr. Lee encountered the negro in his back yard last night when he went to an out-house to get a scuttle of coal. He called to the negro, who then fired at him. The bullet struck the minister in the abdomen. As the intruder fled, he fired a second shot, this bullet striking Mr. Lee in a less dangerous part of the body.

Mr. Lee managed to walk back to the house with the bucket of coal but collapsed as he sat down in a chair. And was summoned by members of the family.

Officers at once started search for the assailant, but first efforts to track him proved unsuccessful. Bloodhounds were sent for to aid in the search.

Mr. Lee, who was pastor of the Calvary Methodist church of this city, came here in December from Fayetteville where he served several years. Previously he had been located at Kinston.

Before joining the Methodist church, Mr. Lee was pastor of the Buffalo Presbyterian church, near Greensboro.

## Files Suit for Estate Control

Greensboro, Jan. 4.—(AP)—E. C. Exum of Stantonsburg filed suit in Wayne county Superior court today to regain control of his estate, estimated to be worth \$105,000.

Exum charges that, although he has been declared competent by the courts, he is unable to regain his estate. He was ruled incompetent in March, 1926 and his wife, Mrs. Sarah E. Exum, was named as his guardian.

Since then, Exum alleges, Mrs. Exum has failed to make an inventory of the estate and has sold several tracts of land without revealing to him the terms of the sales.

Mrs. Exum and several individuals and corporations who have had dealings with the estate since the incompetency proceedings, are defendants.

## PICK POCKET RETURNS VICTIM'S POCKETBOOK

Davidson, Jan. 4.—(AP)—Dr. W. L. Lingle, Davidson College president, has his pocketbook back and \$65.

Dr. Lingle was relieved by a pickpocket of his bill-fold and \$65 on a recent trip to Chicago. The purse was mailed back to him from the Windy City. The green-backs were missing.

## Widow Becomes Artist

New York—Harry Lehr's widow has become a commercial artist. Her first work is a jacket design for a Count's book, a satire on American social life. The widow of the former New York social arbiter does her art work at her residence in Paris. She was formerly Elizabeth Drexel of Philadelphia.

## Dies From Burns

Granit Falls, Jan. 4.—(AP)—Miss Nina Costner, 17, died yesterday from injuries she received when kerosene she was using to re-kindle a kitchen fire at the Costner home exploded and enveloped her in flames. The home was destroyed.

## DR. DAWSON LAID TO REST NEAR GRIFTON

### Funeral Service Conducted From Late Home This Morning at 10:30 O'clock

Funeral services for Dr. W. W. Dawson, of Grifton, prominent physician and member of the Pitt County Board of Commissioners, were conducted from his late home at Grifton this morning at 10:30 o'clock. Rev. W. A. Lillycrop, rector of St. Paul's Episcopal church, Greenville, Rev. A. C. D. Noe, rector of the Grifton Episcopal church, and Rev. Perry Case, pastor of the A. D. Christian church, officiated. Burial was made at the Quiner burying ground a few miles from Grifton.

The final rites were attended by hundreds of sorrowing friends, many sections of the state, floral tributes in a rite of the high esteem in which Dr. Dawson was held. Men high in the medical science were present to pay tribute to the man who had done so much in behalf of his profession, as were those in lower walks of life to whom the deceased had ministered during his long years of service to his community.

Tragedy, grim and stark and cold, surrounded the death of this man whom the people of Pitt county loved almost as they loved their fathers. Suffering from mental depression over injuries sustained in an automobile wreck several weeks ago, he went out to the Grifton-Flat Ridge game reserve Thursday afternoon, and in the silence of the hunting lodge, fired the load of a shotgun through his heart.

The gun and a stick with which he is supposed to have tripped the trigger, were found lying nearby, telling in a mute way of the tragic ending of the peerless leader of governmental affairs of this county.

The body was found about an hour later by D. M. Seymour, of Grifton, who had been hunting along Moccasin river upon which the hunting lodge is located. The coroner investigated the case a short time later and his jury returned a verdict that death was caused by a gun in the hands of the deceased.

Although suffering injuries of the fourth and fifth vertebrae and concussion of the brain in the automobile wreck, physicians expressed belief that Dr. Dawson would eventually recover. However, after he returned home from the hospital, he expressed to friends the belief that his mind had been affected by the accident. He declared that his brain refused to function as normally as it once did, and friends believe that brooding over this condition resulted in the act that brought to an end the colorful career of the man who had spent the most of his life ministering to the sufferings of the people of his beloved community.

Aside from being prominently identified with the medical profession, Dr. Dawson was vice-president of the Bank of Grifton, and had important land holdings in various parts of the county. He also owned extensive farm lands in Pitt, Lenoir and Greene counties. Dr. Dawson was a member of the Pitt County Medical Society, past vice-president of the North Carolina Medical Society, and a fellow of the American Medical Association. He was a Knight Templar Mason and a Shriner. He was also a member of No. 452, A. F. & A. M., of which he was a past master; Kinston Chapter R. A. M., and St. Paul's Commandery, Knights Templar, and of Sudar Temple, Mystic Shrine at New Bern. He was also a member of the State Board of Medical Examiners and the board of directors of Caswell Hospital.

Dr. Dawson rendered distinguished service to the county as chairman of the Board of County Commissioners during the period following the war. Sometime after his retirement, he was reappointed to the unexpired term of a commissioner and since that time had attended virtually every meeting of the body.

Probably his most outstanding service to the county came no later than last year when he conducted speaking campaign in the interest of lower land taxes. He carried the fight to the very doors of the legislature, and his argument supported by other able leaders of various counties of the section, resulted in enactment by the General Assembly of a measure tending to bring to a desired relief.

Out of respect for Dr. Dawson the courthouse was closed from 10:30 to 12:00 o'clock to day in order to give officials and clerks an opportunity of attending the

SELL IT NOW.

With the re-opening of the tobacco market next Tuesday for the after Christmas portion of the 1929-30 season, growers who have a portion of their crop yet unsold should lose no time in getting it marketed. The market probably will not remain open but about three weeks and naturally the factories do not wish to remain open longer than is necessary to take care of the balance of the crop. If you have some tobacco left on hand get it ready for market now and bring it on in just as soon as the market reopens. The selling time is growing short now and you can gain nothing by holding your tobacco back.

A BEGINNING.

The opening of a cream route through our county yesterday marks the beginning of the dairying business here and just how much progress we will make along these lines depends entirely upon our farmers. Deliveries yesterday were made by only eight persons, totaling a little over eighty dollars worth of butter fat, or ten dollars to the person. This might sound small, but just think how much this would mean to each of our farmers each week in addition to having the benefits of a sufficient milk supply for needs at home and skim milk to fatten pigs and chickens.

Under the present plan the butter fat delivered to the route is being carried to another place for manufacture, but if there is interest enough in dairying in this community to warrant a supply, there is no doubt that we can get a plant here for the manufacture of creamery products which would mean much to our community. It is an humble beginning we are making now but it is a beginning along lines that hold tremendous possibilities for us if our people are of the mind to develop the industry.

A LOSS TO THE STATE.

When the tobacco farmers in Eastern North Carolina faced ruin upon the opening of the tobacco season unless tobacco prices were increased, Dr. W. W. Dawson, of Pitt County, became chairman of a committee seeking to secure fairer prices. He headed the committee to Washington, D. C., to lay the appeals of the farmers in that governmental setting to the representatives of the great tobacco companies. That signal service was representative of his whole life as man, citizen, good physician. His death is more than a local

loss. It is a State loss, for Dr. Dawson stood high in the medical profession, in Masonry and in all matters of civic progress.

A few weeks ago he sustained serious injuries in an automobile accident. He returned home, having in part recuperated in body, but not from the concussion of the brain. "It will not function," he said to a friend before he was dead, the fatal wound believed to have been self-inflicted when he was not himself. It is a tragedy to lose so good a man as the result of a deplorable accident.—News & Observer.

ABOUT TOWN

The passing of Dr. W. W. Dawson, of Grifton, will be received with profound sorrow by the people of Pitt county.

Always taking an active interest in the welfare of the county, the former member of the County Board of Commissioners, physicians and extensive landowner, played an important part in moulding the sentiment of the public over a period of many years.

Probably his most outstanding services came no later than last year when he stumped this section of the state in behalf of lower taxes. It was largely through his argument in behalf of the oppressed landowner that the legislature saw fit to take steps providing the relief which the taxpayers sought.

As chairman of the county board of commissioners over a period of many years, Dr. Dawson rendered exceptionally fine service, especially during that period of depression and readjustment following the war. His wise council at that time no doubt enabled the county to pass over the period in good shape and to carry on into the future without financial reverses as experienced by other localities.

They were crucial times—times filled with many changes, but the steady hand of Dr. Dawson at the helm of the county government, brought the frail craft to safe shores, and today Pitt county enjoys the fruits of his wise direction of her affairs.

Naturally, sales are not expected to be heavy at this season of the year, but there still remains right much tobacco to be marketed and if the farmer does not act rapidly the curtain of the present season will be rung down before he completes his sale.
