PROHIBITION CONTROVERSY FLARES ANEW

LaGuardia of New York Says More Drinking in Idaho Than in New York

Washington, Jan. 7.—(AP)—The capital prohibition controversy flared up again today with a declaration prepared for the House by Representative LaGuardia, Republican, New York, who said there was "more drinking per capita in the state of Idaho than there is in the city of New York."

Idaho is the home state of Senator Borah, one of the staunchest of the drys, who has been most active recently on the enforcement question.

LaGuardia spoke of "The Bloody Mer" of three members of the crew of the Black Duck recently off the New England coast by Coast Guardsmen engaged in a rum runner chase.

"The case of the Black Duck," he said, "is but another paragraph in the shameless annals of prohibition."

"The treasury department rushes into print to justify the slaying of these three men," he continued. "Yet the record is bare of any fact showing that the Black Duck had refused to leave to or was in actual light. The Coast Guard officials and the crew of the cutter 220 have been hailed and praised for having well performed their duty, yes, their duty as seen in the light of prohibition."

Part of the liquor taken from the Black Duck, he added, "was in turn sold by members of the Coast Guard."

"Citizens of this country are prohibited by law to drink alcoholic beverages and yet on the same day that the Black Duck was captured members of the Coast Guard got crazy drunk members of the Coast Guard have been found purloining part of every seizure of liquor made by them."

Referring to Idaho, LaGuardia said there were more saloons per capita there than in the city of Philadelphia.

"There are more bootleggers per capita in the state of Idaho than there are in the city of Chicago," he added. "Liquor is better in the state of Idaho than in any of the large cities, and cheaper."

The city of Wallace, Idaho, LaGuardia said, has a population of 2,816 inhabitants, and in the month of May "there were seven saloons operating wide open, where anything could be purchased over the bar from Canadian beer to mint juleps."

"In the city of Kellogg," he continued, "with only 3,017 inhabitants, there were three saloons and thirty bootleggers engaged in furnishing the supplies besides their own retail trade in the surrounding territory. In the small town of Mullan, with 1,320 inhabitants, there are several stills operating in full blast and doing a thriving business."

REPARATIONS DISCUSSED AT HAGUE CONFAB

Financial Experts Clearing up Proper Date for Maturity of Installments

The Hague, Jan. 7.—(AP)—Financial experts who took part in the preparing the Young plan at Paris had the floor here today at the second conference on reparations.

Their problem was to clear up the proper date for maturity of the installments; the Germans contend the last day of each month is that on which they had based their reckonings of capacity to pay, while creditor nations claim to have assumed the fifteenth of each month as the maturity date.

A matter of about 4,000,000 marks of \$1,000,000 annually in interest is involved, which the Germans insist if they are to pay should be deducted in equivalent amount from the capital or present value of the reparations debt.

To aid in presenting their view they telegraphed yesterday for Dr. Hjalmar Schacht, president of the Reichsbank, and Ludwig Kastl, a co-finance in preparation of the Paris Young plan, to come to the Hague. At first it was understood Dr. Schacht would leave immediately but it was learned later he would not come here until January 12. Herr Kastl, however, is expected today.

Rudy Vallee Refuses to Marry N. Y. Show Girl

New York, Jan. 7.—(AP)—Hubert Prior Vallee—the Rudy Vallee of the radio and the crooning voice—has denied all but one allegation charged in the \$200,000 breach of promise suit filed by Agnes O'Laughlin, Broadway show girl.

And as to that allegation, Rudy, through his attorneys, said: "Defendant denies each and every allegation contained in paragraph numbered four except as much as alleges that he refuses to marry plaintiff and has stated to plaintiff that he will not marry her."

LEAF MARKET RESUMES WORK IN THIS CITY

Sales Resumed This Morning Following Several Days' Closing for Holidays

Following observance of the Christmas holidays, the Greenville tobacco market re-opened this morning to receive the remainder of the tobacco crop of this section of the state.

According to an early report of sales issued by K. W. Cobb, supervisor of sales, there was approximately 63,000 pounds of bright leaf on the floors of the various warehouses.

It was estimated that the price situation was similar to that prevailing when the market closed for the Christmas holidays, with some grades selling possibly stronger.

Competitive bidding was described as unusually keen with all of the large tobacco companies being fully represented.

According to an announcement issued yesterday the market will close for the season Friday, January 24th, instead of Tuesday, January 21st, as previously announced. This will give the growers something like three weeks in which to dispose of the remainder of their crop, and they were urged to get busy and market their offerings as rapidly as possible.

Chester, S. C.—(AP)—Arthur Emery, general manager of the Aragon Baldwin Cotton Mill chain in South Carolina, has tendered his resignation.

Durham, N. C.—(AP)—During a funeral at the home of R. W. Bright, the floor of the living room gave way and mourners and casket were dropped seven feet to the ground. Firemen and police were called. No one was seriously hurt.

Yourk, S. C.—(AP)—Officers found something new in moonshining when they raided a still in the Mount Zion section. The still was being driven by a steam engine. Eight hundred gallons of mash

were seized.

Spartanburg, S. C.—(AP)—Frank Mayhew, Roy Hill and Forest Cantrell, who have been convicted of robbing 14 stores and seven post-offices in the Carolinas, drew terms of 20 years each. Officers said they confessed to robbing postoffices at Wingate, N. C., Mount Pleasant, N. C., and three sub-stations at Charlotte.

Goldsboro, —(AP)—The proprietors of a drug store here were fined \$10 and cost for keeping open in violation of the Sunday blue laws. The judge ruled that soda crackers and soft drinks are not a square meal and do not constitute the drug store a restaurant.

Two Guests Burned to Death in Hotel Fire at Pittsburgh

Pittsburgh, Kas., Jan. 7.—(AP)—Two guests of the Wick Hotel here were burned to death and five injured early today by fire which forced 74 scantily clad persons to flee from the hotel, and which seriously damaged the three-story hostelry.

Flames blocked the front stairway and entrance of the hotel and guests leaped from windows and slid down ropes to safety. Few had time to dress and many braved blizzard conditions in night clothing.

Plane Forced Down at Warsaw

Warsaw, N. C., Jan. 7.—(AP)—An airplane which made a forced landing near here yesterday after giving out gasoline had been unable to continue the trip to Miami, Fla., this morning, the wheels bogging in soft earth. Charles F. Hirsch of Philadelphia, owner, and J. S. McCormick of Landsdowne, Pa., were the only occupants of the plane.

Refuses \$4,750 Grant

Dublin—Leitrim county has refused a grant of \$4,700 for a Carnegie library. It would have been necessary to tax the farmers in order to maintain the library and the county council decided that the money could be used to better advantage in relieving distress.

SNOW STORM SWEEPS OVER THE ROCKIES

Blizzard Stretches From Slopes of the Rockies Almost to Gulf of Mexico

Denver, Colo., Jan. 7.—(AP)—The Rocky Mountain west was storm-blasted today by a blizzard that stretched from the slopes of the Rockies eastward and south through Kansas, Oklahoma, and Texas, almost to the gulf.

The swirling snow resulted in the crash of an air mail plane in Colorado last night. Today Montana, Wyoming, and Colorado felt the effects of the storm that came after an extended period of mild weather.

Clear and cold weather, the kind that sends the mercury reeling, prevailed in Montana, where many points reported temperatures as low as 20 below. At Lewistown, 25 below was reported, a new low mark for the season. Nearly a foot of snow lay on the ground at Helena. Automobile travel was difficult, even on the main highways out of the Montana capital.

Snow was general over Wyoming and air mail service was hampered. Thermopiles received six inches of snow and the mercury dropped to six below at Sheridan.

The snow was light in Colorado, but near-zero temperatures prevailed early today.

Sweeping into the region south-east of the Rockies, the storm brought sleet all over Oklahoma, with sleet and snow forecast for parts of Texas.

More Prisoners At State Prison Than Ever Before

Raleigh, Jan. 7.—(AP)—There are more people in the North Carolina state prison now than ever before, according to Warden H. H. Honeycutt.

The prison population is 2,250. Warden Honeycutt announced yesterday, declaring the facilities of the central prison and the prison farms were taxed to capacity. The warden said admission had been increasing steadily since 1927. In September of 1927 there were only 1,592 inmates. Admissions last year totaled 1,189, the largest in history.

JAPANESE DELEGATES IN LONDON

Negotiation of a Mediterranean Pact of Non-Aggression Is Deemed Possible

London, Jan. 7.—(AP)—Japanese delegates to the London five power naval conference today visited the foreign office and were received officially by Arthur Henderson, the British foreign minister. They were introduced formally by Sir Robert Van Sittart, permanent secretary to the foreign office that no outline of Mr. Henderson's conversations with Premier Wakatsuki, head of the Japanese delegation, and his Japanese colleagues, would be made public.

Paris, Jan. 7.—(AP)—Negotiation of a Mediterranean pact of non-aggression, it was learned authoritatively today, is now deemed possible.

The successful conclusion of such a pact, it is believed here, would affect favorably the whole course of the London naval conference and would increase notably the chances of success of that meeting.

Preliminary negotiations during the past two days have radically changed the pessimism of last week on the question of Mediterranean pact.

There is much interest as to whether the United States through the American delegation would give such a pact moral support. If so, it is believed, Great Britain would be self-denying ordinance for the Mediterranean which would pledge all the signatories to non-aggression, this increasing France's feeling of political security.

Statesmen close to the situation are said to be convinced that France's insistence upon political obscurity must be taken into account.

They also are represented as being convinced that without French support the conference would be threatened and that this support, to be obtained, must take stock of the apprehension of France concerning invasion.

With her were her father, King Albert, her mother, Queen Elizabeth, Prince Leopold and his wife, Princess Astrid, and Prince Charles, her other brother, whose title is Count of Flanders.

It was the first visit of the Belgian royal family to the Pope since 1922, and it was accompanied by the same elaborate ceremony which marked the welcome of the holy to see King Victor Emmanuel and Queen Helena of Italy December 5.

BAPTISTS WILL OBSERVE THEIR 100 BIRTHDAY

Plans Now Underway for Centennial Celebration Here During March

Rev. A. W. Fleischmann, pastor of Memorial Baptist church of this city, has returned from Raleigh, where he attended a meeting of the committee having charge of arrangements for the centennial celebration of the Baptist State Convention to be held in this city during the month of March.

Although the program has not been completed by any means, Mr. Fleischmann said the convention would be attended by at least a thousand of the most outstanding members of the denomination in this state. He said there would be no discussions dealing with official business, and that the entire two days' session would be devoted to consideration of the one hundred years of history of the convention.

The sessions will be held in the Memorial Baptist church. It was upon this site that the first Baptist State Convention was organized one hundred years ago, although in a different building. The church at that time was known as the Missionary Baptist church, and the present structure was erected some years later after the membership had conducted a strenuous building campaign through the "buy a brick" plan. Many a tender memory is associated with the early struggle of the congregation and the convention, and it is expected the facts as presented by different speakers will be of more than passing interest to the hundreds of people to be in attendance.

Fleischmann said the committee was endeavoring to make the celebration as much interesting as possible, and to do that an effort will be made to bring to the city both men and women high in the religious, social, educational and financial life of the south. Detailed information concerning the various features of the celebration will be made public from time to time, it was said, and the people will be kept fully informed as to what to expect when the centennial celebration gets under way.

HOOVERS WILL BE GUESTS AT SOCIAL EVENTS

President Will Break Presidential Precedent by Attending Club Reception

Washington, Jan. 7.—(AP)—President and Mrs. Hoover will leave the White House tonight to attend two social affairs given in their honor and in keeping one of these engagements will depart from recent presidential precedent.

The first will be a dinner given by Vice-President Curtis and his sister and official hostess, Mrs. Dolly Curtis Gann, in their suite at the Mayflower hotel.

Then, they will go to a reception given by the Congressional club at the club house. The membership of the organization includes the wives of cabinet officers and members of Congress.

Tradition prescribes; and custom of late years has strengthened it, that almost the only social contact of the president and first lady must be within the White House walls. But the Hoovers have their own ideas. They have tossed many a little worn-out convention overboard since he became president. They do pretty much as they please.

MARRIAGE OF PRINCESS TO BE BIG AFFAIR

Brilliant Assemblage to Attend Wedding of Marie Jose and Prince Humbert

Rome, Jan. 7.—(AP)—Marie Jose, Princess of Belgium, and Crown Prince Humbert, of Italy, tomorrow will be married before one of the most brilliant assemblages seen at any European court since before the war.

The ceremony will take place at the historic Pauline Chapel of the Quirinal palace, scene of four conclaves for election of Popes. It will be the first time since April 9, 1923, when Princess Yoland of Italy married Count Calvi Di Bergolo there, that it has been used for a royal wedding.

Cardinal Maffi, archbishop of Pisa, noted astronomer and long-time friend of the Italian royal family, will perform the religious rite. He will be assisted by Monsignor Beccaria, chaplain of the royal household, who baptized the bridegroom and has been his spiritual mentor through childhood and youth. Other distinguished prelates also will assist.

The guests will number three kings—Albert of the Belgians, Victor Emmanuel of Italy, and Boris of Bulgaria—the queens of Belgium and Italy and almost all members of the royal families of the two nations. Besides these there will be the Duke of York, representing King George of England; Prince Cyril, and his sister Princess Eudoxia of Bulgaria, the Infante Don Ferdinand representing King Alfonso of Spain; Marshal Petain representing France, and Prince Paul and Princess Olga of Jugo-Slavia.

Princess Marie Jose is 23 years old, and the third child of King Albert and Queen Elizabeth. Prince Humbert, whose title is Prince of Piedmont, is the third child but the first son of King Victor Emmanuel and Queen Helena. He is 25 years old, and has the rank of a colonel of infantry in the Italian army.

There is a love match, fostered years ago when each enjoyed winter sojourn together at Milan and in northern Italy. The liking they held for each other as children they retained during early maturity, and it is said, when the question of marriage came up, were most happy when their separate choices were confirmed by their parents.

President Hoover Bids Farewell to Delegates To London Arms Parley

Washington, Jan. 7.—(AP)—President Hoover gave a stirring talk today to members of the American delegation to the London Naval Conference and their technical advisers at the White House breakfast.

This was the chief executive's last meeting with the delegation before its departure Thursday for the British capital and it was the final gathering of the entire group before embarkation.

Secretary Stimson, chairman of the delegation, said after the breakfast that Mr. Hoover had "back-up" talk, outlining the general American position and "in his inimitable way" reviewing the world situation which led up to the conference.

The secretary said the meeting showed no differences of opinion among the group and that they would carry on as a unit. It was also agreed that Mr. Stimson would be the sole spokesman for the delegation at London.

Immediately after the breakfast the president and delegates posed for photographs and Mr. Stimson subsequently gave a farewell message to the American public through talking pictures.

Washington, Jan. 7.—(AP)—Conscious of inevitable difficulties, but counseling confidence and patient effort, President Hoover said goodbye and good luck today to the delegates who will speak for him at the London Naval Conference.

Five of the seven members of the delegation, and a group of their ranking technical advisers, were invited to a breakfast conference at the White House. On the presidential calendar the event was classed as social and informal, but it provided opportunity for a parting word of advice about the momentous discussions which are to begin two weeks from today in the British capital.

It now is apparent these discussions may embrace a consideration of further limiting aircraft carriers and a class of ship which has received little attention heretofore in the conference preliminaries. The air-

craft carrier provides a floating base for naval airplanes, and already is under certain limitations as a result of the Washington treaty. If further limitation is proposed at London, the United States will be prepared to discuss it.

Guests went to the executive mansion this morning with their affairs in Washington finally wound up for an indefinite stay abroad. Secretary Stimson of the state department, head of the delegation, had closed his desk and arranged to leave during the day for a short visit to his home on Long Island. Most of the official party, however, is to depart on Thursday morning on a special train timed to make quick connections that afternoon with the Steamer George Washington at her pier at Hoboken.

Besides Mr. Stimson, the delegates invited to the breakfast included Secretary Adams of the Navy Department, Dwight Morrow now ambassador to Mexico and soon to become a Senator from New Jersey; and Senators Reed of Pennsylvania and Robinson of Arkansas. The other two members of the delegation, Ambassador Charles G. Dawes and Hugh Gibson, already are abroad.

The president also included in his invitation the naval officers and state department officials who are to go to London to provide technical advice, and two men who will shoulder temporarily the duties of membership in the cabinet while their chiefs are away—Undersecretary Coitton of the state department and Assistant Secretary Jancie of the Navy. In all, eighteen places were laid at the big table in the state dining room.

Mr. Hoover's words of counsel to his chosen representatives were, of course, kept under the seal of official confidence. Unquestionably, however, the delegation not only will leave Washington with certain broad lines of policy well defined, but with a knowledge of the president's detailed views on some of the most difficult problems of the conference.

NEGRO KILLED IN ARGUMENT NEAR AYDEN

Another Also Injured When Freddie Grimes Begins Action With Shotgun

Because he did not like the idea of carrying a curse, Freddie Grimes, 19-year-old negro of the Ayden community, shot to death another negro by the name of Willie Quinerly, then seriously wounded Claude Quinerly, a brother of the dead youth.

Grimes was being held in the county jail here today on a charge of murder, and the only thing he has said in connection with the shooting was that he didn't like to take the cursing which the dead youth is alleged to have given him.

The shooting occurred at the home of Grimes, in the Elm Grove community, about three miles from Ayden. The two Quinerly boys had been living with Grimes. They had an argument over something relating to household duties, and in the midst of it Willie Quinerly is alleged to have used profanity and then called Grimes by a name that no man likes to carry.

Grimes is alleged to have brought a double-barreled shotgun into action, killing Willie Quinerly with a single discharge. Claude Quinerly fled, but the second load from the gun lodged in his body as he sped out into the open. While his injuries were described as painful, they were not considered necessarily serious.

Grimes probably will be given preliminary hearing today or tomorrow, and then bound over to the next session of criminal court.

Fleet of Planes Bound for Cuba

Charleston, Jan. 7.—(AP)—The 27 naval sea planes, bound for Lunacy, Cuba, for the general fleet maneuvers, took off from here this morning for Miami, Fla., after spending the night at moorings in the Charleston harbor.

The flag plane bears Capt. J. Halligan, commander of the aircraft squadrons of the Atlantic scouting fleet.

Tarheel farmers are recleaning and treating their tobacco seeds in preparation for planting the seed beds.

WHITE HOUSE ASKED AID OF SUGAR EXPERT

Document Throws a New Light on Tariff Issue at Lobby Investigation Today

Washington, Jan. 7.—(AP)—A document read today before the Senate lobby committee said R. L. Purdon, sugar expert of the Department of Commerce, had been asked by the White House and Senator Smoot of Utah, to work out a sliding scale for sugar duties.

The document was contained in a letter from W. H. Baldwin, publicity man employed to work for lower sugar rates in the tariff bill, to Junior Owens, secretary of the American Bottlers of Carbonated Beverages. The letter said:

"I am enclosing a highly confidential memorandum on the sliding scale which you may be interested in seeing."

The memorandum said Purdon had been asked by the White House and Senator Smoot to work out a practical sliding scale.

"His name must not be mentioned in connection with the following information which he has given," the memorandum said.

Baldwin had previously testified that he had been paid \$1,500 monthly for his work by Owens and that H. H. Pike, New York sugar broker, had added a bonus of \$1,000 monthly.

The memorandum said:

"R. L. Purdon, chief of the sugar section, food staff division, Department of Commerce, has been asked by the White House and Senator Smoot to work out a practical sliding scale. His name must not be mentioned in connection with the following information which he has given."

"There are various basis that may be used in working out a sliding scale. The sliding scale idea just transfers the argument over the tariff rate from what will be the tariff rate to what will be the base line for measuring the tariff on the sliding scale."

"The sliding scale would be pricing it if the changes in duty were exactly corresponding with the change in price; but if a change in duty does not correspond to the change in price, it would not be price fixing, but merely a tendency to stabilize prices."

"He personally believes that a sliding scale would be practicable, and that it represents a scientific effort to protect the consumer and at the same time the domestic industry. However, he says it must be administered by somebody who knows the sugar business."

"The Garner plan will not work. The first thing to do in attempting to work out a sliding scale is to get an honest price on sugar. It can be done, it is just a matter of administration by some one who knows the sugar business."

"The important factors are the price where the sliding scale begins and the price at whatever date line may be determined upon and the method of administration. All plans mentioned publicly today, so far as he knows, would give the edge to some factor or other in the industry."

POSSE ENDS MANHUNT AT FOREST CITY

Attempt to Locate the Slayer of Kelly Moore Proves Unsuccessful Today

Forest City, N. C., Jan. 7.—An unsuccessful manhunt, in which 250 officers and citizens of Rutherford county participated, ended early this morning when officers in charge decided Walter Branch of Henrietta, the object of the search had escaped.

Branch is charged with murder in connection with the death early Monday of G. Kelly Moore, of Cliffside, who was fatally injured in an automobile collision.

The fugitive fled immediately after the accident but he was seen late yesterday by officer who were scouring the swamps on the Broad river between Henrietta and Cliffside.

They gave chase but Branch eluded them, discharging his cost as he ran. It was badly spotted with blood, indicating, officers said, that he had been wounded.

A call was issued for citizens after the officers lost the trail of the man and the 250 men formed a wide circle that stretched for miles along the Broad river and forest in the section.

year, he leaves our district,

words of appreciation for
splendid service he is ren-
dering the state in his admin-
istration of the law. He has
no hobbies and he does not
seek notoriety, but seems
wholly engrossed in an ef-
fort so wisely, beneficently
and impartially conduct the
courts over which he pre-
sides. He is patient and
courteous but maintains at
all times the dignity of the
bench, and quickly inspires
public confidence in both his
legal learning and in his de-
sire and ability to make the
courts a place where men
may look for justice. We
await with pleasure the time
when under the rotative sys-
tem he shall again come
among us."

A HOT TIME IN THE

ABOUT
TOWN

Several months ago the country
was told that liquor and narcotics
were being sold in the very shadows
of the nation's capital.

This resulted in a grand jury
probe.

Yesterday that grand jury re-
ported that lawlessness and crime
were as bad as had been pictured
in any of the charges.

This is a condition that not only
demands the attention of the capital
city police department but every
member of Congress who assemble
at that point from time to time to
conduct the affairs of the nation.

It is inconceivable that such a
state of affairs should exist under
the eyes of members of Congress
who have been charged with the
faithful discharge of obligations to
the various communities they rep-
resent. It looks like somebody is
not living up to the high trust im-
posed in them, and when the guilty
ones are found they should be dealt
with according to the law, and not
according to the high rank of office
which they represent.

This brings back to us the im-
portance of looking into the much
mooted question of immunity of
members of Congress. They are
no longer immune when such con-
ditions exist in their very midst,
and the quicker they are held re-
sponsible for their conduct outside
Congressional halls the sooner there
will be some genuine house clean-
ing at the seat of government.

Money crops—whose value is
governed by conditions over which
producers have little control—rule
supreme on North Carolina farms.
While the staple foodstuffs and
feedstuffs products are neglected
to such extent that in 1928 North
Carolina fell \$158,000,000 short of
producing sufficient quantities of
those crops, the full production of
which would have put the state on a
"Live-at-Home" basis and have
made the farmers independent of
the fickle, fluctuating prices of cot-
ton and tobacco.

This is one of the important find-
ings of a comparative survey made
by Charles A. Sheffield, assistant to
the director of the Extension Ser-
vice at State college. Mr. Sher-
field's survey is based on the find-
ings of the Federal Farm censuses
of 1925 and 1900.

It is shown that the farmers not
only do not raise enough foodstuffs
and feedstuffs to supply the wants
of the state as a whole, but actu-
ally fall short by many millions of
dollars of raising enough to supply
their own needs. In 1925 this
margin amounted to almost \$62,-
000,000, representing the difference
between the value of corn, wheat,
oats, hay, veal, mutton, lamb and
milk, which the farmers of North
Carolina actually raised and the
value which they needed for their
own use if they lived as well as the
average citizen of the United States.

North Carolina farmers in 1925
fell short by \$20,300,000 of produc-
ing enough milk for their own needs
fell \$13,809,400 short of producing
enough corn, fell \$10,600,000 short
on hay, fell \$9,313,983 short on oats,
\$7,059,608 short on wheat, \$765,377
short on mutton and lamb, and
\$731,970 short on veal. The survey
shows that the farmers did not
raise enough eggs, poultry, port,
beef, and potatoes to supply their
own needs of the state.

This proved conclusively that the
"Live-at-Home" movement, recently
enunciated by Governor Gardner
should receive the earnest consid-
eration of the farmers of this part
of the state and inspire them to go
into the business of raising more
of the things they consume at home.
The time for such an experiment
was never better, than the present
and it is to be hoped that this
year will find many of them trying
it out.

It does not require the bright
perspective of the optimist to see
the innumerable possibilities await-
ing the earnest worker in all sec-
tions of the eastern North Carolina

where resources have hardly been
scratched beyond the surface level.
Yet there are those who walk
about from place to place pleading
hard times. They chant the same
old lines from morning to night, from
day to day, and week to week hope-
fully perhaps that somebody will take
 pity upon them and start complain-
ing.

Naturally, any fool knows that
conditions are not what they usu-
ally are, but we haven't starved,
and what is more, we are not con-
tinuing to starve. This country is too full
of resources and possibilities, to per-
mit people to sit down and starve,
and the man or woman that struts
out to accomplish something will
find nothing impeding their pro-
gress.

We have seen hard times before,
we shall see them again should we
continue to live, but the world
must continue moving and the man
that sit down to whine and com-
plain will find that he is going to
be left far in the rear.


