PLAN DRIVE FOR FUNDS IN THIS CITY

Salvation Army Drive to Raise \$4,000 Budget to Open Early Next Week

The advisory committee of the local organization of the Salvation Army met yesterday afternoon and heard an interesting report of the activities of Captain Cranford and his helpers during the year just past. In accepting the report and in recognition of the splendid work done, the committee voted expressions of appreciation to Captain Cranford for his splendid work and efforts. President W. L. Best presided at yesterday's session and C. E. Bennett was made temporary secretary.

The support and maintenance of the Salvation Army for the present year was discussed at length, and plans started for the campaign for funds which will be launched on Wednesday of next week. The drive will follow the get-together supper and meeting on Tuesday evening at 7 o'clock at Parkerson's Dining Room, which will be attended by about fifty citizens who constitute the workers that will assist in raising the budget of \$4,000.00.

Campaign headquarters have been established in the offices of the Merchants Association, and C. B. Bennett has been elected as chairman. And several sub-chairmen are to be named to assist in directing the campaign which will be in progress three days beginning on Wednesday morning of next week.

The Salvation Army has rendered a great service in Greenville and the outlying territory contiguous thereto since its organization here a few years ago. The major part of their work and efforts in with those people who are not reached by any other agency and an organization of its kind is a blessing to any community in which it operates.

Continue Effort to Recover Bodies of Wreck Victims

Algiers, Algeria, Jan. 8.—(AP)—Efforts continued today to extricate bodies of ten or more victims from the debris of a passenger train wreck between Tunis and Algiers yesterday night. At least twenty persons were killed and as many injured. Ten bodies already have been recovered.

The wreck occurred when one of the train's two locomotives left the tracks while crossing an iron viaduct near Guelma. The viaduct collapsed and two coaches were thrown into the ravine. Several freight cars fell atop them. The train was running 45 miles an hour.

Belgian Princess Becomes Bride Of Prince Humbert, Heir to The Italian Throne

Rome, Jan. 8.—(AP)—Princess Marie Jose, only daughter of the king and queen of the Belgians, this morning became the bride of Prince Humbert of Piedmont, heir to the Italian throne.

The ceremony was performed at Mass in the historic Pauline Chapel of the Quirinal palace, scene of four conclaves for the election of Popes, and scene six years ago of the wedding of Humbert's sister, princess Yolanda, to Count Calvi di Bergolo.

Cardinal Maffi, archbishop of Pisa, noted astronomer and friend of the Italian Royal family, performed the ceremony. He was assisted by Monsignor Beccaria, chaplain of the royal household, who baptized today's bridegroom and was his spiritual mentor through childhood and youth.

Five kings and queens, 28 princes and 26 princesses of the blood were among the guests, who constituted one of the most brilliant assemblages seen at an European court since the war. King Albert and Queen Elizabeth of the Belgians and Leopold and Astrid, Duke and Duchess of Brabant, and Charles, Count of Flanders, came from Brussels for the wedding.

King Victor Emanuel of Italy, Queen Helena, and other members of the Italian Royal family were present. King Boris of Bulgaria, Prince Cyril and Princess Eudoxia of Bulgaria, Prince Paul and Princess Olga of Yugoslavia were among the other royal guests.

The Duke of York represented his father, King George of Great Britain, Marshall Petain, savior of Verdun, and M. Deco de Fouquieres, director of the protocol, were present for France. Ambassador John W. Garrett and Mrs. Garrett represented the United States. The Infante Don Ferdinand was sent by his cousin King Alfonso for Spain. Premier Mussolini, his cabinet, secretary, and their wives were present.

The bride, a tall, striking girl, entered the historic chapel on the arm of her father, King Albert, who was garbed in the full dress of a general. The wedding march was an old Sardinian hymn sung by the Papal choir lent the Royal family for the occasion. At the altar rail

waiting for her stood the Crown Prince, resplendent in the full dress of a colonel of infantry, and wearing the collar of the Annunziata, Italy's highest decoration about his neck.

Dark, of high stature, handsome, and with a pleasing smile, he presented a colorful figure in his gray green uniform relieved by silver epaulettes with their long fringes, the plaques and medals, and the long purple shoulder sash, caught up just under the sword at his left.

The bride wore a cream white velvet gown at ankle length with a mantle of the same material, seven yards long, and embroidered with ermine. The queen of Italy, wore cloth of gold with pearls and a golden mantle five yards long. Princess Yolanda, and Marie wore regal mantles of house of savoy blue bordered in gold.

Cardinal Maffi, smiling benevolently, approached the royal couple as they went forward to the priest. He prepared for them before the altar. His cassock of brilliant red was surmounted by a rochetto of rare old lace, and on his head was the cardinal's red beretta. His Episcopal ring, studded with a brilliant amethyst, glittered on his finger.

He read first the terms of the Italian code governing marriages, since by virtue of the conclusion of the Lateran treaties of last February 11 the priest officiating at a wedding assumes the functions of a civil officer of the Italian state.

Had the couple been married before the signing of the Lateran treaties they would have had to go through two ceremonies, one civil, the other religious.

Matrimony, the Cardinal told the princely pair, "imposes the reciprocal obligation of faithfulness and assistance," with just the suggestion of a friendly smile he told the bride to the throne that "the husband is the head of the family." The wife, he added, must follow her husband's civil condition and assume his full name, and is obliged to follow him "where he believes it opportune to fix his residence. The husband has the duty of protecting his wife." He must, the cardinal continued, "keep her close to him and administer to her all that is necessary for her life in proportion to his riches."

It was unmerciful punishment for a child so small, and the court sent the father to jail in order that he might have adequate time to realize the crime which he had committed in such rough treatment of an infant.

There were several other cases of more or less importance given hearing at yesterday's session, the majority consisting of worthless check charges.

\$500,000 Liquor Haul Is Reported At Philadelphia

Philadelphia, Jan. 8.—(AP)—Alcohol valued by prohibition administrator Smauel O. Wynne at more than half a million dollars at bootleg prices was in the hands of the officials here today.

The alcohol, together with 17 vans of liquor and several thousand dollars worth of distilling apparatus, was seized in a raid last night on one of the largest distilling plants uncovered in this city since prohibition.

Three arrests were made. The alcohol, in 2,800 five-gallon cans, was loaded on four five-ton trucks for delivery to customers when the agents closed in on the two story building.

Authorities said, the building, occupied by the Belko Manufacturing company, had been under observation for some time. They said the plant had been in operation several years, ostensibly in the manufacture of machinery.

SUGAR BROKER TESTIFIES AT LOBBY PROBE

Name of President Hoover Mentioned in Letter From Broker to Sugar Dealer

Washington, Jan. 8.—(AP)—A letter read today before the Senate lobby committee said W. C. D'Arcy, publicity man of the Coca-Cola Company, "has a personal method of approach to Hoover and is going to see that Hoover gets full but concise data on the sugar subject."

The reference was contained in a letter written by H. H. Pike, Jr., Wall Street sugar broker, to P. A. Staples of Cuba, who is connected with the Central Hershey Company.

Pike, who was on the witness stand, testified his information was received "from some one" but he said he had forgotten who it was.

Senator Robinson of Indiana, the only regular Republican on the committee, asserted that the letter indicated D'Arcy has "some backstairs way of getting to" the President.

When Pike said he did not know who gave him the information Robinson shouted:

"Then you ought to have kept quiet. This is the purest kind of leaking."

"I can tell everything now that I knew then," Pike replied.

Robinson asserted that the reference was unfair to the President but Pike said he understood all that was meant was that D'Arcy either knew or could reach him through a friend.

The letter to Staples dated February 1, said "Bob" Woodruff, president of the Coca-Cola Company "is after me every time he comes up here." It continued:

"The day before yesterday I saw him at noon. He then got me down to breakfast yesterday morning where he and his advertising man, W. C. O'Arcy, Mr. Horsey, export vice-president, and Ralph Hayes, publicity vice-president of the Chatham and Phoenix National Bank.

"We went over the matter in some detail and ended up this way:

"Mr. D'Arcy has a personal method of approach to Hoover and is going to see that Hoover gets full but concise data on the sugar subject.

Hoover Delegates Expect Great Difficulty at The London Naval Conference

Washington, Jan. 8.—(AP)—As viewed in advance from Washington, the forthcoming London conference presents a picture in historic contrast to the memorable outlines of the gathering of the sea powers in 1921.

President Hoover, as well as the delegates who are to sail from New York tomorrow see a pathway beset by difficulties, to be successfully traversed only by patient plodding. They give every evidence of confidence in the ultimate result; but they recognize fully that the circumstances and the methods of 1921 are not the circumstances and the methods of 1930.

Speaking a word of farewell yesterday to members of the delegation, the president adjured them to be patient, and called upon the patience to bear with confidence and the patience the ordeal of a diplomatic discussion which may last for many weeks from the opening session on January 21. He said no "hurried conclusions" were expected, but predicted that eventually the spokesmen of the United States, Great Britain, Japan, France and Italy would find a common basis for ending naval competition and permanently promoting peace.

The contrast between London in 1930 and Washington in 1921 runs deeply into the diplomatic fabric of the world's quest for universal understanding on the sea.

At the Washington conference, Secretary Hughes stirred the emotions by the direct and forceful manner of his diplomacy from the very moment the first session opened. He laid before the astonished delegates of the other powers a complete and sweeping proposal for reduction of naval armaments, running from the biggest to the lightest ships of war. Not all of it was accepted in the end, but it furnished an accelerating impetus to quick and decisive progress from the outset.

At London Secretary Stimson proposes a course of quiet, persistent effort, wholly devoid of diplomatic fireworks. Not only that, but if the expectations of the chief American delegate are borne out, none of the other powers will begin the negotiations by talking in detail of what they must have for national security, or by sounding any other note which might jar on the sensibilities of any of the conferees.

Mr. Hughes, in the beginning, saw an opportunity to smash through obstacles by the sheer weight of an aggressive attack. Mr. Stimson disarms in the present different set of circumstances no such possibility; he depends rather on the force of undemonstrative persuasion.

NEW HEARING IS DENIED FOR DR. J. H. SNOOK

Slayer of Theora Hix to Die in the Electric Chair on January 31st

Columbus, Ohio, Jan. 8.—(AP)—The State Supreme court today denied an application of Dr. James H. Snook for a re-hearing of his appeal from a sentence of death in the electric chair for the murder last June of Miss Theora K. Hix. He is to die in the electric chair January 31.

The court had denied Dr. Snook's double appeal from a conviction in Common Pleas court here. The former Ohio State University professor had sought review of the case on its merits and also filed a petition in error as a right raising a constitutional question.

The bandits entered the dining room and held up the guests with revolvers. Yang was seized and bound. He is believed to be still in Fecchow, but the other five have been taken up the Minkiang to the bandit stronghold.

Certain physical features of the situation throw additional illumination on the parting words of President Hoover and the known purposes of Secretary Stimson. In 1921 the American government held, so to speak, a handful of trumps in the form of a great battleship fleet, regarded by American statesmen as beyond the absolute necessities of peace. The United States was able to lay on the table a momentous offer to restrict construction.

But at London in 1930 the United States finds itself behind; rather than ahead, in certain unrestricted classes of warcraft, notably cruisers. There has been no hint that President Hoover is willing to sacrifice any considerable percentage of the fifteen-cruiser building program. The Americans will have to make in other directions.

They want the holiday in battleship building continued, they would be content with a limitation reducing destroyer strength, and they would like to abandon the submarine altogether. But the world's discussion of naval armament in recent months has trust the cruiser in the very first rank of controversy, and it is at this very point that the American government finds a positive limite on its ability to offer reduction.

Although the president is charged with conducting the foreign affairs of the nation, the treaties he makes must be ratified by the Senate before they come into force. Whatever might be his own idea of an appropriate sacrifice in the interest of peace, Mr. Hoover has not been permitted to forget that the negotiation of a treaty unacceptable to the Senate would be useless. The cruiser building program had strong support in the Senate from both parties, even at a time when it was known that some such negotiation as that proposed at London was within the realm of likelihood.

Throughout his preparations for the conference, the president has conferred many times with Senate leaders. They have told him frankly their opinions as to the value placed on a strong cruiser fleet by senators who in the past have been influential in the consideration of appropriations for the navy. He sends his delegation to London with full knowledge of this situation, and with two Senators and one prospective senator among the delegation membership. It is assumed the delegates will have in mind a treaty not only satisfying American naval opinion, so far as possible, but having likewise a prospect of Senate ratification.

Fatally injured in an automobile wreck at Richmond, Va., yesterday morning, O. C. Gregory, vice-president of the J. P. Taylor Tobacco company, died yesterday afternoon. Funeral services will be conducted from his late home in Richmond tomorrow afternoon at three o'clock, and burial will be made in the Richmond cemetery.

Mr. Gregory, a native of Oxford, N. C., was for many years manager of the Greenville plant of the American Tobacco company, and his death was received with profound sorrow by members of the tobacco industry here. Details of the accident were not received here.

St. Petersburg, Fla., Jan. 8.—(AP)—Smiling and waving his hat at a cheering crowd of several hundred, former president, Calvin Coolidge arrived here today aboard a special train that brought 200 delegates to the annual convention of the New York Life Insurance company.

Mr. Coolidge, who became a director of the insurance company soon after his retirement from the presidency, posed with Mrs. Coolidge for photographers at the railway station.

Upon reaching his hotel he posed for sound picture photographers meanwhile chiding the cameramen for delaying his breakfast.

Chicago, Jan. 8.—(AP)—The one and only Charles Arthur "the great" Shires found the world full of sunshine today.

His third successful ring venture in four starts was chalked up by St. Paul, Minn., last night when his furious Longshoreman rights flattered Tony Faeth, St. Paul pitcher, in the first round. It was a decisive victory for "the great" and the officials and spectators were satisfied to a man that there was no semblance of a "dive" in that ring battle.

Meanwhile, the Illinois and Michigan State Athletic Commissions were expected to clear the Great Arthur from charges of "fixing" his bout with "Dangerous Dan" Daly of Cleveland here last December and of attempting to "fix" his postponed match with another fighter at Detroit.

The Illinois commission took testimony yesterday from Promoter Mullen, who arranged the Shires-Daily match, and Eddie Meade, manager of the "dangerous one" and then indicated it would give Shires a clean bill of health. Shires was to appear before the Illinois commission today to tell his story and prompt acquittal seemed certain. Daly so far has refused to appear before the commission.

Acquittal of the charges made by Battling Criss, who said he was asked to take a "dive" and refused, is anticipated from the Michigan commission, which is to hear Shires' story tomorrow.

If Shires is returned to good standing in Illinois and Michigan, his friends are certain he will make a quick trip to the White Sox for a contract in keeping with his confessed greatness for 1929. The Great One has announced he would demand a salary of \$25,000 but it is certain the White Sox will balk at such a sum.

Secretary Harry Grabiner of the White Sox insists the club is not interested in Shires until he is cleared from all charges and his suspension for striking former Manager Russell "Lena" Blackburne last season has been lifted.

YANKS REFUSE TO PAY BABE HIS OWN PRICE

New York, Jan. 8.—(AP)—Babe Ruth things he's worth \$85,000 a year for the next three years to the New York Yankees, but he has yet to prove his argument to the satisfaction of President Jacob Ruppert and Secretary Ed Darrow.

Ruppert thinks he can afford to pay the Babe \$75,000 per annum for the next two years but that offer is exactly \$10,000 too little and one year too short for the man who made home runs what they are today.

These two viewpoints couldn't be reconciled at a conference in Ruppert's brewery yesterday, each side retreating in good order to consider the matter calmly and sanely.

Baseball followers considered the biggest obstacle in the way of a demand for a three year contract. The Babe has just completed a three year contract at \$70,000 a year but Ruppert said yesterday he would not give Ruth another one on any terms. The Yankee president evidently feels that Ruth is setting no younger fast and that it would be too much of a gamble to give him such a long-term contract.

His "top offer," the colonel assured Ruth, was a two-year contract at \$75,000 per annum but the mighty slugger nonchalantly turned down this wage, equal to the salary paid to the president of the United States and the \$10,000 more than is paid to K. M. Landis, commissioner of baseball.

Ruppert and Darrow said that the next move must come from Ruth. The Babe said he would leave Saturday for St. Petersburg, Fla., where the Yankees will train. Ruth will be 36 next month and has been in the big leagues since 1914.

The slugger's salary has jumped from \$10,000 to \$70,000 per year since he joined the Yankees in 1920. Sold in that year by the Boston Red Sox for a sum reported to have been \$125,000, Ruth played under a holdover contract calling for \$10,000. He got \$25,000 for his work in 1921 and \$52,500 per year for a five year contract covering 1922-23-24-25-26. He signed a three year contract at \$70,000 a year in 1927.

JACK SHARKEY WILL BATTLE BRITISH ACE

New York, Jan. 8.—(AP)—Jack Sharkey, Boston sailor man, will battle Phil Scott, heavyweight champion of Great Britain, in Madison Square Garden's annual southern spectacle at Miami, Fla., Feb. 27.

Difficulties were ironed out in a long conference at the Garden last night.

Selection of Scott as Sharkey's opponent was practically dictated by the Boston sailor, generally regarded as the outstanding contender for Gene Tunney's vacated heavyweight throne. At a recent conference in Boston, Sharkey threatened to break away from the Garden for good unless it abandoned its attempt to match him with "Tuffy" Griffiths in Miami. He named two or three possible opponents he would be willing to meet but favored Scott especially.

Advance calculations on the match forecast a decisive victory for Sharkey provided he can duplicate such a performance as he flashed against Tommy Loughran, whom he knocked out in two rounds. Scott is fair boxer with a good left jab but he does not hit hard enough, it would seem, to bother Sharkey. The tall Briton, now in England, is under somewhat of a cloud in this district as a result of his recent battle with Otto Von Porat. Scott won that bout on a foul in the second round but investigations later seemed to confirm a rather general belief that he was not hurt by the low blow and could have continued.

The Garden has been rather lukewarm to Scott as a prospective opponent for Sharkey, preferring Griffiths, Victorio Campolo or even Primo Carnera.

STOCK MARKET

New York, Jan. 8.—(AP)—Trading on the New York stock exchange today declined to the smallest volume since the summer of 1928 with prices still floundering around within a narrow trading area, and giving no indication of a definite trend. Gains out-numbered losses but floor traders continues the bulk of activity, the public apparently maintaining a complete indifference to the proceedings.

Business news had a little more cheerful tinge. Preliminary estimates indicated a sharp increase in the unfilled orders of the United States steel corporation in the monthly tonnage report to be issued at noon Friday. Iron Age reported that "steel production has taken an upturn after two months of sharp curtailment and the outlook is for further improvement, although it is expected to be gradual". Directors of the J. C. Penney company increased the annual dividend from \$2.33 to \$2.50, and indicated their intention of further increasing the payment to \$3 annually in the next quarter. Directors of the Zenith Radio company omitted the usual reason the need of conserving cash.

Call money renewed at 41-2 per cent and again dropped to 4 when the supply of funds far exceeded the demand. The time money and commercial paper markets displayed an easier undertone. But the official rates remained unchanged.

Recent weakness of some of the European currencies, particularly sterling, suggested the possibility of a further decline in discount rates.

Much of today's activity was in stocks selling between \$20 and \$50 a share, although the widest fluctuations, as usual, took place in some of the high priced issues. Western Union, which dropped 73-4 points yesterday, rallied 51-2 in today's early trading. Ingersoll Rand dropped 53-4 and Columbia Carbon 5, heaviness of the latter probably representing the traditional "selling on the good news" following the announcement of a higher dividend.

A good demand was apparent for General Electric, Simmons, General Railway signal, Collins and Aikman and U. S. Cast Iron Pipe, while Allied Chemical, U. S. Industrial Alcohol, Lambert, Gillette Safety Razor, Westinghouse Electric, and American Tobacco B yielded 2 to 3 points on a renewal of selling pressure.

SLEET STORM SWEEPS OVER GREAT PLAINS

Breath of Winter Reaches From the Dakotas to the Gulf of Mexico

Kansas City, Jan. 8.—(AP)—Over the favorite domain of King Winter—the vast region of the great plains and the eastern slopes of the Rocky Mountains—there rolled today the grim-like beat of a gigantic sleet storm with which the burly old monarch heralded re-establishment of his rule.

From the Dakotas and Montana to the Gulf, and from the Mississippi river to the Continental Divide, sleet, snow and rain drove south and eastward on the wings of a northern gale, which the mercury dropped out of sight in the bulbs of thermometers not built to register such temperatures as prevailed.

In Glasgow, Mont., the official thermometer broke yesterday after 70 degrees below zero.

Air lines, buses, railroads and all forms of vehicular traffic were forced to mighty struggles, and in many cases failed to keep moving. Transcontinental Air Transport plane schedules were cancelled here yesterday and there was little prospect of resuming flight today, as snow and sleet whirled over the city. National Air Transport planes departed for Chicago, but an incoming plane was forced down at Rushville, Mo., and arrived four hours late.

A Western Air Express plane, westbound, was forced down at Wichita last night. The eastbound plane from Los Angeles was cancelled.

Weather bureau officials said that, except in the far northwest, the storm would continue over tomorrow, but that a gradual rise of temperature might be expected by Friday.

The program falls into three divisions—a round table discussion led by state directors for the morning session, the presentation of two plays at the afternoon meeting, and the annual Twelfth Night Revels of the Carolina Playmakers this evening. All meetings will be held in the Playmakers Theatre, where the conference will open at 10:30 Saturday morning.

The directors will be welcomed to the university by Prof. Koch, who will make a short talk in opening the discussions.

The discussions are designed to give the directors an opportunity to exchange ideas on methods of directing and producing plays. Directors who have already consented to lead discussions are Robert Wunsch of Asheville Senior High, who will preside; Miss Grace Everest, of Fayetteville High; Miss Ella Henninger, of Greensboro College; Miss Vivian Burton, of Smithfield High; Mrs. Oscar Randolph, of Morganton High; Miss Sally Richardson, of Winston-Salem High, and Miss Edith Russell and E. MAN WANTED FOR MURDER SURRENDERS

Walter Branch Walks Into Sheriff's Office at Rutherfordton and Gives Up

Rutherfordton, Jan. 8.—(AP)—Walter Branch, Henrietta man, who has been the object of an intensive two-day search in Rutherford county following the filing of murder charges against him, surrendered to sheriff's officers this morning about 10:45 o'clock.

Warrant for Branch was sworn out Monday following the fatal injury of G. Kelly Moore, 72, prominent Cliffside contractor, in an automobile wreck early Monday morning near here. He is alleged to have been the driver of the car reported to have carried liquor, which crashed head-on into another automobile

occupied by Moore and Lox Harrill, also of Cliffside, who was less seriously hurt.

Branch, himself injured in the accident, fled immediately afterward. To local officers this morning he displayed a badly cut foot, a bruised chin, gums from which several teeth were missing and lacerations on the face.

The man's story of the sweeping man-hunt of which he was the object, was graphic.

An early impulse to give himself up, he said, was conquered by his fear that the officers would shoot him. All day Monday he lay in hiding between Henrietta and Cliffside, while the officers beat about him. Once he was sighted and shot at, but escaped by running.

He attempted to swim the Second Broad river, but found it too much for him and turned back. He had nothing to eat from Monday morning until last night.

Weakened by his wounds and by hunger, he related, he went home last night, and this morning had a friend telephoned the Rutherford sheriff his desire to give himself up. Officers went to the home and arrested him. He is confined in the Rutherford county jail here.

Art Acord Held On Rum Charge

Los Angeles, Jan. 8.—(AP)—Art Acord, one time star of wild west films, was back on the stamping grounds of moviedom today "dead broke", and eager to convince the law he is not "trying to be crooked". Acord was brought from Nogales, Arizona, to answer a charge of possession of liquor.

The court wanted him to appear in person, however, and when he failed to do so a search was initiated which resulted in his arrest.
