

French Premier Will Ask Sec. Stimson For More Facts About Arms Parley

Paris, Jan. 16.—(AP)—It was understood here today that Premier Lardieu when he meets Secretary Stimson, head of the American naval delegation, in London Sunday, will ask him frankly for information concerning the preliminary naval conversations between the United States and Great Britain. He will ask, probably, just what party means when the word is brought into practical application. The projected questioning of the American secretary of state, it was felt, was more for the completion of his information than indication of any suspicions of England and the United States.

WET AND DRY FORCES CLASH IN CONGRESS

Tenth Birthday of Prohibition Brings About Resolution for Repeal of Law

Washington, Jan. 16.—(AP)—Prohibition's tenth birthday found the wet and dry issue a subject of heated controversy at the capital with members discussing it on the House floor. The Senate receiving a resolution asking repeal of the eighteenth amendment, and with Commissioner Deane of the prohibition bureau, in a formal statement, announcing that "substantial progress" toward drying up America had been made. In the House, Representative Oliver, Democrat, New York, broke the quiet that virtually has been maintained on the floor since receipt of the Hoover prohibition enforcement reorganization program. He asserted that if this sweeping realignment were carried out it would "smother the revolution no more effectively than a lace curtain will smother a fire in an oil well."

Bomb the Home of City Collector At Chicago, Ill.

Chicago, Jan. 16.—(AP)—Morris Eller, city collector, and Mrs. Eller were thrown from their beds early today by the explosion of a bomb at the rear of their home in a three-story apartment building. Eller, who was unhurt, said he knew of no motive for the bombing. Police, however, pointed out that the city collector had been the center of attack in the politico-criminal alliance charge developed by the investigation of Frank J. Loesch, acting as special prosecutor. Eller has often been spoken of as "Boss" of the ward known as "the bloody twentieth." He is the father of the Superior Court Judge Emanuel Eller.

Mountain Dew Makers Said to Be On Run

Atlanta, Jan. 16.—(AP)—After ten years of prohibition, enforcement authorities say they find mountain moonshiners on the run—with improved running gear. Gone is the old stone jug, hidden in the stump, long a trademark of the hill fraternity. A portable tin container, such as city bootleggers use, has usurped its place. "Changes have come to the entire 'Mountain Dew' industry" if the North Georgia hills are an index, according to Howard P. Wright, deputy prohibition administrator here. Firearms still flourish, but federal agents aren't targets any more, says Wright. The guns from the mountains form the Mountaineers' co-operative telegraph system to warn shiners that prohibition agents are guests of the countryside. "In every moonshining district there's a lookout," Wright explained. "When he sees strangers who might be prohibition agents he runs back of the shed and fires a gun in the air. The still operators near do the same, and run. In a few minutes the alarm has spread through the whole district and every still is deserted. We seldom have any trouble, however, except to catch them on the run."

Prize for Gumption

Southend, England.—The Rt. Rev. Harry A. Wilson, Bishop of Chelmsford, would like to see a prize for girls' gumption established. "It is not people with brains but people with gumption who get on in the world," he said in an address at a girls' school here. He believes that fashions, in particular, show girls' lack of gumption. "Why on earth?" he asked, "should you not strike out on your own lines even if you are told you must wear a hat of a peculiar shape and a skirt of a particular length?"

English Birthrate Decreases

London.—The birthrate in England for the third quarter of 1929, as figured by the registrar general, is the lowest in history.

Cardington, England, Jan. 16.—(AP)—The new British dirigible, R-10, left its hangar today for a test flight. It is expected to remain aloft for five hours or more.

SEN. WHEELER WOULD CALL RADIO OWNER

Demands that W. K. Henderson Appear Before Committee to Answer to Criticism

Washington, Jan. 16.—(AP)—A request that W. K. Henderson, who operates station KWKH at Shreveport, be called by the Senate interstate commerce committee to answer criticism about the language used over his station was made today by Senator Wheeler, Democrat, Montana, but no immediate action was taken. The request was made as William S. Hedges, president of the National Association of Broadcasters, was testifying at a hearing on the Couzens communications bill. Hedges said Henderson was not a member of the association. "In view of the fact," said Wheeler, "that Henderson's name has been brought into our discussions so many times, and in view of the criticism of him on the floor of the Senate and Henderson's criticism of the Radio Commission, I think it would be well to have him come before the committee."

Woman On Trial for the Murder of Two Children

Camden, N. J., Jan. 16.—(AP)—The prosecution in the case of Gladys May Parks, charged with the murder of Dorothy Rogers, 4, and Timothy Rogers, 2, motherless children, who were in her care, neared its close today.

Attorneys for the defense will move to dismiss the charges against the prisoner on the ground of insufficient evidence.

If the motion fails, Samuel P. Orlando and Carl Kisselman, the attorneys, said they were not prepared to say whether they would place Miss Parks on the stand, as it would depend on developments.

Detective Sergeant McGowan, of Newark, today testified under cross-examination that Miss Parks made a statement to the police at the time of her arrest at Newark voluntarily. In it, she said Dorothy died after she had been slapped for an indiscretion and that the boy died after an accidental fall downstairs in their Camden home. She admitted she buried the two children in shallow graves, the little girl at National Park, near here, and the boy at Absecon, near Atlantic City.

California Visited by 2 Earthquakes; No Damage Done

Los Angeles, Jan. 16.—(AP)—The earthquake which shook a large section of Southern California late yesterday was found today to have registered more sharply in the inland mountain areas, although no appreciable damage was reported.

Two distinct quakes, at 4:25 and 4:35 P. M., were felt generally from the sea eastward to the Coachella Valley, and from San Diego to the Mojave desert.

Dr. Harry L. Wood, seismologist of the California Institute of Technology at Pasadena, said his instruments indicated there were three tremors, the first, very faint, at 3:25 P. M.

San Diego, the point farthest south to report the quake, felt the two tremors, but they were not sufficiently strong to elicit more than casual comment in that city.

In Los Angeles the 4:25 P. M. shocks were felt distinctly. The first of the greatest intensity and longest duration. It swayed flagpoles in the business district, and rocked buildings with a rolling movement. There was no sharp jolt.

Pomo, 40 miles east and slightly south, experienced heavy shocks, with temporary disruption of telephone service, the quake there caused some exodus of residents into the streets, as it did also in San Bernardino 60 miles east of Los Angeles.

Order Autopsy On the Body of Woman at N. Y.

New York, Jan. 16.—(AP)—Although police listed the death as due to natural causes, the medical examiner's office ordered an autopsy performed today upon the body of Mrs. Harriet Adler, estranged wife of a bond broker, found dead in the Pent House apartment of a motion picture director.

Dr. Harry Weinberg, assistant medical examiner, said that a heart attack was the apparent cause of death, but that indications on the throat, made by a string of pearls, and a slight discoloration of the face hinted strongly enough to strangulation to warrant an autopsy.

Mrs. Adler, who was 35 years old and the wife of Hamilton Adler, head of a brokerage firm here, was found dead in the apartment of Dudley Murphy on the roof of an East Forty-First street office building.

Murphy told police that Mrs. Adler came to his apartment early yesterday morning. He said he and John M. Barbour, a friend, left her sitting in the living room when they retired. When he awoke, Murphy said, he found Mrs. Adler lying face down across a corner of a couch. He tried to arouse her and discovered she was dead. Police absolved Murphy an Barbour of all blame in her death.

Dr. Wineberg said that the woman evidently had been drinking heavily. Murphy attracted attention in Hollywood with his camera work in the "Ballet Mechanique." Since then he has directed several pictures, including "Frankie and Johnnie" in which Gilda Gray was featured. Paramount representatives said he had directed one "short" for them but was no longer with the company.

Taft Rests Well At Asheville

Asheville, Jan. 16.—(AP)—Chief Justice Taft had a good night's sleep at Grove Park Inn last night and awoke this morning refreshed and apparently in fine spirits. It was announced by members of his party this morning.

The skies here this morning are overcast with a marked chill in the atmosphere and Mr. Taft's program called for him to remain in his suite the entire morning. Doctors said he did not appear to be fatigued today as a result of his trip from Washington. He expressed himself as amazed at the beauty of the inn and the surrounding hills, and seems highly pleased at the prospect of a rest here.

The newspaper gathering opened last night with an address by David Lawrence, Washington newspaper correspondent, and publisher of the United States Daily, on "The Trend of the Times." Mr. Lawrence asserted:

"We can no longer regard ourselves as an independent unity in the world. We have got to recognize the security of economic cooperation. The intense desire to increase production is slowly diminishing. The next decade will be one of distribution. The next decade will witness an intense competition in transportation. It will be a period of economic readjustment, of cost cutting, of elimination of waste and probably of elimination finally of competition."

The speaker traced the economic progress of the United States from the beginning of the reconstruction period following the world war through the financial upheaval of the latter part of 1929.

"I don't believe," he said, "we can foresee the effect of that dislocation of 1929, the topsy-turvy condition into which the country was thrown."

PARTIES IN CRIME.

Governor Richards, of South Carolina, in his message to the General Assembly of his State yesterday, recommended and urged that the buyer of liquor be made equally guilty with the seller and, as such, punishable for violation of the prohibition laws. While it has been argued in some quarters that laws to this effect would cut off a source of information for enforcement officers because buyers would not then testify against bootleggers, it has been our idea that only in a small percentage of cases now are the buyers willing to testify against the sellers, so we do not believe that the new law would make it any harder to enforce prohibition.

On the other hand, we do know that without buyers the bootleg game would necessarily become so unprofitable that it would die out of its own accord even if there was no effort to enforce it, therefore it is the buyers who are making it possible for the illicit whiskey traffic to continue to exist. Make whiskey drinking unpopular and you will make bootlegging unprofitable and this can be done only by legally making the buyers equal parties in the crime for which they are now morally responsible, through providing a market for the wares of the bootlegger.

FOOD FOR THOUGHT.

Does North Carolina, especially the eastern section of the State, really want to increase its farm income? If so here are some facts and figures set forth by the Oxford Public Ledger that should suggest a way of greater farm prosperity in North Carolina through a system of more diversified farming:

"Wisconsin and Minnesota have nearly as many dairy cows as all the Southern states combined.

"North Carolina has nearly a hundred days longer growing and grazing season than Wisconsin and Minnesota.

"North Carolina needs annually, to meet home demands, 30,000,000 more pounds of butter, 11,000,000 more pounds of cheese, 10,000,000 more gallons of fluid milk, and 6,000,000 gallons more ice cream than the state's present ability to supply.

"Other nearby Southern states are also importers of these products in amazingly large quantities.

"Out of 45 carloads of live poultry placed on the New York market one day in November, only four cars were from the South. Okla-

homa supplied one of these and Tennessee the other three.

"Any one of the several states of the North and Middle West supply the markets daily with two to three times as much poultry and eggs as all the Southern states combined.

"Atlanta is a convenient nearby market for North Carolina products, and yet hundreds of carloads of California eggs are sold in Atlanta.

"Most of these shipments come from sections far less fortunate in climate and soil resources than North Carolina, where the growing and grazing season extends from the middle of April to the middle of December."

ABOUT TOWN

If Governor Richards of South Carolina had his way about it liquor drinkers would be made as guilty as the makers. In a message to the legislature yesterday, the Governor declared that the only way to make prohibition effective is to bring into disrepute both the maker and consumer of bootleg whiskey.

"If you wish, gentlemen, to really break up the liquor traffic, enforce prohibition, and at the same time create a condition that will alleviate much of the suffering of humanity, generally, then I urge to pass a law imposing the same penalty upon the buyer that is imposed upon the seller. I urge that the prohibition law be so amended that those convicted of a second offense be not allowed the alternative of a fine.

If the advice of Governor Richards was heeded in South Carolina, and in the entire country for that matter, it is easy to assume that conditions would become more favorable within the next several years. The reason prohibition has not been as effective as it should be because there are too many people who drink the vile stuff without being held responsible for their conduct. When the time comes that they shall have to assume as much responsibility as the maker then and then alone shall we expect to see the dry law actually become what its supporters hoped it would.

"Where in the world is all the hard times talk coming from?" asked Hugh L. Allen, former superintendent of the local Water and Light Commission, who was in the city for a short visit yesterday. "I never have seen such improvement and progress in any town as I noticed in Greenville while walking about the streets today. I have been all over the state and right at the present I believe that Greenville is doing as much construction work as any town I have been in and much more than most of them.

"You folks in Greenville and Pitt county have the resources to make your section the garden spot of the world and yet many people are talking hard times. Tell your citizens for me to snap out of it. If there ever was a section with possibilities it is in Eastern North Carolina and especially Pitt county. Forget about that hard times talk and look on the bright side of the picture."

The Salvation Army drive got way to a good start in this city yesterday morning and indications point to successful completion of the campaign the latter part of the week.

The Salvation Army is asking the people of this community to give \$4,000 this year with which to continue their work of ministering to the needs of the poor element, and especially those other organizations are unable to reach. That the city will respond, we have not the slightest doubt. The army workers have done a splendid work in all parts of the country, and it is certain their efforts will be just as great in the future as in the past.

Reports of Greenville banks following the annual meeting of stockholders indicate that all of the institutions experienced healthy growth during the year just closed despite the claim that financial depression has existed here during the winter.

When the banks of a community are in a healthy and thriving condition the general run of people have nothing to fear. The banks are something of an index to community life and their resources indicate in a way the trend of affairs in the financial and business realm. Greenville has some of the strongest banking houses to be found in this part of the state, and it is a generally conceded fact that they will continue to grow and thrive as this great agricultural section awakens to the possibilities contained in its fertile soil.

As a former director of the Department of Health of this county, Dr. Chester rendered particularly fine service and greatly endeared himself to the people in all sections. He was diligent in his effort to improve the health of the various sections, and the Health Department benefitted greatly from his four years of untiring service.

Greenville again welcomes Dr. Chester, and it is hoped his stay here will be just as pleasant as it was the last time.

The passing of Dr. Zeno Brown will be received with profound sorrow by many of the older residents of the city who knew him during his young days when he was an active practitioner of his profession in this city.

Dr. Brown probably was one of the most prominent physicians in the county several years ago, and while not in active practice in recent years because of ill health, numbers who were familiar with his record, sought his services. He was a life long resident of Greenville, except, of course, the years he was away at school, and all of his life's interests were centered here. He had faith in the possibilities of Pitt county, and believed that opportunities for expansion were just as great today as they ever were.

NATURE PUTS ON BIG SHOW OVER NATION

Earthquake in California, Cold in West and Rising Streams in Indiana Reported

An earthquake in Southern California, extreme cold in the north west and Rocky Mountain regions, and floods in the middle west and south were included in the show put on by nature in the United States in the last 24 hours.

While buildings were rocking and flagpoles swayed in Los Angeles, Pomona, and along the San Bernardino valley in Southern California, 500 families were being driven from their homes by a swollen, raging Wabash river at Vincennes, Indiana.

At Ottawa, O., 20 persons were rescued from second story windows after the Blanchard river had gone far beyond its banks.

Today cold was sweeping down from the northwest, and throughout the Mississippi Valley, where rivers had gone outside their banks, were great areas of ice and slush.

Cold set new records in the Rocky Mountain region. Reports from Denver were that six persons had died, victims indirectly of the cold. It was 7 degrees below zero in Denver early today.

A vast area of cold and snow extended as far south as Albuquerque, N. M. Snow blocked roads through the mountain passes in Colorado and New Mexico.

The cold extending into the south, however, was expected to save the portion of the county from bad floods. It was clear and crisp there today, and tributaries of the Mississippi were receding from flood stage.

Weather in New England and down along the Atlantic Coast, was about normal today. It was cold, but unseasonably so, and there were flurries of snow.

Youth Commits Suicide Corinth, N. Y., Jan. 16.—(AP)—Suspended from high school for drinking home-made wine in the school building, Eugene Clothier, 14 years old, committed suicide last night. Principal Herbert A. Beckman said he suspended Clothier when investigation disclosed he had brought the wine to school. The boy was in his first year at the high school.

AL SIMMONS LED LEAGUE WITH HIS BAT

Chicago, Jan. 16.—Al Simmons performed his duty as clean-up man for the champion Philadelphia Athletics in championship style last season, leading the circuit in the important business of batting in runs, official 1929 averages revealed today.

The heavy swinging Philadelphia participated in 143 games and drove in 157 of the 901 runs scored all season by Connie Mack's team. Thirty-four times, he scored himself by home runs and came home with 80 more through the assistance of his mates.

Babe Ruth, playing eight games less than Simmons, was second with 154. The Bambino tied with his Yankee teammate, Lou Gehrig, for the honor in 1928 with 142.

Simmons and Ruth were the only two American League batsmen to drive in an average of one or more runs a game during 1929. Dale Alexander, husky Detroit rookie, finished third by driving in 137 runs in 155 games while Gehrig was next, sending 126 runs across in 154 games.

Other leaders and the number of runs they batted in were Heilmann, Detroit, 120; Fox, Philadelphia, 117; Kress, St. Louis, 107; Gehrig, New York, 106; Lazzari, New York, 106, and Fonseca, Cleveland first baseman who won the American League batting championship, 103.

The best harvester of bases on balls for 1929 was Max Bishop of the Athletics. Bishop became so particular at what he swung at that he was given 128 passes to first base in 129 games. Lu Blue of St. Louis was second with 126 passes in 151 games. Gehrig got 122 free passes and Fox worked the pitchers for 103, many of them intentional.

Ruth, who has been honored for years with 100 or more free trips to first base each season and who holds the record with 170, received but 72 in 135 games in 1929.

Joe Sewell retained his title as the hardest man in the American league to strike out, tying his own world's record of four strikeouts in 152 games. "Mickey" Cochrane of the Athletics struck out but eight times in 135 games while Sam Rice of Washington whiffed only nine times in 150 contests.

Jimmy Foxx, possessing a hit or nothing complex, was the easiest man to strike out among the regular batsmen, churning the air 70 times or two more than Gehrig and 10 more than Ruth.

Dykes of Philadelphia, Schang of St. Louis and Reeves of Boston were hit by pitched balls seven times each during the season. As a club, St. Louis received the most bases on balls, 589, while the Yankees struck out collectively 518 times.

Spears Elected As Head Coach At Oregon University

Minneapolis, Miss., Jan. 16.—(AP)—With the University of Minnesota making last minute efforts to keep him as head football coach, Dr. Clarence W. Spears started today for the west with the offer of an \$11,500 annual salary as gridiron coach at the University of Oregon awaiting him.

Dr. Spears was elected coach at Oregon at a meeting of the institution's executive council at Eugene last night, and he will meet Dr. Arnold Bennett Hall, president of the Oregon school, of Missoula, Mont., Friday to discuss final acceptance.

Coach Spears has been dissatisfied with management of athletic affairs at Minnesota, especially over financial matters relating to assistant coaches and their salaries.

The Gopher mentor receives \$7,500 a year at Minnesota and devotes all his time to football. At Oregon, in addition the salary increase, he would be permitted to practice medicine in the off-football seasons.

The Senate Athletic committee, governing body of sports at the Gopher institution, held a hastily called meeting late yesterday to discuss the situation with Dr. Spears. While the meeting was behind closed doors, it is understood that Spears aired his grievances fully and presented conditions under which he might remain here.

Dr. Spearch came to Minnesota five years ago from West Virginia University. During his tenure as coach at Minnesota, the Gophers have won 28 games; lost 9, and tied three.

Washington and Lee Beat the Blue Devils

Charlotte, Jan. 16.—(AP)—The mighty Duke Blue Devils were smothered today under the sting of a major defeat in their season's basketball campaign.

After crushing Maryland and Virginia and finally the powerful Navy outfit, the Devils fell last night at Durham before invaders from Washington and Lee. The brilliant General five downed the Blue Devils 33 to 29, in one of the most dazzling games ever seen in Durham.

The Generals moved on to Chapel Hill today for an engagement to-night with the North Carolina Tar Heels. The Blue Devils on Saturday night at Durham will meet Wake Forest in a North Carolina "big five" contest.

Davidson, one of the "big five" teams, last night at Davidson took a 39 to 25 victory from Lenoir Rhyne, a North Carolina "little six" outfit.

Dr. George W. Hawley, bone specialist, wrote "finis" to Delaney's ring career today when he declared that an injury to the right arm which has bothered the former champion for two years threatened to cripple the ram permanently unless Delaney abandons boxing.

Delaney, with tears in his eyes, heard the doctor's dictum after an X-Ray examination.

Delaney retired from the light heavyweight title to enter heavyweight ranks. He was planning a comeback campaign. His first bout was to have been against Tom Kirby of Boston at the Providence Arena on January 24.

Quintero Fights Mandell to Draw At Miami Beach

Miami Beach, Fla., Jan. 16.—(AP)—A ten-round non-title combat in which the ramming fists of young Manuel Quintero held Champion Sammy Mandell to a draw today put the young Cuban left hander near the front of the lightweight boxing picture.

Quintero's puzzling southpaw fighting style won him an even break in his engagement with the title holder here last night. Promoter G. R. K. Carter said the inaugural of the winter fist season in the Miami area attracted 11,000 persons who paid \$32,000 to witness the match. Market Report Cotton--Stocks--Grain

COTTON MARKET

New York, Jan. 16.—(AP)—Cotton opened steady at unchanged prices to an advance of 5 points today with active months showing net gains of 4 to 7 points during the early trading on covering and some trade or commission house buying, promoted by reports of rather a better demand for cotton goods and talk of a campaign to reduce acreage in the south.

March sold 49 to 17.42 and July to 17.75 but the advance seemed to meet some southern selling and realizing and the market was comparatively quiet at the end of the first half hour with prices showing reactions of 2 or 3 points.

Private cables said that hedging and liquidation had been offset by trade calling and a good spot demand in the Liverpool market. Spot sales there amounted to 10,000 bales but included only 4,000 sales of American cotton.

Manchester reports indicated further sales to India and said results of the Shanghai auctions were more encouraging.

GRAIN MARKET

Wheat closed shaky, 1-2 to 1 7-8 a bushel under yesterday's finish; corn closed 1 1-8 to 1 3-8 down; oats 1-2 to 7-8 off, and provisions varying from 7c decline to a rise of 25c.


