TARDIEU WILL TRY FOR VOTE ON THURSDAY

Possibility of Agreement Between U. S. and Japan Seen at Conference Today

Paris, March 3.—(AP)—Andre Tardieu and members of his second cabinet officially constituted yesterday, went immediately to work today on the ministerial declaration on which they will seek a vote of confidence in the Chamber Wednesday.

Given a vote of confidence M. Tardieu expected to have a French naval delegation back in London and ready to resume negotiations on Thursday.

London, March 3.—(AP)—A tentative agreement between the United States and Japan on the Japanese demand for a seventy per cent ratio was said to be looming large as a possibility today.

Excellent progress was reported to have been made in conversations between Senator David A. Reed, American delegate, and Ambassador Matsudaira of the Japanese delegation.

These two old friends have been discussing the Japanese-American problems informally in private, and their talks will continue this week.

It was understood the conversations have been along lines of possibilities especially the possible increase in Japan's ratio in submarines as compared with capital ships under the Washington treaty. They also are trying to devise some scheme whereby the date of laying down cruisers by one country would control the right of the other country to construct additional cruisers.

The United States has now become prime mover in the negotiations with Japan while Great Britain is awaiting the outcome. The previous British negotiations with the Japanese extending two or three weeks are said to have resulted in a complete deadlock. The British are being kept informed of the progress of the American-Japanese conversations.

Meanwhile the experts' committee which has been considering the classification of special ships has reached an agreement and its report has gone to the printers.

Tomorrow the heads of the various delegations will meet at St. James' Palace to consider the report of the experts' committee on the French category scheme. The delegations hope that Ambassador Fleury will have instructions from Paris which will enable him to represent his country at this meeting.

If these instructions do not arrive it probably will be necessary to adjourn some of the proposals until the French delegates return.

Another question which is dependent on the French return is that of the humanization of submarines. The other four delegations have gone as far as they can in preparing a draft treaty without the presence of the French.

New York, March 3.—(AP)—A cabled appeal, sent from this city by the Foreign Policy Association over the signatures of 1,200 of the nation's most prominent men and women, was in the hands of the American delegation at London today.

The message urged "reduction, not merely limitation, of armaments. It was sent yesterday, after it had been written and the signatures had been authorized within 72 hours through an intensive telegraphic campaign of the association.

The message said that the Kellogg-Briand peace compact outlawing war had been signed by all the participants in the parley and should guide the conferees.

The message reminded the delegates that President Hoover, in his Armistice day speech, had said that this country would make the nation and its people of any other nation and added the warning that the failure of the conferees would have a calamitous effect on American public opinion.

Prominent Farmer of Black Jack Dead

Hardy Smith, prominent farmer of the Black Jack community, died Sunday afternoon at 4 o'clock. He was 81 years of age. Funeral services were conducted from his late home this afternoon at 3 o'clock by Elder Laughlin, and interment was made in the family burying ground near the home.

He is survived by the following children: Mrs. John Praden, Beaufort county; Mrs. J. A. Clark, of Greenville; Mrs. J. J. Smith, Black Jack.

Mr. Smith was a member of the Free Will Baptist church for thirty years. He was also a deacon of the church.

ORDER HIGHER FREIGHT RATES IN THIS STATE

Supreme Court Orders Increase in Intrastate Rates Before April 30

WASHINGTON, March 3.—(AP)—After rehearing a complaint by the Virginia State Corporation commission, the Interstate Commerce commission today decided that intrastate rates in North Carolina on classified freight shipments are discriminatory to shippers of classified freight in Virginia. The discrimination was ordered removed by requiring the North Carolina intrastate rates to be increased on or before April 30.

The commission said the rates caused unjust discrimination because they were less than the class rates prescribed in the Southern class rate investigation.

The North Carolina Corporation commission protested that the application of the general Southern class rate rule mentioned would result in an increase of 24 per cent over its present class rate. This estimate, however, the Federal commission did not entirely accept.

Raleigh, March 3.—(AP)—The decision of the Interstate Commerce commission today that North Carolina intrastate rates, on classified freight shipments, must be revised will cost the local shippers hundreds of thousands of dollars annually, the State Corporation commission estimated today.

The real extent of the increase cannot be ascertained until a copy of the full order is received. I. M. Bailey, counsel, said, and any estimates until then would be only guesses.

The case was first brought in 1925 by the Virginia State Corporation commission when it alleged that intrastate rates were low as compared with inter-state rates between Virginia and North Carolina, and discriminated against intrastate rates.

The first hearing was held in April 1925 and after the examiner's report the interstate body reopened the case and allowed the Virginia commission to amend its original complaint as it found the original so drawn that it was unable to give a decision.

The rehearing was held in February 1929.

The revision, the State Corporation commission said, would result in an increase in North Carolina rates on classified shipments of 24-1-2 per cent on single line hauls and 12-1-2 per cent on joint line hauls.

No Solution to Death of Youth At Mill Village

Marion, March 3.—(AP)—Marion county officers today apparently had no solution to the mystery surrounding the shooting of David Buckner, 14-year-old son of a Marion textile worker, Saturday night.

Sheriff Oscar Adkins said his investigations had not disclosed evidence sufficient for him to bring charges against anyone.

Meanwhile the youth is in Marion General Hospital in a serious condition. He received the full charge of a shot run in his neck and shoulders while standing in the yard of Mark Toney, textile worker who lives near the Marion Manufacturing Company.

Two women, Mrs. Sophie Hemphill and Mrs. Susie Owens, said they heard and saw shots fired from the Toney home, but officers appeared inclined to discount their statements.

SIX KILLED IN RIOT

Buenos Aires, March 3.—(AP)—Six persons were killed and twenty injured in riots yesterday growing out of the national Congressional elections. Disturbances occurred in the provinces of Entre Rios, Cordoba, Buenos Aires and Santa Fe.

Wedding Party of Thirty Persons Drowns in Lake

WARSAW, Poland, March 3.—(AP)—An entire wedding party of thirty persons, including the bride and bridegroom, was drowned yesterday in Lake Narogina, in the Wilno district when ice broke under the weight of their sleighs.

The party, laughing and happy after the wedding in the village church of Swienty, decided to take a short cut across the frozen lake. They had almost reached the opposite shore when a crack appeared in the ice which finally broke through. The wedding party was thrown screaming into the water, and efforts to rescue any of them were futile.

Demands Government To Begin Action To Aid Unemployment Situation

Senator Wagner of New York Scores Inactivity of President Hoover

Washington, March 3.—(AP)—Congress was urged today to set its machinery speedily in motion to relieve unemployment which, a group of Senators asserted in rapid fire speeches on the floor, was widespread and working hardship on many individuals.

Wagner, a New York Democrat, touched off the debate by demanding action on bills to survey the situation with a view to providing relief. LaFollette of Wisconsin, a Republican, then declared "alarms over red scares and communist demonstrations" were attempts to "divert attention" from the real issue of unemployment.

By this time administration Senators were on their feet. Feet of Ohio, a Republican, said he would discuss unemployment in a prepared speech tomorrow.

Washington, March 3.—(AP)—A demand for organization by the government to meet the unemployment problem was made in the Senate today by Senator Wagner of New York.

"In an address severely condemning the Hoover administration policies on this point, the New York Democrat called attention to recent manifestations of unemployment in some large cities. He proposed that support be given to his bills to provide more information and voluntary cooperation with the states in maintaining clearing houses of jobs and men in search of work, and to provide a long range plan of business stabilization through the proper timing of government construction.

Wagner assailed contentions that the delay in enactment of the tariff bill was responsible for business conditions and denounced the leadership of President Hoover in the tariff controversy. He said to blame unemployment on the tariff is "an unadorned act of tawdry politics."

"The Republican party was incapable," said the New York Senator, "of writing a tariff bill that would meet with the approval of its own members. The Republican leadership in Congress was incapable of bringing about a redemption of the party pledge."

"When this breakdown occurred in the Republican party the President did not come forward and exercise the leadership which was the prerogative of his office. He did not take hold of the reins of party direction and guide a united party back to the performance of its campaign pledges.

"Instead he was undecided; he was undetermined; he vacillated; he permitted the west to be lured that he was counted among the insurgents, while in the east he gave comfort to the Old Guard. Meanwhile, he drifted and permitted every tide and every wind of popular fancy to shift his course; and when a dangerous shoal was in sight that intrepid captain gave the callant command, 'come, let us have breakfast together.'"

Senator Wagner recalled Mr. Hoover's own suggestion for legislation to meet unemployment difficulties and asked "what has become of that program?"

"We have none of the fundamental information. We have no stabilization machinery. We have no system of employment exchanges. And we have heard nothing further from the President in regard thereto."

RELATED COLD WAVE SWEEPS ACROSS DIXIE

Freezing Temperatures Reported From Mountains to Coast in Carolina

Charlotte, March 3.—(AP)—Winter temperatures which came back to the Carolinas after a 10-day period of balmy warmth had the two states shivering today.

High temperatures which had caused fruit trees into bloom and brought out the hardest of spring flowers at an unusually early date gave way yesterday before the chill bite of a blustering March wind.

Freezing weather prevailed from the mountains to the coast and the temperature continued to drop as the night advanced.

The cold and wind brought snow to mountainous sections of North Carolina, but elsewhere clear skies prevailed. Even in the mountains little of the snow stuck to the ground except upon mountain tops.

The drop in temperature caused fruit growers to speculate today upon the extent of damage to their crop. Because of the unseasonable warmth in February blossoms were well advanced and right to be nipped by cold.

In Spartanburg county, South Carolina, peach growers burned smudges through the night in an effort to save their crop. While the extent of damage was problematical, George Ross, superintendent of state-owned farms in North Carolina, expressed belief that the peach crop of the Sandhills section in this state had not been greatly damaged.

The cold wave in some places brought an extreme drop of as great as 40 degrees in temperatures during 24 hours. From temperatures of 50 and above the mercury fell to 10 or lower. At Asheville last night the mercury reached 17 degrees. Temperatures as low as 20 were reported from numerous sections.

Atlanta, March 3.—(AP)—Winter cold swept Dixie a belated and unexpected gust today churning up piercing winds and a flurry of snow in the Atlantic Seaboard states to the accompaniment of sub-freezing temperatures.

The coldest weather was reported in the recesses of the mountains of western Virginia where the mercury dipped to ten above. After several weeks of premature spring temperatures South Carolina peach growers set smudges to burning in orchards filled with blooming trees.

Snow fell steadily last night in North Carolina and Asheville, N. C., and traces of the white flakes peppered the mountains as Knoxville and Nashville, Tenn.

Ice-sheathed highways disrupted traffic in Virginia and caused numerous minor mishaps. A strong northwest wind carried temperatures below the freezing point in north Georgia.

Weather forecasters said the cold would moderate as rapidly as it settled over the south, predicting rising temperatures for tomorrow.

Labor Leader Says Soviets Cause of Riots

New York, March 3.—(AP)—Matthew Woll, vice-president of the American Federation of Labor, in a letter published today charges that the propaganda agency of the Soviet Government is responsible for the series of unemployment riots in several cities in recent weeks.

In his letter which was sent to commercial organizations in 500 cities and to members of Congress, Mr. Woll quotes official communist sources to support his charge that under that guise of a "world-wide unemployment demonstration, set by the Communist International for February 26, but later postponed to March 6, the Bolshevik government of Russia is deliberately and openly promoting its revolutionary program in our country seemingly without let or hindrance."

He said the riots which had occurred in New York, Chicago, Cleveland, Pittsburgh and other industrial centers were preliminary to the world-wide demonstration to be held March 6.

Man Killed for Being Peacemaker

Chicago, March 3.—(AP)—Arthur Dolan was killed for being a peacemaker.

He was standing at the curb when two automobiles crashed yesterday, and he observed the quarrel that ensued between the two drivers, both negroes. He sought to settle things by giving his eye - witness version to the disputants.

\$3,000,000 Fire On River Front At New Orleans

New Orleans, March 3.—(AP)—A river front fire of undetermined origin, which burned to death two men and injured 12 others, was brought under control early today after damaging a wharf, two warehouses and a steamship. Leonard Smith, the warehouse supervisor, estimated the loss at \$3,000,000.

The charred body of Joseph Ryan, 46, merchant, who was listed as of New Orleans, was found aboard the steamship Scandia of the Dixie Mediterranean Steamship Company, which drifted into midstream after the flames had severed its moorings.

The injured, all visitors, were trapped aboard the ship. Mrs. Elizabeth Barton, 57, the only person seriously burned was taken from the craft by Seaman Charles Lunn, who gathered her in his arms, jumped overboard and swam to safety.

SAYS HOOVER WILL FAVOR NEW TARIFF

Senator Capper Thinks Independent Coalition Draft Will Meet Approval

Washington, March 3.—(AP)—Senator Capper, of Kansas, today indicated his belief that, in effect, the Democratic-Republican independent coalition is writing a tariff bill which will be agreeable to President Hoover.

While the Senate began what it was hoped would be the final week's work on the measure which has occupied it just six months next Saturday, Capper said in a radio address that "it is my belief that the Senate discussion and action will result in tariff rates in line with President Hoover's program, this in spite of the fact that those rates, in great part by political enemies of the President."

Characterizing Mr. Hoover's first year as President as a "year of fact finding," the Kansas Republican asserted that "the policies followed, the programs laid down and initiated, the actions taken by President Hoover so far, are along lines that will rebound to the best interests of the entire country in the long run."

"It seems to me," he said, "this first year of President Hoover's has been a year of fact finding; a year of work on data and blue prints; a year of foundation laying. These are the marks of the engineering mind of President Hoover."

Capper named six major national projects which he said the President had facing him on beginning his term; farm relief; law enforcement, including prohibition; limited tariff revision, inland waterways, preparation for an approaching economic crisis and promotion of world peace.

He praised Mr. Hoover's handling of the stock market crash as a "masterly piece of work," said that the Federal Farm Board "has helped the situation" and that the success or failure of the inland waterways program would be a later development.

"Capper expressed approval of the 'commission' idea and said he looked for recommendations of the law enforcement commission to be enacted. Good will come from the London naval conference, he added, "though perhaps not to the extent that many of us had hoped."

PRINCE WALES STRICKEN BY FEVER ATTACK

Heir to the English Throne May Be Forced to Abandon Hunting Trip in Africa

Nairobi, Kenya Colony, British East Africa, March 3.—(AP)—The Prince of Wales, heir to the British throne, is suffering from an attack of sub-tertian malaria, and has had to return here from South Kenya Colony where he was hunting and photographing elephants.

He was taken ill suddenly Saturday afternoon with chills fever after a hard day in the bush near Voi, where a fine herd of elephants had been reported. He returned immediately to Nairobi.

Sub-tertian malaria is a familiar and less malignant form of the tropical malarial disease group. Its principal characteristic is recurring fever and chills about every other day.

London, March 3.—(AP)—The Prince of Wales, who is ill in British East Africa with sub-tertian malaria, in the opinion of British court physicians, will find it necessary to abandon the remainder of his African trip, and to return to England as soon as he is able.

Sub-tertian malaria is considered here less severe than either of the two other forms of the disease. It was predicted here he would remain for a day an invalid at government house while the disease ran its course. After which he would get a fortnight's rest and permanently abandon his hunting tour as he did the previous time in 1928 as a consequence of his father's illness.

It was recalled here how Queen Mary, after seeing a film of African jungle life the other day, expressed her concern at her son's proximity to the big ferocious beasts, such as lions, elephants and rhinoceroses. It seemed here, however, that the misfortune which has overtaken the prince, actually was due to one of the smallest human enemies of the jungle—a mosquito.

Dismiss Appeal in S. C. Bond Case

WASHINGTON, March 3.—(AP)—The South Carolina State Highway commission scored a victory today in the proposed \$65,000,000 highway bond issue, when the Supreme Court dismissed the appeal of Clarence L. Johnson and other citizens of the state, brought to prevent the sale of bonds, holding that the appeal had failed to present a substantial federal question.

The bond issue, authorized by the Legislature, was attacked by Johnson and his associates who contended that under the state constitution the consent of the qualified voters of the state must first be obtained.

TOWN CLEANS UP FOLLOWING EARTHQUAKE

Considerable Damage at Brawley, California, After Six-Day Quake Siege

Brawley, Cal., March 2.—(AP)—Although its populace still was slightly nervous, Brawley went back to a business-as-usual basis today after cleaning up the debris left by a six-day siege of earthquakes.

Bricks that fell from the walls of buildings and glass which crashed to the sidewalks during the heaviest shocks were hauled out of town quickly. Supplies of glass also were rushed here from Los Angeles to repair the damage to store fronts.

The quakes began last Tuesday and were felt throughout Imperial valley, from Calexico, on the Mexican border, to Calipatria, near the Salton Sea. Wednesday, Thursday and Friday slight quivers were reported, some of them felt only in the northern end of the valley, the center of which is here.

On Saturday at 3:47 p. m., the first major shock was experienced. It was centered here. Three other major tremors visited the same area during the night, and yesterday, in their wake, several smaller ones occurred. The last at 2 p. m. Saturday's quakes were felt in Calexico, El Centro, Calipatria, Holtville, Imperial and Westmoreland. They damaged buildings in Brawley, shattered windows in Calipatria and in Holtville, and broke dishes in Westmoreland, but did no damage in the other cities.

City Engineer J. C. Farr said the structural damage here would approximate \$100,000. One two-story

apartment building virtually was wrecked and was condemned, and the walls of more than two-score other business structures were cracked. The shock in three cases broke pillars and shattered walls. Huge pillars at the high school were cracked.

Mrs. E. C. Durham sustained a fractured leg when a mass of bricks fell on her as she was walking down the street. A rancher was knocked unconscious by bricks falling through the top of his automobile, and a child was struck in the face by a piece of cornice. Other casualties were minor bruises.

Many hotel guests here spent sleepless hours Saturday night sitting in lobbies and interrupting card games to dash into the streets with each recurring shock. Residents, however, apparently unafraid in frame houses, adhered to their routine.

Kisses Hand of Negress in Haiti and Wins Favor

Port-Au-Prince, Haiti, March 3.—(AP)—William Allen White, newspaper publisher of Emporia, Kansas, and member of President Hoover's investigation commission here, has won the entire populace of this capital with an act of his last night.

While a parade of Haitian women passed before White, who was standing at the gate of the Hotel Excelsior, where the commission is residing, one of the women, an aged negress, dressed in black, stepped in front of him and said: "Please, Commissioner, deliver us."

As she spoke she bowed. White grasped her hand, bowed himself and then kissed her hand. For a

moment everyone was quiet. Then there was a roar of wild cheers. Cries of "Long live the commission" and "Long live President Hoover" were heard on all sides. Women leaders cried with happiness and said the Emporia man's act was one of the greatest gestures of friendship the Hoover group could have made toward Haiti.

Previously members of the investigation commission had prevented an interruption by the National Guard, of a demonstration which the Haitians wished to stage in protest at the American occupation and an expression of hope for restoration of self government.

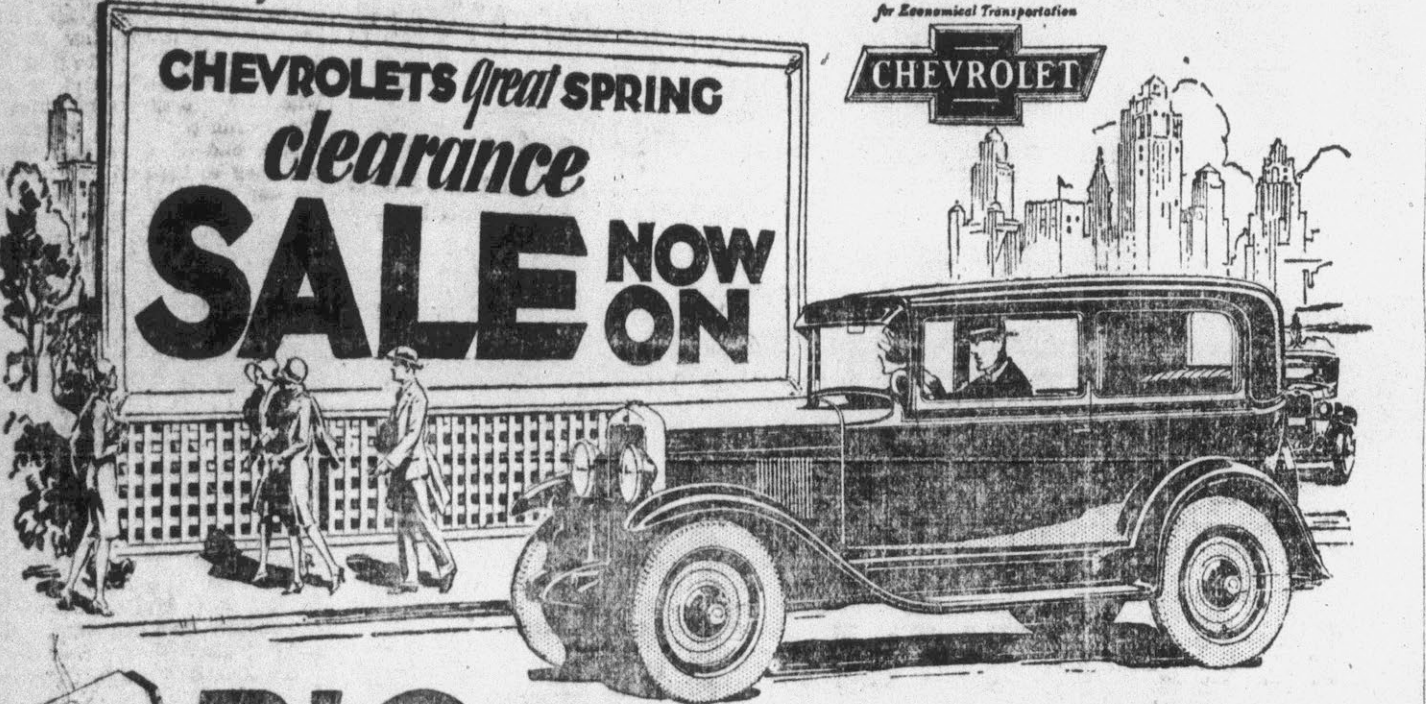

Two Buildings Wrecked by Fire At Lincolnton

Lincolnton, March 3.—(AP)—Two brick buildings which housed four stores in the heart of Lincolnton's business section were in ruins today from a fire which caused property damage of \$125,000.

The buildings destroyed were owned by E. C. Baker and W. E. Crigg. Each was valued at \$33,000 and was partially covered by insurance.

The stores located in the buildings were the Square Store, the Shoe Store and Day Mow, a women's shop, all operated by Karch Enterprises, Inc., and the Lincolnton Furniture & Undertaking Company. H. Karch and I. M. Karch estimated the loss of goods in their stores at \$40,000 with \$25,000 insurance. The loss to the furniture concern was estimated at \$5,000, covered by insurance.

Slight damage was also done to Lander Hardware store and the Lincolnton Drug Company, adjoining the buildings burned.

The origin of the fire has not been determined. It was first discovered on the second floor of the Square Store at nine o'clock yesterday morning. Firemen received assistance from the Hickory, Cherryville and Gastonia departments in fighting the blaze.

Fireman Whitfield Tobey, of Lincolnton, was injured slightly when struck on the head by a concrete block when a sustaining wall of one of the buildings fell.

as the present unconstitutional system remains Pender, for example, will be overtaken and Forsyth will be undertaken. The system should be financed by a uniform tax on all property in the State and from other sources to be provided.

3. The State Highway Department should have control and direction of every road in the State, hardsurfaced and other, lateral as well as State, and the Legislature should provide the money for such complete care for all the roads from Murphy to Manteo without any tax on real or personal property.

4. Reduction of expenses, drastic reduction in State, county and city governments in every branch. In the inflation period extravagance crept in. Instead of reduction, there has been in most departments an increase in officials and an increase in compensation. Individuals have been forced recently to economize. Governmental agencies must do likewise.

These are the four steps to be taken if taxes are to be reduced on home-owners and factory-owners and store owners and farm owners. Unless the State legislators are ready to pass measures to bring about these three fundamental reforms, all their talk about "favoring reduction of taxes on real estate" will result in no relief. Advocacy of reduction of the assessment of lands, wherever the income does not justify the present assessment, is all right so far as it goes. But it does not go to the root of the matter and at the best is but applying a broad poultice where surgery is needed.

Here are the three necessary steps:

1. Reach property now untaxed and secure new sources of revenue.
2. Provide the money for an eight months uniform public school by a uniform tax on property in every county in the State on a uniform State directed assessment of property supplemented by funds from other sources.
3. Put all public roads under the State Highway Commission and provide the funds from gasoline and other sources, relieving property from all road tax, for State highways and lateral roads. It will be well to use convicts largely in the program.
4. Cut expenses and cut deeply.

THE ONLY WAY TO TAX RELIEF

The taxing of property now untaxed, the finding of new sources of revenue, the operation of the schools by the state, the taking over of all roads in the state by the state and definite cuts in expenses all along the line are set forth by the News and Observer as the only way to bring about a just system of taxation in our state and any real relief to the present overburdened landowners. The constitutional duty of the legislature along this line is certainly plain and clear-cut, and it is to be hoped that with an election in the offing citizens generally, throughout the state will see to it that the next session of the General Assembly is composed of men who will see their duty and do it. Only in this way can we hope to gain any tax relief.

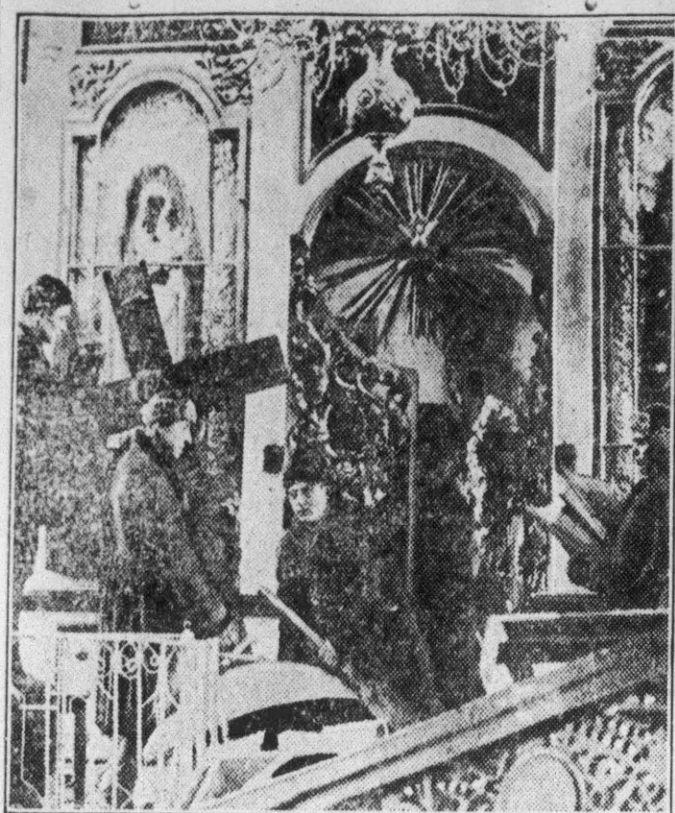
Under the heading, "The Road to Tax Relief," the Observer says:

The road to tax relief is as plain as a pike-staff. It was urged during the last session of the Legislature and before that but fell on deaf ears as to its full acceptance. The increase in the gasoline tax and using it as a measure of local tax reduction was a step in the tax reduction. It was an excellent palliative and has in most counties resulted in reduction in taxation. It was not supposed to be more than partial relief. Because some counties have not followed the line marked out by Governor Gardner, the full benefits intended have not been obtained.

The real program of relief must embrace four things:

1. Securing the taxation of the millions of dollars of intangibles now escaping all taxation, increasing the income tax, and tax on public service corporations earning big money, and finding new sources of taxation such as the same sort of sales tax on luxuries as is now imposed on gasoline, fertilizer, etc.
2. Obeying the plain mandate of the Constitution by a State system of schools. In his very excellent and thoughtful article in Sunday's News and Observer, LARRY I. MOORE, a leader of the New Bern bar—calls attention to the fact that Section Two of Article Nine of the Constitution directs "The General Assembly at its first session under this constitution shall provide by taxation or otherwise for a general and uniform system of public schools." Instead of obeying the Constitution and giving "a general and uniform system of public schools," the Legislature does nothing but direct each county to have a six months school out of revenues it collects, and then gives additional sums by way of largesses to help equalize the terms. It is the duty of the Legislature to levy and collect enough school tax to carry on the schools for a uniform term. At present some poor county levies a 32 cent tax on lands assessed at more than its value to give its children a six months school while a rich county on assessments ridiculously low levels a thirty cent tax to give its children an eight months school. The spirit and letter of the Constitution will never be carried out until all property is assessed uniformly at its true value and a uniform tax levied for a uniform school term. It should be for eight months, and then if any county or district or city wishes a longer term it should be authorized to do so by increasing its taxation. The basis of this uniform system must rest upon a State Equalization Board to see that property in Forsyth and Durham counties, for example, are assessed at their value, something which is not now done. Mr. Moore has put his hand on the very weak spot of the tax burden. As long

Alabama, the only team to finish the Dixie campaign with a perfect record, had tough sledding to nose out Georgia's powerful Bulldogs in their game Saturday night. The Georgians led at the half 15 to 11 but the Crimson basketballers put on steam in the final minutes to eke out a slim 29 to 26 verdict.

Kentucky had its hands full with Sewanee during the first half of their contest but rapidly pulled away in the last period to double the score on the Mountaineers, 44 to 22.

In the second upset of the tournament Tennessee's Vols handed the Washington and Lee Generals, favored to reach the finals, a nice licking. It marked the second time in as many years that the Lexington cagers had been eliminated in the early rounds after having been picked as one of the outstanding teams of the circuit.

Although outscored by Georgia Tech in the final half, Duke's early lead proved sufficient to give them a 44 to 35 win over the Jackets.

The battle between Duke and Kentucky tonight is forecast to be one of the closest of the tournament. The Blue Devils offer the fastest offense of any team entered but their defense is lacking. The Durham boys evidently place all their faith in their high scoring power.

SPORTS SLANTS

The business of steaming up the Sharkey-Scott fight show in Florida this year not only met with a flock of obstacles but it has raised some question as to just how long the winter fisticuffs may be promoted in the resort area.

Anything may go over when a boom is on but the folks in Florida have had their minds on business for some time and the visitors find a variety of pursuits and pleasures well organized for their benefit. Boxing is not conspicuous among them. Racing, tennis, golf, the surf and quieter, less strenuous or exciting pastimes claim the attention of most of those who go South for their health, for fun or for variety.

It takes a big spectacle to command state-wide interest. Florida's make-up is so complex, its interests so varied that it is difficult to draw the crowds to any one spot or event. Miami may continue to furnish an ideal battleground for at least one important heavyweight circus each year but neither Scott nor Sharkey brought in the fistic appeal to make the prospect much brighter.

The Dixie die-hards among the legions at St. Petersburg, though not so young as he used to be, could have beaten either of the main bout participants.

Aside from Miami, Tampa and Jacksonville are the best Florida locations for professional sports. Both are good "fight towns." Jacksonville expects to see a revival of horse-racing there on a substantial basis by 1931, thereby sharing some of the popularity gained by Miami's track, Hialeah. Tampa is not so enthusiastic about the sport, perhaps for the reason that opposition to horse-racing, or specifically, the gambling feature of it, is more pronounced on the west coast than on the east. STOCK MARKET

By STANLEY W. PRISONIL, (Associated Press Financial Editor) New York, March 3.—(AP)—A sharp struggle for control of the price movement between opposing speculative forces brought about widespread irregularity of price movement in today's market.

A sprinkling of public utilities, chemicals, tobaccos and specialties were pushed up to new high levels for the year, while selling pressures brought about rather sharp recessions in a number of steel, motor and railroad shares.

Liquidation of stocks was inspired, in part, by the decline in wheat prices, the reported falling off in steel mill operations, and the slow-down in the recovery of many important lines of business. Some selling also came into the market on theory that the recent rapid advance in many issues had impaired their technical position, and that a corrective reaction was due.

Secretary of Commerce Lamont said he expected good business within two months. The National City and some of the other monthly bank reviews stressed the irregularities in business, and pointed out that practically all indexes of production and trade were running much below a year ago. Directors of the Warner-Quinn company cut the quarterly dividends in half, placing the stock on a \$1 annual basis.

The American Telephone & Telegraph company led a list of corporations which reported 1929 earnings in excess of those of the previous year. Call money renewed at 4 per cent and was in plentiful supply at that figure. Time money rates were unchanged, but an easier undertone was reported in the market.

Columbian carbon was an outstanding strong spot, soaring nearly 7 points to 185 3/4, which duplicates the year's high. U. S. Industrial Alcohol ran up 4 3/8 points to 43. Diamond Match 4, and Air Reduction, Warren Bros., and Brooklyn Union Gas, 3 each, the last three touching new highs for the year.

Atchison was marked up 3 3/4 points and New York Central and Delaware & Hudson 2 each, but Pittsburgh & West Virginia dropped 6 1/2 and Hocking Valley 4, U.

S. Steel common sold down more than 3 points to 180 3/4. Auburn auto dropped 5 1/4 points and Eastern Aircraft 3 each, but partial recoveries were made from the low levels. Nash Motors sold below 50 for the first time this year.

GRAFT PROBE CONTINUED AT ATLANTA, GA.

Indictments Against Twenty City Officials Termed "Peanut Charges"

Atlanta, March 3.—(AP)—Indictments against twenty persons, including six councilmen and the city clerk, the first since the city was freed from a four-month-old industry termed "graft" charges, were announced today in announcing a continuation of a grand jury investigation into alleged graft in the municipal government.

While the accused persons, two of them women, issued vigorous denials of guilt, Solicitor General John A. Boykin said "the big ones are what we are just getting into," and a new grand jury was summoned for organization.

Cases against Councilman Harry York, indicted on six bribery counts and Jack White, business partner of York's, facing similar charges, have been set for trial March 17 as the first to be heard. The case against City Clerk Walter Taylor, indicted on 16 bribery counts, and described as "the pay-off man" by the grand jury, is to be set for trial today.

Taylor through his attorney, denied all of the charges and York said the indictments represented "simply another attack on the present representative Democratic form of government that has made Atlanta the greatest city in the south."

White also denied the charges and said the indictments were "unfair." Mrs. J. E. Andrews, a civic worker, indicted for libel, said she would refuse to make the bond of \$500 fixed for her.

Mrs. Andrews in a statement said: "The public was encouraged to give information which they possessed to the grand jury with the promise of immunity from any conditions that may follow. I gave information which was correct and was called a dirty liar by John A. Boykin (the solicitor). If my relatives and friends will regard my wishes there will be no bonds posted for me."

Mrs. J. R. Wakefield, editor of the Georgia Women's World, indicted with Mrs. Andrews for the publication of allegedly libelous statements against Solicitor Boykin in a statement said: "I am indicted for attacking the corrupt Fulton county political ring. There is no less majestic in attacking a corrupt boss."

Mayor L. B. Ragdale, criticized by the grand jury for the use of city tractors, men and materials on his private lands, is in St. Louis, but he said "here last night he would return immediately and issue a statement."

BIG MARATHON DANCE CAUSES STR IN MICH.

State Commission to Attempt to Stop Dance in Progress for 106 Days

Detroit, March 3.—(AP)—A marathon dance which has been going on for more than 106 days at Eastwood park, East Detroit, appeared about to end today with the state commissioner of labor and industry moving to stop it after local and county authorities failed to interfere.

The marathon, which according to witnesses, rivals the most savage dances of primitive peoples, has gone on uninterrupted since last November 18.

Several pastors of the district attacked the marathon dance in their Sunday sermons. The Rev. Roland Travers of the Mount Clemens Baptist church, who has been warring a campaign against the dance, referred to it Sunday as "in many ways, the saddest, most heart-breaking affair I have ever attended."

"It was not a funeral service over a dead body, but far worse," he declared. "It was the slow death of the physical, mental and spiritual natures of nearly a dozen young people."

Spectators have been attracted to Eastwood park by morbid curiosity. Wild scenes have been enacted as the contestants dropped exhausted to the floor. The spectacle of a young person foaming at the mouth or becoming suddenly rigid and apparently lifeless has not been uncommon.

Stella F. McLeod, investigator for the State Labor Commission, described the marathon as "an uncivilized exhibition a million years removed from the modern concept of the dance as a form of personal amusement or aesthetic expression."

She spoke of contestants as being in "the last stages of mental and physical exhaustion."

When the marathon started last fall the dancers were all allowed 20 minutes of each hour for rest. This rest period has been shortened to 10 minutes and now is being shortened one minute each day. Only five couples have been able to continue through the winter. The partners take turns sleeping. A young woman carrying a man about the room while he sleeps is part of the show.

Board to Select Chase Successor During Tuesday

RALEIGH, March 3.—(AP)—The board of trustees of the University of North Carolina will assemble here tomorrow in the offices of Gov. C. Max Gardner to consider selection of a successor to President Harry W. Chase, resigned.

It is not known whether the majority of the board favors immediate naming of a president of the University, or whether a sub-committee to investigate possible selections will be named.

R. D. W. Connor of the University faculty; Herman Glenn Baily, of the faculty; Dr. B. R. Lacy, president of Union Theological Seminary, Richmond, Va.; Dr. William E. Dodd, of the faculty of the University of Chicago; Chief Justice W. P. Stacy and Associate Justice Wilbur P. Proctor, as well as others, have been included in possible nominations for the presidency.

Dr. Chase resigned recently to accept the presidency of the University of Illinois. He served the University 10 years. At the time that he was elected his selection came after a sub-committee of the board had investigated the qualifications of a number of men considered for the position.

Attempt to Plug Gap in Covenant Outlawing Wars

GENEVA, SWITZ., March 3.—(AP)—Attempting to plug a gap in the covenant of the League of Nations to make war impossible, the committee of jurists now at work on this problem today found itself deep in discussion of the attitude of the United States.

The committee was considering proposals that if the council should be unable to reach a unanimous opinion as a measure for the settlement of an international dispute, the questions should be submitted to the world court, for an advisory opinion.

Dr. Von Buelow, German representative, pointed out that under recently advanced protocol for the adhesion of the United States to the court, it was provided that questions affecting the interests of the United States should not be made the subject of an advisory opinion without the United States' consent.

BRIDE KILLED IN AUTO CRASH NEAR DANVILLE

Burlington, March 3.—(AP)—A 19-year-old girl, en route to her wedding, was killed and five members of the wedding party including the groom-to-be, were injured near Danville, Va., today when their automobile left the highway and plunged down an embankment.

The dead girl is Miss "Hallie Cheek" of Burlington.

The wedding was to have been in Danville and the party was making haste to reach the Virginia city. Approximately 25 miles from Burlington, the automobile which was traveling at a high rate of speed failed to take a curve and plunged down the embankment.

All the members of the party, with the exception of Slim Henderson driver of the automobile, are in a Danville hospital. The others injured are Harnden Willis, the prospective groom; Miss Ellen Cheek, sister of the dead girl; Miss Evelyn Willis, sister of the groom-to-be; and Sedrick Matthews, a friend. All are from Burlington.

Taft Continues to Improve
Washington, March 3.—(AP)—Unless the condition of William Howard Taft undergoes some sudden change due to the arteriosclerosis from which he has been suffering, Dr. Francis R. Hagner said today, "his span of life is undetermined."

Visiting his distinguished patient earlier than usual, Dr. Hagner said Mr. Taft's condition has improved from the critical stage of a few days ago.

The official bulletin issued by Dr. Hagner and Dr. Thomas A. Clayton, said:

"The former Chief Justice has had a good night. He continues to take some nourishment. A few days ago his condition was very critical but he has slightly improved and unless some further change occurs due to the arteriosclerosis, his span of life is undetermined."

Kings Mountain, N. C.—(AP)—Harvey Jackson, 40, Kings Mountain, was instantly killed in an automobile wreck here. He attempted to seize the steering wheel, causing the crash.

Asheville, N. C.—(AP)—Two street cars collided here, injuring four women passengers.
