THE PRICE OF VOTES FOR SUGAR

In the end the taxpayer and the consumer always is the one who has to do the paying and especially is this true when it comes to the practice of swapping votes, commonly known as log-rolling, within any legislative and lawmaking body.

Discussing the recent vote in the United States Senate on the sugar tariff and declaring that this action will add millions to the cost of living in America, the New York World says:

"No one will be so naive as to believe that the nine Senators who voted against an increase in the sugar tariff on Jan. 16 and then reversed their position and voted for an increase on March 5, were swayed by the intellectual appeal of the protectionist arguments of the Republican Old Guard. Each and everyone of them got something in return for his flop. He would have been an arrant fool if he didn't get something for in switching his vote he ran considerable risk of incurring the resentment of a large body of consumers among his constituency, and he needed to gain some special favor for his section in order to counteract this resentment.

"There were five Democrats among those who executed this about-face on the sugar duty. To what blandishments of the Old Guard did they yield? The circumstantial evidence is very strong. Senator Dill of Washington was one of the deserters. He is keen for a tariff on lumber and shingles. Senator Thomas of Oklahoma is another. He is laboring day and night for a duty on petroleum, of which his State is a leading producer. Senators Ashurst and Hayden of Arizona were two other Democratic deserters. They have recently joined forces with the Senators seeking to impose a duty on lumber, and during the current week they have obtained a duty of 7 cents on long-staple cotton, of which their State produces a small amount. Finally, there is Senator Trammell of Florida. This week, with the help of the Old Guard, the Florida Senators have succeeded in retaining the present limitations on the importation of cigars in small quantities—a restriction which President Coolidge strongly urged Congress to repeal, and which has caused the Cuban government to discontinue its parcel-post agreement with the United States. Flor-

ida is a cigar-making State. "The Democratic votes for a higher sugar duty appear, then, to be far from an outright gift to the beet-sugar industry. The same is true of the Republican votes which were changed on this latest test. Senator Jones of Washington, one of the backsliders, has an eye on a lumber tariff; Senator Pine of Oklahoma, another of them, hopes to obtain a duty on crude oil. And so it goes. There has been some very effective log-rolling, and it has played havoc with the Senate coalition. What the new alignment has accomplished will cost consumers many millions, and they will be lucky indeed if still more millions are not added to their living costs before the log-rolling combination has finished with the Tariff Bill."

ROBINS SIGN AN ARMISTICE AND GET BUSY

Associated Press Sports Editor Clearwater, Fla., March 8.—The signing of an armistice along the Brooklyn baseball battle front, has furnished new life and enthusiasm for 37-year-old Uncle Wilbert Robison and his flock.

It remains to be seen whether the Robins fly higher this year than sixth place, something they have been unable to do since they were pennant contenders in 1924. There are sufficient problems and worries in the squad to make any manager but jovial Uncle Robbie lost weight. Brooklyn has an outfit that may be a sensation, as the Phillies were last year, or it may again be a flop. It has exceptional batting strength and promising young blood, pitching greatness even if only Dazzy Vance and Watson Clark are in form—and it has a new spirit, engendered by Robbie's infectious enthusiasm.

On the other hand, the jinx of physical ailments that ruined the club's chances last year has not entirely disappeared. The throwing arm of Glenn Wright, former Pirate shortstop has improved but is still a question mark. Del Bissonette, slugging first sacker, is not in condition, due to long illness and a crop of boils. The pitrohrs have developed spring wildness. Babe Herman, the club's leading batsman of 1929, has been a holdout.

There are "ifs" to almost every angle of the club's organization but Uncle Robbie has not the slightest doubt he will solve the existing problems.

The most interesting prospect is the sensational bid for regular jobs of Keystone youngsters, Neal Finn and Gordon Slade, purchased for around \$60,000 from the Missions of the Pacific Coast league. Finn is a second baseman and Slade a shortstop. They have come east with reputations on a par with that of Lary and Reese, the Oakland pair bought by the Yankees. They have class and color in action. If they make good this year, Brooklyn's long-standing Keystone worries may be settled for some time to come. Wright, whose arm has met early tests and Jake Flowers, will start as the Keystone combination but Slade and Finn will see action.

SPORTS SLANTS

Associated Press Sports Editor Two of the greatest pitchers of the last two decades come to the cross-roads this year, where either may strike another good year or hit the trail that leads to oblivion.

No names have been more illustrious in the flinging fraternity than Herbert Pennock and Grover Cleveland Alexander. Pennock, one of the greatest southpaws of all time, has never been defeated in world's series competition. Alexander, who ranks with Johnson, Matthewson, Walsh and Young among the foremost right-handers of all time, has studied his career with come-backs and sensational performances.

Pennock was not of much service to the Yankees last year. Neuritis made his pitching arm virtually useless and it is a question whether it will respond to workouts this spring. If not, he probably will retire, for Pennock is comfortably fixed after nearly 20 years of major league service and needs seek no minor league occupation.

Alexander, back with the Phillies after a dozen years in the West with the Cubs and Cardinals, showed signs of slipping again last year, although the manager to score enough victories to put him ahead of Matthewson's National league record of 372. "Old Pete" has traveled a rough and boisterous pathway, which has been anything but the well known straight and narrow. Alex's convivial spirit has often been his undoing but his great right arm has kept strength and control for a long time. He was thought to be through when the Cubs sold him down the river to St. Louis and most everyone knows how big a part he played in helping the Cardinals win two pennants.

Sam Breadon, St. Louis club owner, thinks Alex has at least one more good season in his arm and looks for the change of scenery to benefit him. The Phillies will welcome any contributions the veteran can make to the winning column.

It is worth noting how successful many of the famous old time batteries of baseball have become. Alexander's former backstop, Bill Killefer, with whom he was sold to the Cubs, now is managing the St. Louis Browns.

The noted Washington battery of pre-war days, Johnson and Street, also has joined the managerial ranks. Barney is starting his second year at the helm of his old club, the Senators, while Gabby Street

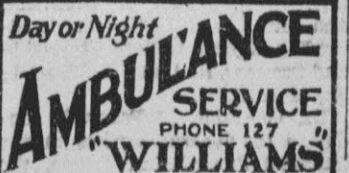

## Gives Record of 1929 High School Class in College

Of the seventy pupils who graduated from Greenville High School last spring forty-four went to college. While this number going to college is 62.4 per cent of the graduating class, it is only 9.4 per cent of the enrollment of the high school, and approximately 27 per cent of the number in that class when they were freshmen.

The scholastic reports of the standing of these 44 students are now in the high school office and the following figures are compiled from them.

### COTTON MARKET

New York, March 8.—(AP)—Cotton opened steady at a decline of 6 to 19 points today on over night selling orders which seemed to have been brought in by the break of yesterday and more or less general selling or liquidation. Houses with both Liverpool and Continental connections were among the sellers on the decline, which extended to 14.22 for May and 14.52 for October, making net declines of about 10 to 13 points on the more active months.

The new October contract was relatively easy, selling off to 14.26 compared with 14.55 at the close yesterday. There was considerable covering and some trade buying at the decline, while there may have been a little buying for a week-end rally, but prices were within a few points of the lowest at the end of the first half hour. Liverpool was relatively steady.

Cable advises said general liquidation had been absorbed by trade calling and covering in that market but that there was only a small turnover in cloths and that yarns were pressed for sale.

### STOCK MARKET

New York, March 8.—(AP)—The recovery in stock prices during the past week, which has lifted the general index of 90 issues to the highest levels since the November break, showed signs of slowing up in today's brief session of the market under the weight of heavy profit-taking and occasional short selling.

Scores of issues were marked 1 to 6 points in today's early trading, and J. I. Case ran up more than 14 points, but the gains were cut down by realizing, and a rather long list of issues sold 1 to 3 points below yesterday's final quotations.

The Timken Roller Bearing Company, showed slightly larger earnings for 1929 than the year before but the Barnett Leather and Homestake Mining Companies made unfavorable comparisons with the previous year.

The closing was irregular. Total sales approximated 1,800,000 shares.

### Woman Sent To Jail For Assault On Stenographer

Clarksdale, Miss., March 8.—(AP)—Convicted of simple assault for an encounter with her husband's stenographer, Mrs. K. A. Carney, 53, today was under sentence of three months in jail and a \$500 fine.

Mrs. Carney was tried on a charge of assault and battery with intent to kill Miss Mac Ross, 22.

"You have been tried by fair and impartial jury which heard your statements and those of Miss Ross and weighed them carefully," Judge W. A. Alcorn told Mrs. Carney. "Owing to the fact that this was a most aggravated assault it will be the duty of the court to sentence you to three months in the Coahoma county jail and impose a \$500 fine."

The incident which resulted in the charge against Mrs. Carney occurred on the night of February 11, last. According to the testimony given by Mrs. Carney she followed an automobile in which her husband, an attorney, and Miss Ross, were riding into the county and saw Miss Ross disembark at her home. When she questioned the young woman, Mrs. Carney said, Miss Ross cursed her and "I slapped her several times with the back of my hand." Miss Ross suffered a broken nose and other facial injuries.

Miss Ross said Mrs. Carney would not permit her to explain the automobile ride, "that each time I tried to explain she called me a dirty liar and struck me in the face."

She said that Carney had called at her home ostensibly to take her to the office to do some stenographic work but instead drove out on the highway, that she protested and he finally drove her home.

### Trial Marriage Goes to Rocks

Chicago, March 8.—(AP)—Marriage of two University of Chicago students in which they signed a contract agreeing to restricted social and economic claims on each other has collapsed.

The breakdown of the unusual pact signed by Leo Dolan, and Virginia Roth, before their marriage in September, 1928, was aired in superior court where Dolan lost an alienation of affections suit against his father-in-law.

The agreement, introduced as evidence in the trial, and entered into an attempt to "foster and preserve the great love which now exists," evidently fell far short of that mark. At the end of the trial Dolan told the court he was not really after the money (he sued for \$50,000) and merely wanted his wife back, but the young woman refused to speak to him and left the courtroom on the arm of her father.

Judge Michael L. McKinley, in directing the jury to return a verdict of "not guilty," said it was "the most outrageous contract I have ever heard of." He called it a "mere companionate marriage," by which you assume all of the benefits and none of the duties of a husband.

Dolan denied it was a companionate marriage and insisted everything would have worked out all right if his father-in-law, Edgar Roth, architect had not interfered.

The contract provided that Dolan was not to support his wife until 1933 when both should have finished their university courses. Each one promised not to interfere with the other's career, attendance on a career and they were both given the right to forbid social relations with other persons.

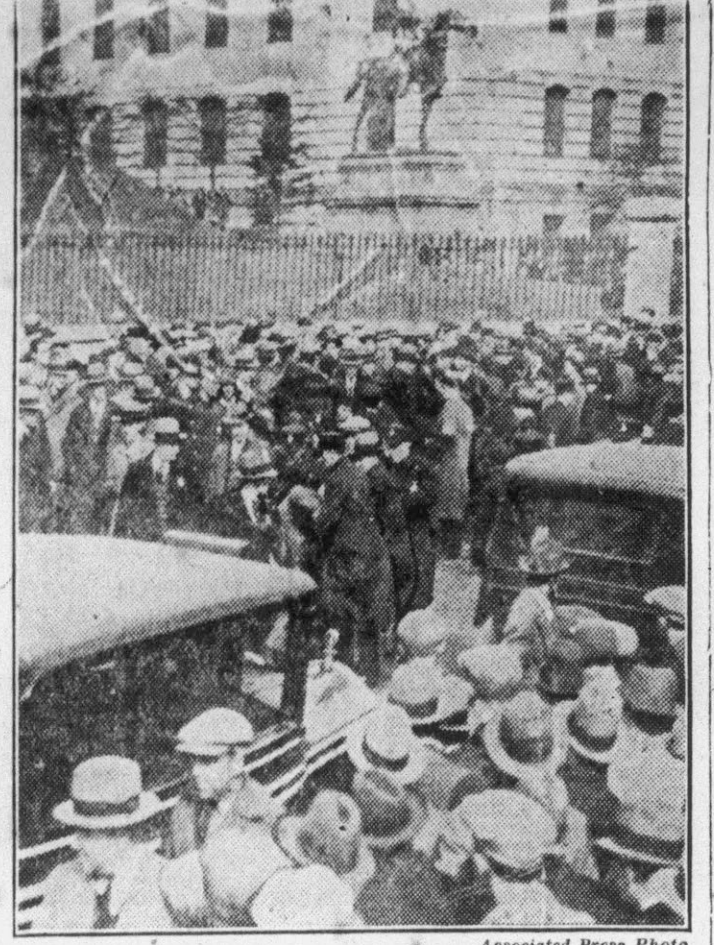

Sallbury, N. C., March 8.—(AP)—Captured heavily-armed at a negro house in Davie county, Bill Saunders, about 22, said to be from Pittsburgh, Pa., and Fred Rouse, 27, of Concord, N. 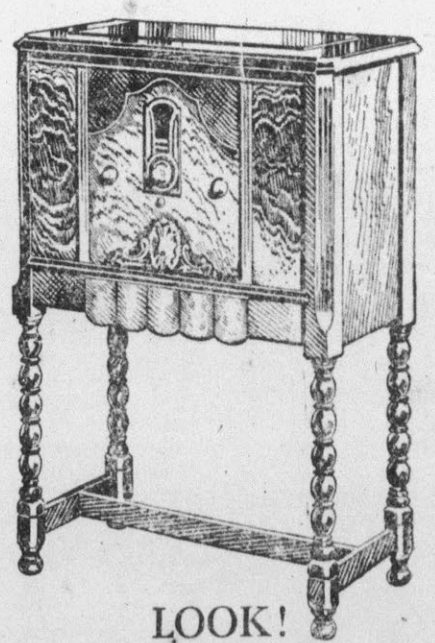
