

America Declines To Enter Security Pact At London Conference

Delegation Takes Important Stand That It Cannot Participate Even In A Consultative Capacity In Any Security Pact Which Would Be A Quid Pro Quo For Reduction Of French Naval Claims

London, March 11.—(AP).—The American naval delegation, it was stated in authoritative quarters, is taking the important stand that it cannot participate even in a consultative capacity in any security pact which would be a quid pro quo for reduction of French naval claims.

It was said that perhaps there would be no objection to a consultative pact as such but that there would be grave objection to entering one at this juncture as an inducement to France to reduce her naval figures.

America, it was understood, is not prepared to enter any agreement under which France later might feel she was entitled to ask the United States as a moral obligation to give material assistance in the event that France were the object of war-like aggression.

The position was said to be this: France originally asked Great Britain to give her guarantees under which Great Britain would furnish material assistance in the event that France were attacked. In exchange France would cut her naval claims. Great Britain declined such a commitment, now France suggests as a substitute a more comprehensive pact which might embrace the United States in a consultative capacity.

London, March 11.—(AP).—The French and British naval experts at the James Palace today were making a careful and minute study of the crucial French naval tonnage claims. Progress to the extent of agreeing on a tentative set of figures as a basis for further argument was achieved.

The French and British navies were ranged side by side and the comparative needs of each was discussed. The problem was being attacked after this fashion in general: "You say you need so much tonnage in this class. Just why do you need it? Is it not a fact that you could do with less?"

It was said that by a process similar to this the British and Americans were able to get their figures down and that the same tactics also had been applied to the American and Japanese problems.

The big five leaders plan to meet at the House of Commons this afternoon to continue their discussion of the French position with the results of the experts' meeting before that. It was understood that the chief delegates probably would go forward into the political aspects of the situation; that is France's demand for a pact of guarantee against aggression.

Hoover Lauds Record Of Taft Before Scouts

Washington, March 11.—(AP).—William Howard Taft's solicitude for youth and children is seen by President Hoover as urging on the Boy Scout movement and instrumentalities working for the betterment of the boys and girls of the land.

On the eve of the funeral of the first honorary president of the Boy Scouts, the Chief Executive last night departed from a prepared address before the banquet signaling the twentieth anniversary of the Scout movement to eulogize the late former President and Chief Justice.

"We meet this evening," President Hoover said, "under a cloud of deep sadness. Since many of you started your journey to America has passed into the great beyond, and in determining not to cancel this occasion your committee has acted in the spirit of William Howard Taft. With a lifelong open hearted devotion to boys, the first honorary president of the Boy Scouts, would have known of it, insisted that your work should go forward.

"This occasion commemorates the twentieth anniversary of the Boy Scouts, and it is indeed in keeping with the true spirit of this great spirit whose name graced your first anniversary."

The boy, with his sister, the President said, is the most precious possession of the American home, "the problem of our times and the hope of the nation."

CHAIN STORE TAX CASE IN HIGH COURT

Supreme Court Recessed Until Noon Today Out Of Respect For Taft

Raleigh, March 11.—(AP).—The State Supreme court this afternoon and tomorrow, as fast as the cases could be disposed of, was to hear appeals in the "chain store tax" suit, in an appeal from a conviction for a post-dated check and an appeal from a stock license tax imposed by the Secretary of State.

The case of the State against Crawford presented the question on post-dated checks.

The chain store case, brought by 16 chain store operators in North Carolina, was decided in favor of the State by Judge R. A. Nunn in Wake Superior court.

The suit is to test the constitutionality of the section of laws of 1929 which taxes operators of two or more stores \$50 for each store. In the appeal of James A. Hartness, Secretary of State, and Nath. O'Berry, treasurer, from a Wake county court verdict ordering a refund to the Carolina Coach Company, the question of the right of the State to impose the stock fee on authorized capital stock of a corporation resulting from the merger of the two already incorporated firms who have paid tax on a stock is involved. The Wake county court held that the company did not have to pay the tax in case of merger.

Escaped Convicts To Be Returned To Prison At Raleigh

Raleigh, March 11.—(AP).—The North Carolina Supreme court recessed its regular Tuesday session for hearing appeals from 10 o'clock until noon today out of respect to William Howard Taft, whose funeral was held in Washington today. Flags on all State buildings were at half mast today in honor of the former President and Chief Justice.

Triplets Born To Couple In Wayne; Father A Cripple

Goldboro, March 11.—(AP).—The Stork visited the home of Mr. and Mrs. Ruffin Hooks of this county yesterday and in one sweep increased the number of the family by three.

The triplets, two boys and a girl, bring the number of children born to the Hooks in the last five years to seven.

Mrs. Hooks is 21 years of age and was married when she was sixteen. The father is a cripple and unable to walk.

BYRD TALKS TO AMERICA OVER RADIO

Famous Commander Responds To Och's Greeting From New Zealand

New York, March 11.—From more than 10,000 miles away Admiral Richard E. Byrd greeted America by radio today as a nation listened. He spoke from Dunedin, New Zealand, his first stop on his homeward journey from the South Polar regions.

The explorers' hello to America was in response to a welcome back to civilization by Adolph S. Och, publisher of the New York Times. His replies were barely distinguishable in a barrage of static and other forms of interference.

It was Wednesday morning in Dunedin, shortly after 12:30 when Byrd responded to Mr. Och's greetings, at the receiving end in the United States, it was 7:30 Tuesday morning.

The voice of Admiral Byrd was brought to the United States over the most elaborate hookup of radio circuits ever attempted.

Greetings also were given Admiral Byrd by Paul Saltsbury, vice-president of the Times; Martin P. Price, general manager of broadcasting of the General Electric Company of Schenectady, and Clyde Wagner, a General Electric engineer.

Admiral Byrd responded to each speaker with a "hello" that came through clear enough to be heard, but most of the other things he said were drowned out either by static, fading, or music interference.

This two-way conversation, with listeners all over the country permitted to eavesdrop through the chain broadcast, was made possible by the co-operation of the General Electric broadcast and shortwave stations at Schenectady.

The voices from New Zealand were brought to America over one of the longest radio network combinations ever used. Three transmitters, miles of land wires and a connection by submarine cables made up the principal part of the hookup.

Admiral Byrd was in the studio of 4YA at Dunedin, his voice went over 500 miles of cable and 1000 miles to Wellington, where station 2YA sent them on a 420 meter wavelength to Sydney. It was this gap using a broadcast channel which was believed to have been responsible for most of the interference.

From Sydney the explorer's voice made the long jump from Australia to Schenectady. Short wave station VK2ME of the Amalgamated Wireless Australia, Ltd., sent the signals out on 28.5 meters.

At Schenectady, the short wave signals were cut into the broadcast transmitter of WGY as well as the national wide network of the NBC chain.

The American side of the conversation went direct to Dunedin through the medium of WGXAF on 148 meters without a relay. Mr. Och and the others spoke from a little farm house in Glenview Hills, about ten miles northeast of Schenectady. Transmitting and receiving apparatus was installed in a bedroom, with a sloping ceiling. The house is occupied by some of the General Electric experimenters.

Attend Funeral Of Beer Gangster

Chicago, March 11.—(AP).—Three gang leaders boasted of their "big business" ventures to Chief of Detectives John Stege yesterday.

First there was Joe Salis, known for years as the Beer Baron of the South Side, who came down from his Wisconsin country place to attend the funeral today of his friend and henchman, John (Dingbat) Obera, slain on a gang ride last week.

Between his tearful pleas to the detective chief to "call off the cops" while he attended the past rites of his friend, Salis found time to tell the chief and reporters of his \$100,000 country place in Wisconsin "with a golf course and a club house to accommodate 26 people."

Grand Jury Asks Indictments For College Hazers

Raleigh, March 11.—(AP).—Grand jury requests that the solicitor draw indictments against seven former North Carolina State college students charging them with "unlawful hazing" were on docket today in Wake county superior court.

The grand jury presentments were placed on docket yesterday, signed by Grand Jury Foreman P. D. Thomas. Solicitor L. S. Brasfield said he would send the requested bills of indictment to the grand jury tomorrow.

All seven of the students named in the grand jury presentments were recently expelled from the college following a reported outbreak of hazing. Their names are: R. L. Smith, Greensboro; J. A. Ramsey, Salisbury; J. M. Leroy, Jr., Elizabeth City; H. W. Clark, Eufala; W. Jerry Moore, Harmony, accused of beating a sophomore, C. D. Kennenberger, Jr., of Greensboro, and cutting his hair.

A. T. Campbell and J. E. Lassiter, Greensboro, charged, along with the other five, with cutting the hair of two freshmen, L. A. Massengill and R. C. Pleasant.

Republicans Seek Repeal Of Dry Laws

New York, March 11.—(AP).—The National Republican club, numbers among its members Chief Justice Hughes, Elihu Root, Ofsted Mills, Theodore Roosevelt, and other prominent party leaders, today was on record by 461 votes to 335 against the prohibition amendment. The club has 2,000 members. President Hoover is an honor member.

After a four-hour session marked by spirited clashes between wets and dries in a vote of 461 to 335 adopted a resolution which held the Eighteenth amendment "is disruptive of our federal system, in that it is destructive of the rights of the states," and urged representatives of the Republican party in both houses of Congress to advocate and vote for its repeal "in order to restore the American form of government."

The club has a membership of about 2,000, about half of whom live in New York and vicinity and the rest scattered throughout the country. Many leaders of the party are members.

Both the wet and dry factions agreed an intensive battle for proxies.

Motion to table the resolution was defeated when Richard W. Lawrence, president of the club, reversed an earlier ruling and admitted the wet proxy votes under the new motion.

It was then defeated by a vote of 479 to 369.

Warren To Help City Get Better Mail Delivery

A message from Congressman Lindsay C. Warren said he would do everything possible to bring about an improvement in the mail service between Greenville and northern points.

The message was in reply to a petition from business men of Greenville to the Postoffice department, asking for better service.

"I appreciate the fact that with the withdrawal of trains on both railroads, that mail service for Greenville has been seriously impaired, and I assure you that I will do all possible to get you better service," Congressman Warren declared.

Editor Of Manufacturers Record Tells Why Progress Is Not More Pronounced

Little Rock, Ark., March 11.—(AP).—Small politics and petty jealousies have been dominating factors in hindering industrial development in the south, Richard H. Edmunds, editor of the Manufacturers' Record of Baltimore, said in a message read to the annual industrial conference of the southern division of the American Mining Congress here today.

"Southern states have been hindered by interminable political disputes, not between parties but within one party," said the message.

"If groups of southern states could band together into organizations for cooperative work covering every phase of their resources and potentialities, progress in agriculture and industry in the next ten years would exceed all that has been done in the last 25 years."

Herbert A. Brooks, Clearwater, Fla., hotel manager, speaking of "tourist industry" in the United States declared this had become a five billion dollar business.

"In six states alone, California, Florida, Minnesota, Michigan, Wisconsin and Colorado the gross annual tourist business amounts to two and a half billion dollars," Brooks said. "All other states combined have at least this much. The five billion dollar tourist industry outstrips nearly every other business in the United States."

L. Diamond Buried At Kinston Today

L. Diamond, furniture dealer of this city, died suddenly at his home yesterday morning as result of high blood pressure. Funeral services were conducted in Kinston this afternoon, burial being made in the Kinston cemetery.

Mr. Diamond came to Greenville about a year ago from Kinston and operated a furniture store on the lower end of Dickinson avenue. He is survived by a wife and three small sons.

P. & N. DEFIES I. C. C. RULING ON EXTENSION

Railway Line Begins \$15,000,000 Extension Program In N. C. And S. C.

Gastonia, March 11.—(AP).—Grading crews, held in readiness here since yesterday, began work this morning on the proposed route of the Piedmont and Northern Railway five miles from Gastonia.

Acting under orders from company officials who were authorized by the board of directors in Greenville, S. C., yesterday to begin work at once, clearing of the right of way was begun under supervision of C. T. Wanner, Duke Power Company engineer.

The work was begun in defiance to an Interstate Commerce Commission ruling.

Additional teams and men were being secured here this morning to be added during the day.

Charlotte, N. C., March 11.—(AP).—Defying the Interstate Commerce Commission, the Piedmont and Northern Electric Railway moved today to carry out plans for a \$15,000,000 extension of its lines in North and South Carolina by actually beginning work on one sector of the proposed extension.

The first step on the railway's program was to build a 53-mile link from Spartanburg, S. C., to Gastonia, N. C., connecting its lines in the two states. Next the road proposed to put down a 73-mile stretch of track from Charlotte to Winston-Salem, N. C., and ultimately to extend its lines on to Durham.

Pursuant with action by the railway's board of directors, construction crews were assembled today just west of Gastonia and east of Spartanburg to start work on the proposed interstate sector of the road.

Immediate beginning of this construction was ordered at a meeting of the directors yesterday in Greenville, S. C. Officers of the company were instructed to prosecute to completion "with due diligence and dispatch" the Spartanburg-Gastonia link.

Completion of the Charlotte-Winston-Salem-Durham sector "originally projected and planned" also was reaffirmed and approved and ordered "not to be abandoned."

Asked yesterday after the meeting of the directors when work on the Spartanburg-Gastonia project would begin, W. S. Lee, president of the railway, asserted:

"Tomorrow morning the order will be given to start carrying out the program."

After a hearing in Charlotte, the I. C. C. denied the P. & N. permission to extend its trackage, holding in a ruling of October 6, 1927, that for the road to do so would create a new trunk line through the Carolinas which, the commission contended, was not needed.

The railway took the matter to the U. S. courts and when the Supreme court last month ruled it was without jurisdiction, the railway officials decided to proceed with its construction plans.

Mr. Lee called the meeting yesterday, and authorization by the directors to proceed was the result.

Should the I. C. C. seek an injunction to halt the construction, P. & N. officials have intimated they will again appeal to the U. S. Supreme court and fight the case to a finish.

Completion of the proposed two new sectors would give the electric line a railway system from Greenwood and Anderson, S. C., on the south to Winston-Salem and Durham, N. C., on the north. This officials of the company assert, would be as planned by the late J. B. Duke, founder of the P. & N. and the Duke power interests.

The P. & N. now has lines from Greenwood and Anderson to Spartanburg, and Greenville, S. C., and from Gastonia to Charlotte, N. C.

Taft Laid To Rest In Robes Of Chief Justice Of U. S.

Washington, March 11.—(AP).—William Howard Taft goes to his grave dressed in the robes of Chief Justice of the United States.

He placed folds of the black robe that he wore during the years he was on the bench was placed about his broad shoulders as he lay in the black, burnished casket at the capital.

His face was turned slightly to one side and light shined through the dome fell upon his strong profile. His expression was peaceful, though a touch of gravity was added by the marks that illness had left upon his face.

BYRD PARTY HONORED AT NEW ZEALAND

Members Of Antarctic Expedition To Be Feted At Round Of Receptions.

Dunedin, N. Z., March 11.—(AP).—Somewhat confused by automobiles and street cars after spending more than a year in the snow-bound and desolate loneliness of the Antarctic, Rear Admiral Richard E. Byrd and the members of his expedition today renewed acquaintance with civilization.

After dodging automobiles Maurice Hanson, chief radio engineer, said that previously he had thought New York was the largest city in the world but since his return here yesterday he could not help but think Dunedin, which has a population of about 85,000, was the hub of the universe.

Many members of the party went riding in American automobiles and electric street cars or walking on the pavements about town, all new to them after the many months on the ice and snow of the Antarctic.

The ships were deserted by the party, and the members have taken up residence in hotels where comfortable chairs and rich foods are receiving special attention. A round of receptions has been provided in honor of Admiral Byrd and his party.

Admiral Byrd declined to divulge any important conclusion he reached after his exploration in the Antarctic. He stressed the importance of the flight during which he discovered and surveyed 280,000 square miles of previously unmapped territory and rated his perilous flight over the South Pole as secondary.

The survey of the region, which he named Marie Byrd land, by scientists and geologists with the expedition, he said, "should prove useful," but he declined to amplify the statement.

Admiral Byrd revealed that he had arranged for Norwegian whaling ships, which operate in the Antarctic, to pick up his airplanes next season. It was necessary for them to leave the planes at Little America when the expedition sailed for Dunedin.

He said that his expedition, like most others after completing explorations, was on the verge of bankruptcy but that he "hoped to pull through all right."

President Hoover and Other High Government Officials Take Part in Funeral Service For Former President and Chief Justice of U. S. Supreme Court; Burial at Arlington Cemetery

Washington, March 11.—(AP).—William Howard Taft was committed to his maker today in funeral services which bestowed the last tender offices of the government he served, the church in which he worshipped, and the people whom he loved.

Thousands paid their homage as he lay in state under the dome of the capitol. Then in All Souls church, high on Sixteenth street hill, he received the simple ministrations of the Unitarian faith in which he lived. The federal government claimed him last of all, for military burial at Arlington.

A blustery March rainstorm, which whipped into the facts of his military escort and drenched the great flag draped about his casket, overcast the somber picture of the passing of the only man in American history to serve both as President and Chief Justice of his country.

President Hoover led the nation in tribute. As the cortege passed the White House he stood bareheaded with Mrs. Hoover beneath the portico. At All Souls church, with all of the other high officials he took part in the short service.

The few where Taft himself had worshipped for many years was banked high with flowers. His own pastor, the Rev. Ulysses G. B. Pierce, read some bits of poetry, intoned a few lines of Scripture, and said a prayer. The organ pealed the supplicating notes of "Abide With Me," and "Lead Kindly Light."

That was all. There was no funeral oration.

Washington, March 11.—(AP).—William Howard Taft received today the high honors which a grateful nation reserves for those who have reached the loftiest pinnacles of its service.

It was his own day in the heart of a great people that esteemed him for his statesmanship and loved him for his humanity and to whose welfare all the years of his manhood were given.

From dawn until a wester sun dipped steeply above the calm hills of Arlington National cemetery, where it was his wish to sleep for all eternity, every pulse of the government beat in rhythm to the tribute heaped upon his memory.

At the last, it was left to the thunder of guns and the soft notes of the bugle, chanting a soldierly requiem to a fallen commander, to voice the message that Taft of Ohio had laid him down to his long rest where only those who in life served the flag faithfully and well may gather in the fellowship of death.

In the fullness of his years, weighed by distinctions such as had come to few before him, the man who had been President and Chief Justice was a plain citizen again when death beckoned him away. Yet, because of the heights of public place he had known, and because, too, of the almost unbroken service to the nation that was his life work, no eulogium was too great for him in death.

The affairs of the nation were paused to do him honor. The business of government, stood at pause; at pause in the White House he had known intimately as President and cabinet officer, in the high court where his last public service was given, in the halls of Congress.

A clattering cavalcade was marshalled to escort him in death from the peaceful Wyoming avenue home to the capitol of the nation along the route over which he had passed in life, once flushed with a great victory to take his oath of highest office and again, four years later, silent and motionless beside his chosen successor, tasting bitterness of defeat, riding, for a time, out of public eye.

Under the wide, white dome of the capitol where only America's greatest dead may keep their last vigil, the low catafalque which had borne the caskets of other Presidents, waited to receive him. Last before him to rest upon it was his fellow Ohioan, Warren Harding, from which came the appointment that William Taft most treasured of all his heaped up honors, the Chief Justiceship.

It was true: Harding held his tragic home-coming to Washington. As then, and for this other son of Ohio, the great bronze doors that face the rising sun were set ajar, that all who would might enter.

State To Seek Modification Of Increased Rates

Raleigh, March 11.—(AP)—Modification of a recent order of the Interstate Commerce Commission increasing freight rates on classified shipments, in this state will be sought by the North Carolina Corporation Commission.

The state commission will petition the I. C. C. to modify its order and give the rate body the right to deal with the rates at issue. I. M. Bailey, counsel for the Corporation Commission, announced yesterday.

The modification will be sought, Mr. Bailey explained, to "avoid any increase in rates on commodities moving between points in North Carolina higher than the rate applicable on the same commodities moving between Virginia points and North Carolina."

The increase in the North Carolina intra-state rates was ordered by the I. C. C. on complaint of the Virginia Corporation Commission. The Virginia body claimed the present rates were prejudicial and that Virginia shippers suffered.

The North Carolina Commission has every hope that its petition for a modification of the order will be granted, Mr. Meekins said.

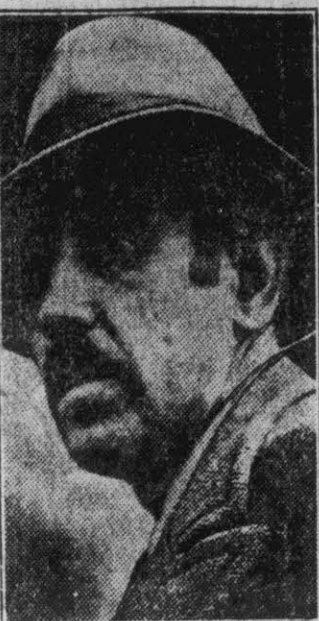

lanta.TAXES AND NAVAL
LIMITATION

Entirely aside from its significance as a move toward permanent world peace, the naval limitation conference in London, if successful, will have a salutary effect on the tax situation in the five major nations.

The navy is one of our most expensive institutions, and at present absorbs \$1,200,000,000 of tax money annually. The life of a navy is about twenty years.

A battleship of 35,000 tons costs approximately \$40,000,000. A 10,000-ton cruiser costs \$17,000,000 and a 3,000-ton submarine, \$6,000,000. In addition, the cost of manning and operating these ships must be considered. It can be readily seen that aggressive naval limitation will be of great value to the struggling taxpayer.

HUGE FIRE LOSS
CONTINUES.

Should the fire losses for January be repeated each month through the year, the total loss in 1930 would be over a half billion dollars! Put to constructive use this enormous sum would build a road 400 miles long at a cost of \$25,000 a mile, with sufficient left to develop 100 foot lots on both sides and provide for each lot a house costing \$7,000, furniture costing \$3,000, a \$1,000 garage and a \$1,000 car.

Fortunately January is often the worst month of the year for fire losses. Also the \$42,344,035 reported by the National Board of Fire Underwriters for January, 1930, is five per cent less than for the same month in 1929. As a matter of fact, losses have decreased slightly each year from \$561,980,751 in 1926 to \$422,215,128 in 1929, but even the latter figure is many times too large. It represents property values that have gone up in smoke and the destruction of raw materials that can never be replaced.

Such a huge fire loss should be sufficient warning to Americans to handle fire with care.

DIVIDENDS CONFINED
TO INVESTORS.

Aren't they prosperous, seeing that the tariff measure is to increase their subsidies and the public service commissions are permitting them to charge

ABOUT
TOWN

Better mail service between Greenville and northern points is what the business men of this section want at this time, and they have asked the Postoffice department to look into the matter and see what can be done.

The taking off of passenger trains on the two railway lines operating in and out of Greenville has disrupted the mail service to no little extent and letters going north are delayed several hours because of their inability to reach connecting lines on time.

This is a situation that demands immediate attention and it is hoped the Postoffice department will take some step to relieve the condition. This can be done very easily by sending mail out on northbound buses. It would not only relieve the situation here but in other sections vitally affected by the deliveries.

Show windows play a big part in the life of a business establishment, and Greenville merchants are beginning to realize the fact. During the last two or three years windows have been enlarged and improved considerably along the principal business streets. The change not only beautified the stores but enabled the merchants to make a complete showing of their extensive stocks, from season to season. Right at this time there is an outstanding improvement underway in this city. It is at the store of W. A. Bowen which when completed will be among the most handsome structures in this part of the state. Both the interior and exterior of one section of the store is being completely remodelled, and the show windows compare favorably with the large stores to be found in metropolitan centers.

Greenville people are proud of improvements of this kind because they are true indications of progress, of a desire of the business men to keep stride with the community which they represent. It is to be hoped other changes of this kind will occur from time to time during the next few years. They will enable Greenville merchants to maintain indisputable possession of their claim of being the principal shopping center in this part of the state.

The reason crime is falling off in Pitt county is because the criminal element is too poor to pay their fines, according to belief of members of the local law enforcement bodies.

The number of defendants appearing in both mayor's court and county court have fallen off considerably during the last few months, and the only thing officers can advance for the situation is the financial stringency existing in the various communities.

In fact, the majority of defendants given hearing the last three months were either remanded to jail because of failure to raise bond or fines, or given a certain period of time to make the payments.

The situation is one of the most unusual in years, and if poverty is a deterrent to crime the criminal element will remain slim for some time to come.

Charitable contributions and gifts are deductible within limitations provided by the revenue act. In order that a deduction may be made, contributions to a corporation, trust, community chest, fund or foundation must meet with several tests. Such organizations must be operated exclusively for religious, charitable, scientific, literary, or educational purposes, or for the prevention of cruelty to children and animals. No part of this income must inure to the benefit of private stockholders or individuals.

Contributions made to a mission, any fund, church building funds, and for the benefit of other activities of the church are deductible. Pew rents, assessments, and dues paid to churches are regarded as contributions. Gifts to any corporation or association organized or devoted to the advancement of learning are exempt.

Gifts to an individual are not deductible, but if made to a charitable organization, as defined by the revenue act, may be deducted even though the organization distributes funds among the individual beneficiaries.

The spirit of springtime is in the air and from now on the streets of Greenville will be flocked from counties bargain hunters from different parts of eastern Carolina seeking the splendid values offered by local merchants at all seasons of the year.

The reason Greenville claims the distinction of being the "principal shopping center in eastern Carolina" is because it draws from a larger trade territory than any other town in this section of the country and because its merchants always have plenty of real values to offer their patrons.

YANKS READY TO STEP BACK IN BIG FIGHT

St. Petersburg, March 11.—(AP)—The warning may as well be broadcast now that the New York Yankees, after taking it strictly on the chin in 1929, are ready to step right back into the American league pennant fight and make the Athletics prove they belong on top.

Four years ago, after the first championship machine of the Yankees cracked up, the late Miller Huggins produced the cogs needed for another three-year winning drive.

Keen-eyed wise Bob Shawkey, "Hug's" successor at the helm, may repeat the process. At least Shawkey has a wealth of remarkable material in hand to remedy most, if not all of the weaknesses of 1929, whether or not this is sufficient to accomplish more than an argument with Connie Mack's great outfit. Pitching remains the question mark and a big one.

With Babe Ruth roaring defiance from all corners of the field eager to prove he is a bargain at \$80,000 and far from being "through" the Yankees have his spirit as a rallying point.

The youngsters as well as the veterans all gain a big chunk of inspiration from the Babe, who is more irreplaceable on the field than ever. Cynics doubt Ruth's under-pinning and digestive system can carry him through more than 100 games at his old pace; yet outwardly the big, bronzed playboy of baseball looks to be in remarkably good condition.

The club needed a robust, hard-hitting outfielder to replace Bob Meusel and seems to have found him in Allen (Dusty) Cooke, who hit 358 for St. Paul in the American Association last year, and looks like a finished product.

A third baseman was required and he appears to have arrived in full equipment in the person of Ben Chapman, also from St. Paul. Ben's throwing habits have been altered in camp but he can field as well as hit.

More and better pitching has been the most important of the spring's requirements and, though only the actual battle will prove anything, the club apparently has uncovered three, if not four prospective stars in Ivy Paul Andrews, the Alabama boy, who was with Albany last year; Americus Polli who won 22 and lost 9 with St. Paul last year; Vernon Gomez, southpaw who won 18 and lost 10 with San Francisco; and Bill Henderson, picked up as an after-thought from Jersey City.

Reserve strength was needed in case anything went wrong with the seasoned keystone combination of Mark Koenig, firststop, and Tony Lazzeri, second baseman whose shoulder has bothered him for some time. On tap for this possible emergency are Lyn Lary and Jimmy Reese, the former Oakland combination, brought together again for the first time since they were bought by the Yankees. Reese, with the benefit of additional experience is a fine looking second base prospect.

Burly Lou Gehrig, at first, and Kentucky Earle Combs, in center, need no recommendation for their jobs.

Behind the bat, the Yankees seem better equipped than at any time since Wally Schang was in his prime. Ransy Bill Dickey was a great young catcher last year and a greater one this year on the basis of his work so far. Eugene (Bubbles) Hargrave, persuaded to accompany Polli, Chapman and Cooke in the general movement from St. Paul to New York, has the experience needed to work with the young pitchers, as well as potent bat.

There is no question whatever that the Yankees will have as big, if not a bigger wallop than ever and no one has yet referred to them as the "hitless wonders." With Dickey or Hargrave wearing the mask there is a potential 300 hitter in every position and a 350 punch in three or four positions. Combs, Lazzeri, Ruth and Gehrig all have hit over 350 in the American league. Cooke did it in the American Association and Hargrave has exceeded this mark in both the National league and American Association.

STOCK MARKET

New York, March 11.—(AP)—The stock market turned irregular today after an opening outburst of buying had carried more than two score issues to new high levels for the year.

Trading was heavy in volume, with the ticker falling more than 20 points behind the market. The exchange was closed at 12:30 p. m. out of respect for the memory of former Chief Justice Taft whose funeral is being held today in Washington.

Call money renewed unchanged at 4 per cent, with indications that the rate would be maintained. Wall Street is looking for a temporary stringency in call money over the week-end because of the heavy income tax payments on March 15, and the expiration of about \$70,000,000 in stock and bond subscription rights this week. The largest of which is the Baltimore & Ohio issue.

General Motors crossed 45 to a new high level for the year, one block of 15,000 shares changing hands at that price. Checker Cab, DuPont, Radio, Timken Roller Bearing, Coca Cola, Condole Film, Warren Bros., and General Refractories were among the many other issues to sell at new peak prices for the year.

Peoples Gas large blocks of which are reported to have been taken out of the market by investment trusts, was marked up 5 points to a new top at 289. Auburn Auto responded to reports of increasing sales by climbing 5 points to a new peak at 254.

J. I. Case broke 7 1/4 points, Vanadium Steel 5 1/2, and Industrial Rayon 5. Renewal of selling pressure against Simmons Co. carried that issue down more than 3 points to 58 1/2, or below the low price touched in the November break of last year. U. S. Industrial Alcohol, Hershey Chocolate and American & Foreign Power fell 2 to 3 1/2 points.

The closing was irregular. Total sales approximated 2,900,000 shares.

FINAL TRIBUTE TO TAFT IN FUNERAL RITES TODAY

(Continued from page 1)

Long before the hour set a host of plain Americans of every creed and color was waiting there. Most of the former President's life was spent in Washington. There were many humble neighbors and friends of the years who found places in that seemingly endless queue. Men, women and even children were there in hundreds who had known him in life. There were those who recalled him in the bloom of his mature manhood, who saw still in his face his wide, cheery smile or heard again the bubbling chuckle that gave mirthful punctuation to many a public address.

The church services themselves were as simple as the faith in which the dead man lived and died. There was no attempt at eulogy by Dr. Ulysses G. B. Pierce who was more than pastor to Mr. Taft. All his Washington life he had worshipped at All Souls' Unitarian church. It was a warm personal friend, a family friend, to whom the task of finding religious consolation was entrusted.

And he sought it in simple, kindly old hymns, "Lead Kindly Light" and "Abide With Me" in brief Scriptural readings, in prayer and in excerpts from old poems dear to Mr. Taft in life. Organ and chiming bells alone carried the musical setting of the service. Among the bells was one that has tolled the passing of Presidents for more than a hundred years.

For the last scenes army orders had summoned the full pomp of military funeral pageantry, horse, foot and artillery, ranked in battalions as befit the high place the dead man once held as commander-in-chief, and flanking columns of marines and Blue-Jackets to be speak his similar place over all the nation's sea forces.

All these were mustered to lead the way to a peaceful, freight-laden hillside, its clustered branches and undergrowth a ready budding with the life of a new nation.

The burial plot had been chosen by the family of the dead President. From that slope Washington looks hazy and beautiful in the distance beyond the wide river. And on this quiet look at the wealth of honor for the dead that marked the day centered.

It was to Dr. Pierce that the last spoken word of the simple service was given. That, and his reading of Tennyson's "Crossing the Bar" at the grave side, came last before the ranked guns, shrouded in the trees of the hillside above, were awakened to shout their clamorous word of farewell.

Amid those rocking, resounding blasts, an army bugler was stationed to catch up the quaking echoes of the old grave yard and hush them again in the plaintive notes of "taps," the soldier's farewell.

And to those dying notes, soft in the evening air, a nation left the message that "nims" had been written to the book of life for Taft of Ohio, President, Chief Justice and plain American citizen, who had well earned the "peace that passeth understanding."

Co-op Case Carried To Court Of Appeals

Raleigh, March 11.—(AP)—The claim of three attorneys for \$75,000 additional in fees for the part they played in having the Tri-State Growers Cooperative Association thrown into receivership, will be carried to the United States Circuit Court of Appeals at Richmond, Va. J. Crawford Biggs, counsel for the petitioners, said today.

The attorneys seeking the additional fees, W. M. Person, B. W. Euford and P. W. Gildewell, were refused any further remuneration by Federal Judge I. M. Meekins, who held in an opinion that they were not entitled to any further pay. Each was paid a fee when the association used his services, he said.

Mr. Biggs said he would perfect the appeal this week and that he hoped the Circuit court would act on it shortly.

The Tri-State Association had about 96,000 members when it was thrown into bankruptcy in 1926. It was indebted more than nine million dollars. All the recognized indebtedness has now been paid and all tobacco of the association has been sold. The receivers recently announced they expected to have about \$500,000 to distribute among the members of the Association.

Striker's Son Still Remains Unconscious

Marion, March 11.—(AP)—David Buckner, 14-year-old son of a textile striker here who was shot ten days ago, remains unconscious at the Marion General Hospital, doctors said today. There is little change in his condition.

Dr. H. B. Dittmore, physician in attendance, compared the boy's state to that of a shell-shocked soldier. None of the bullets entered his brain to injure it organically, he declared, but the shock has entirely deranged his functions.

No arrests have yet been made and no warrants issued in connection with the shooting, Sheriff O. F. Adkins' office reported. The attack occurred in the vicinity of the Merion Manufacturing Company village.

Over Hundred Sick Of Strange Malady; Quarantine Ordered

Johnson City, Tenn., March 11.—(AP)—A quarantine of 105 persons suffering from a mysterious paralytic malady was in force today in Washington, Carter and Unicoi counties.

Announcement of the quarantine was made by Dr. S. S. Moody, Washington county health officer, who said all school children in the families affected had been instructed to remain at home, but adult members, who were not suffering from the malady, would be permitted to go to their businesses provided they exercised rigid precaution at home.

"Probably 98 per cent of the Washington county cases have a history which shows drinking," said Dr. Moody. "About 50 per cent of the patients said they had recently been drinking Jamaica ginger and many others drank plain bottles."

This served to increase our suspicion that liquor may be the cause, but does not confirm it." All of those afflicted thus far, except two women and a 14-year-old girl, have been adult males.

Dr. Moody said some experienced pain but many others did not and a few were unable to control their hands.

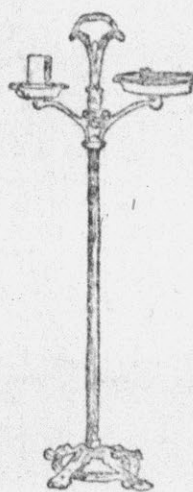
