MRS. DOHENY ON STAND IN BRIBERY TRIAL

Wife of Oil Magnate
Tells About Prom-
issory Note Bearing
Fall's Name.

Washington, March 17.—(AP)—Mrs. Carrie Estelle Doheny, wife of Edward L. Doheny, today took the stand in her husband's trial on charges of bribery, to tell of the loan of \$100,000 Doheny made to Albert B. Fall, former secretary of the Interior, in November, 1921.

"Mrs. Dohenys," asked Frank J. Hogan, Doheny's chief counsel, "did you ever see a promissory note bearing Albert B. Fall's signature?"

"Yes," replied Mrs. Doheny. "I told how the signature was torn from the Fall note by her husband just before they departed from New York to Los Angeles. She said Doheny told her it was a demand note, and if anything happened to them it would leave Fall in a bad position. If their executor insisted on payment, he explained, she said that by tearing off the signature Fall would be able to get the money."

She told of taking the note to Los Angeles and putting it in a safe deposit box and added it was misplaced and not found until after Doheny had testified before the Senate oil committee. She produced the signature which was shown the jury. She also identified the remainder of the note.

"Mrs. Doheny," asked Frank J. Hogan, "did you ever see a promissory note bearing Albert B. Fall's signature?"

"Yes," replied Mrs. Doheny. "I told how the signature was torn from the Fall note by her husband just before they departed from New York to Los Angeles. She said Doheny told her it was a demand note, and if anything happened to them it would leave Fall in a bad position. If their executor insisted on payment, he explained, she said that by tearing off the signature Fall would be able to get the money."

Her husband told her of Fall wanting the loan before making it, she said.

The court then sustained a Government objection to what Doheny had told her wife about the loan before it was made. The defense argued that the answer would show Doheny's mental state at the time. It pointed out that the question had been allowed at the Fall-Doheny conspiracy trial but Justice sustained the Government's objection.

Mrs. Doheny said she and her husband were in New York at the time the first learned Fall had asked for a loan.

Another Government objection then stopped the examination and the arguments were made at the bench out of the hearing of the jury.

Bull Fighter Badly Hurt At Madrid Arena

Madrid, March 17.—(AP)—Tossed about by a black bull with wide horns, Sydney Franklin, Brooklyn bull fighter, today was in a hospital injured seriously, although probably not fatally.

In a second off guard, as he whirled his maddening red cape in front of the enraged beast's eyes, he turned his back on the animal which impaled him and banded him about like a plaything for several minutes.

His physician, predicted he would live but said it would take him 40 days to recover. Since he is not a member of the bull fighter's cooperative association he must spend his convalescence in an ordinary hospital instead of the specially equipped institution the Toreros maintain.

The bull which proved Franklin's nemesis was his first of the afternoon. He went out jauntily to face the black beast and danced carelessly in front of it with his red cape.

There was something in the temper of the bull which warned the spectators, and there were rumors that the American had a tough animal to conquer. In the midst of the muzzling Franklin made a whirling pass at the bull with his cape, and turning for an instant was caught on the brute's right horn. The bull, triumphant and angered to frenzy, lifted the limp form of the Yankee Torero and tossed it about as a rubber ball, which it seemed to balance in midair. Finally Franklin rolled off and fell writhing in the arena while others in the ring chased off the bull to keep it from gouging him again.

FIRE DESTROYS BUILDINGS AT CHIMNEY ROCK

Worst Fire in History
Of Town Does Dam-
age Estimated at
\$75,000.

Chimney Rock, March 17.—(AP)—Fire starting late last night swept through nine buildings, with a loss estimated today at \$75,000, before the lack of further tinder brought it under control. It was the worst conflagration in the history of the town.

Originating in Oscar Shytle's cafe, probably from a defective electric connection or stove fire, the flames spread rapidly. The George W. Logan Inn was totally destroyed, with practically all its furnishings. The loss was set at between \$15,000 and \$20,000. Mr. Logan, his wife and two small daughters had narrow escapes from the flames.

Other buildings destroyed were the Miller Hardware Company's structure, W. J. McEntire's garage, the Tar Heel Inn, an office building owned by Attorney M. L. Edwards, of Rutherfordton, the Carolina Home, apartment building owned by the Citizens' Building and Loan Association of Rutherfordton, a building owned by a Kings Mountain family and another small building. Woods were also set afire by the flames, but the blaze was quickly extinguished.

Work Gets Under Way At N. C. Demonstration Farm On The Bethel Highway

Twenty Convicts Put
To Work at Model
Farm Between
Greenville and Bethel
to Further Govern-
or's Live at Home
Plan.

Preliminary work in connection with the operation of the State Demonstration Farm, located on the highway between Greenville and Bethel, got under way today, and within a few months Pitt county people will have an idea of what Governor Gardner meant when he inaugurated the "live-at-home" plan sometime ago.

The farm is located on the Blount and Brown properties and is divided by the highway from Greenville to Bethel. The land was donated by M. O. Blount of Bethel to enable the state to carry on its program of agricultural development, and especially to give Governor Gardner a chance of showing the farmers what he meant by growing enough of the different kinds of crops to enable them to live at home all the year around.

George H. Ross, director of State prison farms, was in Greenville today making preliminary arrangements for the farm, and stated that twenty convicts from Caledonia farm were put to work on the Demonstration Farm today. The work of cleaning off the fifty acres of land and dividing it into about fifty or more plots will continue for a period of about two weeks, and after that time the planting of crops will actually begin.

Mr. Ross said it was the purpose of Governor Gardner to show to the farmers the importance of growing crops to enable them to live at home all the year around.

Expect Income Tax Collection To Meet Budget

Raleigh, March 17.—(AP)—Indications are that payments of income taxes in North Carolina "have a chance" to total the \$7,700,000 anticipated in the original budget estimate for 1929-1930, A. J. Maxwell, State Commissioner of Revenue, said today.

"Of course," Mr. Maxwell said, "we cannot say until most of the returns have been tabulated, but if the returns received so far are representative we may equal the original estimate."

It was pointed out by Mr. Maxwell that returns have not been compared as to figures but that only the total to date as compared to the total to the same date last year was considered.

"The actual money in hand or collections to date indicate we have a chance to equal the estimate," said Mr. Maxwell, "and today's mail received by the income division mail department was the largest single day's mail ever received by the division."

The budget estimate originally was for \$7,700,000 the first year of the current biennium and \$8,250,000 the second year.

STATE BIRTH RATE SHOWS SLIGHT LOSS

Death Rate, However,
Indicates Gain in
1929 Compared With
1928

Raleigh, March 17.—(AP)—The birth rate in North Carolina decreased slightly in 1929 as compared to 1928 and the death rate increased, according to provisional figures compiled by the statistical division of the State Board of Health.

There were 77,630 births registered for 1929, which made a birth rate for the year of 26.0 per thousand population with the estimate being 27,750 population total. In 1928 there were 80,887 births registered, 3.257 more than in 1929, and a birth rate was 27.5 per thousand.

North Carolina apparently again for the tenth consecutive year, led the United States with the highest birth rate, as the state board preliminary reports from other states showed a slight decrease generally over the nation.

There were 37,055 deaths during 1929, or a rate of 12.5 per thousand of population. This compared to 36,133 deaths in 1928, or a (Continued on page 3)

SIX KILLED IN ACCIDENTS IN CAROLINAS

Five Others Seriously
Injured in Plane and
Automobile Mishaps
In Two States.

CHARLOTTE, March 17.—(AP)—Six persons were dead and five others were seriously injured today as the result of week-end highway and aviation accidents in North Carolina and South Carolina.

The death list:

Marie D. Brown, Jr., of Mocksville, N. C.
W. S. West, of Raleigh.

Four negroes—Jerry Wade and his wife, George Van Dyke and Glyde Gillen—who lived in the vicinity of Bamberg, S. C.

Brown was killed yesterday in an automobile wreck ten miles west of Chapel Hill on the Burlington highway. A machine in which he and two others were returning from the Jackson Day dinner in Raleigh turned over and pinned him underneath. Robert S. McNeal, chairman of the Davis county executive committee, who was driving, and John Leach, managing editor of the Mocksville Enterprise, escaped with minor injuries.

The death of West resulted when an automobile in which he and T. K. Fountain, also of Raleigh, occupied, turned over last night on a curve a few miles east of Greensboro. West was instantly killed and Fountain was taken to a Greensboro hospital badly hurt.

The four negroes drowned in the South Edisto river near Bamberg yesterday. Their auto plunged into the stream after side-swiping a buggy. The car was said to be going at a rapid speed.

Five persons were injured, two rather seriously, yesterday at Greenwood, S. C., by a commercial airplane that failed in an attempt to take off and crashed into four automobiles at the flying field. A. B. Carter, of Ninety Six, and Tom Ouzts, of Epworth, were the most seriously injured. Mrs. M. M. McKinney and two of her children were slightly injured.

The plane was demolished, but T. Seymour Jessup, pilot, and E. Clarke, owner and passenger, were uninjured. Jessup said last night he was unable to explain what caused the plane to swoop down and hit the automobiles.

The fifth person to be seriously injured in the two states was Duane Miles, said to be of Guilford county, near Greensboro. He was injured early yesterday in an automobile collision near the city limits of Durham. Physicians were doubtful whether he would survive.

Hoover Will Visit Fishing Camp Soon

Washington, March 17.—(AP)—Even though the trout season will not be open, President Hoover has decided to make his first visit of the year to the Rapidan fishing camp in the Virginia mountains this week-end.

Since he plans to leave Washington sometime Saturday it is doubtful if he will have an opportunity to visit the little school in Dark Hollow which he was instrumental in having established.

The trout season will not open until Tuesday, April 1, under Virginia law, and Mr. Hoover has made clear that he will observe the statute. No indication was given that he would prolong his stay in the mountains to cast a line on the opening day.

Girl Stabs to Death Her Rival in Love

Camden, S. C., March 17.—(AP)—Her rival in love, Bessie Robertson, 16, of Rock Hill, stabbed to death, Lottie Villigut, 19, of Camden, today was in the Camden jail facing probable first degree murder charges.

The killing occurred last night at the residence of S. L. Edensfeld, where the Robertson girl boarded, after a quarrel over the affections of Cleo Gregory, 25-year-old Camden man said to have been the sweetheart of the Villigut girl.

The girl went to Miss Robertson's home, Camden police said today they were informed, to "have it out" with her. The quarrel became heated, a knife flashed and the Rock Hill girl, daughter of a farmer living near Rock Hill, died instantly police reported.

An inquest underway this morning was expected to result in formal filing of first degree murder charges against Miss Villigut. The solicitor said that charge would be asked.

Rain, Snow, Hail, And Tornado At Los Angeles, Cal.

Los Angeles, March 17.—(AP)—An atmospheric disturbance featured by heavy rain, snow, hail and a freak tornado in Los Angeles, today moved into Arizona after spending three days over southern California.

Weather bureau officials declared that a hail shower last night at the Coastal plain.

Snow in the higher altitudes caused isolation of several mountain resorts in the San Bernardino and San Jacinto mountains.

Snow plows were expected to clear the roads by tonight or tomorrow. The freak tornado, which struck three suburbs and a portion of Los Angeles Saturday, caused several thousand dollars damage to industrial buildings. It was the only violence of the storm.

Arizona reported that the cloud blanket had covered the entire state and was drenching pastures and filling irrigation reservoirs.

Rain was reported at Mazatlan, Mexico, far down the Gulf of California coast, where it was expected to interfere with the harvesting of winter vegetables.

WOMAN SLAIN AT CHICAGO AND ROBBED

Body of Gangster
Found Floating in
River, Victim of
Gang Vengeance.

Chicago, March 17.—(AP)—The slaying of a woman election judge and a new version of gangland "ride" today added fresh crimson blotches to Chicago's crime record. Scarcely half a block from her home the body of Mrs. Ida M. Doyle, 61-year-old Republican election judge, was found yesterday in a south side alley, the skull crushed by heavy blows.

Her hands and torn clothing bespeke her futile struggle against robbery and death. Her purse, containing a few dollars and the check she received several hours before for her registration day work, was missing. A gold band wedding ring torn from her finger by the slayer, was found in a nearby yard.

Several hours later, the body of John (The Billion) Rito, gangster and racketeer, was found floating in the north branch of the Chicago river.

Wrapped in a blanket and trussed up with wire—a prayer book and rosary in a coat pocket and the hands mockingly folded as in prayer—Rito's body showed traces of torture, stabbing and a beating. A wire loop had slipped its mooring on the river bottom and a coroner's physician said he had been in the water about two weeks.

Rito's death was seen by police as another episode in the battle between Moran and Capone for near north side liquor trade, that resulted in the bombing of the Club Algers several weeks ago.

PITT OFFICER SLAYS SELF WITH PISTOL

W. B. Vandiford Com-
mits Suicide Sunday
Afternoon While in
Fit of Despondency.

W. B. Vandiford, Pitt county deputy sheriff, committed suicide late yesterday afternoon by firing a single bullet below his heart. Temporary insanity was ascribed as reason for the act. He was about 45 years of age and one of the best known officers of his community.

That suicide was contemplated was indicated by a note found in a pocket of the dead man, directing his wife to take good care of his mother and daughter and to meet all of his financial obligations. Vandiford, it was said by close friends, had been despondent for several weeks and this is believed to have produced temporary insanity, leading to his rash act.

The tragedy occurred back of the home of Frank Eiks, on the Greenville-Farmville highway, about two miles from Greenville. The body was discovered by a negro who notified relatives.

Vandiford was found sitting in his automobile, gripping the steering wheel, as if he had attempted to turn the car around after firing the bullet into his body. The finger of the right hand gripped the gas lever, and a cigarette was in the left hand.

The bullet penetrated below the heart, severing an artery, and producing almost instant death. The car had been driven to the edge of a small thicket.

Vandiford had been in service of the sheriff's office about four months, filling the vacancy made by the resignation of Preston Pierce, chief of police of the city of Greenville. He was known as a good and faithful officer, and made his last appearance to the court house on business last Friday morning. He was a deacon of the Red Oak church and secretary of the Sunday school.

He is survived by a wife and one daughter, his mother, Mrs. Annie Vandiford, and one brother, Jim Vandiford, all of whom reside on the Greenville-Farmville road, about six miles from Greenville.

Funeral services were conducted from Red Oak church this afternoon at three o'clock by Rev. Lee Sadler, pastor of the Eighth Street Christian church, and Rev. W. H. Marshburn, of Robersonville. Interment was made in the family burying ground.

Taxicab Driver
Gets Lesson On
Money Matters

Chicago, March 17.—(AP)—Ray Kaufman, taxicab driver, has learned that all who go into banks are not bankers and that all that comes out is not money.

His enlightenment may be credited, or debited, to R. F. Davidson, of Evanston, who, it should be mentioned, carries a most impressive brief case.

Davidson chartered the cab operated by Kaufman in Morton's Grove, suburb west of Chicago, and ordered the chauffeur to drive him to a bank in Evanston. Then he had himself driven to banks in Wilmette, Winnetka, Kellinworth and Niles Center, all suburbs. At each stop he explained he was "making a withdrawal."

The driver thought, after driving to three or four banks, that his fare must be planning some big financial coup or maybe to start a bank of his own. But after a while he became suspicious and when Davidson ordered him to drive back to Niles Center, Kaufman merely nodded and headed for the Evanston police station.

There police searched the brief case and found advertising literature; they searched Davidson and found 8 cents.

FORMER RULER OF SPAIN DIES EXILE IN PARIS

Primo De Rivera Sudden-
ly Dies At Hotel
In Paris.

Paris, March 17.—(AP)—The hand which ruled Spain firmly for nearly seven years today was still in death.

Garbed in the sack cloth and sandals of a Carmelite monk the body of Don Miguel Primo De Rivera was in an unpretentious suite of a modest Latin quarter hotel.

Tonight a train will take it back to Madrid, where in life Captain General Primo De Rivera was dictator of Spain.

Secretary Lamont Be- lieves Lower Interest Rates Ought to Bring About Speeding up of Construction Pro- gram in Various States During The Next Several Months

Washington, March 17.—(AP)—Secretary Lamont said today that the lower interest rates on money throughout the country should permit an important speeding up during the next few months in new construction which he said already had been stimulated by the "remarkable cooperation" from the various states.

The commerce secretary asserted the high interest rates during the past year had been one of the major factors in slowing down construction and added that while the rate had "dropped in New York the earlier money conditions have not yet reached throughout the country."

This condition could not be worked out in 24 hours Mr. Lamont said, but the situation is gradually loosening and construction during the spring should be greatly aided by the easier money.

The secretary pointed out that the states and governors have been pushing public construction and have been aided by the Government wherever possible.

The state of Ohio was cited by Mr. Lamont as one of the states which has gone furthest in its efforts to offset the depression following the stock market crash. He said Ohio has let approximately \$3,000,000 in road contracts since December, during a period when road construction ordinarily is at a standstill in that section.

The secretary added that the committee composed of bankers, manufacturers, merchants, bankers and others have been formed in that state to stimulate private enterprise.

Secretary Lamont also said his department was working toward a constant check upon the number of unemployed in the country. The unemployment census to be taken next month, he explained, will be used as a basis upon which figures can be kept up to date.

While it is impossible to gauge the number of men out of work at the present time, said the commerce secretary, was expected to give definite information along this line, and that in the future, by a campaigning process in various sections, his department would be able to keep abreast of the situation.

Missing Student Seen at Wilkesboro

Chapel Hill, March 17.—(AP)—Dr. Harry W. Chase, president of the University of North Carolina, today received a message from North Wilkesboro which said a youth answering the description of Morgan P. Moore, of Asheville, N. C., university freshman who disappeared from the campus two weeks ago, was seen there last night.

The message was from a Dr. Garther, of that place. It said the youth talked with several persons on the street, gave his name and said he was from Chapel Hill. The police and county officers who were told of the youth's presence were unable to locate him.

Five Americans Injured in Fight With Filipinos

Manila, March 17.—(AP)—Five American sailors were nursing injuries today, the result of a riot with a crowd of Filipino civilians at Kitchell Field here following a baseball game yesterday.

Timely intervention of B. K. West, an American police captain, who heard the disturbance and ran armed from his home, subduing the rioters until police and the naval shore patrol arrived, was generally credited with saving the five from being beaten to death or severely injured.

Responsibility for the fight was not clear. Although some said it was inspired by communists, others credited the disturbance to gangsters seeking to retaliate for recent anti-Filipino riots in California.

THIS IS FOREST WEEK

This is Forest Week and Charles Lathrop in a brief review of the present situation as it confronts the nation points out that North Carolina can play not only an important but a profitable part by the adoption and carrying out of a real forestry program, and he urges every citizen in the state to get behind such a movement.

Declaring that putting idle lands to work growing trees is of great importance to North Carolina at this particular time, Mr. Lathrop says:

"North Carolina has a great deal at stake in the future of forestry in her state. She has in the neighborhood of four million acres of unproductive forest area. She has great industries that constantly call for forest products and she is just over night from the great manufacturing centers to the north. There is a great market now being supplied by the Pacific coast states.

"The original pine forests of the South probably contained over 1,000,000,000 board feet of timber covering about 130,000,000 acres. Beginning shortly after 1890, when the pine woods of the Lake States became diminished through over cutting, the movement of the lumber industry to the South became more rapid.

"The manufacture of southern softwoods increased steadily and reached its maximum in 1909 with an output of 17,000,000 board feet. Since this high point was reached there has been a slow dropping off in the production of southern pine.

"Although this lumber still dominates the eastern markets, the current cut is only about two-thirds of the maximum. In 1924 it was estimated that there remained about 139,000,000 board feet of virgin pine timber, scattered over some 114,000,000 acres. There is in the South also approximately 119,000,000 feet of second growth timber. The 225,000,000 acres of Southern forest soil must be made to continue their important part in the prosperity of the South and of the nation.

"Each year the world cuts about fifty-six billion cubic feet of wood. Of this a little less than half is of the size and quality that make it suitable for sawing timber—the lumber used for building and for general construction. The rest—more than half—is small, inferior material cut chiefly for fire-

wood. North America produces half of the wood cut in the world, and the conifers or softwoods supply about three-fourths of the sawing timber. It is the conifers whose perpetuation is essential so that the world may continue to be kept in timber.

"Foresters estimate that about thirty-eight billion cubic feet is grown yearly. This is the figure to balance against a cut of fifty-six billion cubic feet when plans for the future are being made.

"Home grown timber keeps home grown industries growing. North Carolina can have a big part in this program if she will look ahead. Every citizen should get behind the state forestry department and the department of public instruction in their endeavor to spread the forestry message during Forest Week. In forests and forest resources lie future economic security not only of North Carolina but of the nation."

It is apparent that Pitt county people are going to have plenty of material to choose from in the county election in June, if developments last week count for anything.

Seven candidates filed notice of candidacy during a period of about three days last week and virtually every one of them promised to use his influence in behalf of tax reduction.

As tax reduction is one of the main things under consideration at this time, it looks like each of the aspirants for office is on the right road to get the public vote. Each of the present incumbents in the state Legislature is seeking renomination, but there is a contest as well as in the Senatorial field.

While only two candidates have filed for county office—that of Sheriff—it was expected that this field would widen up during the next several days, and that there will be quite a wide range of choice.

It takes plenty of contestants to liven up an election, and with a few more entrants Pitt county will be treated to one of the most vigorous campaigns in many a year.

If the opinion of J. H. Like Mr. Shouse said, however, it is difficult to determine how the country is going to run two years ahead of election, but he entertains an opinion like thousands of others who voted the Republican ticket the last time but who will go back to the Democratic fold next time.

DUKE MUSICAL CLUBS DELIGHT LARGE AUDIENCE

The Duke Musical Clubs delighted with their varied program a large audience at East Carolina Teachers College Saturday evening. It was quite a festive occasion. The Senior class of the college occupied honor seats at the side front, and the young ladies in evening dresses ready for the reception that followed, gave a suggestion of the box circle at opera houses. As one group of musicians took charge of the program, those in the other group took seats in the rear of the auditorium or strolled around the lobby.

The Glee Club at present is the center of interest because of the approaching European trip. The songs on the program here are to be repeated in the program they will use in Europe, but there will be more, as the club will have the entire program. There will be several other negro spirituals, as these have been called for especially, and the Duke men will, in a way, be the American interpreters to Europe of negro spirituals.

The quartet and solo numbers were familiar songs, but as favorites in America they are peculiarly suitable on a program for foreign countries. These are "The Sweetest Story Ever Told," "For You Alone," "Juanita," and "Rose of My Heart."

The club repeated this year the song that won for them the southern championship last year, "The Comrades' Song of Hope," and will sing it in Europe.

The symphony orchestra opened the program with three excellent numbers—"Lustige Overture," by Keler Bela, "The Anvil Chorus" from "Il Trovatore," and "Light Cavalry Overture," by F. Von Suppe. This "finest college orchestra in the South," as it claims to be, is getting seasoned, and there is a polish about their playing that shows this orchestra is acquiring professional ease.

The University club orchestra plays and sings its jazz with a difference, and this makes it pleasing to those who, as a rule, do not care for jazz, as well as to the jazz fans. And they also played beautifully some serious numbers. They played "Navy Blues," with the vocal part by Herbert and the Band, "Kamennoi-Ostrov," by A. Rubenstein, and the following group: "I Live You, Believe Me, I Love You," "Chinese Honey-moon," and "Harvest Moon," with vocal part by trio and band, and "The Man from the South."

Sechrist is president of the Duke Musical Clubs and C. S. Hooper, Jr., is vice-president. It is of interest to note that the members of these organizations are from twelve different states and the District of Columbia. The four classes are divided as follows: 5 seniors, 22 juniors; 15 sophomores, and 13 freshmen.

Greenville had two representatives, one in the symphony orchestra, Ed Thomas, and one in the glee club, "Buster" Starkey. Durham and Smithfield were the only places that had more than two representatives.

Robert Bruton, the soloist of the glee club, who has a beautiful tenor voice, is a brother of Mrs. R. G. Fitzgerald of Greenville.

LARGE NUMBER SEE SHRINE PICTURE SUNDAY

Sunday afternoon at 2:30 o'clock an appeal for the Shriners' hospitals for crippled children was made by the presentation of a moving picture entitled "An Equal Chance." The film was produced by the Metro-Goldwyn-Mayer Company of California. Many famous actors contributed their services to make the film a success and its presentation yesterday was the occasion of a great demonstration of approval.

Over 15,000 crippled children have been treated at the 15 Shrine hospitals and mobile units in various parts of the United States and Canada during the last five years. Each Shriner in the United States and Canada is assessed at \$2.00 for the support of these hospitals, which makes a total of \$1,200,000 for this purpose. This income is supplemented by contributions made by Shriners and others. Last year W. W. Burgess, of Greenville, S. C., was so impressed with the work of the hospitals, that although he is not himself a Mason, he made a gift of \$350,000 for the establishment of a hospital in his own town, provided it should be made one of the units of the Shriners' hospitals for crippled children. Hejaz Temple of Greenville, contributed a lot and \$25,000 for equipment. This hospital with a capacity of 50 beds, was opened in 1927 by the Imperial Potentate and the Imperial officers.

An appeal was made to the Shriners present to make personal contributions as they were able, but especially to make bequests in their wills. By making provisions in their

will the income for the support of the hospitals during the next few years will be greatly enhanced.

It is the hope of the Shrine to establish a well-equipped hospital in every large center on the continent. There are about 300,000 crippled children in the United States and Canada whose parents are unable to obtain the necessary medical and surgical skill for their children. The hospitals are administered with the utmost economy and efficiency, the per capita cost being about \$3.50, which is much lower than the average private orthopaedic institution.

The campaign of publicity now being carried on among the Shrine Temples is wholly financed by Allen H. Ratterree, a Shriner of Los Angeles, California, as his contribution to the charity for the crippled children.

Many people who failed to see the picture are now asking that it be run again, so it is possible that it will be shown again next Sunday afternoon at 2:30.

STOCK MARKET

New York, March 17.—(AP)—Heavy buying of the oil shares, a score of which moved into new high ground on grains turning from fractions to 5 points, turned the general course of stock prices upward today after an early period of irregularity.

The demand for oils was influenced by recent favorable developments in the trade situation, and rumors that the United States Senate was likely to adopt a duty on oil.

Barish professionals tried to unsettle the market in the early trading, but failed to force much liquidation of long stock. American Locomotive, Gillette Safety Razor, International Silver and U. S. Industrial Alcohol were hammered to new low levels for the year, and probably a dozen other issues sold down 1 to 3 points.

Despite reports of a slackening in some of the major industries last week, Wall Street found considerable encouragement in preliminary reports that federal income tax collections were exceeding earlier estimates and from Secretary La. mont's statement that officials of various states were showing remarkable cooperation in responding to the Federal Government's plea that building work be speeded up.

Call money was in plentiful supply at the renewal figure of 31-2 per cent, but dropped to 3 in the fourth hour. Outside money brokers showed little inclination to lower the official rate. Outside money was available as low as 21-2 per cent. Time money and commercial paper markets also displayed an easier undertone.

Maneuvers Prove

U. S. In Need Of

More Cruisers

Quantanamo Bay, March 17.—(AP)—Recent maneuvers have served to confirm high ranking officers of the United States fleet in their opinion that the particular need of the navy at present is increased cruiser strength.

Reviewing the lessons learned in the war game "Battle of Navassa" last week, they pointed out that both of the opposing fleets have been considerably hampered by a lack of cruisers and destroyers as well.

The cruisers, the officers say are necessary to increase the fleet's mobility in battle and give it an adequate range of intelligent operation.

Rear Admiral T. P. Maguder, who served as umpire in last week's battle, is emphatically of the opinion that a large fleet of fast cruisers should be provided.

He believes, too, that the United States should build up to the limit of the 135,000 tons of aircraft carriers allowed by the Washington treaty and that new ships of this type should be smaller than the "Saratoga" and the "Lexington" which were used in the battle.

He says the "Battle of Navassa" had demonstrated that giants like the Lexington and Saratoga are almost as easily destroyed as smaller aircraft carriers.

Admiral L. M. Nulton, the commanding officer of the United States fleet, who commanded a fleet supposedly defending America from attack in the recent maneuvers, says he was handicapped by lack of fast light cruisers.

On An Odyssey

FEEL SURE OF THE TOP

Fort Myers, Fla., March 17.—(AP)—Although the full cast of world's champions, for various reasons, has not been completely reassembled in training camp, there appears ample justification for the confidence among the Athletics that they will enjoy another season's run at the top of the American league heap.

The benign leader, 67-year-old Connie Mack, and his agile men are "in," holding baseball's highest office with an outfit that seems to be decidedly on the upgrade, rather than showing any signs of disintegration. The burden of proof is on the seven other clubs and so far, with the exception of the New York Yankees, no particularly damaging evidence has been offered to threaten the reign of the House of Mack.

The Athletics, barring accidents, will take the field to defend their honors this year with the same team that scampered victoriously from the world's series battle with the Cubs last October.

Mack is the only manager in either league able to stand pat on his 1929 lineup. As a result he and his chief aides, Eddie Collins and Kid Gleason, have concentrated on inspection and development of a wholesale crop of youngsters. Many of them to be tagged for future delivery; scant few to be kept for immediate tryouts.

The net profits of the training camp are likely to show in better reserve strength and in at least one important addition to the pitching staff that is already among the best in either league. The outstanding twirling newcomer is Leroy Mahaffey, a big South Carolina right hander, who came to the A's via Portland of the Pacific Coast league. He has shown sufficient stuff to stamp him as a probable starting regular.

The tip-off on Mahaffey's ability is the fact that the players call him "Speed" on a club which boasts three of the greatest fastball flingers in the game in Lefty Grove, Rube Walberg and George Earnshaw.

The recruit is expected to round out a five man starting staff with Texas Bill Shores. This would permit Mack to hold in reserve, for relief duty or an occasional starting turn, three such able veterans as Knuckle Ball Eddie ommel, old Jack Quinn, who admits to a mere 44 years; and Howard Fimke, world's series hero, serving also as a pitching coach this spring.

Outside the box, the only position in doubt when the camp was pitched was shortstop, where the youthful southern recruit, Eric McNair, appeared as a rival for the veteran Joe Boley. This doubt has been removed by Boley's steady work and evidence that the veteran's arm still can keep the ball ahead of the fleetest runners. McNair, who is only 20, nevertheless will be kept in reserve.

Boxing Program Full This Week

New York, March 17.—(AP)—Two champions and several who would like to be, should provide the nation's boxing fans with plenty of high class action this week.

The champions are Bat Battalino of Hartford, Conn., and Mickey Walker. Those who would like to be champions include Kid Choccolate, Cuban featherweight, and Primo Carnera of Italy and Tommy Loughran of Philadelphia, each of whom has at least one eye on the vacant, heavyweight throne.

Battalino meets Bud Taylor, in a ten-round bout at Detroit Thursday night, but the Hartford lad is leaving his featherweight championship back home in cold storage.

Nor will Walker's middleweight title be at stake when he tangles with Jimmy Mahoney of Chicago in a ten rounder at Chicago tonight.

Carnera, who has knocked out his first nine American opponents in anywhere from one to six rounds, meets the old trial horse from Indianapolis, Chuck Wiggins, at St. Louis tonight. Loughran, at the same time, will be seeking to find that very elusive quality, punching power, in a ten rounder at Philadelphia.

Chocolate comes back to New York after a long vacation in Havana to meet Al Ridgeway, heavy punching New Jersey boxer, in the ten round feature bout at Madison Square Garden's regular Friday night show. Black Bill of Cuba and Midget Wolgast of New York, finalist in the recent flyweight tournament here, meet in the 15 semi-final.

Old Chapel to Be Razed

Columbia, S. C.—The old chapel of Columbia Theological Seminary, where Woodrow Wilson, as a boy of 16, made the profession of faith in Christ, will be torn down, brick by brick and stone by stone, and reconstructed in Decatur, Ga. Wilson's father was once a professor in the seminary, which now is located at Decatur.

W. H. Covert Called To Immanuel Baptist Church Of Greenville

W. H. Covert, of Winterville, has accepted a call to the pastorate of the Immanuel Baptist church of Greenville, it became known today. He will begin active service with the local church on April 15.

Mr. Covert, originally from New York state, has been pastor of the Winterville Baptist church for a period of two years, and during that time has rendered splendid services to his congregation. He is a graduate of Yale Divinity school, and has held several charges in the Southern Baptist convention.

Mr. Covert will succeed Rev. L. R. O'Brien who resigned several months ago to do evangelistic work in other parts of the state, the pulpits having been filled by various ministers from Sunday to Sunday as the search for a pastor continued.

Aid of Spirits Sought in Murder

Buffalo, N. Y., March 17.—(AP)—Authorities today had evidence from graves that aid of spirits of departed Indian warriors had been invoked to aid in the slaying of Mrs. Henry Marchand, wife of a Buffalo artist.

An old squaw, who accompanied a searching party to the Indian burying ground at the Cattaraugus reservation, said Nancy Bowen brought the aid of the warriors' spirits in her plot against the artist's wife, who was beaten to death with a hammer in her home two weeks ago. Nancy is a squaw who with Lila Jimeron, a younger woman of the reservation, now is in jail awaiting trial on a charge of first degree murder. The trial is scheduled to start Thursday.

In the graves of warriors, dead many years, were found food and whiskey for the journey the spirits would have to make to do the "white witch" to death; also effigies of Mrs. Marchand in the form of small dolls, of cloth, wood and paper.

One of these paper dolls had been cut from the page of a letter sent to Lila Jimeron. The handwriting was similar to that of Henri Marchand, husband of the victim who is now in the Erie county jail held as a witness under bail of \$25,000. No effort has been made by the prisoner to obtain bail.

Anson Jimeron, father of the accused Lila, did the digging in defiance of Indian beliefs that those who tamper with the resting places of the dead soon will come to an untimely end. Jimeron wielded the spade only in an effort to uncover some evidence which might aid in the defense of his daughter. Other Indians looked on in awe.
