DOHNEY IS ACQUITTED ON CHARGE OF BRIBING U. S. CABINET OFFICER

Oil Magnate Receives Verdict Of "Not Guilty" After Single Ballot By Jury, Which Was Out One Hour And Six Minutes; Several Women Kiss Dohney As The Crowd Files By Him In Courtroom

Washington, March 22.—(AP)—Edward L. Dohney, was acquitted today on a charge of bribing a former cabinet officer.

A jury of three women and nine men in the District of Columbia Supreme court sustained Dohney's plea that the \$100,000 he gave to Albert B. Fall, Harding's secretary of the Interior, was a loan and set him free.

The government charged that the money was given Fall to influence his award of the Elk Hills naval oil lease to a Dohney company.

Fall was convicted four months ago of accepting the money as a bribe and the contradictory verdict today has set up one of the most unique cases experienced in American jurisprudence.

Dohney arose as the jury filed into the courtroom and to its box. The jury men and women remained standing while the clerk asked if they had arrived at a verdict.

"Yes," replied the foreman. "What is your verdict?" asked the clerk.

"Not guilty," replied the foreman.

There was a tense stillness in the court room as Dohney and his counsel watched the foreman as he replied. The jury was polled and confirmed the verdict.

Justice Hitz dismissed the jury after thanking it for its service and left the bench. The jury took but one ballot. The jury came in at 12:07 p. m., having been out one hour and six minutes.

Mrs. Dohney pushed herself inside the rail and embraced Dohney. With tears streaming down their cheeks the two stepped to the jury box and thanked each man and woman of the jury.

After thanking the jurors, Dohney said that he had been confident of acquittal from the start.

Both Dohney and Mrs. Dohney were hidden from view as jubilant friends crowded about them. One of Dohney's associates exclaimed, "we told you your day was coming, and this is it."

Mrs. Dohney answered, "I knew it would when we came to court." As a line formed and fled by Dohney several women kissed him on the cheeks.

Mrs. Dohney, holding her arms about him, also kissed the man now free on alleged participation in the Harding administration oil scandals.

Two women members of the jury were among those who had clasped the hands of Mr. and Mrs. Dohney as they stood side by side leaning against a railing around the bench.

Carr Reported in a Semi-Conscious Condition Today

Reports received in this city today from the bedside of C. S. Carr, of Norfolk, who was critically injured in an automobile accident near Murfreesboro yesterday while on his way to Greenville, were to the effect that physicians were a little more hopeful concerning the injured man's condition.

Mr. Carr received a fractured skull, rib, knee and a broken arm. His son, C. S. Carr, Jr., was also injured, but it was not necessary that he be confined in a hospital after receiving medical aid.

Dr. R. L. Carr, brother, left this morning for Norfolk to be at the bedside of the injured man. Mrs. E. B. Fiklen, sister-in-law of Mr. Carr, and Charles Carr, a son, left yesterday immediately after first word of the accident reached the city.

Mr. Carr, who has been unconscious since the crash, was reported to have been in a semi-conscious condition this morning. The accident is said to have resulted from a blow-out that caused the car to overturn.

Scarface Al Capone Told To Get Out of Chicago Or Face Arrest Every Minute

Leader Of Underworld Told By Police Commissioner That 'Chicago In The Future Would Not Be A Safe Place For Him'

Chicago, March 22.—(AP)—"Scarface Al" Capone today had the choice of leaving Chicago or being arrested every time a policeman sees him.

He called at detective headquarters yesterday resulting in nothing but advice—advice from Deputy Police Commissioner John Stege that "Chicago wouldn't be a safe place for you, Al."

The police said they didn't want him, the state's attorney and the federal prosecutor said the same thing. Capone, coming out of seclusion for the first time since his release Monday from a Philadelphia penitentiary, called on them all.

State's Attorney John Swanson, not taking time to see the gang leader personally, sent word to his caller that he had no charge against him at present.

Assistants to the United States attorney told Capone that until his contempt of court case, on which he is out on bail, is called for hearing, the federal government had no desire to detain him.

Stege, who had accompanied Capone on his tour, then told him that police had no charges to bring against him, but would nevertheless arrest him on sight every time he appeared in public. He also mentioned, in his argument against Chicago as a permanent home for Capone, the large numbers of gang killings.

"Somebody might bump you off any time," Stege said, "and my boys would be bothering you all the time. You know how they are—hot-blooded and ambitious."

To show that he meant what he said, Stege called in all the members of his force he could find who had never seen Capone.

"There are no boys," he told them. "The next time you see him bring him in."

Capone suggested procedure would not be legal and Stege replied that Capone could always sue for false arrest. "That's been done before," Stege admitted. "Dingbat Ozerla did that. By the way, did you hear what happened to Dingbat?"

Ozerla was killed, gang fashion, two weeks ago.

"I don't want to sue anybody," Capone said. "All I want is not to be arrested if I come downtown."

"You're out of luck," was the reply, "your day is done."

To reporters, Capone obligingly explained where he had been since his release from the Philadelphia prison where he served 10 months for possession of firearms.

Winter Takes Belated Fling At Greenville

King Winter, making a belated appearance in this section of the country, took a terrific swing and completely floored the infant Spring in the annual clash of the seasons last night, and today a cold wave swept over Greenville and Pitt county, accompanied by a light snowfall that melted as rapidly as it hit the ground.

That the fling is here to stay a day or so longer was indicated this morning in the report of the weather department, predicting snow and colder in the interior, and rain, changing to snow and colder on the coast tonight. The report also forecast "mostly cloudy and continued cold Sunday, preceded by snow on the coast, and strong winds."

The snow started falling this morning shortly after 8 o'clock and continued incessantly until about 11 o'clock. The flakes were of normal proportion between 9 and 10 o'clock and gave evidence of real winter time.

Sleet and snow were reported from other sections of the state, but in only a few places was it reported as sticking.

North Carolina Keeps Ahead On Tax Collections

Raleigh, March 22.—(AP)—Income tax collections in North Carolina by the State Department of Revenue continue to lead receipts to the same date last year but federal collections are now \$600,000 behind the same date a year ago.

A. J. Maxwell, state commissioner of revenue, reported his collections up to today to be practically equal to collections last year through March 31. A total of \$6,813,105.67 has been collected this year, if \$175,000 in "installment payments" due in September is included. Actual receipts to today are \$6,738,105.67 for this year.

Court Raises \$10 For Hungry Girl

Chicago, March 22.—(AP)—Jobless and hungry, Margaret Black, 26, and not long up from Atlanta, Ga., wrote a bad check for \$10.

James T. Dale, who cashed it, had her arrested. She told her story in court yesterday, and Judge Erickson dismissed the charge. The court then took a collection totalling \$10, which was handed to Dale to cover the amount of the check. Dale presented it to Miss Black.

SAYS GOSPEL OF EDUCATION TO BE SPREAD

E. J. Coltrane Speaks At Final Session Of N. C. Education Association

Raleigh, March 22.—(AP)—The gospel of education will be carried into every corner of the state during the coming year by the North Carolina Education Association, E. J. Coltrane, superintendent of the Salisbury schools, told the association this morning at its final session when he was formally installed as president.

Mr. Coltrane emphasized the importance of commendation rather than criticism, a thing which the profession has suffered too much from, he said, and advised the teachers to learn and speak the language that the children and the citizens of the state can understand, taking time to give information and interpret what they are trying to do in the schools.

Prof. John H. Cook of North Carolina College for Women in Greensboro, the new vice-president of the association, called attention to the harmony and progressive policy of the session of the association.

The association adopted resolutions looking toward the continued educational progress of the state; commending to the Legislature an enlarged program of state aid for extended terms; endorsing the legislative program of both the State League of Women Voters and the State Parent-Teacher Congress as it relates to eight months terms and laws governing school attendance and labor of children under 16 years of age.

The annual session this year was devoted to the theme: "Education for a Larger Life," and this morning's topic to round out the program was "Integration of Home and School."

Mrs. Raymond T. Binford, president of the State Parent-Teacher Congress, brought a message from that organization and Dr. Garry Cleveland Myers, head of the division of parental education of Cleveland college, Western Reserve University, spoke on "Getting Together: The Home and the School."

Dr. Myers declared that the purpose of the Parent-Teacher Association is to interpret the school to the home and the home to the school, not to boss the school. He declared it to be the most important organization in the country.

"No matter how untutored a father and mother may be," Dr. Myers said, "they have something to contribute to their children." He placed before the teachers their responsibility. In this time he said when it has become news to read about a golden wedding day, to emphasize the importance of the home and of parents. They must, he added, instill a pride in and devotion to their parents in the pupils.

Dr. Royster Meets Tragic Death In Va.

Chapel Hill, March 22.—(AP)—The tragic death of Dr. James F. Royster, 50, who was fatally burned at a sanitarium in Richmond, Va., where he was a patient, brought grief today to Chapel Hill.

Dr. Royster was dean of the University of North Carolina graduate school. His death occurred yesterday.

Dr. J. H. Hall, Dr. Royster's physician, said the educator walked deliberately into a trash fire on the ground of the sanitarium. He was so badly burned that he died a few hours later.

A coroner's jury returned a verdict of burns self-inflicted.

Dr. Royster, who was one of the south's best known scholars, had been in bad health for several months and was on a year's leave of absence from the university.

While on a visit to London last year as a director of the American University Union, he was stricken with appendicitis. An operation was necessary, and it was believed the educator never fully recovered from its effects.

A graduate of Wake Forest college, Dr. Royster had in succession been teacher of English at the University of North Carolina, head of the English department of the University of Texas, and Kenan professor of English, dean of the college of Liberal Arts, and head of the graduate school of the University of North Carolina.

CITY AWAITS VANGUARD OF N. C. BAPTISTS

Plans Fully Completed For Centennial Celebration In City Next Week

With programs off the press and being assembled by the printers, Greenville today awaited the opening of the centennial celebration of the North Carolina Baptist State Convention here Wednesday and Thursday, March 26-27. The sessions will be held at the Memorial Baptist church and the East Carolina Teachers college.

Over a thousand people from this and other states are expected to be in attendance during the two days the celebration is in progress. They will include men high in the life of the denomination—men who have played an important part in the unparalleled growth of the church since that memorable occasion one hundred years ago when the state convention was organized by a handful of loyal followers in this city.

Arrangements have already been completed for handling the crowd, and when the vanguard begins arriving next Tuesday night, the local committee will have accommodations ready for them. The city has thrown its arms wide open to welcome the Baptists hosts, and it is expected that should attendance go over the thousand mark accommodations will be sufficient to care for every single person.

It will be the first time the Baptists have ever celebrated a birthday. While they waited a long time to do it they are planning to make this celebration count for all the missing ones both from the standpoint of interest and attendance. Other states of the southland have signified their intention of joining North Carolina in celebrating the splendid record of a hundred years of service to humanity, and they will send speakers to convey their congratulations and continued good wishes for greater success in the future.

The historic old edifice, erected in place of the building in which the first sessions of the convention were held, has been "dressed up" in anticipation of the arrival of the Baptists hosts, and the entire building presents a splendid appearance, fully in keeping with the importance of the occasion to be celebrated inside its walls next week.

All arrangements have been completed by state and local committees, and there is nothing to do at this time but mark time and wait until the final hymn has been sung bringing to an end the memorable event.

Stocks Nose-Dive Under Influence Of Low Money Rates

New York, March 22.—(AP)—The stock market, which has been moving into new high ground nearly every day this week under the influence of cheap money rates, went into a sharp nose-dive today as a result of heavy profit-taking and short selling.

A sprinkling of issues which had been marked up \$1 to \$5 a share to new high records in the early trading, quickly fell back as "bear" traders uncovered new weak spots and forced such stocks as Wool, worth, National Cash Register and Simmons Co., into new low ground for the year. Western Union broke \$18.50 a share to a new low at \$18.50 on publication of a poor January earnings statement.

The snow started a few minutes before eight o'clock and within an hour the tops of dwellings, automobiles, and lawns were covered with a white mantle. The streets and sidewalks, however, were not obstructed as the flakes melted as fast as they landed.

New York, March 22.—(AP)—By the calendar, Spring arrived in New York as well as in the rest of the country yesterday, but by the thermometer, it was only 18 degrees above zero here at six o'clock this morning.

The mercury had mounted to 24 by the middle of the forenoon, and the weather bureau predicted fair weather for the rest of today and tomorrow, with the wind diminishing and the temperature slowly rising.

Annual Cost of Disease To America Estimated At Ten Billions of Dollars

Dr. C. O'H. Laughinghouse, Secretary Of The State Board Of Health, Tells Of The Staggering Cost Of Sickness In Address To Kiwanians

"The annual cost of disease to the people of the United States is \$10,000,000,000 a year," said Dr. C. O'H. Laughinghouse, secretary of the State Board of Health, delivering the principal address at the regular twice-a-month meeting of the Greenville Kiwanis club at the Rotary building last night.

The speaker presented a mass of facts and figures concerning health conditions in this country, and brought home the fact that "an ounce of prevention is worth a pound of cure" in the final analysis of the situation.

B. B. Sugg presided over the session last night and the program was in charge of Dr. S. M. Crisp, who introduced the speaker of the evening. The singing was led by C. B. Rowlett. Mrs. Charles White rendered two solo numbers. She was accompanied at the piano by Mrs. Ray Tyson, Jr.

James B. Day, Jr., vice-president of the Norfolk National Bank of Commercial and Trust, was a guest of the club, and said that his institution found dealings with the people of this section very satisfactory "as they always repaid loans extended to them from time to time."

"In addition to the expense from medical services imposed by disease," Dr. Laughinghouse declared, "there is an estimated annual loss to the people of the United States of \$2,000,000,000 as a result of decreased wage-earning capacity. And this is not all—there is still further loss of permanently interrupted wage-earning capacity through postponable deaths, estimated to be \$6,000,000,000, making the total annual cost of diseases to the people of this country, \$2,500,000,000 for medical services, plus \$2,000,000,000 loss in wage earning capacity, plus \$6,000,000,000 death losses

North Carolina Republican Nominated By President Hoover To Succeed Justice Sanford; Nomination Received With Almost Universal Acclaim By Democrats And Republicans In North Carolina

Washington, March 22.—(AP)—The nomination of Judge John J. Parker, of North Carolina, as an Associate Justice of the Supreme Court is expected to be approved by the Senate with a minimum of opposition.

This view was expressed in many quarters today after study of the situation which found few signs of dissatisfaction and several pertinent factors to support the prediction.

Chief among the latter was the favorable attitude of the southern Democrats. Parker is a Republican, but Democrats from his section have a high regard for his qualifications and are pleased that the south has thus been recognized. In addition, the Republican regulars are expected to support the President's selection.

Thus, it was pointed out, whatever opposition might develop is expected to be confined to the independent Republicans from the west and it is by no means certain that objection will come from that quarter.

The independents are reserved judgment. Senators Borah of Idaho, and Norris of Nebraska, leaders of the group are awaiting complete information as to Parker's qualifications. From what they know of him already, they said, they are inclined to favor his confirmation.

However, observers here are mindful that the bitter fight over the confirmation of Chief Justice Hughes developed unexpectedly. When his nomination was sent to the Senate, it appeared that confirmation would come almost by acclamation.

ABOUT TOWN

The Pitt County Woman's Coun-

rived from exhibits at the fair, and
it is expected this effort will result

the coming years.

The fair offers the best oppor-
tunity in the world to set forth the
accomplishments of women of the
farms of the county, and it is to be
hoped they will take the advice of
the Council and see what they can
do along the exhibit line next fall.

The Department of Agriculture
has found that there is an over-
supply of flue-cured tobacco on
hand at this time, and this should
be a warning to farmers to watch
their step when they begin plant-
ing the next several weeks.

With this condition already ex-
isting, it is evident that another
large crop of tobacco would mean
nothing more than suicide for the
planter, and to avoid this situa-
tion there is nothing to do but to
put brakes on planting and hold
down acreage as much as possible.

The average planter has always
reasoned that "John Brown is go-
ing to cut acreage this year, so I'll
increase my acreage and make a
killing." And right here is where
the big mistake is made. This
kind of reasoning will not go this
season with conditions as they are,
and John Brown and all of his
neighbors had better heed the
warning contained in the statement
by the Department of Agriculture.

This is the time of the year to
clean up, therefore, it is hoped the
people of Greenville will do every-
thing possible to tidy up their
premises and get all set for the
hot summer months to come.

The city is doing everything pos-
sible to create a sanitary atmos-
phere in every district, but this is
going to be almost impossible with-
out the support and co-operation
of the public. The sanitary in-
spector may do his dead level best
to keep things clean, but his ef-
forts will be almost futile if the
people do not help.

If there is a condition in your
neighborhood that needs attention
and you do not know how to go
about effecting the improvement,
why not confer with the sanitary
inspector and seek his aid. That
is his job, helping keep things clean
and his advice will go a long way
toward improving the condition of
the various neighborhoods if he is
just given a chance of "showing
people how it is done."

The underprivileged child is one
of the greatest problems the nation
has to deal with at this time, and
it is only right that the matter
should receive the serious consid-
eration of the various clubs and
organizations right at this time.

Several of the clubs are contri-
buting annual appropriations to
this work, and the results they are
getting are most gratifying. Not
long ago one of the clubs decided
to double its appropriation realiz-
ing the actual need of more money
to carry on the work at this time.

It is to be hoped other organiza-
tions will do likewise and help
the youngsters in their effort to over-
come physical handicaps and to
become citizens which the nation
will be proud of.

People who have never shopped

mer and see the thousands of
splendid values which the local
merchants have to offer.
Greenville rightly claims the dis-

W. H. \$500 HOMESTEAD CHATTLES EXEMPTION?

The present law allows a \$500
exemption on household effects, but
owing to the present day ex-
pense of furnishing a home, I consider
that inadequate, and therefore urge
an increase to \$500.

Home furnishings are valued
much as homes are. The home
worth \$50,000 gets on the tax list
at \$20,000. Similarly does furni-
ture. We find many a home with
ten and fifteen thousand dollar
furnishings, valued for taxes at
about 20 per cent. The big exemp-
tion, you observe, goes to the well-
to-do. Now would it not comport
with honesty to give a decent ex-
emption and value the difference
for taxes as it ought to be? It is
bad government to levy on neces-
sities up to the hilt, and permit lux-
uries to get by for a song. An ex-
travagant home calls for extrava-
gant furnishings. It is this type of
property that is escaping its share
of taxes. Do we really desire all
property to bear its just share of
the tax burdens? Shall we go af-
ter the luxuries? Then see that
the tax assessors get on the job
and put over an honest job for the
people. Don't waste your time
talking about INTANGIBLES for
taxation until our assessors have
learned the art of finding and plac-
ing at proper value the TANGI-
BLES on the tax book.

The present tax law would not
be so bad if it were honestly ad-
ministered along lines suggested, do
you think?

ics in the state until 1925 when
he was appointed by President
Coolidge to the U. S. Court of Ap-
peals for the fourth district.

When informed yesterday of his
appointment, Judge Parker was
asked by a newspaperman how "it
felt" to be thus honored.

"It makes me feel very humble,"
the jurist replied. Questioned fur-
ther, he said:

"Naturally, I am pleased, but
there is no statement for me to
make. I have merely been appoint-
ed by the President, and the matter
is now up to the Senate."

Among prominent North Caro-
linians commenting upon Judge
Parker's appointment were Gov. O.
Max Gardner, and former Governors
Cameron Morrison and A. W. Mc-
Lean.

ANNUAL COST OF DISEASE TO AMERICA ESTIMATED AT EN BILLION DOLLARS

(Continued From Page One)

(2) to pay in part, (3) to pay nothing for medical care.

"According to the U. S. Bureau of the Census, in a study of 'hospitals and dispensaries' in the United States as of the year 1923, 49.7 per cent of patients treated in general hospitals were able to pay in full; 19.3 per cent of patients paid in part, and 31 per cent of patients paid nothing. It is reasonable to assume that approximately 50 per cent of the patients pay their physicians' bills in full, 20 per cent in part, and 30 per cent nothing at all."

After discussing several other phases of the public health question, Dr. Laughinghouse brought to the attention of his hearers the fact that the most advisable way

to fight the staggering cost of disease is through preventative measures. He declared that satisfactory and profitable life must have well labor. Sick labor is a liability to industry. He said the County Commissioners and the city Board of Aldermen control life on a vast scale than do any other people of the community.

He urged his hearers to give the public health question the important consideration which it deserves. He declared that the scientific, economic, sensible, profitable and only way to reduce materially the cost of sickness, the cost of crime and the cost of sin is to prevent it by beginning with the health of the babies while they are in their mother's womb. "To build as you should build, you must fight the first of preventative disease. To your tents, O Israel."

COTTON MARKET

New York, March 22.—(AP)—Cotton opened steady at an advance of 6 points to a decline of 4 points today and showed continued irregularity during the early trading. Buying on fairly steady Liverpool cables and favorable week-end reviews of the cotton goods trade, appeared to be just about offset by week-end realizing.

Fluctuations were quite rapid with May contracts after selling up to 15.85 at the start, declining to 15.72 and ruling around 15.76 at the end of the first half hour. The general market at that time was about 1 to 9 points net lower with the latter deliveries relatively easy.

Liverpool reported that Bombay buying and trade calling had been supplied by realizing but said there were fair cloth sales for India with some trade improving and that yarn sales were in excess of production. There were also reports of a larger business in the domestic cloth market.

Cotton on shipboard awaiting clearance at the end of the week was estimated at 115,000 bales against 122,000 last year.

STOCK MARKET

New York, March 22.—(AP)—The stock market enjoyed a temporary outburst of strength in which several oils and specialties were marked up to new high records today, and then turned reactionary under the weight of a large volume of profit-taking and short selling.

Most of the early gains of 1 to nearly 5 points were substantially reduced, and a rather long list of issues sold down 2 to 11 points below yesterday's final quotations.

There was nothing in the day's news to explain the sudden change in speculative sentiment. The market, however, has been moving into higher ground almost daily, in the fact of recurrent weakness of many specialties, and the technical position of many issues in which pools have been operating obviously has been weakened. Meanwhile, business has shown few signs of a general recovery.

Operators committed to the side of rising prices state that the recent rally in stocks has been discounting the expected improvement in business later in the year. Bullish operations have centered largely in stocks of companies with the best prospects of improved earnings. Bearish professionals, have found little difficulty in hammering stocks of companies, current earnings and prospects of which have fallen far short of earlier estimates.

The closing was weak. Total sales approximated 2,350,000 shares.

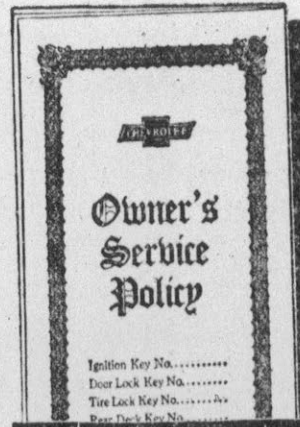

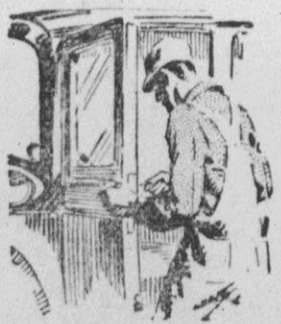
