SAYS CAPONE CANNOT STAY IN FLORIDA

Governor Carlton Declares State Will Not Shield Chicago Underworld Leader.

Tallahassee, Fla., March 24.—(AP)—Governor Doyle E. Carlton declared in a statement issued here today that Al Capone, Chicago gang leader, "will not establish headquarters in Florida."

Ascertaining that it is a question of being "for or against the gangster," the governor said the people "may take their respective sides."

Capone may for a time "wrap himself in the technicalities of the law," the governor added. "Other criminals have. He may for a time. He will not establish headquarters in Florida. His element will not take root here. His attendants will not be an armed guard to protect him in his past crimes against society."

The governor's statement followed action of Capone in securing a federal court injunction, restraining Florida sheriffs from carrying out an order from Governor Carlton to arrest the gang chief on sight and convey him to the state's border.

Capone was expected to arrive at his estate on Palm Island at Miami today.

The governor's statement follows: "I make no apology for my no retreat from my original stand. Florida as a playground in the nature of things is more liberal than some other states. It will not, however, become a haven for crooks and criminals or the headquarters for gangsters and gunmen. "Chicago, whose citizens have felt it necessary to take the law into their own hands for the protection of property and life, should be a sufficient warning. The issue is not as new here as some might think.

"Al Capone is the recognized leader of perhaps the most vicious gang that ever infested a city, a gang to whom the Constitution and the law mean nothing when it is to protect the property and life of the other fellow. So far as I am concerned, he is an outlaw and those who wish to court and fondle and make of him a hero can assume full responsibility for their actions.

"In the meantime the people may take their respective side. It is for or against the gangster. Those who wish to lend aid and comfort to such an element have the privilege. For me there is but one position and in this I expect the support of every thinking, self-respecting citizen, whose first interest is the welfare of the state."

Guy Martin Jones Passes Away Here; Interment Sunday

Guy Martin Jones, age 28 years, died here Saturday at 6 p. m., after an illness of several weeks.

He was the son of Albert and Elizabeth Lilly Jones and was born in Pamlico county. His father died when he was five years old and he was at Oxford Orphanage from the age of 6 to 18 years. He has been in Greenville for the past seven or eight years, engaged in the shoe repairing business, and was the owner of the Norfolk Shoe Repair Shop on Evans street.

He was married six years ago to Miss Myrtle Jones, who survives him, with one child, Helen. He also leaves his mother, Mrs. Elizabeth Jones of Craven county, three brothers and three sisters, George and David, of Pollocksville; Claude of Vanceboro; Mrs. Witherington, Craven county; Mrs. Lelia Jennings, Lumberton and Mrs. Thelma Oakley, Grimesland.

Funeral services were conducted from the home on Vanet street in West Greenville at 2:30 p. m., yesterday by Rev. E. L. Hillman, pastor of Jarvis Memorial Methodist church, of which he was a member since a boy at the Oxford Orphanage. Interment was in Greenwood cemetery, where the local camp of the Modern Woodmen of America had charge of the services at the grave.

Funeral bearers were Neighbors of the camp of Modern Woodmen.

Mrs. Jones with the aid of her brother, Dennis Jones, who has been employed by her husband in his business, will continue the Norfolk Shoe Repair business.

Gasoline Coach On New York Central Lines Hurls Sedan Against House Fifty Feet Away, Scattering Victims Three Hundred Yards Along Tracks.

Auburn, N. Y., March 24.—(AP)—Eight persons, seven identified as residents of Syracuse, N. Y., were in morgues here today after gasoline coach of the Auburn branch of the New York Central railroad plowed into their automobile last night at a crossing, the previous oil of which had caused it to be marked for elimination this summer.

The identified dead: Ruth Dunlavy, 17; Bertha H. Klerks, 19; Mrs. Dorothy Klink Parks, 25; Earl J. Besaw, 24; Frank Straus, 23; Edward Chelgren, 20; Darius Auletta, 25.

One woman was unidentified.

The party rode in a light sedan into the path of a gasoline coach of the Auburn branch of the New York Central railroad at Shoemaker crossing near here, last night and their bodies were scattered for 300 feet along the tracks. Identification of the young women was difficult.

The coach, traveling downgrade at high speed, caught the sedan broadside, hurled it against a house 50 feet away. Twenty-five or 30 passengers in the coach were shaken up but none was hurt.

Railroad officials said that although a red danger signal was flashing at the time, the sedan sped full into the path of the heavy coach. The front end of the railroad car was badly damaged, the control machinery being jammed so the coach traveled nearly three quarters of a mile before it stopped.

Several Flights Across Atlantic Ocean Planned For The Summer Months

Four West to East Crossings By Airplane Announced and One From East to West; British Dirigible and Graf Zeppelin also to Fly

New York, March 24.—(AP)—The gulls which float in lazy flight over the North Atlantic airlines will have visitors again this spring and summer, as they have each year since 1927, if ambitious plans announced by fliers of many countries are carried through.

Four west to east crossings by airplane have been announced and one from east to west. The R-100, giant British dirigible, probably will make a London-Montreal flight this summer and a round trip cruise to Lakehurst via some South American port is planned for the Graf Zeppelin, already a friend of the airwise North Atlantic gulls.

The lone east-to-west contingent, ambitious to win through where only the Junkers Bremen has been successful is Dieudonne Costes, holder of the world's distance record and conqueror with Le Brix of the South Atlantic.

The French air ministry frowns on further trans-Atlantic "stunt" flights however and it may be official pressure will be brought to block the contemplated journey of France's ranking flier.

Planning flights from west to east are John Henry Mears, holder of the round-the-world record of 22 days with the late C. B. Collier, Herbert Fahy, test pilot of the Lockheed Airplane Company, Col. Gustavo Leon, Mexican army ace, and Clifford McMillan, American commercial pilot.

McMillan, who has flown in air derbies in the country plans a New York-London flight, a crossing never before made, and if successful, may continue on around the world. Mears and Fahy's crossing from Newfoundland to London would be only stages in world flights. Col. Leon plans a New York-Paris hop, along the trail that Lindbergh blazed. All of the flights are dependent on developments, financial and others.

Chicago, March 24.—(AP)—Texas Guinan has made her last appearance at her Chicago night club and her first at the Chicago police station.

The Green Mill, north side cabaret which has heard the cry of "hello sucker!" since last December, was closed by police order after Miss Guinan and others had been questioned for several hours concerning their shooting early yesterday of Leon Switzer, owner of the club.

Harry O. Volter, business manager for the internationally known night club hostess, was arrested in connection with the shooting, along with his reputed bodyguard, Arthur D. Reed. Police said both of them are ex-covicts. Police did not detain Miss Guinan who came to the station and volunteered the information that she was on the dance floor helping entertain the guests when the shooting occurred in the cabaret's office.

Man Breaks Out Of Coffin And Produces Panic

Mexico City, March 24.—(AP)—Juan Garcia, 24, a clerk living near Atzacapotzalco, Mexico City suburb, saved himself from the grave by nearly sent his startled relatives there when he suddenly broke from his coffin, while being transported to a cemetery.

Following an extremely heavy meal with wine, Garcia suddenly collapsed and a physician pronounced him dead.

THREE SLAIN BY POLICE AT BUFFALO, N. Y.

Wounded Automobile Thief Escapes While Hospital Companions Die

Buffalo, N. Y., March 24.—(AP)—Police today were searching for a wounded automobile thief who escaped from a hospital while two of his companions were dying in the operating room and the body of the fourth was being taken to the morgue. The identity of the missing man is unknown to the police.

The casualties occurred yesterday in two encounters between automobile thieves and the police. In the first the man killed was Walter Krajewski, 21 years old, for whom the police had been searching as the suspected murderer of a patrolman, during the holdup of a chain store last February.

The second clash occurred an hour later, and the same police squad did the killing.

The dead are Henry Pietrowski, 20; Edward Dombkiewicz, 17, and John Drazdowski. Dombkiewicz is a brother of Peter, who recently cut the throat of David Glikstein, jeweler, in Supreme court during trial of the "Blonde Bandit" gang.

The pursuit of the second stolen car covered several city blocks and during the chase a fusillade of revolver and riot gun shots were exchanged between the pursuers and the pursued.

The car containing the fugitive, craned into the curb and hit a telephone pole when Pietrowski, at the wheel, received a charge of shot in the back. The car thieves continued to fire, the police declare, and they returned it until the fugitives' guns were silenced.

Pietrowski was found dead at the wheel. The three other bleeding from many wounds, were hurried to the City hospital. It was thought that the man who later escaped was done for, and the surgeons were giving their attention to the other two who subsequently died. ARMS PARLEY WORKING OUT COMPROMISE

London, March 24.—(AP)—Secretary Stimson and Prime Minister MacDonald got together at 10 Downing street today with the idea of trying to work out some Franco-Italian compromise which will be sufficiently interesting to Andre Tardieu to draw the French Premier back to London.

The American and British delegation chiefs were taking M. Tardieu at his word that he would return to the conference when there was something worthwhile for him to consider. Colonel Stimson was accompanied by Ambassador Morrow and Senator Robinson.

Without promising to draw conclusions, it set forth the weak spots and the strong spots in statistical fashion giving, when available, comparisons with the figures for the close of 1929 and the corresponding period of last year.

In assembling the figures, Barnes said, he learned that "the importance laid upon construction as an influence in restoring industrial balance has not been overemphasized" and that for a revival of construction "the first requirement is adequate and reasonably priced credit."

The reports were received, he added, at a "time when we have passed through a sufficient portion of the year 1930 to make possible some formulation of reasonable expectations."

At the same time, the Federal Reserve Board issued its monthly bulletin on business and financial conditions, saying that industrial production had increased, employment while wholesale commodity prices and money rates had continued to decline.

Seven Persons Burn To Death As They Sleep

New York, March 24.—(AP)—Seven persons, six of them members of one family, burned to death as they slept and an eighth, a young son of the family, escaped with severe burns and bruises when fire enveloped their home in Bayside, Queens, early today.

The dead are Mr. and Mrs. John Fliss; four of their children, three girls and a boy, ranging in age from four to 17 years, and Charles Jerzon, 43, a boarder.

The entire family, asleep on the second floor of the wooden two-story one family house, was trapped by the fire which broke out in the basement, spread so rapidly throughout the building that it was burned before fire apparatus arrived.

Stanley Fliss, 14, was burned before he jumped from his bed. He leaped out of a second story window and ran a half mile to the nearest house. He was in such a condition of hysteria that he was unable to give an account of what happened. The boy, bruised by his jump, was taken to a hospital.

Parker Nomination Sent To Committee

Washington, March 24.—(AP)—The nomination of Judge John J. Parker of North Carolina, to be a Justice of the Supreme Court, was referred today by the Senate judiciary committee to a sub-committee headed by Senator Overman, Democrat, N. C.

Overman said he would call an early meeting with a view to getting a report back to the whole committee in time for its meeting next Monday.

Overman has endorsed Parker. No official protests have been received. Members of the judiciary committee, however, did receive a letter today from a Miss Mary F. Speers, of this city, protesting against a decision rendered by the Circuit Court of Appeals of which Parker is a member. She complained he had the endorsement of the "oil and liquor interests."

HIT AN DRUN DRIVER HELD AT CHARLOTTE

Charlotte, March 24.—(AP)—E. H. Cotton, 37, was held in jail here today in default of \$5,500 bond as the driver of a car which ran over W. P. Coalsou, 26, manager of an automobile tire agency, and injured him fatally and then sped away.

Cotton was charged specifically with manslaughter, driving an automobile while intoxicated and hit-and-run driving. He was arrested after G. E. Peele, an employe of the tire agency, had given chase to the car which struck Coalsou.

WICKERSHAM SAYS LAW CAN BE ENFORCED

Chairman Of Law Enforcement Commission Appears At Senate Investigation

Washington, March 24.—(AP)—Chairman Wickersham of the Hoover Law Enforcement Commission believes the prohibition law "can be measurably enforced although human appetite is widespread."

This prediction by Wickersham was given the Senate judiciary committee when he appeared before them in executive session.

Testimony of that hearing was made public only today.

Wickersham said a fair test would have to await an opportunity for enforcement under the Justice Department as proposed in legislation now before Congress.

"Until that is done," he asserted, "no one can say absolutely whether the law can be or can not be enforced."

"I think it can be measurably enforced, although human appetite is widespread. We all know the history of efforts to enforce regulation of the use of liquor which resulted finally in prohibition. It is a long and somewhat disheartening history."

The judiciary committee, which is considering a resolution by Senator Norris, Republican, Nebraska, for a Senate investigation of prohibition enforcement, today called Attorney General Mitchell to appear before it next week in this connection.

The Wickersham testimony disclosed that the commission chairman believes there has been a "steady improvement" in dry enforcement, particularly during the last year.

It disclosed also that he is advocating a modification of the Jones act, passed a year ago, which increased the penalties for liquor law violations.

Wickersham said the Jones act "covers the offenses indiscriminately under the classification of felonies with the exception of possession and maintaining a nuisance."

"That is contrary to what I think is sound legislative policy," he continued. "I do not think you ever can enforce laws more effectively by putting extreme penalties on minor violations of the law."

Senator Walsh, Democrat, Montana, inquired into the administration of this law, and Wickersham testified the judges and prosecuting officers had used "discretion" in the application of the heavy penalties so far as minor offenders were concerned.

MR. HIGGS DISCUSSES PROBLEM OF TAXATION

Mr. Editor: "In 1920 no state except South Carolina had higher farm real estate values, when stated in terms of pre-war values than North Carolina. In 1920 no state except Florida shows farm lands as much above pre-war level as North Carolina. It might be added that Florida's peak prices was not reached in 1920 but six years later."

"The inflation only slightly less in North Carolina than in South Carolina in the nine years since 1920 South Carolina farm values have fallen back almost to pre-war level whereas North Carolina land values have maintained at a higher level relatively to the pre-war prices than in any state except Florida." In ten states present values are below the pre-war prices.

The above is taken from News Leader published on July 10, 1929.

From the table published in the News Leader I find "Farm real estate values in terms of pre-war values North Carolina 1920, 223; 1929, 171. South Carolina 1920, 230; 1929, 110."

It appears that with the exception of Florida (and that state should not be considered since much of Florida farm land was cut up and sold in town lots) judged by pre-war levels, North Carolina is assessed higher for taxes than is the farm land of any other state in the Union. With a combination of short crops, low prices, and high taxes it is no wonder that thousands of farms are being sold for taxes and that our farming industry as a whole is on the verge of bankruptcy.

The foremost question in the state today is the matter of taxation. Land owners are demanding a reduction of taxes on real estate. Indications are that this is going to be the chief issue between the two parties. A hungry man accepts bread from the hand that offers it. If the Democratic party refuses tax relief on real estate the owners will gladly accept it from the Republican party.

The Pitt County Woman's Council met at the Woman's Club Building in Greenville on Tuesday, March 18, at 2:30. The meeting was presided over by Mrs. O. H. Jackson.

All clubs except two responded to the roll call. Miss Nice then asked each president to inform her club of the following:

(1)—The Bureau of Standards will initiate a nation-wide survey of accidents in the home to cooperate with the general Federation of Women's Clubs. Mrs. C. Kimmon asks that the Home Demonstration Clubs make this survey also.

(2)—Each club shall appoint a garden leader to check on gardens of individual club members once each season and reports will be mailed to the state office at the end of the year, this being done to determine results of the Live-at-Home program.

(3)—The Chilean Nitrate Fertilizer Company is offering 100 pounds apiece to three garden demonstrators in the county. Demonstrators are as follows:

(4)—The Curb Market takes on new life in the early spring. Every seller is his own advertiser and should grade, clean and display his products to the very best advantage.

(5)—Each club was asked to make plans early for the fair as Mr. Dall states there will be a fair if you'll all help, so let us all put forth an effort to make a novel and educational showing.

(6)—Mrs. D. A. McCormick, treasurer of the N. C. Federation of Home Demonstration clubs, reminds us that it was voted at the state meeting last July that each club pay 25c dues this year instead of \$3.00 per county. The county secretary was asked to collect these dues and send to Mrs. McCormick by April 1.

Plans for the Short Course this summer were discussed. The following committee was appointed to help with the plans:

Mrs. B. L. Tyson, Red Oak.
Mrs. O. H. Jackson, Winterville.

A Recreational Leaders' School will be held by Miss Ella Gardner on April 14 and 15 in Greenville. Announcements will be made.

Each club secretary then reported with a report of club work dating from December 1, 1929. Gratifying results were evident in each report and a brief summary will be given.

1—Arthur Club has a new club room, with furnishings, made possible by their award at the Pitt County Fair. It is also used as a first-aid room for the school. Five pints of cream were furnished for the live-at-home supper in December, also salt and pepper. Mrs. Mack Smith is garden leader for the year.

2—Winterville Club gave a wonderful report. Aside from the regular program, they are working to beautify the highways and unsightly places. Eleven have helped to plant ivy, rose vines, etc., in order to hide the unsightly junk piles. A group of six boys and seven girls, calling themselves the "Evergreen Community Club" have organized themselves to help beautify the lawns and roadsides.

3—Hopewell Club gave a gratifying report of work accomplished outside of club meetings. They held a called meeting and painted jar. They are working hard to beautify their home lawns. Eighty-five articles dealing with arts and crafts were reported. Every member has planted a garden.

4—Remston Club has held two called meetings. Miss Parker was present at their February meeting and spoke on a year-round garden. Mrs. Edwards was selected to have a model garden and to can vegetable but, a variety of 57 hints of fruits and vegetables allotted for each member of the family.

5—The Griffin Club was organized on February 28, 1930. There were 19 members enrolled and after the election of officers, Miss Nice showed a number of decorative stitches and seam finishes.

6—Red Banks did the decorating for the Live-at-Home supper in Greenville December 18, 1929. Seventeen attended the supper. An emergency kit was purchased for the school, also two hat blocks for the club. Twelve hats have been made and fifteen books read. There

is a balance of \$54.85 in the treasury. Miss Carrie Wynne was appointed garden leader.

7—The Simpson Club furnished four pounds of butter and three gallons of milk for the live-at-home supper in Greenville. Nine members attended. A live-at-home program was held in Grimesland High School on February 13, 1930. The Parent-Teacher association cooperated in planning the program.

8—Red Oak Club made and furnished the place cards for the live-at-home supper in Greenville. They are working to raise money in order to build a club house. Parties have been held to attain this project and individuals of the community have been generous in responding. Great interest is also shown in gardening and two members sell produce at the curb market.

Fifty-eight books have been read and seventy-seven articles dealing with arts and crafts were reported as being made, also eighty-six pieces of clothing for ladies and children, several of the decorative stitches being used.

There are 15 4-H girls' clubs with an enrollment of 431 members. Each girl is to make fair articles by April 25. A club uniform will be made by each girl as a part of her work for this unit. The public is invited to the achievement program the 4-H girls will hold in Greenville at an early date.

At the conclusion of the meeting, spiced tea was served by Miss Nice. Mrs. W. H. Woolard and Mrs. E. F. Arnold accompanied us with puffed accompaniment to the delightful beverage. Those present were asked to help advertise puffed, thereby assisting the Woman's Club in paying for the handsome building in which our meeting was held.

STOCK MARKET

New York, March 24.—(AP)—Bullish forces regained control of the price movement in today's stock market after an early period of irregularity. Resumption of big scale pool operations lifted a score of specialties to 12 points to new high records, while gains of 1 to 3 points were scattered throughout the general list by early afternoon. There were a few soft spots here and there, Montgomery Ward and American Locomotive sinking to new low levels, but they failed to cut much of a figure in the day's proceedings.

Call money held steady at 4 per cent with no immediate indications of a change in rate. A nominal calling of loans was reported, but these were replaced with new funds.

The summary of business conditions published by the National Business Survey Conference, even though it made no definite predictions of future trends, had a cheerful effect on speculative sentiment. While current business in many lines has been disappointing, operators on the long side appear to take the position that the recent decline in securities values generally over-discounted whatever trade recession has taken place.

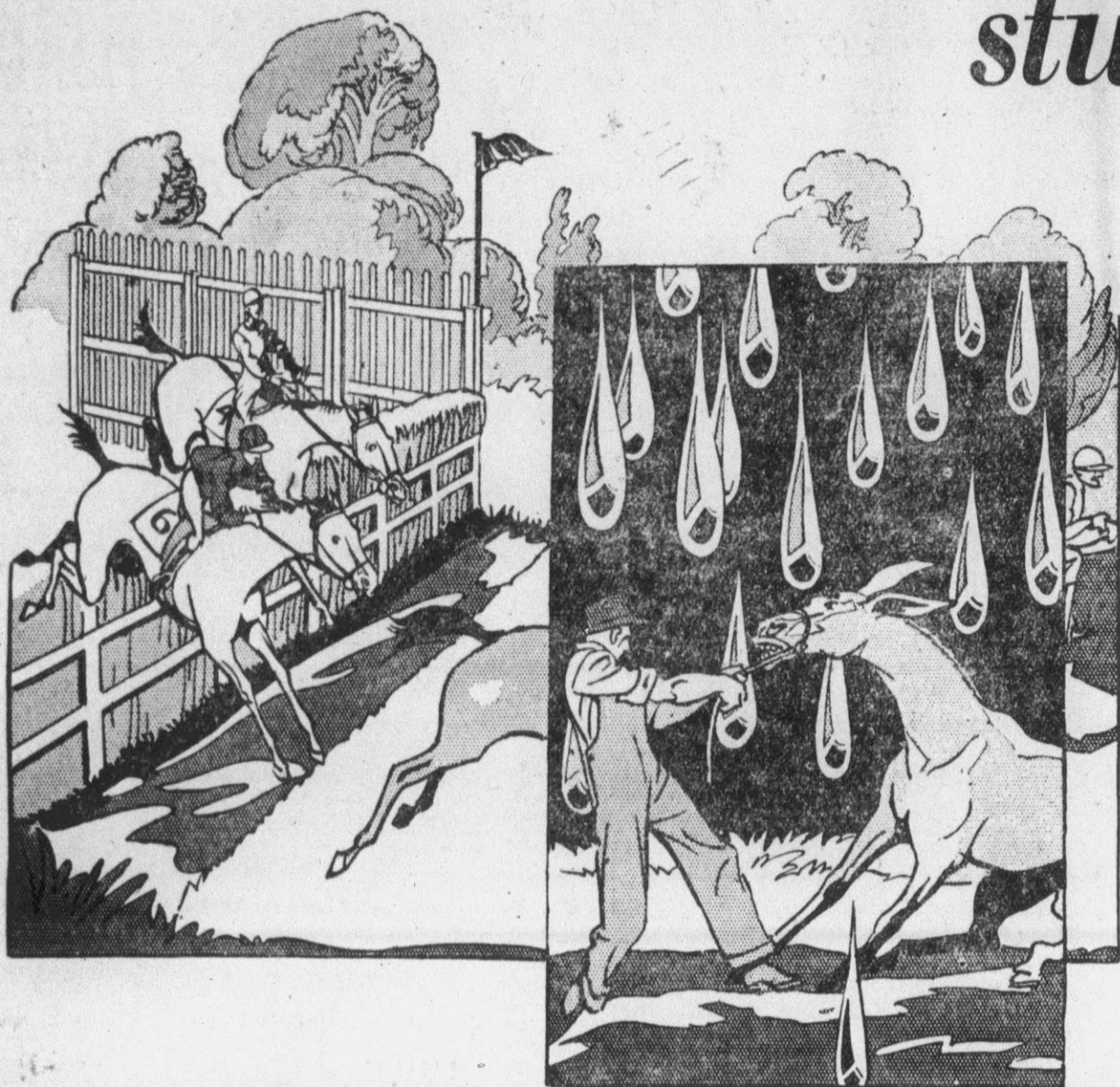
