RELIEF.

When nearly two hundred citizens will voluntarily gather in the court house and remain there for three hours discussing taxes and the welfare of the county, as was the case with today's meeting, surely it is a healthy sign for it shows that our people are becoming interested in the affairs of their government and are willing to give their time and attention to citizenship. Despite the length of today's session that convened in the mid-forenoon, and lasted until the afternoon, there was not the usual hot-air wrangling that accompanies such meetings, but a sane and sensible discussion of affairs as they exist and an effort at a solution of our problems in a safe and sane way. Just such an attitude on the part of our people has been sadly lacking, though badly needed, for a long period of years and this is more reason for rejoicing that at last our people are beginning to think and to see the light of their duties as citizens.

It is a known fact that at every session of our legislature in history there have been lobbies of one kind and another representing almost every phase of business and industry except that of Mr. Average Citizen, and in today's meeting we see the beginnings of a state-wide organization that will bring light to our people and present a united front to our next and future legislatures. The two most important things now before our people are that we cannot continue to demand grand and luxurious things in the way of government without paying for them, and the next thing is to see to it that once we have decided on the kind of government we are to have, every piece of every kind of property pays its just share of the burdens.

In the organization of the North Carolina Tax Relief Association composed of the individual units of the one hundred counties in the state we see the bringing about in our state not only a better and more economical administration in all branches but a more just sharing of the burdens. The organization is now in its infancy but the future just ahead is bright and its accomplishments for the common people of the state should be unlimited. Our people are beginning to see the light that points the way out of the darkness of our dilemma.

Persons who attended the program of mass singing at the East Carolina Teachers college last night, no doubt were greatly impressed by the splendid showing made by between five and six hundred representatives of county schools. The youngsters presented a program that would have been a credit to a community where mass singing has been practiced over a period of many years, and the county school system is to be congratulated upon the achievement.

Mass singing is demanding more attention in the schools of the country at this time as it has a tendency of increasing children's appreciation in the art of music. It also awakens the public to the wonderful results to be obtained from activities of this kind and should hold the attention of the people for many years to come.

The fact that six hundred children entered the chorus is sufficient justification for the statement that they are interested and that they will continue to be interested providing they are given a chance. The schools should continue this singing program each year and encourage the children in every way possible.

Greenville is host today to the district music contest and several hundred children representing various schools of the section are present to vie with one another for higher honors.

The winners in the elimination contest will have the honor of going to Greensboro to participate in the finals. This is an honor coveted by every town of the district and it is safe to say there will be some real talent represented.

Greenville is always glad to have the honor to entertain a gathering of this kind and it is to be hoped the students will meet here for many years to come, striving as they did today, to accomplish some distinction in this branch of art.

It is indeed good news to learn that final surveys are under way on the Cox Mill road extension through Creeping Swamp to the county line. This extension is ten miles long and will be of invaluable aid to farmers of the district in reaching Greenville during the busy harvest season.

When the link in Craven county is completed Greenville will be connected with New Bern by a complete hard surface system, greatly expediting travel from this city to the Craven county capital.

The completion of the two roads will speed up travel between the north and the coast and the distance will be reduced to no little extent. These two links have been needed for a long time and the sooner they are completed the better the people of this section of the state will like it.

With the coming of real spring-time, the people of this great trade territory are turning their attention to wearing apparel for the hot days to come. They should not fail to consider the many advantages which Greenville, "the principal shopping center of Eastern North Carolina," offers, and would do well to inspect local stocks before buying elsewhere.

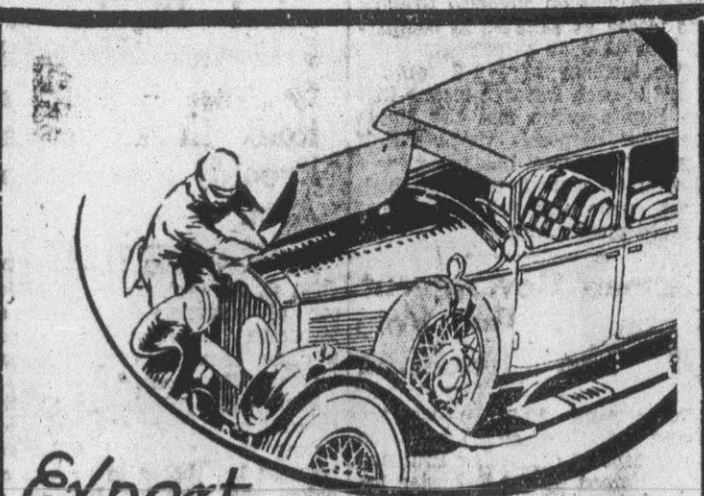

Market Report

Cotton--Stocks--Grain

COTTON MARKET

New York, April 12.—(AP)—Cotton opened steady today at a decline of 7 points to an advance of one point. There was a some realizing in the near months apparently, and perhaps a little selling on relatively easy Liverpool cables and a favorable view of recent weather conditions in the south. Offerings were absorbed by week-end covering and the market held fairly steady at the end of the first half hour with the active months ruling about 3 points net lower to 1 point higher.

It was reported that trading on the stock exchange in Tokyo had been resumed, but there still seemed to be some nervousness here over the reports of unfavorable economic conditions and labor troubles in one of the large Japanese cotton mills.

Cotton on shipboard awaiting clearance was estimated at 117,000 bales against 108,000 last year.

GRAIN MARKET

Chicago, April 12.—(AP)—General selling, much of it a stop-loss character, sent the wheat market reeling downward today, notwithstanding that Farm Board allies were conspicuous buyers. Nearly complete absence of export and domestic milling demand added to the bearish effect of weather changes that were construed as incentives toward lower prices. Speculators led the late selling, whereas purchasing toward the last was confined largely to traders who previously had been sellers and were therefore in a position to collect profits.

Wheat, closed heavy, 1-7-8 to 2-3-8 lower than yesterday's finish; corn closed 5-8 to 1-3-8 down; oats 3-8 to 5-8 off and provisions showing 5 to 10 drop.

STOCK MARKET

New York, April 12.—(AP)—Extensive week-end readjustment of speculative accounts brought about considerable irregularity in price movement in today's session. Such selling as occurred was largely a correction of top-heavy speculative positions built up in the last week or two, with the market generally showing underlying strength and as yet giving no evidence of any definite change in the general upward trend which it has shown this year.

Trading was moderately heavy in volume, the day's sales running close to 2,000,000 shares.

Allied Chemical was again an outstanding feature, soaring more than 12 points to a new high at 343 on top of a gain of 14-18 points yesterday. The stock had sold as low as 255-3-4 this year. Monsanto Chemical advanced nearly 4 points. Recent strength of the chemical shares has been influenced in part by the increasing use of chemicals in industry and agriculture.

Public utilities, which were the chief object of selling attacks in the early trading, developed several points of strength as the market drew to a close. American and Foreign Power and Detroit Edison were marked up nearly 4 points. American Water Works converted an early loss into gain and early recessions of 1 to 3 points in many of the other recent leaders were cut down. International Telephone crossed 73 on a heavy turnover.

Several of the department stores issues responded to reports of heavy pre-Easter trade. Hahn and Abraham & Straus moved into new high ground. R. H. Macy was heavy.

DEMPSEY OFFERS

CARNERA \$50,000

Chicago, April 12.—(AP)—Jack Dempsey has offered Messrs. Duffy and See, managers of Primo Carnera, \$50,000 and a percentage of the gate, for an outdoor bout in Chicago some time this summer.

The former heavyweight champion, however, does not propose to meet the Italian himself, but has lined up George Godfrey, huge negro from Leipsville, Pa., as a ring of meat thieves operating in North Carolina.

CHICAGO CUBS

HOMETO MAKE

REAL SHOWING

New York, April 12.—(AP)—To support the theory that everybody loves a winner, the baseball experts have given the Chicago Cubs as big a vote of confidence in the forthcoming National League race as they did the Athletics in the American League scramble.

The results of the fourth annual Associated Press consensus, compiled today from the opinions of more than three score major league baseball writers and sports editors, show an overwhelming majority satisfied to string along with the 1929 pennant winners.

The A's have it by only a slight margin. Whereas 60 out of 63 named the Mackmen to win again, 54 out of 66 have gone on record as favoring the Cubs to repeat.

In the American League, the remaining five votes for first place went to the Yankees. In the National, the Pittsburgh Pirates have nine votes for first place; all cast before Grimes was traded, while St. Louis gets two and the New York Giants one.

On the basis of the general balloting, the experts look for a much tighter race in the National League, with at least two formidable "dark horses" representing Brooklyn and Philadelphia.

It took a pennant victory by the Cubs last year to finally make them favorites. Joe McCarthy's men were picked fifth in 1927 and finished fourth, selected for third position in 1928 and finished third. Named as runners-up to the Giants last year in a very close finish, the Bruins completely upset the dope by making it a runaway, while the Giants skidded down to third.

This is how the Associated Press consensus predicts each league's order of finish:

National — Chicago, Pittsburgh, New York, St. Louis, Philadelphia, Brooklyn, Cincinnati and Boston.

American — Philadelphia, New York, Cleveland, Detroit, St. Louis, Chicago, Washington and Boston.

The Chicago Cubs, with the hitting and pitching they possess, appear to dominate their league in spite of infield accidents and uncertainties as to the condition of Bell and Hornsby. Meanwhile, the chances of the club picked to give them the toughest fight, Pittsburgh, seem to have been hit by the release of Burleigh Grimes to Boston.

Ransomed Oil Man

Reaches Mazatlan

San Angelo, Tex., April 12.—(AP)—Again escaping from the clutches of bandits who destroyed two railway bridges and attempted to halt a train upon which he was leaving Mexico, J. E. Bristow, ransomed San Angelo oil and mining operator today was expected to depart from Mazatlan, Mexico, for his home here.

The wife of the 60-year old American whose experience in the wild country of western Mexico have excited the interest of the nation, yesterday received a telegram from her son, Gordon Obrie Bristow, telling of the safe arrival of the rescue party at Mazatlan.

Gordon Bristow, a former star football player at the University of Oklahoma, succeeded Wednesday in obtaining release of his father for \$15,000 ransom. The elder Bristow was held for a month by the robber chieftain, Cruz Delgado, near Ahuacatlan, Nayarit.

The second attack on the American mine owner and his party was made, 35 miles south of Escuinapa, a mountain village about half way between Tepic, Nayarit, and Mazatlan.

When the train halted, upon reaching the first bridge, which had been burned, a number of armed natives were reported to have appeared along the right-of-way. They were routed by an escort of Mexican troops which is accompanying the Americans out of the danger zone.

TAX MISSION DISCUSSED

AT MASS MEETING HELD IN COUNTY COURTHOUSE HERE

of this commission would be to check over the budgets of the various departments when submitted to the county commissioners and ascertain whether or not they were in keeping with the county's ability to pay. This commission likewise would interest itself in the true valuation of property and assist county commissioners in the hearing of appeals from tax-payers.

Upon closing his address, the meeting was thrown open for election of delegates to the Raleigh meeting and the adoption of resolutions to be presented at that meeting. Delegates were, R. L. Johnson, J. E. Winslow, J. C. Gallows, J. W. Martin, Marcellus Smith, alternates, F. M. Wooten, M. O. Blount, J. R. Farnage, J. L. Perkins, R. L. Davis.

The matter of the appointment of a tax commission composed of representatives of various townships, outlined by Judge Wooten, was then put into the form of a motion and unanimously adopted. The appointment of the five members for each of these townships will be made at a series of meetings to be held within the near future, and the work of this commission will begin at once.

Getting back into the resolutions to be adopted talks on the various issues were made by J. W. Holmes, E. G. Flanagan, C. W. Hearne, S. J. Everett, P. C. Hard-

ing, M. K. Blount, K. A. Pittman, D. J. Whichard, J. W. Martin, W. H. Rogers, R. L. Johnson and others.

In addition to urging the strictest economy in every phase of public work in county, state and municipality, these speakers by suggestion and motion presented the following items which were included in the resolutions of instructions to our representatives at the state meeting of the Tax Relief Association:

1. That the State suspend and refuse for the next two years any appropriation for further expansion of the State institutions of higher learning. That the expenses for maintenance of such institutions be carefully scrutinized and if possible greatly reduced.
2. That the present law which exempts from taxation stocks and bonds and foreign corporations be repealed. That all such property be listed on the tax books at its true value. That the taxes thereon go into a state fund to be allocated to the various counties in the state.
3. That the first act of the 1931 Legislature be a revaluation of all land, especially farm lands, placing it on the tax books at its true value in money without regard to the amount of revenue to be raised.
4. That one half of the surplus of the State Highway Commission now derived from the original four cents gas tax be allocated to the counties to relieve the counties of the tremendous burden of taking care of its rural roads which are not a part of the state highway system.
5. That after placing land on the tax books at its true value in money, the following sources of revenue to make up the deficit be sought: Increase on corporation income tax; increased franchise tax of electric power companies; sales tax on luxuries.
6. To make the best efforts to show the governor and the state government that they should avoid if possible the necessity of raising an additional four million dollars for next year's operation as set forth in the budget estimate, and urged them to reduce rather than increase expenses in every branch of government.
7. To urge the passage of the bill now before Congress for a remission to our state ten per cent of the tobacco tax now collected by the federal government from this source.
8. To seek the abolition of the penalty on taxes prior to the dates of the advertising of tax sales.

A committee composed of F. M. Wooten, D. J. Whichard, and R. W. Smith was chosen to draft resolutions covering the above line of thought for presentation to the state today.

In a brief address following the adoption of the resolutions, Hon. F. C. Harding spoke principally to the candidates for the State Legislature. He declared that from these resolutions the candidates should gain the thoughts and wishes of the people of Pitt county and he urged that, whoever was elected to these important positions to carry out these wishes of their constituents.

The meeting then adopted a resolution petitioning the County Board of Commissioners to direct the tax suits and tax cases now pending to be continued from court to court until efforts at relief in the way of extended time for payment of same could be procured from the next Legislature through amendment of the present county finance act under which these cases were filed.

FIGHT IN MONTANA

Butte, Mont., April 12.—(AP)—Primo Carnera, Italian boxer, who has been knocking out opponents almost before the cash customers get comfortably seated, will not be allowed to fight in Montana.

Joe L. Markham, of Butte, chairman of the Montana State Athletic Commission, today ordered J. A. Livingston, also of Butte, secretary of the commission, to notify promoters of the state of a ban on the 270-pound "man mountain."

Sponsors of Carnera's present western tour recently attempted to schedule a bout for him in this city, but insisted on naming the opponent. Butte promoters refused the terms. More recently, Havin promoters sought the commission's sanction to a proposed fight for Carnera at that city.

Kinston.—(AP)—Routine cases occupied the attention of Superior court today following the continuance, for the third time, of the trial of John Summerlin, Wayne county filling station proprietor, charged with fatally shooting Owen Stroud, a policeman, at the fair here last fall. The case had been set for trial today but motion for continuance was allowed by Judge Henry A. Grady, presiding.
