MAN AND HIS ENCHANTRESS HELD IN JAIL

Otto Sanhuber and Mrs. Oesterreich Indicted for Slaying Her Husband

Los Angeles, April 18.—(AP)—Otto Sanhuber, who imprisoned himself in Garrets for ten years in order to be near Mrs. Walburga Oesterreich, the woman he loved, today again was close to his alleged enchantress, but both occupied cells in the county jails.

The pair was indicted jointly yesterday by the grand jury for the murder of the woman's husband, Fred Oesterreich, retired Milwaukee, Wis., garment manufacturer, August, 22, 1922.

Authorities said their arraignment in Superior court signaled solution of Oesterreich's slaying which, because of apparent lack of motive and absence of clues, mystified police for more than seven years.

Sanhuber confessed that he lived like a bat in attics of the Oesterreich homes here and in Milwaukee from 1911, when he first met Mrs. Oesterreich, until more than a year after he had slain her husband.

In a confession Sanhuber said he heard Mr. and Mrs. Oesterreich quarreling in August, 1922, and crept down and slew Oesterreich. Afterward he crawled back to his hideout and lived in secret as an unsolved crime on police records and active investigation ceased.

The clue was furnished recently by Herman S. Shapiro, an attorney who said because his life had been threatened by conspirators with Mrs. Oesterreich he had decided to reveal that he had discovered "The man in the attic."

Grayson, Ky., April 18.—(AP)—Field of conjectures over charges that Mrs. Susie Vickers, 63, may have been buried alive March 29 was in sight today with the announcement that the Carter county grand jury had completed its investigation.

Indications were that the only action to come out of the charges that proper precautions were not taken to determine that Mrs. Vickers was dead, would be an indictment for slander already voted. The name of the person accused in the indictment will not be made public until a warrant is served.

Witnesses were heard Wednesday and yesterday by the grand jury on the charges brought by two sisters, whose parents employed Mrs. Vickers in their home for 17 years.

The two, Mrs. George S. Clay, and Mrs. Houchell Johnson, told Circuit Judge G. W. E. Wolford that Mrs. Vickers was subject to fainting spells, would remain in a state of coma for long periods, and that perspiration was wiped from her face at the funeral, indicating, they thought, that she was not dead.

Mrs. Vickers died March 27 apparently of a heart attack while preparing the evening meal for herself and her third husband, near here.

The body was buried without the rites of an undertaking and was re-embalmed. The grand jury refused to issue an order to disinter the body for an autopsy.

Placerville, Calif., April 18.—(AP)—The aid of state officials was invoked today to fight trichinosis, an illness caused by improperly prepared pork, which has caused two deaths and made 24 persons ill here.

The second victim to die, Frieda Wunschell, 13, succumbed yesterday. George A. Wunschell died on Tuesday. The infection was caused by pork prepared for a picnic about ten days ago.

The poisoning, physicians said, is caused by flesh worms conveyed into the system by improperly cooked or cured meat. Penetration of the embryonic trichinae to the muscle products excruciating agony, with fever and delirium. Trichinosis is one of the most virulent diseases known and the Placerville cases are regarded by El Dorado county authorities as "among the worst we have ever seen."

College Student Held In Slaying

The police were told that Paynter died following an altercation with Maxton at a west end residence where both were roomers.

Administration Leaders Of The Senate Seek To Question Judge Parker

Washington, April 18.—(AP)—Examination by the Senate judiciary committee of Judge John J. Parker, of North Carolina, nominee for the Supreme court, has the approval of the administration and steps will be undertaken immediately to bring that about.

Friends of Judge Parker received information today that Attorney General Mitchell was in favor of the examination of Judge Parker by the Senate committee with respect to the protests against him.

Senator Watson, of Indiana, the Republican leader, immediately took steps to seek Parker's endorsement. The nominee is a Republican.

The Republican chief clerk is not a member of the judiciary committee. He sought a conference with Senator Overman, Democrat, North Carolina, who is leading the contest for Parker's confirmation.

Chairman Norris, of the judiciary committee, said he saw no reason for calling Judge Parker.

If Parker asks to come before the committee, he said he would be glad to extend him the opportunity but unless the committee voted to call him he would not ask him here.

Washington, April 18.—(AP)—Administration leaders in the Senate are prepared to ask that Judge John J. Parker be called before the judiciary committee to answer the protests of labor and negro organizations against his confirmation as an Associate Justice of the Supreme court.

Two Republican Senators are considering the possibility of going to President Hoover with a request that Parker's name be withdrawn and several more are preparing letters to the Chief Executive asking some explanation of the nominee's views on the race question.

The growing dissatisfaction within the party and the possibility of serious opposition led late yesterday to a conference of eighteen Republican Senators at which the situation was thoroughly discussed.

Afterward, Senator Watson, the party leader, said he would ask that Parker be called before the committee. In addition he disclosed that he had been asked during the conference to go to President Hoover with a request for the withdrawal of the nomination. This he declined to do.

It is the view of those close to the President that he will stand by Judge Parker, at least until the nominee has had an opportunity to answer the accusation brought by the negro organization that he is prejudiced against that race, or until some of those who endorsed him ask for the withdrawal.

Senator Watson took steps last night to communicate his desire for a hearing to Senator Overman, Democrat, North Carolina, chairman of the judiciary sub-committee, which considered the Parker nomination and made a favorable report.

SEEK TWO MEN IN THE MURDER OF MISS BAKER

Police Continue Inquiry Into the Slaying of Former Cheraw Woman.

Washington, April 18.—(AP)—Two men, one in Virginia and one in Washington, were sought today for questioning by police as the week old inquiry into the slaying of Mary Baker, former Cheraw, S. C. girl, gained fresh impetus.

The man sought in Virginia lives in the vicinity of Warsaw. Police said ardent letters from him to Miss Baker were found in her effects.

If found, police said, the Washingtonian would be confronted by three persons who saw a man beating a woman in a parked automobile in Washington last Friday, the day Miss Baker was slain. If the suspect should be identified as the man in the motor car, police plan to arrest him.

Questioning last night by Virginia authorities of Mildred Sperry and Olga Skinner was believed to have given investigators information that intensified the search for the two men.

Miss Sperry and Miss Skinner, roommates of the dead girl, disappeared after her burial and were located after a search at Mount-castle, Va., near Richmond. They explained that they left Washington because publicity and questioning by reporters was distasteful. They accompanied Commonwealth Attorney William G. Cloth to Arlington, Va., and after a long conference with him, returned to Washington.

Miss Baker, navy department employee, disappeared Friday afternoon after attending a church meeting. Her body found the next day by a cultist in Arlington National cemetery.

Her roommates called police after she failed to return home and the ensuing search resulted in finding of her body under a cultist. She had been shot to death.

Despite an intensive investigation and questioning of a number of men known to have been friendly with the girl, no arrests have been made.

Scotland Neck Doctor Dead

Scotland Neck, April 18.—(AP)—Dr. H. Irving Clark, 73, died at his home here last night following an illness of several weeks with heart trouble. Dr. Clark would have been 74 years old tomorrow.

Funeral services will be held from Trinity Episcopal church here tomorrow.

Dr. Clark, who had actively practiced medicine for 51 years, was a son of Gov. Henry T. Clark and Mary Parker Clark and was born in Tarboro, April 19, 1857.

He was a former Grand Master of the North Carolina Masonic Grand lodge.

Sinclair Hearing Set for Tomorrow

Raleigh, April 18.—(AP)—W. H. Fisher, United States attorney for Eastern District of North Carolina, will attend the preliminary hearing before Commissioner I. W. Massey at Selma tomorrow Superior Court Judge N. A. Sinclair, charged with violation of the prohibition laws.

The hearing will be held at 10 o'clock tomorrow morning. Judge Sinclair was served with a warrant for his arrest by Ivan Byrd, chief deputy marshal here, and said he would be present at the hearing.

Witnesses for the government, according to the warrant, are Agent C. S. Coats, J. H. Roebuck, J. H. Allsbrooks, and W. H. Daniels. Coats is the agent who found whiskey in a traveling bag of Judge Sinclair when he searched it last March 30 and the others named are Martin county deputies sheriff, it was said.

Dance Orchestra To Give Program At Church Opening

New York, April 18.—(AP)—Music by a jazz orchestra on Easter will open New York's most modern church, housed in a 23-story apartment hotel costing \$3,000,000.

The Rev. Dr. Edward H. Emmett of the Manhattan Congregational church said the dance orchestra has been engaged for six Sunday evenings to attract young people to church. "The churches," he explained, "have neglected the youth of our city too long." The selections to be played by the orchestra have not been announced.

JAMES DUNCAN HEADS STATE REPUBLICANS

Greensboro Attorney Elected Chairman at Charlotte Convention

Charlotte, April 18.—(AP)—James S. Duncan, Greensboro attorney, today took the helm of the Republican party in North Carolina.

Duncan was elected state chairman at the state convention of the party here yesterday. The convention adopted a militant party platform calling for school reform, tax revision and law enforcement and sounding a challenge to the Democrats for "supremacy of the state."

No nomination was made for the U. S. Senate. Failure of the convention to name a man to make the race was taken to mean this matter would be left to a Republican primary in June. Three Republican candidates have announced, two calling for a primary.

The convention, however, nominated I. G. Greer, of Boone, for state treasurer, and instructed state committeemen to draft candidates for other offices if they did not offer.

Towards the close of the convention, a resolution was passed unanimously endorsing Judge John J. Parker, of Charlotte, as a nominee for Justice of the Supreme Court. The convention deplored efforts "by men unfamiliar with his character and public service" to defeat his confirmation.

In electing Duncan state chairman to succeed Brownlow Jackson, of Hendersonville, the delegates swept the Greensboro man into office on a first ballot landslide. Duncan received 23 3-23 votes to the 27 15-23 of his nearest rival.

Jake Newell, Charlotte attorney, was second in the chairmanship race. Postmaster O. R. York, of High Point, came third with 232 votes, and Junius H. Harden, of Burlington, was fourth with 57.

Mrs. Juanita Gregg Winn, of Liberty, polled 83 1-4 votes on the first ballot to be elected vice-chairman. Mrs. J. K. Hester, of Reidsville, was second with 202 3-4. Miss Luma McLamb, Smithfield, received 187 1-2 votes, and Mrs. Lillian M. B. Rodgers, Wilmington, 191 3-4.

After the ballot the election of all officers was made unanimous by acclamation.

Greensboro, April 18.—(AP)—James S. Duncan, of Greensboro, who was yesterday elected state chairman of the Republican party today announced that State headquarters will be moved from Hendersonville to Greensboro within the next two weeks, with A. M. Mac Whirter, secretary under Chairman Brownlow Jackson, of Hendersonville, in charge for the present.

"We hope to have headquarters established in Greensboro by May 1," Mr. Duncan said. The new chairman expressed himself as being highly pleased with the manner in which affairs of the party were handled at the state convention and predicted a rosy future for the Republican party in North Carolina. He said plans were underway for waging a strenuous campaign in the state.

NINE NEGROES PAY FINES FOR STAGING ROW

Tenth Man Found Not Guilty of Disturbing Religious Worship In Conflict

Nine negroes, charged with disturbing worship at a negro church in the Bell Arthur community, were found guilty by a jury sitting in the criminal term of Pitt County Superior Court here yesterday, and were required to pay fines ranging from \$15.00 to \$50.00 each. A tenth negro by the name of Fred Midgett was found not guilty in connection with the affair.

The defendants were: Nathaniel Midgett, Fred Hall, Ed Barrett, Alonzo Hall, Turner Joyner, Herbert Barrett, Vera Hall, Charlie Midgett and Bennie Willoughby.

They were alleged to have staged a free-for-all fight on the churchyard about a year ago, and guns and knives and other implements of warfare were brought into play during the conflict. One or two of the combatants were injured, and the disturbance assumed such great proportions that services at the church were almost completely suspended until quiet had been restored.

The matter was reported to the township officers and the defendants, after preliminary hearing, were bound over to Superior Court under bond. The case was one of the longest drawn-out of the present term, having been started Wednesday afternoon and continuing until about the noon hour yesterday. A considerable amount of testimony was produced by both state and defendants.

Joe Mabry, colored, of the Ayden community, charged with stealing hogs, was sentenced to four months' service on the county roads. He was alleged to have taken hogs belonging to W. O. Jolly, farmer, residing near Ayden.

C. H. Walsh, charged with giving worthless checks, was released upon payment of \$50.00 and cost.

Edward Letchworth was found not guilty of a charge of disposing of mortgaged property.

Expression of W. H. Stayton, Chairman Of Board Against The Prohibition Amendment, Received By The Senate Lobby Committee During Testimony of Henry H. Curran

Washington, April 17.—(AP)—An expression of belief by W. H. Stayton, chairman of the board of the association against the prohibition amendment, that President Hoover "is beginning to doubt whether prohibition can be enforced" was received today by the Senate Lobby committee.

The opinion was contained in a letter written last February by Stayton, to Charles S. Wood, of Philadelphia, a vice president of the wet organization.

It said: "My own feeling is, as I talk to senators, members of Congress and public officials here, that Mr. Hoover is beginning to doubt whether prohibition can be enforced."

It added that Mr. Hoover "wants to take plenty of time to consider it, but he is being abused a little too much."

The Stayton letter was introduced into voluminous lobby committee record while Henry H. Curran, president of the association against the prohibition amendment, was testifying for the third day. Curran had said a while before that the "tide is turning" against prohibition in Congress.

The subject was brought up by Senator Walsh, Democrat, Montana, as Curran began his third day of testimony before the committee.

After reading a news story published in 1927 which said the country was dry, Walsh asked the witness: "Do you still think the tide is turning in favor of prohibition?"

"There is no doubt of it," Curran insisted.

"The pendulum has a long, wide swing," he added, "and it is a tide of opinion that cannot be stopped."

Will Celebrate Midnight Ride Of Paul Revere

Boston, April 18.—(AP)—A third rider will join "Paul Revere" and "William Dawes" tomorrow in spreading the alarm "to every Middlesex village and farm."

Dr. Samuel Prescott had been a courtier late that historic April night in 1775 when the "Red Coats" were on the march, history relates. Midway between Lexington and Concord he came upon the British, who had temporarily captured Paul Revere and forced Dawes to flee in another direction.

Learning of their mission, Prescott took up the task. Speeding away through moonlight by ways toward Concord. He bore the message to the defenders of ammunition stores there of the approach of the enemy.

Negro Man Wanted In Connection With Death Two Women

Wilmington, April 18.—(AP)—Thomas Pickett, 46, negro, was the object of a search today throughout eastern North Carolina following the burning to death of two Negro school teachers last Tuesday near Mooretown, Pender county.

The teachers, Maggie Moore and Rokie McKoy, were burned to death when their house was destroyed by fire. Examination of their bodies revealed buck shot wounds.

Pickett, according to authorities, had been an unwelcome admirer of the McKoy woman. He was last seen leaving Mooretown shortly after the fire, in an automobile and was said to have been carrying a shot gun.

# CHURCHES OF ROME OBSERVE GOOD FRIDAY

## Commemoration of The Death of Christ Observed By 400 Churches of City

By HUDSON HAWLEY (Associated Press Staff Writer) Rome, April 18.—(AP)—Before altars stripped of their ornaments and surmounted by veiled crucifixes, with the tabernacles in the center standing open and empty, black-vestmented priests solemnly prostrating themselves today commemorated the death of Christ in all the churches of Rome, and throughout the Catholic world.

Rome's commemoration of Good Friday was, as always, particularly impressive because of the number of purported relics of Christ's passion and death to be found here.

A great "procession of penitents" composed of thousands of clerics and laymen, wended its way to Santa Croce in Gerusalemme, where a comparatively large piece of what is said to be the cross of Calvary has been kept for centuries.

Between the hours of noon corresponding to the time that Christ is supposed to have suffered his agony, all business was at a standstill, and traffic largely suspended. Rome had almost the aspect of a dead city, such as ancient Ebusus, rather than that of a busy modern capital.

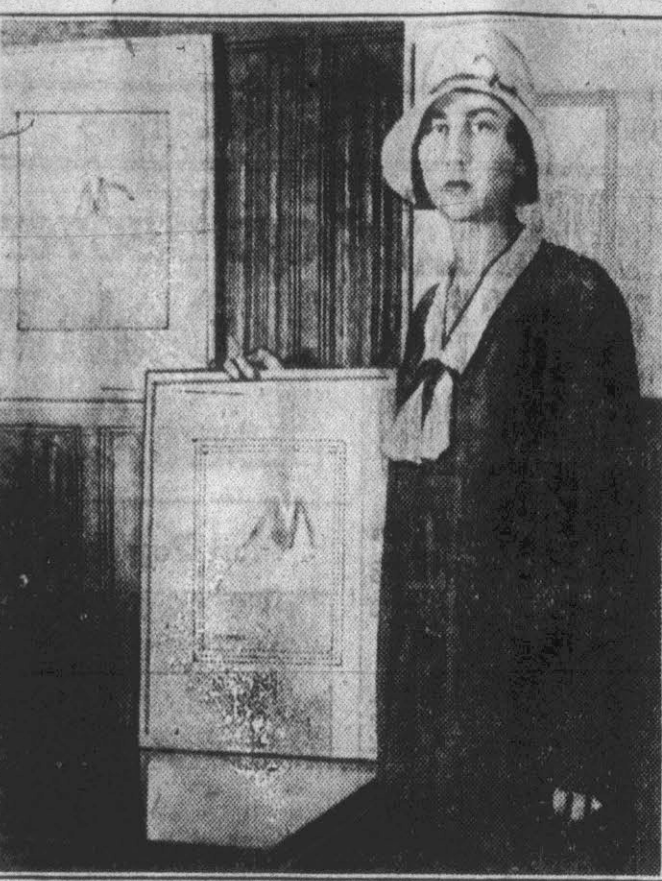
The Scala Santa, or Holy staircase, enshrined in the church just across the way from St. John Lateran, was the goal of thousands of penitents, both Italian and foreign. The tradition is that the staircase is the very same that Christ ascended in the praetorium of Pontius Pilate in Jerusalem, on his way to appear before the Roman Magistrate. The steps, all of marble, are assumed to have been brought to Rome by St. Helena, mother of Constantine, the first Christian emperor.

All day the pious pilgrims ascended those stairs on their knees, praying fervently at each pause. When they reached the top they were permitted a view through a lattice of the chapel known as the Sancta Sanctorum or Holy of Holies which contains a very early picture of Christ, and some precious relics. In every one of Rome's 400 church churches the Good Friday "Mass" of the pre-sanctified was celebrated in the presence of vast congregations. In each the host, consecrated the day before, on Holy Thursday, and reverently borne from the "Altar of Repose" to the main altar, the choir chanting the 7th century hymn, "Vexilla Regis" by Venantius Fortunatus. Its English title is, "The Banners of the Cross Advance."

Thereafter came the ceremony of the veneration of the Cross. The veiled crucifix was taken down from above each altar, and gradually uncovered, the clergy chanting the "Ecce Lignum Crucis", whose first line, translated, is "Behold the Wood of the Cross, on Which Hung the Salvation of the World". The priests then removed their shoes in sign of reverence, knelt and bowed three times, and kissed the crucifix, placed on the altar steps. Thereupon the laity were permitted to approach and perform the same act of homage.

## Broken Engagement Causes Young Man To Take His Life

New York, April 18.—(AP)—A four-page letter from a young woman breaking an engagement to marry today was believed by the police cause of the suicide of John Douglas, 21-year-old Yale graduate and son of Dr. John Rindlaub, physician of Fargo, N. D.

His body was found yesterday hanging from a length of electric wire suspended from a steam pipe on the ceiling of his room at the West Side Y. M. C. A.

The letter, signed "Dana" and believed from Fargo was dated April 12. It was found by police on a table in the room.

It read: "Dear John—your long letter came this morning. The only thing I can do, John, is to break our engagement. I have been true to you, no other man has interested me. I have laid awake at nights wondering what to do about it all, and trying to find the easiest way for both of us to break the engagement. I received your letter this morning and it proved it was right: It hurts to do it. I don't seem to be your main interest. Your letter said you didn't want me unless I felt you could make me happy. You made me divinely happy in New York last year, since then I have been miserable, waiting for letters and not finding what I wanted most in them.

"Your love had been most ardent. My heart and pride has been hurt. The break will be a relief to both of us.

"Our year in New York together has been my dearest memory. I was never so happy. I'd like to remain a friend.

## Political Activity Of Church Council Under Fire Today

Charlotte, April 18.—(AP)—Alleged political activities of the Federal Council of Churches were under fire today in an overture of the Mecklenburg Presbytery to the general assembly of the Presbyterian church of the United States.

The Presbytery urged the general church body to withdraw from the Federal Council of Churches, because, it was asserted, the council "is now being investigated by the Congress of the United States for its political activities on questions which Christ did not commission the church to settle."

The overture further declared that the church council "has been charged from reliable sources with being in sympathy with Communism and with Russian Soviet propaganda" and "that the Federal Council of Churches radio program has been the means of widespread

The rug was then shipped back to the factory for cleaning and upon its return to this city will be placed on exhibition by Quinn-Miller and company in order to show the genuine wearing qualities of this rug. During the first twenty eight days that the rug remained on the sidewalk a careful check was made as to the number of persons who walked over the rug each day and it was found that during that time approximately forty eight thousand persons had walked on the rug since it was placed on the sidewalk. This is considered the heaviest possible test that can be had as to the wearing qualities of any rug and represents more than years of wear within the home. It will be interesting to view this rug after it has been cleaned and returned here for exhibition.

Tobacco plants are short in this section of the country, but one never would realize it out on the W. A. Talley farm in this county where they are busy pulling plants and transplanters are running at full blast setting out the next golden harvest.

For the next several days numbers of planters in different parts of the county will do as they are doing on the Talley farm and by the time hot weather actually comes Pitt county's premier crop will be in the ground.

Midnight Shows Are Suspended By White's Theatre

Midnight shows are taboo at White's theatre in the future, according to announcement made this morning by R. E. Corbett, manager of the theatre. The action was the result of a request of the Ministerial Association that Sunday midnight shows be suspended in the interest of the moral welfare of the city.

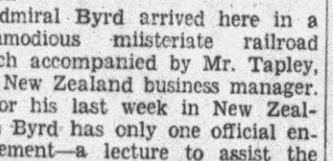

## NO TAX RELIEF FOR THE POOR CLODHOOPER

Having been complimented profusely on my few contributions on the tax issue, and I am thankful. But none of those doing the complimenting, so far as I have been able to observe, has done any writing for the papers. Have talked with several of those offering for office, and a dumb oyster is about as willing to give you a plan for tax relief as they are. Have heard some speak and read what others have had to say, and if their proposed remedies are what the people want, then I have overshot myself in advocating the poor man's cause.

I most earnestly desire a tax free homestead for everyman, rich and poor, who owns a home. Also, better exemptions on household and kitchen furniture, and, at least, inments. All this for the benefit of the poor man. The rich have had big exemptions all the time. So what I am asking for the poor is that they, at least, be allowed to have the crumbs that fall from the tables of the more fortunate. Will the rich consent? Never. The poor, the producer, the sustainer and backbone of the life of the nation will continue to grind at the mill, suffer and agonize, hoping against hope for a deliverer, but the master will show no pity. Indeed his case is hopeless; for he can't rid himself of the yoke of economic dependence. The Federal Government has no pity. It penalizes agriculture to the extent of \$25,000,000,000, a year to take care of tariffs and additional profit to wholesalers and retailers occasioned thereby. Then our States are notoriously pitiless in the administration of their revenue laws so far as the poor are concerned. All tariffs and taxes ultimately are paid by the producers of raw products. Therefore, a tax on the manufactured products enhances the price of such materials, but reduces the price on raw products; and our

Allen, Cincinnati outfielder, got the homer in the ninth inning and provided the only occasion on which a Red leg reached second base. French himself took part of the edge off his feat by giving five bases on balls.

Earl Whitehill of Detroit and Pat Malone of the Chicago Cubs were yesterday's three hit pitchers with the St. Louis representatives, the Browns and the Cardinals, as their victims in abbreviated contests.

In Detroit, the Tigers were stopped by rain after 5-2 innings but beat the Browns, 6 to 1, on Whitehill's hurling and homers by Marty McManus and Dale Alexander.

Chicago's Cubs, lacking Rogers Hornsby, and Charlie Grimm who were kept out to give slight injuries a rest, scored three times in six innings while Malone held the St. Louis Cardinals helpless with his speed ball for a shutout victory. Rain stopped the game after the Cubs had scored again in the seventh but the run did not count.

Riggs Stephenson was the outstanding Chicago player, getting a home run and two doubles in three trips to the plate.

Army Completes Tests Without Use of Pilots

San Francisco, April 18.—(AP)—The feasibility of waging war in the air without the use of human pilots and of sending huge planes, piloted only by machinery, on cross-country trips, has been demonstrated by the army air corps.

A big army bomber took off from Mather Field, Sacramento, last night bearing four men and a queer looking machine about the size of a hat box. When the plane was well in the air the pilot, Major Hugh Knerr, turned the controls over to the little machine, which flew the ship straight as an arrow to San Francisco.

Over the Bay City Knerr touched a button and the machine guided the 15,000 pound plane in circles for 20 minutes and then headed it back to Sacramento. Except for the take-off and landing, the machine did all navigating, keeping the plane on an even keel through the rough air and maintaining the course with mechanical precision.

The purpose of the flight, army officials said, was to prove the feasibility of using automatically piloted planes as huge instruments of destruction to be hurled against an enemy without the aid of human hands.

Sperry's invention consists of two gyroscopes. The instrument weighs less than 50 pounds in all and was installed in the forward cockpit. Delicately sensitive, it detects every movement of the plane and automatically rights the ship whenever it strays from its course.

When Knerr left the control of the plane to the automatic pilot he retired to a rear cockpit of the ship, and except for going forward to press the buttons for turns, remained away from the instrument.

Former High School Athlete Sentenced To Term In Prison

Batesville, Ark., April 18.—(AP)—J. P. Barber, 22½ former high school athlete, was convicted of second degree murder by a jury in Circuit court here today and his sentence fixed at 21 years imprisonment for the slaying a year ago of Maurice Osborne, a young merchant of Cord, Ark.

Barber was tried on a first degree murder charge but the jury was instructed by the court that it could convict him of a lesser offense.

Osborne's wife, Norma, 23, who testified to an illicit romance with the young athlete, is under a nine year sentence in connection with the slaying.

Barber, on the stand yesterday, contradicted the woman's story that he had previously gained her consent to kill Osborne and sought to persuade her to leave with him.

His testimony was that he had gone to the Osborne home on the night of last July 1, to discuss with Osborne, a life long friend, plans for a fishing trip.

Upon arrival there, he said, he faced the muzzle of a shotgun held by Osborne and in a struggle that followed the gun was discharged once, the charge striking Osborne. He said he then took the gun and fired two additional shots into the prostrated body and fled.

He was captured only a few weeks ago in Kentucky and returned here for trial.

Mrs. Osborne was tried a short time after the slaying. She has an appeal pending in the Supreme Court and is at liberty under bond.

Would Sound Out Sentiment About P. O. At Chicod

Washington, D. C., April 17.—Congressman Lindsay Warren has asked the Daily Reflector to sound out the patrons of the Chicod post office on the recent order of the Post Office Department contemplating its discontinuance. The department states that receipts of the Chicod office are constantly getting smaller, and that the same service can be given by rural routes out of Greenville and Grimesland.

Mr. Warren has asked the department to hold up any action until he can ascertain the views of the people. He states to the Reflector that he has already received several letters from the patrons saying they have no objection to the office being discontinued. In 1925, a similar order was issued, but Mr. Warren succeeded in getting it revoked, because at that time all of the patrons desired that the office be retained.

Investigate Death Of Florida Woman

Jacksonville, Fla., April 18.—(AP)—With her husband under arrest on a charge of assault with intent to kill, authorities today began an investigation into the death of Mrs. J. B. McNamara in a hospital here last night.

Taken to the hospital Wednesday night, after a quarrel with her husband at their home. Physicians said she had been choked and bruised about the body.

Her three children, two of whom are twins, aged nine, were placed in the custody of a police matron.
