LENTEN FAST COMES TO AN END IN ROME

Church Bells of City Ring Out Joyously Bringing End to Season of Abstinence.

Rome, April 19.—(AP)—The Lenten fast and abstinence ended at noon today. Shortly before that the "Gloria in Excelsis" sung at all the Holy Saturday masses was the signal for the bells of all Rome's churches to ring out joyously, in contrast to Good Friday's mournful silence.

The sacred images and paintings, heavily veiled in purple or black coverings since Passion Sunday, were again brought to light, and the organs once more were played. It was a striking prelude to Easter Sunday, always a gala day in Rome.

The blessing of the new fire, representing Christ's resurrection, was carried out in picturesque fashion under the portico of St. John Lateran, Rome's cathedral.

There Cardinal Pompili officiated, striking a spark from a flint. He then ignited the Paschal Candle, after blessing the five grains of incense, representing Christ's five wounds, inserted in it. After that the Cardinal and attendant clergy moved in solemn procession up the great nave of the basilica, the candle being borne ahead.

Baptisms of adult converts to catholicism were performed at the Lateran and other churches. The ceremonies in all cases ended with the singing of the 116th Psalm, "Laudate Dominum" (Praise Ye The Lord), and the "Magnificat" or canticle of the Blessed Virgin, contained in the first chapter of Luke.

Soon after the pealing of the bells the parish priest and their curates not attending the masses started forth for the blessing of homes and offices, each cleric being accompanied by an altar boy. Hardly a room in all Rome was left unperfumed with Holy Water.

In each case the priest recited the prayer calling upon God to send an angel from Heaven, "to guard, cherish, protect, visit and defend all that are assembled in this place."

In return for this benediction of their homes, the Romans put small cash contributions in the little leather sack carried by the altar boy, or into the Holy Water vessel itself, to go toward the "good works" of their parishes, and for the poor. In many houses the families arranged the food for Easter Sunday dinner in their dining rooms, in order that the priest might bless their first post-Lenten repast.

Florence, Italy, April 19.—(AP)—That startlingly striking Holy Saturday ceremony known as "the explosion of the Sacred Cart" which had its origin six centuries ago, was performed here this noon to the joy of the assembled peasants from outlying townships, and a large number of American and British tourists spending the Easter holidays on the banks of the Arno.

The "Sacred Cart", under all its coverings of red damask, flowing ribbons and garlands of flowers, contained secreted within itself a host of firecrackers, rockets, pinwheels and other picturesquely inflammable affairs. A fuse on top of it was connected with a special wire that led to a spot just above the high altar of the nearby cathedral.

When the clergyman celebrating the solemn high mass of today reached the "Gloria in Excelsis Deo" (Glory to God in the Highest), and the bells began to ring out from the steeple and the organ to play an artificial pigeon with a skyrocket embedded in its tail was seen to shoot down the wire and out over the heads of the congregation into the square beyond. Sizzling as it sped on its way it soon hit the fuse on top of the cart, igniting it and setting off all the concealed fireworks with an resounding splutter and roar.

The flaming dove that thus set the cart on fire is regarded as symbolic of the Holy Spirit, which, in the version of the acts of the Apostles, descended upon the assembled disciples the first pentecost day in that form.

Convicted of Paying Man To Kill Wife

Anthony, Kans., April 19.—(AP)—Ben H. Turner, 60, superintendent of a salt plant, accused of paying \$65 to have his 56 year old wife slain, was convicted of first degree murder by a jury here today. The verdict carries a penalty of life imprisonment.

Jim Strutton, young employe, of Turner, confessed the slaying, and testified he was hired to kiss Mrs. Turner here the evening of February 26 last. Strutton said he secreted himself in the Turner home until Mrs. Turner returned from a shopping trip and then, beat, choked and shot her to death. He said he received \$65 of a promised \$135 from Turner.

BISHOP'S SON CHARGED WITH SLAYING MAN

James Maxton, Jr., Held For Killing Aged Man While in Drunken Frenzy.

New York, April 19.—(AP)—James Matthew Maxton, Jr., a somewhat bruised and disheveled young man, who followed with curious and troubled eyes the activities of the reporters whose company he had hoped some day to join, was today in West Side Court on an affidavit, signed by a policeman, charging him with homicide.

James Maxton, son of the Right Rev. James Matthew Maxton of Chattanooga, Bishop Coadjutor of the Protestant Episcopal church in Tennessee, has been accused by fellow lodgers of having killed David Paynter, aged 73, while in a drunken frenzy. The killing occurred in a shabby rooming house.

Maxton, according to his attorney Martin W. Littleton, admits that he had been drinking, but denies that he killed Paynter. Paynter's death occurred, according to the story Maxton told his lawyer, during a general melee that followed when he went down to the basement kitchen, adjoining the landlady's room, to investigate the cause of a gas leak and was evidently mistaken by his fellow lodgers for a burglar.

Hearing on the charge against Maxton was adjourned until next Wednesday, April 23. No plea was entered today, until Wednesday. He will be held in the jail attached to West Side court.

Maxton had several bruises and scratches on his neck and face when he appeared in the police lineup and later in West Side court today. There were cuts on his hands. His well cut grey suit was wrinkled, and his shirt and collar rumpled. He is a short, rather stocky youth, good looking, with hazel eyes, thick dark hair, and an olive skin. He looked sallow and tired today.

For nearly half an hour before he was arraigned he sat on a bench in a room adjoining the courtroom, his grey hat pulled well down over his eyes, smoking cigarets and gravely going through the morning papers.

"I had a talk with the boy this morning," said Mr. Littleton. "His story is this: 'Friday evening he had in his room a guest—a young woman to whom he was reading one of his stories, probably a girl who was in one of his classes at the School of Journalism at Columbia.'"

Mr. Littleton was here interrupted by some of the reporters who wanted the name of the young woman.

"Didn't ask him and I don't know and I wouldn't tell you if I did," replied Mr. Littleton who is himself a former resident of Tennessee.

"While she was there, the landlady, Mrs. Rose Hickey, I believe her name is, and some of the other lodgers were drinking in the landlady's quarters in the basement. Once during the evening, while the young lady was still there, the landlady came up and brought Maxton a drink, gin, I think he said. (Continued on page 3.)

North Carolina Jurist Expresses Willingness to Answer Protests Against Confirmation of His Nomination To Supreme Court.

Washington, April 19.—(AP)—Judge Jern J. Parker, of North Carolina, today informed Senator Overman Democrat of North Carolina that he would be glad to come before the Senate Judiciary committee to answer protests against his nomination as an Associate Justice of the Supreme Court.

Senator Overman at the request of the Republican leaders, has said he would ask the Judiciary Committee to invite Judge Parker here. The committee will meet Monday and it is likely that the nominee will be asked to appear at the meetings a week later.

Protests by Negro associations against a speech attributed to Judge Parker in 1920 as causing the Republican leadership some concern.

It has been decided to have the Judge here to discuss that point in particular.

The telegram of Judge Parker stated his willingness to appear before the committee was sent voluntarily by him.

Friends of the nominee here asserted today there was no likelihood whatever of the Judge asking that his nomination be withdrawn.

COURT TAKES RECESS UNTIL NEXT TUESDAY

Two Men Found Not Guilty of Manslaughter in Closing Session Friday.

Charged with manslaughter in connection with the death of Joe Ford, Jesse Barnhill and Mack Worthington, of the Bethel community were adjudged not guilty by a jury in the criminal term of Pitt County Superior court in this city yesterday.

Ford was run down and killed by an automobile on a highway near Bethel several months ago and Worthington and Barnhill were arrested on suspicion following an extensive investigation by county officers. They were given preliminary hearing and bound over to Superior court under bonds of \$1,000 each.

After completing work yesterday afternoon Judge Barnhill, of Rocky Mount, who is presiding over the court, ordered recess until Tuesday morning so that court officials and members of the bar might observe the Easter holidays.

B. J. Wooten, James Kearney and Robert Johnson, colored, of Greenville, were each sentenced to the county roads for six months on a charge of possessing equipment for the manufacturing of whiskey. They were arrested by county officers and appeared from a similar sentence in county court.

Robert and Mattie McNeil, colored, charged with larceny, were adjudged not guilty.

Mistrial was ordered in the case of R. L. Lovett, charged with forgery. He was alleged to have forged a check on E. R. Dudley.

Found Guilty Of Slander by Radio

Chicago, April 19.—(AP)—The verdict in the case of the State of Illinois against Fred Bruce was "guilty of slander by radio." It was the first suit of its kind since Illinois adopted a radio libel law in 1927. John H. Ehardt, police magistrate-elect of Berwyn, a suburb, charged Bruce, defeated candidate, with uttering slanderous and defamatory remarks in the campaign.

"Since Bruce made the remarks in Cicero, how can he be tried in Berwyn?" the defense counsel queried.

This puzzled Justice "Levitian" for a time but he finally ruled that because of the ether waves, the damage to Ehardt's reputation was done in Berwyn as well as in Cicero and as justice of the peace in Berwyn he had jurisdiction.

Morning Watch Services Brought To Close With Sermon By Fleischmann

Pastor Memorial Baptist Church Delivered Splendid Message at Final Service Today; Revivals To End Tomorrow.

Rev. A. W. Fleischmann, pastor of the Memorial Baptist church, spoke at the "morning watch" service at Jarvis Memorial Methodist church this morning. He spoke on the subject, "At the Foot of the Cross." His text was taken from the 26th verse of the 27th chapter of Matthew. "And sitting down they watched Him there."

Describing the scene of the crucifixion, Mr. Fleischmann drew the attention of the audience to the question, "Why did these soldier gamblers act in this manner? He said he believed the answer lay in the fact that they reached a conclusion concerning the man who hung on the center of the cross."

"There are three conclusions that we, too, may reach concerning Jesus," the speaker declared. "They are these: first, no man ever lived like Jesus lived; second, no man ever spoke as Jesus spoke; and no man ever died like Jesus died. It is of equal importance for us to reach a decision concerning the Lord Jesus in relation to our own lives."

The service this morning was the last "morning watch" service of the simultaneous campaign. Regular services will be held in all the city churches tomorrow, and the two-week campaign will come to a conclusion in the evening.

Jarvis Memorial Methodist Church Last evening marked another service of interest. The presence of the Boy Scout Troop and a goodly number of other young people along with the adults made glad the hearts of those who are so interested in the young life of today. After several appropriate and inspiring hymns, and special music by the choir, a most helpful message was brought to the hearers on the subject; "Arise and Build." Not only was it helpful to the young people, but there was a great message for the older people. It brought to us the necessity of building a life upon the solid foundation of honesty, truthfulness, purity, and sincerity; a life with clean, and high ideals; a life not forgetting God, but taking Him into the innermost room of that life as a co-partner and helper. Our future America and world-wide affairs, politically, educationally, and religiously, lies in the hands of the youth. Parents, boys and girls, what will we have the future to be in our country, in our town, in our homes, in our own lives? May the Jesus way of living be your answer.

Billy's parents, Mr. and Mrs. W. R. Meredith, yesterday filed suit against the Humboldt Hospital, of Albany, Cal., and two nurses and a physician, asking \$1,000 on the ground that they operated on the wrong boy.

SIX SLAIN AS NATIONALISTS ATTACK COPS

Police Sergeant Major Among Those Killed In Indian Attack on Armory.

Calcutta, Bengal, India April 19.—(AP)—A group of 100 Indian Nationalist today attacked the police armory at Chittagong, across the Meghna Estuary east of here, and killed six of the defenders. The dead included one sergeant major.

Before assaulting the armory the insurgents cut telephone and telegraph lines leading out of the city, which is of about 30,000 population, and derailed a train about 40 miles away blocking the railroad line.

A detachment of eastern frontier riflers under command of Lieutenant Colonel Dallas Smith was ordered from here to Chittagong to handle the situation. They left Calcutta this morning.

In Calcutta strong guards were established at all gun shops, while armored cars and armed police took up positions in strategic locations. The authorities ordered an immediate search of the city for arms and ammunition.

EDITOR DEAD

New York, April 19.—(AP)—Chas. P. Stack, 48, biographical editor of the Associated Press, died here last night after an illness of several weeks.

Stack was born in Troy, N. Y., April 5, 1882 and entered newspaper work in that city. He came to the Associated Press in 1920 and served in the Albany, Newark, N. J., and Philadelphia bureaus before coming to the New York office.

Ethel Dropped By Actors. New York.—Ethel Barrymore has been dropped as an officer of the Actors' Equity Association. Last summer she opposed Equity's efforts in the film industry.

SCORES PERISH WHEN CHURCH IS CONVERTED INTO BLAZING INFERNO

Bass Confesses Killing Pearman In Plot To Get \$200,000 Life Insurance

Retired Columbia, Mo., Dentist, Admits Killing Friend On Road While Driving to Columbia.

St. Louis, April 19.—(AP)—The St. Louis Post Dispatch says today in a dispatch from a staff correspondent at Bentonville, Ark., that Dr. A. J. Bass, retired Columbia, Mo., dentist, has confessed he shot and killed William R. Pearman, his friend, last March 26 in a plot to collect \$200,000 insurance he held on Pearman's life, under the name of William Folta.

The newspaper which published the text of Dr. Bass' confession, says he admitted he killed Pearman on a road near Rocheport, Mo., while driving Pearman to Columbia, his home, from Kansas City. The confession says he was forced to commit the crime by three St. Louis gunmen who followed closely behind his car on the trip and later disposed of the body.

The confession published by the Post Dispatch says after the shooting, Dr. Bass hauled Pearman's body, locked in the rear compartment of his coupe, to his farm near Columbia, kept it there over night and the next day drove with it more than 250 miles to Joplin, Mo., where he turned it over to the gunmen.

Dr. Bass is quoted as saying the gunmen then took the body in their car to Gravette, Ark., where they dumped it out, while Dr. Bass returned to Columbia.

The confession names "hooker" as one of the gunmen and says 11 and the others had insisted Pearman, a Columbia mechanic, be "bumped off" immediately "because he was drinking and talking too much," and for the further reason that the gunmen wanted \$100,000 which was to have been Pearman's share in the insurance fraud.

According to the confession, Dr. Bass sold Pearman some land in Arkansas under the name of William Folta, as a part of the insurance fraud plot and then took out \$200,000 insurance on "Folta's" life. The gunmen, Dr. Bass said, were to have supplied a body to be identified as that of Folta, but "they failed me in this and insisted upon making Pearman the goat."

Dr. Bass was quoted as saying his own life was threatened if he did not kill Pearman.

Accordingly, the confession said, he drove to Kansas City March 26 for a conference there, with Pearman concerning taxes due on the Arkansas land. There, he said, "Hooker" met him outside the Savoy Hotel where Pearman was stopping and said Pearman must be killed.

That night while they were driving along the State highway near Rocheport with the gunmen's car close behind them, according to the confession, Dr. Bass shot Pearman in the head and he slumped forward, dead.

He then stopped the car, he said, and the gunmen helped him remove the rumbled seat and lock Pearman's body in the compartment. He then drove on home, Dr. Bass said, and the next day met the gunmen outside Columbia by pre-arrangement and drove with the body to Joplin where it was transferred to the gunmen's car about 8:30 o'clock that night. This arrangement had been made, the confession explains in order to remove suspicion from Dr. Bass.

He returned to Columbia and waited there until word came of the finding of the body and then, as it is fully to think that we can live for self, an evil, sinful life, and then at death be completely changed into a good, holy person. Life hereafter is a continuation of this life, that's all. Only we will have no restraints in that life; we will have free rein to test what we are afraid to test to the full here. God bears out these statements in the parable of Lazarus and the rich man, where each one went to his own place, one to rest and happiness, the other to misery and torment. In the judgment scene of Christ pictures, the separation of that day will be natural, just more distinct than the separations which go on on this earth now. Men will naturally divide themselves into two companies. In the Book of Revelation the bad are separated from the good, and the statement made: "He that is unjust, let him be unjust still; he that is righteous, let him be righteous still." VIRGINIA MAN QUESTIONED IN GIRL'S MURDER

Julien Gallegher Held In Connection With Death of Government Employee.

Richmond, Va., April 19.—(AP)—Julien Gallegher, 28, year old salesman of Warsaw, Va., was taken into custody here early today for questioning in connection with the killing of Mary Baker, near Washington, and left for Arlington a few hours later with William C. Gloth, commonwealth's attorney of Arlington county.

Gallegher, while awaiting the arrival of the Arlington officers, told police that he could establish a complete alibi for the entire preceding the finding of the body of Miss Baker, a young government clerk.

He said that he had in his briefcase sales tickets, checks and reports that would prove his whereabouts and show his travels over his regular route.

Mr. Gloth said no charge had been placed against Gallegher but that he would be questioned fully on arrival in Arlington shortly after noon today.

Gallegher talked freely at police station and willingly posed for pictures. He said he met Miss Baker last fall and that he also knew Miss Mildred Sperry, who lived with Miss Baker. He said he went with Miss Baker and other friends to Baltimore within the last few months.

Gallegher was arrested early today in Richmond on information obtained from Sisson. After completing his examination of the latter shortly before dawn, Gloth left at once for the Virginia capital to question the second suspect there.

The police said they had learned that Gallegher and Sisson made an overnight trip to Baltimore in company with Miss Baker and another woman on March 22 and that Sisson registered at a hotel there under his own name, while Gallegher and the woman registered as Mr. and Mrs. Julian Morgan and wife and daughter.

Sisson was taken into custody at his home in Warsaw late yesterday and was immediately escorted to Arlington.

He told the authorities that on the night of the murder he dined with his wife, mother-in-law and daughter at their home in Warsaw and then drove to Tappahannock, a town some seven miles away, where he talked with several people. Then, he said, he returned to Warsaw, arriving at his home about 10:15. Warsaw is near Richmond.

One Hundred and Fifty Persons at Choceti, Rumania, Burned To Death During Good Friday Night Vigil Services; Two Priests and Notary Among Those Who Made Vain Attempt To Escape From Building.

Choceti, Rumania, April 19.—One hundred and fifty persons were burned to death within a few minutes here last night, when a church in which a Good Friday vigil service was being conducted caught fire and was destroyed.

Just three who were inside the building when the fire began escaped. They attributed death of the others to their Pious anxiety for the sacred vessels, the host, and a valuable altar cloth, which they rushed to rescue.

They turned finally to the door, the one means of egress. It opened inward, and the mass, panic stricken and goaded by the searing fire, jammed against it, and died before those outside could push it open.

It was all over in a few minutes. The blazing ceiling, tapestries and paper wreaths on the walls fell on the fear-mad congregation, who trampled the women and children under foot. Their screams were futile, and soon died out, leaving only the crackle of the flames and the shouts of would-be rescuers.

The fire began when a breeze, wafted through a high rear window which had been opened in view of the springlike weather, stroked a candle's flame with one of the tapestries. Its tinselled fringe took fire, paper wreaths caught, and in a minute the building was a blazing inferno.

The structure was 100 year old and its worn eaten boards were tinder to the blaze. Outside the fire departments of Choceti and Pitesti fought vainly with antiquated apparatus to extinguish the fire. Those who had escaped and the crowding townsmen tried to open the jammed door but the massing of those inside against it made their effort unsuccessful.

Among the dead, who were buried to a cinder, were two priests, a notary, and the burgomaster of Choceti, which is a small town of 5,000 population, 65 miles northwest of Bucharest, near the edge of the Transylvanian Alps. Hardy a family escaped unharmed.

Bucharest, Rumania, April 19.—(AP)—Ninety-six bodies of men, women and children were recovered today from the ruins of an ancient church in the town of Choceti which was struck by a disastrous fire and panic during Good Friday services last night.

Forty persons still were missing. It was feared their bodies were among the smoldering ruins.

Seventeen persons who at first had been believed dead apparently had fled madly into the surrounding country where they were found wandering about severely injured.

Charlotte Wins Track Event and Goldsboro Debate

Chapel Hill, April 19.—(AP)—Charlotte was the North Carolina high school track champion today, while the debating honors of the State rested with Goldsboro.

Charlotte athletes piled up a total of 47 points at the 18th annual track championships here yesterday to cop the title in competition with 200 of the State's best high school track men from 19 schools. Wilmington was second with 27.4 points; Greensboro had 241.3; High Point 161.4; Spring Hope 9; Raleigh 8.

The Goldsboro negative team, composed of Ezra Griffin and Miss Eleanor Bizell, won the Aycock memorial cup last night in the final contest of the annual State-wide high school debating contest. The winners triumphed over the Goldsboro affirmative team in all Goldsboro final round. Approximately 800 students took part in the first preliminaries.

Harvey Harris, of Raleigh, and Claude Council, of Chapel Hill, were the finalists today in the 19th annual State high school tennis tournament. They won out yesterday in the semi-finals.

ABOUT TOWN

Pitt county farmers are busy at this time planting their next harvest of golden leaf. Much progress will be made in this connection during the next several days and by the time warm weather gets here to stay the major part of the crop will be in the ground.

The farmers got an early start in the preparation of their land this season, and the farms are in better condition at this time than any other time in years. Should the growers diversify a bit more than in past years there is no question but that the next harvest season will see them pull out of the hole they have been in the last several months by reason of last season's short crop.

This is one of the greatest agricultural sections of the country, and with the adoption of thrift measures our farmers certainly ought to be in as good condition as those in any part of the country. They must learn to produce enough crops outside the main crops to enable them to live at home when the money crops fail to measure up to expectation. By doing this they should not be so vitally affected by periods of depression in the years to come.

Just a Little Trip to Greenville About forty years ago, I visited the little village on the Tar called Greenville. I was a traveling salesman then known in those days as a drummer. I sold goods in Greenville and then drove to Pacotus, Grimesland, Farmville and other places in Pitt County. There were no automobiles, and had to trudge along over bad roads with horse and buggy, although tiresome. It was pleasant. People were contented, happy, did not have so much and didn't need so much. Never heard of autos, radios, and such like, no railroads, people got their goods by boat, made good crops, sometime the prices were low, but still you never heard of such hard times, just didn't live so fast and at such high rate as to day. Still they got along alright and you never heard the cry that is broadcasted over the land today as nothing to do, and no money, high taxes, can't pay them to save our lives, and all this late day stuff called Hoover Prosperity.

Someone has said that Abraham Lincoln freed all the niggers, Henry Ford freed all the animals, and bless God, Herb Hoover freed the whole business, nobody got anything to do. Right much truth in it.

Well, it was my privilege and pleasure to visit Greenville again. Not Greenville, the little village of old but Greenville, the "City Beautiful" situated on the same old river, the "Tar". My visit was not in the capacity of a drummer, but I was a delegate to the Methodist Sunday School Conference from the Bible Class and the adult section of the Divine Street Methodist church, Dunn, N. C. And right here, I wish to say a few words about the conference. The attendance was good, something over 600 being present. Had some fine talks. The Bishop's sermon was extra fine and there was much interest manifested through out the meeting. The good people of Greenville treated us royally, but I was not surprised for Greenville people are noted for their fine hospitality. A wonderful revolution has come to Greenville since I walked the streets as a drummer boy 40 years ago. Nine tobacco warehouses for the sale of leaf tobacco, tobacco factories, cotton mills two railroads, modern business houses, good hotels, elegant homes, fine schools, the Eastern Carolina Teachers College being located there and many other evidences of progress and prosperity. But with all this, I was sad when I thought of my friends of long ago who on my visits I would mingle with and exchange a few shots about politics and other current topics of the day. It was an honor to have such men my friends as Gov. Jarvis, Col. Harry Skinner, Capt. Laughinghouse, Chas Skinner of "Hotel Macon" fame, Dr. O'Hagan, Capt. John Flanagan, Col Cotten, Dave Whichard, editor of the Daily Reflector, and others I knew then. Those fine characters have finished their labors and have gone on, crossed over the river and are now resting under the shade of the threes of eternal life but today it is an honor to be able at this good hour to have such men my friends as Col. James, Sen. Harding, Sen. Blount, Dr. Laughinghouse Representatives Flanagan, Cox, Clark, Brown and others in Pitt

County. No nobler men North Carolina has ever produced. Pardon a little diversion from my subject and deal just a little in politics. I have been connected with the General Assembly for over a quarter of a century. I have seen men come and go, men of ability, but I have seen no county represented more ably than the county of Pitt. It has always been so. The last two sessions, 1927 and 1929 with Blount in the Senate and Flanagan and Cox in the House, Pitt was safe. I have never seen in all my experience, a new man with only 2 sessions to his credit do so much as Ed Flanagan. He was the father of the bill to have license plates made in the State Prison, thereby saving \$50,000 or more for the State. His first term he was instrumental in having the appropriation of the equalization fund increased from \$1,500,000 to \$3,250,000 and in the 1929 session from \$3,250,000 to \$6,500,000 and this money does not come from real estate. He introduced the bill which became a law to increase gas tax from 4c to 5c. This increase to go to counties for road purposes. He advanced the idea to reduce the interest charge on delinquent tax payers from 20 percent to 10 percent and after a hard fight was compromised at 12 percent, thereby saving 8 percent to the tax payers. There were many other pieces of important legislation that he advocated. He was a member of the two most powerful committees, finance and appropriation, quite an honor for a new member but Ed Flanagan was a popular member from the first day to the closing hour, and he made a reputation of which any man should be proud, and right here I want to say to the good people of Pitt County, you will make a mistake if you fail to send back Ed Flanagan and Marvin Blount. Blount was a pioneer in the Senate and was the daddy of the Highway patrol Bill and other important legislation. This session of 1931 will be the most important session in twenty years and we must send men with backbone and experience, with minds of their own, business men who can and will do something to relieve the tax situation. If you get good men to represent your county, don't change. The longer

you send them, the more influence they will have, some counties send the same representatives twenty five years. With Ed Flanagan and Marvin Blount representing Pitt County, you can rest easy. Please pardon this lengthy script, but it was in my system and had to come out. I enjoyed my visit very much and will come again if you will let me. O. P. SHELL.

Sinclair Hearing Has Been Deferred

Selma, April 19.—(AP)—Preliminary hearing for Superior Court Judge N. A. Sinclair on charges of violating the Federal prohibition laws, scheduled for today, has been "indefinitely postponed".

United States Commissioner L. W. Massey, before whom Judge Sinclair had been summoned to appear, announced the postponement last night. He said the delay had been granted to allow the jurist more time to arrange his defense.

The commissioner said he expected the hearing to be held within the next ten days. Charges were brought against Judge Sinclair by Federal prohibition Agent C. S. Coats who found a pint of whiskey in the judge's handbag. The discovery was made when the jurist was halted on a highway and his luggage searched.

Judge Sinclair declared the affair was a "frame-up". Later, William H. Everett, a farmer living near Williamston, was quoted as saying he slipped the liquor in the judge's grip as a practical joke.

Last Man Club Thinned Down To Last Member

Atwater, Minn., April 19.—(AP)—The famous Last Man's Club today is down to the last man. Originally there were 33 members, civil war veterans from B company, First Minnesota Volunteer Infantry. Death took them, one by one, until only two remained—Peter O. Hall, 91 years old, of Atwater, and Charles Lockwood, 89 years old, of Chamberlain, S. D.

Today there remains only Lockwood. His comrade of war and of peace died last night. Thus to Lockwood alone is left the sober ceremony of drinking a toast to the 32 who have gone; toasting them in the bottle of Burgundy wine purchased July 21, 1866, when the club was organized.

July 21 of each year has been the date on which the Last Man's Club met. It was on that day that B Company went under fire at Bull Run. Each year the club has met, and each year the membership has dwindled.

At each annual gathering the bottle of Burgundy has been brought from the bank vault where it is kept, a reminder that the day would come when one of them would one day sit alone at that table and drink the toast to dead men.

The last man is Charles Lockwood. Yesterday he was up and about the farm, doing his chores as usual. He is suffering from a slight cold, but plans to attend the funeral of Hall here Tuesday.

Whether he will fulfill the original intent of the club and drink the toast to the memory of the dead has not been made known. Three years ago, when only three members of the Last Man's Club were left, the bottle of Burgundy was opened.

One of the three put the bottle to his lips. He tasted it and the bottle was re-sealed. That man was Peter Hall.

Duchess Convicted Of Suicide Attempt

New York, April 19.—(AP)—A bunch of boys in West 23rd Street were playing hide-and-go-seek last night when Harry Restel, 12 years old, found what he thought was the ideal place to hide.

Harry tried the doors of the Interstate Trust Company and to his satisfaction found them open. He groped his way into the darkened interior to an inner set of doors and found them open also. But hiding, even in a good place, becomes tiresome when there is no seeker, so Harry emerged and told the gang about it.

The gang rounded up a policeman who returned to the bank with them. He added to the list of poen doers those on a vault filled with silver valued at \$7,000. A call brought a half dozen detectives to the scene. An assistant manager routed from his bed at his Long Island home said he was positive all the doors were locked after the close of business. So far as could be determined nothing had been taken from the Bank. No watchman was on duty.
