RECTOR FREED AFTER CHURCH COURT BATTLE

Minister Charged With Marrying A Catholic, Faces Only Bishop's Warning

Lexington, Ky., April 25.—(AP)—Victor in a fight he waged virtually unaided, the Rev. Julius Arnold Velasco, rector of St. John's Episcopal church at Dayton, Ky., today faced only an admonition by his Bishop for his marriage to a Catholic and his aftermath.

The 31-year-old minister, whose romance led up to a two-day battle before an Ecclesiastical court here to retain his church orders, conferred last year only a few months before he married Vatherine Rogers, of Baltimore, was acquitted last night of the major accusations filed against him by a Diocese committee.

Conducting his own defense, the rector forced from prosecution witnesses the admission that he violated no church law. He won a verdict from the court of fellow ministers that cleared him of charges that he violated an agreement to resign if he married a Catholic, and that he denied his Bishop, the Rt. Rev. H. P. Almon Abbott, the right to enter his parish after the breach between them.

Opposing him were two veteran attorneys, acting for the prosecution. He might have been suspended, or even unfrocked, under section 1 of Church Canon No. 28, which applied to his case. The verdict calling for admonition by the Bishop was the lightest possible for the offense of which he was found guilty, using derogatory language toward his church superior.

In the Christ Church Cathedral parish house where the hearing was held the petite blonde woman in the case sat two days, by special permission of the court. The Bishop who, it was testified, brought Velasco to his diocese last year from Maryland, where the young rector then was a deacon, did not attend.

The rector and his bride of three months returned last night to his tiny parish in the northern Kentucky suburb, across the Ohio river from Cincinnati, for ministering to which he receives \$2,000 a year salary.

Formal charges of having failed to carry out the agreement to resign his charge if he should marry the Catholic girl he was known to love were filed against Mr. Velasco, a native of Key West, Fla., several weeks ago after he and Bishop Abbott had clashed.

In several hours on the stand, explaining his position and referring the while to himself as "the defendant" and "Velasco"—the rector brought out that he did sign the agreement, which he said was drawn up a few hours before his ordination, he declared he realized it was uncanonical and that he learned it had been rescinded by the diocese committee shortly after the ordination.

The marriage was performed at Elliott City, Md., by a Catholic priest. The committee's position was that it destroyed his usefulness.

BOTH WETS AND DRY CLAIMING VICTORY TODAY

Dry Statute Bitterly Assailed In Final Hearings Of Senate Committee

Washington, April 24.—(AP)—Both wets and drys claimed today to have emerged victorious from the House Judiciary committee's investigation of conditions under the prohibition laws, which saw the dry statutes bitterly assailed and staunchly defended by a long succession of witnesses.

The committee, with a voluminous transcript of testimony to show for its extended hearings, planned to take no further action as a result of the inquiry or to report any legislation based upon the investigation.

The hearings were conducted on proposals that the Eighteenth Amendment be repealed, although their purpose, as phrased by Chairman Graham, was to permit the wet spokesman to place their views before the country.

With the inquiry at an end, interest in the prohibition issue centered upon the sessions of the Senate Lobby committee, which is conducting an investigation of organizations formed to oppose or sponsor the anti-liquor statutes.

Beginning his hearings on February 12, the House group heard the prohibition laws vigorously assailed by the wets and then spiritedly defended by the drys.

Two days of rebuttal by the anti-prohibitionists, yesterday and Wednesday, brought the inquiry to a close.

In an endeavor to refute the statements of dry witnesses, the wets presented two noted football coaches, Tad Jones of Yale, and William W. Roper of Princeton, and Sir Henry Drayton, who is in charge of the Ontario system of liquor distribution through government dispensaries.

As the last witness of the investigation he testified late yesterday that the government sale system was instituted because a bone dry law had not proved successful. E. C. Drury, a former premier of Ontario, appearing for the drys had said that the government sale plan was a failure.

NEGRO IS GIVEN SIXTY DAYS FOR DRIVING DRUNK

Several Other Cases Disposed Of In Criminal Court Here Yesterday

Eddie Barrett, colored, charged with operating an automobile while drunk, was sentenced to sixty days on the county roads by Judge M. V. Barnhill, of Rocky Mount, who is presiding over the criminal term of Pitt County Superior court in this city.

Court disposed of half a dozen other cases during the session yesterday. They involved charges of worthless checks, embezzlement and breaking and entering.

This is the final week of the two weeks' term of court and work more than likely will be completed late this afternoon or sometime tomorrow. A great dent has been made in the docket, and numbers of cases which have been hanging fire for sometime have been disposed of.

Charlie Cormack, colored, charged with breaking and entering the Yum Yum Barbecue Palace, on the other side of Tar river, was adjudged not guilty.

Monroe Briley, aged white man of Bethel community, was found guilty of failure to support his wife, but Judge Barnhill failed to pronounce sentence.

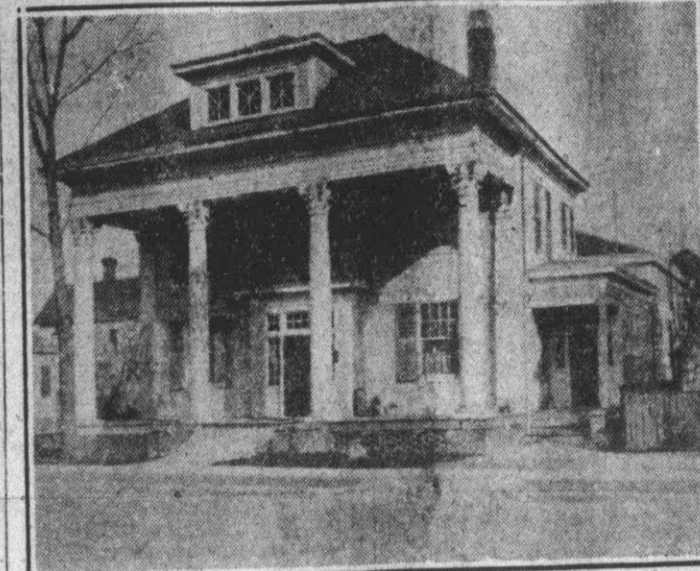
Lulu Edwards, colored, was found not guilty of a charge of assault with a deadly weapon.

Charged with embezzlement, Felton Whitfield, was adjudged not guilty.

Samuel Levine was permitted to pay the cost of action on a charge of aiding and abetting Tom Coor, local shoe shop operator, in the giving of a worthless check for a bill of goods.

C. D. Thomas was released upon payment of cost on a charge of giving a worthless check.

History Of The Greenville Woman's Club

Thirteen years ago there were three flourishing clubs for women in Greenville, so-called "book clubs" for the reason that they had study programs and circulated current books, in the absence of a town library. One of these clubs, the End of the Century, laid the foundation of the Greenville Public Library, whose history has recently been published.

The movement of Women's Clubs was sweeping the country, and the sphere of their activity, almost unlimited, was not covered by any Book Club in Greenville; so the need of a Woman's Club was keenly felt by many.

Mrs. R. R. Cotten, already active in State and National club work, was one of the prime movers in the organization of the Woman's Club in April, 1917, and throughout her life, was our Honorary President, and our adviser and inspiration in all that we have done. We feel that we owe our success as a club, to her influence and guidance.

Mrs. M. H. Quinerly was elected first president of the club, serving two years, enthusiastically leading the women in the many activities of "war work".

The members of this club took part, as individuals or committees, in every phase of war work to which the community was adapted—selling Liberty Bonds, War Saving Stamps, Red Cross Seals, directing or helping in "drives" for Red Cross membership; the registration of Women for Service; and collecting clothing for refugees; sending magazines, delicacies and money to hospitals and cantonments. Conservation was encouraged by lectures and demonstrations of war cooking, (eggless, sugarless, butterless foods), canning of fruits and vegetables; and prizes were given for home and school gardens.

A Rest Room was established and maintained on Evans street for the use of the country women on their days in town. Playgrounds were equipped at the Evans Street school and the cotton mill, and a supervisor was employed for one summer. For another summer a lady instructor in dramatic and artistic expression was employed, and a pleasing out-door exhibition was given.

Night school was maintained at the cotton mill, and regular day school established, and Parent-Teacher meetings started.

The club has always co-operated with the departments of Health and Public Welfare, assisting with Baby and T. B. Clinics, conducting County Surveys of Health, and serving lunches to the attendants at the Summer Short Course, and in many other ways.

The Health Department of the Woman's Club has had charge of the sale of Christmas Seals, has a special treasurer for disbursing the funds, which have kept many a needy and deserving person in the State Sanatorium, besides contributing to home comfort of those who could not go to Sanatorium. It has also placed books on Health in city and county schools, and put emergency medicine cabinets in all the city schools.

The Woman's Club has sponsored many civic movements, such as 6 o'clock closing for the stores in summer, community sings and Christmas trees, the curb market, music memory contests in the schools, a class in Bible study conducted by Mrs. Mary Steidley, art exhibits with descriptive programs, story-telling for the children in the Public Library, and the first appearance of the Carolina Playmakers in Greenville.

Classes in millinery, basketry, and crepe paper and sealing wax favors have been held under its auspices. Flower shows and plant exchanges have been carried on by the Garden Club, and seeds distributed to school children for home and school gardens. Shrubbery was set out around the Court House, and trees planted in various places, and the

culture of the crepe myrtle trees fostered.

TO QUESTION CLAIRVOYANT IN BAKER CASE

Police Will Also Quiz World War Veteran In Washington Murder Mystery

Washington, April 25.—(AP)—A clairvoyant and a world war veteran today came under police scrutiny as search for the slayer of Mary Baker young government employe, neared the end of its second week.

Long before day Lt. Lieutenant Edward J. Kelly, chief of the homicide squad, and Commonwealth attorney, of Arlington County, Virginia, went into the northeast section of Washington to investigate a report that a clairvoyant there had told Miss Baker but a week before her death that she would be killed by a married man.

The investigators reported later the woman had denied knowing Miss Baker or making such a statement. They indicated however, the story would be further checked.

Another member of the homicide squad early today went to a Washington Hospital to question a man held there for mental observation. He was described as a Veterans Bureau Patient, and had been reported to investigators as a friend of the slain girl.

This report was brought to detective headquarters by a Washington policeman, Edward W. Daniels. The name of the suspect was withheld.

Inspector William S. Shelby, chief of detectives, said that aside from these two leads investigators probably would concern themselves principally with running down to the mass of "tips" and "clues" that have poured into his office.

He said letters containing information about the case had been received from cities hundreds of miles distant from the capital, and that although much of it was worthless, every possibility was being investigated.

FILING TIME FOR ELECTION ENDS TONIGHT

One Hundred And Seventeen Candidates Filed For Various Offices

Raleigh, April 25.—(AP)—At noon today 117 candidates for United States Senator, Congressional, State or Judicial district positions had filed notice of candidacy with the State Board of Electors one other candidate had sent in his fee but his blank was incorrectly filled out. The filing period ends at midnight tonight.

No candidate in either party had filed for the Superior Court, bench in the 13th district, of which Judge A. M. Stack is the present judge.

Senator F. M. Simmons, J. W. Bailey of Raleigh and T. L. Estep of Stratford have filed for the Democratic nomination as United States Senator and Rev. H. Grady Dorsett of Wake Forest, George Butler of Clinton and Congressman George Pritchard of Asheville have filed for the Republican nomination.

There are three contested Democratic seats in Congress. In the third district Charles Abernethy of New Bern is being opposed by Samuel H. Hobbs of Clinton in the fifth Frank Hancock of Oxford and A. F. Sams of Winston-Salem have filed. In the ninth Hamilton C. Jones of Charlotte, A. L. Bulwinkle of Gastonia, and W. Albert Sams of Marshall are candidates. One Republican candidate has filed for Congress in every district except the first.

George P. Pell is being opposed for re-election as Democratic corporation commissioner by James H. Holloway of Raleigh. Stanley Winbourne is unopposed for his Democratic seat and Capt. Nathan O'Berry is unopposed as Democratic candidate for State Treasurer. I. G. Greer of Boone has filed as Republican candidate for state treasurer and J. T. Prevette of North Wilkesboro is Republican candidate for the corporation seat of Pell while B. C. Campbell of Raleigh is candidate for the corporation place of Winbourne.

Four Democrats are seeking the Superior judgeship in the 16 district and a Republican is also in the race. Republicans have filed for the judgeship in the first, sixth, eighth, ninth, twelfth, fourteenth and sixteenth districts. Democrats have filed in all except the 13th.

WOMAN KILLS ANOTHER AND THEN HERSELF

Jealousy Over Social Position Believed To Have Caused Double Tragedy In Calif.

Laguna Beach, Cal., April 25.—(AP)—Jealousy over social position was blamed by the authorities here today for the murder of Mrs. Doris Murray Palmer, an artist formerly of Chicago, and the suicide of Mrs. Guy Bates Post, erstwhile musical comedy star and divorced wife of the noted actor.

The bodies of the two women, who were reputed to have been "very close friends" were found in Mrs. Palmer's bungalow here late yesterday.

Mrs. Palmer, known as an artist and designer of scenery for the Laguna Beach Playhouse, had been shot in the back. Mrs. Post's body, with a bullet through the mouth and brain, was found lying on a revolver, in which two exploded shells were discovered.

Mrs. Post, known on the stage as Adels Ritchie, was seen moving about the Palmer house an hour before the bodies were found. Mrs. Palmer was believed to have been slain early in the afternoon, within fifteen minutes of the time Mrs. Francis Berie, socially prominent here, had delivered an invitation to a luncheon that excluded Mrs. Post.

Sheriff Sam Jernigan said he believed the invitation fanned the jealousy between the two women into a frenzy that caused Mrs. Post to shoot Mrs. Palmer and then turn the pistol on herself.

Mrs. Post last year was director of the annual Boy Scout benefit play at the playhouse here, which is sponsored by Harold McCormick, multimillionaire son of the late Harvey McCormick of Chicago. Cyrus H. Co McCormick, this year Mrs. Palmer, because she designed the sets, was given the honor.

The change in directorship, their friends said, caused them to quarrel. Authorities said that when Mrs. Palmer was supervising a dress rehearsal of the play, Mrs. Post heard to say "I'd like to shoot her." The play was to have opened last night, but the double tragedy caused the theater to remain dark.

Mrs. Palmer was shot through the back, and it was not known whether she was taken unawares.

Bank Commissioner Indicted In Ky.

Frankfort, Ky., April 25.—(AP)—O. S. Denny, state banking commissioner, today was indicted by the Frankfort County grand jury on two counts of "failure to take charge of a bank promptly and effectively after having knowledge of the bank's condition, insolvency and unsafe."

Governor Refuses To Remove Warden Until After Investigation Of Fire That Cost Over 300 Lives Is Completed; Probe Expected To Be Completed Today

Columbus, Ohio, April 25.—(AP)—Apparently accepting restoration of prison discipline, convicts in the Ohio Penitentiary, where 319 prisoners lost their lives in a fire Monday went to breakfast in an orderly manner early today.

Catcalls and hooping were absent and for the first time in four days the men marched with a firm, snappy step. Guards expressed amazement at the demeanor of the men who only yesterday were a howling mob, refusing to abide by the orders of their keepers and refusing to heed orders until their demands for the removal of Warden Preston E. Thomas were met. The Warden was not removed however.

The board of inquiry transferred its activities today from the penitentiary to the office of Attorney General Gilber Betsworth. A complete report of the investigation will be placed before Governor Myers Y. Cooper tomorrow. Until then, the governor will take no action regarding the administrative personnel at the penitentiary.

No convicts were summoned to appear at the final session of the board. Several guards, including Night Captain John Hall, Thomas Walkinson, William Baldwin and Thomas F. Little, were recalled to give further testimony as to their efforts to rescue the ill-fated prisoners from the locked cells.

Several witnesses have testified that confusion among the guards was partly responsible for the delay in getting the doors of the burning and smoke-filled cells unlocked. Two persons, Albert Nice, chief of the Columbus Fire Department, and Deputy Warden J. C. Woodward, told the investigators they believed all of the men could have been saved, had the cells been opened promptly.

As the inquiry neared its close, rumblings of discontent continued to pervade the old prison where hundreds of sullen convicts maintained an attitude of passive resistance—aimed, their leaders said, at the dismissal of Warden Thomas. The revolt, they said, will continue until that end is achieved.

Although the prisoners at first were extremely unruly and threatened to kill guards, it appeared to day they would confine their resistance program to refusing to obey orders. Opposition to Thomas was based on prisoners' charges that under the present regime they were treated cruelly. Other prisoners, however, said they had witnessed no brutality.

At last night's session of the inquiry board, Harry Dillehay, a trustee in the warden's office, said he and Warden Thomas went out into the prison yard after the fire alarm had been turned in, and that the Warden exclaimed "My God what's going to happen next."

Upon returning to the guard-room Dillehay said the Warden ordered the guards to get the man out of the fire-ridden cells. J. H. Rhodes contradicted part of Dillehay's testimony, declaring that Warden Thomas did not go into the prison court. He said Thomas remained in the guard room and instructed the guards to "get the keys and get them out."

Harding Asked To Appear In Court In Civil Hearing

Charlotte, April 25.—(AP)—H. P. Harding, superintendent of the Charlotte Public Schools, today was added to the list of those summoned to appear before a special commissioner for examination in preliminary proceedings in a legal action brought by Miss Alice Warren, school teacher, who alleges she failed of re-election through conspiracy.

Mr. Harding will appear Monday with Aubrey Elliott, principal of the Alexander Graham Junior High School, where Miss Warren is instructor in home economics. Mrs. John A. McRea, of the Charlotte school board, is under summons to appear Tuesday.

Mrs. Warren charges that she was denied a contract to teach her next year because she is a friend of Warren G. Myers, Charlotte business man, who is suing W. R. Foreman, member of the school board, to recover \$8,000 alleged to have been fraudulently taken by Mr. Foreman from partnership funds.

SCIENCE ALL SET FOR THE SUN ECLIPSE

Lick Observatory Astronomers Prepare For Eclipse On April 28th

Camptonville, Cal., April 25.—(AP)—In peaceful Oak Valley, as silent almost as the phenomena they have come to photograph, Lick Observatory and other astronomers are taking strategic positions for a concerted exploration of the eclipse of the sun April 28.

Within and along the computed line of the shadow which the moon will lay upon the land by passing between the sun and the earth at the rate of about 1,200 miles an hour the finishing touches are being given to months of preparatory work.

From dawn to dark and often late into the night, checking, correcting and testing of instruments and apparatus is being carried on.

Using a rustic building that once served as a mining town dance hall as a laboratory, Dr. J. H. Moore, astronomer of Lick, and Dr. D. H. Menzel, assistant astronomer, have made numerous tests of the density and strength of light and of the photographic plates which will be employed.

Perhaps the most perfect combination of radio, airplane, telescope and spectroscope ever attempted will be brought into play to record the various phases of this eclipse and its totality which it is estimated will have a duration of only 1.3 seconds.

From the Naval Observatory at Mare Island electric time signals will automatically drop a sensitized plate a fraction of an inch each eighth of a second so that the spectroscope will photograph what is equivalent to a moving picture of the atmosphere of the sun during the final moments of partial eclipse and the entire period of total eclipses.

Telescopic observations will have to do chiefly with the sun's corona which to the eye looks like a thin layer reflection or halo around the solar "disc". The photosphere or portion of the sun which the moon will almost cover completely is defined by Dr. Menzel as "the layer which gives rise to light—that part of the sun's atmosphere where it begins to be opaque."

Seek Early Action On Liberalization Of Compensation

Washington, April 25.—(AP)—Early action on the bill passed yesterday by the House providing liberalization of compensation allowances for World War veterans was demanded in the Senate today by Senator George, Democrat, Georgia.

The Georgian served notice that if the Veterans' bill was not quickly acted on by the finance committee, he would move to discharge the committee and get it immediately before the Senate.

Senator Bratton, Democrat, of New Mexico, joined in the demand for early action. He said he would propose an amendment to the House bill to provide a minimum of \$50 a month for veterans suffering from tuberculosis.

Senator Ashurst, Democrat, Arizona, also threatened a move to discharge the finance committee from consideration of the Veterans' legislation.

Prince Of Wales Returns From Hunt

Windsor, Eng., April 25.—(AP)—The Prince of Wales, home from his African hunting trip, landed on Smith's lawn in the Windsor great park today, making a perfect landing.

On his arrival in England the Prince was as close as he could get to his new country resident, Fort Belvedere at Sunningdale. From the front door a private road is being built to the private Royal Air-drome at Smith's lawn, Fort Belvedere has been in the hands of builders and decorators for some time in preparation for the prince's return from Africa.

The Duke of York and Prince George were awaiting their elder brother and greeted him. Then they drove to the prince's country house where King George and Queen Mary welcomed him home.

Makes Permanent Court Order For Capone Freedom

Miami, Fla., April 25.—(AP)—Federal Judge Halsted L. Ritter, today made permanent the temporary injunction issued March 27 forbidding 29 Florida sheriffs from carrying out an order of Governor Doyle Carlton to arrest Alphonse Capone on sight and escort him to the state penitentiary.

Capone and his attorney, J. F. Condon, were the only witnesses at a hearing in Federal court. At the conclusion of testimony, Judge Ritter read a written opinion stressing freedom of citizens of the United States and of Florida, unless restrained by due process of law.

After ordering the injunction made permanent, Judge Ritter called Capone to the bench and urged him to take advantage of his privileges as a citizen of the United States in lawful exercise of his faculties.

The courtroom was crowded, none of the 29 sheriffs named in the order appeared during the hearing.

Approve \$225,000 For Wright Marker

Washington D. C., April 24th: Representative Lindsay Warren stated today that the director of the budget had approved an appropriation of \$225,000 for the memorial to the Wright Brothers to be erected at Kitty Hawk, North Carolina. From Havana he will fly to Cristobal, Panama, and remain there to fly back the main at an undetermined date in the near future.

The girl was injured fatally last night when a speeding motorist reached from his automobile and seized her arm as she walked the street with a companion. Jerked from the edge of the sidewalk, she fell against the curbing and her skull was fractured.

Lawing disclaimed any knowledge of the occurrence, but police said they had evidence he was in the car, which they asserted had been stolen in South Carolina. They are seeking another man believed to have been the driver of the automobile.

He urged the local merchants to get busy and do their best to desire the support of their patrons. COLD BREAKS IN AGAIN ON BIG LEAGUES

The present chills and dampness of spring appear to be starting up trouble for major league baseball teams almost as fast as they are piling up double headers.
Only one club so far has played all its games: the Chicago Cubs, gaining this honor, while the St. Louis Cardinals and Detroit Tigers have escaped serious consequences, with but one postponement apiece.
More cold weather yesterday caused the postponement of all but two major league games and neither of these proved very profitable to the club owners. Only about 1,000 St. Louis fans turned out to see the Browns beat Detroit, 12 to 4, while about three times that number appeared at the Cubs park in Chicago to see the St. Louis Cardinals down the National league champions, 9 to 2.
For the rest, the cold was piling up more grief. The Boston Braves, for example, seen headed for something like the slaughter of September 1928 when they played four successive double headers against the New York Giants and lost all eight games. The Braves now have five twin bills to play against New York and each one makes the prospects look better for the Giants, who have less need to conserve their strength.
The New York Yankees are in similar difficulties. Out of six games scheduled against Philadelphia, they succeeded in playing only the opener in each city.
And the Yankees have a rather small staff of starting pitchers, ill fitted to endure the rigors of a succession of twin bills while the champion Athletics seem ready to go as far as they like with overtime play.
The Chicago White Sox also headed for trouble with six double headers scheduled against the Cleveland Indians and St. Louis Browns, but hot whom have more pitching strength to hurl into the battle.
Although St. Louis gained all the glory in the two games that did survive yesterday, the teams owe it to a few selfless players. George Fisher, slugging young outfielder, played the leading role as the Cardinals downed the Cubs, scoring one run and driving in four with a single, two doubles and a sacrifice in four trips to the plate.
Chick Hafey followed the example Fisher set in the previous inning when he tripled with the bases loaded to bring in three of the five runs St. Louis scored in that inning. Sylvester Johnson hurled the entire game for the Cards.
Fred Schulte and Chad Kimsey divided the honors in the Browns' triumph over Detroit. Schulte did most of the heavy hitting while Kimsey stepped in as a relief pitcher when Herman Holshausen began to wobble and shut out the Tigers without a hit for four innings.

COTTON MARKET

New York, April 25.—(AP)—Cotton opened steady today at a decline of 1 to 12 points. Attention of the trade was centered on the May position. The first May notices issued here were estimated at about 226,000 bales and there appeared in the market evidently caused some liquidation of May. There was also active covering and after selling off to 16.15 at the start May advanced to 16.27 or within a point of yesterday's closing quotations. It was reported that interest representing the Southern Co-operative Associations were stopping the May notices, but fluctuations continued nervous and irregular during the first half hour. May reached 16.19 compared with 16.28 at the previous close.

The new October contract after selling up from 15.09 to 15.16 eased off to 15.07, making the market 6 to 10 points net lower around 10:30 o'clock. Liverpool was lower than due on the New York close of yesterday which may have accounted for some of the early selling. Liverpool cables reported trade calling supplied by Continental and Bombay selling and said the India boycott was affecting business in cotton goods.

STOCK MARKET

New York, April 25.—(AP)—The stock market presented a rather spotty appearance during the greater part of today's session, but major speculative activity seemed to be on the upside.

Corporation earnings for the first quarter made up a large part of the day's business news. American Bank Note, Kelvinator, Bush Terminal, Chicago Great Western and Maine Central showed increased earnings per share over the first quarter of last year while Bethlehem Steel, Michigan Steel, Independent Oil & Gas, Congress Cigar, Union Carbide, St. Louis San Francisco and Pere Marquette made unfavorable comparisons.

Foreign buying of copper continues in fair volume but the domestic demand is quiet.
