CANNON FAILS TO PRESIDE AT M. E. MEETING

Surrenders Gavel to Bishop Beauchamps At Dallas Convention Today

Dallas, May 16.—(AP)—Bishop James Cannon, Jr., of Washington, D. C., today's president of the General Conference of the Methodist Episcopal church, surrendered the gavel to Bishop W. J. Beauchamp, of Atlanta, Ga., "because of certain matters before the conference."

He asked Bishop Beauchamp to take the chair after making two statements concerning the work of the Board of Temperance and Social Welfare, one of which he said was unusually pertinent "because of the statement of Dwight Morrow that he was not in favor of a return of the saloon, but was in favor of repeal of the Eighteenth Amendment."

When Bishop Cannon took the chair he was greeted by applause which was not ended until more than half the delegates had risen to their feet in tribute to him.

Proceeding without thanks for the unprecedented demonstration, Cannon took the conference that he had ten thousand copies of the address of James E. Houghson, fraternal delegate from Canada, printed for distribution.

The conditions to which Cannon referred were the charges pending against him of gambling on the stock market.

Another wave of applause followed, and immediately Bishop H. M. DuBose of Nashville demanded the floor. A copy of the morning paper, the Dallas News, in his hand, Bishop DuBose said that he wished to publicly express his resentment of the article appearing in the paper.

This article said in effect that those bishops whose political activities had been attacked had "complied" with members of the Episcopacy committee whereby they were to be freed of accusation in regard to politics in return for which they combined with the "anti-Cannon" forces.

Bishop DuBose declared there was no truth in the statement. "I am sure," he declared, "that no member of this conference sought to bring about a compromise I do not live in a glass house. I am willing to see everything I do and everything I say printed. But I resent this statement."

Another round of applause greeted this statement. Bishop E. D. Mouzon of Charlotte, was the next to gain recognition.

"I merely rose to say" he said, "that I am in full accord with the statements made by colleague and friend, Bishop DuBose."

Mouzon, with Moore, DuBose and Cannon, were those named by the Rev. Rembert Smith of Washington, Ga., as taking undue part in politics in 1928. All were exonerated of these charges by the Episcopacy committee.

F. C. Martin, Sr., Passes At Bethel; Burial Yesterday

Funeral services for F. C. Martin, Sr., were conducted from his home in Bethel yesterday afternoon and burial was made in the family burying ground two miles from Bethel. Rev. E. L. Hillman, pastor of Jarvis Memorial Methodist church of Greenville, assisted by Rev. W. L. Barrs, pastor of the First Baptist church of Bethel, officiated. Members of the Masonic lodge of which the deceased was a member, took part in the services.

Mr. Martin died Wednesday evening at nine o'clock after illness extending over a period of seven years. He suffered a stroke of paralysis several years ago, and for the past five years had been confined to his bed. He was a native of Pitt county and spent all of his life in the Bethel community. He was engaged in the farming industry prior to the illness that resulted in his confinement.

He is survived by his widow, who before her marriage was Miss Sophronie Ross, daughter of the late S. R. and Margaret Ross, and six children, J. T. S. H. and F. C. Jr., and Mrs. J. O. Warren, Bethel, and Mrs. Hubert Speight, Farmelo. He is also survived by one sister, Mrs. N. L. Gray, of Robersonville.

ARMED POSSE SEEKS NEGRO AT LIBERTY

Unidentified Negro Charged With Attempted Assault on 14-Year-Old Girl

Liberty, N. C., May 16.—(AP)—Heavily armed posses of officers and citizens today were searching a thickly wooded section near Liberty for an unidentified Negro who attempted to assault a fourteen-year-old girl late yesterday.

Blood hounds in charge of Ashboro officers were expected here during the day to aid in the hunt. Six suspects arrested by the posse which began its search shortly after the attack were taken before the girl, daughter of a furniture factory employe, but she could identify none of them and they were released.

The girl related that she was at home alone yesterday and after going out into the back yard for something returned to the kitchen to find a Negro apparently about 20 years old there.

The intruder grabbed her, she said, gagged her with a handkerchief. (Continued on page six)

Showdown On Tariff Bill Delayed Until Next Week; Conferees Reach Impasse

Question of How to Get the Bill Returned to the Senate Without Another House Vote Proving Principal Source of Worry to Members

Washington, May 16.—(AP)—The showdown on the debenture and legislative flexible tariff provisions promised in the Senate late today was postponed probably until next week when the tariff bill conferees reached an impasse on how to get the bill back to the Senate.

Senator Smoot, Republican, Utah, said after the conference that the question still to be decided was how the bill could be returned to the Senate for action without forcing another House vote on provisions in disagreement.

The Senate conferees must decide this for themselves as the House managers are unwilling to negotiate further until the Senate gives its conferees a free hand to work out an adjustment over the flexible and debenture clauses.

Deadlocked on the Senate's amendment to revoke the authority of president to proclaim emergency tariff changes, the Republican Senatorial conferees sought to be released from a previously imposed restriction binding them to insist upon this provision.

The House conferees, meanwhile, stood steadfastly upon their decision not to carry the negotiations further until the representatives of the Senate were given authority to work out a compromise. The Senate's amendment had been voted down by a large majority in the

House. Congressional leaders were convinced that rejection by the Senate of its conferees' request could only have the result of killing the tariff bill, the product of sixteen months of effort, in conference.

The Democrats were ready with a counter motion that the conferees be instructed not to abandon the amendments in question.

Two Officers Slain in Raid

Hohenwald, Tenn., May 16.—(AP)—Two officers are dead today as the aftermath of a moonshine ambush on a prohibition raiding party deep in a wood near his distillery.

Deputy Sheriff M. L. Newton, 37, of Lawrence county, was killed instantly late yesterday by bullets fired upon the raiders as they approached the distillery hidden at the bottom of a ravine.

Deputy Sheriff Luke Hinson, 21, of Lewis county, was wounded seriously and died in a hospital today.

Later officers arrested John P. Hines, who said he was farmer. He was hoeing corn in a field near the distillery. He denied knowledge of the raid or ambush.

Elbert, five-year-old child of Ed Smith, passed away at the home of Bud Nobles here last night.

Funeral services were conducted this afternoon by Rev. W. H. Covert pastor of the Immanuel Baptist church, and burial was made in the family burying ground near Black Jack. Death followed illness of only a few days.

Gold Star Mothers Given An Enthusiastic Welcome On Arrival At Cherbourg

Liner Escorted Into Port By Two French Planes; Crowd of Several Thousand Cheer As Boat Arrives; Mothers Weep At Demonstration

Cherbourg, France, May 16.—(AP)—This former wartime port of American debarkation, today greeted 231 Gold Star Mothers of the United States, who arrived on the steamship America at 2:45 P. M.

The liner came into port escorted by two French military planes. An enthusiastic reception was given the party.

Every member of the party arrived in fine health and spirits, greatly affected, however, by the tumultuous welcome.

Officials representing the government and the port administration met the mothers as they came ashore and gathered on the railway platform adjoining the dock.

Four noon addresses were delivered after which the train to Paris departed at 3:40 P. M. and other reception awaited them at the invalides station at Paris.

A crowd of several thousand assembled on the dock cheered as the boat came in and while the mothers slowly disembarked.

There were masses of flowers waiting for them among which were fourteen huge bouquets from Bentley Post, American Legion.

There were also many flowers for Mrs. Sarah G. Thomas, of New York, who had been elected president of the group on board the ship; Mrs. Eva Lindsay, of Bethel, Ohio, dean by virtue of her age; and Mrs. Felipa H. Crespin, Omaha, Nebraska, the youngest mother in the party.

Mrs. Thomas, as leader, will place a wreath on the grave of the unknown soldier tomorrow.

Many of the Gold Star Mothers wept. Their trip on the steamship had been full of interest and reasonably quiet. On the second day the group had thrown a wreath into the sea in memory of the war dead who lie beneath the waves. There had been the usual Sunday services at sea for all creeds and as much entertainment as the mothers wished.

CLUB WOMEN PAY TRIBUTE TO LEADER

Memorial Service Is Held for Mrs. Sallie Southall Cotten At Pinehurst

Pinehurst, May 16.—(AP)—Officers of the North Carolina Federation of Women's Clubs in session here were elected today for the coming year.

Mrs. Jack Hoilister of New Bern was named first vice-president, Mrs. Eugene Davis of Statesville was elected trustee; Miss Elizabeth Sewarber of Southern Pines was chosen treasurer; and Mrs. J. H. B. Moore of Greenville was elected recording secretary. All other officers held over to another year.

The North Carolina Federation of Women's Clubs was asked by its resolutions committee today to go on record as favoring a 55-hour week for day workers and a 50-hour week for night workers in the textile industry.

Resolutions prepared by the committee and submitted to the Federation at its convention here also recommended gradual abolition of night work for women and children, elimination of the fourth-grade clause from the child labor statute and a requirement instead that all children under 16 who engage in full-time gainful occupations be required to have completed the sixth grade.

Indian Government Plans Negotiations For Peace With Nationalist Leader

Bombay, India, May 16.—(AP)—Indian peace prospects brightened today with announcement in Liberal quarters of an early expected government for negotiations with Mahatma Gandhi, civil disobedience prisoner. A government meeting at Bombay and a secret session of the all-India Congress, held simultaneously, presaged decisive action in some direction before the week-end.

While these reports were going abroad, Mme. Sarojini Naidu, successor of the Mahatma and Abbas Yabji, was arrested early today for attempting a salt raid at Dharsanana and shortly after ward set at liberty. Mme. Naidu and her band of volunteers had sat in the road outside of the village since yesterday forenoon, when halted by police.

Some of her followers were detained after her release. All were given food and drink from which they had abstained during the entire time of the roadway impasse.

Violent rioting occurred late yesterday at Mymensingh, Bengal, in which about 90 persons were injured. The clash occurred over delivery of liquor and herbs used to make liquor, from the government depot by civil disobedience volunteers. The police charged when the disturbances became violent. The district magistrate was hurt as was the superintendent of police. One officer, four non-commissioned officers and 28 constables were injured. Fifty-three rioters were threatened, indicating the extent of the disturbance.

Raids on the Dharsanana salt pans by small parties today continued to be attempted but without success.

Previously these volunteers had attempted to supply Mme. Naidu and her followers with food and water. The police previously had spread a carpet for her and furnished her with bedding. It also appears the police supplied her with food.

Sholapur advices said all the mills in that large textile community reopened this forenoon without incident. Shops throughout the city, which is still under martial law, were reopening.

# EAST LEADS THE CONTEST IN AMERICAN

Although two rainy days at the finish did some serious damage to the schedule of the first inter-sectional series of the 1930 American League season, the results of the past two weeks have given ample proof of a clear margin for the Eastern clubs over their Western rivals. Starting May 1, the American League clubs played 49 games and the east's representatives won 32 of them winding up with Washington's 4 to 2 triumph over the Cleveland Indians in the only American League game which escaped rainy and cold weather.

The Senators put themselves above the 500 mark for the inter-sectional play by the final victory. They won seven games and lost six. And Sam Jones and Sam West, pitcher and outfielder, played the leading roles in winning the game. Jones kept Cleveland's ten hits scattered so they could do little damage as he outpitched Young Willis Huddlin and West drove in two Senator runs with a home run and a triple.

The Philadelphia Athletics, champions and league leaders, made the best showing of the inter-sectional play. They won eleven games and lost two, one each to Cleveland and St. Louis. The New York Yankees won eight and lost three. Washington came in third while the Boston Red Sox, lowest of the Eastern clubs, tied with Cleveland, highest of the Western clubs, with six victories and as many defeats. St. Louis, Detroit and Chicago followed in order in the inter-sectional standing.

Chicago's White Sox, with but three victories in a dozen inter-sectional games, barely averted another defeat yesterday when rain descended in the middle of their final game with the Athletics although they could not win. After Philadelphia had driven Red Faber from the mound with a six run attack in the second inning, the Sox staged a great comeback against Mose Grove to tie the score in the first half of the fourth, just before rain halted proceedings. The score reverted to the fourth inning and there was no official game.

The National League, with the completion of its first inter-sectional series scheduled for today, also got in only one game yesterday. That one was a wild hitting thriller in which the Boston Braves edged out the Chicago Cubs, 10 to 8. Burleigh Grimes, former nemesis to the Cubs, gave away two runs at the start and the Braves did not catch up until the fifth inning when Lance Richbourg hit a home run with the bases full. Chicago scored three more runs in the next inning and Boston squared that account an inning later.

Rogers Hornsby's home run gave the Cubs another trio and almost won the game in the eighth. Grimes, yielding 13 hits, pitched all but the last inning. The New York Giants provided some news for National League fans while they were idle in St. Louis by doing away with a jinx by the simple method of trading players. Clarence Mitchell, baseball's only left handed spitball pitcher, was added to the Giant roster in exchange for Ralph Judd, a young right hander. The trade, as Manager McGraw explained it, was something of a defensive move as Mitchell's peculiar delivery has caused frequent trouble but McGraw also said he believed Mitchell's experience would be for useful to his team at present than a promising young pitcher who liked experience.

# U. S. GOLFERS WIN WALKER CUP CONTEST

Sandwich, Eng., May 16.—(AP)—The American Walker cup team today won the cup, emblematic of international team golf supremacy for the sixth time.

With three points won in the foursomes yesterday, the Americans today had only to win three singles and halve another to win the contest outright and win three singles to insure retaining possession of the cup which never has been surrendered by an America team.

Bobby Jones, George Voigt and Harrison R. Johnson won their matches today in short order, leaving no doubt as to the outcome since the British could win the five remaining matches and still fail to get the trophy.

When the third straight American victory was reported for the day and the British found they could not win, George Von Elm and Roland MacKenzie were leading in their matches while neither of the two Portland, Ore. Players, Dr. O. F. Willing and Don Moe were far enough behind to count them out. Francis Quimet trailed T. A. Torrance and seemed likely to suffer defeat.

## LOOK AHEAD.

"Eat, drink and be merry for tomorrow we die," has become apparently the most popular philosophy of the day. The Epicurean theory of living, broadened to include expensive cars, fine clothes and all modern luxuries, is gaining adherents daily. The great majority of people seem to live with but one object in mind—to crowd every so-called pleasure into an uncertain period of existence.

The result is that many are living beyond their incomes and have become literally slaves, with the automobile companies, clothes shops and others owning their salaries for months ahead. The first of each month, with its flood of unpaid bills, among which a pay check all too small must be divided, is an ordeal that is creating wrinkles and gray hairs.

Even the purchases cannot be fully enjoyed for worry about how they are to be paid for. After the last installment is finally sent in, the articles are usually much worn or "Mrs. Jones" has a later model that one must have in order to keep up. What an existence!

Yet, the system of spending ahead is continually growing in favor. For instance, in the automobile field an analysis of the annual reports for 1929 show that there was an increase of approximately 12 per cent in the number of motorists purchasing automobiles on the installment plan. There was a total of 3,441,629 automobiles financed by the 411 companies. This increase would probably be shown in all industries whose products may be used for pleasure and purchased on the installment plan.

No doubt, many families are denying themselves the necessities of life that they may obtain the luxuries.

Too few people look ahead and provide for the future. The nest that once retained the nest egg has been discarded for lack of use. The probability of a rainy day has been forgotten. Because today the hen is laying and the sun is shining, the eggs are eaten and the umbrella thrown away.

What is to be the ultimate result if this or the succeeding generation does not adopt a saner, sounder basis of living? It should be recalled that all pleasure is not gained by acquiring luxuries. They often are a source of grief rather than joy when one cannot in reality afford them. They give only an artificial pleasure at

the most and one should pause occasionally and plan for the future. Look ahead and avoid a possible wreck. —(Scottish Rite News).

# ABOUT TOWN

Willard L. Dowell, secretary of the North Carolina Merchants Association, will be the principal speaker at the quarterly meeting of the Greenville Merchants Association next Tuesday evening.

He will speak on a subject of paramount interest to the people of this state, that of the sales tax. This question will very probably be one of the bones of contention at the next meeting of the North Carolina Legislature and it is well that the merchants fully inform themselves of the question before the session begins.

By the time of the next convention of the Greenville congregation will be housed in their new church building on Fourth street overlooking the ravine. The new home will be far more commodious than the old edifice and would enable the church to entertain the visiting Diocese delegates in splendid form.

Greenville is always glad for an organization of this kind to visit here. It gives the outside people an opportunity to learn something of the development which the city has made in past years and the resources and possibilities afforded by the future.

The office of Superior Court for this district seems to have become attractive all of a sudden. Not many years since Judge Guion resigned and then Judge Wheeler was elected twice and resigned and Judge Guion was appointed and held it until he quit after a year or more in office and then Judge Horton was twice elected and after a few years resigned and then Judge Albion Dunn was appointed and held the position for about a year. None of these gentlemen had opposition in the primary following their appointment for election because of established, not to oppose immediately a man appointed or elected to fill an unexpired term in the Judgeship. As Judge he has presided over the Superior Courts in all sections of the State and has made a splendid record. Lawyers and laymen generally approve of him as Judge and man. Many of the most important civil and criminal cases arising in this state during the last few years have been successfully and correctly tried in courts presided over by Judge Nunn. ## EARL OF DERBY WILL WITNESS TURF CLASSIC

Louisville, Ky., May 16.—(AP)—The color and pageantry of America's greatest horse-racing classic, taking definite hue and form today for the fifty-sixth running of the Kentucky Derby, centers about two decidedly contrasting figures of the turf—the English Earl of Derby and the freckled-faced Yankee Earl of Sande.

Though they travel in separate spheres, the paths of these two will bring them into one and the same spotlight late tomorrow afternoon, if racing form and favor mean anything, for Earl Sande is the popular choice to ride the great eastern colt Gallant Fox to victory and enable his owner to receive the prized gold trophy from the hands of the distinguished British patron of the turf.

The Earl of Derby, seventeenth of his line, will witness for the first time the American race counterpart of the classic English event bearing his name. The guest of Joseph E. Widener, eastern sportsman, while in this country, the English Earl was expected to reach Louisville today from Lexington, where he has been visiting the choicest of blue grass breeding establishments. Tomorrow he will occupy a post of honor at the "Derby", a civic holiday declared in his honor and an opportunity arranged for him to broadcast impressions of the race over an international radio "hook-up".

The Earl of Sande is no such stranger to Churchill Downs and the route that leads to the laurels of derby victory. Twice before, in 1923 and 1925, the boy who rode to fame from Idaho to New York has booted home winners in Kentucky's classic. Tomorrow he will have the chance to cap the climax of a dramatic come-back by riding home a winner on Gallant Fox, black son of Sir Gallahad III. Just a week ago, Sande rode Gallant Fox to triumph in the rich

breakfast at Pimlico. If he wins again tomorrow, as he is expected to do, Sande will equal the best record of any jockey in the long history of the derby and Gallant Fox will duplicate the achievement of Sir Barton which in 1919 reversed the order, capturing the Preakness after a surprising victory in the derby. No other horse has ever won both of these three-year-old classics.

The odds are all in favor of Gallant Fox, which will race in the colors of the Balair Stud, owned by William Woodward of Chicago. It has long been a tradition that anything can happen in a horse race, especially the derby, but the eastern colt was backed down today 7 to 5 by an influx of financial support and looked upon generally as the class of the field, with the possible exception of Tannery, strapping chestnut son of ballot and owned by Edward F. Pritchard of Paris, Ky.

Market Report Cotton--Stocks--Grain

COTTON MARKET

New York, May 16.—(AP)—Cotton opened steady today at an advance of 1 to 7 points, with the new crop relatively firm on unfavorable reports from Texas and some parts of the central belt.

The appearance of notices estimated that 9,100 bales seemed to be in some selling of May and the price eased off from 16.13 to 16.08 during the first few minutes, or about 4 points net lower. There again seemed to be some selling of July against purchasers of May and July decline to 16.19.

The new crop, meanwhile, held quiet and steady with active months working about 9 to 13 points net higher or up to last night's closing quotations after the early offerings were absorbed, with the general list ruling about net unchanged to 12 points higher at the end of the first half hour.

Liverpool cables said trading was much restricted with the relative steadiness of near months there attributed to covering and scarcity of contracts. A sustained demand from the British home trade for cotton goods reported in Manchester but export demand was poor with yarns inactive and rarely offered.

GRAIN MARKET

Chicago, May 16.—(AP)—General buying hoisted wheat values today, evidence being that North American wheat export business in the last 48 hours has amounted to 3,000,000 bushels.

Wheat closed strong 2 1-4 to 3 1-2 higher than yesterday's finish; corn 2 1-8 to 2 5-8 up; oats 1-2 to 1 advance and provisions varying from 25 decline to a rise of 20.

STOCK MARKET

New York, May 16.—(AP)—The stock market virtually surrendered itself to speculative apathy today, and Wall Street was left to comb the business news and statistical studies coming to hand for signs of developments that might cause a market awakening.

One of the most encouraging statistical analyses making its appearance was the analyst preliminary index of business activity for April, which, at 92.8, showed a sharp upturn from the 89.5 figure for March. The principal March to April gains were in freight car loadings, electric power production, and cotton consumption.

Call money on the stock exchange held at 3 percent, but time money showed an easier tone, with an abundance of 30-day funds available at 3 to 3 1-4 percent.

Imports of gold, however, reached the large total of \$65,539,000, and this has undoubtedly been an important factor in the current low credit rates.

Warren Pipe and Fairbanks Morse two specialties which are rumored to have attracted new market sponsorship, rose moderately to new high ground for the year.

Reynolds metals, another specialty which has shown renewed activity of late, sagged a little in the early trading, but was quickly supported when news tickers carried a report that it would soon announce the acquisition of another large maker of metalliferous foil. This stock has been held by reports of increasing tobacco sales.

Bristol added this would give "us some six inch cruisers, a type we don't need and we will have scrapped some of our battleships."

Up to this time, Bristol said, he had been speaking for the general board. He added: "Speaking for myself, I want to say that I am in full accord with the board."

"Does this treaty give the United States parity?" asked Senator Johnson, Republican, California. "No."

"Is it necessary that the 5-3 ratio with Japan be retained?" "That is my belief."

"Does the London treaty retain that ratio with Japan?" "It does not."

When Jones had finished, the Naval committee adjourned until Monday.
