## REUNION OF VETS DRAWS NEAR CLOSE

### Biloxi Gathering Will Come to End With Brilliant Parade Today

Biloxi, Miss., June 6.—(AP)—The remnants of the once powerful armies of the Confederacy were mobilized today for a grand parade along the Mississippi Sound Beach, concluding the 40th annual reunion of the veterans.

The business of the reunion was terminated with the election of General W. L. Stephens as Commander-in-Chief for the coming year and the unanimous decision of the officers of the southern and northern to meet the veterans of the north in a joint reunion.

The vote against a joint reunion was recorded after denunciation of the proposal of the Grand Army of the Republic that the Confederate flag should not be carried in a joint parade of the northern and southern warriors.

The United Confederate Veterans will meet next year in Montgomery, Ala. In selecting the Alabama city for the 1931 reunion, there was no discussion of a meeting place for 1932. Neither was there any discussion of bringing the annual reunions to an end.

General Stephens succeeds General R. A. Sneed of Oklahoma, as commander-in-chief. Departmental commanders, who according to a decision reached yesterday, will in future be called vice-commanders. They were named as follows: General Homer Atkinson, Petersburg, Va.; department of the army of northern Virginia, comprising South Carolina, North Carolina, Virginia, West Virginia and Maryland; General R. D. Chapman, Houston, Tex., re-elected, trans-Mississippi department, comprising Texas, Oklahoma, Missouri, Arkansas and Pacific states; Brigadier General C. A. Desaussure, Memphis, Tenn., department of the army of Tennessee, comprising Louisiana, Florida, Tennessee, Alabama, Mississippi, Georgia, and Kentucky.

### Says Educational Qualification May Be Used At Polls

Raleigh, June 6.—(AP)—Attorney General Dennis G. Brummitt, in response to an inquiry from Wake county election officials, today ruled that the educational qualification test may be applied to registrants on primary election day.

One may be challenged on primary election day on the ground that he does not possess the necessary educational qualifications, and it then becomes the duty of the registrar and judges of election to determine that question," he said.

## MAN CLUBBED TO DEATH ON N. C. HIGHWAY

### B. K. Bryant Robbed of Money and Slain By Assailants Near Marshall

Marshall, June 6.—(AP)—Clubbed to death and then robbed of money and his automobile, the body of B. K. Bryant, 30-year-old electrician of Greenville, Tenn., was found on the road between Asheville and Marshall Friday morning about 2 o'clock.

Authorities believe that a negro who bought gas at a filling station near here at an early hour Friday morning killed Bryant. The description given by the filling station operator of the car driven by the negro tallied exactly, even as to the license number with that of Bryant's machine, it was said.

Bryant's skull was fractured and a bloody club was found near the body. There was also blood in the road in which footprints were found and bloody underclothing was found near the body. It was believed that Bryant's blood had become spattered on the person who killed him, and that the killer threw away the bloody clothing.

Authorities believe that Bryant was flogged, presumably for a ride, and struck in the head as he talked to the man or men who flagged him. ## DEFIANT WITNESS IN LOBBY QUIZ

### Bailey-Simmons Battle Occupies Considerable Part of Lime-light; Little Challenging of Voters Expected At Local Polls Tomorrow

Interest was at fever stage today as candidates for congressional, state and county officers made their final appeal to voters preparatory to the Democratic primary tomorrow. It has been a long time since Pitt county has seen such a determined fight for the various offices, and it was expected that a record vote would be polled tomorrow.

The campaign so far, however, has been devoid of bitterness, and only a spirit of friendly rivalry exists in virtually all sections of the county. The report was circulated today that there would be considerable challenging of voters here tomorrow, but this was denied today by George Clark, chairman of the Elections Board, who declared that little trouble was expected in this connection.

As is evident in other parts of the state, principal interest today centered about the Bailey-Simmons fight for the United States Senate. Supporters of both candidates claimed to be in the lead today, but this was merely guess work and nobody will be able to say definitely who is the winner until final tabulations have been received from over the state tomorrow night.

Considerable attention is also being given to the race for judge and solicitor of this district. With both Nunn and Frizzelle for judge, and Clark and Moore, claiming enough votes to win, it was evident that this race would be fought with much interest, throughout the district.

As to the candidates right here in the county, voters are giving most of their attention to those for the State Legislature. There are seven in the field for the House of Representatives and three for the Senate. This promises to provide one of the most stubbornly contested battles in years, and it will be impossible to determine the winners until the final vote has been counted.

There is a dearth of candidates for seats on the Board of County Commissioners and the battle in this field unquestionably will be one of the most stubbornly contested in years. Many of the candidates were late getting in the race, but they have been unusually active in the last several days, and promise to furnish a spectacular fight along with the rest of the crowd.

There is no contest for county offices with exception of that of sheriff where Sam Whitehurst, incumbent, is opposed by Wyatt Tucker. Both candidates have combed the woods for votes over a period of several weeks, and a large vote is expected to be cast in this field.

The county will vote on the Australian ballot system for the first time in history. Booths will be placed in each of the county precincts, and voters will have the privilege of voting in complete privacy. Ballots will be placed inside the booths and nobody will be permitted to take tickets on the outside.

By reason of the new ballot system the polls will not be surrounded by representatives of the various candidates attempting to mark tickets and offer suggestions as to the best man to vote for. This feature will be completely eliminated and the voter will be able to cast his ballot without molestation from such a source.

## City Gives School Board Fifth Street Library Site; Adopt Parking Ordinance

### Forty-Five Degree Parking Angle On Dickinson Avenue Declared Unsatisfactory, and the Old Plan of Parking On Both Sides of Street Adopted

Members of the Board of Trustees of City Schools who several months ago so generously donated the old Evans Street School property to the Library Commission as a site for the Shepard Memorial Library, are today in receipt of a gift themselves. The gift consists of the lot on Fifth street which the city has held the last several years for a library site and which was abandoned for this purpose when the school board agreed to give the Evans street school property for location of the new library.

He proposed that the Fifth street library site be sold and the proceeds from the sale be donated to the city school system as appreciation of the liberality in the gift to the library and the improvements effected in the system in the last few years.

## Both Bailey And Simmons Forces Claiming Enough Votes To Win In Primary

### Candidates for Congressional and State Offices Renew Activity As the Zero Hour Draws Near; Labor Federation Against Simmons

Raleigh, June 6.—(AP)—The Republican and Democrat parties of North Carolina select their candidates for congressional and state offices in primary elections tomorrow and the fight between Josiah W. Bailey and Senator F. M. Simmons for the Democratic nomination to the United States Senate will be decided.

Election interest is centered on the contest between the two veteran party leaders, with T. L. Estep of Allegheny County, who seeks the nomination on a "wet" ticket, relegated to the back of the stage.

Republican voters face the task of choosing between four candidates for the nomination to the Senate. They are Congressman George M. Pritchard, of Asheville; Irvin B. Tucker, of Whiteville, a former U. S. District attorney; Rev. H. Grady Dorsett, of Wake Forest; and George E. Butler, of Clinton, veteran of many campaigns.

As the zero hour approached candidates and their supporters renewed activity. Bailey managers have issued a statement claiming that their candidate will be nominated by "not less than 60,000 votes." Backers of Senator Simmons continued to express optimism.

In the first speech of the Democratic senatorial campaign, Mr. Bailey here last night discussed without mentioning his opponents' name, the issue around which the fight within the ranks is based—Senator Simmons' refusal to support the presidential candidacy of Alfred E. Smith in 1928.

Baring his plea of party regularity, the Raleigh attorney said that in order that the Democratic party "may live and be strong and useful, it is the duty of every Democratic voter to sustain the party by voting for its nominee. Any other course than this means party destruction."

From Washington Senator Simmons referred voters to his 29 years in the Senate and his record of party service. The Craven County man, now 74, has been unopposed for the Senate nomination since 1912.

A "last-minute" development was the statement of the executive committee of the North Carolina Federation of Labor, given out by its president, T. A. Wilson, at Asheville last night. It attacked Senator Simmons' record on labor problems and charged that he was "unsympathetic" to it.

James S. Duncan, of Greensboro, state chairman of the Republican party, at the same time issued a call for "every Republican in the state to vote in the primary." He contended that "bitterness and strife" exist in the Democratic party.

In but four of the ten districts is there opposition for a nomination to Congress, all between Democrats. Opposing candidates are: Third District, Congressman Charles L. Abernethy, of New Bern, and Samuel H. Hobbs, of Clinton; Fifth District, Frank Hancock, Hamilton C. Jones, of Charlotte, former Congressman A. L. Bulwinkle, of Gastonia, and Dr. W. Albert Sams, of Marshall; Tenth District, Wallace B. Stone and Zebulon Weaver, both of Asheville.

George P. Pell, incumbent, is opposed for the Democratic nomination for Corporation Commissioner by James H. Holloway, of Raleigh.

Candidates for Solicitor are many. Judges of the Superior Court who are being contested for the Democratic nomination, are Judges R. A. Nunn, of New Bern, Fifth District; Henry A. Grady, Clinton, Sixth District; Edward H. Cramer, of Southport, Eighth District; N. A. Sinclair, Fayetteville, Ninth District; and T. C. Hoyle, Greensboro, 12th District.

Every county selects its delegates or delegate to the general assembly, as well as many of its county officers. Proposals for tax reduction have featured Senate and House campaigns in almost every county.

## AGREE UPON TWO RATES OF TARIFF BILL

### Conferees, However, Strike Snag In Effort to Rewrite the Watch Paragraph

Washington, June 6.—(AP)—Acting with dispatch, the conferees on the tariff bill reached an informal agreement today on the challenged duties on rayon filaments, specialty cheese, and frozen cherries.

The conferees, however, struck a snag in endeavoring to rewrite portions of the complex watch paragraphs and it was doubtful if the measure could be reported back to the Senate today.

Representative Rid, Republican, Illinois, regarded as an expert on watch tariffs, and Senator Bailey, Democrat, Kentucky, whose points of order against these and other rates sent the bill back to conference yesterday, were called in by the conferees to aid them.

Senator Steck, Democrat, Iowa, whose attitude had been regarded as uncertain announced he would vote against the bill. Terming himself a "protection Democrat," he assailed the measure as "a fraud if not a crime."

Close voting is in prospect when the conference reports are put to roll call tests next week and the leaders of both sides are keeping a close check on how individual ballots are to be cast.

Chairman Smoot of the Senate finance committee, called the conferees together today in the hope of rewriting disputed clauses in time to re introduce the conference report before adjournment this evening.

The bill went back to conference after vice-president Curtis had sustained Democratic points of order contending the conferees had exceeded their authority in writing provisions affecting the rates on cheese, watch jewels and rayon and a clause relating to the temporary free entry of cattle from Canada and Mexico for pasturage purposes.

The House late in the day concurred and reapointed its conferees. A move by Representative Garner, of Texas, the Democratic leader, to have the conferees instructed to accept the Senate's free listing of leathers and shoes was defeated on a roll call vote.

**Local Bank Host To Bankers and Lawyers of Pitt**  
Last night at the Woman's Club the Greenville Banking & Trust Company entertained bankers and members of the legal profession of Pitt county. Following a delightful supper, W. H. Woolard, in a brief talk, called attention to the trust department recently put in operation by the bank. He stated that under the old system of individual executors or administrators of estates that there has been so much loss and so much irregularity in handling of estates that the day had come when individuals were looking to strong business institutions to have charge of administering their estates.

LET EVERYBODY VOTE

On Saturday of this week, for the first time in the history of North Carolina, the voters of both the Democratic and Republican parties will name their candidates for office in a State-wide primary.

The primary tomorrow not only is a new departure in that respect, but for the first time the voters will cast their ballots under the Australian law enacted by the last General Assembly. This guarantees to every voter the right in a booth to mark the ballot without observation or persuasion. It is the first real secret ballot for the whole State in North Carolina. It ends the presence of workers pulling and hauling when voters go to cast their ballots. It insures privacy and secrecy. No one has a right to know how a voter marks the ballot unless the voter chooses to disclose it. That right has hitherto been denied. Tomorrow, under the new law, this privilege and right will obtain.

Good government can be secured and perpetuated only when the citizenship—men and women—are enough interested in it to take part in nominating good officials in the primaries in June and in electing them in the November election.

All intelligent, free citizens owe it to themselves to conscientiously inform themselves as to the issues involved in the places to be filled, and to cast their ballots in accordance with convictions honestly formed.

To the thoughtful citizens, no business engagements or pleasure trips will be permitted to interfere with the duty of exercising the high duty of citizenship. If good men and good women abdicate, they invite bad government. It is always true that those who have a selfish interest to subserve will be sure to vote and vote early. Unless the citizens, who have no axe to grind, are alert and vigilant they are responsible when government fails to function justly. Put this down as true. These who are organized against the public weal always vote early. Let all who place the common weal above all else see to it that they are ready and willing to make some sacrifice, if need be to select the best and most honest officials.

The News and Observer urges all voters—Democrats and Republicans—to enter the primary of their respective parties and nominate the best fitted men whose names appear on the ballot.

In most State elections in North Carolina, a Democratic nomination results in election in November, but this is not always the case. Republicans, who hope to win, should seek to put up their best men. This year both parties select their candidates in a primary on Saturday, June 7th. Voters in both parties should present the best candidates for the suffrage of the people.

Vote early Saturday. Let nothing influence your action but the highest good to the commonwealth and its people.—News and Observer.

ABOUT TOWN

Establishment of the emergency telephone service on the highways of Pitt county will be received with general interest by the citizens of the various communities. This offers a great boon to motorists, assuring them of being able to reach any section of the country in case of an accident. It puts the person at home in closer touch with the man or woman on the highway and offers great possibility for development.

Some such service has been needed for a long time, and now that it is to be established in Pitt county the public should do everything possible to support it. Each member of the emergency club will be given a key that will fit any box on the state highways, and it matters not which direction he may go, he will be able to obtain aid within a few minutes in case he should ever need it.

When a person starts out on the highways these days he doesn't know what time he is going to need help. He may have car trouble or an accident away off in some rural district and a long distance from human habitation, but if he should there is the telephone at intervals of a mile to aid him. This is a wonderful service in these days when highways are frequented so freely, and every automobile owner should do his best to maintain membership in the club.

Eye, ear, nose and throat specialists of Greenville are rendering invaluable aid in the tonsil clinics conducted under auspices of the Pitt County Department of Health. The clinics are held for the purpose of getting school children in condition for entering school next fall and also for attention of those already in school.

The doctors are doing this work at small cost so that people not financially able to pay the regular fee may get their children in proper condition for school life. It is to be hoped the public will take advantage of the clinics. It is imperative that the children be in the best physical condition for school life.

The public Health work in Pitt county is doing much toward improving conditions among the colored element is demonstrated by the fact that out of 6,000 Negroes examined for general trouble only 200 showed positive signs of infection.

This fact was brought out in the recent examinations in connection with the clinic in this county under direction of two doctors from the United States Health department. The campaign is to continue for a period of several weeks and unquestionably will result in a great improvement in this field of health work.

This was the principal matter considered last night, although there were several other minor things given attention.

Mayor Lanier told the board that the forty-five degree parking angle adopted for Dickinson avenue on May 15th, had proved unsatisfactory, and recommended that the ordinance be rescinded. Other members of the board said they had also heard much complaint about the matter and agreed that the old way of parking on both sides of the street alongside the curb was decidedly more satisfactory.

The chief of police was instructed to repaint original markings on both sides of Dickinson avenue so that the old parking plan might be continued as soon as possible.

The matter of purchasing a new typewriter for the city clerk's office was left to the discretion of Clerk Gaskins with power to act.

A committee from the Sycamore Hill Baptist church, colored institution on Greene street near the river bridge, appeared before the board with a petition for paving and gutter on that section of Greene street. Owing to the fact that the city had gone to the limit of the budget for the present year, the delegation was told that the matter would have to be deferred until after the beginning of a new fiscal year.

Aldermen Boyd, of the street committee, assured Fred Barnhill, spokesman for the delegation, that the board realized the need of paving in that section and would endeavor to give them relief at the earliest date possible.

The mayor was authorized to sign an agreement with the Atlantic Coast Line Railroad regarding the placing of a new sewer on the right of way of the railroad on 12th street.

A report of election officials of the aldermanic contest held May 5th was read and accepted.

The board ordered that J. L. Hassell be given a deed for a lot in Cherry Hill cemetery, and that the clerk continue to investigate a \$35.00 check which Mr. Hassell had given as payment for the lot and which had become confused in the records.

Alderman Boyd told the board that the street sweeper was in need of new tires and the matter was referred to the street committee with power to act.

Members of the street committee were instructed to look after the sweeping of the river bridge as often as advisable to keep it in good condition.

Mayor Lanier explained that the Board of Health had proposed that the city and county go fifty-fifty on an all-time sanitary officer for the county. He said that although the matter had been included in the next budget for the Board of Health, this had not been passed upon by the commissioners.

The lobby chairman had an engagement to speak tonight at Dexter, Mo., and it was not known here whether the address had been cancelled. His telegram did not mention returning.

For two days Cannon refused to answer questions concerning the candidacy of Gov. Alfred E. Smith and yesterday climaxed his defiance by walking from the committee room while being examined.

Speaking over his shoulder as he clutched his crutch, he informed the committee that if they wished to subpoena him he would be at his office.

Walsh described the action as "plain contempt of the Senate" but would not indicate what procedure he thought should be taken.

Consideration was being given to a plan to ask the Senate to specify that the committee could inquire into political activities. Walsh contends the committee already has this authority.

tion already noted—that of Governor Smith. I am sure, Fellow Democrats, that you are not deceived as to the purpose of the fight being made upon me and as to the character and identity of the forces that are bent upon my political destruction. You have the facts.

If I have truly and creditably represented you and the State of North Carolina in the Senate, if I have rendered good service to the people, the churches, the schools, the laboring men, the farmers, and the industries of my State, and if I have measured up to the requirements of the office of Senator, you do, I feel confident, know the facts with reference to these matters and will give them due consideration. If I have reached a position in the Senate that is Creditable and useful to you and our beloved State and Country, it is by your kindness, and the work I have ever found my greatest pleasure in doing.

I am most content to rest my candidacy in your hands, without leaving my post of duty here to make speeches for myself.

Washington, June 6.—(AP)—Opponents of the London naval treaty today claimed voting gains, but its sponsors were still confident the pact would be ratified.

Senators Johnson of California, and Robinson of Indiana, Republicans, who are expected to lead the fight against the arms limitation agreement, made claims of increased strength. Robinson predicted the treaty would be rejected.

Meanwhile, procedural difficulties had been smoothed over with the definite adoption of the original plan for debating the pact at a special session, to be called by the President as soon as the present regular session is adjourned.

This program was finally agreed upon after three days of conferences between the chief executive and leaders of the various factions in the Senate. The "Young Republican" group had been considering an effort to bring the treaty to a vote before adjournment.

Chairman Borah of the foreign relations committee, which has the pact under consideration, was among those who conferred with Mr. Hoover and he issued a statement last night saying he had told the President "that so long as the Senate remained in session" he would feel it his "duty to urge the treaty be disposed of with all convenient dispatch."

He went on to say he would begin calling daily sessions of the committee, to continue until a vote is reached, as soon as the testimony taken at the recent hearings is available in printed form and requested documents have been received from the State Department.

Secretary Stimson, who was present at the Hoover-Borah conference, told the Senator these papers would be ready for delivery today. They were demanded by Senator Johnson, a member of the committee, and consist of exchanges between Washington and London which led up to the recent naval conference.

## STOCK MARKET

New York, June 6.—(AP)—The stock market was subjected to another minor bear offensive today, but the speculative community has given itself up so completely to a premature case of mid-summer spathy that bears were unable to make much headway.

Wall Street was distinctly surprised by the increase of \$79,000,000 in brokers loans, announced last night. In view of the extreme sluggishness of the stock market during the period covered by the loan figures, the gain as generally interpreted as indicating that new bond issues were not selling well. This was seized upon as bearish material by professional traders, and prominent shares generally were depressed a point or two. More than a dozen issues, mostly inconspicuous, reached new lows for the year.

Such developments as a drop of more than 11 per cent in Woolworth's May sales, although largely due to abnormal sales efforts a year ago; a drop of about 9 per cent in the May sales of Simmons and subsidiaries; passing of the Coty dividend, and of a news ticker analysis predicting a sharp drop in automobile output during the next 60 to 90 days, were not of the character to impart any buoyancy to the market.

There were some indications, however, that the commodity situation cleared up. Some Chicago board members are becoming more optimistic as to the outlook for the wheat market.
