# SENATE PASSES HAWLEY-SMOOT TARIFF

## START SUIT AS RESULT OF SEA TRAGEDY

### Owners of Oil Tanker Asks \$350,000 Damages Against Fairfax Officials

New York, June 13.—(AP)—Suits for \$350,000 have been filed in Federal court here by Lake Tankers Corporation, owners of the oil tanker Pithis, against the Merchants and Miners Transportation Company, owners of the steamship Fairfax which rammed and sank the Pithis off Boston June 10 with a loss of 47 lives.

The sum of \$350,000 is the value put by Mallory and Company upon the Pithis and its cargo.

The suit was filed last night just before the closing of the clerk's office in the Southern New York District of the United States Court and the Merchants and Miners line immediately filed a petition for limitation of liability.

The Fairfax was valued at \$1,350,000 when she was built in 1926. Depreciation and the cost of repairs from the collision, an item estimated at \$150,000, would give the Fairfax a present value of perhaps \$1,150,000 or slightly less, it was estimated by counsel for the plaintiff.

This amount, if the petition for limitation of liability is granted, would be the utmost which could be recovered by litigants against the Merchants and Miners line in damages for the loss of the Pithis and its cargo and for the loss of life in the collision.

Boston, June 13.—(AP)—Members of the crew of the oil tanker Pithis, which was rammed and sunk by the steamship Fairfax off Boston Tuesday night, testified today at the opening of the second day of the Federal inquiry into the disaster which claimed 47 lives.

Kipp was proceeding under orders from Boston Navy Yard to Norfolk as a passenger on the Merchants & Miners liner Fairfax when the ship drove her bow into the oil tanker a few miles off Seaside.

Immediately after the crash, Kipp said he saw several men and women passengers and members of the crew jump into the sea and he saw one life boat filled with Negroes, apparently of the crew. They were sitting quietly, however, and not making any effort to lower the boat.

He was joined on deck by Sergeant Hutchcroft, also a Marine, and the two joined in helping to fight the fire which broke out from the flaming oil shot out by the tanker after it exploded from the collision. He said he was not one of the Marines who helped to repair the radio antennae.

Kipp praised the work of the nurses and women who helped to care for the injured.

## Film Companies Sue N. C. Shows

Raleigh, June 13.—(AP)—Two big film companies, the Universal Pictures Corporation and the Productions, Inc., today entered suits in equity against theatre operators in New Bern, Durham and Kinston in Raleigh Federal court.

The plaintiffs, with home offices in New York, charged George W. Logan of Durham, E. F. Lewis of New Bern and James Lowery of Kinston with exhibiting films belonging to the film companies "without the agreement, license, permission or consent of the plaintiffs."

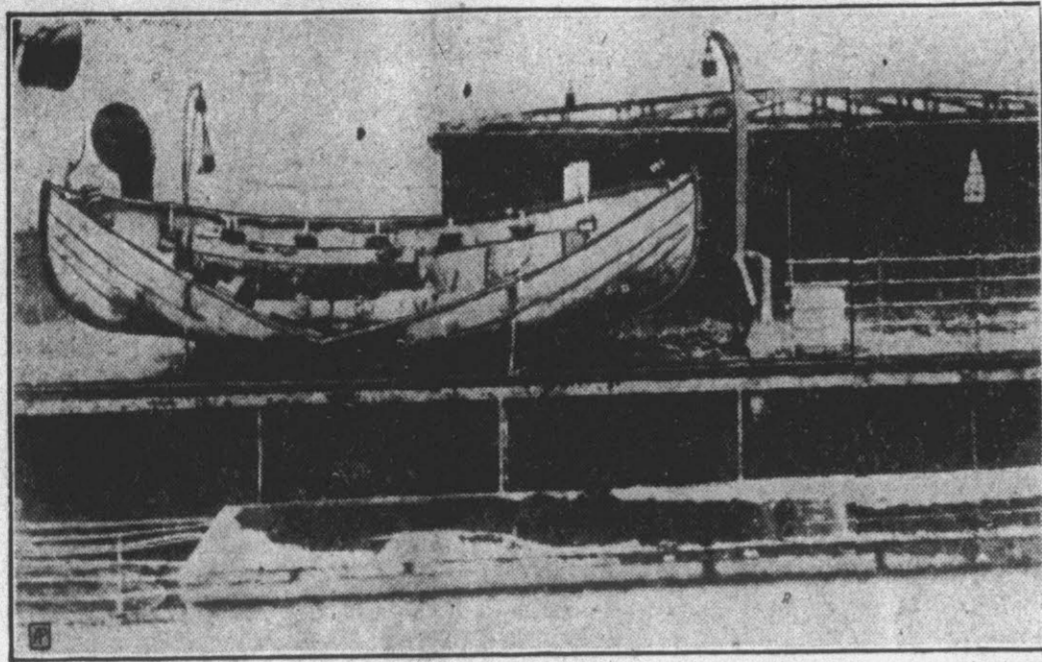
The plaintiff companies asked \$350 for each infringement of the copyright of their pictures by the exhibitors.

## Set High Record For Deportation Of Alien Faction

Washington, June 13.—(AP)—When the government's fiscal year terminates on June 30, the immigration service will have set a new high record for the deportation of aliens.

Commissioner Hull estimated today the total number deported would reach 17,000, an average about 60 for every business day during the year. The government will have spent about \$1,000,000 on the task.

## DEFER ACTION ON NAVAL PACT UNTIL MONDAY

### Secy. Stimson Tells Committee It Should Base Action On the Treaty

Washington, June 13.—(AP)—Replying to the Senate Foreign Relations committee assertion of its right to the London naval papers, Secretary Stimson wrote today to the committee it should base its treaty action on the language of the treaty itself.

The secretary of state acknowledged the committee's resolution in a brief letter to Chairman Borah. He made no mention of forwarding the exchange of notes among the powers leading up to the London parity. The committee resolution did not demand the papers.

Accepting the incident as closed, Senator Borah called another meeting of the committee for Monday when he hopes to get action on the treaty.

There were indications that some committee members would seek to defer action because of the refusal of President Hoover and Secretary Stimson to turn over the notes but it was apparent that a majority would vote for immediate action on the treaty.

## FORMER FAIRFAX COOK HAPPY IN GOLDSBORO

Goldsboro, June 13.—(AP)—Eurylochus Bryant, Goldsboro negro, hasn't a job, but he's mighty glad he quit his last one.

Eurylochus was second cook on the liner Fairfax and just before it took its ill-fated voyage, the negro quit and came home.

## RULES NEGRO HAS RIGHT TO VOTE IN U. S.

### Circuit Court Says Virginia Can't Bar Negroes From Its Primary

Asheville, June 13.—(AP)—The United States Circuit Court of Appeals, in an opinion handed down during its summer session here today ruled that the Virginia Democratic party did not possess the constitutional right to bar negroes and "other races" from its primary.

Attacking the legality of the party rule in limiting the primary to white persons, the court's opinion remarked that "if all the political parties in the state of Virginia incorporated the same qualifications in their rules and regulations as did the Democratic primary, nobody could participate in the primary except white persons, and other persons would be deprived of a material right guaranteed to them under the Constitution as amended; that is, the right to participate in the selection of candidates to be voted for the election."

The ruling on the right of negroes to participate in Democratic primaries in Virginia was contained in the court's opinion affirming a decision of the District court at Richmond, in the case of James O. West, negro, vs. A. C. Billey, William Boltz and William Richer. West refused the right to participate in the Democratic primary for selection of city officials of Richmond on April 3, 1928, on the grounds that the plan of the Democratic party primary, adopted June 11, 1924, limited the right to white persons. The three men were Democratic judges of the precinct in which the negro resided.

While his plea for a mandamus was rejected, West entered suit and was awarded \$5 damages at the trial October 23, 1928. The three election officials appear to the Circuit court.

## Durham Man Fatally Hurt In Auto Wreck

Statesville, June 13.—(AP)—S. T. Hodges, president of the Home Mortgage Company, of Durham, was injured fatally today in an automobile accident near here.

Brought to Davis hospital with a fractured skull, he died shortly before nine o'clock this morning.

Hodges was found beneath his overturned automobile six miles from here on the highway to Hickory in an unconscious condition. He never recovered consciousness.

Apparently there were no eye-witnesses to the accident, but investigating officers expressed the belief that both right wheels of the automobile had gone off the paved section of the highway while the automobile was traveling at a high speed and caused it to overturn.

Both front and rear right wheels were smashed and the automobile was badly wrecked.

## Walsh Abandons Attempt To Seek Senate Power To Make Bishop Cannon Talk

### Says He Thinks Some Such Action Should Be Requested, But Leaves It To Somebody Else to Do It; Might Cause Stir By Reason of His Being A Catholic

Washington, June 13.—(AP)—To avoid any charge of attempting to prosecute Bishop James Cannon, Jr., Senator Walsh of Montana today abandoned his proposal to seek specific Senate authority for the Lobby committee to investigate the political activities.

"I think such a resolution should be introduced," Walsh said, "but I shall not introduce it. The bishop has repeatedly charged that his investigation was a Catholic and wet persecution. Since I am an humble member of the Catholic church, I would immediately be charged with attempting to persecute him. Therefore I shall take no further action."

## MEASURE ADOPTED BY A VOTE OF 44 TO 42 DURING AFTERNOON

### Segrave Fatally Injured When Speed Boat Wrecks In Test At Windermere

### Internationally Known Speed King Died This Afternoon As Result of Injuries Sustained In Run With Newest Boat, Miss England 11

Windermere, England, June 13.—(AP)—Major Sir Henry C. Seagrave, internationally known speed king, died shortly after five o'clock this evening from injuries he suffered when his speed boat overturned on Lake Windermere.

The famous racer, who holds the world automobile record of 231 miles an hour was fatally hurt while testing out his newest speed boat, Miss England II, with which he hoped to capture the international trophy at Detroit, this summer.

While pounding along on the lake at a speed of about 100 miles an hour, the boat suddenly was seen to turn over and plunge into the water. Seagrave was dragged from the wreck by the owners of speed launches which shot to his assistance. He was taken to a nearby hotel and was found to have suffered a broken arm, also broken ribs and a fractured thigh.

There were two companions in the boat with him. Mechanic E. Halliwell was believed to have been caught under the boat which sank within an hour, efforts to find his body were made immediately. The third member of the crew, M. J. Wilcocks was badly injured and was taken to a hospital.

Sir Henry, who actually had achieved his record breaking objective with nearly 100 miles an hour before the disaster came, was taken from the water suffering from shock and the violent impact he suffered when he was thrown from the speeding craft. He was found to have sustained multiple injuries from which he failed to rally.

He died between 5:00 p. m. and 5:30 p. m., several hours after the disaster. He was 35 years old and was internationally famous for his exploits as a speed racer. He was most famous for his record of 231.36 miles an hour which he made at Daytona Beach, Fla., March 11, 1929, in his 12-cylinder automobile the Golden Arrow.

It was stated that the accident was due to a step on the outside of the bows of the boat giving away under pressure against the water. The bottom of the boat was crushed in.

Major Seagrave upon his return to England after establishing the automobile speed record was given a tumultuous reception and was knighted by King George.

After establishing the automobile record, Seagrave turned his attention to motor boat racing and for the past year has been trying out speed boats. In May, 1929, he said that he was through with automobile races and that the preferred motor boats.

## SECY. STIMSON SCORES CRITICS OF NAVAL PACT

### Assails Opponents In Britain and Japan for Their Narrow Viewpoint

Washington, June 13.—(AP)—A renewed appeal from the administration for early action on the London naval treaty faced the Senate Foreign Relations committee today as it continued its series of daily sessions intended to end in a vote on the pact.

Assailing the opponents of the treaty here, in Great Britain and in Japan for a "narrow viewpoint" Secretary Stimson last night delivered a radio address in which he said the London conference was "one of the greatest victories for peace."

The treaty, he said, "is the culmination of a ten-year movement toward peace between the various naval powers of the world and also a step in the vitalization of the Kellogg-Briand pact."

Of the opposition, he said it comes mainly from some extremists among the professional warriors of each country, while the "civilian population is giving it overwhelming support." The nature of the criticism, he added, is evidence that in formulating the treaty concessions were evenly distributed.

He criticized naval officers who testified against the pact before Senate committees, and praised the stand of Admiral William V. Pratt, who supports the pact. Referring to the officers who opposed it, the cabinet officer said:

"I am speaking of a tendency—the tendency of the professional military viewpoint. It is narrow. It only covers a portion of the field which must be considered in matters of national security and defense and its limitations and dangers have long been recognized by the American people."

He opposed the movement to have Senate ratification postponed until later in the year, predicting if this were done "the bitter efforts of a single group of newspapers which is now devoted to defeat of the treaty" would be directed toward making the pact an issue in the coming senatorial campaigns.

### Only Five Democrats Voted In Favor of the Bill; Adoption Assures Congressional Approval; President Hoover Will Probably Receive the Measure Sometime Next Week; Republicans Predict He Will Sign It

Washington, June 13.—(AP)—The Senate today passed the tariff bill by adopting the conference reports.

The vote assured Congressional approval of the measure.

The House votes tomorrow on the conference agreements adjusting differences between the two branches and affirmative action in a few hours is expected.

President Hoover probably will receive the year and a half old Hawley-Smoot bill next week. Republican leaders have predicted he would sign it.

He will study the provisions before acting.

The vote on adoption was 44 to 42.

The bill as it stood at the final roll call was not the measure which passed either the House or Senate, but was a compromise between the two, reached by conferees of the two houses, as the case in virtually all the twenty tariff bills that preceded it.

Supplanting the Republican Fordney-McCumber act of 1922, the measure would raise an estimate revenue of \$630,000,000 or \$107,000,000 more than the existing law based on 1928 importations.

Of 3,218 named commodities and basket clauses comprising the measure, changes are made in 1,122, or about 32 per cent of the total. There are 887 increases in rates and 235 decreases. 75 items transferred from the dutiable to the free list and 48 now on the free list placed in the protective category. Over 250 of the increases are on farm products.

Many of the products given protection for the first time in years are of first importance. They include brick, cement, softwood lumber, long staple cotton, hides, leather.

## Lenoir Woman Was Victim of Ship Collision

Winston-Salem, June 13.—(AP)—A North Carolinian was one of the 47 persons who lost their lives when the liner Fairfax collided with the tanker Pithis Tuesday night. It has been definitely established here. She was Miss Elizabeth Gardner, 26, of rear Kinston.

First reports said that Miss Gardner was of Winston-Salem and all efforts to identify her here failed. It was learned last night, however, that the young woman was on her way to visit a sister, Mrs. Allie Davis, of Deep Run, near Kinston, when the collision occurred.

# TWO MEN DIE IN ELECTRIC CHAIR IN KY.

## Order From Governor Stays Execution of Three Others Awaiting Death

Eddyville, Ky., June 13.—(AP)—Three men who had sat through the long night awaiting death in the electric chair were granted stays of execution here today after they had heard the deadly whirr of an electric motor that sent two others to their death.

J. L. Huggitt, state pardon commission, reading Governor Sampson's indefinite stay of execution for the three negroes, Lloyd Williams, 24, John Keller, 27, and James Grigsby, 28, right after Ballard E. Ratcliffe, 33, a white man, and Richard Edmonds, 36, a negro, had been executed. Official witnesses and newspapermen at Western State Penitentiary were waiting to assemble for Grigsby's execution when the order was read.

Ratcliffe died first, his execution requiring four shocks of 2200 volts each before physicians pronounced him dead. Life was extinct at 12:23 a. m., five minutes and 45 seconds after the first shock. Edmonds was pronounced dead at 12:33, three minutes and 20 seconds after the first shock. The customary two shocks were sufficient to cause death.

The two men met death calmly. Ratcliffe walked in, his footsteps hardly audible above the buzz of an electric fan that stirred the hot air in the crowded room. He bent his head and looked fixedly as each arm was strapped to the chair.

The man who earlier in the night had flung aside his crude mask of insanity and had declared he was ready to die, jerkily, "I'll meet you in glory." The Rev. L. J. Knott, prison chaplain, prayed briefly. Warden L. R. Gumm nodded to C. E. Collier, chief electrician. The whirr of the big motor drowned out the buzz of the little one that spun the fan blades. Ratcliffe's body shot forward and strained against the straps. It slumped and another shock was given and he was examined. Dr. D. J. Travis, prison physician and Dr. E. L. Busby, of Hopkinsville, found him still alive. Two more shocks were required to end his life, despite his slight physique.

Edmonds' execution followed in short order. He looked straight ahead, hardly moving his heavy set body and powerful limbs as he was strapped in.

"I'll meet you in heaven," he said before the chaplain's prayer. After two shocks, Dr. Travis and Dr. Carl Dunn, of Lakeland, pronounced him dead.

Keller and Grigsby were convicted with Edmonds for the slaying of Harry S. Jones, Louisville laundry night watchman, and Williams was under death sentence for the killing of a filling station manager. Edmonds had confessed, exonerating Keller and Grigsby.

Ratcliffe had been convicted of the murder of William A. Nuse, an aged carpenter, slain with a hammer as he placed flowers on his wife's grave in Louisville one Sunday morning in May, 1928. Nuse, who customarily carried a large sum of money, was robbed of \$1,020 at the time.

# TO SELECT NEW HEAD OF DRY OFFICE SOON

## Speculation Rife As to Who Will Have Charge of Prohibition Job

Washington, June 12.—(AP)—The man who is to have charge of prohibition under the Justice Department is due to be selected soon that speculation as to his identity intensifies.

Transfer of responsibility from the Treasury Department takes effect July 1. Attorney General Mitchell and his aides have not disclosed who was being considered as enforcement director; but those mentioned prominently include Robert L. Watts, assistant district attorney in New York; Howard Jones, an assistant to G. A. Youngquist, assistant attorney general; Samuel O. Wynn, prohibition administrator at Philadelphia; and J. Edgar Hoover, chief of the bureau of investigation of the Justice Department.

Watts has handled the prosecution of prohibition cases in New York City. He is regarded in enforcement circles as informed and able.

Jones served as assistant to Mabel Walker Willebrandt, while he was assistant attorney general in charge of Volstead prosecutions. Even if another were selected as director, the consensus is that Jones would be appointed assistant.

Wynn is connected with prohibition enforcement under the Treasury. It has been said Mr. Mitchell

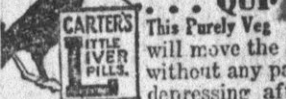
prison camp this afternoon. He had said were two attempts on his life.

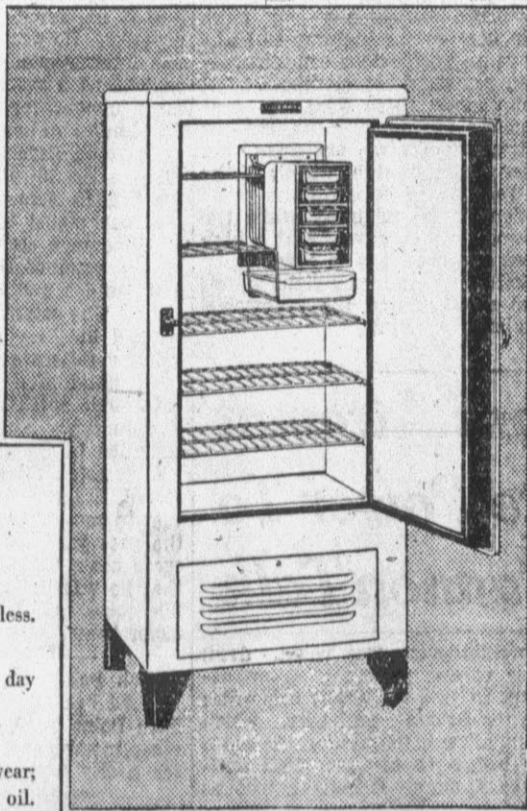

ACCIDENTS DECREASE EXCEPT WITH AUTOMOBILES. Last year the accidental death toll reached a new high record of 97,000, as compared with 95,086 in 1929, according to the National Safety Council. This increase was due entirely to the automobile, which claimed 31,000 lives, 3,000 more than in 1928. All other causes of death show a gradual decline.

Accidents to school children are increasing far less rapidly than accidents to adults, thanks largely to the accident prevention work in schools which is encouraged by the National Bureau of Casualty and Surety Underwriters. Between 1922 and 1929 total fatalities of persons of all ages, increased almost 25 per cent, while in the same period accidental deaths of children under 15 gained less than one-tenth of one per cent.

The states with driver's license laws are making better records in relation to their own past experience, than the states where ex-

aminations are not required. Reports from two cities where fatalities decreased during the year are interesting. In St. Louis, the credit is largely given to effective school work, school patrols and strict enforcement of traffic laws by police; in San Francisco to scientific traffic studies, adequate enforcement, safety work in schools and a continuous campaign of education by the press, radio stations and service clubs.

The National Safety Council points out one encouraging factor in the analysis—eliminating the annual toll of deaths due to the automobile, the national death rate from all other accidents has declined 30 per cent since 1913.

ABOUT TOWN

Farmers are urged to turn their attention to the production of as many crops as possible this year. Many have already adopted this plan and the harvest season will see them realizing on their efforts during the hot summer months. The production of the things consumed at home is necessary if the people live up to the live-at-home movement enunciated by Governor Gardner some months ago. In fact, the more different kinds of crops produced the easier the growers should find it to get along.

Chickens and hogs and cows have added much to the revenue of this section the last few years and it is certain they will prove just as valuable this year as ever.

Faith in the possibilities of your home town is one of the greatest requisites in the progress of the small town today. Any town composed of men with faith in its future is bound to experience development. It can't be stopped.

The people of this nation today are pleasure hungry, and they keep themselves in a financial strain all the time trying to keep pace with some wealthier neighbor who makes more in a month than they make in a year.

There is plenty of pleasure to be had without the outlay of so much money. The person who finds times hard should refrain from the expensive pastimes, and spend only for the things actually needed.

Economy should be the watchword of this section of the state for the next several years to come, for it is through this plan alone we hope to get back to normal.

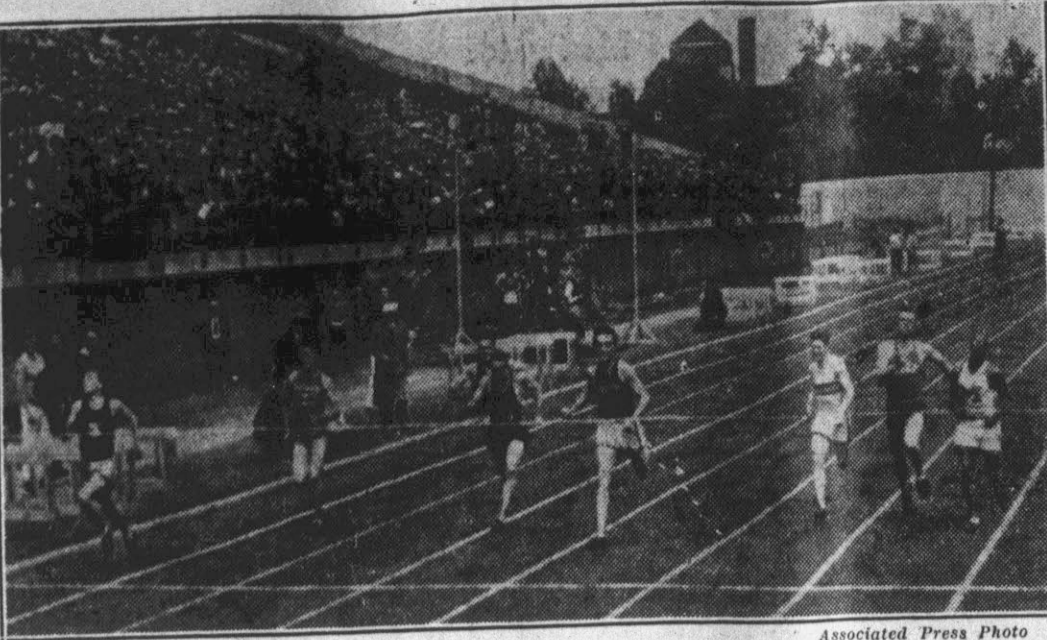

# GERMAN FIGHTER CAPTURES HEAVYWEIGHT CROWN WHEN HE IS FOULED BY SHARKEY

New York, June 13.—(AP)—The fistie world that had hoped to wake up today to celebrate the crowning of a new and undisputed world heavyweight champion discovered, instead, that it had just another headache, hangover, and contraversion.

Max Schmeling won on a foul from Jack Sharkey within the last six seconds of the fourth round of what was to have been the decisive battle for the heavyweight title last night at the Yankee Stadium but they left the situation as chaotic as were the wild scenes accompanying the abrupt finish of the match.

Severely battered though he had been, the black-thatched 24-year-old German youth, who looks, bobs and weaves like the one and only Jack Dempsey, emerged with whatever honors and title claims go with victory. He may, for the time being, be put at the top of the heavyweight class, at least by his own countrymen and by the New York State Athletic Commission, which proclaimed its right before he had to crown the winner as the new champion of the world and successor to Gene Tunney, who retired two years ago.

Schmeling's cause may be espoused further by the national boxing association and he is a candidate at least for the inscription of his name upon the fulcrum-Tunney trophy, emblematic of championship recognition so far as its donors are concerned. But today, could analysis of the unsatisfactory and disappointing climax to a two-year search for a fit monarch of heavyweight ranks appear to offer no round basis for proclaiming the young German possessor of honors universal in scope, where neither of the principals in the main test, before-hand, held any clear or undisputed claim to championship recognition.

Dark-browed, likeable, courageous Max, experts may hold, should not be penalized and deprived of recognition for events beyond his control, but the fact remained that Schmeling was carried bodily and in apparently great pain from the ring last night, the winner, but a badly battered one.

Schmeling was hurt by a punch that was unquestionably low after having been deviously outboxed and outpunched by Sharkey, who with one erratic blow of his fist swept away the high honors that seemed almost certain to be his. The German crumpled to the floor, to be carried to his corner and declared the victor only a few minutes after it seemed he was on the verge of being cleanly knocked out, in the third round, when the American battered his young rival all over the ring with a viciously sustained two-fisted lough.

In the third round, Sharkey had Schmeling groggy and a quick victory apparently in his grasp. A round later, the tables were reversed with such startling rapidity that scenes of the wildest disorder and confusion developed.

The fatal and final blow, intended as a left hook for the stomach but somehow unintentionally misdirected, was delivered as the fighters were close together along the ropes, with the top of the young German's fourth round only a few seconds away, with Sharkey's back between him and Schmeling, failed to see the punch. Withholding his decision, as the German sank with his head to the floor, Crowley hesitated and was almost instantly surrounded and harassed by the manager, seconds and handlers of the two fighters as he sought advice from officials on either side of the ring. With the clamor still at its height and the crowd in complete uproar, Crowley finally accepted the unequal judgment of one of the judges, Harold Barnes, and pronounced Schmeling the victor on a foul.

Barnes was the only one of the three officials to have an unobstructed view of the final blow and he unhesitatingly called it grounds for disqualification of the American.

The finish was a shock to the big crowd estimated at more than 70,000 spectators, who had contributed to an estimated "gate" of \$740,000, the largest in three years.

The senators bowed to Chicago's Wallace, 10-5, in a free hitting battle that saw Ted Lyons chalk up his ninth victory of the season after three previous failures to get past his eighth.

The New York Yankees fell on White Heat and two successors for 12 hits, including Babe Ruth's 23rd home run of the season, and trounced the Detroit Tigers, 14-2.

Walter Stearns won his eighth victory for the St. Louis Browns, beating Boston, 6-5, but just minutes before he had a Red Sox rally in the eighth inning that fell only one run short of a tie.

In the National League, Brooklyn stretched its lead to four and one-half games by beating Cincinnati, 2-2, while their leading rivals, the Chicago Cubs and New York Giants, were beaten.

Jack Flowers' pinch double with the bases loaded in the seventh gave the Robins their win, and hit coring the typing and what proved to be the winning run.

Pittsburgh halted the New York Giants' nine-game winning streak, 10-7, bunching hits for five runs in the first and four in the seventh.

Claude Willoughby scored his first victory of the season as the Phillies beat the Cubs, 5-3, in a game halted by rain in the sixth. Chuck Klein got three singles for the Phils and ran his consecutive hitting streak to 29 games.

## SPORTS SLANTS

The American boys and girls have been doing pretty well in the golf and tennis stride of foreign fields, furnishing two of the big winners in Helen Wills Moody and Bobby Jones, two runners-up in Glenna Collett and Bill Tilden.

The British open golf, the Wright man Cup and Davis Cup tennis contest, still are to be settled before the spring; invasion is closed. American prospects are at least as good as any, in the first two events, with Jones and Mrs. Moody leading the attack. There is at least a fighting chance in the Davis Cup skirmish, if the boys can get past the European Zone winner, which probably will be Australia, and if Bill Tilden rejoins the colors for another joust with the French.

### STOCK MARKET

New York, June 13.—(AP)—After a fortnight of steadily declining prices, interrupted by only one rally worthy of note, bears began to lose their courage in today's stock market, and extensive short covering set in motion a broad upturn, accelerated by heavy buying in anticipation of a substantial technical rebound.

A few supporting orders appeared in pivotal shares as the opening, but bears were able to depress the list substantially during the early trading. The market became extremely dull on the decline, however, and shorts were inclined to accept this as a warning that the selling movement, momentarily at least, was completed. By midday, early losses were generally regained. Trading up to midday was in about half the volume of the same period yesterday.

Market sentiment in brokerage circles remained vague and confused, however, and commission houses hesitated to make buying recommendations, fearing that the rally might prove as short lived as that of Tuesday. There was no inclination to forecast a sustained upward movement until a decided turn appears in business. Unsettled sentiment of commodity prices was still an unremoved fly in the speculative ointment.

The decline of \$103,000,000 shown in the weekly brokerage loan compilation was about in line with expectations, and apparently was not a market factor. Credit rates continued their fresh decline, with call loans renewing at 21-2 percent for the first time since March. The abundance of credit, however, continues primarily a reflection of slack business. The analyst preliminary index of business activity for May was announced at 89, a new low for the cyclical decline which started in August, 1.2 point below the level of March.

During the morning selling, losses of 2 to 8 points were numerous with Allied Chemical making the maximum drop, only to rally somewhat. American Telephone touched a new low for the year at 214, before rebounding.

### YOUTH HURT WHEN HE FALLS THROUGH ELEVATOR SHAFT

Raleigh, June 13.—(AP)—Claude Bishop, Jr., seven-year-old son of Mr. and Mrs. Claude Bishop of Glenwood avenue, was reported in a precarious condition at Rex Hospital here today after he fell about 35 feet down an open elevator shaft at the State Supreme Court building today.

The full extent of the injuries to young Bishop could not be ascertained this afternoon but hospital attaches said an X-ray was planned.

Young Bishop, together with his brothers and sisters, about five or six children, had gone to the court building to view the exhibits they boarded the elevator, operated by Handy Lee, one the first floor to be carried to the second.

Lee opened the door when the elevator reached the second floor and thought all of the children got out he then started the carriage up before closing the door. Young Bishop jumped out of the open door, lost his balance and fell head foremost, backwards down the shaft.

### Raskob Deplores New Tariff Bill

New York, June 13.—(AP)—John J. Raskob, chairman of the Democratic National committee, in a telegram to Senator Joe T. Roan, minority leader, attacks the tariff bill now before Congress as conducive to business depression, unemployment and wage-cutting.

"The pending tariff bill," he said, "inevitably will cripple our foreign trade and will not be helpful to domestic business except in a few isolated instances and is generally adverse to the commercial structure of the United States and to agriculture as well."

"Moreover, the flexible provision embraced in the bill means the continuance of the deplorable process of lobbying and logrolling as the method of accomplishing the settling of rates which ought to be purely an economic and not at all a political process."

He endorsed the Simmons-Norris amendment under which Congress would limit its tariff revisions to recommendations of a non-partisan body of experts.

### Business Women Meet At Raleigh

Raleigh, June 13.—(AP)—Delegates to the three day convention here of the North Carolina Federation of Business and Professional Women's clubs disposed of a business program today and looked forward to being entertained at a tea late this afternoon at the executive mansion by Mrs. O. Max Gardner.

The convention was opened last night when the executive committee, including officers and committee chairman, was honored at a banquet by the Raleigh club.

The first general session was held this morning presided over by Miss Lona Gildewell, of Reidsville, president. Committee reports to be received were those of Miss Ann Lee Hoffman, of Rocky Mount, recording secretary; Miss Lola Y. Irving, of Reidsville, corresponding secretary; Miss Fleeta Green, of Rocky Mount, auditor; Miss Bessie Withers, of Henderson, treasurer; Miss Annie Aderhold, of Statesville, finance; Miss Elsie Flake, of Winston-Salem, first vice-president; and Miss Olive Webb, of Raleigh, chairman of credentials.

### Princess Helen Becomes Queen of Rumanians

Bucharest, Rumania, June 13.—(AP)—Princess Helen of Greece, divorced wife of King Carol II and mother of Prince Michael, today became Queen of Rumania.

The transition was accomplished with publication in the official Gazette of a royal decree authorizing "her royal highness, Princess Helen, to bear the title, 'Her Majesty'."

Carol's act was accomplished in line with his reasoning that parliament's annulment of the acts of banishment and renunciation of January 4, 1926 had made him king de jure from the day of his father's death. Helen, not divorced from him until later, similarly became queen at that date.

It was understood, although not so stated, that Helen would be crowned with Carol, probably as early as October. Some further legal procedure may be necessary to make this possible, but it was believed the arrangement would be effected for Michael's sake if a personal reconciliation has not taken place by then.

Queen Helen was not at the railway station when Queen Marie, Carol's mother, arrived aboard the Orient Express from Mexico and Oberammergau, but King Carol—attired as a general of aviation—and Prince Nicholas were on hand with troops and government officials.

### Says Nation Going To Return to the Hitching Post Idea

Biloxi, Miss., June 13.—(AP)—A return to the hitching post idea of the parking of automobiles in the metropolitan area of the cities and shorter working hours for the silent nightly army of scrub women were advocated here today by speakers before the national association of building owners and managers.

"It is my belief," said Owen N. H. Owens of Montreal, Ont., chairman of the downtown garage committee of the Association "that we are coming back to more and smaller garages in the downtown districts of cities on the North American continent."

"Years ago we used to drive up to a store and tie our horses and buggy to a hitching post. That was real convenience." The flooding of the country with automobiles made that an impossibility and in our haste to do something about it we provided large garages which are not so convenient because of the time it takes to park the car in a garage and then walk three or four blocks to our destination. I believe we are coming back to the hitching post in our office buildings, in our department stores, in our hotels, in the form of small garages conveniently located to suit the patron."

Mr. Owens advised the use of basements and ground floors of office buildings as modern garage lobbies decorated in keeping with the rest of the building for the service of patrons. He estimated that in the future the office building would be a combination building with one square foot of space set aside for parking purposes to every four square feet of rental office space as a probable ratio.

Logs, now dutiable at \$1 per thousand board feet, are among the 75 commodities on which levies were wiped out completely.

The major rate reductions are on automobiles, aluminum, plate glass, and unset diamonds.

Textiles, of all kinds are given higher rates as well as clothing of wool, cotton, silk, rayon, and mixtures of any of the two.

Pottery and chinaware manufacturers, producers of zinc and manganese ores, felt and straw hat makers, and manufacturers of furniture, hardwood flooring, and hundreds of miscellaneous products are given increased protection.

The administrative provisions of existing law have been largely rewritten, although only in secondary
