THIRD PERSON WOUNDED BY N. Y. MANIAC

Slayer Decides to Spare Some On Receipt of Additional Blackmail Money

New York, June 20.—(AP)—The search for the maniac slayer who in letters to a newspaper has admitted the killing of two men in Queens and threatened 14 others, turned to Brooklyn today after a third man had been shot and critically wounded.

Police said the description of the assailant of Morris Horwitz, 50, an insurance broker, who was shot in his automobile early today, tallied with the description they have for the slayer of Joseph Mozyński and Noel Sowlcy in Queens.

Horwitz was shot after a second letter purporting to have been written by the slayer of Mozyński and Sowlcy was delivered at the newspaper office. It was in the same handwriting as the earlier communication.

In the second letter, the writer said he had decided to spare six persons because a certain document had been returned to him and he had received \$37,000 in blackmail money, but that seven others were still marked for death unless another document was forthcoming and \$39,000 additional blackmail.

The persons mentioned were all designed by cabalistic symbols, those to be spared were listed as W. R. V-8, College Point; S-12, College Point; K-2, Brooklyn; Z-3, designated as tall blonde woman; M-6, N. Y. C.; XX, a New York detective.

The list of seven to be killed was given as: X-14, X-21, Y-2, L-6, X-7, and V-4.

"All initials withheld—too much of a clue for the super-detectives of Bayside," the letter said.

The letter which was quite long contained a rambling account of the slaying of Mozyński and Sowlcy. The shooting of Mozyński, Sowlcy and Horwitz were similar in detail. All three were shot as they sat in parked cars with women.

Mozyński, who was a grocer of College Point, N. Y., and was married, was killed a week ago as he sat in his delivery truck with Miss Catherine May.

Sowlcy was with Miss Elizabeth Ring when he was shot near Queens Village last Monday night.

Horwitz told police that he was sitting with his wife in his car in front of his home on Carroll street. They were talking to a daughter who sat on the porch when a man with a pistol in his hand thrust his head through a window of the car.

"Move over, start that car and keep going or I'll kill you," Horwitz said the man ordered.

Horwitz moved over and the man jumped into the car. He struck Horwitz over the head with his gun and then shot him in the shoulder. The bullet took a downward slant and lodged in the abdomen. The man then fled.

In their search for the maniac police compared the description they have of the slayer with that of Joseph Ustica who escaped last month from Kings Park Hospital for the Insane where he was confined for the slaying of William Gilbridge, a Brooklyn contractor in 1928.

Ustica had delusions that he was supposed to recover some mysterious documents and was to protect women. The mention of documents in the letters sent by the slayer of Mozyński and Sowlcy and the fact that the descriptions failed to indicate that Ustica and the man sought were the same person.

Bobby Jones Wins British Open Golf Championship For The Third Time Today

Hoylake, England, June 20.—(AP)—Bobby Jones today won the British Open Golf championship for the third time with a score of 291.

The open champion of the United States increased his golf titles to three as he won the amateur championship of Great Britain last month. He is the first man to hold the British amateur and open golf championships since John Ball accomplished the feat in 1890.

The Georgian won in spite of two shaky rounds today. He took 74 strokes in the third round when he carded a six and 75 in the afternoon when he had a seven on his card. His first two rounds of 70 and 72 pulled him through.

Leo Diegel and Archie Compton threatened until Compton ruined his chances with 43 strokes for the first nine in the afternoon and Diegel remained in the hunt until the sixteenth hole when he took a six.

Diegel was even par for the five handicap holes through the 14th taking a three at the 13th and five at the 14th. When he took a four at the 15th he needed three more fours to tie Jones. But he took a six at the 16th.

Compton played the first four holes coming home in fours and then took a five, wiping out his chance.

The Diegel P. G. A. champion of the United States made a great bid but finished two strokes behind Jones, taking 75 for the third round the same score Bobby returned.

Archie Compton, giant British pro went from the sublime to the ridiculous in his last day's play. He broke the course record in the third round with a 68 and then fell away to 82 in the fourth for a 72 hole score of 297.

Diegel smiled all the way through the last few holes and grinned cheerfully as he walked off the home green with a brawny policeman beside him thrusting the crowd aside.

Cries of "hard luck Diegel!" greeted the American professional along all sides but Leo continued to smile.

"There are too many bunkers on that course for me," he said. "What riled me was being bunkered off that tee shot on the sixteenth, that's the best shot I hit all day. I'd like to have won but I hope to have better luck next time. I come nearer every year anyway."

Diegel finished third in the British open last year.

URGES LARGE ATTENDANCE AT PRIMARIES

Hooks Says It Is Important the Precinct Meetings Be Well Attended Saturday

Pitt county people were urged today to attend the precinct primaries to be held at the various voting places of the county tomorrow afternoon at 2 o'clock. The meetings will be held for the purpose of electing delegates and alternates to the County convention at Greenville Saturday, June 28.

W. E. Hooks, chairman of the Pitt County Democratic Executive committee, joined numbers of other citizens this morning in impressing upon the people the importance of attending the precinct meetings. The county chairman said it was imperative that only the most representative citizens of the fourteen precincts be elected as delegates and urged that this fact be given serious consideration.

In addition to choosing delegates, the county primary will elect an executive committee of five members. One of these five members must be chosen as chairman of the committee.

Mr. Hooks said these precinct gatherings were very important and as they lead up to the county and state conventions where plans for the state political campaign will be finally consummated.

The campaign this fall will be marked by intensive drives in every section of the state, and Pitt county has been assured of some of the most prominent speakers of the party, including no other than J. W. Bailey, Democratic nominee to the United States Senate, former Governor Cameron Morrison and other important party members.

NATION PLANS BETTER TYPE OF WARSHIPS

Designers Busy Creating Combination Cruiser and Aircraft Carrier

Washington, June 20.—(AP)—Plans for a drastically different hybrid fighting ships are occupying the navy's designers. It would be a combination cruiser and aircraft carrier, capable of engaging in a running battle as well as launching more than two dozen airplanes for scouting or combat.

It would be of a radical design in that its large guns and their number would be devoted to the fighting class, yet a landing platform on its deck would equip it to carry from three to six times as many airplanes as the most modern cruisers now afloat.

Instead of launching its planes from a distance and running from an attack, as the existing carriers must, the proposed cruiser-carrier might get into the melee and let its brood bomb and harass the enemy while it joined orthodox cruisers and battleships in battle.

While some "old-line" navy officers have expressed opposition to the cruiser-carrier because its effectiveness might be lessened by a reduction in armor to allow for the weight of airplanes, the Bureau of Aeronautics said that a 10,000 ton or even a 7,000 ton cruiser-carrier is the vessel that all nations soon will be building because of the increased effectiveness of airplanes in battle.

Tentative plans for the vessel provide for as many as 10 six-inch guns as well as storage space of the planes. About 70 per cent of the deck would be devoted to a landing platform, while the necessary super-structure and two triple or quadruple gun turrets or boxes would be grouped in the bow. Other guns would be at the stern, while the anti-aircraft batteries would be on platforms at the sides of the landing platform.

A ship of this type, naval designers say, would not come under the London naval treaty definition of a carrier. The treaty classifies as a carrier any ship "designed for the specific and exclusive purpose of carrying aircraft."

The United States, if the treaty is adopted is interpreted as allowing the construction of six 10,000 ton cruiser-carriers of the contemplated type. If the navy chose to reduce the ships to 7,000 tons it could build nine. It is not likely, however, that more than a few experimental cruiser-carriers would be constructed immediately.

By June of 1932, the five-year naval aeronautics program will have been completed. There will be more than 1,000 useful airplanes available, more than 500 on ships. Completion of the authorized 13,800 ton carrier would increase the total fleet strength to 575 and the construction of cruiser-carriers would bring the total aerial strength afloat to a minimum of 800 airplanes.

Admiral Byrd And Party Given Noisy Welcome To Capital Of The Nation

Polar Explorer Hints At More Work in the South Pole Region As Soon As He Pays Off Debt Incurred in Recent Expedition

Washington, June 20.—(AP)—Those long cold and lonesome nights near the world's southernmost tip seemed far away today as Rear Admiral Richard E. Byrd heard personally from President Hoover the felicitations which the radio took to him last November.

The "universal pleasure at your successful flight over the South pole" was expressed in that message to the frigid regions. With a warm noonday sun on the White House lawn the president added the handclasp of fellowship.

There also stood that hardy tarred band of 74 which followed the leadership of "Dick". The play which believed the monitory among them in the ice-bound huts was recalled by their jollity. Some seemed abashed, however.

Mr. Hoover, who radioed to Little America the people back home were "glad of proof that the spirit of great adventure still lives" was looking forward to preserving Rear Admiral Byrd tonight with a special gold medal of the National Geographic Society. It commemorates the aerial dash to the South Pole.

Laughing like school boys on vacation the party of explorers reached Washington early to be greeted by an echo of the tumultuous reception accorded yesterday by New York.

What their welcome lacked in volume was made up in the spontaneity and sincerity of the cheerers who met the train and cheered from the sidewalks.

One of the proudest around was "Dick" Byrd, Jr., aged ten, who had missed his daddy so much in the past two years. He held tightly to his mother's hand and his eyes dwelt long on his white uniformed Rear Admiral-Father.

Special greetings were given during the day to Paul Siple the Erie, Pa., Boy Scout who accompanied the South Pole expedition. A group of uniformed scouts assured him of their envious admiration.

Late in the day, as a cessation from his constant reception in a day and a half of homage from others, Rear Admiral Byrd himself will give homage—to Floyd Bennett, Admiral Robert E. Peary, and Admiral Charles E. Wilkes in Arlington cemetery.

On Bennett's grave, where the stone was plucked which weighed a silken American flag dropped over the South Pole, Byrd will lay a wreath in tribute to the pilot who flew him over the top of the world.

Wreaths also will be laid on the graves of Peary, discoverer of the North Pole in 1899, and of Wilkes who, as a navy lieutenant on a polar expedition in 1840, first recognized the ice-bound south as a continent and christened the great area of art-Arctic.

Tonight President Hoover will present to Admiral Byrd a special medal of the Geographic Society in honor of his South Pole flight. The presentation will take place at Washington auditorium, with the entire Byrd command grouped upon the stage and officials and diplomatic Washington assembled below.

SEES DELAY IN ADJOURNMENT OF CONGRESS

Adverse and Favorable Report On Shipped Bill Submitted to Senate

Washington, June 20.—(AP)—After a conference with Republican leaders in the Senate, Speaker Longworth said today congressional adjournment before July 1 seemed unlikely.

He said it was "only a guess" as to when Congress would be able to adjourn in view of the parliamentary situation in the Senate. With the passage of the second deficiency bill today by the House he said his branch would be able to adjourn within three days.

Adverse and Favorable Report On Shipped Bill Submitted to Senate

Washington, June 20.—(AP)—An adverse majority report of the judiciary committee and a favorable minority report on the Shipstead bill to limit the use of injunctions in labor disputes were submitted today to the Senate.

The majority report was a supplemental one, the measure having been reported adversely some time ago with the understanding that it be discussed early in the next session.

The majority felt the bill would give rise to problems "more grievous" than those it seeks to solve and suggested further study of the question. Senator Steiwer, Republican, Oregon, submitted their views.

The minority, through Chairman Norris, of Nebraska, urged the need of curbing the action of judges in labor disputes, asserting workingmen have been harmed by court interference in the past.

Echoes of the fight against the confirmation of Judge John J. Parker of North Carolina who was rejected as a supreme court justice were heard in the reports.

Commenting on a section of the bill which would outlaw "Yellow Dog" contracts the majority report said there was no legislative power to inhibit contracts providing against union memberships. The "Yellow Dog" contract prohibits a workman from joining a labor union during his period of employment. Judge Parker's action in upholding a similar contract was a basis for the successful fight against him.

Another Gangster "Bumped Off" At Chicago, Illinois

Chicago, June 20.—(AP)—The body of a man thought to be a gang victim, wrapped in canvas was found in an automobile in a clay hole in Blue Island south side suburb today.

The car lay mired among a heap of junk automobiles at the foot of a railway embankment.

The license of the automobiles had been issued to Daniel LaMorte resident of the east side Italian section of Blue Island, who informed the police the car was stolen last night.

The police tentatively identified the body as that of Lorenzo Juliano 40, a minor character in the alcohol racket at Chicago Heights, another suburb. Mrs. Juliano told the police her husband had not come home last night but did not go to the scene of the slaying to identify the body which had a bullet in the breast. Her description to the police tallied with that of the dead man.

Probe Stabbing of Three Men in Ga.

Rockmart, Ga., June 20.—(AP)—The stoning and stabbing of three young men "taken for a ride" in a one horse wagon was being investigated by police here today on the theory that they were the victims of a gambling brawl.

Bill Hulse and his son Fred were held on suspicion while Coroner B. H. Leonard ordered an inquest over the mutilated bodies of Cliff Jones, Lige Harper, and Ernest McCullough. Other arrests were expected.

The bodies were found late yesterday in a dry well in a hilly, unhabited section about six miles east of here by Alonzo Sorrell while he was hunting bee trees. He first saw articles of clothing and bloody stones near the well, then found the corpses stacked in its depths. Further investigation revealed a long trail of blood, the hoof-prints of a horse, and the wheel-marks of a small farm wagon such as is used in this section.

Coroner Leonard said superficial investigation indicated the men may have been shot as well as stoned and stabbed, but that an autopsy was necessary to make sure Jones, Harper and McCullough was employed. The condition of their bodies indicated they had been slain some time yesterday morning. Police thought the killing took place several miles from the well.

FALKLAND MAN SUCCUMBS TO HEART ATTACK

C. A. Marslender Laid to Rest in Falkland Cemetery This Afternoon

C. A. Marslender, well-known citizen of Falkland, died suddenly at his home late yesterday afternoon as result of a heart attack.

Funeral services were conducted from his late home this afternoon at 4 o'clock by Rev. N. M. Fleming, assisted by Dr. Venerable. Burial was made in the Falkland cemetery.

Mr. Marslender for many years was one of the best known business men of his community. He had taken an active part in the religious, social and business life of the section and was well known over the county.

He is survived by his wife and one daughter. He is also survived by two brothers, Jim and Lawrence Marslender, and two sisters, Mrs. Charles Clayton, of Washington, and Mrs. D. M. State Parks Meet Comes to Close

Linville, June 20.—(AP)—A morning business session, capped by a final trip through sections of the mountains of western North Carolina, will bring to a close today the tenth national conference on state parks.

Josephus Daniels, editor of The News and Observer and one-time navy secretary, presided at the final session today at which several addresses were scheduled.

Speakers included Jay Downer, chief engineer of the West-Chester County Park Commission, N. Y., whose subject was "The Economic Value of State Parks and Their Influence on Adjacent Property"; Wilbur A. Nelson, professor at the University of Virginia, who was to read a paper, "Federal Aid for the State Parks."

M. A. Matoon, supervisor Pisgah National Forest, North Carolina, was the only "far heel on the fixed program. Methods of saving beaches from private control were to be discussed by Tom Deering, secretary of the State County Parks and Beaches Association, of San Diego, Cal.

Juncombe Farmer Sentenced to Pen

Asheville, June 20.—(AP)—Dock Allen, 53, farmer of the lower Homin Valley section convicted of second degree murder late Thursday afternoon for the slaying of Anderson Henderson, 54, neighbor, was sentenced to six to eight years in state prison Friday by Judge James L. Webb in Superior Court. While the court was temporarily delayed in getting a jury for the case of H. G. Littlejohn, Asheville man facing trial for a first degree murder.

The State tried to get a first degree verdict and death penalty in the Allen case but the jury found the lesser degree while the Littlejohn case in the second first degree case to be taken up this week in court. The jury in the Littlejohn case is expected to be obtained Friday afternoon, ten of them having qualified by 11 o'clock Friday morning when a new venire of 25 men was ordered summoned while the court proceeded with the sentencing of Allen.

High Navy Officers Asked to Confer on Battleship Program

Washington, June 20.—(AP)—High officials of the navy department were called before the House naval committee today in its consideration of the program for the modernization of battleships.

Acting Secretary Jahncke headed the list of witnesses which included also officers of the Bureau of Engineering, ordnance and construction and repair. Secretary Adams is expected to appear on Monday.

The measure before the committee was the Darrow bill to authorize an appropriation of \$30,000,000 for reconditioning the battleships New Mexico, Mississippi, and Idaho.

A move to defer action until December was defeated yesterday by a committee vote of 13 to 6.

White Man Held In Killing Case At Goldsboro

Goldsboro, June 20.—(AP)—Jim Aldridge, 30, of Lagrange was held in the Wayne county jail today in connection with the slaying Tuesday of E. L. Flinchum, prohibition agent.

Aldridge was arrested in Lagrange last night but his arrest was not revealed until today. Sheriff W. D. Grant refused to say what connection he thought Aldridge had with the shooting. His only comment was: "We expect to get some important information from him."

Twenty Men Trapped As a N. Y. Building Collapses Today

New York, June 20.—(AP)—Twenty men were injured and several others escaped injury today when a six-story general merchant, disrepair collapsed at 415 Washington street on the downtown west side.

The firm was occupied by a fruit firm, was reported to have collapsed today with twenty men at work in it. Fire and police trucks and six ambulances were sent to the scene.

An eye-witness of the wreck said that "the whole building seems to be in the street." Police and firemen were digging in the ruins and police lines held back huge crowds which gathered. The site of the collapse was in the wholesale fruit and vegetable warehouse district.

Byrd's Welcome to New York Was 70-Ton Affair

New York, June 20.—(AP)—This city's welcome to Rear Admiral Richard E. Byrd and his crew yesterday was a mere 70 ton affair, compared to the 1800-ton welcome extended Colonel Charles A. Lindbergh on his return from Paris three years ago.

This estimate by Charles S. Hand, superintendent of the city's sanitation department, was based on the amount of paper swept up in the streets over which the processions passed.

The cost of cleaning the streets was estimated at \$22,000, which is in addition to the \$9,000 appropriated by the city for the official reception.

Continue Probe of Man's Death

Greetsboro, June 20.—(AP)—Despite the fact that Vernon Way 15, has confessed that he shot his father to death Wednesday night as he sat beside the boy's mother on the front porch of their home near here, police continued today an investigation of the affair.

The boy's full confession was withheld by officials who said they expected further developments. They said that statements of Mrs. Way of the shooting tended to exonerate her youngest son.

Aged Woman Dies At Her Home Here

Mrs. Millie Ward, 75, died at her home on Evans street yesterday evening at 7:30 o'clock. The body was taken to Martin county where a funeral took place this afternoon.

Mrs. Ward was a native of Martin county and had only been living in Greenville several months. She is survived by one daughter, Mrs. E. Jones, one brother and two sisters, all of Martin county.

Senator Reed Praises Treaty

Washington, June 20.—(AP)—Replying to Senator Johnson's criticism of the London naval treaty, Senator Reed of Pennsylvania who participated in its foundation last night praised the pact and urged its ratification.

He spoke by radio in answer to an address summarily delivered by Johnson the night before. Much of his comment was directed at the remarks of the latter.

The treaty Reed said "removes competition in naval construction among the three leading powers in the world" gives "three countries a holiday from battleship building during the next seven years and saves tax payers of the United States an outlay of \$400,000,000 on replacement of battleships alone."

"It allows the people of these three great nations to rest secure in knowledge that one of the three can be attacked in its home waters by any nation on earth. It makes plain to all the world that one of the three countries is designing war upon either of the others. It promotes to an important degree the international friendship that we all desire."

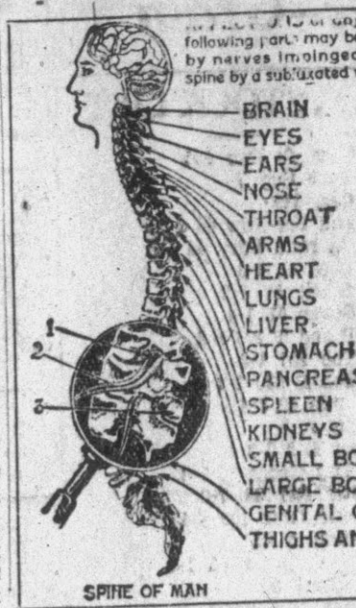

STOCK MARKET

STOCK MARKET... LEA... New York, June 20.—(AP)—The swift upturn in share prices proved too good to be true and was largely wiped out in a new selling wave in today's market. The violence of the rebound yesterday only attracted renewed bear selling and a more favorable opportunity for nervous traders still anxious to lighten their holdings.

The reduction from 3 to 2 1-2 per cent in the New York rediscount rate immediately enlivened the demand for gilt-edged bonds but had only a passing influence on stocks. The stock market opened with another abrupt upturn perhaps more in response to the \$211,000,000 drop in brokers loans than to the lower rate but early gains were soon cancelled and prices dropped swiftly under aggressive selling around midday. Soon after 1 o'clock, however trading slackened and support appeared.

There was a growing feeling in brokerage circles that prices would be unlikely to go much lower at least would not on the whole break through the levels of November 13 but commission house advices still remained cautious and there was no inclination to predict a rising market. Reassuring was the action of one large wire house in reducing its marginal requirements to approximately 25 per cent of market value. Furthermore it was learned that some investment trusts were fairly actively buying stocks.

London, June 20.—(AP)—Indian dispatches indicated that trouble with tribesmen on the northwestern frontier continues notwithstanding elaborate precautions taken by the military. A Lahore dispatch to the Daily Mail said that anxiety continues, Indian Nationalist propaganda having led the tribes to believe that British rule was passing. The air force, artillery and infantry were said to be co-operating in putting down the movement. The correspondent said also that there was widespread belief that one of the sons of former King Amarrullah of Afghanistan was recruiting an army among tribesmen for an advance into India.

A check of all police stations disclosed he was not being held.

She said a man, posing as a police officer, came to their home early last night and compelled her husband to accompany him. She did not suspect he had been kidnapped until her visit to police headquarters today.

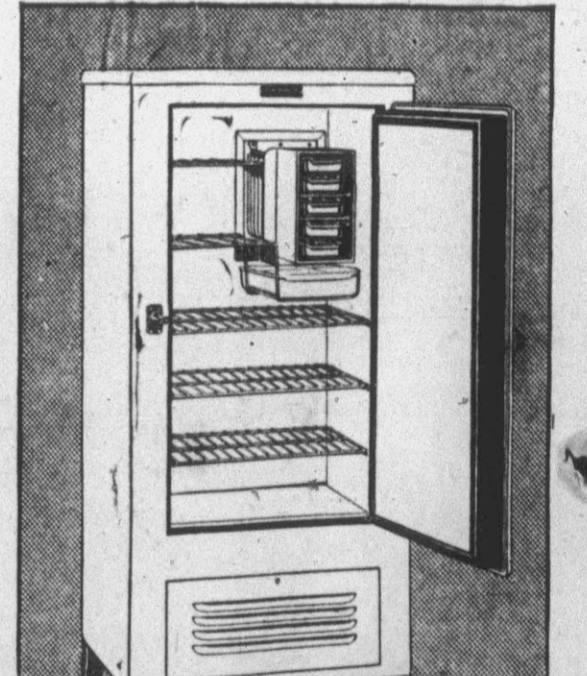

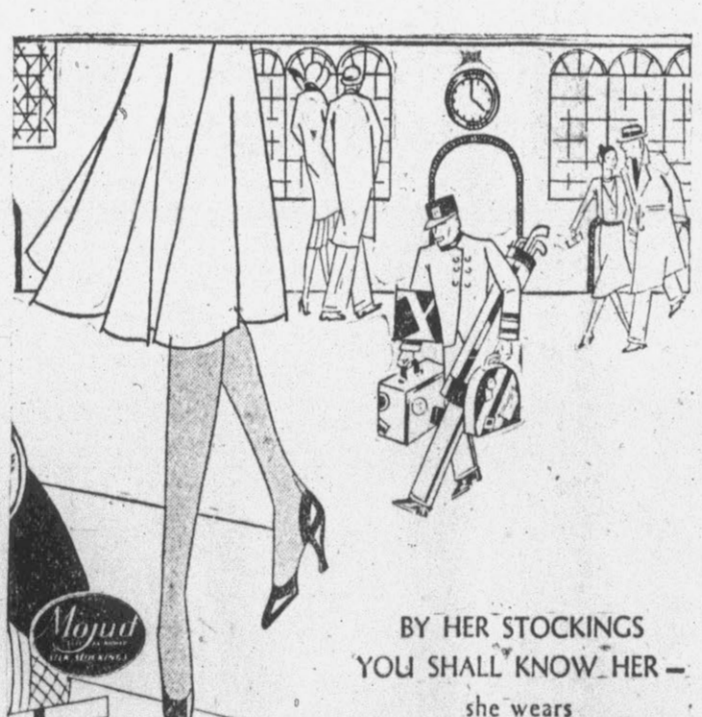
