SENATE STILL TALKING OVER LONDON PACT

Work Continued Today Without Any Sign In Sight As to Vote Taking

Washington, July 19.—(AP)—The Senate talked on and on again today about the naval treaty it is set to ratify eventually, without a sign in sight as to when the vote will be taken.

Sixty-two Senators answered the opening roll call and leaders were confident that a quorum could be maintained for the second successive night session, if necessary.

Senator Reed, Republican, Pennsylvania, was insisting upon going straight through again tonight hopeful that a vote might be forced before adjournment.

Senator Walsh, Democrat, Massachusetts, a member of the naval committee, opened debate, saying he did not want to lend any encouragement to the treaty opponents but he felt compelled to offer a resolution of reservation. His resolution provided:

"That the Senate of the United States is satisfied, in view of the substantial completion by December 31, 1936, of all cruisers mounting guns in excess of 6.1 inches, all aircraft carriers, all destroyers, and all submarines permitted under the treaty for the limitation and reduction of naval armament, signed at London."

Opponents of the pact, led by Senator Johnson, Republican, California, maintained their refusal to consider any agreement for a final vote. Likewise, Senate leaders who opened negotiations for some understanding on the contest found many pact advocates aroused and unwilling to consider any agreement with the opposition.

Doctor Under Fire Gaining Support of Friends Back Home

Sylva, N. C., July 19.—(AP)—Dr. John R. Brinkley, under fire of the Kansas Medical Board of Topeka which is seeking to revoke his license to practice in that state, today had behind him the favorable testimony of North Carolina friends.

The board had complained that Dr. Brinkley misrepresented his earlier education in applying for his license by stating he received his preliminary education at Tuckasee High School, the board says, but that in 1906 there was no such institution.

Yesterday Dan Tompkins, editor of the Jacksonville Journal, and mayor of Sylva, stated Dr. Brinkley did receive his earlier education at Tuckasee High School, this county, but that at that time there were no accredited high schools. Mr. Tompkins said that, on the basis of his record at Tuckasee, Dr. Brinkley was admitted to Loyola Medical School.

In Topeka, Robert L. Madison, Cullowee, N. C., former president and now professor at Western Carolina Teachers College, testified to virtually the same statements of Mr. Tompkins.

V. V. Hooper, Sylva, told the board he was Dr. Brinkley's boyhood chum and that both were classmates at Tuckasee. Affidavits and other witnesses bore out Dr. Brinkley's statements that he was a student at the school in question. The Kansas board has been seeking to revoke Dr. Brinkley's license after the Millford, Kansas, "goat gland" operations have been characterized as "not possible of success."

Get Wrong Baby and Want Him

Chicago, July 19.—(AP)—The Charles Bambergers and William Watkins may have the wrong babies but Mr. Bamberger wants the one he has now even if the hospital tag says it belongs to the Watkins.

Both babies were born June 30 at the Englewood hospital. Both were boys. It was Mrs. Watkins' first and Mrs. Bamberger's third.

Both babies and mothers did nicely and all were discharged from the hospital on the same day, July 9.

Three days later, Mr. Watkins was personally supervising bathing of his son, christened Charles E. Watkins. On the baby's back was the piece of hospital identification tape.

It read: "Bamberger."

Half an hour later, Mr. Watkins stormed into the Bamberger home, crying "You've got the wrong baby. Yours is mine."

A nurse had just bathed the Bamberger baby and had removed the tag, but she found it and it read: "Watkins."

Hospital authorities said they would make blood tests today to determine the parentage.

Edgecombe Officers Seek Negro For Attempting To Assault Two Small Girls

Five and Seven-Year-Old Daughters of a Farm Tenant Badly Bruised By Assailant in Attack at Tobacco Barn Near the Town of Saratoga

Wilson, July 19.—(AP)—Edgecombe county officers, aided by bloodhounds, today were searching wooded tracts near the Edgecombe-Wilson county line for Oliver Moore, 30, negro, alleged to have attempted to assault two small white girls late yesterday.

The girls, aged 5 and 7, are the daughters of Moore's landlord, E. F. Morgan, Edgecombe county farmer.

The alleged attack took place in a tobacco barn where Moore was curing tobacco. The children's clothing was torn and their bodies bruised.

The farmer notified Saratoga and Stantonburg officers of the attack and they in turn notified Sheriff O. A. Glover here and Sheriff Ed Bar. din in Tarboro.

Bloodhounds were secured and placed on the negro's trail, but he had not been seen at two o'clock this morning when the search was temporarily abandoned. A posse took up the hunt at daybreak today. Sheriff Bardin arrested Moore's brother last night and was holding him in the Edgecombe county jail at Tarboro pending investigation of the case. Moore's wife and two children could not be found by officers last night, they apparently having fled from their home in fear of mob violence.

Typhoon Claims Thirty Lives In Parts of Japan

Tokyo, July 19.—(AP)—Thirty dead, scores missing and injured, and immense property damage was the known toll today of the typhoon and rainstorm which swept over the Loochoo and Kishiu islands in the southern part of the empire yesterday.

Thousands of persons were made homeless when the storm, traveling 100 miles an hour, destroyed hundreds of dwellings.

The wind swept over the islands, crossed the straits and roared into Korea, leaving destruction in its path.

A train was wrecked and 20 persons injured, and reports said a village of 300 was burned in a landslide loosened by the heavy rain.

On the water the casualties were believed far greater than on the islands. Hundreds of boats were smashed and sunk, some carrying their crews to death.

The death toll would have been far greater, it was believed, except for the fact warnings of the storm had been broadcast the previous day.

Dispatches from Fusan, Korean seaport, said the storm struck there at noon, leveling homes and causing panic before continuing inland undiminished.

Electric plants were crippled and communication interrupted, making it difficult to learn the extent of the storm's fury.

Most transportation systems were at a standstill because landslides had covered roads and the railway tracks.

English Released Under \$4,000 Bond At Kenansville

Kenansville, July 19.—(AP)—Stephen English was out under \$4,000 bond today while his lawyers began perfecting an appeal in an effort to clear the young Wallace man of the charge of murdering his wife.

English was convicted yesterday in Duplin county court of beating his wife to death last January. Following the jury's verdict Judge G. V. Cowper sentenced him to 20 to 30 years in state's prison.

The case went to the jury on Wednesday night after over a week's trial but, finding they couldn't agree, the jurymen were locked up over night.

TWO ROBBERS ARE HANGED IN COLORADO

Pay Death Penalty for Slaying of Four Men In Connection With Bank Robbery

Canon City, Colo., July 19.—(AP)—George J. Bashier and Edward L. Royston went to their deaths on the State Prison gallows last night for the slaying of four men in connection with the robbery of the First National Bank of Lamar in May 1928.

The double hanging left Jake Fleagle, a fugitive, the only member of the small band of ruthless killers who were sought throughout the United States for more than a year after the robbery. Ralph Fleagle, reputed bandit leader, was hanged a fortnight ago.

Prison officials asked the condemned slayers, recently baptized in the Catholic faith, if they had any preference in the order in which they died.

"I'll go," Abshier said and was taken to Royston's cell for a farewell. Abshier was pronounced dead at 9:53 p. m., Royston dying an hour later.

In the Lamar holdup, A. N. Parrish president of the bank and his son, John, were slain by the quartet. Two tellers were kidnapped and later the body of one, E. A. Kissinger, was found. He had been murdered to still his tongue, it was revealed later.

Royston had been wounded in an exchange of shots in the bank before Parrish and his son were shot down. Dr. W. W. Wineinger of Dighton, Kas., was called to treat his wounds. The doctor's body was found sometime later. He had been killed by a shotgun charge in the back of his head.

Youth Confesses Killing Mother

Holstein, Iowa, July 29.—(AP)—A 14-year-old boy confessed to County Attorney George Clark, Jr. last night that he knocked his mother unconscious with a brick, dragged her into the kitchen of their farm home and shot her to death.

The youth, Lester Mohr, said he had quarreled with his mother, Mrs. Gus Mohr, 35, Thursday afternoon over some work she wanted him to do and that he threw bricks at her while she was in the farm lot.

INTERVENTION BY THE BRITISH IS PROTESTED

Egyptian Prime Minister Says Presence of Warships Is Act of Intervention

Alexandria, Egypt, July 19.—(AP)—With two British warships in the harbor Prime Minister Ismail Sidky Pasha in an official note published today accused the London government of having intervened in Egypt's affairs.

His note was in answer to a communication made him by Sir Percy Loraine, British high commissioner in Egypt, in which he was told, after Tuesday's serious rioting here, that he would be held "responsible for protection of foreign lives and property in Egypt."

A similar communication, it was announced Wednesday in the House of Commons at London, was addressed to Mahas Pasha, premier resigned and head of the Wafdist, nationalist or majority element.

M. Sidky Pasha said that "order and tranquility having been restored, the presence of British warships in Egyptian waters is no longer required for the proposed object of safeguard." In conclusion he said that the British note could be interpreted as calling in question the government's exclusive authority.

"I do not evade for an instant the responsibilities alluded to in the British government's communication, although the communication is not of a nature to facilitate the task which I am resolved to accomplish," he said.

Fourteen persons were killed and 56 injured, among them several foreigners, in Tuesday's rioting, which grew out of political rivalries.

OLDEST MAN ARRIVES AT NEW YORK

Another Endurance Champion, Zaro Agha, Claims He Is Going to Live On

New York, July 19.—(AP)—An endurance champion of another sort was a visitor in the city today. He is Zaro Agha, a Turk, who claims to have endured for 156 years.

He is here to offer his antique body for examination by scientists and dictate a century and a half of autobiography for consideration.

But Zaro Agha is not resting on his laurels.

"I am going to live as long as the world lasts," he declared. Among the items of his shipping list while he is here is a set of artificial teeth. He said he needs them to replace his third natural set which he cut at the age of 105. They were not very sound he explained and at 120 he was a toothless old man again.

He has endured 12 wives and six wars. He outlived 11 wives and now is wedded to a woman 90 years his junior, whom he left in Istanbul while he makes his American tour.

Of his 38 children all are dead but his youngest daughter who was born when he was 67. He has no idea how many grandchildren, great-grandchildren and later generations of descendants he has.

His war record, he said, began with a campaign against Napoleon in Syria. He fought against the Greeks and in four wars against the Russians. In the last one, when he was 103 years old, he was an artilleryman, that is, he carried field pieces on his back through mountain passes.

Carrying things on his back was his forte, he said. Between wars he was a heavy-duty porter in Constantinople. Now he is content to carry the burden of his years, no trifle.

His skin is yellow and wrinkled and of the texture of parchment. His eyes are bright but sunk deep in their sockets. He hears well and speaks in a high cracked voice.

He said he never has used alcoholic stimulant or tobacco. Sweets and fruit constitute his principal diet.

Flying Yachtman

CAPONE DENIES HE HAS PAID MANY PAPERS

Discredits Statement Attributed to Him in Copyrighted Story At St. Louis

Miami, Fla., July 19.—(AP)—Alphonse Capone—by his own pronouncement the chief lieutenant of Chicago's gangland—says he is willing to go before any grand jury to deny statements attributed to him that he has "plenty" of Chicago newspapermen on his payroll and that he and Chicago police knew who killed Jake Lingle, Chicago reporter.

Capone dictated a statement at his Palm Island estate last night regarding a copyrighted story written for the St. Louis Star by Harry Brundidge.

"If he is trying to build his reputation on what he thinks I said, and not the truth, he is a deliberate liar," Capone asserted.

"I defy him to say these statements he has made are true. I will face him before any grand jury and deny them to his face."

"It is the truth when he said I gave Lingle a diamond belt buckle," Capone said. "Lingle was a dear friend of mine. The buckle was a Christmas present and I gave it to him as a Christmas present and not for any service he had rendered me as a newspaperman."

Capone said Brundidge talked with him for approximately ten minutes recently.

He said when Brundidge asked him if he ever had paid money to newspapermen he had replied that he never had, but that if he had he wouldn't tell the reporter about it.

"I told him I was through with the racket in Chicago and didn't care to be mixed-up in it one way or another," he continued.

During the conversation, Capone said, Brundidge several times attempted unsuccessfully to turn the course of conversation to shootings in Chicago, and eventually proposed to write a story of Capone's home life. The latter proposal was refused, Capone said.

"All he is trying to do is to build up a reputation by faking stories on a so-called interview he had with me, the facts of which I have just mentioned," Capone said.

Capone also denied that he had contributed to the senatorial nomination of Ruth Hanna McCormick of Illinois, but added that he would have been glad to contribute had he been approached.

His statement as to his retirement was interpreted as strengthening reports that he will erect a second Florida mansion, this one to be on a 502 acre tract in Broward county, 40 miles north of here and near the exclusive Boca Raton club.

A contractor recently said the estate would include a private golf course, swimming pools and tennis courts.

However, neither Capone nor his attorneys has verified the building plans report.

ORDERS HOUSE CLEANING IN NEW YORK CITY

Mayor Walker Plans Probe of Irregularities in Board of Standards

New York, July 19.—(AP)—A "house cleaning" of his administration has been ordered by Mayor James J. Walker.

The mayor's action follows widespread investigations by federal and county attorneys into alleged irregularities in the Board of Standards and Appeals in the granting of garage permits, and the department docks with respect to pier leases.

The dock department was placed under fire through disclosures which resulted in the indictment of former County Judge W. Bernard Vause of Brooklyn, who is now on trial in Federal court. It was charged that Vause, who resigned after he was indicted, had received a fee of \$250,000 for getting a lease of Hudson river pier space for the United American line.

William E. Walsh, chairman of the Board of Standards and Appeals, resigned after he had been indicted for accepting a gratuity.

This was preceded by indictment of William F. Doyle, former veterinarian whose practice before the Board of Standards and Appeals was said to have been so lucrative that it brought him about \$200,000 in fees in less than three years.

The mayor's investigation is to be in charge of James A. Higgins, commissioner of accounts.

House Committee Hears About Financial Standing Of Communists In U. S.

Translation of Article Purportedly Written By the Former Charge d'Affaires of Soviet Embassy In Paris, Read to the House Investigating Committee

New York, July 19.—(AP)—Translation of an article purportedly written by Gregory Dessedovsky, former Charge d'Affaires of the Soviet Embassy in Paris allegedly describing Moscow's financial affairs in the United States, was read before the special House Communist investigating committee today.

The article said the Amtorg Trading Company was headed by important Communists from Moscow. The directors, it said, usually were sent under a disguise and were "bombed" to sign notes for double the amount of the stock issued to them in order to make them directors.

In order to finance the Communist propaganda work, the article said, Moscow sent money from Berlin to the Amtorg Company. Secret agents, it continued, handled the funds which had been gradually increased in recent years. In addition to spending approximately \$100,000 a year as a subsidy to the American Communist party, Moscow permitted the party to draw emergency funds up to \$10,000.

The Narkomtorg in Russia, the Department of Commerce, approved the officials of the Amtorg, according to the translation. However, it was added, some American citizens were made officials in order to ally suspicions.

The article said an astute agent going under the name of Philas had charge of propaganda work in the army and navy in this country and worked through Amtorg.

The article was read to the committee by Inspector John A. Lyons, of the radical squad of the New York police department. He identified Dessedovsky further as a former director of Amtorg.

John L. Leary, of New York, industrial editor of the World, testified that William Z. Foster, Communist leader, believed every strike was a trailing ground for a revolution to come.

Leary said he was assigned to report the strike in Gastonia, N. C., and others sponsored by Communists. Each strike, he said, was used "as a peg for a collection agency," and much of the money collected for the strikes was used for propaganda purposes.

Asa P. Randolph, of New York, negro president of the Brotherhood of Sleeping Car Porters, told the committee Communists sought to control his organization during the last several years ago. Although the Communists became active among the negroes about the same time as among the whites, Randolph said, they had become more aggressive during the past year and a half.

Under questioning by Representative Nelson of Maine, Randolph said the Communists promised the negroes they would eliminate all discrimination among the races. The committee recessed until Tuesday.

Calls On Purported Dead Mother to Pay His Fine in Court

Chicago, July 19.—(AP)—Mrs. Mildred Heinrichs said Charles Eoff extorted \$10 from her, so police arrested him.

"He told me he wanted \$10 to help bury his mother," she testified before Justice Harry Porter.

Eoff was fined \$100.

"But I haven't got it," said Eoff.

"Work it out in jail," said the court.

"Can't you wait a while?" he pleaded. "My mother will pay the fine."

"You mean the mother you buried?" asked the court.

"Yes," said Eoff. "She's down in Danville."

The court agreed to wait.

ARREST MAN FOR SLAYING JAKE LINGLE

Thomas Abbott Captured After Exciting Chase With Police

Chicago, July 19.—(AP)—Thomas Abbott, who has been secretly sought as the actual slayer of Alfred (Jake) Lingle, was captured early today in a spectacular chase in which hundreds lined the streets, cheering.

Abbott, driving the same type of automobile used in the recent attempted assassination of Jack Zuta, led a police flivver squad a ten mile chase before he was caught at the door of his apartment.

The chase started at Diversey avenue and extended north as far as Rogers Park, then south again. Several times in doubling back on the trail, the Abbott and police cars sped up and down North Clark street. Hundreds of persons, recognizing the machines by their speed and constant reappearance, lined the streets and cheered.

Many shots were fired by the officers. A gun was found in the Abbott car.

Abbott, who was accompanied during the chase by his wife, denied having any part in the murder of Lingle, the Tribune reported, who was killed June 9, or in the attack on Jack Zuta.

There was a bullet hole in the back of the Abbott car which police believe was made by officers who fired on the machine from which the attack on Zuta was made. They said they did not believe any of the shots fired in last night's chase struck the machine.

NATION AGAIN BAKES UNDER WAVE OF HEAT

Virtually Every Section Gripped By Withering Temperatures Today

Chicago, July 19.—(AP)—A withering heat fastened itself upon America today.

From Great Lakes to Gulf and from ocean to ocean, the continent cooked. Three figure temperature readings were common. Ninety degrees or better were recorded in virtually every section.

On the basis of official government figures, the average maximum temperature for the United States yesterday was 90.5.

Out of 94 government weather bureaus reporting to the Chicago forecast, 54 had temperatures of 90 degrees or better. Only nine of the entire number reported maximums under 80.

The nation's granaries, baked hard by persistent sun, faced drought. Livestock in many places saw green pastures turn russet and die. The danger of corn being fired in the field was felt in Iowa.

A few deaths occurred—sun strokes, prostrations and drownings; but the number was not large considering the extent of the heat wave.

Beaches, especially those near large cities, swarmed with people. In Chicago, where an estimated quarter of a million took to the water to smother off the heat, Lake Michigan had a temperature of 68 degrees.

Phillipsburg, Kan., had 113 degrees, and Emporia had 109. Scores of other communities in the middlewest reported unofficial readings above 100 degrees.

Weather prophets were doubtful concerning any immediate relief for most of the country. The possibility of thundershowers was spoken in the central and northwest, but the forecasts pretended to see no certain surcease to the heat.

The need of rain was felt in a score of states. The United States weather bureau at Washington said the dry spell was particularly severe in Tennessee, Arkansas, Alabama, Mississippi, and Louisiana, and to a slightly less degree in the middle and southwest.

Los Angeles, July 19.—(AP)—Southern California's record breaking six day heat wave receded today after having taken eight lives. Matilda Lagrant, 76, died yesterday in an auto camp at Hollywood in the Imperial valley. Her death raised to seven the number of fatalities occurring in the below-the-sea-level valley flanking the lower end of the Colorado river.

Cool breezes from the Pacific brought relief from the high temperatures. All sections outside of Imperial valley reported below 90 degrees weather. Los Angeles cooled off to 84. In the Imperial district the thermometers still were above 100 degrees but lower humidity was reported. El Centro registered 106.

During the heat wave a high mark of 118 degrees was reached Monday at Calexico, on the Mexican border.

The first sunstroke death in Los Angeles county in more than two decades occurred Thursday at Montebello, Los Angeles suburb.

Young Woman Drowns When Two Boats Collide

Chicago, July 19.—(AP)—A saucy speedboat, the "Whoopees" carrying a party of six young people and a pilot, crashed amidships into the 14-ton yacht, "Scarab" of the Rogers Park beach in Lake Michigan last night, catapulting Miss Betty Ayres, 18 years old, to her death.

Six other members of the party, as well as the four men aboard the yacht, reached shore safely, although Benjamin Marshall, Jr., 21-year-old, son of the wealthy Wilmet architect, was severely injured.

Aboard the "Scarab," an auxiliary yawl whose home port is Larchmont, N. Y., was the craft's owner, George M. Pulver, wealthy Washington mortgage broker, Freeman Higgins, New York, and a crew of two.

The speedboat had been rented by young Marshall and was piloted by Barton Webster. Aboard, in addition to Miss Ayres and Marshall, were Miss Dorothy Marshall, 14; William J. De Riemer, 18, son of Dr. Albert De Riemer; Robert Shotwell, 16, son of Alfred H. Shotwell, millionaire manufacturer; and Miss Janet Schreiner.

Members of the Marshall party said the Pulver yawl collided on running lights. The collision occurred about half a mile off shore.

DESTROYING OUR FORESTS.

The wanton destruction of timberland is one of the most tragic phases of our fire waste record.

In a period of ten years, between 1916 and 1925, an average of 51,021 forest fires occurred each year, entailing an annual destruction of property value of \$20,994,916. It requires 40 to 100 years for a tree to reach maturity. Yet, by fire, whole forests can be totally destroyed in a few hours.

Great fires, wiping out all timber over broad areas cause the extinction of wild life, radical changes in climate and damage to agriculture. The state and national governments do everything in their power to prevent such catastrophes. But they cannot be successful without public co-operation.

Tourists, by carelessness with tobacco, matches and camp fires, are leading offenders. Some of the worst forest conflagrations in our history have occurred when camping parties moved on without completely extinguishing their fires.

It should be our patriotic duty to help protect and conserve our great forests.

THE COLLAPSE OF A POLICY.

The administration's plan of farm relief has now been tried and has failed completely. Its failure is virtually admitted at the White House.

The final collapse took place in the last few days. On Friday a week ago Senator Capper of Kansas made public his demand that the Federal Farm Board should buy a hundred million bushels of wheat to stabilize the price. On Monday of this week Senator Capper went over the head of the Federal Farm Board and placed his demand before the President. That same day it was made known at the White House that the President would not instruct the Federal Farm Board to buy the wheat. On Thursday the President went one step further and made known his approval of the Federal Farm Board's refusal to buy wheat. Thus definitely ended the hope and the pretense that the administration would and could stabilize prices by solving the problem of wheat surplus. It is now frankly admitted by the spokesmen of the administration that they can do nothing about the surplus except to advise the farmers to curtail themselves by cutting down their acreage.

The Hoover Administra-

tion took a political gamble on farm relief and lost. It insisted that the West should abandon its own plan of farm relief and accept the administration plan. The administration plan was one which could work only if it were not put to a severe test. It could work only if the world's production of wheat was low and the demand for the American surplus high. In that event there was no real need of farm relief and the administration's measure for farm relief would not be put to the test. Things have not turned out luckily for the administration. There has developed an economic crisis of the first magnitude in which all sham remedies are bound to fail. The administration's plan was a sham remedy and it has failed. Mr. Hoover is now paying the price of an indecisive and trafficking policy.

There were two large alternatives open to Mr. Hoover when he first committed himself to the subject of farm relief during the Presidential campaign. One course was to accept the program which the West itself demanded, on the ground that however theoretically unsound it might seem, and however certain he might feel that it was going to fail, it was in the long run better to fail with a plan which the West believed in than to fail with measures which the West did not believe in.

The other alternative was to stand resolutely on his economic convictions, say frankly to the West that the Federal Government could not fix prices, could not subsidize agriculture, and that, fundamentally, the farmer must work out his own salvation.

Either alternative would have been statesmanlike, both would have been costly but either would have had its compensations. To have tried the first course, which was to give the West what it wanted, would have been costly, but it would have compelled the West to face its problem by giving it power and responsibility. The other course, which would have had the merit of representing the convictions of the President and of the dominant element in the Republican Party.

What Mr. Hoover actually did was to try to please everybody a little. He put through a farm-relief measure which didn't openly propose to fix prices, and then used the machinery set up for a half-hearted attempt to fix prices. Having started to fix prices he quickly stopped fixing prices, with the result that he led the farmers to believe for a while that the government would buy wheat, and then disappointed them by refusing to buy wheat.

In the mean time, while he was offering the farmers an unworkable scheme which they didn't want, he allowed the industrial wing of his party, under cover of the pretense that the tariff was to be revised in the interest of agriculture, to put into effect new taxes on commodities which greatly increased the cost of living to the farmer. Thus, out of the Republican program of farm relief the farmer has got a farm-relief measure which admittedly cannot help him, a tariff on agricultural commodities which admittedly

cannot help him, and an industrial tariff which is very effective and which hurts him a very great deal. When the whole record is surveyed it will not be surprising if the Western farmer feels that the time has come for another one of his periodic political rebellions. —(New York World).

ABOUT TOWN

A mad dog was killed in Greenville yesterday and members of the police department have warned the public to be on the alert for more dogs suffering from the rabies.

Along with the warning came notice also that the ordinance prohibiting dogs running at large would be strictly enforced in the future, and people guilty of violation will be summoned before the mayor to say why the law was not observed.

The ordinance provides that all dogs be properly chained and accompanied by their masters when appearing on the streets. Dogs unchained not only prove a menace to the people at large, but they also jeopardize the lives of the entire neighborhood.

People who have dogs should take extra precautions at this season of the year. The rabid dog discovered yesterday is believed to have bitten several other dogs in the Third street community, and this makes it imperative that every body be on his guard against the menace in the future.

Automobile owners who have not procured city license plates, will be promptly prosecuted hereafter, according to announcement made by Chief of Police Preston Pierce yesterday.

The chief declared that numbers of cars were being operated about the city without licenses, and it is his purpose to arrest the owners and to give them a chance of telling the mayor about it.

He also said that some of the car owners had bought license plates but had not properly displayed them. In order to avoid the embarrassment of being stopped and questioned by police, all citizens have been requested to place the plates in a conspicuous place so there will be no doubt about them in the minds of the traffic officers.

The city derives considerable revenue through the sale of license plates, but the sales are not nearly as large as they should be owing to a disposition of the public to try to get by without the tags. It takes money to run a municipality, and sources of revenue of this kind is the only way the town can pay its bills, therefore, the importance of everybody meeting his

just obligations to the city.

Fertilizer demonstrations such as that recently held in the Ayden community should prove of invaluable aid to the farmer in solving the problem of enriching the soil for the cultivation of the various crops produced in this section.

In fact, it enables the growers to exchange opinions on the different methods of cultivation, and in the final analysis proves beneficial to the farmer and business man alike. Improved methods of farming is the only way the farmer can hope to keep pace with industry in the future, and every time there is a demonstration looking to the creation of better ideas the farmers should make it a point to attend and become fully posted.

Pitt county growers are among the most thrifty in the state, but there are lots of pointers they might gain by rubbing elbows at the demonstrations, and it is to be hoped they will not neglect the opportunity of attending demonstrations arranged through the county farm department and other organizations from year to year.

People who attempt to drive fast in congested areas, not only violate the laws but they jeopardize lives of hundreds of other people. Every automobile operator should make it a point to be as careful as possible when threading his way through heavy traffic. By doing this he not only eliminates the possibility of damaging life and property, but saves himself the embarrassment of being forced to attend court to defend himself against some criminal action.

Then, too, there is another phase of the traffic situation that should command more attention than it does. That is the stopping of cars before entering main streets and highways. In the city there are stop signs designating where such stops should be made and it is the duty of everybody to at least slow up and see if the way is clear before attempting to cross.

The majority of accidents result from inattention to such traffic regulations and if the people who always seem in a hurry would really realize the importance of obeying the law, the toll of life and property resulting from accidents should be materially reduced.

New York, July 19.—(AP)—Cotton opened steady today at an advance of 8 to 13 points with active months still showing net gains of about 12 to 15 points in response to higher Liverpool cables and continued dry, warm weather in the central and western belts.

Trading was fairly active on the advance which carried the new October contract up to 13.30 but the demand tapered off after the initial buying orders had been supplied and there was slight setbacks later under week-end realizing. At the end of the first half hour, trading was quiet with the market showing reactions of 6 or 7 points.

Liverpool cables said there had been continental and Bombay buying as well as covering and trade calling in that market and reported a better inquiry for cotton cloths in Manchester, although they said many offers were unworkable. The amount of cotton on shipboard at the end of the week awaiting clearance was estimated at 49,500 bales against 56,300 last year.

STOCK MARKET

New York, July 19.—(AP)—With week-end business surveys giving no tangible indications of recovery, stock market traders today appeared inclined to feel that the rally in share prices had been carried far enough, and hurried to take profits before the week-end shutdown.

The bull forces failed to rush in toward the close and drive stocks back up again, as they have during recent sessions when profit taking was heavy. This was a little disappointing, as Wall Street had expected an effort would be made to close the week with a strong market, to help speculative sentiment. U. S. Steel closed only 3-4 lower, but Westinghouse Electric lost nearly 3 points, American Telephone and Byers, about 4, and Eastman Kodak 7.

The mercantile reviews reported some activity in retail sales of seasonal merchandise, but the first week of wholesale buying for autumn has been rather quiet in the New York markets. Industrial activity has ebbed further, several large plants, including those of Ford and Western Electric, closing down for two weeks for vacations and inventory taking.

The sales report of Sears, Roebuck for the four weeks ending July 16 showed a drop of nearly 15 per cent from the like period of last year, which was a little unsettling. Johns Manville reported earnings for the second quarter of only \$998,529, a little improvement over the first quarter, but well below expectations of some months ago when a brisker upturn in building was predicted. It was less than half the net of \$1,933,007 reported for the like period of last year.

The grain markets were firm, reflecting reports of crop damage in Canada, and better export demand for wheat. Kansas City Southern, the second class 1 rail-road to report June earnings, showed a balance after taxes of \$449,501, only moderately below the \$440,544 reported for June of last year. The Chicago Association of Commerce calculated unemployment in that city at 43-10 per cent of the population.

BIG STRUGGLE GOING ON IN THE NATIONAL

Almost unnoticed amid the tumult and shouting over the Brooklyn-Chicago battle for first place in the National League, there is a stirring bit of baseball warfare going on in the second division of the circuit, with Pittsburgh, Boston and Cincinnati involved in a three-way struggle for the best position.

Pittsburgh's Pirates are on top, the second division today, holding fifth place by a half game margin by virtue of yesterday's 12 to 4 triumph over the Boston Braves. Cincinnati, victorious over the humble Phillies, 13 to 6, still are in seventh place but only a half game behind the Braves.

Glenn Spencer pitched the Pirates to their third straight victory in Boston, allowing only two hits of which three went to Welch.

The Reds and Phillies engaged in a wild hitting affair in which the Phillies scored five runs in the fourth to gain a 6-6 tie and the Reds duplicated the rally in the eighth to clinch the decision. Home runs were the big feature with Chuck Klein hitting his 27th for Philadelphia and Hellmuth, Sirrup and Meusel connecting for Cincinnati's four baggers.

Chicago's Cubs likewise used the home run route as they clipped Brooklyn's lead to a single game by winning the fourth clash of their "crucial" series, 6 to 2. Hack Wilson, Clyde Beck and Woody English clouted homers to account for four of Chicago's runs while Del Bissonette's four base blow was the only real wallop of the five hits the Robins made off the delivery of Sheriff Fred Blake.

Brooklyn still has the advantage going into the series final today, even if the Cubs win the last game; the Robins will hold first place by a four point margin.

New York's Giants went a long way toward settling their dispute with St. Louis over third place by rallying for five runs in the ninth to win the second in a row, 8 to 7. The Giants could not make much progress against Bill Hallahan in the first eight frames, but they did a good job of it in the final, getting six singles.

The lowly St. Louis Browns provided the big thrill of the American league's day as they blew a seven game losing streak sky high at the expense of the New York Yankees. The Browns started hitting and scoring in the first inning and, refusing to be intimidated by the great Babe Ruth, who made his 33rd home run, or Lou Gehrig, who clouted his 25th, they didn't stop until the eighth, rolling up a 14 to 6 score.

Incidentally they moved out of eighth place by a three point margin over the Boston Red Sox, who lost a 7-6 decision to Detroit as the Tigers found Milton Gaston for six of their runs in the fourth inning.

The Philadelphia Athletics won their eighth straight game by scoring eleven runs in two innings to defeat Chicago 15 to 1. For home runs, two by Jimmy Fox, were tossed in among Philadelphia's 15 hits and George Earnshaw allowed the Sox only seven blows.

Washington got back in the winning column to even the series with Cleveland and remain 3-1-2 games behind the Athletics with an 8 to 6 victory.

SPORTS SLANTS

It will be some time before the cheering sections from block letters and the boys in moleskins go into a huddle, but warning now may be served that Prof. Knute Rockne, in good health and spirits, will go on the war-path against any undue meddling with his football shift.

"The Rockne of Notre Dame" was a sick man, flat on his back, when the rules-makers last spring came out of their secret pow-wow to announce that henceforth "at least" a full second or a rapid count of 1-2-3-4-5-6 must elapse between the shift and the moment the pigskin is snapped into play. Hitherto a count of four was deemed sufficient to protect the interval of one second required by gridiron law. Rockne defies anyone to count six inside a split second without stuttering.

If this was designed merely to check abuses, all well and good, so far as Rockne is concerned, but if as he suspects, it was aimed as a sweeping wallop at shift plays in general, especially those synchronized maneuvers of the Notre Dame system, there will be a vigorous rebuttal before the next whistle blows for a kickoff.

"What's the idea of this 'long count'?" Rockne asked in a recent discussion I had with him on the subject. "There doesn't seem to be any need for it. The count of four was sufficient safeguard. If not, let 'em use a stop-watch."

"If the rules-makers want to hand-cuff one of the features that has made the modern game so attractive; if they want to do away with smart, fast play and go back to the old rock 'em and sock 'em style of offense, why let's have this long count and kill the shift altogether."

What Rockne would like to know is why he or some other delegate representative of the shifting school was not given the opportunity of a rebuttal last March when the "long count" was inserted into the rules.

Shamrock Runs Into Heavy Gale On Way to N. Y.

Portsmouth, Eng., July 19.—(AP)—Shamrock V ran into a gale within an hour of her departure for New York and Newport today, causing Captain Ned Heard to consider the advisability of anchoring off Yarmouth until the weather cleared.

Captain Heard signaled, "If we find weather outside continued suitable after we leave Pithead we will anchor off Yarmouth."

"I don't think we will find the wind so bad when we get into the open sea."

The Shamrock was joined off Spithead by the Steamyacht Erin. Arrangements were made for the Shamrock to keep in touch with the Erin by signaling every hour of the day and night throughout the voyage the simple message "Q. K." Master of Fairfax to Be Given Hearing at Norfolk, Virginia

Washington, July 19.—(AP)—The trial of Captain Archibald H. Brooks, master of the steamer Fairfax, on charges of unskillfulness, negligence and reckless navigation will be held in Norfolk, Va., at the request of his counsel.

The Fairfax was involved in collision off the Massachusetts coast last June which cost 49 lives. Though jurisdiction over the disaster would ordinarily come under the Boston district of the steamboard inspection service, and a trial board would be convened there to consider evidence on charges of bad seamanship filed against Brooks by the government, the transfer to the southern port was said to be desirable as a matter of convenience to witnesses. A considerable number of the passengers aboard the Fairfax were marines and sailors and now on duty at the Norfolk base.

The great loss of life in the disaster was due to explosion of the gasoline cargo of the Tanker Pinthis, the other boat in the collision.
