SLAIN RADIO ANNOUNCER LAID TO REST

Law Partner Clears Name of Perry Buckley As Body Is Lowered In Grave

Detroit, July 26.—(AP)—With a July thunderstorm as his requiem, the body of Gerald E. (Jerry) Buckley, slain radio announcer, was buried in Mt. Olivet cemetery today.

Simultaneously with the lowering of Buckley's body into the grave, Thomas F. Kennedy, his law partner, made public an affidavit designed to clear the name of the man who was known for his unrelenting attacks on the underworld.

Thousands of persons lined the streets as the body was carried from the home to St. Gregory's Roman Catholic church for the last services; other thousands followed the procession to the cemetery.

Most of the crowd had known Buckley only as a voice on the air, an invisible speaker who championed their cause and voiced their half formed opinions on old age pensions, municipal government, crime and many other topics.

Until Buckley fell, with 11 gangster bullets in his body Wednesday, most of the crowd had never seen his face. Since that time more than 100,000 persons have passed his bier.

The affidavit given out by Kennedy was signed by Frank Chock, an admitted bootlegger. It stated that Chock unwittingly had signed a statement given him by Police Commissioner Thomas C. Wilcox two days after the slaying in which the allegation was made that Buckley had forced him (Chock) to enter the bootlegging business and then attempted to collect \$4,000 from him.

According to Chock's newest affidavit, Commissioner Wilcox obtained his signature to a document he did not understand and which he could not read. Chock said he could not read English and that he was unable to grasp the significance of the statement as it was read to him. He said he signed it only because he feared he would be sent to jail.

While these developments were taking place, Inspector Norval Marlett of the blackhand squad, announced that he had been telephoned by "Black Leo" Cellura for whom the police have been searching since the slaying of the announcer.

Marlett said that Cellura had protested the linking of his name with the slaying and intended to remain in hiding because he did not want to be arrested for a crime with which he had no connection.

Dry Agent Held For Shooing Boy

Columbus, Ga., July 26.—(AP)—A 19-year old Columbus boy was dead of a gunshot wound today and a prohibition agent was held by police who investigated conflicting stories of the circumstances of the shooting.

Ray Rodgers, 19, was shot last night in the back yard of a residence here. W. K. Johnston, Jr., the prohibition agent said that he was hiding in the yard when Rodgers and a girl companion arrived in an automobile. Johnston said he flashed a light into the automobile and that Rodgers and the girl, who told police she was Eunice Johnson, 19, grabbed for his pistol. During the fight for the gun, Johnston said, Rodgers was shot. The girl said no effort had been made to take Johnston's pistol.

UNUSUAL HEAT TEXAS VOTES CONTINUES IN FOR GOVERNOR ALL SECTIONS

Some Relief In Southwest; New Wave Strikes New York With Three Deaths

Chicago, July 26.—(AP)—Rain over most of Wisconsin and northern Illinois brought some relief from the heat wave in the north central states today, but abnormal heat continued in the southwest. In Chicago at 9 a. m. the reading was 76; while Milwaukee reported 68 and it was 70 in St. Louis and Minneapolis, where another shower was centered.

Kansas, Nebraska, Missouri and Iowa seemed destined for another day of extreme hot weather with prospects of equalling 100 degrees temperatures.

New York, July 26.—(AP)—Seventy five thousand fugitives from New York's newest heat wave took refuge in Central Park last night and slept on lawns and the benches.

Despite tempering mid-week showers that city confronted today another blistering week-end. Yesterday's high was 90 degrees, and at 8 o'clock (EST) this morning the thermometer started upward from 78, with mounting humidity, threatening to make the heat more oppressive than yesterday.

Three deaths and three prostrations were reported in twenty four hours.

Man Acquitted of Murdering Another

Bryson City, July 26.—(AP)—A Swain county jury has found that Prentice Boston, of the Tennessee State Park Commission, came to his death as the result of accidental discharge of a gun in the hands of W. B. Griffin, of Townsend, Tenn.

Griffin later yesterday was acquitted of a charge of murdering Boston. The shooting occurred July 4 at a camp on top of Clingman's Dome, its altitude of 6,880 feet making it the highest peak in the Great Smoky mountains.

Millard Smith, the state's principal witness, testified hearing a shot and of seeing Boston topple over dead. Griffin, admitting the shooting, declared a gun he was examining accidentally discharged.

LIVE AT HOME APPROVED BY WELFARE BODY

State Workers Talk Over Problems At Institute at Chapel Hill

The superintendent of public welfare stands as the county's representative to those in need. For this reason, the work of the welfare officer is doubled and trebled in hard times, and he or she feels the tremendous responsibility of providing for the victims of the economic situation.

During the past week, the welfare officers of the state have been gathered at Chapel Hill to discuss their problems, and to get concrete suggestions from each other as to how they can best meet the unusual demands for help caused by the serious unemployment situation.

"Unemployment and dependency" was the subject for the annual Institute of Public Welfare conducted under the auspices of the State Board of Public Welfare and the University. That was the subject nearest the hearts of the welfare people, and many interesting experiments have been related during the discussions when everybody was allowed to tell about the situation back home.

The main conclusions that were reached were that Gov. Gardner's Live-at-Home program will go a long way toward solving the problem, if it is followed by the farmers throughout the State; that, in this event, the farms should be profitable enough to absorb the surplus population of the industrial communities, many of whom were originally farmers; that the industrial cities are already choked with extra workers who have no jobs or only part time jobs, and that they cannot care for any additional unemployed; that it will save time and expense for each community to try to help work out a plan for the salvation of its own, rather than permit them to wander into other communities where they may become dependent and have to be returned home at the expense of the county of their legal residence.

A number of interesting methods employed by the welfare officers in recent months in dealing with the situation were related. For instance Mrs. Georgia Hammond, of High Point, secretary of the city welfare department, has inaugurated a card system for the use of the mill employers. Each card has the record of an employee, his length of residence in the city, the number of his dependents, the type of work he can do, and a record of his service. The employer in hiring or firing is largely guided by the information contained in the card files. Mrs. Hammond has found the system to be of inestimable value in that it enables the employer to cooperate with the welfare department in using workers who are legal residents and who have dependents that might otherwise require public support.

"Keep your people at home. We cannot absorb them. We have too many unemployed now. There are no jobs for our own people, and no hope of any work for those who do not belong to us," that is the gist of what the superintendents of public welfare in the industrial communities have had to say. They will go back to their counties to work out their problems with the people at home—and they will need the cooperation of every individual and every agency.

To be successful, the welfare officer must have the united support of the community. It is a tremendous job at best, besides an extremely interesting one. Sentiment has long given way to intelligent constructive planning. For that reason, the welfare officers always seek to reduce to a minimum the amount of giving of baskets of food, shoes and clothing he has to do, and devote as much time as possible to helping restore families to independence, preventing delinquency through the juvenile court, and restoring broken homes and home life for children.

State Senator Thomas B. Love, whose name appeared on the ballot by virtue of a Supreme court order, had attempted to introduce "Anti-Tammany" issue into the election.

Asserting she was a proxy candidate for her husband, former Governor James E. Ferguson, who was barred by a Supreme court ruling from becoming a candidate after his impeachment, other candidates conceded Mrs. Ferguson would be one of the run-off primary opponents.

United States Senator Morris Sheppard made little active campaign for re-election although opposed by two candidates.

Republicans were passive in their campaign, making no public speeches. Four candidates were in the field.

Ten of the seven Democratic seats in the lower house of Congress were contested within the party today.

Bailey Delivers Principal Address to Catawba Voters

Newton, N. C., July 26.—(AP)—Josiah William Bailey, Democratic nominee for U. S. Senate, was to deliver the keynote speech at the Catawba county Democratic convention here this afternoon.

Mr. Bailey was expected to arrive here at noon and to begin his address at two o'clock.

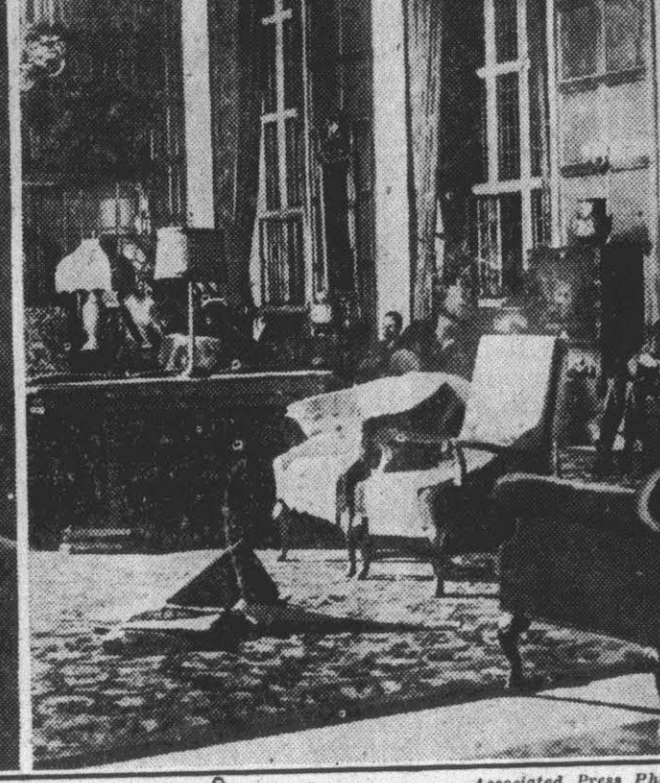
Harmony was expected by party leaders to rule the convention today. Only two office nominations, sheriff and register of deeds, are being contested.

Soviet Russia Accuses U. S. With Interfering With The Soviet Union

Government Organ Charges Violation of Elementary Requirements of International Law During Investigation of Activities of Communists

Moscow, July 26.—(AP)—Izvestia organ of the Soviet government today editorially accuses the United States government of having interfered with the internal affairs of the Soviet Union through the Fish Congressional Commission.

The newspaper charges the commission with violation of the elementary requirements of international law.

Izvestia is particularly bitter over the form of questions asked of Peter Bogdanoff, chairman of the board of Amtorg Trading Corporation, especially those relating to Amtorg's political activities and the aims of the Communist International in the United States and the actions of certain Russians.

Among these are M. Serebriakoff, who was exiled with Leon Trotsky; M. C. Gurevitch, in 1928, acting chairman of Amtorg, and a specialist in aniline chemicals; Victor Nolin, now dead, former minister of commerce in the Lenin cabinet and director of the All-Russian Co-operative Society, and M. Platakoff, noted economist and in 1926 general director of Amtorg in New York, later a foe of Stalin.

The newspaper also challenges the line of questions which sought to link Amtorg officers with the secret police.

"The anti-Soviet demonstrations" the editorial goes on, "have for their purpose the destruction of the wide economic connections between the United States and the Soviet Union. For the benefit of the small, limited interests of certain groups. Such a campaign can only lead to serious difficulties for the Soviet-American trade and serious damage to American financial and industrial interests."

London, July 26.—(AP)—George Bernard Shaw was astir early today—his 74th birthday anniversary. While most Londoners were fighting the need to arise from bed the famous Irish dramatist stepped briskly from his home in Whitehall Court and walked to the Royal Automobile Club for a swim.

On his way home he passed under a ladder, proving that he is not superstitious even on his birthday. At the Duke of York's monument Mr. Shaw spiritedly bounded up the steps leading from the mall two at a time and shortly afterward was enjoying his swim. He remained in the water half an hour.

LIST OF DEAD FROM QUAKE STILL MOUNTS

Italian People Greatly Alarmed At Continuance of Earth Shocks

Rome, July 26.—(AP)—An official recount of casualties obtained up to 8 o'clock last night was issued this morning, placing the dead from Wednesday's earthquake at 2,142 and the injured at 4,551.

Even these figures probably will be augmented, as it still is impossible to estimate the number remaining under wrecked buildings in the four devastated provinces.

The official communique accompanying the figures told how yesterday a woman and a girl who had been buried under the ruins of their house since Wednesday were finally taken out alive.

Naples, July 26.—(AP)—The Italian people, still dazed by Wednesday's severe earthquakes, are alarmed by the continuance of earth shocks and fear that even more may follow.

In the last two days there have been eight new quakes, although they did no severe damage in comparison with the mid-week tremors.

Five new shocks were felt yesterday in the same southern region stricken Wednesday. Two occurred in the morning and three in the afternoon and while no great damage or loss of life was disclosed the nervous populace was frightened.

Melfi, already torn, felt shocks especially. There many buildings weakened by the previous tremors collapsed. Among them the Palazzo palace. One wall of the jail fell and 17 prisoners attempted escape, but were held back by guards until removed to the jail at Foggia.

A shock, felt at Ariano Thursday, caused the death of an elderly woman, killed in the collapse of the registry office. Avellino also felt two shocks Thursday, but apparently no damage was done.

The quake was no respecter of persons, many mayors and their staffs being killed so that there is no one to gather the figures.

In a number of townships the records were destroyed, making an accurate roll call of the remaining inhabitants impossible, while many of those who survived fled like frightened deer to the mountains and have not been heard of since Wednesday morning.

Neapolitans today awaited a visit from King Victor Emmanuel, who yesterday made a tour by motor of the stricken areas.

The king is eager to visit this city, since he was born Prince of Naples, in 1869, but since Naples was comparatively little damaged he went through the devastated regions first. It is believed he will arrive tonight, although his exact plans are secret.

The king arrived at Rocchetta Sant'Antonio in mid-afternoon and immediately set out to comfort his grief-stricken subjects.

Through numerous hard hit townships, such as Aquilonia, Lacedonia and Melfi, he drove and surveyed the ruins of this once serene and picturesque countryside.

Most of the communities are fed on army rations. Naples military and naval officers having distributed 80,000 bread rations, 15,000 tons of meat and 11,800 rations of hard tack so far, the supplies being hauled out by motor truck.

Tree-Sitter Comes Down After Staying Aloft Over 29 Hours

John David Bridgers, son of Mr. and Mrs. S. L. Birdgers, came down from his lofty perch in a tree top today and brought to an end Greenville's first tree sitting endurance contest. He had been in the tree for a total of 29 hours and 2 seconds when he decided he had endured enough and came back to earth to join the hundreds of young admirers who have watched the contest with more than usual interest.

Young Bridgers climbed the tree yesterday morning before breakfast. He found atmospheric conditions so favorable that he decided to stay aloft and had his mother to send breakfast up to him. He had previously built a small platform in the tree top in anticipation of carrying out a "sitting" program and this served him in good stead as he set the first record of the kind in the history of Greenville.

Yesterday at the noon hour two tots of the neighborhood in the persons of Curtis Perkins, Jr., and Billy Whitehurst, climbed the tree and had their noon day meal with John David.

Scores of people have visited the Bridgers' home the last several hours to view the young sitter and he is probably the best known youngster in the city by reason of his exploit in the tree top.

Pritchard Says Prohibition Is Here to Stay

Clinton, July 26.—(AP)—(Congressman George M. Pritchard, of Asheville, Republican nominee for the U. S. Senate, pledged his support to prohibition which he said "is here to stay" in an address here today.

Speaking before the Sampson County Republican convention, the Asheville congressman asserted the "good citizens of America" would see to it that the 18th amendment was not repealed. He branded brewers, and said "even the most liquor as the 'worst of all crime hardened drinker knows the evils of alcohol and does not want this temptation placed within the reach of his children."

"In former days," he said, "women and children were the chief sufferers from the liquor evil. Wives to which they were entitled were squandered in bar rooms. Children cried for food while the father's earnings swelled the coffers of the saloon keepers."

"Prohibition has wrought a wonderful change. As a result of this great reform, savings accounts of the wage earners of America have increased many billions. Wages are now spent for homes, clothing and education. The laboring classes have automobiles, radios and countless other luxuries."

"Instead of kicks and curses, wives and children receive kind and loving treatment."

Congressman Pritchard said he had voted for the transfer of prohibition enforcement to the Department of Justice, for increased funds for enforcement and would always vote "to retain in our constitution this great moral and economic reform."
