## R-100 BEGINS FLIGHT OVER THE ATLANTIC

### World's Largest Airship Leaves Cardington, England, for Trip to Montreal

London, July 29.—(AP)—The British dirigible R-100, Canada bound, was out to sea this afternoon about 30 miles from the northwestern tip of Ireland and running into adverse winds.

The huge ship reported her position to the air ministry at 2 p. m. Greenwich Meridian time (9 a. m. EST) as at 55 10 north latitude and 9 10 west longitude.

There were low clouds and adverse winds, but otherwise everything was proceeding excellently.

The position given by the R-100 indicated that after leaving the coast of Scotland, she had skirted the northern coast of Ireland and then swung directly westward out over the Atlantic.

Cardington, Eng., July 29.—(AP)—Great Britain's gigantic airship, the R-100, today was on a 3,385 mile journey to Montreal.

The six motors were started at 3 a. m. (9 p. m., Monday EST) while the ship was tied to its mooring mast here, and soon were warmed to a smooth purr.

At 3:45 a. m. the ropes were cast off and, to the cheers of a crowd that had waited throughout the darkness, the big ship floated up gracefully and turned northward for Liverpool. A strong and cold wind was blowing.

The course was left to the discretion of the commander, Squadron Leader R. S. Booth, but in general it was to be by way of northern Ireland; to a point south of Cape Farewell, Greenland; across Labrador and then down the St. Lawrence river to St. Hubert air station at Montreal.

The first plan was to cross the Irish sea from Liverpool and fly over northern Ireland, but when the start was made it was understood that the ship would dodge Ireland because of a low pressure area there and would go by way of the Hebrides islands, which are off the bleak northwest Scottish coast.

After the airship had left a communique from the Air Ministry said that a deep depression west of the Hebrides would make it necessary for the R-100 to head for northern Ireland and then steer a northerly course so as to take advantage of east winds.

The communique said that while the general weather conditions were not unfavorable, a ridge of high pressure existed over the mid-Atlantic and the general tendency from the west side was for light southwest winds.

Under the schedule planned the airship should reach Montreal sometime early Friday morning.

Forty-four persons were aboard, among them the five officers and 32 men of the crew. The seven passengers included Major G. H. Scott, famous as an airship commander although he is not dipping "this cruise"; Lieutenant Commander Six C. Dennison Bury, director of the company which built the R-100 and Wing Commander R. B. B. Colmore, representing the Air Ministry. The others are principally observers and weather experts.

The R-100 is the largest airship in the world, even passing the famous Graf-Zeppelin. It is not so long as the Graf—709 feet compared to the German ship's 776—but is fatter and has more lifting capacity, with six motors compared to the Graf's five.

The R-100 has a cruising radius of 4,000 to 6,000 miles; a full speed of 83 miles an hour and a cruising speed of 72; capacity for 5,150,000 cubic feet of buoyant gas, and lifting power of 156 tons.

For this flight the airship carries 2,000 pounds of food, divided into three days' ordinary rations and one day's reserve ration, with an added supply for emergency. Even chewing gum, which has never obtained the foot-hold in Great Britain that it has in the United States, is included.

Meals will be served in a dining room after preparation in a small kitchen. No smoking will be permitted, as the buoyant gas is of the inflammable type.

## ASSAILANT OF GIRL HELD IN PRISON HERE

## Negro Spirited Here Following Attempted Criminal Attack Near Chocowinity

Robert Brown, negro youth, was being held in the Pitt county jail in this city today charged with an attempted criminal assault upon a 15-year-old girl near Chocowinity Sunday. The negro was brought to Greenville Sunday night by Beaufort county authorities in an effort to prevent mob violence.

A mob consisting of two or three hundred men, it was said, formed in the Chocowinity community, shortly after the crime was reported, and fear for the safety of the negro caused officers to spirit him out of the Beaufort county jail to this city. He remained in the city jail during Sunday night and was transferred to the county jail Monday.

The girl said the negro met her as she was walking along the road near her home and first asked her for road directions. She said he then seized her, ripped the clothing from her body and threw her to the ground. Her screams are said to have been heard by her grandfather and the negro fled at his approach.

The negro was arrested about an hour later and identified by the girl. In the meantime, news of the attack had spread over the countryside and the officers were forced to rush the negro out of the county to escape the vengeance of a mob of two or three hundred persons who, it was said, was bent on revenge.

Officers said the negro stoutly denied the attempted attack upon his arrival here. He has maintained an attitude of innocence ever since his confinement here, declaring that he was not the one involved in the crime.

## Mother and Son Killed in Wreck

Wilmington, July 29.—(AP)—A mother and son were dead here today and another was recovering from a fractured skull as the result of an automobile accident on highway No. 20.

Mrs. I. A. Cain, 45, of Acme, died in a hospital here last night of injuries received in the wreck. Her 10-year-old son, Jasper, died yesterday morning.

Eugene, 12, who was riding with his family, is expected to recover. Mr. Cain, a railroad agent at Acme, suffered slight injuries.

## True Bill Against Highway Officer

Monroe, July 29.—(AP)—A true bill charging K. B. Mann, state highway patrolman, with assault with a deadly weapon with intent to kill was returned today by the Union county grand jury.

Mann is alleged to have shot and wounded Floyd Helms on the Monroe-Charlotte highway on May 18. Mann will go on trial Thursday morning.

## Record Sales Reported From Several Towns With Prices Ranging All the Way From One Cent to Thirty-Five Cents a Pound; Quality Improved

Atlanta, Ga., July 29.—(AP)—Prices on Georgia's bright leaf tobacco markets on the opening day of the season today ranged between one cent and thirty-five cents per pound, with receipts in many warehouses at a record for the first day.

The State Bureau of Markets, reporting from Hazlehurst, Statesboro, and Blackshear, recorded heavy receipts with the quality good.

Hazlehurst with one warehouse had 400,000 pounds on the floor at the opening of the market with prices ranging from one to 25 cents with the average 10 and 11 cents.

Statesboro had receipts of 200,000 pounds but no sales were to take place until 2 o'clock.

Blackshear with one warehouse, had receipts of 250,000 pounds with an average of 12 1-2 cents per pound. The average price at Blackshear for the first week last year was 19 1-2 cents per pound.

Dispatches from Tifton said all three large warehouses were filled for the opening auction. Prices ranged from 2 cents to 3 cents. Most offerings today were sand lugs with better quality to be offered later.

The prices were lower than at the opening last year.

Metter reported at noon that the three warehouses there were filled to capacity with tobacco and more continued to arrive from sections north of Altamaha river.

The prices were lower than last year.

Prices opened good at both warehouses at Waycross, the larger grades, especially sand lugs, bringing exceptional prices. Planters receiving 15 to 25 cents for the lower grades were satisfied.

Fair to good quality at Thomasville brought 10 to 18 cents per pound, with a limited quantity running to 20 cents and above. Low grades, not so low as last year, brought 6 to 9 cents. The average price of all grades was 13 to 14 cents per pound.

The Douglas market, one of the big three in the state, opened with slightly more than a million pounds on the floors of the five large warehouses. The price average of eight cents was reported to be the lowest since 1921.

While the crop this year was estimated to be smaller than in 1929 when a 90,750,000 pound yield was sold for approximately \$16,700,000, growers said the leaf was of better grade and that the cash return would probably be greater.

Buyers from leading tobacco companies in the United States and other countries flocked to the Georgia tobacco belt by the score.

Sales starting today will continue until the crop is sold. The markets are closed each Saturday to permit recording of the week's sales.

There are approximately 50 warehouses in the south Georgia cities of Adel, Bainbridge, Baxley, Blackshear, Cairo, Camilla, Claxton, Fitzgerald, Douglas, Hahira, Hazlehurst, Metter, Moultrie, Nashville, Pelham, Quitman, Statesboro, Thomasville, Tifton, Valdosta, Vidalia and Waycross.

## Capital Of Hunan Area Doomed As Communists Burn Way Through City

Shanghai, July 29.—(AP)—Changsha, capital of Hunan province, apparently was doomed today as Communists burned and looted their way through the city.

The Communists, forming a force of 10,000 swarmed into the city yesterday after defeating the relatively small Nationalist guard remaining after the departure of government troops for the Honan and Shantung civil war fronts.

Warned of renewed Communist activities, American, British and Japanese authorities had sent river gunboats to Changsha to protect their nationals. Foreigners hastily boarded the vessels.

Changsha is a silk manufacturing center and the nearby territory produces metals. The city is surrounded by a wall twelve miles long and is famous for having withstood along of all the cities of south China, the siege of the Taipang rebels more than three score years ago. In recent years it has gained a reputation for the cleanliness of its streets, a rare thing in these Chinese cities, and for other progressive features.

Yale College in China is located at Changsha.

Foreign gunboats were forced to withdraw from the city due to the lowering of the river level. Foreign property worth millions of dollars thus was left at the mercy of the Reds. Burning and looting was going on unrestrained.

The majority of the foreigners left the city, having boarded warships in the Siang river. A report yesterday however, said three American missionaries had remained in the walled city, which has a native population of about 500,000.

Davidson, N. C., July 29.—(AP)—No word has been received from Dr. W. H. Lingle, Presbyterian missionary in China, since May 8, his brother, Dr. T. W. Lingle, Davidson college professor, said today.

Dr. Lingle said the Associated Press reports that his brother was in the hands of marauding Chinese Communists was his first information to that effect.

A native of Rowan county, North Carolina, Dr. W. H. Lingle has been in the Chinese mission field since 1890. His wife, the former Jean Richie of Ohio, is with him. Of his two married daughters, one is in the United States and another on route to this country.

Another brother of the missionary, Dr. Walter L. Lingle, is president of Davidson college, Presbyterian institution here.

J. Marvin Pruitt, 34, of Greenville, was also killed. Dalton Hall, 25, of Greenville, and Miss Zella Austin, formerly of Anderson, but now living in Greenville, were injured.

Hall was unconscious this morning and Miss Austin refused to give any information about the unidentified woman. She was questioned last night and again today, but declined to say whether she knew the woman's name.

The four were riding in an automobile which overturned on the Anderson-Williamston road 6 miles from here.

## Pitt Commissioners Fix New Tax Rate At \$1.35 At Special Session Here

### Rate Is Based On An Estimated Valuation of \$44,000,000; Increase of Six Cents Over Previous Year Caused By Injunction Restraining Road Tax Collection

The tax rate for Pitt county during the present fiscal year will be \$1.35 on the \$100 valuation. The rate is based on an estimated valuation of \$44,000,000.

The new rate was announced following a special meeting of the Board of County Commissioners held in this city yesterday.

The new rate, it was stated, is six cents higher than the rate for the previous year. The raise was made necessary by a court order restraining the county commissioners from levying or collecting a special sale tax for road duty in several townships of the county. The order was signed by Judge M. V. Barnhill of Rocky Mount.

The values in the county it was explained, have been reduced by one million dollars since the 1929 levy was made. The loss in revenue experienced by the county as result of the restraining order is given as approximately \$25,000.

Members of the board pointed out that the county must set up this year several thousands of dollars on account of revaluation and to bear the expense of the elections as this is election year.

According to estimates made public yesterday, uncollected taxes for the last year after deducting the insolvent list and the amount from which cannot be collected on account of the restraining order will be in the neighborhood of \$170,000.

## CONSERVATIVE PARTY WINS OUT IN CANADA

### Liberal Government of McKenzie King Overthrown in General Election

Ottawa, Ont., July 29.—(AP)—After 12 years in power the Liberal government of W. L. Mackenzie King has been overthrown. The Conservative party, headed by Richard Bedford Bennett, won a majority of seats in the House of Commons in yesterday's general election.

When Mackenzie King submits his resignation to the governor general, the Prime Minister will be Bennett, a lawyer who has practiced for years in Calgary and was born and educated in Nova Scotia. He has been Conservative leader three years. He is 60 years old and wealthy. The time of the change is not definite as an outgoing ministry is given opportunity to adjust its affairs.

Victory for the Conservatives, traditional proponents of a high protective tariff, was forecast early by an almost unprecedented upset in Quebec, Liberal stronghold. There they gained 20 seats, increasing the four Quebec seats they held in the last Parliament to 24, and defeated two Liberal ministers.

Bennett won an easy victory in his constituency in Calgary, Alberta. Mackenzie King fought an uphill battle against his Conservative opponent in Prince Albert, Sask., and won.

Five Liberal ministers were defeated: Charles Dunning, Minister of Finance, whose last budget included tariff reprisals against the United States; T. A. Crerar, Minister of Fisheries, and W. F. Kay, Minister with Portfolio.

Ten women sought seats, but Agnes C. MacPhail, the first woman to enter Canada's House of Commons, alone was elected. She has held her district since 1921.

In the campaign the Conservatives attacked the countervailing duties against the United States imposed by the Dunning budget on the grounds they were not sufficiently retaliatory against the new United States tariff.

Injection of the unemployment issue by Bennett's promise of a special session aroused widespread interest among the voters.

Mr. Griffin has been living in Greenville for a year and is now employed as chef at the Greenville Rotary club.

## SEVERAL MEN DIE AS BOAT SINKS IN PA.

### Six Members of Crew of Stoneboat George J. Whelen Rescued As Boat Goes Down

Erie, Pa., July 29.—(AP)—Fifteen members of the crew of 21 of the Thomas J. Whelen, a boat engaged in drawing sand from Lake Erie, were drowned today. The vessel turned over off Dunkirk, N. Y.

The other six members of the crew were rescued and brought here aboard the Steamer Amasa Stone, bound here from Buffalo, N. Y. They said their craft turned over in about 190 feet of water without warning and floated for half an hour. Some of the men clung to the wreck before it sank.

Erie, Pa., July 29.—(AP)—The stoneboat George J. Whelen foundered in Lake Erie today, carrying fifteen of her crew down with her. Six seamen were saved.

The ship turned over, apparently with little warning, six miles off Dunkirk, N. Y. at 12:30 a. m. (EST). The crew of the steamer Amasa Stone, of the Pickands-Mather fleet, picked up six members of the Whelen's crew and brought them to port here with the first word of the sinking.

Captain W. H. McNeil of the Amasa Stone said he heard the cries of several men in the water. He was able to find and save six.

The men were found floating in Lake Erie. They were wearing life preservers Coastguard cutters 164, 197 and 107 were sent from Buffalo to the scene of the wreck to aid in the search for other possible survivors.

The Whelen was understood to have headed for Buffalo last night. Meanwhile a severe electrical storm has swept the eastern end of Lake Erie.

Lake sailors today recalled that three years ago a sand freighter broke in two during a storm at about the location where the men were picked up this morning. Six of its crew were drowned.

Cleveland, Ohio, July 29.—(AP)—Officials of the Kelly Island Line & Transport Company, said this sand-sucker Whelen was enroute from Sandusky, Ohio, to Tonawanda, N. Y., at the time of the reported foundering. It was commanded by Captain Tom Waggay and had a crew of about 18 men. The Whelen is a 200-foot steamboat and was considered seaworthy.

## Radio Suits Are Drawing Attention

Washington, July 29.—(AP)—The Radio Commission is watching closely the three suits instituted by the Radio Manufacturers Association of New York in the Federal courts challenging the constitutionality of the South Carolina receiving set tax.

Duke M. Patrick, assistant general counsel of the commission, said the suits attacked the tax as an alleged interference with interstate commerce. He declined to comment on the merits of the case.

About 50,000 receiving sets owners would be affected by the tax which ranges from 50c on sets costing \$50, or less, to \$2.50 on those valued at \$500 or more.

The plaintiffs, including station WBT of Charlotte, N. C., and the Louis D. Rubin Electrical Co. of Charleston, S. C., in addition to the Radio Manufacturers Association, contended radio broadcasting was subject only to federal regulation.

## STATE LICENSING HELPS.

Does a State drivers' license law help check automobile accidents? Otto G. Fifield, Secretary of State in Indiana, says that it does. While the drivers' license law has been in force less than a year in Indiana, Mr. Fifield declares that "good results" are being realized. The Indiana law provides that, for cause, the license granted by the State shall be revoked and about one thousand drivers' licenses were revoked in Indiana in the first year of the law.

The law is being enforced, says Mr. Fifield, "and it will continue to be enforced with greater severity. Because of rigid enforcement instead of there being a greater number of revocations there will be a less number." No legislation can prevent accidents on the highways but the testimony from many quarters is that the licensing of drivers by the State, accompanied by the revocation by the State of such licenses where the privilege of using the highways is abused, helps greatly to reduce the number of automobile fatalities.—Asheville Citizen.

## ABOUT TOWN

With automobile thefts becoming more widespread in this community, it is incumbent upon the public to observe more care when parking their cars. Right recently several automobiles have disappeared from the streets of the city, and a thief more bold than others, actually went into a garage of a resident, and made away with his car. This is a situation that not only demands the attention of the police but also the automobile owner. Automobiles are valuable property, in that several hundreds of dollars are involved in each piece of property of this kind. The car owner should make it a habit to lock his switch every time he leaves his car. This will make it impossible for a thief to move a car from a thickly populated section without attracting more than ordinary attention. It is a caution that should result in the saving of thousands of dollars worth of property with the passing of each month in addition to helping break up the activities of the thieves. Automobile accidents on the public highways of this state over the week-end indicate in a forceful way the danger involved in the operation of such machines. It brings home to us the fact that people are not yet as careful as they should be in the handling of cars, and the necessity for more drastic action in the enforcement of traffic regulations. The life of the careful driver is imperiled by the man who gives little thought to his own safety and the safety of hundreds of other people along the highways. The man that drives at a reckless rate of speed takes his own life in his hands. He never knows what time something is going to happen to his car that will cost him his life, and probably the lives of others, and this one fact should cause him to do everything possible to drive as

carefully as possible at all times. It is too late to think about what might have been done after life is extinct or some human being is writhing in mortal agony. The time to act is before the tragedy, and that time is the present—right at this moment.

This fact is gradually being impressed upon the minds of the public by statements from leading business men from other sections of the country who have begun investing here. When people begin talking like that it is bound to have an impression on the minds of those on the outside. 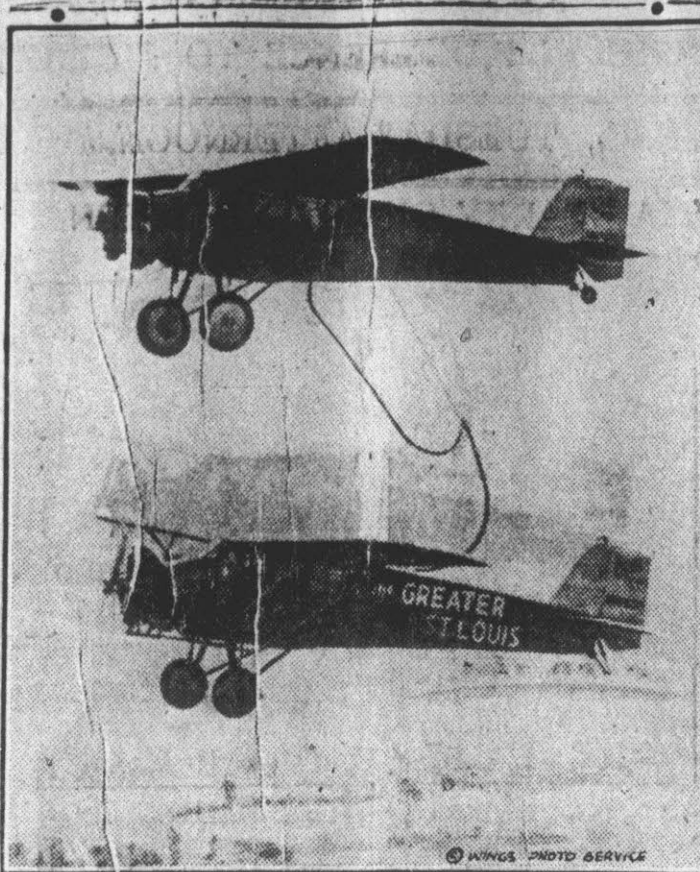

INVISIBLE BARRIERS SURROUND THE PACIFIC

Washington, July 29.—(AP)—An invisible fence, barring the wanderings of denizens of the ocean's depths, has been found stretching east and west across the Pacific.

A belt of oxygenless water beginning three hundred feet below the surface, reaching downward for a thousand feet and exceeding one hundred miles in width, was one of the most interesting finds of the non-magnetic ship Carnegie before it was destroyed by fire at Samoa last year.

The discovery has just been made public by O. W. Torrosson, navigator and executive officer of the ship which cruised up and down the Pacific ocean in search of scientific knowledge.

All creatures of the ocean need oxygen. Torrosson points out, and this curious stratum of water which does not carry that essential element must prove an effective barrier to living things. The scientist did not attempt an explanation of the peculiar phenomenon, nor did he draw conclusions as to its effects beyond pointing out that "the fishes and other creatures in the oceans are part of man's food supply and anything which affects them is, therefore, important to us."

# LUCAS SLATED TO LEAD THE G. O. P. FIGHT

## Indications Current That No Successor to Huston Will Be Elected in Months

Washington, July 29.—Although Claudius H. Huston is to retire as leader of the Republican national committee on August 7, indications were current today that his successor would not be selected for some months.

In the meantime, Robert Lucas of Kentucky, who became commissioner of internal revenue several months ago, is slated to take over the active campaign for the approaching congressional elections as chairman of the executive committee of the party, a post which Mr. Huston holds ex-officio in addition to his chairmanship of the major committee.

The change in the original plan of procedure under which Senator Fess of Ohio, the personal choice of President Hoover, would have been elected at the meeting of the executive committee August 7 to succeed Mr. Huston followed a determination by party leaders that the executive committee is not empowered to elect a chairman of the national committee. This, the high command of the party now holds, can be done only by the entire committee.

Although in March, 1929, the executive committee was authorized by the major committee to fill vacancies, a precedent for the present attitude has been found in the circumstances surrounding the retirement of Dr. Hubert Work as chairman.

Dr. Work announced during the summer of 1929 that he would resign, but his resignation was not accepted and Mr. Huston elected until September, when the entire committee was called together for the purpose. The by-laws change is interpreted as applying only to filling vacancies in the committee's personnel.

The present alignment under which Mr. Lucas would carry on the congressional campaign and the election of Mr. Huston's successor would be delayed has the approval of President Hoover, it was said, and has been endorsed generally by party leaders who have studied the question of the executive committee jurisdiction.

Some opposition to the choice of Senator Fess has been reported since his powerful support for the post became apparent. The decision to delay his election has met with the approval of some who are desirous of avoiding further conflict within the party.

Party leaders predicted that today's vote would reach 325,000 because of the big field of candidates and the political pyrotechnics which accompanied the campaign.

The accusation of excessive expenditures entered the campaign when Woodson E. Norvell twice unsuccessfully sought to bar his millionaire opponent in the senatorial race, Charles J. Wrightman, Tulsa oil man.

Campaign managers said the number of candidates for the two principal offices precluded the possibility of any one receiving a majority, which would necessitate a run-off primary August 12, an innovation for Oklahoma.

Chief among the nine Democratic aspirants for the gubernatorial nomination were W. H. "Alfalfa Bill" Murry, constitutional author and founder of an ill-fated colony of American farmers on a 50,000-acre tract in Bolivia; Frank Buttram, Oklahoma City civic leader and millionaire; E. B. Howard, Tulsa, Judge Frank Bailey, Chickasha, A. S. J. Sham, state auditor and M. E. Trapp, former governor.

Henry S. Johnson, ousted as governor on charges of incompetence, campaigning for vindication, assailed bitterly his nine opponents for the senatorial nomination, which include Charles J. Wrightman of Tulsa, Lee Cruce, and J. B. A. Robertson, both former governors. T. P. Gore, a blind former senator and Mrs. Kathryn Van Leuven, assistant attorney general.

Winston-Salem, N. C.—(AP)—C. P. Johnson and George Wall were convicted here of operating a lottery. Johnson was fined \$500 and given a six months sentence. Wall was fined \$100 and given a 12-month suspended sentence.

# OKLAHOMA TO RAIN BRINGS STAGE BALLOT BATTLE TODAY END TO HIGH HEAT WAVE

## State to Nominate Candidates for Governor and the United States Senate

Oklahoma City, July 29.—(AP)—Voters of politically turbulent Oklahoma were offered slates of candidates including two impeached governors, two oil millionaires, a woman and a blind former senator from which to select senatorial and gubernatorial nominees at the primaries today.

Party leaders predicted that today's vote would reach 325,000 because of the big field of candidates and the political pyrotechnics which accompanied the campaign.

The accusation of excessive expenditures entered the campaign when Woodson E. Norvell twice unsuccessfully sought to bar his millionaire opponent in the senatorial race, Charles J. Wrightman, Tulsa oil man.

Campaign managers said the number of candidates for the two principal offices precluded the possibility of any one receiving a majority, which would necessitate a run-off primary August 12, an innovation for Oklahoma.

Chief among the nine Democratic aspirants for the gubernatorial nomination were W. H. "Alfalfa Bill" Murry, constitutional author and founder of an ill-fated colony of American farmers on a 50,000-acre tract in Bolivia; Frank Buttram, Oklahoma City civic leader and millionaire; E. B. Howard, Tulsa, Judge Frank Bailey, Chickasha, A. S. J. Sham, state auditor and M. E. Trapp, former governor.

Henry S. Johnson, ousted as governor on charges of incompetence, campaigning for vindication, assailed bitterly his nine opponents for the senatorial nomination, which include Charles J. Wrightman of Tulsa, Lee Cruce, and J. B. A. Robertson, both former governors. T. P. Gore, a blind former senator and Mrs. Kathryn Van Leuven, assistant attorney general.

Winston-Salem, N. C.—(AP)—C. P. Johnson and George Wall were convicted here of operating a lottery. Johnson was fined \$500 and given a six months sentence. Wall was fined \$100 and given a 12-month suspended sentence.

## File Suit Against Hospital In Baby Case At Chicago

Chicago, July 29.—(AP)—The baby boy in the William Watkins home today became "John Doe."

As the infant's "best friend," Mrs. Grace Dibrell, a prominent club-woman, authorized Attorney Barratt O'Hara, counsel for the Watkins family, to file today a \$100,000 suit for "lost identity" damages against the staff of the Englewood hospital, where the Watkins and Charles Bamberger babies were born June 30.

The baby who alleges "he does not know who he is," will seek in the suit to learn if he is rightfully Charles Evans Watkins or George Edward Bamberger, the boy baptized Sunday as the Bamberger's son.

Attorney O'Hara disclosed that another suit, for \$100,000 damages for "mental anguish" would be filed soon by Mr. and Mrs. Watkins against the hospital.

In the trial of the suit, O'Hara said, the findings of the scientists and medical men summoned by Health Commissioner Arpold H. Kegel would probably be offered as evidence.

These findings would convince Mr. and Mrs. Bamberger, if they would study them, that they have the infant really born to Mrs. Watkins. Dr. Kegel said after declaring that Bamberger had refused to read the findings.

Mrs. Dibrell, head of the mothers of Illinois, a group formed after the baby mixup, said a mass meeting of "mothers, prospective mothers and prospective brides" would be held Thursday to discuss means of thwarting another such maternity ward tangle.

# STOCK MARKET

New York, July 29.—(AP)—The bulls fortified themselves behind important industrial and utility shares, while bears played havoc in today's stock market in the merchandising and rail issues.

Losses in most of the pivotal issues were held to a point or two, but among the carrier, chain store and specialty issues, there were numerous breaks of several points.

Trading was light, and it was estimated in commission house circles that as much as 75 per cent of the business was for the personal accounts of floor traders.

Most important banking interests appear to regard these hand-made fluctuations of the market as inconsequential.

On the whole, the days news favored the bear cause.

Speculators for the decline were quick to place an unfavorable interpretation on the victory of the high tariff party in Canada, estimating that retaliatory schedules may reduce our export trade to the extent of a few hundred millions annually. Also, Amtorg's threats to take its business elsewhere held a prospect of a further reduction of \$100,000,000 or more.

Much of the selling of the merchandising shares was evidently based on the New York Federal Reserve's estimate showing a drop of 21 per cent in wholesale business in this district in June, but wholesalers point out that they have slashed prices drastically since May and that the reduction in the actual volume of goods from June of last year was probably not more than 10 per cent.

The fact that the first 60 roads reporting June net not only showed a drop of about 34 per cent from June, 1929, but more than 1 per cent from 1928, accounted for heavy selling of the carried issues. A few earnings statements which Wall Street was glad to have out of the way made their appearance. As expected, reports of Southern Railway and National Cash Register showed dividends unearned. On the whole, however, earnings statements have not been as bad as anticipated.

General Motors was well supported, selling fractionally higher, and duPont, which has a 23 per cent interest in it, sold up 3 points for a time. Losses in Radio, U. S. Steel and General Electric were held to narrow margins.

# STIRBLING KNOCKS OUT PHIL SCOTT

London, July 29.—(AP)—W. L. (Young) Stribling has tossed aside the caution that used to mar his efforts in the ring and smashed his way once more into the forefront of challengers for the heavyweight championship.

Just five weeks after his sensational one-round knockout of Otto Von Porat, lantern-jawed Norwegian, Stribling stormed through the weak defenses of Phil Scott, English champion, in Wimbledon stadium last night, felled the London fireman four times in the first round and knocked him out in the second.

A crowd of 35,000 roared approval of the Georgian's ferocious attack and jeered their fallen champion as the final count of ten found him sitting on the floor of the ring and vainly trying to get to his feet.

Stribling had been a heavy favorite to win but few had expected the Macon heavyweight to turn in so workman-like a job of it. The American leaped to the attack with the first bell, never gave Scott a chance to make use of his undoubted boxing skill, flailed away at the Briton's body with an educated left hand and had him groggy and staggering almost before the bout had started.

"Pitiful," "disgusting," "humiliating," the press called the bout today, making no attempt to vindicate Scott. "He was outclassed, outboxed and outpunched," said Sporting Life's expert who added that Stribling was the "best and cleverest" heavyweight in the world not excepting Schmeling.

Among the stinging comments on Scott's schooling was the following from the Express:
