PRES. HOOVER PLEDGES HELP TO DRY AREAS

Says No Stone Will Be Left Unturned to Relieve Distress in Drought Areas

Washington, Aug. 5.—(AP)—President Hoover announced today no stone would be left unturned by the government in its efforts to assist in relieving distress caused by the unprecedented drought.

The seriousness of the situation in a wide area east of the Mississippi and in the middle west has been the subject of conferences between Mr. Hoover and Secretary Hyde.

The result was to order a detailed survey made by the Department of Agriculture which will have a report next Monday.

President Hoover in his statement said:

"The drought situation has been the subject of several conferences between Secretary Hyde, Chairman Legge and myself. The Department of Agriculture has undertaken a detailed survey of the situation. They will report next Monday upon the condition in each area in the country. The information so far indicates great variation in the effect of the drought, both as between states, and even between farms in the same counties.

"There can be no doubt, as to its most serious character in many localities, and that unless relieved there will be real suffering. The maximum intensity seems to lie in a belt roughly following the Potomac, the Ohio, and the Mississippi rivers.

"The measures of assistance that the Farm Board and the other agencies of the federal government can and should undertake are being determined.

"It is evident already that large areas of feed movement to the livestock in the drought areas or movement of animals out of the worst areas will need be undertaken later in the fall. It is too early to determine the precise character of relief; much depends upon how far the spread of the drought; but no stone will be left unturned by the federal government in giving assistance to local authorities. I have asked the railways to investigate the situation from a transportation point of view."

Washington, Aug. 5.—(AP)—The monotony of weather forecasts predicting no let up in the almost unprecedented drought which has baked vast agricultural regions between the Rocky Mountains and the Appalachian continued unbroken today.

Aside from light and scattered showers there was no prospect for general rain throughout the parched belt for at least 24 hours more.

As weather bureau officials watched the drought their reports showed only the lightest rain and continued high temperatures in the drought area for the past 24 hours.

No general rains were forecast although there were prospects for light showers today (North Dakota, Missouri, Kansas, Indiana, Illinois, Ohio, and Kentucky).

Somewhat cooler weather was predicted for the central portions of Indiana and Illinois and for North and South Dakota.

Official Washington was viewing the drought with concern. President Hoover has been informed by Louis J. Tabor, master of the National Grange, that unless sufficient rain comes within 10 to 30 days the drought will be a "major catastrophe."

GOV. GARDNER SEES SPECIAL OFF AT SELMA

Declares War On Scrub Cattle As the Livestock Train Begins Tour of State

Selma, Aug. 5.—(AP)—Gov. O. M. Gardner, speaking to 1,000 farmers and farmwomen here today as the "North Carolina livestock development" special train started a three weeks tour of the state, declared "one pure-bred bull is worth more than any county commissioner I ever saw or any four or five governors."

Governor Gardner, calling on the people of Johnston county and the state to aid him in bringing prosperity and happiness to the farming people of the state, "declared war" on scrub cattle and scrub people.

"Scrub cattle in North Carolina have done more harm than all the boll weevils and are greater than all the pests.

"A scrub is a person, animal or plant that has no ancestors and should not have any offspring. The scrub should be the first thing to go in Eastern North Carolina. It must go and be replaced with pure-bred stock.

"A person cannot live with scrub by cattle or scrubby people without becoming scrubby and therefore all scrubby persons must be eliminated."

Pointing out that Johnston county had as fertile land as any county in the state, Governor Gardner deplored the fact that there were only 3,500 cows in the county, one to every 16 persons and one to every two and a half farms.

He declared the county could never be prosperous, free of pellagra and healthful without any adequate supply of milk from healthy, pure-bred cows.

He said he was anxious to see happy and prosperous farm people in North Carolina and asked the people of Johnston county to join him in furthering the four main points of his "live-at-home" program which he outlined as being: Elimination of scrub cattle; statewide use of pure-bred seed; improvement of the agricultural home life; and launching of a movement to rid the state of scrub people.

He advised the farmers to quit putting their energies to production of cotton and tobacco and supplement their crops with livestock, continuing some production of the "cash" crops, however, as a method of diversification.

Unprecedented Situation Created in the County By Inability of Commissioners to Dispose of \$250,000 Worth of Notes in the Face of Pending Litigation

Pitt county employees yesterday faced their first payless pay day, and it was indicated today that they might go without pay indefinitely—or at least until pending court action to restrain the sale of \$250,000 worth of notes could be finally settled.

Coinciding with inability of the county to meet its debts, the Pitt County Highway Commission announced suspension of road work in every section of the county. Workmen of all units were laid off indefinitely, and convicts were sent back to camp to remain there until some action has been taken as to their disposition.

All county offices, however, remained open today and business was being continued as if nothing had happened. Yet, the shortage of funds to carry on the various departments of government was being felt most keenly, and the officers experienced a feeling of insecurity as they delved down into the coffers to find them empty.

The financial dilemma was brought about by court action seeking to restrain the sale of \$250,000 worth of notes. Although there are two separate actions awaiting ruling before the next term of Supreme court, the one which actually was instituted several days ago by S. I. Dudley, who was nominated to the Board of County Commissioners in the last primary, Dudley, representing other citizens, as the complainant stated, asked Judge R. A. Nunn of New Bern to sign an injunction restraining the commissioners from selling the bonds. But Judge Nunn refused to do so. Dudley then filed notice of appeal to Supreme court.

The Board of Commissioners previously had arranged for the sale of the bonds at one of the best prices reported in history of the county, but when they met yesterday to pay bills and settle other matters coming up at the first meeting of the month, they were advised that the bond attorney had refused to confirm the sale in the face of the pending litigation.

This left the commissioners in one of the most precarious situations in history of the county, and after handling a few minor matters awaiting consideration members of the board returned to their respective homes to mark time and await some change in the financial status of the county.

Previous to this action, the commissioners had been confronted by two other injunctions, one affecting the sale of \$100,000 worth of notes and the other attempting to restrain the collection of a road tax in several townships of the county. The first case was brought by S. T. Hooker and others, and the second by Dr. Grady Dixon, of Ayden. Both of these cases are now hanging fire, which with the one brought by Dudley produces one of the most extraordinary situations in the annals of the county government.

County employees were reticent today regarding the outcome of the situation. Nobody could say with any degree of accuracy when the middle would be settled. It may be closed within the next few days or it may hang over the next session of Supreme court in September. There was some talk of calling on the governor to speed up court action, but this was nothing more than pure speculation today.

The members of the Board of Commissioners refused to discuss the situation. If they have any new move up their sleeves, they did not divulge it during deliberations yesterday. They realize the situation is critical, but they have adopted a policy of silence until things have been ironed out and the coffers of the county again jingle with ready cash.

The shortcomings of Greenville merchants were presented in a plain and convincing way at the courthouse last night by Howard J. Wisehaupt, of Cleveland, Ohio, noted business analyst, who has come to Greenville to show the business realm how to get out of the "dumps." He declared that too much pessimism prevailed at this time and that the section would never be able to develop as it should until the merchants got rid of wry smiles, hopeless expressions and general lassitude and bucked the line hard to realize the opportunities which the future holds for them.

Mr. Wisehaupt spoke under the auspices of the Greenville Merchants Association. He will deliver another lecture at the courthouse tonight at 8:15. While here he will also conduct a school of salesmanship, giving employees of the various business establishments of the city an opportunity of improving themselves and to render better service to their employers.

Speaking on the subject, "Success or Failure," the Cleveland man confined his talk largely to a discussion of general business conditions throughout the country and their relation to Greenville and this part of the state. He also gave an insight into the type of business necessary to meet the demands of the future, and produced many a laugh with shafts of sarcasm directed at the merchants affected with the "stiffs" and too

Voters Of Four States To Choose Candidates For November Election

Virginia, Kentucky, Missouri, and Kansas Ballot Today for Governors and Members of Congress; Wet and Dry Issue Features Virginia Primary

Richmond, Va., Aug. 5.—(AP)—A wet-dry issue in the eighth congressional district and an argument over party loyalty in the fifth were expected to bring a larger than usual number of voters to the polls today in those areas for the Democratic primary.

Only three congressmen will be nominated by the party today. Senator Carter Glass, of Lynchburg, who comes up for re-election this year, was unopposed within the party, and five Democratic incumbent congressmen also have no primary opposition.

In the ninth district, the home district of Bascom Sloop, Republican national executive committee man from Virginia, John W. Flanagan, was nominated in convention in May. In the seventh, John W. Fishburne, a former Circuit court judge, was declared nominated by the district executive committee when no opposition developed for the primary.

In the second district, where the third of the races is taking place today, little interest has been manifested.

Five persons are seeking the seat vacated by Congressman R. Walton Moore, in the eighth. Senator Frank L. Ball, declared by the Anti-Saloon league to be "satisfactory," is the only one of the group that came out in the campaign on a strictly dry platform. The others were Howard W. Smith, a former Circuit court judge, Thomas R. Keith, law partner of the retiring congressman, Randall Mackey and E. E. DeJarnette. Party leaders predicted a heavy vote in the district.

GEN. M'ARTHUR MADE CHIEF OF ARMY STAFF

Brilliant Military Leader Appointed to Succeed General Summerall

Washington, Aug. 5.—(AP)—Major Gen. Douglas MacArthur today was appointed chief of staff of the army by President Hoover succeeding Gen. Charles P. Summerall.

President Hoover said it gave him great pleasure to promote so brilliant a soldier to the position upon the retirement of General Summerall.

The Chief Executive acted upon the recommendation of Secretary Hurley in promoting General MacArthur over other major generals who outranked him.

General MacArthur was recently ordered to command the Ninth Corps Area with headquarters at San Francisco. He had been in command of the Philippine department.

He will assume his new duties upon the retirement of General C. P. Summerall, November 20.

While the new chief of staff is seventh on the list of major generals eligible for the post, he is the ranking officer who can spend the entire four years in the position without having to retire for age. He was born in Little Rock, Ark., January 26, 1880 and was appointed to West Point from Wisconsin in 1899, graduating at the head of his class. He entered the engineering corps. For five years he served in engineering work and later as aide to the President.

From 1908 to 1917 he was assigned to various instruction duties and was assistant to the engineer officer in 1914.

From the outbreak of the World war, MacArthur's rise in rank was rapid. In 1917 he became a colonel of infantry and a year later a brigadier general. He commanded the 84th infantry brigade of the Forty Second Division at St. Mihiel and in the Meuse-Argonne offensives. He was twice wounded.

SAYS SOUTH OFF OF ISMS OF ANY KIND

President of Manufacturers Says Section Will Never Turn to Socialism

University, Va., Aug. 5.—(AP)—The south will never turn to Communism or Socialism in the opinion of John E. Edgerton, president of the National Association of Manufacturers and a speaker at the Institute of Public Affairs here today.

Mr. Edgerton and Franklin W. Walton, Jr., a Washington representative of the Baltimore Sun were speakers on this morning's program. Former Governor Frank O. Lowden, will deliver the principal address at the general meeting of the institute tonight.

Round tables and open forums of the institute went into full swing today after formal opening last night by Governor Pollard. Dr. Edgerton, an Alderman-president of the University, and Dr. Charles G. Maphis, director of the institute.

Edgerton's subject was "A Labor Policy for the South."

"If I know the south as well as I think I do," he said, "it is not for a long time at least, going to tolerate Communism, Socialism, or other 'isms' of varying hues parading in different disguises which conflict with American institutions and those eternal principals or rights upon which they are founded."

He said freedom in the matter of employment was the principal reason for American industrial supremacy and the south must continue "open shop" to have permanent prosperity.

Mr. Walton, who visited Haiti with the Forbes commission last winter, discussed the United States policy in that island republic.

Without criticizing the United States' motives in Haitian intervention, Mr. Walton said it had discouraged rather than aided in self-government in Haiti.

Of three reasons offered for the American occupation of the little republic after the assassination of President Samin 1915, Walton said only on the grounds of safeguarding the Panama Canal was this country justified in its action. The other two reasons offered at the time were to protect Americans, and for the sake of humanitarianism.

Low Prices Prevail On Opening Sales Of S. C. Tobacco Market Today

Early Reports From Border Markets Indicate That Sales Will Be Around Two Thirds What They Were Last Year; Average From 10 to 12 Cents a Pound

Raleigh, Aug. 5.—(AP)—Tobacco growers of North Carolina who sold their tobacco on the warehouse floors of seven border markets of the South Carolina belt in opening sales today appeared this afternoon to have received an average price of about four or five cents a pound below the price the first day last year.

Unofficial and incomplete reports from the border markets this afternoon indicated that the average price received run from nine to eleven or twelve cents a pound. Last year the border markets averaged from 143 to 18 cents a pound on opening day.

Offerings today totalled slightly over 1,000,000 pounds, according to estimates, and last year they ran over 1,500,000 pounds.

Lumberton reported that some baskets of better grade leaf sold as high as 40 cents a pound. Sales there totalled about 250,000 pounds, compared to 300,000 last year. The average today was about ten cents a pound, compared to 15.4 last year. Most of the sellers were accepting the price.

Tabor had 75,000 pounds today with the average apparently below ten cents. Sellers expressed dissatisfaction. Last year Tabor had 125,000 pounds with an average of about 14 cents.

Clarkton had 80,000 pounds today, compared to 60,000 last year. The average appeared to be ten cents, compared to 16.9 cents last year.

Whiteville reported 300,000 sold today for about 11 or 12 cents per pound average, compared to 350,000 last year at 14.3 cents average.

Fair Bluff had about 70,000 pounds today which sold for an average of about 11 cents. Farmers expressed dissatisfaction. Last year the market had 100,000 pounds which sold for about 14 cents.

Chadbourne today reported sales estimated at about 200,000 pounds, about the same as last year, with the price running very low for common grades and fairly good for better tobacco. It appeared the average would be about 10 or 12 cents. Sales will not be completed until late this afternoon. Last year the average was about 14 cents.

Columbia, S. C., Aug. 5.—(AP)—The late season and fright at the low prices paid Georgia tobacco growers conspired today to give the South Carolina warehouses their lightest opening day in recent years.

Early reports from the state's tobacco belt indicated that the offerings today will probably be around two-thirds what they were last year.

Prices paid, while lower, were said by farmers to be better than expected. The prevailing average seemed to be from 10 to 13 cents.

Mullins, the largest market in the state, reported approximately 350,000 pounds offered today as compared with 700,000 offered on the opening date last year. Observers hesitated to make an estimate on the average price but said indications were it might run in the neighborhood of 11 cents.

Lake City, the second largest market, reported from 350,000 to 400,000 pounds offered for sale at an average of approximately 11 cents.

Loris offerings were said to be bringing a 12 to 14 cent average, with 100,000 pounds on the independent floors.

At Kingstree, the amount offered was somewhat less than last year's 250,000 pounds, and the average price was estimated at around 10 cents.

Darlington farmers, offering 85,000 pounds, were said to be satisfied with the 11-cent average for the secondary grades being offered.

Atlanta, Ga., Aug. 5.—(AP)—Eugene Talmadge, state commissioner of agriculture, today advised Georgia tobacco growers to take their crops to the North Carolina and South Carolina markets unless the prices improve.

He also suggested that growers pay more attention to curing and grading, but urged them not to "give away your tobacco at the present prices."

"Store it," he said, "and unless the prices improve, load it on a truck and take it to the Carolina markets."

He said he expected the Carolina crops to be short because of a

PREDICTS LAW TO CURB FUNDS FOR CAMPAIGN

Senator Nye Predicts Campaign Funds Committee Will Recommend Action

Washington, Aug. 5.—(AP)—Recommendations by the Senate campaign funds committee for federal legislation to curb campaign expenditures were predicted today by Chairman Nye as a result of the investigations the committee is carrying on in several states.

The legislation, he believed, will be urged in the committee's first report on these investigations.

A constitutional amendment to empower Congress to legislate on the nomination or election of candidates for the offices of Senator and Representative, President and Vice-President, is contemplated in the program the North Dakotan is preparing to submit.

Nye said he expected other members of the committee to join him in active sponsorship of such legislation. Several already have expressed privately the conviction that Congressional action should follow their inquiries.

"By the time Congress comes back," he said, "we will have figures on the costs of primary and general election campaigns in 34 states—with a showing of a single campaign at the price of perhaps a million dollars, and of another at as little, probably, as \$500. The inescapable conclusion is that legislation is necessary."

A legislative program proposed more than a year ago by Senator Bronson Cutting, New Mexico, Republican, designed to curb the high cost of election, has been brought to light again by Senator Nye. He took it for study from the files of the Senate Judiciary committee, where it has rested since Cutting introduced it.

Senator Cutting's secretary said today the New Mexican would join in an active campaign for early action on some such legislation.

Nye is working on a plan involving legislation to provide that each state set the time limit of election expenditures, and pay these expenses in final primaries.

"This would mean preliminary primaries, to eliminate candidates who came in merely because of the freedom to do so they would have under such a system," he continued.

"If the state set the limit, knowing the state would bear the expense, it seems to me the legislators could be depended upon to keep them down. It seems to me that would prevent translation into actuality of the aphorism we are hearing more and more often—that the Senate, the last free forum of the people, is becoming a rich man's club."

Frank Lockamy and Son Hurt In Wreck

Frank Lockamy, and son Frank, Jr., received painful injuries when the automobile in which they were riding sideswiped a truck and ran into a ditch on the Norfolk highway, near Drivier, Va., Sunday. Mr. Lockamy's injuries consisted of cuts on the nose and forehead, and his son suffered the loss of teeth and cuts about the face and arm.

Mr. Lockamy was returning to Greenville when the accident occurred. He was meeting a car coming from an opposite direction when a truck ran out onto the highway from a side road directly in the path of the Greenville car. Mr. Lockamy's machine, sideswiped the truck and plunged into a ditch. Occupants of the truck escaped uninjured.

TIME FOR OUR PEOPLE TO TAKE A HAND.

Pitt County employees yesterday for the first time ailed to receive the money due them for the previous month's services to the county, not because the county is in any worse shape than it and other counties of the state have been many times before, but purely, as we see it, as a result of bullheadedness on the part of a small group who because they were not permitted to run the county according to their own desires have determined to bring about all possible embarrassment to the present county board probably in the hope of forcing the members to resign.

Yesterday's failure to pay it was the result of bond attorneys' refusal to approve the sale of \$250,000 worth of the county's notes because there is pending litigation that already a judge of the superior court has declared as without reason and foundation but which was appealed to the Supreme Court by the complainants apparently just to have the matter pending in order to block the sale of the notes.

Such was their idea today they have the pleasure of knowing that they have carried their point so far, but beyond that we see no good so far as the taxpayers are concerned and on the other hand a situation is being created that no doubt will be against us in the future.

When the notes were offered for sale, according to law, last week the bidders accepted them subject to the approval of the bond attorneys because of the pending litigation and the interest rate was the lowest figure at which the county has ever been able to borrow money and at that time Judge F. I. Wooten, counsel for the complainants, we are informed, was asked to withdraw action in order that the sale might go through, but his reply was that the action would be withdrawn only if the board of commissioners would comply with a resolution adopted by him and his associates demanding that the budget estimate for highways, roads and bridges and the county farm be reduced fifty per cent., and that "all other departments of Pitt County government without exception be cut twenty-five per cent." Of course everybody wants all the tax reduction possible but the use of a little common sense will convince us that under such a cut the county could not operate with any degree of efficiency and the board of

commissioners used wisdom in declining the compromise offered with the result that the note sale was not approved by the attorneys and yesterday the county was without sufficient funds to meet its bills for current operating expenses.

During the past few weeks other counties in the state have borrowed money in anticipation of this year's taxes and have enjoyed very low interest rates and Pitt County could have done the same thing but for this pending litigation. Now we find ourselves placed in a position where we must borrow money at higher rates, (we can sell our notes at five per cent interest instead of the 3 3-4 offered), or we must do without until the Supreme Court hears the pending litigation. Either \$1,500 of our tax money must go to pay extra interest or we must suffer the embarrassment of not paying our employees or our county government must cease to function and close down for lack of funds, all because of a few persons (we say a few because we do not believe that this group by any means represents the majority of our taxpayers) see fit to make all the possible trouble for the present administration under the guise of an effort to help the taxpayers of our county.

It seems to us that the time has come for, not a few, but all our people to gather together, settle down to brass tacks and straighten out this wrangle in order that the affairs of our county might be carried on as they should be.

We must go forward and we cannot do so in the face of the present tactics of the so-called "Taxpayers Association."

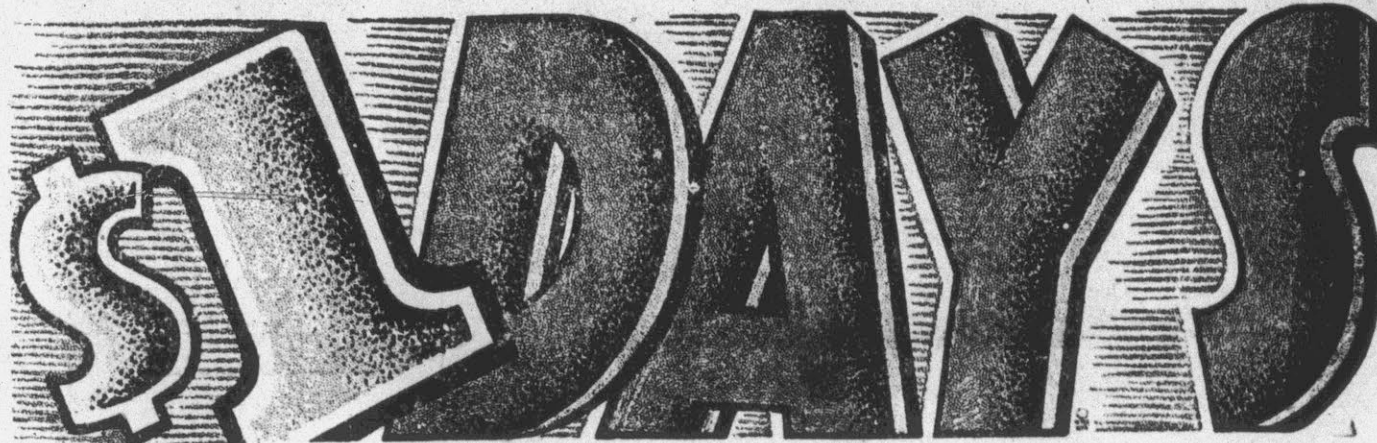

RESUME PROBE OF CAMPAIGN IN WASHINGTON

Campaign Funds Committee Hears About Recount of Ballots in Penn.

Washington, Aug. 5.—(AP)—Testimony on the recount of ballots in the Republican gubernatorial primary in Pennsylvania was given today by George W. Greasey, of Philadelphia, as the Senate campaign funds committee's inquiry into expenditures in the Senatorial primary was resumed.

Greasey, supervisor of election recounts said he had seen many "mutilated" ballots cast in the Pinchot-Brown gubernatorial contest and 80 such ballots had been thrown out in one district and 50 in another.

Former Governor Gifford Pinchot and Francis Shunk Brown are the principals in the recount.

Questioned by Chairman Nye, Greasey said no Senatorial candidate had asked for a recount.

He said ballots in bundles marked "50" also had been thrown out as "identified ballots." Many erasures also had been found, he said, but he would not say whether evidence of "fraud or corruption" had been found.

Most of the erasures, he added were "on Francis H. Bohlen, who was candidate for the Senate, and T. W. Phillips, who was candidate for Governor."

The recount up to yesterday had covered 377 of 411 precinct division boxes.

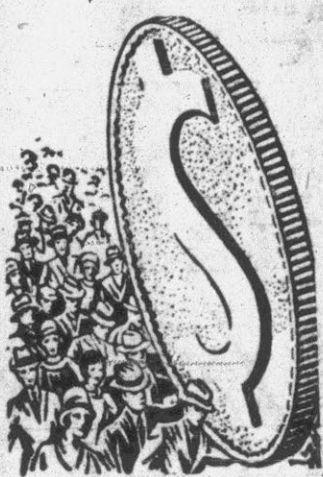

COTTON MARKET

New York, Aug. 5.—(AP)—Cotton opened steady today at a decline of 4 to 10 points in response to the relatively easy showing of Liverpool and a feeling that yesterday's covering had somewhat eased the technical position of the market.

There were rallies of several points right after the opening on unfavorable features in the weather news, but after selling up 12.91 for October, and 13.36 for March, or some 6 to 9 points above opening prices, the market eased again under selling promoted by a private report that it was raining at Wichita Falls.

The new October sold off to 12.85 and March to 13.10 with the market showing net declines of about 5 to 10 points at the end of the first half hour. A private report placed the condition of the crop as of August 1 at 66.4 and the indicated yield at 13.749,000 bales.

STOCK MARKET

New York, Aug. 5.—(AP)—The bull troupe continued to perform rather wearily to an all but empty house in today's stock market, but failed to show any signs of discouragement.

U. S. Steel was bid up moderately to new high ground for the current recovery above 170, and a few other pool favorites were turned over rather actively. Bulls still failed to develop any notable following however, and while floor transactions reflected some stimulation, commission houses were all but idle.

The severe draught damage to crops in the central west tended to accentuate speculative uncertainty, particularly on reports of heavy rains over certain areas, causing a substantial setback of the cotton market. On sober second thought, Wall street could not interpret any major domestic crop catastrophe very bullishly, although it might end the depression in grain prices. A little more bullish attitude was taken toward the wheat market, however, particularly since indications of a short crop in France.

Although wholesale buyers, with only a month left to Labor Day, have not been very active in the New York markets of late, some pickup in retail trade is viewed as a seasonal certainty, and the merchandising shares were bid up more actively than for some time. Macy gained more than 3 points, and Woolworth, Kresge, Sears Roebuck and Simmons made moderate gains.

Operators for the advance were again pressed forward in Standards of New Jersey and California, Radio, American Tobacco, Eastman Kodak, Johns Manville, Electric Power and Light, Mack Truck, Hudson and Loew's were among issues rising 1 to more than 2 points.
