TRUE BILL IS RETURNED IN BOWEN CASE

Grand Jury Also Finds True Bills In Two Murder Cases and Minor Charges

The new six months grand jury of the criminal term of Pitt County Superior court returned a true bill for secret assault against J. F. Bowen, prominent Greenville merchant, in connection with the shooting of T. D. Phillips, prominent dealer, because Phillips' radio disturbed Bowen's family.

The case, one of the most unusual of its kind in the history of radio, is set for hearing Thursday. It was indicated today that the courtroom would be packed to overflowing each day as the curious from this and surrounding communities, attracted by sensational accounts of the shooting, come here to hear the charges aired in court.

There were three other charges against Bowen—forcible trespass, carrying a concealed weapon and assault and battery—which did not require investigation by the grand jury.

Bowen is alleged to have gone to the Phillips home on a night in July and demanded Phillips to cut off his radio. Phillips did as requested, and asked Bowen what right he had to make such a demand. As Phillips walked to a door leading out to the porch, Bowen is alleged to have fired at him through the window with a pistol, the bullet taking a button off of Phillips' trousers and imbedding itself in a wall.

Phillips walked out on the porch, and during the controversy ensuing Bowen is said to have given mere vent to his wrath by knocking Phillips to the floor.

The case came up for airing in a magistrate's court several days later, and Bowen was held for action by Superior court under bond. Bowen has declined to make any statement regarding the affair.

Although this case will be the principal high light during the present term of court, the grand jury yesterday returned true bills in other cases which promise to furnish more than passing interest to the people of the localities in which they originated. True bills were returned against Jodie Whitley, charged with the murder of Paul Forbes; Ed Hatton, for the killing of Marcellus Riddick; Roy Carr and Howard McNeill, charged with the theft of an automobile, and D. C. Ross, assault with a deadly weapon. A true bill was also found against Hyman Gardner, held in connection with the burning of the Clay Root schoolhouse. Hearing was begun in this case yesterday.

The Jodie Whitley case holds considerable interest to the people of the Penny Hill section where the shooting occurred. Whitley is charged with firing a shot that resulted in the death of Paul Forbes, well-known planter of the Penny Hill section. Whitley, who escaped after the shooting later surrendered to the sheriff of Pitt county and since that time has been held in jail here without bond.

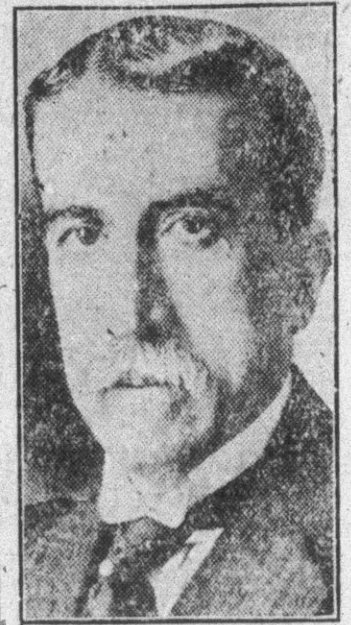
The shooting was the outgrowth of an altercation which Whitley and Forbes had at a tobacco barn on the Forbes' plantation. Whitley was alleged to have slapped one of Forbes' daughters, and Forbes retaliated by hitting Whitley with a hammer as he fled from the barn. Whitley, it was alleged, went home and got his gun, posted himself under a tree near the Forbes' home, waiting for Forbes to come out. He fired at Forbes, and fled. A few days later Forbes died. There was some doubt as to the cause of his death, and an autopsy was held under direction of Coroner E. S. Williams. It was discovered that one of the shots from the gun had passed through Forbes' eye, entered the brain and caused a hemorrhage. The coroner's jury returned a verdict that Forbes came to his death as a result of a gun in the hands of Whitley, and ordered that Whitley be held without bond.

The murder charge against Ed Hatton, colored, followed the shooting to death of Marcellus Riddick in an alley back of the Greenville Cafe about two weeks ago. The two men had engaged in an argument, and Riddick, it was alleged, invited Hatton to the alley to settle the dispute. The report of a pistol was heard by persons in the cafe, and Riddick staggered through the cafe kitchen door, and fell dead with a bullet through the throat. Hatton claimed he shot in self-defense as Riddick threatened to kill him and reached to his hip as if he meant to pull a gun when he fired the shot that brought the argument to an end.

URGES LEGION TO TAKE STAND IN THIS STATE

Governor Gardner Speaks At Annual Convention at Winston-Salem

Winston-Salem, Aug. 26.—(AP)—A challenge of leadership in affairs of their state was thrown to North Carolina Legionnaires today by Governor O. Max Gardner. Speaking at their state convention here, Governor Gardner told members of the American Legion they had reached the substantial fullness of their powers. "North Carolina calls you to leadership," he said, "at a time when genuine qualities of leadership can bring us into a new prosperity and an enriched cultural and spiritual life. No one doubts your courage to die for your state or your principles. I am not challenging you to that. I am challenging you to live for your state and your principles, and to live for them as if living for them were as fine and as noble as dying would have been. I challenge you to lead."

The state chief executive previously had told the Legionnaires the first duty of the leader was to know. "What change in our agricultural outlook would be made if every man in position of leadership in this industry knew the agricultural problem in all its ramifications and inter-relationships with business, industry, mobility of population, and world trade?" he asked.

"Likewise," Governor Gardner said, "the leaders in other phases of the state's industrial and social life must know. Contending, he said, "Then, I think the leader must face the truth as he sees the truth. He cannot straddle. He cannot temporize with facts. Without hypocrisy and without shifting, the leader must, with a sincerity and a directness that he who runs may read, stand for the public good. He must know what is for the public good and he must have the will to do what he knows is for the public good."

Snake Takes Bite of Farmer's Toe

New Bern, Aug. 26.—(AP)—O. J. Perry, farmer, had trouble of the toe, having injured it recently. Leather pressed upon it painfully. Very carefully, therefore, Perry cut away the offending part of the shoe. "Ah!" he said, relieved, wiggling the toe ecstatically. And he went away to cut brush. There was a snake in the grass—or brush. It selected Perry's protruding toe and bit. Serum was administered at New Bern and it is thought Perry will recover.

Judge Moore Overrules Motion By Attorney for Convicted Men for Continuance of the Case Until Next Session of Mecklenburg Superior Court

Charlotte, Aug. 26.—(AP)—Judge Walter Moore today ordered capias issued for Fred Erwin Beal and six other men convicted with him of second degree murder of O. F. Aderholt, Gastonia chief of police. Beal and his associates have been at liberty under bond pending an appeal to the State Supreme court which last week denied their plea for a new trial.

Judge Moore's order was issued after he had overruled a motion by J. Frank Flowers, attorney for the convicted men, asking a continuance of the case until the next term of Mecklenburg court.

Flowers contended the continuance should be granted since the Supreme court's certification of its decision had not been received by the court here until the day after court opened.

The names of the defendants were called in court and when they failed to appear, Solicitor John G. Carpenter asked that their bonds, totaling \$27,000, be declared forfeited. Judge Moore, however, ordered that the bondsman for the convicted men be notified the bonds would be declared forfeited on September 22 unless Beal and his associates returned to face their sentences.

Beal, who came to Gastonia from Lawrence, Mass., last year and organized a strike in the Loray mill there, is under sentence of 17 to 20 years in the state prison. Clarence Miller, Brooklyn, N. Y.; George Carter, Mizpah, N. J.; and Joseph Harrison, Passaic, N. J., are under like sentences.

W. M. McGinnis and Louis McLaughlin, both of Gastonia, are under sentences of 12 to 17 years and K. Y. Hendricks, Gastonia, of 5 to 7 years.

BANKERS WILL CONFER WITH PRES. HOOVER

Washington, Aug. 26.—(AP)—Bankers of the "worst-affected" drought states prepared at the call of President Hoover today to tackle the heart of the drought problem—how to get funds and credit to the water-starved farmers. The representatives of finance on the various state relief committees converged on the White House for their conference with the President this afternoon.

They were on hand from a dozen states and more were expected. Before them was an outline of financial drought relief committee, providing for establishment of state or local credit corporations which would advance loans to farmers through the intermediate credit banks. How to approach the multiplicity of tasks involved in coordinating small-scale local activities into an efficient national whole, blanked large in the program prepared for them by Mr. Hoover. At the head of the bankers was Henry M. Robinson, of Los Angeles, whose duty on the national committee will be to coordinate the state and regional credit activities for relief.

The President believes farmers in the acute drought areas have been affected differently and relief will have to take individual lines.

Secretary Hyde, chairman of the national committee, returned for the conference from a tour of affected areas strongly convinced that relief committees in each county offer the "only way the government can get down to the ground" in solving the problem.

Under the proposal of the national group, local credit corporations would be set up wherever local banks are unable or unwilling to assume the relief task. They would take loans on easy credit, and endorse them over to the intermediate credit banks.

The corporations would receive two per cent interest above the charge of the intermediate credit banks. Under the present rate of four per cent, the farmer's maximum interest would be six per cent.

PROMISES TO PUNISH EXILED PERU RULER

Head of New Government Declares Leguia Will Be Brought Back for Trial

Lima, Peru, Aug. 26.—(AP)—The obscurity of political exile was denied today to Augusto B. Leguia, deposed president of Peru who for eleven years ruled this country with an iron hand. Yielding to popular clamor General Manuel Maria Ponce, head of the military junta which has replaced the old government, promised a mob of students in a public address that Leguia would be brought back to Lima to face punishment for his "misdeeds."

The Almirante Grau, Peruvian cruiser on which Leguia and his family yesterday left Callao, presumably for Panama, put in back of San Lorenzo Isle, outside Callao harbor, to await orders for disposition of their prisoner. Unverified reports from Callao, said he was seriously ill.

Martial law prevails in the capital as a consequence of fighting in the streets and at the home of the former president yesterday. Several persons were killed and injured.

A complication factor has arisen in what may signify a break between the Military Junta in charge here and the Southern, or Arequipa revolutionary group, headed by Col. Sanchez Cerro.

Many believe Col. Sanchez Cerro will refuse to recognize the authority of the Lima Junta and will insist upon validity of the government he has installed at Arequipa.

General Ponce's promise to punish Leguia was made after an imposing popular display in the course of which a mob led by students gathered outside the government palace and demanded to see the Junta leader.

A student committee was sent inside and Daniel Carrero, its leader, told Ponce that Leguia should be held along with other politicians of the defunct regime who had "misused the public funds" to answer for their crimes.

General Ponce replied that the Junta had decided to punish all the misdeeds of the old politicians and that under no circumstances would Leguia be allowed to leave Peru.

He also said the press would be free under the new regime and that all political prisoners would be freed.

During the night a mob raged the streets of the capital, destroying every reminder of the eleven year rule of St. Leguia. La Avenida Leguia, which connects Lima with Miraflores, was renamed by the populace. La Avenida Arequipa. The Leguia theatre also was rechristened the Arequipa theatre.

Uima, Peru, Aug. 26.—(AP)—Official announcement was made today that the cruiser Almirante Grau, on which is quartered former President Augusto B. Leguia, "has surrendered."

Presumably the Almirante Grau will relieve the former president to the new Military Junta in Lima, following requests by students that Leguia be prosecuted.

Lon Chaney, Cinema Star, Dies In California After Battle Against Pneumonia

"Man of a Thousand Faces," Succumbs to Hemorrhage of the Lungs Shortly After Midnight; Wife and Son At His Bedside In Los Angeles

Los Angeles, Aug. 26.—(AP)—Lon Chaney, whose grotesque screen characterizations won him the sobriquet of "The Man of a Thousand Faces," died here early today after a valiant battle against anemic and congestion of the bronchial tubes.

A hemorrhage of the lungs shortly after midnight suddenly cut short the noted actor's fight for life after he had been reported on the road to recovery. He was 47 years old.

Chaney entered a hospital August 15 for treatment of an anemic condition resulting from a severe attack of pneumonia suffered in New York early this year.

He failed to respond readily to treatment and last week three blood transfusions were resorted to. Last Saturday he became critically ill but safely passed the crisis. Yesterday he was said by hospital attendants to be resting easily.

The hemorrhage which resulted in Chaney's death struck with unexpected suddenness. He was dead in less than 30 minutes, his physicians said.

At Chaney's bedside was Mrs. Chaney, a constant attendant since her husband first was taken ill, and Creighton Chaney, a son by a former marriage.

The death of Chaney removes from Hollywood's varied ranks a veritable mystery man, known almost entirely by his screen appearances. Away from the motion picture lot Chaney inevitably wore a pulled down cap, dark glasses and plain clothes. He commanded a large salary, made numerous investments and reputedly was very wealthy, but made few friends.

Born on April 1, 1883, in Colorado Springs, Colo., the son of deaf and dumb parents, Chaney quit school before he had reached the fifth grade to become a tourist's guide on Pikes Peak.

His introduction to the theater was as a property boy. Later he became a stage hand, and to his death he carried a card in a stage hands' organization. Behind the wings he studied the regular actors and learned of acting which later in life won him fame. He got his first "break" as a song and dance man at a stage hands' benefit when he was sixteen years old.

With his son, George, who now lives in Oakland, Cal., Chaney drifted into the wandering life of a "ham" actor and toured the country. While with the old Hartman Opera Company in San Francisco, he met and married Hazel Hastings, a member of the troupe, who was his companion for 22 years. Of a previous marriage little is known except that a son was born.

Chaney's entrance into the motion picture world was with the slapstick route but in 1912 he became an extra in western films. Later he directed Warren Kerrigan, then a western star, in seven productions. He received his first screen credit in 1914 from Universal for appearance in a leading role in "Hell Morgan's Girls."

With his portrayal of "The Frog" in the "Miracle Man," came his shift from slapstick and westerns to the grotesque characterizations that made him famous. Early this year he signed a five-year contract. The "speakers' bureau" of many actors and actresses, were no terror to the former musical show comedian.

With his portrayals of grotesque characters, Chaney himself slipped into a seclusion that well might have fitted in with the life of some of his screen characterizations. He refused interviews—"none of his shunned personal appearance" and utterly refused to attend premier showings. After studio hours he sought the seclusion of his home and his small circle of close friends.

Among his close acquaintances were General Smedley Butler, of the United States Marines, and Eddie Griffin, the comedian.

Wholly self-educated, he was a voracious reader and a student of many subjects. He wrote the Encyclopedia Britannica's chapter on screen makeup. Though often portraying the cripple or deformed character, Chaney of the lot was athletic and strong.

His hobbies were fishing, football and prize fighting.

From the list of starring vehicles Chaney has appeared in, outstanding are "The Miracle Man," "The Hunchback of Notre Dame," "The Phantom of the Opera," "Laugh, Clown, Laugh," and "The Unholy Three." No sacrifice was too great for the actor to undergo if it meant the better his portrayal and frequently he suffered painfully while the camera ground away.

YOUTH FOUND NOT GUILTY OF ARSON CHARGE

Ayden Negro Sentenced to 20 Years in Penitentiary On Murder Charge

A verdict of not guilty was ordered in the case of Hyman Gardner, young white man of the Clay Root community, charged with the burning of the Clay Root school house last April, by Judge Walter Small of Elizabeth City, in this morning's session of the criminal term of Pitt county Superior court.

The order of the court came after several hours had been spent in hearing of testimony. It was found that insufficient evidence had been introduced to justify sending the case to the jury and Judge Small ordered that the young man be released. Hearing was begun yesterday afternoon.

The burning of the Clay Root school house created considerable excitement throughout the community, and Gardner was arrested following an investigation in which it was alleged that he had made the statement that the school would not open again. He received a preliminary hearing in a magistrate's court here and was ordered held under bond for Superior court action.

James Barber, negro of the Ayden community, pleaded guilty to a charge of second degree murder in connection with the slaying of Ken Edwards, at Ayden several weeks ago, and was sentenced to from fifteen to twenty years in the state penitentiary.

Barber killed Edwards in an argument over fifty cents, which he claimed Edwards owed him. They met on a dark street in the Ayden negro district, Barber demanded payment, and during the controversy, Barber brought a knife into play, slashing Edwards' throat so severely that he died a short time later.

Archie Grantham, one of the main witnesses, was ordered held for investigation by Judge Small in connection with a murder in the Manteo district. The sheriff was instructed to confer with Manteo authorities, and to obtain more information regarding the killing and the possible complicity of Grantham.

DEMOCRATS GO TO POLLS IN FOUR STATES

S. C., Mississippi, California and Idaho to Choose Nominees Today

(By The Associated Press)

Voters of South Carolina, Mississippi, California and Idaho today were choosing nominees for the fall elections.

Senator Cole L. Blease had two opponents for the Democratic nomination, which is considered equivalent to election in South Carolina. If none receives a majority, as seemed likely, a run-off will be held next month.

Senator Pat Harrison and seven of eight representatives were opposed for the Democratic nomination in Mississippi, also considered equivalent to election.

In California, the dominant contest was among five seekers for the Republican nomination for governor. As in the east, all districts voted also for congressional candidates. No senatorial election will be held there this year.

Members of both parties gathered in convention in Idaho, where Senator Borah is up for re-election. The gubernatorial nominations held the major interest.

Columbia, Aug. 26.—(AP)—South Carolina Democrats went to the polls today to select political officials ranging from township magistrates to United States Senator.

Nomination by the Democratic party is equivalent to election in this state. The Republicans do not even offer candidates for state offices, and the general election is simply a matter of form.

Chief interest centers in the two major contests, the tri-cornered race for the senatorial toga worn by Cole L. Blease, and the battle royal for the governorship among eight contestants.

Senator Blease, active in South Carolina politics for 42 years and for the greater part of that time a political storm center, is opposed by Leon W. Harris, Anderson solicitor, and James F. Byrnes, of Spartanburg, for 14 years a member of Congress from the second district.

Blease, seeking reelection on his record during the campaign dropped his fiery tactics of other years and only once gave vigorous answer to the numerous charges hurled at him by Harris.

Byrnes, runner-up to Blease six years ago, has ignored both of his opponents in the campaign oratory. Prohibition, the states \$65,000,000 highway bond issue and what has been termed by the candidates as "honesty in government," have figured in the gubernatorial race.

Ashton H. Williams, young Florence attorney and former state senator, is running on an out-and-out "wet" platform. He has called upon the state to elect him, repeal the South Carolina prohibition law, years older than the Volstead act, and substitute the national prohibition laws in its place. Under this system, he has argued, the medicinal whiskey could be legally sold in the state and the state could tax its sale.

W. W. Smoak, Colleton legislator for the last 10 years, has argued vigorously against Williams' wet platform, pointing out various benefits he has seen derived from prohibition. He is also an advocate of the bond issue.

Olin D. Johnston, Spartanburg legislator; W. H. Keith, Representative from Greenville, and John J. McMahan, former state superintendent of education and former insurance commissioner, have entered the race. Attacks on the bond issue, the state highway department, and the administration of Governor Richards.

Other candidates are A. Frank Lever, former Congressman, who is championing farm relief; R. Beverley Herbert, Columbia legislator, an advocate of tax reform; and Ira C. Blackwood, Spartanburg solicitor, who ran second four years ago.

Governor Richards, South Carolina's first four-year term executive, is not eligible for reelection.

Prices Stronger On Leaf Market At Fairmont

Fairmont, Aug. 26.—(AP)—Tobacco buyers on the Fairmont market yesterday bid in strong competition for all grades of good tobacco and the official average for the day was announced this morning as being \$14.45 per hundred pounds, the best of the season. Sales yesterday totaled 909,864 pounds.

Last season for the corresponding day of sales the average received was \$21.17 per hundred pounds for 621,006 pounds sold.

DRIVER'S LICENSE LAW NECESSARY

The movement for the enactment of a state driver's license law by the next legislature, being sponsored by the Carolina Motor Club and interested citizens of our state, apparently is gaining headway and it is to be hoped that when our lawmakers meet in Raleigh they will realize the necessity of such a measure and will lose no time in putting it into effect.

The automobile accident record will not be reduced in our state until we take decisive means to keep the reckless, the irresponsible and both the mentally and physically incompetent from our public highways where they menace the lives and property of all other motorists and a rigidly enforced driver's license law is the only way to accomplish the desired results.

JUDGE SMALL'S COURT.

The manner in which Judge W. L. Small is handling the criminal court now in session here is such as to attract favorable comment from members of the bar and persons outside the legal circle. In his charge to the members of the grand jury he clearly set forth their duties regarding seeing to the enforcement of the law and emphasized the necessity of the performance of their duty to the letter if our county is to make the progress that it should. Then from the calling of the first case for trial the court has been conducted under an atmosphere of dignity, minus the usual noise and trimmings that go with a crowded court room at a session of criminal court. Yet, with it all, he has conducted his court not with any apparent effort to create an impression of trying to be hard-boiled, but with an even smooth interest in every case and the testimony of every witness, careful consideration of the points of the law involved and sentences in keeping with the gravity of the offense. Such is our idea as to how a court of justice should be conducted and in this respect Judge Small certainly suits us.

ABOUT TOWN

"North Carolina is one of the greatest states in the Union," Judge Walter Small, who is presiding over the August term of Pitt county Superior court, told members of the six months' grand jury when court

opened yesterday morning. "The men of high finance and business have their eyes on North Carolina, realizing as they do that the resources and possibilities of this state are among the best in the Southland," Judge Small said. In view of this condition, it is incumbent upon the people of this state to have faith in the things which the future holds for them, the jurist believed, and they should look to the future with confidence, secure in the knowledge of their ability to keep pace with the rest of the country. Judge Small also indicated that the depression which has existed in the state was one of those conditions bound to happen in the life of any section, and said the time was not far off when there would be an improvement. In this improvement he saw a greater and mightier North Carolina—and a state its people should be proud to claim as their own.

People who are affected by the wanderlust during the winter have been advised to remain at home and not to wander from one section of the country to another in quest of improved conditions.

This advice was issued through the Salvation Army, and it was stated that the organization would be better able to care for the poor providing they should remain in one locality instead of traveling about from one community to another.

This advice is sound and should receive attention of those who make it a habit of roving about from place to place trying to find a better place to live.

It is gratifying indeed to note that stop signs have been placed on Fifth street at the intersection of Pitt, and that "U" turns have been eliminated on Evans street at the intersection of Third.

Traffic on these streets is heavy at all times, and the signs should be instrumental in preventing numbers of wrecks and probable loss of life in the future.

The Fifth street crossing is one of the most dangerous in town, owing to the fact that view of the intersecting street is cut off by buildings. Numbers of accidents have occurred at that point in past years, but fortunately none were serious. The stop signs, if properly

observed, should eliminate future accidents and enable people to pass along both streets without breaking their necks and probably injuring or killing others.

It is against the law to operate slot machines in Pitt county and members of the new six months' grand jury have been instructed to investigate charges of such practice with a view of breaking it up.

Sheriff Whitehurst sometime ago warned against the operation of such machines, but for some unknown reason the operators failed to give the notice due consideration with the result that the matter is now in the hands of the grand jury with instructions to bring presentments against those breaking the law in this connection.

Virtually every type of slot machine is covered by the law, and persons having such machines in their stores should get busy and do away with them before they are called into court to answer charges of operating gambling devices.

ROTES LAUNCH CAMPAIGN FOR MORE TREES

Other Organizations to Be Invited to Help Increase Stock of Shade Trees Here

A campaign for more shade trees in Greenville and the preservation and development of those already existing in different parts of the city was started at the regular meeting of the Greenville Rotary club last night.

Although definite plans for the campaign were not worked out, it was understood that when it gets underway effort will be made to get individual residents to place shade trees wherever needed on their park strips and premises. They will likewise be urged to take care and develop the trees now growing.

It was also understood that when the campaign actually gets underway experts would be called in to take care of the setting out and handling of trees at very small cost per tree.

Other civic and business organizations will be invited to join the Rotarians in this effort to beautify the city by the setting out and development of shade trees.

The question of more trees and the preservation of developing those already on hand was brought to the attention of the club by K. W. Cobb. Mr. Cobb told of the advantage of the shade trees during the summer months and urged the Rotarians to take some action looking to the improvement of the tree situation in Greenville.

Dr. R. H. Wright, president of East Carolina Teachers College, also spoke on the tree question, and expressed belief that more trees, and attention to those already developed would have a tendency of beautifying the different sections of the city, in addition to affording cool places for homes during the hot summer months. He asked that the suggestion for an active campaign be launched immediately with nothing being left undone until something of a definite nature had been accomplished.

A special committee was appointed by the club to confer with city officials, civic organizations and residents with a view of interesting them in the planting of trees and attention of those growing throughout the community.

Many of the most beautiful shade trees of the city have given way to the march of progress during the last several years, some have been destroyed by leaking gas mains and other causes, and today the stock has been so depleted that the streets and residential sections are almost bare. It is the purpose of the Rotarians to interest the people generally in the need of more trees and to see that they are adequately protected from disease and decay after the campaign gets under way.

COTTON MARKET

New York, Aug. 26.—(AP)—Cotton opened very steady today at an advance of 11 to 20 points on a continuance of the covering movement which developed toward the end of last week and some trade commission house buying which was probably promoted by relatively firm cables.

Some southern selling was reported, but it was in comparatively small volume and reiterated reports that cotton was being held in the south contributed to the advance. New October contracts sold up to 11.35 and March to 11.75 during the early trading with the active months showing net advances of about 18 to 22 points. Prices were within a point or two of these figures at the end of the first half hour.

Liverpool cables reported continental buying with local and London covering and said there was less hedging.

GRAIN MARKET

Chicago, Aug. 26.—(AP)—Scarcity of offerings, together with an increase of speculative buying rallied the corn market late today from early declines. For the first time this season, December delivery of corn went to a premium over December wheat.

Uncertainty as to whether the Canadian growers' pool would be compelled to hedge wheat this season had a persistent bearish effect today on wheat values in Chicago, although some Winnipeg reports said positively that there was no stinging on bank loans to the pool.

Best prices for corn, however, failed to hold, and the corn market closed nervous 3-8 to 1-8 lower than yesterday's finish. Wheat closed heavy 1-4 to 1-3-4 down; oats 1-2 to 1 off and provisions varying from 5 decline to an equal gain.

STOCK MARKET

New York, Aug. 26.—(AP)—The motion picture stocks combined to show a few mildly bullish scenes in today's stock market.

Such a coincidence as dismissal of the Warner Bros. receivership petition on the day of publication of an optimistic report to Fox Film stockholders from the new management, at last provided professional traders with some excuse for bidding up stocks.

The advance was helped along by extremely conservative buying recommendations issued to clients by a statistical organization which has been bearish for some time. The

market was sluggish during the early trading, and worked lower under the influence of selling of the agricultural implements, oils and coppers. By mid-day, however, the motion picture stocks turned emphatically upward and were soon joined by a wide assortment of popular trading favorites.

Short covering appeared in some volume. The market continued mostly the private affair of professional traders, however, as no widespread inclination to buy stocks developed.

Fox gained more than 3 points and Loew's nearly as much. The balance sheet as shown for June 30 indicated a complete reversal of the cramped financial disposition shown six months previously. Total assets were carried at about \$192,500,000, a gain of more than 50 per cent from Dec. 31. The problem of permanent financing, however, as it has \$55,000,000 in short term notes coming due next spring. Warner Bros. sold up more than 2 points, although dismissed of the equity suit was only a technicality. General Theatres and Paramount were firm.

As railway earnings reports for July continue to appear, the comparison with recent years shows little change from June. The more favorable reports usually appear first. The Department of Commerce's automobile production report for July was somewhat less than had been expected, and indicated clearly the extent of the slump in that month. Output was 47 1-2 per cent below June and 21 1-2 per cent under July, 1929. Call money continued at 2 per cent.
