## WOMAN DIES IN FIRE AFTER AUTO WRECK

### Man Jailed for Igniting Wrecked Car and Then Refusing to Aid in Rescue

Sylva, Aug. 30.—(AP)—Mrs. Thad Brown, of Ninety-Six, N. C., was burned to death while pinned beneath an overturned automobile 30 miles from Sylva Friday night about 9:30.

J. K. Privett, also of Ninety-Six, is said to have struck a match which ignited gasoline that was pouring out of the machine tank.

Privett was locked up in jail here last night and held on a charge of manslaughter. The charge may be changed to a more serious one at the preliminary hearing which was set for noon Saturday, it was said.

A tale of cold indifference to the woman's cries for aid was told here today by her 16-year-old daughter, who said Privett refused to aid her in her efforts to extricate her mother.

Privett, she declared, when she asked him to help get her mother from underneath the car calmly walked up on the hill, sat down, lit a cigarette, and threw the match toward the machine. It was then that the gasoline was ignited.

The young girl said that, despite her mother's size, the woman weighed about 160 pounds, she had all most extricated her when the match lit the gasoline.

Sheriff's offices here are informed that there was liquor in the party, which consisted of Mrs. Brown, her husband, her daughter, and several small children of the Browns and Privett.

Mrs. Brown was buried beyond recognition.

Details of the tragedy were meagre. It occurred on highway No. 286, between here and Lake Toxaway, about 30 miles from Sylva, in Jackson county.

Mrs. Brown was to be buried near the scene of the wreck and fire sometime today.

The party was on its way to Canada township to visit relatives. Privett was the driver of the car. Mr. Brown, while his daughter sought to extricate her mother, was working with a child, who was injured, it was said.

The car, when it left the highway, rolled 50 feet down the side of the mountain.

Brown said his daughter undoubtedly would have been hurt or killed, had he not seen the gas igniter and snatched her away from the fire.

## Liquor Distiller Confesses Killing Oklahoma Officer

Altus, Okla., Aug. 30.—(AP)—Captured with a truck containing a liquor still, Vernon Robison, 28, confessed to officers today that he and his brother, George, 30, engaged in a gun fight in which one officer was killed and another wounded near here last night.

Vernon Robison placed blame for the actual shooting upon his brother, Deputy Sheriff Elmer L. Carter, who was killed and Joe Whitt, night police chief, wounded.

Vernon Robison was taken to the state reformatory at Granite for safe keeping, and a guard was placed around the hospital at Frederick, where George lay near death with a bullet wound in his chest.

Officers sought Ernest Jackson of Vernon, Tex., said by Vernon Robison to be the third man on the truck halted by Carter and Whitt before the gun fight. The truck, loaded with equipment for making liquor, was found at the home of Buck Robison, father of the two brothers.

Vernon said he first heard a pistol shot from a motor car in which the officers were trailing the truck, and that his brother leaped from the truck with Jackson and returned the fire.

Charlotte, Aug. 30.—(AP)—When 2,500 women start after 100 bowls of goldfish it's awful hard on the women.

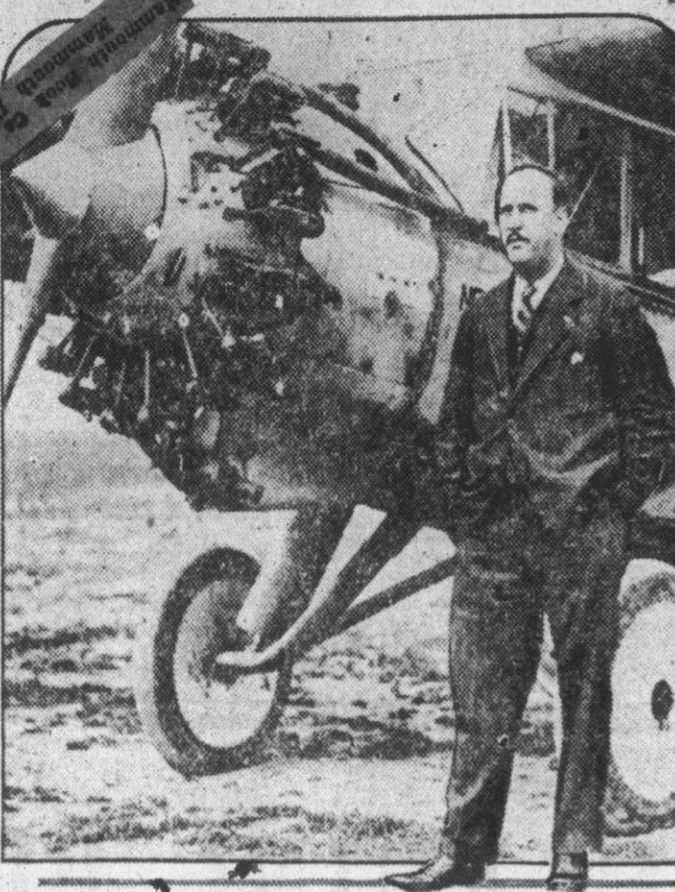
The goldfish, serenely unaware of the commotion they were causing, swam about their glass cages inside a furniture store.

## Tobacco Begins Arriving In This City For Opening Of Leaf Market Tuesday

### Thousands of Faces Turned Toward This City As Annual Pilgrimage Begins to the Shrine of Leaf Tobacco; Nine Warehouses, Nine Factories Ready to Serve Farmers of 20 Counties

The stage is set for the opening of the Greenville tobacco market next Tuesday morning at 9 o'clock and thousands of faces are turned in this direction in preparation for the annual trek to this center of the bright leaf industry.

Tobacco and tobacco men have been arriving in the city for the last several days and when the curtain is rung up on the opening scene it will find everything in place with tobaccoists holding out hope for the best season in history of the market.

Of course there is much doubt and uncertainty existing regarding the price situation, but this has not brought about any discouragement. If the price situation is low at the opening, the growers have the word of prominent tobaccoists that there will be an improvement in a few days after the common tobacco, which usually features the market opening, has been disposed of.

In addition to this encouraging news, Pitt county has one of the best crops of tobacco in years. It is a striking contrast to last season when the section failed to produce a little better than fifty per cent above normal acreage, the result of incessant rain accompanied by scorching hot weather. In spite of near draught conditions this season the crop is normal and hundreds of farmers who last year failed to realize anything will have the consolation of seeing some real cash rolling into their pockets.

The Greenville tobacco market, as in past years, has a definite goal to strive for this season. That goal is the sale of 75,000,000 pounds of bright leaf. The same goal was set for last season but the crop shortage caused sales to drop off and the market fell short of the mark. The record established in 1928 is 71,372,240 pounds, but it was sufficient to enable the market to maintain its reputation as the second largest bright leaf tobacco market in the world and the best in the state.

Nine cavernous warehouses and factories will take care of the farmers' offerings from twenty counties this season. They have undergone many improvements during the last several months with a view of facilitating sales, and the farmer will find the market in better position than ever before to handle the millions upon millions of pounds of tobacco produced this season.

The warehouses have provided the farmers with virtually every accommodation known to modern day industry, and days may be spent in tobacco town in perfect comfort. With increased warehouse and factory floor space such things as block sales have been practically eliminated on the Greenville market, and growers may market their

## LABOR TO HAVE FULL SWING IN CAPITAL CITY

### Officials and Socially Prominent Leave Washington for the Week-End

Washington, Aug. 30.—(AP)—Labor Day celebrations over the week-end have the capital stage virtually to themselves, or at least Monday is officially the beginning of the social season, highest government officials and Washington's socially prominent people have elected to remain away.

President Hoover will remain at his highland camp on the Rapidan river until Labor Day afternoon, and of the cabinet members only Secretary Hyde, drought-bound, remained at his desk today.

The ranking official in capital on the holiday will be Assistant Secretary Castle, of the State Department. Secretary Stimson hurried back to his Long Island home after several days' strenuous entertaining here in honor of visiting British and French barristers and urists.

Vice-President Curtis has been in and out of the capital all summer. Secretary Mellon will spend Labor Day at the home of his daughter, Mrs. David K. Bruce, on Long Island. Attorney General Mitchell, who went to Scotland for some grouse shooting some time ago, has not yet returned from abroad. Postmaster General Brown will be in Nova Scotia for the holiday, and Secretary Lamont will spend it at home in Chicago, returning early next week.

Labor's Secretary Davis will speak tomorrow evening at a union church service in Harrisburg, Pa., and on Monday he will join in celebrations at Brookville and Clearfield, Pa.

Official society is virtually absent en bloc, but labor leaders are present and celebrating. At the Washington Cathedral, high on Mount St. Alban, President Green will speak tomorrow afternoon, and officials of local unions will join in the memorial observances.

## To Probe Facist Demand for Firing of Negro Labor

Atlanta, Aug. 30.—(AP)—Today's Constitution says evidence that committees of a newly formed organization known as the "American Fascist Association and Order of Black Shirts" have demanded that Atlanta employers discharge negro labor will be placed before a federal grand jury convening Sep. 8.

The newspaper quotes an unnamed official at the federal building as saying his information was that the committees told the employers that if the demand were not complied with trouble might be expected.

Such action, the official said, was in direct violation of a statute providing penalties up to ten years imprisonment and \$5,000 fine for persons "who conspire to injure, oppress, threaten or intimidate any citizen in the free exercise or enjoyment of any right guaranteed to him by the constitution or laws of the United States or because of his having exercised the same."

The story says stenographic reports of addresses made at meetings of the "Black Shirt" organization, some of which have been "highly sensational and incendiary as to threats made" will be presented to the grand jury along with names of some of the business firms alleged to have been called on by committees and in some cases the names of the committeemen.

## Thirty-Seven Men And Five Women Taken In Raiding

York, S. C., Aug. 30.—(AP)—Thirty-seven men and five women at noon today had been arrested in a series of raids prohibition officers began in York county yesterday and were continuing today.

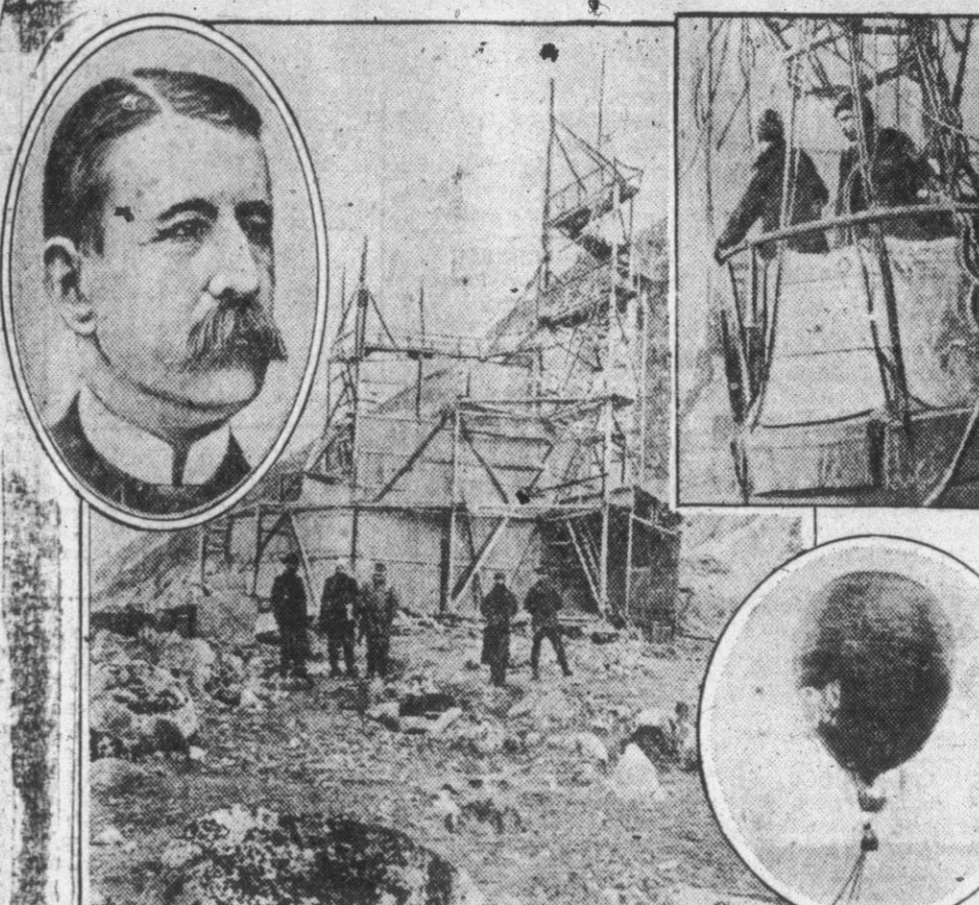
The officers' activity slackened somewhat this morning from the pace set yesterday when 33 persons were arrested, but they continued to serve warrants based on evidence secured by under-cover agents.

J. A. Clifton, deputy prohibition administrator, who is directing the arrests, refused to say how many additional warrants remained unserved, but intimated it was a considerable number.

Seven of those arrested were negroes. Twenty-seven of those caught in the raids were lodged in jail here. The others made bond. Carl H. Hart, U. S. Commissioner, said he would begin holding preliminary hearings in the cases Monday.

## WIFE KILLER SLAYS SELF IN TEXAS PEN

### Vial of Nitroglycerin Tied Around His Neck Brings Death to Lawyer

Amarillo, Tex., Aug. 30.—(AP)—A. D. Payne, Amarillo attorney who confessed slaying his wife in a deposed explosion, ended his own life by the same means early today.

The fatal explosion was believed by officers to have been produced by a vial of nitroglycerin which Payne carried suspended about his neck.

Fellow prisoners in the county jail where the attorney awaited trial for the slaying of his wife were dislodged from their cots. A sleeping cell mate was uninjured. Payne died lying face down in his cot.

The lawyer's death followed by a few hours his indictment by a grand jury on a first degree murder charge. Late yesterday he was visited by two of his children, whom he greeted with a hysterical display of affection.

The attorney gave a letter to his mother and one to the mother of his wife into the keeping of a fellow prisoner shortly after midnight. The explosion took place a few minutes later.

He had asked a group of fellow prisoners to leave his cell, telling them they would know what the bottle suspended from his neck contained "in a few minutes."

He had frequently boasted he would never stand trial.

Payne's wife was killed and his 11-year-old son maimed by a dynamite bomb which wrecked the family car June 12.

Weeks later he asked Gene Howe, Amarillo newspaper editor to investigate the case, saying civil authorities were making no progress.

Howe's investigation led to Payne's arrest. He confessed killing his wife because of love for his stenographer, Miss Verona Thompson, and said he had made four previous attempts to end his wife's life.

## Order Deportation of Two Americans for Assaulting Negro

Stalingrad, Russia, Aug. 30.—(AP)—The American mechanics, Lewis and Trown, employed at the Soviet tractor plant here, today were sentenced to deportation for ten years on charges of assaulting an American negro worker named Robinson.

The court at first gave a verdict of two years' imprisonment, but "taking into consideration the fact that the defendants are laboring under false racial ideals," the sentence was modified to deportation.

The trial, which began several days ago, attracted much attention, with newspapers describing the attack on the negro as racial hatred wholly alien to Communist doctrine.

Asheville, N. C.—(AP)—The sheriff brought Carl Dunn, charged with shooting a Mitchell county woman while intoxicated, to the Buncombe county jail because of high feeling in evidence.

## SAYS REPORT ABOUT ANDREE IS CORRECT

### Denies Retraction of Story About Finding of Bodies of Arctic Explorers

Tromsø, Norway, Aug. 30.—(AP)—A. Sivertsen, owner of the sealing vessel Termingen, today denied to-day emphatically reports published in Copenhagen that Skipper Gustav Jensen, of the Termingen, had retracted his story about the finding of the bodies and effects of the Salomon August Andree Polar expedition by the Dr. Horn Arctic exploration party.

He said the report of discovery of the Andree expedition is correct. Sivertsen continued:

"I have known Skipper Jensen for many years and whatever he says you can rely upon. He is very careful and never would tell anything he was not sure of."

"The message which Jensen brought back from Horn bore Horn's own signature. This message has been preserved here in Tromsø, since he has been sailing north since 1916. There is not a shade of doubt about the discovery."

"I believe everything he says. It is terrible for any one to create a sensation by casting doubt on the authenticity of his story."

Herr Krane, who is Sivertsen's partner, stated this forenoon that he had called the Copenhagen report to Jensen's attention and Jensen, replied: "It is all right. The find has been made. It stands in my log and the British Vice Consul Saether has the original message from Horn. If this message is false then everything else must be a fake."

Further to prove his veracity Skipper Jensen today showed the Associated Press his sacred log, carefully locked in his cabin on the Termingen, the only decoration in which is a picture of Roald Amundsen.

One entry in the log read: "August 8, 1930. Today good weather (Continued on page 3)

## COURT CLOSES AFTER HEARING HEAVY DOCKET

### Seventy-Eight Cases Completed During Criminal Term Here This Week

There were seventy-eight cases disposed of in the criminal term of Pitt County Superior court which came to a close in this city yesterday afternoon, according to a compilation of figures completed today by D. M. Clark, solicitor of the fifth judicial district.

The total of all sentences imposed in the penitentiary or on the roads during the term was given at 33 years and three months. Total fines and payment required to be made were estimated at approximately \$5,330.00. It was explained that it was impossible to estimate the amount of costs paid to the court.

The report also showed there were eight cases in which the defendants forfeited bonds and had capias issued after they had been called and failed to appear. Five indictments were initiated by the grand jury and capias issued for the defendants.

The number of cases continued on account of sickness of parties, lack of witnesses, request of attorney, etc., were estimated at twenty-two.

The court probably attracted more attention than in many years by reason of the number of important cases. One case, that of State against Bowen, attracted state-wide attention, and the courtroom was crowded to capacity during the hearing.

Then there was an arson case in which a young man was charged with the burning of the Clay Root school house. This also drew large attendance. Two or three murder cases also came in for their share of interest, but they proved of minor interest compared with the arson case, and Bowen cases.

Judge W. L. Small, resident judge of the First District, presided over the term, and the rapid manner in which he dispatched business proved a source of much favorable comment.

During the closing session yesterday the court disposed of four cases of minor importance. William Anderson, charged with driving an automobile while intoxicated, paid a fine of \$100 and cost and had his license revoked for a period of twelve months.

Judgment was suspended in the case of William Farrow, charged with carrying a concealed weapon. Jim Wilson paid a fine of \$25 and cost for assault with a deadly weapon.

Jesse Wilson and Noah Gilbert were found not guilty of assault with a deadly weapon.

## TWO HURT IN STREET FIGHT IN ARGENTINA

### Deposed President Is Lodged In Jail In Peru; Deny Revolution in Brazil

(By The Associated Press)  
Buenos Aires, Argentina—Two persons were wounded, one a high police official, in street fights between adherents and rivals of President Yrigoyen. Military precautions against an organized revolutionary movement continued.

Lima, Peru—The new government has lodged the deposed president, Augusto B. Leguia, and his son, Juan Leguia, in prison. Lieutenant Commander Harold D. Grow, American naval reserve officer, who has been in charge of Peru's air forces, will be court-martialed for his support of Leguia during the revolution.

Rio De Janeiro, Brazil—The government has denied rumors emanating from Uruguayan border towns that a revolution is imminent in the state of Rio Grande Do Sul.

Santa Clara, Cuba—An investigation has begun of an alleged seditious plot to storm the army post at Cruces, seizing weapons there and starting a revolt. Twenty men are under arrest.

Washington, Aug. 30.—(AP)—Acting Secretary Castle said today the State Department was studying the case of Harold B. Grow, American naval reserve aviator reported facing court-martial in Peru, but had reached no decision as to what action would be taken.

Ferdinand Mayer, the American charge d'affaires at Lima, cabled the department today concerning Grow, but did not say the airman definitely would be court-martialed.

The acting Secretary of State said the situation presented a complicated case in international procedure, and that both Mayer and the State Department were studying the facts.

Lima, Peru, Aug. 30.—(AP)—The new Peruvian government, which this week succeeded an 11-year-old dictatorship, has suspended the articles of the constitution dealing with public rights in order to punish officials of the Leguia administration.

An official decree said: "The principal purposes of the junta is to reform public administration, prosecuting and punishing severely all of those responsible for misuse of national funds during the Leguia government, and it is necessary to prevent their taking advantage in order to evade punishment."

"Therefore, it is resolved to suspend articles 24 and 31 of the constitution."

Those articles specify the right of citizens under accusation.

Meanwhile the junta continued clearing out Leguia appointees and reorganizing the government.

A decree of the junta annulled the reorganization of the public education system ordered by Leguia before his downfall.

FLAMES THREATEN TO DESTROY FEDERAL BUILDING

Washington, Aug. 30.—(AP)—Fire broke out today in the Federal Trade Commission building, and spread rapidly throughout the old temporary structure until one entire wing was in flames.

The structure was occupied by the fuel administration during the war. It housed many valuable government records accumulated over a period of years. Fear was felt that all were lost.

Alarms were spread and quickly brought all available fire fighting equipment to the scene, even from distant sections of the city.

## Continue Hunt for Slayer of Two Men

Eugene, Ore., Aug. 30.—(AP)—Armed with rifles and machine guns, a large posse today searched the Mohawk valley for Vic Sutherland, 67, alleged Marcola, Ore., moonshiner, wanted for the murder of Joe Saunders, deputy game warden, and Oscar Duley, Eugene policeman.

Duley was wounded fatally on Thursday night when he halted a liquor-laden automobile driven by Sutherland. About an hour later Saunders was killed while forcing a door of the Sutherland residence in search of the alleged killer.

Two deputies also were wounded.

## ABOUT TOWN

Efforts of local business men to interest packers in the establishment of a canning factory in Greenville no doubt will be received with interest by the entire community in view of the important part which such an industry would play in the business life of the locality.

The city has been in need of industries of this kind for years, and there is no question about the abilities of growers to furnish the factory with sufficient products to keep it in operation all the year around. In fact there is enough surplus here to bring rich returns to the growers if it could be conserved, and it is hoped something definite will be accomplished in the movement to bring a canning factory here.

Such an industry would not only furnish a market for the products used, but it would also provide labor for numbers of people who find the summer hard on them because of their inability to obtain employment. Putting these men and women to work would keep money in circulation all the year around and to some extent give the city what it has been needing for years—a weekly payroll.

The members of the Greenville Merchants Association are in sympathy with the movement looking to the setting out and preservation of trees in Greenville. Directors of the organization not only gave their hearty endorsement to the plan but promised their support in making it possible.

With all business and civic clubs working in unison it should not be long before hundreds of young trees are planted in the various residential sections of the city, and many other trees put in a complete state of preservation. This will not only insure shade for the sections affected but will add much to the appearance of the city during the spring and summer months.

The best looking cities in the state are those that have given attention to the trees. There is no reason why Greenville people should permit their supply of trees to disappear when a little attention on the part of an expert would cause them to grow and flourish during the summer months.

The entire citizenship has been called upon to join the campaign, and if the call is obeyed it will not be many years before shade trees will be as conspicuous as their absence is today.

The report of the six months' grand jury of Pitt County Superior court indicates that prisoners at the county jail are not receiving necessary medical attention—at least some of them—to be exact. This is a situation that should receive the immediate attention of those responsible for the physical condition of the prisoners, and if such actually exists it should be improved immediately. A man may be a criminal, but he should be accorded the best care possible while being held in jail. His life is just as valuable as the life of any man to himself and his people, and it is nothing but the plain duty of our officials to see that the prisoners are given adequate attention all through their stay both in prison and on the roads.

Tobacco is beginning to roll into Greenville tobacco warehouses in preparation for the opening of the Eastern Carolina bright leaf market next Tuesday.

The farmers have found that the Greenville tobacco market as in past years has increased its facilities, and at this time is in better position to handle the offerings of the farmers from twenty counties than ever before. Both warehouses and factories have made improvements looking to expediting the sale of the crop, and each day's business will be moved with greater dispatch than previously.

The Greenville market has set 75,000,000 pounds as its goal for the present season, and with the fine crop reported from different sections there is every reason to believe the ambition will be realized. The old record is slightly above the 70,000,000 mark but with the improvements made the past and

present season it should be eclipsed in a much easier manner than anticipated. Every effort has been put forward by tobaccoists, business men and city officials to make the opening one of the most auspicious in years. And people who visit the city that day will find themselves the recipients of every courtesy even though it will be one of the busiest days of the year.

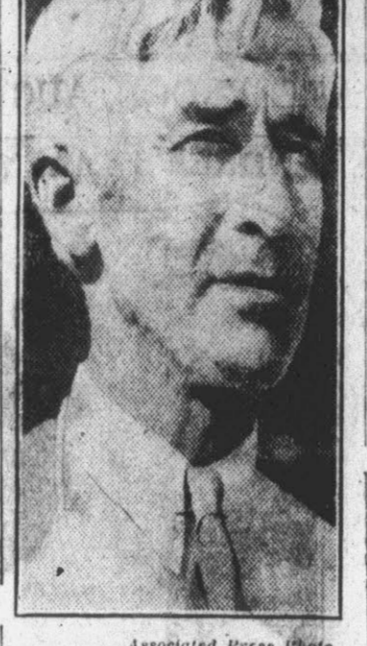

## Revenue Receipts Show a Decrease in North Carolina

Raleigh, Aug. 30.—(AP)—Revenue receipts of the state of North Carolina in both the general and highway funds showed a decrease for the first two months of the current fiscal year under the same period last year, A. J. Maxwell, Commissioner of Revenue, announced today.

Highway funds have shown a decrease of \$185,708.84 for July and August and general fund receipts have decreased \$16,078.69.

During August receipts from the gasoline tax of five cents per gallon decreased \$57,100.76, representing a reduction in sales of tax paid gasoline of more than one million gallons.

License receipts for automobile, sold on a calendar year basis instead of a fiscal year period, show a decrease to date of \$85,566.45 under last year through August.

Highway fund receipts in August 1929 totaled \$1,111,884.47, a decrease of \$113,497.14 under August 1929 collection of \$1,225,381.14. Total highway fund receipts for July and August are \$2,324,221.14, a decrease of \$185,708.84 under the 1929-30 figure for the period of \$2,509,929.98.

General fund receipts for August this year were \$1,365,133.91, a decrease of \$57,796.60 under August 1929 figures of \$1,422,930.51. Total

(Continued from page one) product and return home the same day.

The annual pilgrimage to the tobacco market started the first of this week when the first load of tobacco was placed on the floors of one of the warehouses. Since that time many other loads have arrived and the number will increase to such extent that the golden leaf will actually pour into the city during Monday and Monday night. Tobacco men—hundreds of them from the South Carolina and Georgia markets—are here to receive the

offerings and they will be handled as expeditiously as it is possible to handle such a tremendous volume of business within the space of a few hours.

The trek to the city will reach its height Monday night, and if all indications are correct, the warehouses will be packed to overflowing when the auctioneers begin their rapid-fire sales talk Tuesday morning.

Every business establishment in the city has made preparations to take care of the unnumbered thousands who will flock to the tobacco district during the opening day. City officials have taken every precaution to see that the police department renders the highest type of service in connection with the regulation of traffic. The one hour parking law will be stringently enforced in the business districts in order to keep the streets as clear as possible for the visiting people. Business men who make a habit of parking their cars along principal thoroughfares have been asked to either leave their cars at home or park them around on side streets. This action, it was said by members of the traffic department, would make more room available for the countless thousands who will mill about the tobacco market and along the principal streets during the day.

Everything has been done to make the opening day one of the most auspicious in the thirty-seven years' history of the market, and if the business men, tobaccoists and public officials have their way it will be just that.

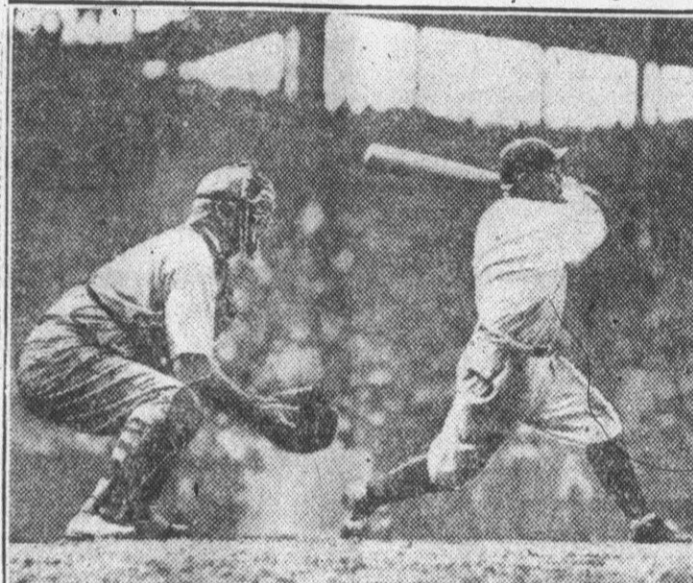

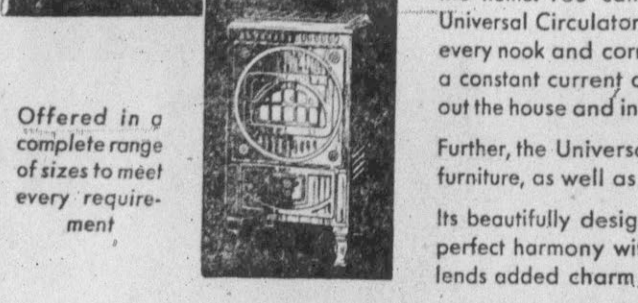
