Federation Of Labor To Ask President To Aid In Unemployment

Convention at Boston Votes to Have Committee Call Upon Hoover With a View to Create a Long Range Planning Committee of Public Works to Avert Future Unemployment

Boston, Oct. 16.—(AP)—An appeal by two young women asking support for the 4,000 striking textile workers in Danville, Va., brought immediate contributions from the delegates to the American Federation of Labor convention today and a promise from President Hoover that the Federation "would rise to the necessity of the occasion."

The women, Mrs. Lucille Humble and Mrs. Della Dilreath, themselves strikers, charged that the Danville workers were overworked, underpaid, and had no right to organize.

Their appeal came after the convention had devoted several hours to unemployment problems and adopted resolutions calling for a long-range planning committee of public works, and further restriction of immigration as measures for relief.

The address of the two striking workers brought tremendous applause from the delegates. The women said they were forced to operate first 16 looms, then 32 and finally 64, that the "stretch out" system had been accompanied by a 10 percent wage cut, and that the workers toiled 55 hours a week for wages ranging between \$8 and \$12 a week.

Boston, Oct. 16.—(AP)—The American Federation of Labor today voted to call upon President Hoover for the creation of a long range planning committee of public works, as a move to avert future unemployment.

The resolution, which instructs the president of the federation and heads of other departments to take up the matter with the President, stated that a long-range planning committee of public works was one of 12 proposals recommended by President Hoover when he served as chairman of a committee appointed by President Harding in 1921 to study future unemployment problems.

The convention accepted a report of the executive council announcing plans for extending its service in publication of unemployment statistics to include on part time employment.

The executive council submitted an optimistic report on national legislation and cited of outstanding importance the failure of confirmation of Judge John J. Parker for appointment to the United States Supreme court.

Declaring that Judge Parker was defeated because of his attitude on "yellow dog" contracts, so-called the council regarded as highly significant the fact that not one United States Senator defended "yellow dog" contracts in the debates upon Judge Parker's appointment.

The report, which was accepted, expressed confidence that the United States Senate would proceed to enact legislation designed to prevent the courts from using "yellow dog" contracts as a basis for injunctions to prevent workers from organizing.

Recent legislation favorable to labor, the report said, included liberalization of the retirement age increases for low paid Federal employees, establishment of hospitals for defective delinquents, provision for parole of prisoners, regulation of employment of Federal prisoners, extension of the vocational education act, provision for free text books in the schools of the District of Columbia, appropriations for rural post roads and creation of the collection of statistics on changes of employment by the Bureau of Labor and Statistics.

Probe Fire Aboard Battleship Colorado

Washington, Oct. 16.—(AP)—The Evening Star said today that the Navy Department believes the fire which disabled the battleship Colorado since June was deliberate and investigators in the guise of seamen have been aboard her in an effort to find the guilty parties.

The paper said Secretary Adams had disclosed the investigation was under way.

Naval intelligence investigators, its account said, had found the fire resulted from a short circuit of electric cables "into which ordinary phonograph needles had been thrust."

TWO PERSONS SLAIN DURING GUN BATTLE

Man and Woman Victims of Fight On Farm Near Walterboro, S. C.

Walterboro, S. C., Oct. 16.—(AP)—A man and a woman were dead today, and the woman's husband was near death as the result of a grim battle in the front yard of a tenant farm in the northwest section of Colleton county late yesterday.

W. W. Cone, who shot to death Mrs. Jacob Nettles and the wounded her husband, was fatally wounded by his own gun when the Nettles' 21-year-old son, Ruthledge, wrestled it from his hands and shot him.

Tuesday Cone, a prosperous farmer, purchased the farm on which the Nettles were tenants at a foreclosure sale. Late yesterday he went to the farm to arrange for eviction.

One of the two survivors of the argument, Bernard Cone, brother of the farm's owner, said when they arrived at the tenant farmhouse, Mrs. Nettles advanced at his brother with a knife. Cone then shot her down.

Meanwhile Bernard Cone was grappling with Nettles and his son, turning from Mrs. Nettles, W. W. Cone shot the woman's husband and killed him.

Beard Cone, fled to his automobile but not before the Nettles' 18-year-old daughter had stabbed him. His injuries were slight.

Young Nettles was arrested later and taken to the Bamberg County jail but last night was removed by Sheriff Lucas C. Padgett to the Colleton County jail here. Bernard Cone also is held in the Walterboro County jail.

The shooting occurred near Lodge a village located at the extremity of Colleton county near the Bamberg County line.

Bishop Cannon Files \$5,000,000 Libel Suit Against W. R. Hearst

Washington, Oct. 16.—(AP)—Bishop James Cannon, Jr. of the Methodist Episcopal church, south, filed a \$5,000,000 libel suit in the District of Columbia Supreme Court today against William Randolph Hearst.

The suit said the New York Evening Journal had printed stories which cast reflections on the character of the present Mrs. Cannon at the time of the death of the Bishop's former wife. These stories, it was said, were printed in other Hearst newspapers.

The principal allegation was that the Journal said Bishop Cannon was at the home of Mrs. Helen Hawley McCallum, whom he recently married, and received telephone messages from his sons as to the condition of his dying wife.

The stories, the suit said, were published on July 24 and 27, this year.

OIL COMPANY MAN TESTIFIES AT SEED PROBE

E. H. Evans of Laurinburg Describes Harmful Effects of Loans

Raleigh, Oct. 16.—(AP)—The practice of large cottonseed oil mills to lend ginners and other mill-money on a "seed refusal contract basis" has had a harmful effect on smaller mills and the lending of such sums has caused an "excessive number" of new gins to be built in parts of North Carolina, the Federal Trade Commission was told here today.

E. H. Evans of Laurinburg, connected with the Laurinburg Oil Company, the Robeson Manufacturing Company of Lumberton and other plants, was on the stand as Walter F. Woode, trade commission attorney, questioned him in regard to the effect lending money by mills to gins had on the cottonseed industry.

The Federal Commission is in the second week of a hearing here as it is investigating, by Congressional direction, to try and ascertain if there has been any collusion between cotton oil mills to "fix" the price of seed in illegal restraint of trade.

Mr. Evans testified that his mills loaned about \$150,000 to probably 30 borrowers during the 1929-30 season.

Asked why the practice of gin loans was started, Mr. Evans replied that it "was forced by competition." He said that he was opposed to the practice and believed that today "everybody is opposed to the practice."

"The practice is bad for the industry," Mr. Evans said, "because the tendency is to enable the man who can make the most loans to get the most seed at equal prices. It gives companies with large financial reserves an advantage over smaller companies."

Mr. Evans, under questioning by Mr. Woode, said that "two or three years ago" some companies pushed the gin loan policy. Asked if he meant the Southern Cotton Oil Company and the Buckeye Company, Mr. Evans replied "yes."

Mr. Woode asked Mr. Evans if the Buckeye Company was not the only company "standing out strong" today for the gin loan policy, but Mr. Evans answered "I won't say."

Why the practice, which has been condemned by various resolutions adopted in the southeast, had not been condemned in North Carolina came in for airing. Mr. Evans said the matter had "never been pushed." Mr. Woode apparently attempted by questioning to show that the reason it was not condemned was because the Buckeye and Southern companies practiced it.

Gin loans, Mr. Evans testified, have increased the building of new gins in the state. He said that in his own territory this had not been to an "excessive extent" but that ginners, mill men and statisticians had seen gave him the understanding there had been "right many in other territory."

Questioned further Mr. Evans said it was his understanding "that in those territories it had been to an excessive extent."

Locate Plane Lost In Wyo, Blizzard; Flier Believed Dead

Cheyenne, Wyo., Oct. 16.—(AP)—The Boeing pursuit plane piloted by Lieut. William W. Caldwell, army flier, lost Wednesday in a blizzard near Laramie, was sighted at 8:15 A. M. (M. S. T.) today by Ray W. Meskimen, flying an eastbound air mail plane.

The plane was seen by Meskimen at Lookout, 28 miles north of Laramie. The air mail pilot reported his discovery upon his arrival in Cheyenne. He said Caldwell had crashed.

The territory in which the army flier crashed is rough and hazardous for landing.

The ground is covered with sage brush and is rolling. Two planes were sent from Cheyenne to learn Caldwell's fate. The ships were piloted by John Cobler and Pilot Boyd.

Officials were fearful Caldwell lost his life because of the fact they had not heard from him although he crashed near farms where telephone communication was available.

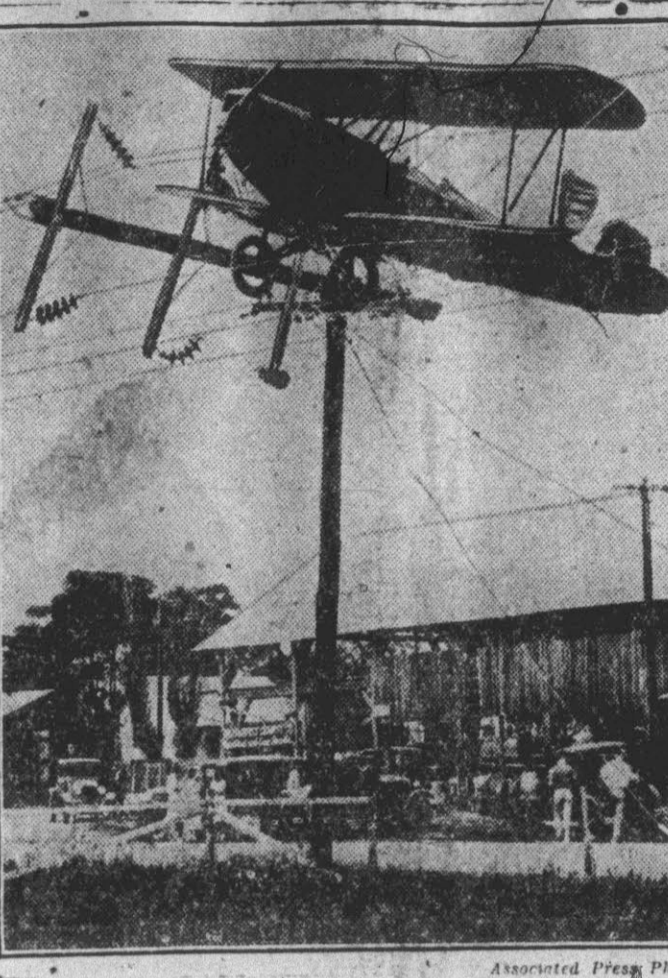

German Chancellor Make Plea For National Unity Amid Howl From Fascists

Bruening Constantly Interrupted by Communist Turmoil During Address Before the Reichstag; Pleads for National Reconstruction

Berlin, Oct. 16.—(AP)—Amid a turmoil of Communist interruptions and occasional howls of derision from the Fascists, Chancellor Bruening today appealed to the German people, through the Reichstag, to buck up, swallow the bitter medicine of Retrenchment, put their shoulders together and get on with the hard but necessary work of national reconstruction.

"The present crisis demands above all moral strength and courageous co-operation of all who love the Fatherland," he declared as he outlined the cabinet's program of financial reform before the Reichstag and asked for clear and unequivocal support.

Defiant of Communist interruptions and with a heavy guard of police around the Reichstag building to prevent repetition of Monday's rioting, the chancellor also declared that the dictatorial financial decrees of last July must not be abrogated.

There had been fears that the Fascists and Communists might prevent the chancellor from delivering his speech. Within five minutes of the beginning of today's session, disorders began and there were Communist cries of "down with the hunger dictator."

However, the chancellor played quickly into his address and was able to continue with the exposition of the plans which he and his cabinet had made to pull the German republic through the political crisis.

Although that world-wide economic depression had struck Germany especially hard, he said the government would submit its plans in the form of a bill.

With reference to foreign policy, the chancellor asserted that the German government would pursue its program of restoring Germany to moral and material equality with other nations, as heretofore by peaceful means.

Rebuking the critics of the peaceful approach program of the late Foreign Minister Stresemann, the chancellor said that his government declined to be a party to any policy of adventure.

FRIDAY WILL BE CHILDREN'S DAY AT FAIR

Tomorrow Set Aside for Entertainment of School Children of County

Friday has been designated "Children's Day" at the Pitt County fair and thousands of children from this and other counties will be admitted free of charge during the day. This is the second occasion of the kind observed by the fair management this season. Several thousands school children were guests of the fair Tuesday, and the midway was thronged with uncounted thousands both day and night.

Secretary Dail said today that special attractions would be offered Friday for the amusement of the children. Greenville city school will observe a half holiday as they did Tuesday, and the students will again be given an opportunity to visit the fair grounds to witness the hundreds of things collected for their amusement.

Fair officials expected large attendance today. Thursday is always one of the big days of fair week from the standpoint of attendance, and the grounds were expected to be well filled both afternoon and night. The awarding of prizes for the various exhibits was completed during the morning hours today, and a complete list of the prize winners will be made public tomorrow.

Exhibits of the home school and farm have attracted considerable attention from the thousands of visitors attending the fair from day to day. The showing in the agricultural building was described as one of the most complete in years. In fact, according to E. F. Arnold, director of the Pitt County Agricultural Department, who is in charge of the agricultural building, there are three or four more booths than last year.

Mr. Arnold expressed appreciation of the splendid showing made by the men and women of the farms throughout the county. He was particularly impressed with the "live-at-home" exhibit, carrying out the idea of Governor O. Max Gardner for producing more of the things consumed at home. He said this department had been a source of interest to the people from remote regions and furnished them with a fairly good idea as to what Pitt county is doing in the way of improving conditions among the farm people of the State.

In the main exhibit building, the skill of the housewives of Pitt county is more playfully in evidence than ever before. This department, under the direction of Miss Ethel Home, head of the county Home Demonstration office, is featuring a collection of exhibits showing what the club women of the county have been doing. Exhibits of the county schools in the same building attracted wide-spread interest, especially among those interested in the educational advancement of the county.

The showing in the livestock building has attracted considerable interest among people interested in this rapidly developing industry. At night the throngs of people along midway have been treated to one of the most complete fireworks displays in years. The program begins every night at eight o'clock, and will continue every night during the remainder of the week.

SPORTS SLANTS

One of the big surprises of the college football campaign is the Vanderbilt Commodores, coached by Col. Dan McGugin, manhandling the rugged Minnesota boys right in front of the home-town onlookers at Minneapolis.

It appears that most of the concentration tossed into the Gopher ranks was thrown by a 145-pound substitute quarterback, Johnny Asbew. I have this eye-witness report of the proceedings from Jay Vesceles:

"This little scrapper, coming into the game as a substitute in the second period, ran the tackles and the ends and threw and received forward and lateral passes until he had Minnesota punch drunk. He scored three touchdowns and raced 65 yards through the whole Minnesota team for a fourth one only to have the play called back because of a penalty.

This little one-man cyclone had a good line and an alert backfield to help him, but he could, and did, do plenty single-handed. He stayed erect through a terrific mauling, leaving the field in the fourth period while the stands stood and gave him a wonderful ovation.

"Asbew was a real personified. He not only scintillated himself but he drove the whole Commodore outfit in an amazing display of generalship.

"If Little Johnny Asbew does become one of the Southern conference's greatest stars of the season, 35,000 Minnesota fans who saw him in action will know that their eyes are good and that it wasn't an optical illusion after all."

Vanderbilt's fine victory and Southern Methodist's great exhibition against Notre Dame more than offset the defeat of Tulane, 1929 Southern Conference champion, by Northwestern in the inter-sectional warfare waged by the south in the mid-west in one afternoon.

The chatter during the world's series was that Northwestern had a team plenty good enough to cap-

ture the Big Ten championship this year. The Wildcats of Evansville have a powerful array with one of the best backs in the conference, Hank Bruder, to "carry the mail" when yards are needed.

Vanderbilt has a guard named Marlon Talley but the Minnesota forwards discovered quickly that he sings oases.

The Red and Black ball carriers have an impressive record for this season, but the Tar Heels argue that action and not records will football games and are going to Athens primed for action.

The Tar Heels will go into the game rated the underdogs. If they lose, it will be no disgrace. If they win, it will be remarkable.

Word from the Duke camp is that the Blue Devils have discovered how to work an aerial attack; they hope to display to advantage against the Navy at Annapolis. Uncle Sam's sailor boys have not been particularly impressive this year but nevertheless they are rated by a substantial margin over Duke in the inter-sectional class.

Coach Jimmy DeHart will pin his faith in the pass game on Murray, a halfback tosser of no mean ability, and Rosky, Watt, and Eshler, who will serve as Murray's targets.

While DeHart is striving for a greater offense, Collins is attempting to mold a better defense. The North Carolina mentor, with his score or more of excellent ball carriers, has no fear of his team's ability to score under reasonable circumstances.

Duke is busy polishing up its aerial offensive for the test. Navy won last year 45 to 2.

The program for this week-end gets underway a day sooner than usual with Wake Forest tackling North Carolina State at Raleigh, N. C. this afternoon and Millsaps embarking upon S. I. A. A. competition with Stetson of Florida at Jackson, Miss.

"Wop" Glover, mighty backfield midget, is shaping up as a real star as Tulane preps for Birmingham-Southern. He is a triple-threat man. Vanderbilt, looking ahead to the Alabama game of a week hence, is concentrating on passing, but will probably keep its new tactics under cover during Saturday's tussle with Spring Hill.

Alabama, hoping for its first victory over Tennessee in a rivalry that began 17 years ago and has been renewed three times, continued to bear down in practice. Up at Chapel Hill, N. C., Carolina supporters ranked the Tar Heel backfield the equal of Georgia's ball carriers and concentrated on bolstering up the forward wall for Saturday.

Asheville, Oct. 16.—(AP)—The residence to be occupied by Mr. Hoover, "Blue Briar," was constructed by William F. Randolph, who sold it to the E. W. Grove interests.

The Grove interests sold it to C. P. Hyman, Asheville realtor, who later sold it to Henri Berger, wealthy financier of Asheville and Paris, France.

The house is located in the city limits and commands a fine view of Asheville.

The Hoovers took a six-month lease on the property with a renewal clause of six months.

Son of President Will Receive Treatment At Mountain City, Later In Fall

Washington, Oct. 16.—(AP)—Herbert Hoover, Jr., who is suffering with tuberculosis at the Hoover lodge in Virginia, is to be taken later in the fall to Asheville, N. C. for treatment.

Captain Joel T. Boone, the White House physician, announced today that a home on Sunset mountain overlooking Asheville had been leased by the son of the President and he would be taken there early in November.

The site was selected over other localities believed by Dr. Boone to be climatically favorable for treatment of tuberculosis largely because of its proximity to Washington and the patient's family.

Dr. Boone said the President's son has responded well to treatment and has made satisfactory progress since he was taken to the Presidential camp in the mountains of Virginia several weeks ago.

Dr. Boone issued the following statement:

"It has been decided that Mr. Herbert Hoover, Jr., will go to Asheville, N. C., later in the fall. The President's camp is not constructed suitably for winter use. This fact necessitates the change of location for the treatment of Mr. Herbert Hoover, Jr. He has leased property on the outskirts of Asheville on Sunset mountain.

The United States abounds in many localities climatically favorable to the treatment of tuberculosis. This section has been selected as meeting the many requirements of this particular case. Its proximity to Washington will afford accessibility to the patient's family.

"Mr. Hoover has responded gratefully to treatment and has shown

satisfactory progress."

For a time late yesterday, members of the posse believed they had the abductor surrounded in a dense woods near Stockton. After several hours for additional help, they searched in vain for the man, who told Mrs. McKinley he was a former convict and would rather hang than return to prison.

Because of last night's downpour, investigators said today the blood-hounds would be of no further aid to them. Dogs from Springfield have been sent home.

Although Mrs. McKinley, in her high school days at Greenfield ranks as the greatest woman basketball player in the world, talked freely of her experiences, she refused to confirm a report she had agreed to pay the kidnapper \$10,000 after her release.

The abductor treated her with "utmost respect," she related, "and before he finally let me go we became downright confidential."

Although the kidnapper, who invaded the Wilson home Monday night armed with a sawed-off shotgun and forced Mrs. McKinley to drive away in her own motor car, reportedly told her about "the gang" investigators today were inclined to believe he worked alone.

Mrs. McKinley and her mother yesterday viewed roguish gallery pictures from the Kansas City police department. Mrs. Wilson, who was bound and gagged by the abductor, said "I'm positive that's the kidnapper," when shown one of the pictures, but Mrs. McKinley was uncertain.

"I looks like the man," she said. While being held by her abductor, Mrs. McKinley said, he repeatedly assured her he would guard her "with my own life" and told her he would be "bumped off" by "the gang" if he tried to prevent them from killing her if relatives did not post \$50,000 ransom.

PROVIDE JOBS FOR IDLE MEN THIS WINTER

Financial and Business Leaders Pledge \$150,000 Weekly Payroll At N. Y.

New York, Oct. 16.—(AP)—In order to provide 10,000 idle men with jobs during the winter months, a number of financial and business leaders have pledged themselves to raise a \$150,000 payroll weekly.

Meeting at the offices of Steward Prosser, chairman of the board of the Bankers Trust Company, the group formed an emergency employment committee to raise the money which will be distributed through the Charity Organization Society and the Association for Improving the Condition of the Poor.

Miss Ann Kempshall, superintendent and assistant director of the Charity Organization Society, said arrangements have already been made with the Department of Parks to supply 3,000 to 5,000 men for work in the parks of Manhattan, the Bronx and Brooklyn, and that other work would be found.

The park employes would be paid \$3 a day, she said, on a five day week basis, giving each man \$15 a week, the lowest wage charity organizations consider possible for a family to live in New York.

Mr. Prosser said the two relief organizations have been receiving extraordinary demands because of unemployment. He declared the effort of his committee to raise funds for the societies would be in addition to the regular appeals of the organizations.

Every man at the meeting, he said, agreed that the present unemployment situation was of such a nature that it constituted a definite civic responsibility.

"The problem," he said, "is of course, a vast one that its efforts cannot meet the situation entirely. It is our hope that municipal, state and national authorities will do the most to carry on a program of new public works which will create new sources of employment and that all employers, whether corporations, firms, or individuals, will also accept their responsibility by maintaining as complete payrolls as possible and by undertaking new construction, improvements, repairs, etc., that ordinarily might be postponed until another year."

Fifteen Suicides In North Carolina During September

Raleigh, Oct. 16.—(AP)—Suicides in North Carolina in September numbered 15, the Bureau of Vital Statistics of the State Board of Health reported today, and violent deaths in the state totaled 141 in September.

There were 34 homicides, 16 accidental drownings and nine deaths from burns or conflagrations.

The Bureau of Vital Statistics had 49 automobile fatalities reported to it, five less than the 54 reported by the State Motor Vehicle Bureau, which lists all deaths in automobile accidents, while the vital statistics bureau only lists North Carolinians.

The birth rate in the state for September was 24.1 per thousand population; the death rate was 10.1 and the death rate for infants under two years of age was 1.5 per 1,000.

There were 149 tuberculosis deaths and 100 fatalities from pellagra in the state in September.

ABOUT TOWN

By order of the Sheriff of Pitt County, gambling devices at the Pitt County fair have been closed. The order came after complete investigation by the sheriff in which it was found that legislation prohibiting the operation of gambling places was being flagrantly violated.

That the action of the sheriff will receive the approbation of the public cannot be questioned. The operation of gambling places in full view of the hundreds of children who attend the fair from day to day does not tend to have a salutary effect upon the community and it was nothing but proper that all places featuring games of chance should have been closed.

The sheriff not so very long ago started a campaign against gambling in Pitt county by the seizure of several slot machines in stores of the towns and out in the country. Since that time he has kept his eye on this form of gambling with the hope of reducing the practice to a minimum if possible.

While numbers of counties permit the operation of gambling devices at fairs, it is a direct violation of state legislation looking to a curbing of this form of crime, and the sheriff is to be congratulated upon his effort to keep Pitt county within the law.

The Sheppard Memorial Library, which is to be formally thrown open to the public Friday night at 8 o'clock, is considered one of the finest structures of the kind in North Carolina.

The building is a memorial to the father of Mr. Harper D. Sheppard, of Hanover, Pa. Mr. Sheppard presented the city with \$600,000 for the building and furnishings and the City School Board presented the Library Commission with the Evans street school site upon which to erect the building. The site was valued at approximately \$40,000. This brings the total investment to the \$100,000 mark.

Greenville people are proud of the new building, and they will have ample opportunity to express their appreciation to Mr. Sheppard when he attends the formal opening. The building has certain community features which make it of far greater value to the city, and people in all walks of life, from the Boy Scout to the business executive, will find something to his benefit behind the walls of the beautiful building.

The exercises Friday night will feature the presentation of the building to the city and its dedication as a memorial to the father of Mr. Harper D. Sheppard, a native and one-time official of the county. It will mark the realization of a great dream on the part of members of the Library Commission and other citizens who have labored long and lovingly in behalf of making the library what it is today.

Greenville high schools copped the third game of the season from Farmville last Friday afternoon, showing conclusively that the boys really mean to come out at the end of the season with a majority of victories to their credit.

\$176,624 Shortage In Account of Late Durham Sheriff

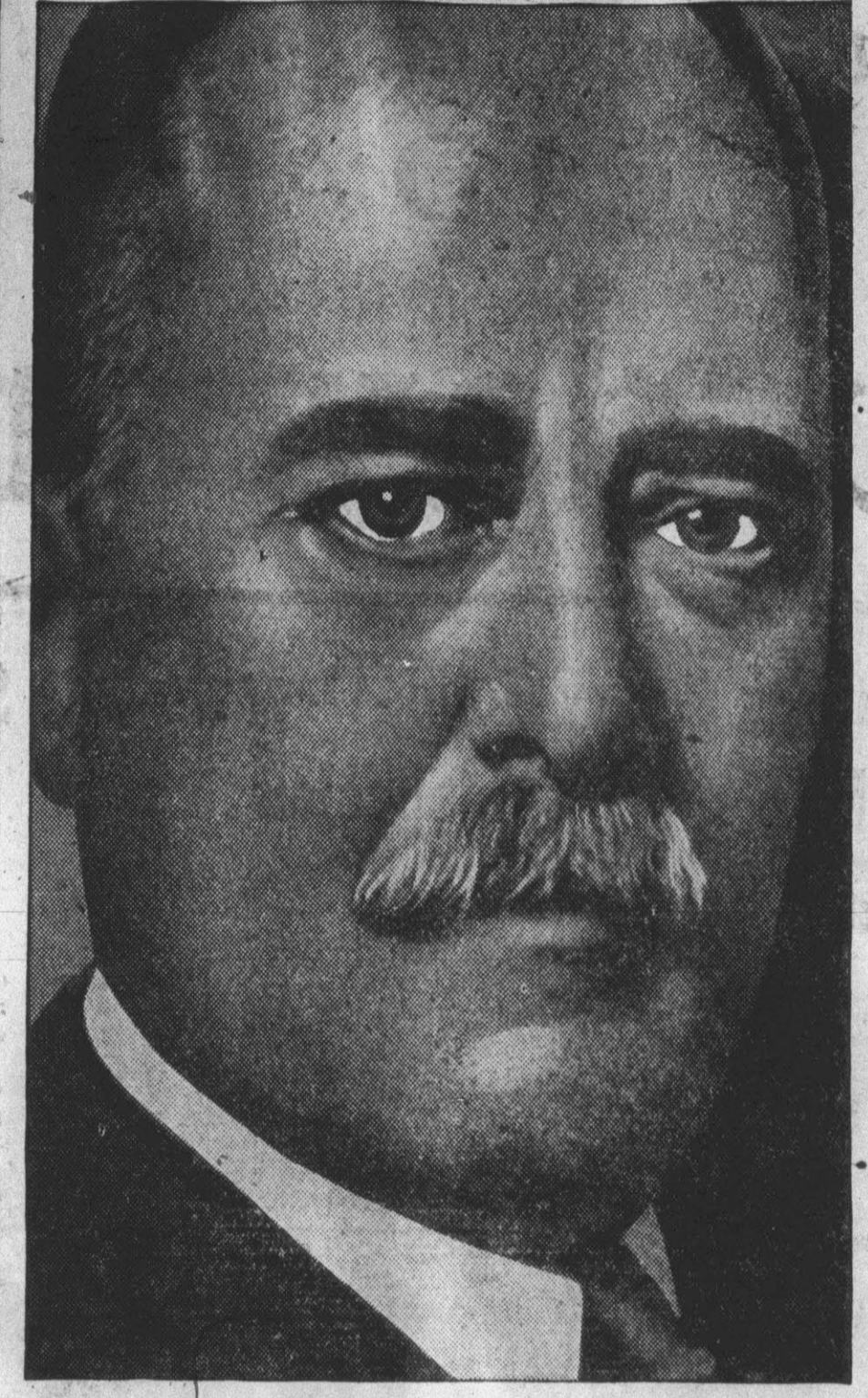

BUILDINGS ON AN INCREASE IN THE U. S.

Building Permits for September Show Increase Over Previous Month

Washington, Oct. 16.—(AP)—Government financial leaders regard with interest recently compiled figures showing an increase in building permits for the United States as a whole of 6.5 percent in September over August, the first increase in September compared with August since 1917.

Building permits are looked upon by some fiscal experts, as among the reliable indices of business conditions. However, the encouragement over the September increase is offset partly by the fact that building permits for this September amounted to only \$135,437,000 compared with \$173,307,852 last September.

While government officers point hopefully to the building permits figures they are still saying nothing about general business conditions.

A non-governmental predictor that the present slump will continue for the rest of the year and that industrial production will not reach normal before April was made here last night, however, it came from Lawrence H. Sloan, vice-president of the Standard Statistics Company of New York in the course of an address before the society of industrial engineers. He held that as a seasonal basis alone the signs were distinctly against sustained improvement.

The value of the residential building permits for September was lower than for any September since 1920 when the figures for 16 cities showed a total value of \$96,763,823.

But the increase in September over August of this year is receiving attention. Also it is said the decrease in September this year over September last year is the smallest in percentage noted for any month since October of last year.

STOCK MARKET

New York, Oct. 16.—(AP)—Share prices drifted moderately lower in a sluggish market today, as readjustment from last week's convulsions seemed to have been completed, and Wall Street enjoyed a breathing spell.

Declines of 2 to 3 points were recorded in such issues as General Electric, U. S. Steel, Westinghouse, Air Reduction, Allied Chemical, Johns Manville, American Telephone American Can and Eastman but the decline was checked by early afternoon, and these were moderately reduced. Gillette was a strong feature, making an extreme gain of more than 7 points, and Warner Bros. and consolidated film industries gained about 2 points each.

Pressure against General Motors for a time during the morning was a little unsettling, but extensive selling caused a decline of only 1 1/2 points and the stock then recovered somewhat. It was said in brokerage circles that the selling merely represented the liquidation of a large speculative account. Most of the day's selling was regarded as profit taking on stock bought at last week's lower levels.

Strength of Gillette reflected announcement of the completion of the plan to acquire Autostrop. The announcement indicated that after the merger is completed, Gillette will be placed on a 54 annual basis as reduced from \$5, but Wall Street had expected a reduction in the dividend and brokerage gossip had indicated that the reduction might be larger.

While business news has not been as bad this week as last week's extreme pessimism had indicated, the commission houses were inclined to advise their customers to move cautiously, for analyses by statistical advisory services this week have stated that sound recovery cannot be hurried.

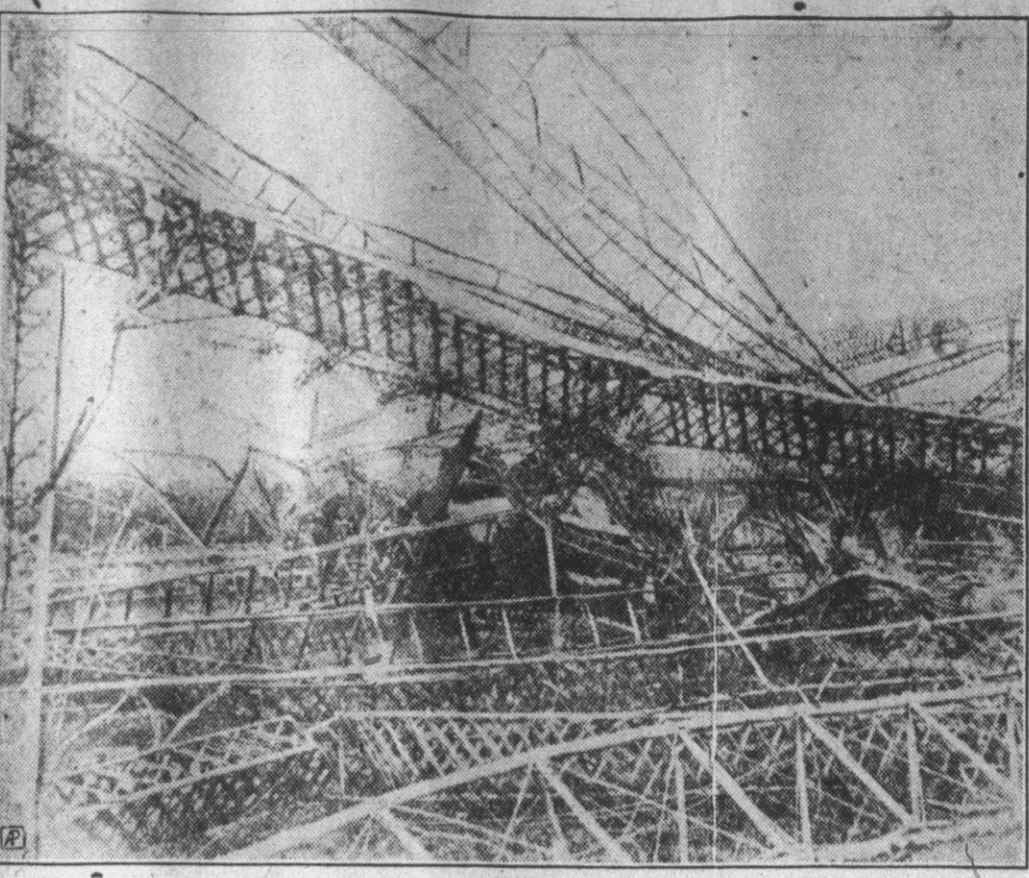
