KING GEORGE OPENS BRITISH PARLIAMENT

MacDonald Government Makes Bid for Retention of Office At Session

London, Oct. 28.—(AP)—The MacDonald government, through King George today made a definite bid for its retention of office by advocating electoral reform long demanded by the Liberal party which holds the balance of power. The maneuver was executed at the opening of parliament.

King George, recovered from his long illness, convened parliament for its winter session with all the pageantry customary for the occasion and read the five minute speech from the throne, in a firm resonant voice.

International relations, India, unemployment, electoral reform and laws relating to trade disputes and trade unions were the high spots touched upon by his majesty in the speech by which the Laborite government has now outlined its program before parliament.

While the king's speech, which was written and composed for him by Mr. MacDonald and his minister, merely mentions that an electoral reform measure will be submitted, the measure probably will include the liberal proportional representation scheme. Such a scheme would give them representation in the Commons far in excess of their present membership, which is limited by reason of three cornered constituency races, in which, although the Liberals always poll a large vote they usually are behind either Conservatives or Laborites or both.

The scene in the House of Lords, where King George and Queen Mary sat before assembled peers, peeresses and commoners of their realm, revealed all the time-honored pageantry of the occasion. His majesty read his address in firm steady tones, indicating full restoration of his health.

Previously he had ridden bareheaded in a long gray great coat, with Queen Mary by his side, in the royal gilded coach through London from Buckingham to Westminster. Thousands lining the streets cheered the two royal figures. Queen Mary responding to the applause with occasional bows and a constant smile. After the half-hour ceremony in the House of Lords they reentered the royal carriage and returned to Buckingham.

Daughter of Late President Dead

Washington, Oct. 28.—(AP)—Relatives here this morning announced receipt of word that Mrs. James Robert McKee, daughter of President Benjamin Harrison, died early today at her home, Berkley Lodge in Greenwich, Connecticut.

Mrs. McKee was Miss Mary Scott Harrison, only daughter of the former president and his first wife, Caroline Scott Harrison. She had been ill since the middle of February when she underwent an operation in New York.

For many years she was a prominent figure in charity and club circles in New York and Indianapolis. Before her marriage she was known as one of the belles in Washington society. With her children she stayed at the White House for the greater part of her father's regime as president, and was mistress of the mansion during her mother's illness and after her death. She was the cause of a storm of criticism before her mother's illness by inspiring the first dance to be held in the Executive Mansion. At that time such frivolous entertainment was considered by many to be undignified for the presidential home.

Mrs. McKee probably will be buried in Indianapolis.

After her hearing in Police court, at which she was ordered held with cut bond for murder, police said she turned to friends and ordered "go get me some cigarettes".

S. I. DUDLEY AIRS HIMSELF ON TAX ISSUE

Replies to Tax Reduction Statement By Other Nominees to County Board

S. I. Dudley, Democratic nominee for the County Board of Commissioners, in a statement issued today declared that the reason he did not sign the statement on tax reduction, issued last Saturday over the signature of the other nominees to the board was because it was too indefinite and meant nothing to the voters.

The statement follows: Mr. W. E. Hooks, Chairman Pitt County Democratic Executive Committee, Ayden, N. C.

Dear Mr. Hooks: At your request, my reason for not signing the statement of H. V. Slaton, T. E. Joyner, H. T. Stokes and F. L. Gaskins, Democratic nominees for County Commissioners, is:

Their statement is too indefinite. They state "That we will do all within our power to reduce taxes and cut expenses in every way possible." To the voters that means nothing. There may be no agreement among them, therefore, they may say it is not possible to reduce taxes and expenses. They have had access to the budget ever since last July and can state now definitely what they will do. Why do they not do so?

I re-state my position. I shall do all in my power to reduce county expenses and taxes as follows, on the basis of 1930 budget:

1—County roads and county home expenditures, 50 per cent.

2—All other expenses of the county, 25 per cent. except:

3—Bonds, interest and sinking fund at par.

I have previously made a similar statement to you as chairman of Pitt County Democratic Executive Committee and I am pledged by conviction to stand by that statement and I decline to sign any paper less specific. It has been stated by the side which seems to oppose tax reduction that the foregoing advocated by Pitt County Tax Relief Association, is impossible. That statement is an opinion. I state that the present tax rate is impossible. That is a fact borne out by records of the Board of Commissioners and the Sheriff of Pitt County. Which shall we do, bring the expenses of Pitt County within the ability of the people of the county, or continue our impossible tax rate and take the consequences? If Pitt county wants reduction of expenses and taxes, elect me a member of the Board of County Commissioners and give me support and such reduction will be made.

CANNON IS IN HOSPITAL AT CAPITAL CITY

Bishop Suffers Acute Attack of Neuritis and Inflammatory Arthritis

Washington, Oct. 28.—(AP)—Bishop James Cannon, Jr., of the Methodist Episcopal church, south, is undergoing treatment at a local hospital for an acute attack of neuritis and inflammatory arthritis.

The churchman's condition is complicated also by other nervous disorder brought on in considerable measure, attending physicians believe, by the pressure of difficulties which have surrounded him in recent months. One or two months of rest and hospital treatment will be required to restore him to health.

The attack of arthritis is a recurrence of an ailment from which he has suffered in the past. It was to ease the pain this caused him, the bishop carried a crutch during the stormy sessions of the Senate sessions of the Senate Lobby committee last winter. On it he stumped from the committee room one day when he refused to answer the Senators' questions. However, Dr. R. Lyman Sexton, in charge of his case said today the arthritis was not a chronic affliction and would yield to treatment.

Bishop Cannon has been under special strain since his recent return from Brazil. He hurried back to this country to meet charges filed against him within the church by four ministers. He will defend himself against these later if they are made the basis of a church trial.

Within the last few weeks legal steps have been taken against one of his sons, R. M. Cannon, of California, in connection with financial difficulties. This, the bishop charged, was one of a series of attempts to persecute him and his family.

Soon thereafter the bishop announced he was filing a suit for \$5,000,000 damages against William Randolph Hearst, alleging libel through the publication in some Hearst newspapers of stories dealing with his recent marriage and other matters.

DANIELS WILL CAMPAIGN IN CITY TONIGHT

Former Secretary of Navy to Speak At Court House At 7:30 O'clock

All arrangements had been completed today for the appearance here tonight of Hon. Josephus Daniels, of Raleigh, Secretary of the Navy during the Wilson administration, who will deliver the third address of the Democratic campaign in this country.

The coming to Greenville of Mr. Daniels has attracted considerable interest, and W. E. Hooks, chairman of the Democratic Executive Committee of Pitt county, stated he expected a capacity attendance. The address will take place at the court house at 7:30 o'clock. W. E. Hooks will preside over the meeting and M. K. Blount will introduce the speaker.

Mr. Daniels has visited Pitt county several times in past years, and is well-known throughout the county. He is considered one of the leaders of the party both in the State and Nation and has played an important part in past campaigns both through the press and from the platform.

Mr. Daniels has spoken in other sections of the State during the last three weeks, and has been accorded much interest and large attendance at each place he has appeared. He will tell the voters here tonight of the splendid record of the party in this State, and bring out several points of the campaign which are not so generally known.

The campaign was opened in Pitt county last Friday by Josiah William Bailey, of Raleigh, Democratic nominee for the United States Senate, who told the voters of the achievements of the party in past years, and mentioned some of the shortcomings of the Republican administration.

The second address was delivered in Ayden last night by Attorney General Dennis G. Brummett, who spoke at considerable length on the tax question and brought out the fact that little reduction of the tax burden could be expected from the Republican party.

Lindsay Warren of Washington, Congressman of the First District will carry the fight into the Black Jack territory Saturday night when he is scheduled to deliver an address at the school building at that place at 7:30 o'clock. This is the first time Mr. Warren has appeared in Pitt county, except to introduce Mr. Bailey, during the present campaign, and Mr. Hooks expects Black Jack people to attend the speaking in large numbers.

PRES. HOOVER BRANDS KELLY OIL CHARGES

Says Allegations Attempt to Cast Odious Scandal On Administration

Washington, Oct. 28.—(AP)—President Hoover today denounced as an attempt to fasten an odious oil scandal upon his administration, the charges by Ralph S. Kelly, former head of the Denver field force of the Department of Interior that oil companies were obtaining valuable oil shale lands illegally from the government.

The president said that while publication of the Kelley charges in the newspapers did not represent the high standard of American journalism, the newspapers might have been misled. He said Kelley or the newspapers publishing his stories could have determined the falsity of the charges by investigations.

Mr. Hoover said that though Kelley came to Washington last July and arranged the sale of his story to a newspaper his charges were delayed so they could be put into the political campaign. He said the newspaper that purchased the story was of political faith opposite to his own.

Kelley, in Mr. Hoover's opinion, could himself have established the falsity of his charges by reference to his own records.

Instead of 8,000,000 acres of oil titles worth millions of dollars being approved by this administration there have been only 43,000 acres of titles granted and these could be bought, the Chief Executive added, for a few dollars an acre.

Of the 43,000 acres, the President said, 20,000 had been approved by Kelly himself.

The President said a proper inquiry and sound criticism by the press was a safeguard of good government, but in this instance the newspaper charges, which Kelly's story which he did not name, had gone further and apparently had made no effort to substantiate Kelley's charges.

Mr. Hoover pointed out that Kelley was in Washington for six weeks last year and during that time made no reference to the charges to his superiors. Simultaneously, the president added, Kelley was negotiating for the sale of these charges to rival political party and even then held them un-til some weeks so they might be launched in the middle of the political campaign.

When charges unsupported by evidence of a man of the character of Secretary Wilbur have been made, the President said, they should do more damage to those who make them than to the man attacked.

Kelley first made his charges a month ago today in a statement to the press. At the same time he announced his resignation after more than 25 years service in the west.

Secretary Wilbur refused to accept the resignation and suspended Kelley pending an investigation which he asked the Justice Department to make.

Attorney General Mitchell on Monday reported Kelley's charges to be unsubstantiated.

Bishop Dies At Opening Session of Parliament

London, Oct. 28.—(AP)—The Rev. Ernest Harold Pearce, Bishop of Worcester, died today in the midst of ceremonies at the opening of Parliament.

The bishop, a spectator, was in the crowd outside of the House of Lords when suddenly taken ill. He was removed to Westminster hospital and on his arrival there was found to be dead.

The bishop, who was 65, was widely known as a scholar and preacher. He was assistant chaplain general during the war years and was chaplain to the king 1913-19. He was the author of several books on church history.

Probe Killing of Golf Links Owner

New York, Oct. 28.—(AP)—Police were investigating today the killing of a miniature golf link owner who was taken for a ride in his own car in the Bronx.

Joseph Fuernman, 40, was dumped out of the automobile into West 174th street, last night with several bullets in his body. He died in a hospital a few minutes later. Police found his car abandoned a short distance from the scene of the shooting.

His wife said he was part owner of a miniature golf links. Police are investigating on the theory that the killing might have resulted from an attempt of racketeers to "muscle in" on the miniature golf business.

Tobacco Market to Sell Out Here During Afternoon

The Greenville tobacco market yesterday sold 1,360,322 pounds of tobacco for \$233,755.14 an average of \$17.18 per hundred pounds, according to official figures of K. W. Cobb, supervisor of sales. The report said there was approximately 800,000 pounds of leaf here today with indications that sales would be completed by three o'clock.

Several Other Actions

Arthur Johnson, Greenville negro was sentenced to from 18 months to two years in the penitentiary on a charge of forgery by Judge Walter Small, of Elizabeth City, in yesterday's session of the criminal term of Pitt County Superior court.

The negro, a former employee of J. Key Brown, local druggist, was charged with forging the name of Mr. Brown mailed to Greenville while away from the city several months ago.

Several other cases were disposed of during the opening session yesterday, and the grand jury returned a number of true bills.

Willie Thigpen, colored, charged with being drunk, paid a fine of \$50 and cost.

Jack Celville, charged with running his automobile into another car driven by Carl Langley, was ordered to pay \$30 damages. Dorsey Godley, charged with stealing a canoe, was adjudged not guilty.

John Gurganus was found not guilty of giving a worthless check. The grand jury returned true bills in the following cases: Robert Oakley and John Atkinson, breaking and entering. Roger Williams, setting fire to a filling station in the Falkland community.

REDS CAPTURE CHINESE CITY OF HANCHOW

**Hundred Slain and
Fate of Two Ameri-
can Missionaries Is
Undetermined**

Hankow, Oct. 28.—(AP)—Communists were reported today to have captured Kanchow, northern Hunan province, where they killed 100 Chinese. The fate of two American missionaries, one man and one woman, stationed at Nanchow, was not learned.

The local government station's calls to Kanchow went unanswered, leading to the belief the Reds had interfered with the Kanchow station, which is within the walls of the city.

Kanchow is a city of 250,000 population, poorly defended with only 1,000 troops forming the garrison. The city is four days march from Kian. At the latter city recently Red leaders indicated to Bishop Magani and Father De Jennis, Catholic missionaries, that they planned to invade southern Kiangsi. The two missionaries took this information to Kiangsi, Kiangsi, when they were released by the bandits to obtain ransom for fourteen other missionaries held as hostages.

There are thirteen foreign missionaries at Kanchow. Six are American Catholics, five British and two German protestants. All of the Americans are priests of the Vincentian Order. Bishop O'Shea of Germantown, Pa., heads the Catholic group.

A message from Shuchow, northern Kwangtung province railroad center, today stated the American priests, Fathers John McLaughlin of Brooklyn, N. Y., who were stationed at Nanchow, Kiangsi, left that city October 9, crossed the Kwangtung border and were heading for Canton.

Kiangsi province was fast becoming the center of China's Communist movement, virtually the entire province was overrun with peasant class Reds while Communists constituted the provincial government, functioning in almost every district.

The principal Red stronghold was reported situated northeast of Kanchow on a plateau fifty miles square and approached only by a narrow pass between high precipices. The entrance was said to be well guarded.

Italy Celebrates March of Fascists

Rome, Oct. 28.—(AP)—All Italy celebrated the eighth anniversary of the Fascist march on Rome. The day was observed as a general business holiday, with public buildings decorated. All members of the Duce's party turned out in black shirts with war and Fascist decorations.

Premier Mussolini in full uniform of an honorary corporal of Fascist militia, was the central figure in a march of veterans in Piazza Di Siena on Pincian Hill here. The veterans proceeded down the Corso Umberto, central thoroughfare of the city, to Piazza Venezia, where homage was done to the unknown soldier.

Later 80 planes executed maneuvers over the city. Bombers were 300 meters up, reconnaissance planes 600 meters up and pursuit planes 800 meters up.

Tonight the historic castle of St. Angelo will be outlined in a fireworks display. Films portraying achievements of the regime will project into the principal squares.

Fate of Kidnapped Banker Rests in the Hands of His Wife

Galva, Ill., Oct. 28.—(AP)—The fate of Earl Yocum, kidnapped banker, rested today in the hands of his wife.

The banker's wife announced that she had called off all outside help in the search for her husband, who disappeared Saturday, and that she was "handling the matter herself." She termed speculation that her husband was held in Chicago

for \$50,000 as "all guess work" and added that no one, except herself, had any knowledge of the supposed ransom demand.

Meanwhile, county authorities abandoned their hunt for the missing man when Mrs. Yocum declined to take them into her confidence. Two special delivery letters have been received by Mrs. Yocum, one from Kewanee, Ill., and the other from Chicago. Both are reported to have dealt with the ransom question.

The apparent anxiety of the Yocum family to drop the investigation was viewed with apprehension by officers of the Illinois Bankers' association. They expressed belief that if an extortion gang obtained "easy money" from Yocum that other small town bankers would become the constant prey of kidnapers.

Atlanta Fails to Get Population Issued at 360,692

Washington, Oct. 28.—(AP)—Atlanta failed today in the District of Columbia Supreme court in its effort to have the Census Bureau publish its population at 360,692.

Director Stewart of the bureau had given the population of the Borough of Atlanta as 270,367. The city brought an action to have included several small communities and municipalities which were included in greater Atlanta by an act of the Georgia Legislature in 1929.

In his opinion, Justice Suddens said that in view of the facts he did not think the court had the authority to compel Director Stewart to fix the higher figure. He said the city and those who brought suit with it "may have misconceived their remedy, but with that the court has no concern in deciding this case."

"For the reasons thus stated," he added, "the rule issued herein must be discharged and the petition of the relators dismissed."

Orphanage Head Embezzlement Goes On Trial for

Richmond, Va., Oct. 28.—(AP)—Many of the state's most prominent citizens were summoned today as character witnesses in the trial of James P. Jones, former treasurer of the Virginia Methodist Orphanage, charged with embezzlement and larceny of \$37,000 of the institution's funds.

Mr. Jones, a former treasurer of the Virginia Anti-Saloon League, and for years a leader of the moral forces in the House of Delegates, has pleaded not guilty to five indictments for embezzlement and one of larceny returned by a Hastings county grand jury. The first five indictments charged embezzlement of specific sums while the last charged that Jones converted to his own use the full amount of \$37,000 over a period of three years.

The state announced that only five witnesses would be used by the prosecution as against sixty-six summoned by the defense. State Tax Commissioner C. H. Morrisett and State Treasurer John M. Purcell were included among defense witnesses along with leading business men and ministers of Richmond.

Jones has been at liberty under \$15,000 bond since September 18 when arrested on warrants sworn out by the commonwealth's attorney, Dave E. Satterfield. Negotiations with a view to securing a settlement of the alleged shortage had been in progress for some time between Jones and the orphanage board when the arrest was made.

HOW IT BEGAN

We all know the main facts in the history of the organization, and the noble aid it rendered to our boys in the world struggle overseas. We are also aware that here in our beloved land, whether she is beating the big bass drum or threading her way up some rickety gangway among the low-rented tenements of our great cities, with the bloom of kindness on her cheeks, the Army lassie is hailed as an angel of mercy and the servant of all.

Let us glance at the beginning of the movement, and how, marching over its battlefields toward the goal to which it has attained, it has bequeathed to the world a lesson for us all. The world is better for having the Army. Incidentally, you and I find the world's atmosphere sweeter because of its service to the poor and the "down and out." It has made it easier to believe in the brotherhood of man and the realization of the dream of the poet when "brothers we'll be and a' that."

The founder of this Army was an Englishman until he organized his world-wide Army, and then he became a citizen of the Kingdom of God on earth. He was great in personality, great in zeal for the honor of God, the Salvation of men, and the duty—the command—the holy privilege of making the poor and unfortunate believe the message of the Nazarene. He was a great organizer, a powerful leader, a believer in the divinity of his appointment as general of the Salvation Army, and a ruthless enemy of all sham, either in business, church life, or in his own organization.

He was converted at 17 through the instrumentality of the Methodists of his birthplace, the industrial city of Nottingham, England. His father was a yeoman, who died of a broken heart in consequence of his business losses. William Booth being the eldest, it fell to him to become the family bread-winner. His business took him among the lowest, and he learned his first lesson in how the poor live. It was at this time in his life that he became enthused by a holy determination to utterly oppose the drink traffic. The English saloon at that time was the rendezvous of profligate and criminal classes.

But his real all-absorbing passion was directed toward the saving of souls. He often said in after life that when a "down and out" gets saved, he washes himself. God cleanses the inside of the man, and the man demonstrates that "cleanliness is next to Godliness."

It is not surprising to learn of his preaching on the market square of Nottingham, visiting the sick and dying, feeding the hungry and clothing the naked. He presaged the organized philanthropy of The Salvation Army in his exploits among the hard-worked, ill-clad and ill-fed factory hands of Nottingham.

One day a Methodist revivalist came to Nottingham—a man called Marsden, and inflamed him with the Utopia of a spiritual Canaan. Booth then eschewed politics into which he was drifting, went to London, and there met a social hell, godless drunken areas of people living on the verge of savagery.

William Booth was stupefied. What could he do?

Central Europe Suffering From Severe Storms

London, Oct. 28.—(AP)—Southern and central Europe, and the lands bordering the eastern Mediterranean and Aegean Seas are suffering from a severe buffeting by gales and icy waters.

Smyrna and Istanbul, Turkey, appear the worst sufferers, at Smyrna at least 68 persons have lost their lives and 3,000 are homeless and without food. Six hundred fifty-five houses have been demolished by floods developing from torrential downpours. At Istanbul 22 persons were injured in the gale.

Parts of southern France, Austria, Czechoslovakia, Jugoslavia and the Alpine regions were deep in snow today with mountain passes and many villages cut off from the world. Telegraph wires were down and traffic over roads stopped. Mount Cenis pass was the only one open between Savoy and Italy.

Says Skyscrapers of Future Will Be Built Steel Alloy

Pinehurst, Oct. 28.—(AP)—A day when skyscrapers will be constructed almost wholly of steel alloy was envisioned today by Charles N. Pitts, of Boston, president of the American Institute of Steel Construction.

In an address to the eighth annual convention of the Institute, he predicted the early general use of all-metal walls for tall buildings, asserting they would prove cheaper, more lasting, more economic and more efficient than masonry walls.

"Our industry," he said, "is facing a tremendous transition which is coming whether we will it or not. The battledeck (steel) floor has been adopted despite the apathy of most fabricators."

"Welding is gaining apace and is destined to play an important part in our industry. Alloy steels, developed for specialized uses, are affording builders something new to think about."

Fitts said the Chrysler building in New York was the first to use alloy steel to any extent in its exterior walls and that the Empire State Building would have an even greater proportion.

RASKOB SEEKS REFERENDUM ON DRY ISSUE

Democratic Chairman Would Make This Objective If Party Obtains Power

RASKOB SEEKS... at New York, Oct. 28.—(AP)—Just a week before election, the chairman of the Democratic National committee last night suggested a national referendum on prohibition be made, one of his party's objectives if it obtains power.

John J. Raskob advanced the proposal as one of six points in the course of a campaign address carried by radio all over the country.

Taking first place in his program was the five day week for workmen. His other suggestions included determination by the Federal Trade commission of the legality of proposed business combinations in advance of their formation; abolition of the capital gains and loss tax; appointment of tariff commission members for life to take tariff-making out of politics, and employment of caution by Congress to have all its legislation square "with good economics."

"Is there any dry so stubborn," asked Raskob, "that he would insist on the country being dry if the people by referendum abolished the 18th amendment? Or is there any wet so bigoted that he would refuse to abide by the decision if a referendum showed the country to be dry?"

The Democratic chairman, who also is a director of the association against the prohibition amendment, said it was a "sorry plight indeed" to see ministers and other good citizens "unconsciously working hand in hand with bootleggers and racketeers in an effort to deny the people of the United States an opportunity to vote on this great social experiment after a ten-year trial."

\$200,000 Jewelry Theft At N. York

New York, Oct. 28.—(AP)—Two
self-assured robbers posing as tele-
graph messengers, gained entrance
to a Broadway jewelry store near
Times Square two hours before it
opened for business today, waited
until the clerical force arrived, then
made the manager open the safe
and escaped with jewelry valued at
two hundred thousand dollars.

They cowed a Negro watchman
with pistols before anyone else
came then as the clerks arrived,
lined them up against the wall be-
side the watchman. Half an hour
later the manager came and con-
fessed that he knew the combina-
tion of the safe.

But the excitement drove the
combination from his mind and
his hands trembled so that he
could not open the vault. One of
the robbers, pressing a gun against
the manager's side, forced him to
telephone M. Rosent hal, proprietor
of the store, who furnished the
combination without asking ques-
tions.

Then the robbers opened the
safe, lifted out the trays of gems
and escaped in an automobile.

Before they left, the robbers
took time to truss up clerks and
the manager with picture wire,
then they took a key from the
watchman, locked the door after
them and walked casually to their
car, carrying the loot in a satchel.

A few minutes later one of the
clerks freed himself and sounded
the store's burglar siren. It
brought ten traffic policemen and
a patrol wagon loaded with rein-
forcements. In fifteen minutes a
crowd of several thousand had
gathered in front of the store.

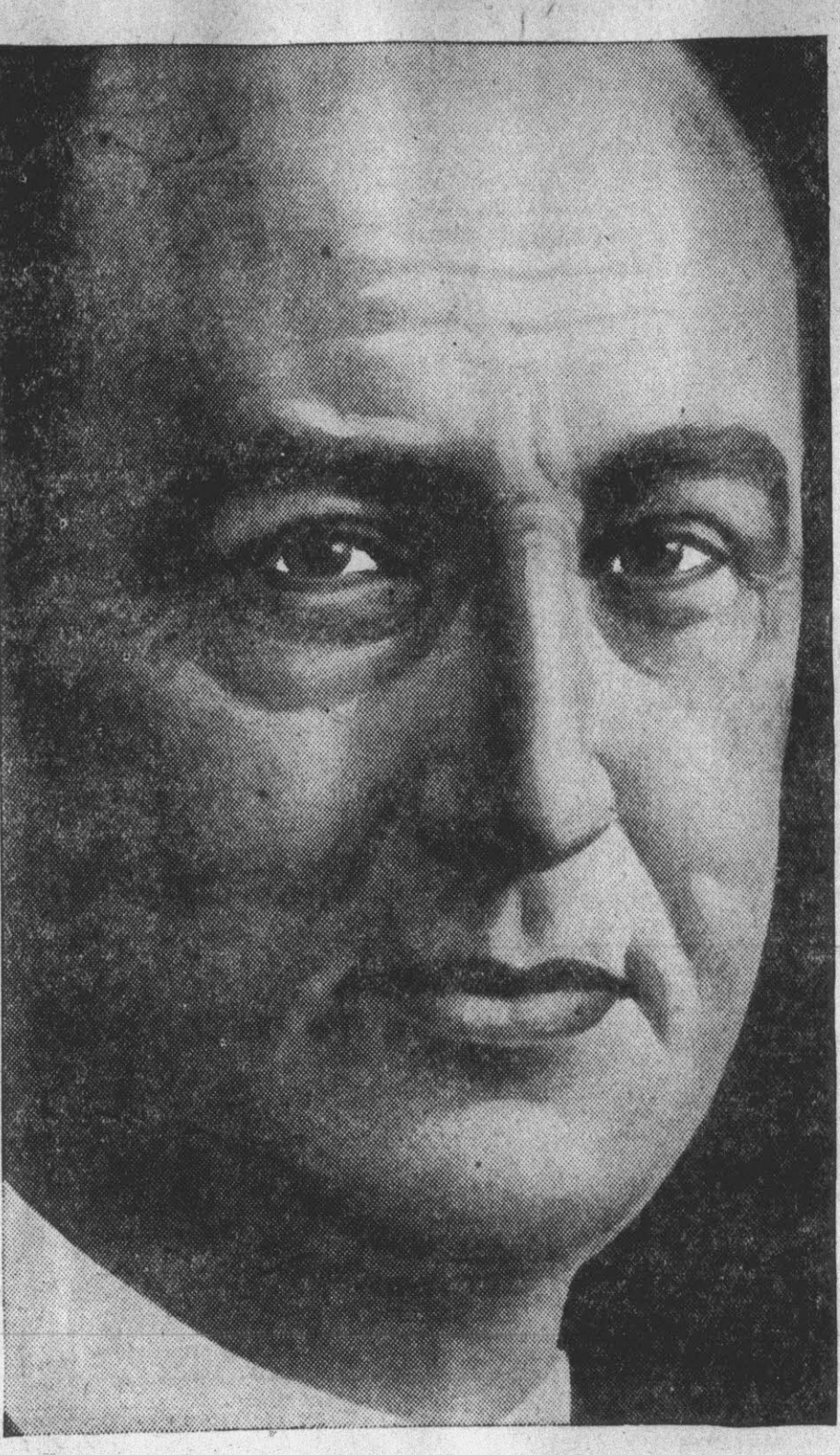

Charlotte, Oct. 23.—(AP)—Two men who are guiding the destinies of North Carolina football teams will hand the reins to other hands at the end of the year and each is making a determined bid to end the season in the proverbial blaze of glory.

When Jimmy DeHart steps aside at Duke in favor of Wallace Wade, the man who brought the Tide at Alabama, he will, if he keeps on like he is going now, be able to do so with a bit of pride in the machine he fashioned for the 1930 grid-show.

The resignation of Pat Miller, Wake Forest coach, which has been before the college's athletic board since September, is to go into effect in June, but to date, the committee has not acted on it.

Miller's outfit has certainly done nothing to discredit this season and for the first time in many moons sports writers are referring to his team as the "Demon Deacons" instead of simply the "Deacons".

Despite the fact that Miller's resignation has not yet been accepted and his successor has not been named, the general understanding at Wake Forest is that the coach will not remain there even if he is asked to do so.

Both DeHart and Miller will pit their charges against tough opponents this week. Duke plays Villanova and the Demon Deacons meet Temple University. Both teams travel to Pennsylvania.

When North Carolina picked out Georgia, Tennessee and Georgia Tech to play on successive Saturdays some folk just couldn't help wailing "suicide schedule" and for the last two week-ends they have seen their predictions come true. The Tar Heels, however, are hoping for better things at Chapel Hill this week with Georgia Tech furnishing the opposition.

The Tornado has failed to be the big breeze ech alumni would have it to be. Except for a husky blow through South Carolina, the Georgians have shown little power this season. Losing to Carnegie Tech wasn't so bad for Tech by an eyelash win over Auburn and a trouncing at the hands of Tulane failed to boost the stock.

Coach Chuck Collins, is spending the week looking for better reserve material for his Tar Heel backfield. McCaskill, Thompson and Daniel are showing up best. Johnny Branch, quarterback, is confined to the infirmary but expects to be out for Saturday's game.

One game that has all the earmarks of a real scrap from this district is the N. C. State-Presbyterian College clash at Charlotte. Ordinarily, the game would be a breather in State's schedule, but this is no ordinary year for either team. State, with the exception of last week's win over Mississippi A. and M., appears to be below par while P. C. is enjoying one of its best years in gridiron history.

Atlanta, Oct. 23.—(AP)—Analyzing the outlook for another crucial contest on the southern scene some of the football faithful recall that while Kentucky's invasions of Alabama have been unsuccessful in recent years the last time Lexington, Ky., was the battleground the Wildcats won, 6 to 0. That was in 1922.

When Alabama comes to Lexington Saturday the Tide also will be facing its third big game on successive week-ends—an unusually difficult assignment considering that the first two opponents turned back were Tennessee and Vanderbilt.

On the other side of the picture it is pointed out that Wade's warriors never have extended themselves to the limit this year and have won all their games without employing the forward pass route. Tuscaloosa, Ala., observers say Wade has an aerial offensive that is better than fair, but sees no reason for uncovering it as long as his power plays get the desired results.

Kentucky for the most part used reserves against Virginia and has all of its regular troops including "Shipwreck" Kelly, backfield backstop, available for Alabama. The Tide came through the Vandy test in good physical trim, but suffered the usual bruises and abrasions attached to a close contest.

Tulane, 1923 winner, still is very much in the conference title chase with Georgia looming ahead as its most formidable obstacle. This week end the Greenies expect another breathing period with little trouble from R-d Cagle's Mississippi Aggies.

Tulane is particularly proud of the showing of its blockers and interferers in the Georgia Tech tilt.

Up at Knoxville, Boss Neyland ordered a stiff scrimmage today for Tennessee in anticipation of the Saturday struggle with the unbeaten Clemson Tigers. The North Carolina victory added "Skeet" Meyer, regular center, to a hospital list which already included Hug and Brandt, crack kends, and Paul Heydrick, fast driving back.

SPORTS SLANTS

Bill Stribling is now considered by boxing master minds the leading contender for heavyweight honors, as well as the "key man" for any successful winter venture under the palms at Miami, yet it has not been deemed safe to try out William at this time on the Manhattan Mob.

Perhaps the moguls of the Madison Square Garden, which is now where near Madison Square any more, have too vivid a recollection of the extremely sour impression that Stribling left in his last performance or two in Manhattan rings. But, one can well ask what heavyweight hasn't left a similar impression?

The nearest Stribling has approached the Gotham frontier was a "near-match" at his old stand, the Newark Armory, with the soft-end-up Myer Christner, scheduled the night after Garden patrons were offered a so-called light heavy weight championship contest between Maxey Rosenbloom and an entry posted as Able Bain.

Whether it was, as specified, a misfortune to some part of Christner's anatomy or, as seemed more probable, a distinct pain in the region of the box-office, the Stribling Christner bout was again put off on very short notice.

Jack Sharkey neither was punched nor harassed by the boxing powers for fouling Max Schmeling and, in effect, short-changing the customers, but the most promising bout of the early indoor season in New York involving Justo Suarez and Jimmy McLarnin, has been put off two months because of the boxing commission's suspension of the South American puncher for tossing a few wild wallop in a recent bout.

Suarez has been the most sensational new-comer of the year in the line, blasting his way through the lightweight ranks nearly as effectively as his countryman, Luis Angel Firpo, did among the heavyweights seven years ago. Justo came here with the old-fashioned idea that the main object in the ring is to punch his opponent into a state of insensibility as rapidly as possible.

Paul T. Harber, Georgia '05, chides me for a clip in reference to the Georgia-North Carolina game of 1929, for which apologies are extended herewith, and adds: "Come south and see some real football by boys whose names can easily be spelled and pronounced—real American-born boys and descendants of a sturdy stock of the Anglo-Saxon race!"

Their names are not so important as the accomplishments of the south's gridiron stars so far this season. The brand of football played in Dixie has been on the up-grade for several years, as Yale, Notre Dame and California have

discovered, yet it has reached new "heights" this fall. Crotchets' outstanding gridiron developments unquestionably have been the inter-sectional triumphs scored by Vanderbilt, Florida, Georgia, Duke and Centenary in the east and mid-west, all against extraordinary opposition.

Bruen Resigns As Madison Sqr. Head

New York, Oct. 23.—(AP)—Covetous eyes all along cauliflower row are yearning today at the manager's post in Madison Square Garden, the driver's seat of boxing that Tex Richard vacated in death and Frick January Bruen relinquished of his own accord to return to the management of the Hialeah Race Track in Miami, Fla.

Bruen resigned yesterday after serving as manager and vice-president of the Garden since June 1929. William F. Carey, head of boxing's wealthiest corporation, announced Bruen's retirement with reluctance and declared that only the pressing duties of Richard's successor in Florida prompted the change.

All along the boxing marts, however, rumors of changes about to take place in the Garden have been travelling the rounds for some time. Reports that Col. John C. Hammond, and Carey himself, were about to resign have been de-

nied officially. At the same time it seemed that a man tempo was brewing among the "600 millionaires" the late Richard interested in the financing of his sports palace over the fact that profits were decreasing, boxing attractions at the Garden deteriorating, and big outdoor fights, once financial windfalls, now showed discouraging losses.

It is rumored now that Bruen, failing to gain the sole authority in dealings with fighters and managers Richard had, decided to devote his entire efforts to the management of the Miami track. And in the meantime, those along Broadway say his successor will be chosen from four men.

Leading the list is Damon Runyon, sports writer, who promoted the Schmeling-Paulino fights in 1922 and the Schmeling-Sharkey match last summer for Mrs. William Hearst's milk fund. Among others under consideration are Wilton Farnsworth, sports editor associated with Runyon in these promotions; Jimmy Johnston, American manager of Phil Scott; and George Black, of Los Angeles, pilot of Fidel Labarta, former flyweight champion, and well-known developer of amateur stars on the Pacific Coast.

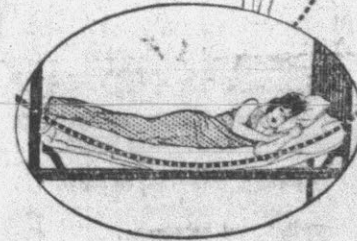

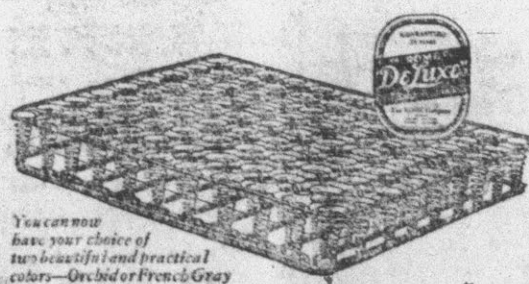
