TWO ARRESTED HERE TODAY ON ARSON CHARGE

Operator of Local Bowling Alley and Negro Assistant Arrested As Result of Fire Saturday Night; Hearing Late Today

R. D. Whitehurst, Jr., local bowling alley operator and Maudie Lewis, negro helper at the bowling alley, were under arrest today awaiting hearing this afternoon at four o'clock on a charge of arson.

The arrests were the result of an investigation that began Saturday night shortly after fire had been discovered in the rear portion of the bowling alley located on Dickinson avenue. When firemen visited the scene of the blaze gasoline was said to have been very much in evidence, having been strewn along the floor and on the alleys and two small cans still containing gasoline had been left on the alleys on either side. Just as soon as firemen had extinguished the blaze an investigation was begun by Fire Chief George Gardner, Building Inspector G. A. Clark and members of the local police force.

It was learned Sunday that the negro helper was missing from this city and had returned to New Bern and local officers went to that place to question him and brought him back to this city to be held as a material witness. Yesterday C. B. Wade, of the State Insurance Department, was called to aid in the investigation and this morning a joint warrant for Whitehurst and the negro was issued. The negro failing to give bond, was held in jail pending the hearing and Whitehurst was released on \$500.00 bond for his appearance this afternoon at four o'clock before Justice of the Peace John Ivey Smith.

Rocky Mount, Nov. 18.—(AP)—It will go hard with the thief Rocky Mount police find with the automobile of Bruce Heath, of Goldsboro.

He had nothing but praise for the Rocky Mount bluecoats when they told him Sunday by telephone they had found his automobile, stolen the day before. He was still praising them when he came here a few hours later to get it, but there was some mention of "dumb coppers over here" when he found it had been stolen again.

Then last night Heath's car was found on the street here, driven to police headquarters. Again he was telephoned the good news. Arriving here this morning, he found it gone again.

Tax Relief Commission Meeting in Raleigh Today to Discuss Tax Situation Had Requested Governor to Call Special Session On the Tax Question

Raleigh, Nov. 18.—(AP)—Governor Gardner today was on record as formally declining to call a special 20-day session of the General Assembly in December to consider taxation problems.

Meanwhile members of the State's Tax Commission were to meet here today to give further attention to its report on taxation matters for presentation to the regular session in January.

Meeting in the capital also today is the advisory budget committee which is to conduct hearings until next Monday or requests for appropriations for state institutions and department to be considered by the General Assembly.

Petition for the special session was presented to the governor by the North Carolina Tax Relief Commission.

In a formal statement declining to call the special session, Gov. Gardner said "A special session in December would interrupt and interfere with the orderly making of plans which are now in progress for the regular session in January that the effect would be to have two sessions without adequate, organized preparation for either."

Full and deliberate consideration to the arguments in the Tax Relief Commission's petition was given, Gov. Gardner said.

"I am impressed," the statement said, "by the facts presented in the petition and am conscious of the conditions described and the relief sought by the committee."

He declared a special session would be unwise and would not be in the interest of the public welfare.

At the Tax Commission's meeting today, Robert Lassiter, of Charlotte, will formally take his place as a member. He succeeds J. K. Norfleet, of Winston-Salem.

Kingsford-Smith Planning Flight Across Pacific

Oakland, Cal., Nov. 18.—(AP)—R. H. Kingsford-Smith, Oakland shipping executive, announced today his famous brother, Wing Commander Charles Kingsford-Smith, was planning a non-stop flight across the Pacific from San Francisco Bay to Tokyo.

The plans were revealed in a letter from the Australian flier, who said he expected to have a new plane named the Southern Cross to negotiate the 4,800 miles. The new plane would be designed to have a cruising radius of 6,000 miles to allow sufficient margin for possible adverse winds.

Kingsford-Smith's westward flight across the Atlantic several months ago was followed by an announcement that in view of his forthcoming marriage he would do no more ocean flying. He recently flew from England to Australia after the westward route.

Midyette and Otis Mann, of Washington, are in a Washington hospital suffering serious injuries.

A report from the hospital today stated that Midyette apparently was out of danger and on the road to recovery but that Mann, the more dangerously injured, was still in a critical condition.

The accident occurred near Grimesland about seven o'clock Sunday night, as the party were returning from Sanatorium where they had been to visit the Midyette daughter, Miss Ruby Midyette. Highway patrolman who investigated the accident stated that the car driven by Mann, slipped off the pavement onto the muddy shoulder of the road and that Otis Mann brought the car back to the wet pavement it went into a skid and crashed into a truck loaded with tobacco. BANK IS MADE RECEIVER FOR FORMER CLERK

Greensboro, Nov. 18.—(AP)—The United Bank and Trust Company, of Greensboro, today was acting as receiver for the real and personal property of Mason W. Gant, former clerk of Guilford Superior Court, under indictment for misappropriating Confederate pension checks.

Judge Thomas J. Shaw signed the receivership order last night following presentation of a complaint by Col. F. P. Hogobood at attorney for Col. W. Wayland Cooke, the present clerk of the court. Property held jointly with Mrs. Gant was included in the order.

The complaint alleged that an audit of Gant's books as clerk shows he received "not less than \$124,000 in excess of all the cash, moneys, funds and securities which he has heretofore turned over or tendered to his successor in office."

"And of all sums and accounts which he is entitled."

Colonel Hogobood said Mr. Gant throughout practically all the tenure of his office kept "his own funds and the funds of the office in the same bank account."

He charged that approximately \$423,000 was paid out of the account of Mr. Gant as clerk of the court, "apparently for Mr. Gant's purchase of lands, construction of buildings, stocks, securities and other personal items."

The defendants are directed to appear before Judge Shaw December 6 to show cause why the receivership should not be continued. Gant is said to be in a hospital in Florida, his wife with him.

NEW DEVELOPMENT SCHEME FOR PALESTINE

London, Nov. 17.—(AP)—A big new development scheme for Palestine, involving the expenditure of \$12,500,000 was announced by Drummond Shiels, Under-secretary for Colonies, in the House of Commons today.

The scheme is supposed by the British government assisted by a loan and is intended to provide settlement for Jews and Arabs on land at the rate of 10,000 annually.

EIGHT BANKS IN KENTUCKY CLOSED TODAY

"Wild Rumors" Cause Banks to Suspend Business for Protection; Arkansas Lays Plans to Re-open Its Closed Institutions

Louisville, Ky., Nov. 18.—(AP)—Eight Kentucky financial institutions with resources totaling more than \$75,000,000 were closed today. The largest of these was the National Bank of Kentucky at Louisville, which was under the control of a receiver, Paul C. Keyes, of the staff of the comptroller of the currency at Washington. Its resources approximate \$60,000,000.

Directors of the National Bank of Kentucky said the suspension yesterday was deemed necessary because of "wild rumors" concerning its condition.

Simultaneously with its closing, two affiliated institutions, the Louisville Trust Company and the Security Bank, suspended operations.

Two small negro banks in Louisville, the American Mutual Savings Bank and the First Standard Bank, which cleared through the Louisville Trust Company, later closed. The Bank of St. Helens, a Louisville suburb, also suspended as a precautionary measure.

Two banks outside Louisville also closed when it was learned the National Bank of Kentucky had suspended. They were the McElwain Megular Bank & Trust Company at Franklin, Ky., and the First National Bank at Horse Cave, Ky. The National Bank of Kentucky served as correspondent for both.

FINANCIAL LEADERS OF ARKANSAS OPTIMISTIC

Little Rock, Ark., Nov. 18.—(AP)—Optimism was expressed in statements of Arkansas financial leaders as they laid plans today to re-open some 43 banks which have suspended temporarily or closed.

The executive committee of the American Exchange Trust Company here, largest and one of the oldest banks in the state which suspended for five days, was engaged with plans to resume operations.

Closing of the American Exchange was followed by suspension of activities by the 42 other banks, the aggregate deposits of which were more than \$27,000,000.

A. B. Banks, president of the American Exchange, and controlling stockholder in 34 of the 42 other banks scattered over the state, said the boards of directors were trying to obtain pledges of loyalty from their communities and supporting capital to assure freedom of danger from a run.

Expressions of confidence in the general stability of the state's financial structure were added by Governor Farnell and Senator Joe T. Robinson to those of bankers. The Little Rock Clearing House Association by a statement assured the public that local banks are in sound condition.

Hysteria followed receivership proceedings against Caldwell and Company, Nashville, Tenn., bankers until recently interested in the American Exchange, was attributed by directors of the latter as the cause of steady withdrawals which reached about \$4,000,000.

Joe Jefferson Dies At Age of 48 Years

Farmville, Nov. 18.—Joe E. Jefferson, 48 years of age, son of the late Robert and Caroline Jefferson, a well known and industrious farmer of the Fountain section, died at his home near the suburbs of that place, on Sunday afternoon at 6:30, following an attack of pneumonia.

Elder Amos Crisp of Pinetops, Primitive Baptist preacher, had charge of the last rites, which were held at 1:30 Monday afternoon at the home, interment being made in the Fountain cemetery.

Surviving are his wife, who was formerly Miss Beale Bell, a sister of L. R. The State Health Department is waging a relentless campaign against barber shops of North Carolina with a view of improving the sanitary condition of such places and in that way insuring the safety of the thousands of patrons.

Right recently inspectors swooped down upon Greenville and arrested several barbers charged with violation of the law regulating the operation of barber shops. These men will be called into court and fined for their failure to comply with the rules for increased sanitation and in the future they will no doubt be more diligent in the operation of their places.

Cleanliness is just as necessary in a barber shop as it is anywhere else, and it is to be hoped the state officers will continue their fight until every barber in the country is impressed with the fact that he must conduct a clean shop or retire from business. It is a movement in behalf of public health, and that in itself should be sufficient to justify the barbers to attempt to comply with the State Board of Health regulations.

filled with both pleasure and profit. This body of men and women are doing much toward building up a higher standard of citizenship, and they may rest assured their efforts are watched with interest by the people of this city, the seat of one of the greatest schools for the training of teachers in the country.

"One of the most important public services yet undertaken by the Carolina Motor Club is the roadside sanitation program inaugurated by that organization and being carried out by H. E. Miller, chief engineer of the State Board of Health, which joined the club some time ago in this new and much-needed activity, in which service stations, county and municipal health officers are co-operating," in the opinion of the Charlotte Observer.

"Under the program, official sanitary inspection is made of the service stations along the highways and those coming up to the required standards are conspicuously marked with metal signs 24 inches square bearing the words 'Sanitation Approved' by the State Board of Health." They also bear the State Highway letters 'N. C.' in monogram. The metal plates are made in the state prison, as are automobile license tags. They are erected by the district engineers of the State Highway Commission.

"In the current issue of the Carolina Motor News, Mr. Miller details a story which at once emphasizes the value and importance of this roadside sanitation program. Mr. Miller tells of an instance in which 39 typhoid cases in eastern Carolina were traced to the use of milk from an insanitary dairy. It was found that the same dairy was furnishing the milk supply of 13 filling stations on one highway and this milk was being sold, in the form of chocolate milk, to passing motorists."

"According to the latest report, about 500 service stations had been inspected, of which 73 had been 'sanitation approved' and the distinguishing signs had been erected at 38. It will not be long before the motorist traveling North Carolina highways will look for the State Board of Health yellow sign lettered in black before purchasing sandwiches or other food or drinks from a roadside service station.

"Incidentally score another for the credit of the public service record of the Carolina Motor Club."

Chicago Finds Way To Get Rid of Public Enemies

Chicago, Nov. 18.—(AP)—Chicago scored today its first victory in its fight to rid the city of "public enemies" by means of an old vagrancy law.

The victory came with the conviction late last night of James (Fur) Sammons, one of the original 28 hoodlums named by the Chicago Crime Commission as "public enemies." He faced a sentence of six months on the county jail rock pile and a fine of \$100.

Sammons, who, according to prosecutors, has a criminal career dating back to 1899, was led away to a cell in the detective bureau to await the next move of his counsel—a legal effort for a new trial. Judge Edgar A. Jonas in municipal court, said arguments on their motion would be heard November 29. STATE BUDGET BODY BEGINS ITS HEARINGS

Figures On Requests of Institutions Will Not Be Available for Several Days

Raleigh, Nov. 18.—(AP)—The Advisory Budget Commission today opened public hearings on requests of state departments and institutions for the biennium 1931-33.

No figures on the requests will be available, however, for several days, Henry Burke, assistant director of the budget, said today.

The department and institutions have been required to fill out three questionnaires dealing with their maintenance, permanent improvements and "on purpose of foundation and productivity."

These questionnaires include the requests of the different state divisions and are not being read at the hearings or made public until the Budget Commission has studied them.

This morning the commission received the requests of the governor's office, executive council, salary and wage commission, secretary of state, state treasurer, attorney general, adjutant general corporation commission and the department of conservation and development and its many divisions.

Though figures asked were not mentioned in any case it was apparent from the general statements made to the commission by heads of the various departments that today's budget requests in most instances are practically the same as those for the 1929-31 period.

The department of conservation and development, however, asked for increases in many of its divisions. The geology department asked for funds sufficient to complete a geological map of the state, pointing out that the last previous one was made in 1892. The division of commerce and industry seeks funds

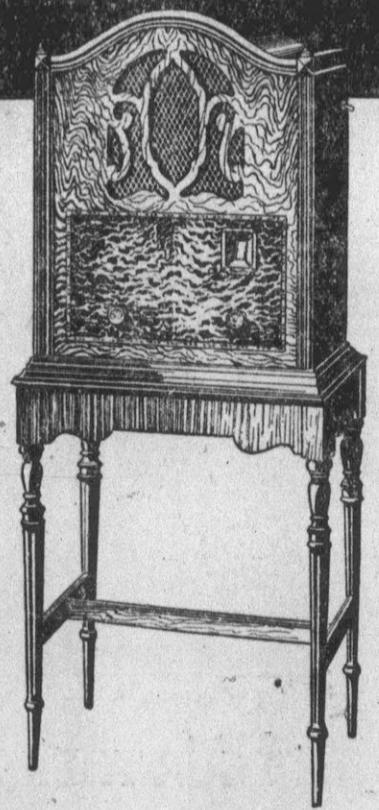

OPENFIELD FOR THE CROWN OF BOBBY JONES

New York, Nov. 18.—(AP)—Bobby Jones, master golfer of all time, who has retired from competition in order to make sound films, has left as a heritage, a wide-open battle for the four American and British National championships he holds.

Nowhere on the horizon at present does there loom any amateur with the golfing gifts needed to duplicate Bobby's unprecedented feat of winning all four titles in a single year. Perhaps there never will be another Jones.

The stocky Atlanta lawyer, alone among amateurs, consistently has beaten the professionals at their own game. Four times he won the American Open against the best pros and amateurs in the game and thrice the British Open fell to his amazing skill.

With his retirement, it seems certain that the pros again will dominate both Open Tournaments, for certainly amateur ranks contain no figure even approaching Jones in shot-making ability or in steadiness under fire.

It is a coincidence, and an odd one, that in the last few months, George Von Elm and Johnny Goodman, the only players who have beaten Jones in the American Amateur in the last seven years, both have announced their retirement as amateurs. Von Elm beat Bobby in the final round at Balmorol in 1926 and Goodman eliminated him in the first round at Pebble Beach in 1929. In every other year the Atlantan emerged the victor.

Press comment on Jones' decision to renounce his amateur status was almost uniformly favorable.

The New York Herald Tribune called Jones' decision "most understandable, most natural."

"Who in his position would not welcome the profitable opportunity to teach golf through motion pictures?" The editorial continued.

"For the Atlanta lawyer's frank facing of the amateur problem there can be nothing but praise. He prefers not to be in any twilight zone but recognizes fully the commercial application of the motion picture contract. It is a straightforward, unequivocal decision and certainly neither the motives nor the attitude of Mr. Jones toward golf in its commercial phase can be criticized."

The New York Times comments that Jones "with dignity, quits the memorable scene upon which he did nothing common nor mean."

SPORTS SLANTS

When great southern football teams are being discussed, they seem to be this season because of the high calibre of pigskin-tossing in Dixie. Many still believe Georgia Tech's wartime array of 1927 set up the standard for all future high powered models.

Without much question, this team coached by John W. Heisman, was the strongest in the country at the time and one of the most powerful offensive machines ever developed in college football.

It was the first Tech eleven to gain nation-wide fame as the "Golden Tornado," rolling up a total of 491 points in winning nine straight games and earning the distinction of being America's highest scoring aggregation.

The war already had upset college racks, but Tech piled up some amazing scores against strong opposition in going through the season undefeated. The Tornado smothered Pennsylvania, 41 to 0, Washington and Lee by 63-0, steam rolled Vanderbilt 83-0 and Tulane 48-0, then salughtered the Carlisle Indians 98-0, and wound up the year by running wild against Alabama Poly, 68-7.

The last victory was especially noteworthy because Alabama Poly had held the Western Conference champions, Ohio State, to a scoreless tie.

Bulwarks in the 1917 Tech line were Captain Carpenter and Fincher at the tackles, Phillips at Center. The ball-toting aces were Hill, the quarterback, Strupper and Gusion.

The performances of these stalwarts climaxed three straight seasons of unbeaten football for Heisman and Georgia Tech. It was the "Golden Age" of football in Atlanta and Dixie's first national championship product. Tech did not occupy such heights again until Captain Pund's 1928 eleven, coached by Bill Alexander, swept the gridirons.

COTTON MARKET

New York, 18.—(AP)—Cotton opened steady today at an advance of 1 to 2 points, with the active positions selling 3 to 4 points above yesterday's closing quotations right after the call in response to relatively steady Liverpool cables.

There was some trade buying as well as covering and future buying of May contracts, which was thought to be against sales of spot cotton in the South, but the demand was readily supplied by southern selling and realizing or liquidation. After advancing to 10.98, December eased off to 10.95, while May reacted from 11.72 to 11.69, but the market held fairly steady, with prices ruling a shade above yesterday's closing quotations at the end of the first half hour.

December liquidation was again in evidence and included considerable switching into later deliveries. Liverpool cables reported covering, continental and Bombay buying in that market and said there was freer buying of cotton cloths for shipment to India.

STOCK MARKET

New York, Nov. 18.—The stock market was becalmed today, save for a few ripples of liquidation left by yesterday's selling wave.

Further selling in the first hour depressed about a score of issues 2 to 4 points, but these were, in the main, more than regained, as the list crept irregularly higher thereafter. Trading was sluggish.

Losses of a point or two in U. S. Steel, American Telephone, Radio American Water Works and Bethlehem Steel were recovered. Eastman Kodak converted a loss of 2 points into a gain of like extent and Allied Chemical substantially more than recovered a 3-point loss. Sears Roebuck, Gillette, Howe Soun National Lead and Air Reduction gained 2 points or more. Some of the falls were heavy, notably Northern Pacific and Union Pacific, the latter losing 5 points.

The days corporate news included announcement of the declaration of the regular stock dividends on Sears Roebuck, in addition to cash, which accounted for the strength in that issue, as there had been some apprehension that the stock disbursements would be abandoned.

Wall Street was naturally a little uneasy over the grain situation, with a wide-open break in wheat at Winnipeg, and the grain stabilization Corp. again making heavy purchases in the Chicago market. The fact that domestic prices were substantially above the foreign markets lent an element of uncertainty to the situation.

Vienna, Nov. 18.—(AP)—From his prison cell, Charles A. Levine who, Vienna police say, is an American aviation enthusiast, today ridiculed allegations of suspicion of intention of forgery which yesterday brought his arrest.

Levine was taken into custody at Semmering Spa, where he was resting, and brought to Vienna. Police said they found a ticket to Venice in his possession.

The Vienna police president said Levine had given orders to a Vienna engraver for metal dies and matrices to enable him to coin French two franc, one franc, and one-half franc pieces as issued by the French Chamber of Commerce.

He said also that in Levine's baggage had been found correspondence revealing an order at Leipzig for machinery serving to force money and other letters discussing an order for counters to be used at international gambling resorts.

The police president said that since the bare preparations for the forging of money constitutes a crime in Austria, Levine must stand trial in Vienna.

Student Court Acquits Abernethy

Raleigh, Nov. 18.—(AP)—Milton A. Abernethy of Hickory, North Carolina State College's militant upholder of the freedom of the press, today stood acquitted of charges of "misrepresentation of fact and reflection on the college student body."

A verdict of acquittal was returned last night after a three-hour secret trial by the college's student council. Dean Carl C. Taylor of the graduate school acted as counsel for the student when it was believed the question of "free speech of students" was involved.

Young Abernethy published a signed article in a Raleigh newspaper as a feature story. The article stated "The game of cheating at State College is unequalled by any other sport." The student contended he based the story on a master's thesis of Professor W. N. Hicks, of the school's faculty.

Abernethy was convicted by a student trial November 8, but an appeal to the college court of appeals resulted in the new trial. The evidence presented last night was held secret, the college rules requiring no person at the trial shall reveal what took place behind locked doors.
