REFUSES TO GIVE NAMES OF U. S. REDS

House Committee Fails to Obtain Desired Information From Communist

Washington, Dec. 5.—(AP)—William Z. Foster, Communist leader, refused today to give to the House committee investigating Communist activities in this country the names of members of the American Communist Central committee.

Questioned at an open hearing, Foster said: "I'm not submitting any names to this committee, if you please."

Asked his reason, he replied that "such evidence could only be elicited for eventual use against us in police court."

The Communists said he was a member of the committee and said no one has priority over him. He declared the purpose of the House committee was to have the Communist organization outlawed.

At the outset, Foster refused to be sworn by Chairman Fish of the committee, asserting in reply to a question that he did not believe in a Deity. He consented to affirm that he would tell the truth.

Twice a candidate for the presidency and once for the governorship of New York, he said he was born in Taunton, Massachusetts, of Irish and English parentage. He was a member of the American Federation of Labor until expelled less than a year ago.

Foster read a prepared statement which said there are 9,000,000 unemployed in the United States.

"Those who are still employed," he said, "are having their wages slashed and are being speeded up beyond the limit of human endurance."

He said the Fish committee "is protecting" the capitalist system "against the protests of the worker."

He charged "special oppression and prosecution" of the negroes by the capitalist classes. Referring to committee members, he said: "While the supporters of Messrs. Bachmann, Eslick and Hall are lynching the disfranchised negroes, the Communists are leading the fight for a complete equality and self-determination for the negroes."

Representative Bachmann, Republican of West Virginia, asked for verification of the charges that negroes were suppressed and disfranchised in West Virginia.

"West Virginia," Foster replied, "is the most tyrannically ruled state in the United States."

He testified white and colored workmen alike were "shot down mercilessly" in West Virginia mining districts.

Bachmann said he was "sorry you are not informed about conditions in that state."

Then the West Virginian asked how the witness proposed to reduce unemployment by promising insurance to those who "don't want to work."

"I expect to relieve it not reduce it," Foster responded.

Doak Nomination Approved By The Senate Labor Body

Washington, Dec. 5.—(AP)—Barren unexpected developments William N. Doak may be able to take office as Secretary of Labor Monday or Tuesday of next week.

His nomination gained the approval of the Senate Labor committee yesterday. The Senate did not act upon it before recessing for the week-end because Senator Couzens, Republican, Michigan, insisted upon the usual procedure under which reports must be over for a day. But Couzens said he had no objection to the nomination of the Virginian and no other Senator indicated opposition. The American Federation of Labor withdrew its objection to Doak right after his name was sent to the Senate.

Confirmation Monday appeared probable.

The long week-end recess was taken mainly to permit committees to work on the more than 200 nominations the president has submitted for approval.

RULE OUT SUNDAY MOVIES IN LONDON

London, Dec. 5.—(AP)—Three high court judges have ruled out Sunday movies under an old law of 1781. The closing order becoming effective December 14.

The ancient blue law unenforced for many years, provides heavy fines for violation.

London is the only city in England which shows movies on Sunday.

MORE MONEY SOUGHT FOR DRY AREAS

Senator Robinson Asks for \$60,000,000 Instead of \$25,000,000

Washington, Dec. 5.—(AP)—Despite the administration recommendation for allotting \$25,000,000 to drought relief, Chairman McNary of the Senate Agriculture committee said today he favored appropriating \$60,000,000 for the purpose and expected the Senate to pass a bill calling for that amount next week.

Senator Swanson, Democrat of Virginia, said no states were harder hit by the drought than Virginia. He also urged the appropriation of \$60,000,000 rather than \$25,000,000.

The farmers are at a loss to know where they will get food and crop supplies for next year, unless the federal government helps, he said.

"Conditions in Virginia are worse than they were immediately after the civil war," Swanson said.

He asked the committee not to complicate the bill, and said it should be passed by January to do any good.

"It should pass next week," Chairman McNary replied.

Washington, Dec. 5.—(AP)—An urgent plea for the appropriation of \$60,000,000 instead of the budget bureau's recommendation of \$25,000,000 for drought relief was made before the Senate Agriculture committee today by Democratic leader Robinson of Arkansas.

Senator Robinson said if Congress is going to deal with the situation at all, it should do so generously.

Several Senators, including Robinson, introduced bills proposing the appropriation of \$60,000,000 for seed and feed loans to drought-stricken farmers. Representative Aswell, Democrat, Louisiana, proposed a like measure.

"Who said \$60,000,000 was necessary?" Robinson asked.

The agencies set up by the president to get the information for Congress as to what was needed.

"Who said \$25,000,000 was enough? One who knows nothing about it, some one who is interested in economy and does not know what is needed."

"I realize I am precipitating an issue but it's going to be raised in the Senate itself if it isn't here."

Robinson advocated his bill, and said if the loans are to be limited to those farmers with adequate collateral, the legislation might just as well be killed.

House Rejects Amendment To Treasury Bill

Washington, Dec. 5.—(AP)—The House today rejected an amendment to the treasury supply bill prohibiting use of government funds for poisoning industrial alcohol. The vote was 106 to 54.

The amendment was sponsored by Representative Linticum, Democrat, Maryland, chairman.

The vote came after a two-hour debate in which proponents of the amendment contended that "harmless" instead of deadly poisons could be used to prevent diversion of industrial alcohol for beverage purposes.

No record vote was demanded, the decision being on a standing vote.

Several timely talks were made in behalf of the factory, showing that it would prove a great help to the community through creation of a new source of income for the farmers, relieve unemployment and aid in the general improvement of the nation.

Paul Kelly, chief of the Division of Commerce and Industry of the State of North Carolina, and Bryan W. Sipe, statistician of the Department of Conservation and Development, attended the meeting and told of the value of canning plants to the various communities of the nation.

Gastonia, Dec. 5.—(AP)—Business is beginning to boom again in the textile industry in this section, if the activity of mills and the outlook of mill executives may be taken as indicators.

A survey today revealed 13 textile plants in Gaston County back on full-time schedules. Other mills that have been on a curtailed schedule were adding more time.

Declares Farmers Must Adjust Production To Consumption In The U. S.

Farm Board In Report to Congress Says Self-Controlled Economic System of Distribution Also Necessary if Farming Is to Get On Par With Industry

Washington, Dec. 5.—(AP)—The Farm Board reported to Congress today that agriculture, to achieve a parity with industry, must adjust production to consumption and perfect a self-controlled, economic system of distribution.

The first annual report of the board contained the views along with a summary of the past year's studies, accomplishments and experiments.

Out of its own experience with wheat and cotton the board was able to tell the legislators that stabilization operations, without the backing of adjusted production, have a limited field. The board members pointed to the results of their own stabilization efforts as an indication of some of the "difficulties and hazards" involved.

Particularly they said, did the failure of cotton producers to curtail acreage substantially in 1930, lead to defeat of stabilization measures.

As for wheat, the board said it had concluded the world outlook would remain gloomy through 1931 with the general price trend downward.

"The board could see no hope," it said, "for arresting such a movement or preventing its serious consequences to American wheat farmers, by co-operative marketing as such, by stabilization measures of the type already employed, or thru adopting any of the proposed measures designed to dispose of the surplus abroad at prices below domestic levels."

Another recommendation emphasized by the board, was reforestation, taking up marginal lands of little present value to preserve them for future years.

The board said its major activities had been devoted to building up farmer-owned and controlled marketing systems, done on a regional or national scale for nearly a score of commodities. This major long-time undertaking was supplemented with the emergency loans and stabilization commitments, totaling a net of \$242,659,476. During the year it received repayments of \$119,328, which returned to

POINCARÉ MAY BE CALLED TO FORM CABINET

President Doumergue Confers With Both Poincaré and Herriot This Morning

Paris, Dec. 5.—(AP)—President Doumergue received Raymond Poincaré at three o'clock this afternoon, and half an hour later Edouard Herriot called at the Elysee Palace in response to a presidential invitation.

Both men have served as premier of France and it was assumed they discussed the cabinet crisis with the president, but neither would make any statement as to whether he had been asked to form a new cabinet.

M. Paul Boncour also was one of a long list of political leaders called in by the president for advice upon the situation.

Poincaré still was a favorite in the lobby gossip to succeed Tardieu. Pierre Laval, former minister of labor, Theodore Steeg, a prominent radical Socialist politician, and Henri Chéron, minister of justice in retiring cabinet, were mentioned as possible heads of transition ministries.

All France looked today to Raymond Poincaré, "Savior of the name," to emerge from his retirement and once more assume the government's leadership, left vacant with resignation of Premier Andre Tardieu and his cabinet.

The Tardieu government was defeated in the Senate and censured for the conduct of the government during the current financial scandals, 147 to 139.

Whatever the desires of those talking to the president for a ministry headed by another, it appeared that the answer to the crisis lay in M. Poincaré.

The veteran statesman's own attitude was believed to have changed somewhat with defeat of his friend and disciple, M. Tardieu.

Just prior to the vote he told friends in the Senate lobby: "If my name is put forward to assume formation of a new ministry, should one be necessary, I shall show my doctors' certificates that it is impossible for me to resume office at the present time. I consider that it would be a public calamity if the government is overthrown and I shall be the first to advise M. Doumergue to recall M. Tardieu."

Today there was general feeling that he would be induced to change his views and accept responsibility for a new ministry.

Other rumors suggested a possible invitation presented apparently by insurmountable obstacles. Prominent among them was that of Aristide Briand, foreign minister in the Tardieu cabinet, but opposition to him has grown of late and success would be doubtful. Others were Henri Chéron and Pierre Laval, Poincaré's close friends.

It was expected that the president would need at least 48 hours for his preliminary consultations. Political prognosticators predicted that a new government would not be formed before the end of next week.

Heir to Millions Dies Shortly After His Inheritance

Blythwood, S. C., Dec. 5.—(AP)—Death today had stepped in to prevent John M. Hawley, aged heir to millions, from realizing them. Hawley died late yesterday. He was 77 years old. Less than a month ago his half-brother, James L. Hawley, of Wheeling, W. Va., died after naming Hawley principal beneficiary of his estate valued conservatively at \$2,500,000.

Hawley died in his modest cottage here. He had been ill for some time with heart trouble. The limelight he acquired when he seemed about to become a millionaire was distasteful to Hawley and he had shunned interviews.

He is survived by eight children.

Board Of Aldermen Lend Endorsement To Purchase Of New Fire Whistle

The Fire Department Committee Also Given Permission to Add Additional 500 Feet of Hose to Equipment; Several Other Matters Given Consideration

The City of Greenville will not be without a fire whistle much longer. This fact was determined at the regular, monthly meeting of the Board of Aldermen at the City Hall last night when Alderman Hobgood reported that a whistle had been purchased and was expected to reach the city at an early date.

The board endorsed the action of Mr. Hobgood, whose committee at a previous session had been instructed to confer with the Water and Light Commission regarding the purchase of a whistle to take the place of the one declared out of commission several months ago.

Mayor Lanier said a whistle was absolutely necessary to the successful operation of the fire department. He declared it was impossible for the firemen to effectively combat the fire menace without a whistle to spread the alarm and that the public had realized this fact most keenly since the old whistle had been condemned to the junk pile.

Mrs. Dail Laughinghouse and Mrs. Percy Nicholson, representing the Junior Women's club, appeared before the board and asked that some action be taken to improve the condition of vacant lots and unlit city streets. Mrs. Laughinghouse, acting as spokesman, said some of the lots presented an unsightly appearance and that the streets were cluttered up with trash from time to time.

George Clark, superintendent of city streets, said the streets were swept with accustomed regularity, but that it was impossible to prevent paper and other refuse matter from blowing about the streets on windy days. He promised to use his every effort to bring about an improvement in the condition.

Mayor Lanier said the city had no right to order the cleaning up of private property unless it merited public health. He promised, however, that city officials would do everything in their power to bring about a cleaning-up of the affected areas.

Mrs. Laughinghouse asserted the club did not wish to antagonize the aldermen in making the request as they are young married women. Had learned long ago that antagonism would not accomplish what dealing with members of the opposite sex. This rally brought a broad smile from members of the board, and caused them to renew their promise to bring about the suggested improvements.

Order Eviction of Strikers At Danville Mills

Danville, Va., Dec. 5.—(AP)—Forty seven notices of evictions from mill-owned homes were being served today against mill families by the management of the Riverside and Dan River cotton mills where 4,000 union employes are on strike.

The notices of eviction, the first issued in large numbers since the strike began in September, are being served through the mill superintendent at Schofield and sixteen through the city police against families occupying mill-owned homes in the city of Danville.

Union leaders said today that numbers of strike leaders are included among those against whom the eviction notices were directed. They were checking this morning to secure more detailed information preparatory to consideration of the matter at a meeting of the strike committee.

Senator-Elect Josiah W. Bailey, who defeated Simmons for re-nomination in the Democratic primary, entered a vigorous protest against confirmation by the Senate of McNinch's appointment.

In a letter to Senator Lee S. Overman, Bailey said "we are informed that Mr. McNinch has been appointed as a Democrat" but "assuming he is a Democrat, the President has appointed him by way of reward for supporting the Republican national ticket in 1928."

"The President has no moral right," the Senator-Elect asserted, "to give a Democratic appointment as a reward for supporting the Republican ticket."

Referring to what he termed "a report" that McNinch spent "power company" money in the 1928 campaign, Bailey said "certainly if any power company did contribute to the McNinch campaign fund, that fact disqualifies him."

Representative Lindsay Warren and Representative-Elect Hirtton James also opposed McNinch's appointment. James said "he is not in very good standing with the Democratic party."

Gov. O. Max Gardner, Chief Justice Walter P. Stacy, of the State Supreme Court and Attorney General Dennis G. Brummitt expressed surprise that McNinch should have been appointed to the position.

Washington, Dec. 5.—(AP)—The Senate Interstate Commerce committee today decided to call the five members nominated by the President for the new power commission for hearings here next Thursday.

Senator Couzens, Republican, Michigan, chairman of the committee, said today he had studied the appointments he had no objections to any of the nominees.

The support of North Carolina Senators, Simmons and Overman, appeared to be behind McNinch. Overman said he sought to establish whether McNinch was in fact a Democrat. He would support him, he added, if he had voted the straight Democratic ticket at the last election. This, he was given to understand, was the case.

Simmons asserted McNinch was a "life-long" Democrat and denied reports that the Charlotte man had any connection with the "power trusts."

HOUSE BEGINS HEARINGS ON RELIEF PLAN

President's Proposal Is to Spend \$150,000,000 for Unemployment

Washington, Dec. 6.—(AP)—President Hoover's plan for spending \$150,000,000 within six months in public buildings projects was started today on the road to legislative enactment, with the first outburst of criticism apparently stifled.

A detailed explanation of his plan, giving the amount allocated to sub-divisions of the government departments but not naming the specific projects to be built, was accorded a favorable reception as the House Appropriations committee began hearings on the proposal.

The chief of the public roads bureau and the chief of the Army engineers, under whom the bulk of the expenditures are to be made, were the first witnesses on the committee list. With the malvo was the director of the budget, who prepared the President's detailed list.

Mr. Hoover's observation that the best of unemployment relief plans lay in the ability to pay wages within the next six months arrested the attention of the legislators. They passed over without comment his other assertion that cabinet allocation had been chosen because selection of projects by Congress would involve "long delay."

Then too the President pointed out that all the work to be done with the funds will be on projects already authorized by Congress. The resolution to carry out the request was introduced in the House by Chairman Wood of the Appropriations committee. A companion measure was placed before the Senate to await the House's action. At the same time the President's emergency committee for employment was busy gathering up odds and ends of red tape in government departments to secure utmost speed in getting the money into circulation after Congress approves.

The president proposed allocating the construction funds as follows: Agricultural Department, \$84,321,980, with \$80,000,000 of this for roads; War Department, \$57,473,800, nearly half of it to non-military outlays such as waterways and harbors; Commerce Department, \$1,083,000; Interior Department \$3,757,000; Justice Department \$335,000 for institutions, and Navy Department \$1,620,000 for yards, etc.

Loyola Cuts Out Intercollegiate Football Games

Chicago, Dec. 5.—(AP)—Football will be dropped in Loyola University's concrete stadium next season, but will be retained in intercollegiate football.

President Robert M. Kelly, last night announced that Loyola had decided to drop intercollegiate football, because "it is our belief that interest and appeal of these spectacular football games are getting away from the colleges and universities and are being centered on the public or, in other words, the colleges and universities are competing with entertainment agencies, rather than serving the chief purpose of athletics which is for physical development of the entire student body."

Loyola, which has an enrollment of 7,000, was one of the first schools in the Midwest to play its entire home schedule under artificial lighting. The past season, while not successful in games won, was Loyola's most successful financially. Football will not be dropped entirely, but will be confined to intramural games.

Four Prisoners Paroled Today

Raleigh, Dec. 5.—(AP)—Gov. O. Max Gardner today paroled four prisoners.

Leon Allen, convicted in Henderson county in October 1929 of highway robbery and sentenced to five to ten years, was the longest term or paroled. Allen, a young boy when convicted, was sentenced along with two others, the parole statement said. One of the two has been paroled and the other has escaped.

"The boy was no more responsible for his crime than the other two," the statement said, and he has made a good record. "It therefore feels that the ends of justice demand that some consideration be shown this prisoner."

Others paroled were: Roy Byrd sentenced in Caldwell county in September 1929 to five years for breaking, entering and larceny; Cecil Matthews, convicted in August 1930 for manslaughter and sentenced to four months in Yadkin county; James Cook convicted in Scotland county in July 1930 of larceny and sentenced to eight months. Cook, Allen and Matthews were all referred to as "young boys" in the parole statements. Matthews, 16 years of age, was sentenced in connection with the death of a party from injuries received when the car Matthews was driving turned over with the deceased in it.

Australian Flier Arrives At Miami

Miami, Fla., Dec. 5.—(AP)—Mrs. J. M. Keith-Miller, Australian flier, who reported she was blown far out of her course to barren Andros Island on a projected Havana-Miami flight last Friday, was brought to Miami today in a chartered seaplane. With her were Captain W. N. Lancaster, her flying associate, and John Liggett III, of Petersburg. The plane arrived at 9:10 A. M.

Mrs. Keith-Miller, who appeared wearied from her week's adventures, said she would try to fly her plane from Andros Island to Miami tomorrow or the next day.

She wore the same clothing in which she took off from Havana a week ago. The heels of her shoes were cut out. She explained she had cut them because of blistered feet while she was making a 16-mile trek from the point of her forced landing to Kemp's Bay Andros Island.

Slight damage to her reconditioned plane has been repaired, Mrs. Keith-Miller said, and it is in readiness for the Miami flight.

At the time of her forced landing during a gale that blew her more than 300 miles east of the Havana-Miami course, Mrs. Keith-Miller was engaged in a projected round trip flight from Pittsburgh to Havana.

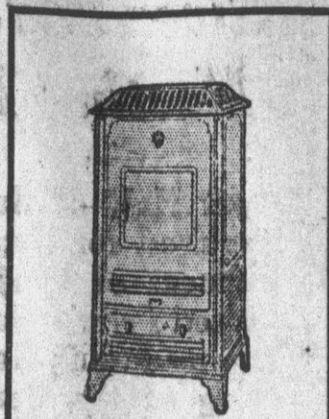

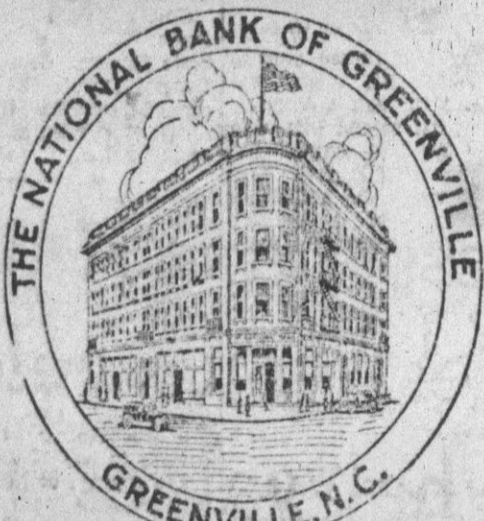

WILKINS AS AVIATOR OF MUCH ABILITY

The "Flying Scientists", Sir Hubert Wilkins, has this record in polar aviation: In the Arctic over 15,000 miles, 12,000 of which are beyond the Arctic Circle and over 6,000 over the Arctic Ocean; in the Antarctic over 6,000 miles.

Yet he would be ranked among the greatest of aviators without one item of his polar record. He was a captain in the Australian Flying Corps during the World War, and was considered one of the greatest aviators fighting on the French front. He was navigator of one of the planes that made the first Australian flight in 1919. He was on the Graf Zeppelin in its first flight around the world, two years ago. This last was a vacation between his Antarctic expeditions. Before any of this, he was the first to take war pictures from the air, in the Balkans in 1919, when he was a mere youth.

This great aviator-explorer is still a comparatively young man, about forty-two years old. This is the first time he has consented to make a lecture tour. Greenville is exceedingly fortunate in having him come here. He will talk on the subject "Flying the Ends of the Earth" and will show movie pictures taken during his expeditions. December 12 is the time, and East Carolina Teachers College the place.

The Farm Department, headed by E. F. Arnold, has rendered the farmers of Pitt county commendable service the past few years through the encouragement of the raising of poultry and hogs and progressive methods of farming.

The outlook for improvement in these extra money crops is brighter for the coming year than ever before, and it is possible the sale of poultry alone during the spring and summer months will swell the earnings of the farmer to a greater extent than ever before.

Mr. Arnold is to be congratulated upon the showing of his department. The future holds forth just as much prospect of development as the past and Pitt county farmers in a few years now ought to be able to see their heads above the clouds which have hovered above them in past months.

Although "Cow Day" was featured by the offering of many bargains to the people of this great trade territory, "Turkey Day" should be of even greater importance. The merchants have put in liberal stocks of Christmas goods and these will be offered in addition to the regular line of merchandise on the counters during "Cow Day."

Shoppers should begin their buying earlier this year and in that way take advantage of the extensive line of Christmas goods which will be offered them upon every hand. It will be the most complete exposition of Christmas gifts in the history of Greenville, and those who buy here may rest assured of getting the best to be had.

a community, and all were very optimistic as to what it would mean to this locality.

Mr. Sipe pointed out the need of canneries and allied industries in Eastern Carolina. He stated that the state was sending to other states \$140,000,000 annually for food products which could be raised and preserved in this state.

Mr. Arnold declared that the soil of Pitt county was adaptable to the cultivation of tomatoes, beans, or most any other commodity bought from the canneries in other sections.

Several of the speakers emphasized the fact that the growers of this section of the state would be compelled to practice diversification

in their farming program if they hope to operate their farms in a successful financial way.

Numbers of out-of-town people were present, including a large group of farmers, who expressed delight in the fact that Greenville was considering the establishment of a canning factory. They thought it was a mighty fine thing and promised their co-operation in making it a success.

Within the next few days a soliciting committee will canvass the business interests of the city with the hope of raising the required amount to make the cannery an actuality. About half of the sum was raised at the meeting last night and prior to that time. When the total sum has been raised the firm will be incorporated with \$100,000 capital stock with \$25,000 paid in.

ate as long as they want to, came up for consideration, but was dropped after several minutes of discussion. Some thought that bowling alleys should close at the same time pool rooms do, and others thought the other way about it. A motion was made to provide an ordinance requiring both pool rooms and bowling alleys to close at the 11:30 hour but it was tabled.

The fire department committee was given permission to purchase not more than 500 feet of hose to supplement the inadequate equipment of the fire department. The matter was brought up by Alderman Hobgood, and finally won out although strenuously opposed by Alderman Waldrop, who sticking tight to his program of economy, thought the purchase should be delayed.

Fire Chief George Gardner was called in to give a few sidelights on the fire department equipment, and stated that the two truck loads of hose which the department had at this time was not sufficient for emergency. He said there were nineteen fires in Greenville during the month of November, an increase over the previous month. Alderman Boyd suggested that the fire committee be permitted to act as it considered advisable. The mayor, however, put the matter up to the board, and the decision was in favor of giving the committee permission to make the purchase.

The Gardner appeared before the Board with a request for permission to conduct a dance during the Christmas holidays. The Board acted favorably, the usual tax of \$50 being required.

The street committee was given permission to purchase a conveyor for the street sweeper, it being stated by the superintendent of the streets that the present conveyor was not durable enough to meet the demands of the street cleaning department.

P. L. Goodson asked the Board to share part of the city's insurance with him, but the matter was

referred to the insurance committee of which T. T. Hillingsworth is chairman.

State Wins Verdict for \$90,519.44 in Case Against Gant

Greensboro, Dec. 5.—(AP)—The State of North Carolina today had won a verdict for \$90,519.44 against Mason W. Gant and the Aetna Casualty and Surety Company, his bonding company.

The verdict was returned yesterday by a Guilford County Superior court jury, which found Gant, former clerk of court, had abstracted and misapplied \$57,539 in Confederate pension funds. The verdict covered this amount, with interest at 12 per cent.

Gant is under 15,000 bond for appearance in court Monday to face 15 indictments charging him with forgery, embezzlement, misapplication of pension checks, and malfeasance in office. Reported to be ill at his home here, he did not appear in court during trial of the civil action against him.

Of the \$90,519.44 total awarded the state, the jury held the Aetna Casualty and Surety Company liable for \$6,184.82.

The bonding company vigorously opposed the state's summary action in court and through its attorneys, said that when Judge Michael Schenk signed the judgment today it would file notice of appeal to the State Supreme court.

Attorneys for Gant announced during the trial he would not resist any judgment rendered under Judge Schenk's instructions.

CHOWAN ELECTION HEAD GETS LETTER FROM NYE

Edenton, Dec. 5.—(AP)—R. E. Forehand, chairman of the Chowan County Election Board, reported today that he had received a letter from Senator Gerald P. Nye asking for further information in regard to the Senatorial election in this county in November. Senator Nye is chairman of the Senate campaign funds committee investigating the elections.

Judge Humphreys Dead At Danbury; Funeral Saturday

Danbury, N. C., Dec. 5.—(AP)—Death today had ended the career of Judge-elect John Daniel Humphreys a month before he was to have taken the seat on the North Carolina Superior court bench to which he was named in the November election. He was 63 years old.

Humphreys died unexpectedly at

his home here yesterday from influenza and complications. He became ill ten days ago and pneumonia developed last Saturday, but his condition was not regarded critical until a few hours before death came.

He was born in Rockingham county in 1867 and received his education in public schools there and at the University of North Carolina.

He moved to Danbury in 1891 to practice law and for 39 years was a leader in his profession. In 1911, he married Miss Bertha

Birkley, who survives, with two daughters, Miss Frances Jarvis Humphreys, student at Salem College, Winston-Salem, and Miss Lou Stella Humphreys, of Danbury.

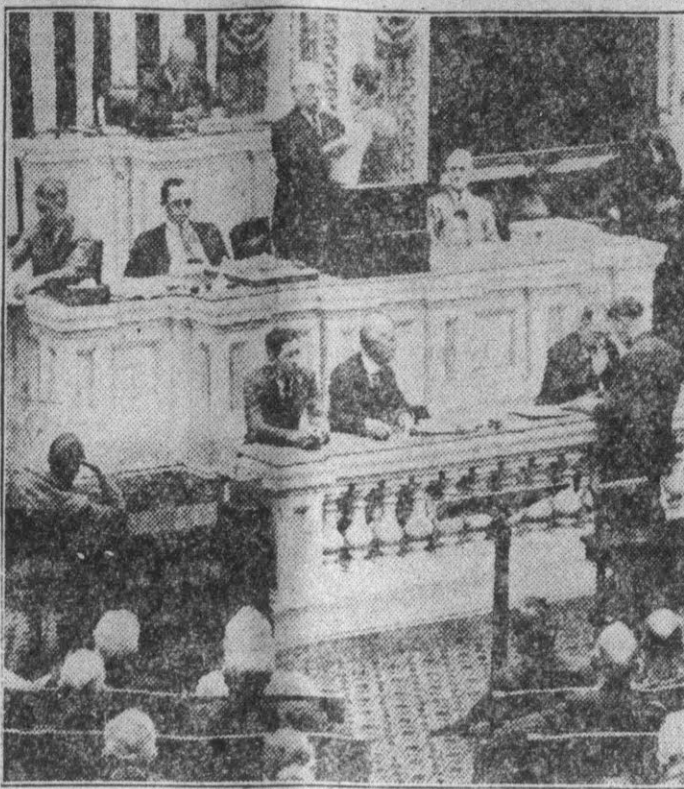

SPORTS SLANTS

Further light on the origin of the All-America football team is shed by R. M. Kauffmann of Washington, D. C., in connection with The Associated Press series of stories on this ancient subject. He writes me as follows:

"The volume 'American Football' by A. M. Weyand, Army, discloses the statement: 'The first All-America team was selected by Walter Camp in 1889 for a magazine conducted by Caspar Whitney. In 1891 the teams appeared in Caspar Whitney's column in Harper's Weekly and were reproduced in the annual Guide by Walter Camp.'

"In 1897, Mr. Whitney being absent from the country, Mr. Camp conducted his football section in Harper's and selected the All-America team. From 1898 until his death Mr. Camp's selection appeared in Collier's Weekly.

"I know that later on both men picked teams, but I firmly believe

that what Mr. Weyand says is true. Also Harford Powell, Jr., in his book entitled 'Walter Camp' gives the 1889 and subsequent line-ups as 'The All America teams of Walter Camp.' I have always heard and still am convinced that Whitney did not anticipate, but followed Camp.

"I am, by the way, a Princeton man, but I would like to see credit given where credit is due. I may add that when I was in college we paid bets as to the winning of 'All-America places' on what Mr. Camp said never on what Mr. Whitney said. That was 1901-05. What Camp said went, even though Whitney treated Princeton better.

"I will add that E. A. Poe '91, of Princeton, was the second of six brothers who made Princeton football history. This record is not equalled at any other college."

This column is indebted to Mr. Kauffmann for contributing authoritative information on the All-America issue and its interesting background.

Collier's, which for a quarter of a century sponsored Camp's selections nevertheless gave Whitney credit

for originating the idea. The fact also is that for nearly ten years Whitney's selections were given preference in Spalding's Guide, with consequent greater prestige. Camp edited the Guide, but it was not until around 1900 that his All-America became the standard by which all others were judged, even though they often aroused violent disagreement and debate.

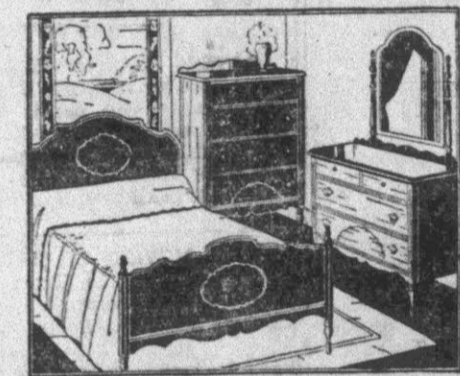

STOCK MARKET

New York, Dec. 5.—(AP)—The underlining influences of impatience and uncertainty caused another gentle settling of share prices in today's stock market.

Trading quickened a little, and the creeping sag of the past two days gained momentum for a time, but around mid-day, the market seemed to strike hardpan, and after a momentary upturn, the trading dwindled off to the vanishing point.

Rails were again the conspicuously heavy group. New York Central, Chicago & Northwestern, Pritico, Southern, Lackawanna and Nickel Plate sold off 1 to 3 points to new lows for recent years. A few specialties broke rather widely. Firestone preferred, Eastman Kodak, and Coca Cola sold off about 5 to 6 points. Shares losing about 2 points included U. S. Steel, North American, American Tob. 8, American Power & Light, Air Reduction and Associated Dry Goods. Losses of a point or so embraced more than a score of prominent shares.

Bears, growing restive, put out a few feelers here and there, and are apparently anxious to test the bottom levels reached Nov. 10, though the lack of extensive liquidation, and the way pivotal stocks have been taken on small declines, has offered them scant encouragement.

The weekly Federal Reserve statement, showing a further decline of \$11,000,000 in brokers' loans, and further extension of credit to meet seasonal and month-end demands, failed to provide much of interest. Call money was possibly a little firmer at 2 per cent. Outside offerings at 1 1/2 per cent were small.

The fall of the French Cabinet was not regarded as a complicating development and foreign exchanges held fairly steady, although there was a slight sag in the franc.

Statements by Royal Dutch officials urging the oil industry to follow the copper and steel producers in bolstering prices were regarded
