

SAYS POLITICS CAUSE DECAY INTECHSPORT

Atlanta, Jan. 10.—(AP)—Coach W. A. Alexander in bristling language last night blamed politics for "athletic decadence" at Georgia Tech and announced the traditional election of a football captain would be postponed until the Varsity assemblies next fall.

He spoke at the annual football banquet and was given an ovation by the crowd in the college dining hall.

"From January 1, 1912 until January 1, 1929, Georgia Tech had an athletic average of more than 700," he said, "that included everything, football, basketball, track and baseball."

"From January 1, 1929 to January 1, 1931 the average is about .100 and there is a reason. From 1912 to 1929 we had no politics in our athletics. When the football team was returning from the Rose Bowl with the national football championship and the greatest victory ever won by a Georgia Tech team, politics entered into the election of a captain."

"That was the reason. Our athletic decadence dates from that day."

"We will elect no captain tonight. We are declaring a new order of things. The men who have been awarded letters tonight have won a fine honor. Ordinarily the course would be for them to meet and elect a captain."

"This year we will move differently. All men will meet on the equal plane this spring. In the practice at that time they will meet on that same plane in September. About the first of October after a month of work, a Varsity squad of not more than thirty men will meet and elect a captain they think has worked the hardest and who is best fitted to be the leader for their season."

"If I were a player and a man attempted to tell me how to vote for my captain I would smash him on the face. Selfish interests will no longer be tolerated. We will have a team that will play as a unit. We will have a team that is strictly amateur in every sense of the word. We will have a team that is positively eligible in its studies. If we cannot win games with them we will lose. But it will be a team that is honest and one that we can be proud of. You can't be selfish and play football."

It was announced that nay coach who in the future enters politics would be dismissed and that any player participating in politics be deemed a traitor to his team and his school.

Announcement also was made of the signing of Jack Cannon former Notre Dame star, as line football coach succeeding Bill Fincher at the employment of Ed Ham, Olympic broad jump champion and Tech Senior, as track mentor, replacing Hal Barron.

SAYS SPORTS OVERDONE BY THE PUBLIC

Richmond, Va., Jan. 10.—(AP)—Viewpoints of several college and university presidents who do not think football is overemphasized in southern schools is presented today in the second of the Richmond News Leader's series of four copyrighted articles making up a symposium on the subject of the major college sport.

Answering the two questions propounded, "is football overemphasized?" and "have you any ideas for reform?" most of the executives quoted today reply that the sport is not overemphasized by the colleges. They suggest, however, that there is overemphasis by sports writers, critics of the sport and the public in general. Another idea expressed is that the matter of emphasis is relative and what is needed is not less stress on the sport but more on class work. Endowment of sports and faculty control are other remedial suggestions offered by those who admit that there may be need for improvement.

President J. M. Smith of Louisiana State University is the most positive in his statement of any of those quoted today. His reply was "I do not think football is overemphasized in the south." President Frank L. Mevey of the University of Kentucky makes the same statement but adds, "It is rapidly moving that way."

Still another graduation of views point is reached in the expression of President John J. Tigert of the University of Florida, who says, "The public may over-estimate the place of football in the academic scheme, but few colleges and universities are guilty of over emphasis."

This idea was repeated by President D. M. Douglas of the University of South Carolina, who says, "I believe football is overemphasized by its critics and the sports writers but not by the universities."

The Devils were booked for a game tonight at Durham with Wofford College, South Carolina quint, licked 25 to 22 by High Point last night at High Point.

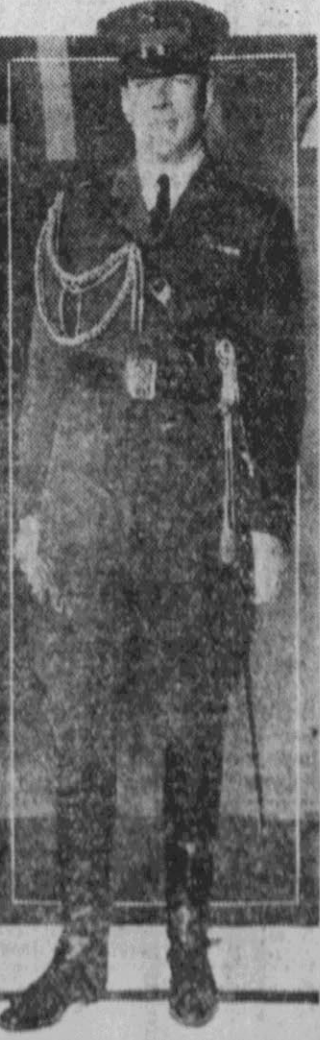
State's Terrors seemingly badly setback by the licking administered them by Davidson, dropped another match last night losing to Alabama, 21 to 17, at Tuscaloosa.

FOUR ANGLERS CENTERED IN RING MUDDLE

New York, Jan. 10.—(AP)—It has become a little axiom that a dozen conferences equal one heavy weight championship bout. So far the boys have used up only two or three of their quota in the situation revolving about Max Schmeling, Jack Sharkey and Young Stribling.

Schmeling is champion everywhere but New York State; Sharkey has been cast by the New York Athletic commission in a role that closely resembles that of defending champion; Stribling seems to be close to a unanimous choice as the outstanding challenger.

The muddle has four main angles at the moment:

First—Nat. Lewis, Chicago promoter, is attempting to match Stribling and Schmeling for the title in Chicago next June.

Second—The Hearst milk fund is attempting to make the same match somewhere outside of New York, probably in Detroit with Cleveland and Philadelphia as the possible cities.

Third—In event that Stribling balks at terms, the milk fund would shift to a match between Schmeling and Primo Carnera.

The milk fund, to which Schmeling is tied by reason of sentiment and written contract, holds the whip hand at present and seems likely to have the chief say where any match involving Schmeling is concerned. "Pa" Stribling, the southerner's father-manager, conferred with milk fund promoters last night but a hitch developed over conditions of the title bout. It was as a result of this disagreement that the possibility of a switch to Carnera was suggested.

So far as Schmeling and the milk fund are concerned, Sharkey is not of the picture. They want either Stribling or Carnera, preferably the former.

These developments all indicated that Lewis and his \$500,000 offer for Schmeling's services had been "left at the post."

Chicago, Jan. 10.—(AP)—The National Boxing Association, controlling the sport in thirty-four states, believes the New York State Athletic commission, in stripping Max Schmeling of the World heavyweight championship, has taken him too much territory.

That at least is the opinion of Walter John C. Clinnin, president of the N. B. A. and chairman of the Illinois State Athletic commission.

The New York commission has acted within its rights," General Clinnin said today, "under its existing rules. In suspending Schmeling for failure to defend his title within six months, but the commission certainly is attempting to take in a lot of territory, when it seeks to vacate a world's championship title without the advice or consent of the rest of the world."

JACK DEMPSEY FIGHTS SOME AT DALLAS

Dallas, Tex., Jan. 10.—(AP)—Jack Dempsey is still a first class fighting man.

Nearly 10,000 sports fans last night saw a flash of the old-time Manassa mauler as Dempsey, engaged by a blow from a bulky wrestler in a match he was refereeing, lashed out a right that drove the offender rolling to the canvas. The victim was Billy Edwards, Kansas City heavyweight.

Stripped of his shirt and his silk undershirt torn by Edwards' pouncing, Jack for the moment was again the man who won the heavyweight boxing championship of the world.

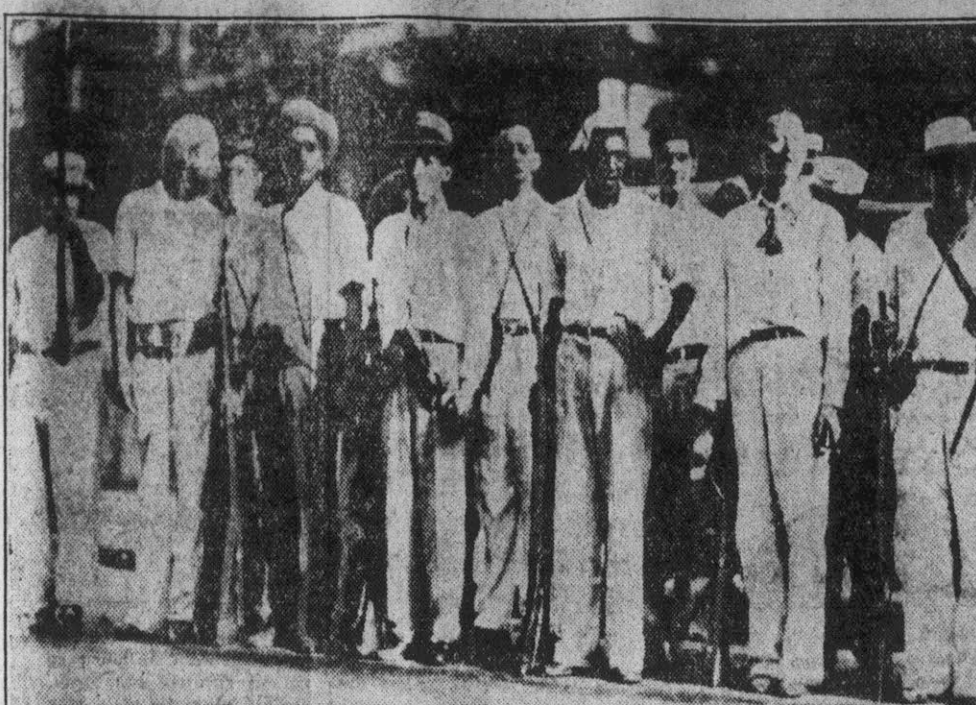
The roar of the crowd was like that on one viewing a million-dollar fight spectacle. Its rush for the tattered shreds of Dempsey's shirt was that of hero-worshipping "cavewoman" hunters. Women joined in the battle for mementoes, hostility marked the ring engagement featuring Edwards and Jim O'Dowd Chicago welterweight, from the start. Dempsey was warned other referees had had difficulties here.

"I don't want to hurt anybody," he replied. "But I'm not going to stand up in front of a crowd like this and let some fellow punch me around. I'll tap him back."

The wrestlers ranted and heaved through two falls. Edwards tore a strip off the "underdog" back as Dempsey broke the "sold" in the second fall. The Kansas Cityan then tore Jack's silk undershirt and all but pulled it off.

Dempsey's are obviously mounted Edwards clamped a headlock on O'Dowd for the third and deciding fall. Dempsey patted Edwards back in token of victory. Edwards continued his hold. Dempsey jerked him to his feet. Edwards swung, grazing Jack's right cheek. Jack led with his left and then snatched a short right to Edwards's chin, lifting him and sending him head first to the mat.

SPORTS SLANTS

It should not be necessary to qualify Big Bill Tilden as a witness in the Davis Cup case. Over a period of ten years, he played in and won more Challenge Round matches than any other tennis player in the history of this international competition.

We were discussing this year's prospects and the suggestion of the retiring president of the U. S. L. T. A., Louis B. Dailley, that the 1931 American cup squad consist of Frank Shields, Sidney Wood, Gregory Mangin and Cliff Sutter.

"That's all right if the intention is just to toss overboard all the experience, time and money devoted to the Davis Cup work of the past three or four years," remarked Tilden.

"What's the matter with Lett, Doeg, Van Ryan and Allison? Are they to be ruled out just because they are married men and have some business responsibilities?"

"These four should compose the 1931 team. They have just begun to capitalize the experience and training they have had in foreign competition. They will be better this year than ever."

"Shields, Wood, Mangin and Sutter still are two or three years away from international calibre. Tilden's decision to play professional tennis under the promotion banner of M. Jacynus Curley, who has been mahout of a large wrestling stable of eyebrows in the more exclusive circles of a game developed in the most fashionable of eastern society."

Just because they enjoyed one good year chiefly on home courts does not signify they will be whirlwinds this year. In fact I think it would be ridiculous to send them abroad as a team, unless it was merely the plan to sacrifice any chance of regaining the cup for several years and give them experience.

"Experience is more than half the battle in playing abroad. Look at the records. Or the example of the French themselves. They picked their men, Borotra, LaCoste and Cochet. Then they sent them over here every year until they finally crashed through. They kept at it for six years before they won at Germantown in 1927."

"The only way in which the U. S. will ever win back the Davis Cup is by selecting three or four men to concentrate on the job. If one or more of the players selected fail to measure up after sufficient trial, substitutions should of course be made, but it is competitive suicide now to discard such players, as Lett, Van Ryn, Allison and Doeg in favor of the greenest kind of material."

"We should stick to the assets we have already developed, meanwhile giving the most promising of the youngsters, such as Wood and Shields, every chance to come along."

M. Curley, however, feels this is doing his record some injustice.

ABOUT TOWN

"Our problem at this hour is not
to spend sixty days in lamentation
over the mistakes of the past or in
over-boasting of the progress of our
past—our challenge is to lift, to
conserve and to keep on solid
ground."

This was one paragraph of Gov-
ernor Gardner's bi-annual message
to the Legislature, but it was
enough to cause the representatives
of the one hundred counties to
think more than they have thought
in months. The country is faced
by one of the most serious read-
justment periods since the end of
the war, and if it is to find its way
back to normalcy—to "safe, solid
ground"—as the governor suggested,
it is going to be necessary for the
legislators to act wisely and with
due regard for the various sections
involved.

It is true the state has made un-
paralleled progress over a pe-
riod of many years, but the time has
come to pause a minute, deliberate
and then begin paying up some of
the debts incurred in our expan-
sion.

The debts accumulated during
those hectic days of progress must
be paid, and the longer they go un-
paid, with continued improvement
programs being made effective, the
more difficult it is going to be for
this great commonwealth to strug-
gle out of the morass of depres-
sion.

The governor "hit the nail square-
ly on the head" in the major part
of his recommendations pertaining
to the reduction of governmental
expenses, and the legislators will
meet popular demand if they will
act favorably for the conservation
of human progress.

The officials and business men
who were fortunate enough to at-
tend the annual oyster roast of the
Water and Light commission at the
power plant on Tar river last night
were not only impressed by the
good things to eat, but also by the
development which the municipally-
owned enterprise has made the last
few years.

The plant by no means is the
largest in the state, but it is one
of the best and has been improved
from time to time until it is cap-
able of meeting every requirement
of the city and community even
under the most extraordinary cir-
cumstances.

The fact that the plant has lost
only a matter of a few minutes, al-
though in constant operation day
and night over a period of many
years, has been a source of pride to
the entire community. It is one of
those enterprises that has been the
hobby of local officials for many
years, and it has reached that stage
where they are beginning to realize
the ambition of it becoming one of
the largest and most serviceable in
the state.

The members of the Water and
Light commission, many of whom
have served for years, have just
cause to throw out their chests and
gaze proudly upon their handiwork.
In that caravansary of brick build-
ings, they have an investment that
will go into millions of dollars, and
which will be worth millions of dol-
lars to the city if operated along
the wise plan as in the past.

Members of the Board of Al-
dermen have solved the problem as
it pertains to the new fire whistle
not making enough noise to be
heard in the western section of the
city, and when the whistle is plac-
ed at a higher altitude its notes
should be heard plainly in all sec-
tions of the town, be it north, south,
east or west.

Following complaints about the
whistle, the board decided to place
it on top of the Montgomery Ward
building, and thereby give the sound
free play on the air. Previously,
the walls of the same building have
prevented the sound going to the
west, and hence the complaints.

The whistle, according to offi-
cials, should be distinguished at a
distance of seven miles from the
city, although its notes are not near
as strident as the old one. The new
alarm is operated solely by air
compression, and is very penetrat-
ing.

The same type of whistle, it has
been stated by authoritative source-

es. is in use in the majority of cities
throughout the country, which
proves conclusively that the alder-
men evidently knew what they were
about when they bought it. It may
sound like a bull, and it is when it
comes to making a noise, night or
day.

With the numbers of cases of
larceny reported in and around
Greenville, due largely to cold lack
of money, and unemployment, peo-
ple should be reminded to keep a
careful check on their property,
especially when they leave it unat-
tended in automobiles and public
places.

Thieves the past few months have
specialized in taking things from
cars, and it is possible that the ma-
jority of thefts in this locality
alone, have resulted from automo-
bile owners leaving valuables in
their cars while they are away.

It matters not where you may be,
you should find it to your advan-
tage to keep a closer check on your
things. If you go up town sup-
ping, don't place the bundles in the
car and leave them. See that the
car is locked if you have to go to
some other place, and in that way
safeguard yourself against the loss
of your property.

There are numerous other ways
the citizenship should be able to
beat the thieves at their own game
if they would only adopt a little
more precaution in their daily life.
The time has come when it is no
longer safe to forget such things
and the man and woman that wants
to prove immune against thieves
should not be forgetful of the dan-
ger that threatens them upon every
hand.

In this new age, when preachers
and prophets are working for the
regeneration of society, too much
cannot be said concerning the or-
dinary virtues of justice and hon-
esty. The average man knows the
difference between truth and false-
hood, honesty and dishonesty. O!

plied to every day life. If it is dis-
honest to steal from anybody, it is
a greater dishonesty to take from
everybody. If I were twenty-one

God is God. God asks not to which
sect does he belong, but did He

This is a great old state, North
Carolina is in great need of ambi-
tious young men, men who are
not afraid to speak and act their
convictions for the betterment of
the conditions of the little forgotten
man.

Pitt county is one of history's
focal spots, the time is now, the
clock has struck. A taste of suc-
cess is as the taste of blood to a
young lion. If I were twenty-one
again, I would identify myself with
some great unpopular cause, cur-
age I think is the finest test of
character. If you think you are
right, have your say, be downright,
upright and outright, stand fast,
stand firm, stand erect, stand alone,
stand with your back toward the
past, and with your face toward
the unfold of God's great plan and
purpose for humanity, and having
done all, stand.

First, they will curse and swear
at you, and then they will swear by
you. Dare to dispute, dare to deny,
dare to dispute, dare to deny dare
to defy, be indifferent to the in-
difference of indifferent men. Remem-
ber the brave words of William
Lloyd Garrison. "I will not excuse,
I will not equivocate, I will not re-

To be first in advocating a right-

her stand alone than creep and crawl
with the crowd, I would rather

moratorium, a legal stay of execu-
tion of any judgments, mortgages
and other evidences of debts against
the lands of the people for a period
of time, say January 1, 1940. On
May 21, 1861, when our grand old
state was seventy years younger
than she is today, a moratorium was
granted, and was effective from June
21, 1861 to January 1, 1870, staying
all executions against the lands of
the people while they were engaged
in war after washing their hands in
blood four years they stacked their
implements of warfare and returned
to peace again to find their lands
grown up in weeds, only a few flea-
bitten mules, their dollars turned
to ten-cent pieces but the morator-
ium saved the day. When the Con-
gress of the United States decided
to enter the World War, our be-
loved President Woodrow Wilson
called for a moratorium to stay
all executions until the war should
end, he also made it obligatory for
the people to give until it hurt, and
then give more. the slogan was.

the yeomanry of North Carolina
win another victory. Someone will
probably denounce me as an infam-
ous Bolshevik, but after these pro-
visions have been in effect for eight
or ten years the richest state in the
Union would build a monument to
the legislators of 1931 as the finan-
cial redeemers of their people.

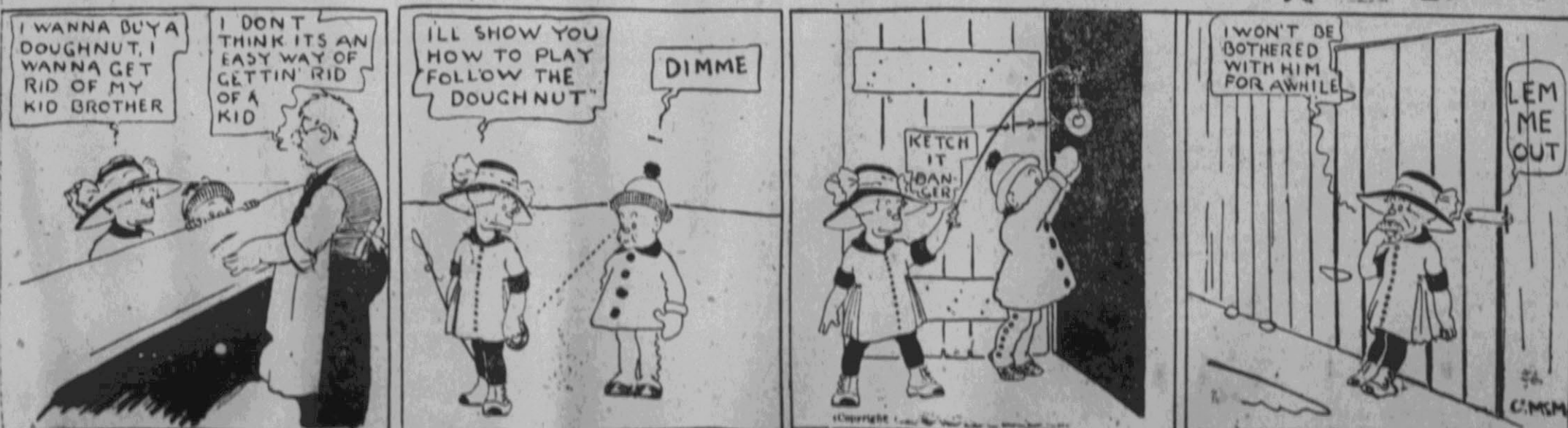

For this tobacco the market paid out a total sum of \$9,464,853.09, at a general average of \$13.90 per hundred pounds.

For the week just closed the market sold 924,446 for \$106,476.38.

Prices yesterday were described as the highest of the season, with numbers of piles averaging from 60 to 70 cents a pound.

Tobaccoists, the report indicated, are urging the farmers to carefully work over the remainder of their crop and market it as quickly as possible.

Cotton--Stocks--Grain

COTTON MARKET

New York, Jan. 10.—(AP)—Cotton opened steady today at a decline of 1 to 5 points in response to relatively easy Liverpool cables and scattered selling which seemed to come partly from the south.

The initial decline carried March contracts off to 10.18 and July to 10.81 or about 3 to 7 points net lower, but the offerings were light and tapered off after the early selling had run its course. The market then steadied on covering for over the week-end, while there appeared to be a little trade or commission house buying and prices just about recovered their losses with March ruling around 10.22 and July 10.66 at the end of the first half hour.

Liverpool cables said there had been trade calling with continental and Bombay buying in that market supplied by hedging against Russian cotton. The cloth and yarn turnover in Manchester was said to be unimportant. Cotton on shipboard at U. S. ports awaiting clearance at the end of the week was estimated at 116,000 bales against 150,000 last year.

GRAIN MARKET

Chicago, Jan. 10.—(AP)—Uneasiness of foreigners who some time ago were sellers furnished unexpected fireworks in wheat today. As a result, May wheat, representing the 1930 crop, rose to levels unequalled heretofore as far back as October. July wheat, which stands for the 1931 crop, averaged lower, however, and the dealings in old crop months were of relatively miniature size. STOCK MARKET

New York, Jan. 10.—(AP)—The stock market again found itself in strong hands at the end of the week today.

Despite the active selling movement which developed late yesterday, the list stiffened soon after the start of today's short session and while the advances were narrow, the closing tone was firm. The list was helped by a retreat of the shorts in the chemical issues, and expectation of a favorable U. S. Steel tonnage report at the close, an expectation which was not disappointed. Trading was light, the transactions aggregating about 800,000 shares.

Allied Chemical regained half of yesterday's 9-point drop, and shares closing a point or two higher included U. S. Steel, Republic Steel, American Tobacco, B. American Woolen shares, Matheson Alkali, Nash, Loew's, Eastman, Sears, Penick and Ford, Gold Dust, Continental Baking, A. New York Central, Rock Island, Union Pacific and Baltimore and Ohio. A few of the rails ran into profit taking however, and Lehigh, Norfolk and Western and Lackawanna lost about 2 points.

U. S. Steel's gain of 33,000 tons in unfilled orders during December was better than expected, most recent forecasts indicating an output of 200,000 to 275,000 tons. Earlier, however, a jump of 300,000 to 400,000 had been talked of.

News from the steel industry was generally cheerful, including an estimate of next week's operations in the Youngstown area, indicating an increase of about 5 per cent. U. S. Steel is expected to step up operations in various areas next week making an aggregate gain in its output of perhaps as much as 7 per cent. In the main the expected January resumption of activity seems to be going off as expected.

Numerous merger reports regarding independent steel companies are again coming into Wall Street. It is recognized that if Bethlehem abandons its effort to consolidate with Youngstown Sheet and Tube, it may seek other properties, but the renewal of reports of an in-
