Says Farmers Must Get Away From Money Crop Idea To Be Successful

T. M. Carrington, Chairman of The Board of The Tobacco Association of The United States Asserts Market is Suffering From Over Production, and That Farmers Must Turn Attention to Things Consumed at Home; Grow Less Tobacco, and Obtain Better Prices, He Advises.

Richmond, Va., Jan. 17.—While not discouraging cooperative effort, T. M. Carrington, chairman of the board of the Tobacco Association of the United States, today expressed the opinion that bright tobacco growers must achieve their individual independence from the "money crop" to place themselves and the industry on a favorable economic basis.

"The 1930 bright tobacco crop was the largest on record, the carry over of stocks is the largest in history and no increase in demand can be expected," Mr. Carrington said. "The growers are suffering from low prices due primarily to over-production and they must work out their own salvation to a large extent by winning freedom from the money-crop idea."

"Everything has gone down in value more than home living. The first tobacco growers to raise the unfavorable economic condition in which they are placed will be those who pay more attention to growing home-consumed products. These farmers will grow less tobacco and probably obtain better quality and better prices."

Mr. Carrington said well-defined plans are being developed to teach farmers to become independent of a "money-crop." He lauded the government extension service at agricultural colleges which have been holding meetings of farmers, landowners, supply-merchants and bankers with the end in view.

Domestic consumption of bright tobacco is becoming more and more in line with cigarette production, he said. The production increased by leaps and bounds for a number of years, but for the first nine months of 1930 the government reported an increase of only 2 per cent over the corresponding period of 1929.

"Use of cigarettes by women had an important bearing on the enormous increases in production during the past decade, but the rate of increase from this source has slowed down to the increase in consumption of cigarettes generally."

Mr. Carrington said a graph showed that the tobacco export curve had started downward, the domestic consumption almost a horizontal trend while production continued sharply upward.

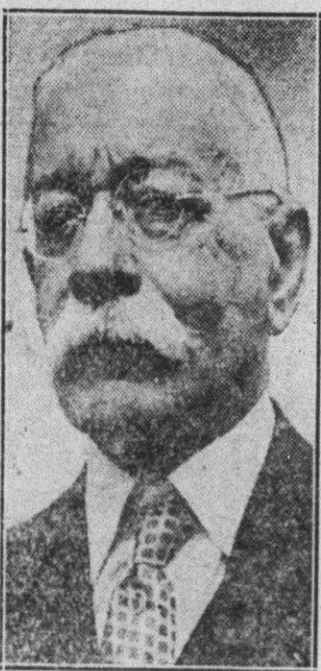
Stocks carried over increased from 440,000 pounds in 1922 to 600,000 pounds in 1930. He pointed out that increased production was due to increased planting in established belts and tremendous expansion of the tobacco growing area. Virginia alone of the four principal bright tobacco states, shows a decrease in acreage, dropping from 136,600 acres in 1922 to 124,000 acres in 1930. North Carolina increased acreage from 505,000 in 1922 to 779,000 last year; South Carolina acreage in the same period increased from 85,000 to 129,000 while Georgia, raising as a factor in production, increased acreage from 11,000 to 127,000.

Season sales on the Greenville tobacco market had reached 69,051,766 pounds when sales were suspended for the week yesterday afternoon, according to the official report made public today by K. W. Cobb, supervisor of sales.

For this amount of leaf the market paid out \$9,590,667.88 and the general price average was \$13.89 per hundred pounds.

Sales for the week were given at \$68,905 pounds for \$125,558.31 and the average was \$12.93 per hundred pounds.

MAN RECEIVES JUDGMENT FOR WRECKED AUTO

Several Other Cases Completed in Civil Court Here Yesterday.

Suing the Litchfield Motor Company for damages to his automobile, H. J. McLawhorn was awarded judgment for \$150 in the civil term of Pitt County Superior court in this city yesterday. He was suing for \$750.

The suit grew out of damages to McLawhorn's automobile while in the company's garage for repairs. It seemed that a mechanic carried the car out for testing purposes after it had been repaired. The car was so badly wrecked that the owner immediately filed suit for recovery.

Dr. G. G. Dixon, Ayden physician, was awarded judgment for \$50 against Grover Harris. The suit was centered around a bill for professional services.

W. L. Smith, of Chocowinity, received judgment for \$1000 against Bettie McGowan in a dispute over a note.

Mrs. Ruby Matthews was granted divorce absolute from Cecil Matthews on statutory grounds. The wheels of justice continued to grind rapidly today as Judge W. A. Devin, of Oxford, made an effort to dispose of as much of the calendar as possible before adjourning this afternoon.

A one-week term of criminal court will convene Monday morning with a docket containing numbers of cases of more or less interest to the people of this territory. Probably the most important cases are those against C. B. Francher, in charge of county convict camps, who is charged with embezzlement, effort to bribe a witness, and two charges of cruelty to prisoners.

Bills for indictment were returned by the grand jury in the last session of criminal court here during the fall.

The embezzlement charge alleges that the roads boys unlawfully disposed of goods which had been assigned for use at the convict camp over a period of several months.

In the bribery case he is charged with seeking to get a witness in the embezzlement case to leave the county.

The cruelty charges grew out of the alleged inhuman treatment of two members of the convict force. Pancher vigorously denied all of the charges after his indictment, declaring that they were the outgrowth of ill feeling on the part of enemies.

A murder case and numbers of charges of robbery and larceny are scheduled to come up for hearing during the week, and court officials today looked forward to one of the busiest sessions in sometime.

Prisoners Protest
Goldboro, Jan. 17.—(AP) Wayne County prisoners are protesting to Jailer Joe Price because the County Commissioners cut off their supply of tobacco and snuff.

ATTEMPTS TO FIND SOLUTION TO RELIEF FUND

President Asks Advice of Administration Leaders on Red Cross Appropriation

Washington, Jan. 17.—(AP)—The Senate today approved the \$25,000,000 appropriation for Red Cross relief work. There was no record vote.

The proposal, sponsored by Senator Robinson, the Democratic leader, was added to the Interior Department appropriation bill.

The vote came so quickly that administration leaders who intended to ask postponement of the proposal were caught napping.

Senator McNary, of Oregon, the assistant Republican leader, promptly asked the Senate to reconsider the vote and then moved reconsideration.

President Hoover called in Senate administration leaders in an effort to work out a solution for the controversy over the relief appropriation to the Red Cross, proposed by the Democrats. The President indicated strongly he would state his position to the public if the Senate overrode his opposition.

Meanwhile, leaders of the administration forces in the House expressed the opinion off the floor the proposal on which action was expected today in the Senate, would not meet much opposition in the House.

Although the House Republican expressed the view that the legislation would set a bad precedent and possibly mean impairment of the present Red Cross organization, they said that during the present crisis such legislation might be justified.

At the same time, they noted that \$25,000,000 for relief activities throughout the entire country was a different matter from the defeated proposal for \$15,000,000 for food purchases by one class of people in one section of the country. The Senate provision for loans for that purpose was eliminated from the drought loan appropriation bill.

President Hoover was advised there is an overwhelming majority in the Senate for the proposal of Senator Robinson, of Arkansas, the Democratic leader, to appropriate the \$25,000,000.

JUDGE GRANTS INJUNCTION IN STRIKE CASE

Strikers Restrained From Interfering With Employes At Danville.

Danville, Va., Jan. 17.—(AP)—A temporary injunction restraining strikers from interfering with the free entry and egress of employes through the gates of the Dan River and Riverside textile mills was made permanent today by Judge Henry C. Leigh, in Corporation court.

The temporary injunction, granted November 1, to the mills was made permanent by Judge Leigh on the grounds that since the defendants have not demurred or answered, the bill "is taken as confessed to by all defendants."

The original bill was directed against Francis J. Gorman, vice-president of the local union whose members are on strike; and J. C. Blackwell, secretary of the union. A supplemental bill named 21 of the strikers. Affidavits were submitted to show that workers were forcibly restrained from entering the mills.

The sixteen week-end of the strike today found the mill sections quiet. There were no demonstrations today to indicate a settlement of the strike among union employes started in September.

Seek Help of Senate In Oil Controversy

Washington, Jan. 17.—The assistance of members of the Senate was sought today by Independent oil producers in their warfare against the large petroleum corporations.

Senator Nye, Independent Republican, North Dakota, was asked to call for an investigation of charges the big companies were combining to fix prices and drive the small producers out of business.

Communism Branded As Threat To Government In Report Of Investigators

Summary of Evidence Gathered in Eight Months of Study by Communist Committee Shows Economic Structure Of Nation Threatened by Red Activities; Recommend Strengthening of Immigration Laws.

Washington, Jan. 17.—(AP)—Fourteen recommendations for dealing with Communism, including outlawry of that party in the United States, were laid before the House today by the Fish investigating committee.

Chairman Fish filed the report after an eight-month study of Communist activities. It was signed by himself and Representatives Bachmann, Republican, West Va., and Eslick, Tennessee, and Hall, Mississippi Democrat, Representative Nelson, Republican, Maine, submitted an individual report.

The committee made the following recommendations: "That the Communist party of the United States to America, section of the Communist International be declared illegal and that the executive authority of each state and the Legislature thereof be informed of the revolutionary principles and objectives of the Communist party and be requested to take appropriate action, to have such party excluded from or denied recognition as a political entity."

"Enlarging the authority of the Department of Justice for the purpose of investigating the revolutionary propaganda and activities of the Communists in the United States."

"Strengthen immigration laws to prevent the admission of Communists and providing for immediate deportation of all alien Communists."

"Provide for additional appropriations to the bureau of immigration for vigorous handling of deportation cases."

"Amend the naturalization laws so as to cancel the United States citizenship of a Communist."

"Deny re-entry to the United States to an alien who has visited Russia to secure training in Communist doctrines."

"Amend post office laws to declare non-mailable all newspapers, magazines, pamphlets, circulars, etc., published, written or produced advocating revolutionary Communism."

"Amend Interstate Commerce laws to prohibit transportation of newspapers, magazines and circulars advocating revolutionary Communism."

"Enactment of Federal law to prosecute Communism or other persons, organizations, newspapers, etc., spreading false rumors for the purpose of causing runs on banks."

"Restriction or elimination of the use of secret codes or ciphers with any government with which the United States has no diplomatic relations and its trade agencies."

"In view of the fact that Soviet government is under the control and direction of the Communists, that the Treasury Department request, through the State Department, permission to send inspectors or agents to investigate the (Continued on page three)

Three More State Banks to Open Soon

Raleigh, Jan. 17.—(AP)—Three more North Carolina banks which were forced to close recently will re-open this week-end, John Mitchell, chief bank examiner, announced today.

The banking department issued orders today allowing the Bank of Dallas at Dallas, the Citizens Bank of Vance at Burnsville, and the Clayton Banking Co. at Clayton to resume business.

Mr. Mitchell said it was impossible to say how many other banks which were forced to close "due to hysteria" might be reopened in the near future but added that several were working on plans to resume business.

Many of the banks which closed in late November and December were forced to stop operations even though they were solvent, Mr. Mitchell said.

Miss Sadie Bell Johnson, 29, died last night at 1:30 o'clock at the home of her brother, Edward Johnson, corner of Summit and Fourth street. She had been ill three months as result of a complication of heart and kidney trouble.

Funeral services will be conducted from her late home Sunday afternoon at 3 o'clock by Rev. E. L. Hillman, pastor of Jarvis Memorial Methodist church. Burial will follow in the Maplewood cemetery at Kinston.

Miss Johnson was a member of the local Methodist church. She is survived by her mother, Mrs. H. C. Johnson; two brothers, Edward Johnson, of Greenville, and J. L. Johnson, of Kinston; two sisters, Mrs. Cleveland Moore, of Henderson and Mrs. William Hooker of Greenville.

Says U. S. Business On The Upturn Now

Washington, Jan. 17.—(AP)—After conferring with President Hoover at the White House, Louis K. Liggett, Republican National committeeman for Massachusetts, expressed the opinion today that American business is decidedly on the upturn.

While he said he did not expect any remarkable showing from the upturning until April, he felt it was decided enough to stop "the playing of politics with hard times in Congress."

Liggett, who directs a large chain of drug stores, said his business was picking up.

INSIDE LIFE OF CLARA BOW GIVEN AIRING

De Boe Trial Recessed After Testimony Dealing With Activities of Actress.

Los Angeles, Jan. 17.—(AP)—After testimony picturing Clara Bow as buying expensive presents for men, ordering large consignments of liquor and playing poker six nights a week, the trial of Daisy De Boe today entered a two-day recess.

The trial, packed full of the names and secrets of film people, closed its first week before a packed house yesterday as Miss De Boe began "telling on Clara."

The blond secretary is charged with illegally taking \$16,000 from the red-headed actress.

Miss De Boe was 40 minutes on the stand as the first defense witness.

Studio officials, who announced Miss Bow had been replaced by Sylvia Sydney, a recent recruit from the New York stage in "City Streets" to have been her next starring vehicle, said the substitution was made at the orders of Clara's physician. They said the change was not made because Miss Bow had violated their edict, which Miss De Boe said had been in the form of a threat to drop Clara from pictures if she got "one more slam in the papers."

De Boe listed some of the presents she bought at Miss Bow's request for the actress' boy friends.

There was a \$4,000 watch for Dr. Earl Pierson, Texas physician and a \$2,000 ring for Harry Richmond, actor and New York night club entertainer, and a \$900 sapphire ring for Lother Mendes, Hollywood film director.

"Is that all you can remember?" Nathan Freedman, defense attorney asked.

Daisy lapsed into thought before replying, "there were so many it is hard to remember them all."

Then she recalled that Clara sent her to a store to purchase a \$10,000 engagement ring.

This testimony was elicited as an explanation of why Miss De Boe had drawn checks, some of them to cash on the "special Clara Bow account," to which she had access. She explained some of the stores declined to take checks, and she drew out the money to make the purchases.

About the liquor, Miss De Boe testified "much, very much liquor was delivered to Clara's home, where she was directed to pay for it at the door. The largest consignment she could remember cost \$275, she said.

The poker parties, Miss De Boe explained, many of the hundreds of checks she drew. She said Clara always had her pay the debts which ranged from \$5 to \$200.

These items, Miss De Boe explained sometimes were paid out of her own account, sometimes by check on the special account, and sometimes in cash. They made book-keeping virtually impossible, she averred.

DENY REPORT THAT MELLON HAS RESIGNED

White House Also Denies That Dawes Will Become Republican Chairman.

Washington, Jan. 17.—(AP)—It was said at the White House today that there was no foundation for reports published today that Secretary Mellon had submitted his resignation.

The reports were published in a Washington newspaper. Similarly, a denial was forthcoming to the published report that Ambassador Dawes would become Republican National Chairman, and that Secretary Adams would succeed him in London as ambassador.

The report as to Secretary Mellon was said at the White House to resemble similar reports that have been denied by the administration since March 4, 1929.

It was also denied that George Akerson, who has resigned as Secretary to the president, would be succeeded by Ray Benjamin, California lawyer and financier.

The published reports were described as apparently a combination of all the rumors and gossip that could be gathered together in one sentence.

DR. LANDRITH DELIVERS PLEA FOR THE YOUNG

Noted Lecturer Says Give Youth More Room For Entertainment in The Church.

"Let the bachelors and old maid go to the parks for their recreation if they want to, but give the children places for entertainment in the church," was the advice Dr. Ira Landrith, of Boston, citizen ship superintendent of the International Society of Christian Endeavor, offered a small but appreciative congregation at the Presbyterian church last night.

Speaking on the importance of giving children proper protection from the vices to be found on every side today, the distinguished visitor, making his second address here in the last year, advocated church parlors where children might spend hours in recreation instead of attending salacious movies, riding around until the wee small hours of the morning in dad's car, or indulging in some pastime tending to tear down the public morals.

The address was preceded by a short song service, prayer and Scripture reading by Rev. W. S. Harden, pastor of the church. An offering was also taken for the promotion of Christian Endeavor activities in this and other sections of the country.

Dr. Landrith, who has won international attention as a lecturer, delivered one of the most vigorous talks probably ever heard here before. In clear, concise phraseology he brought to the attention of his hearers the dangers of present day life, and enumerated among them "the flagrant violation of prohibition noted in virtually all sections of the nation."

He said he did not mention the prohibition question because it was the eleventh anniversary of the Eighteenth Amendment, but because he believed this evil was doing much to wreck the life of that element who do not realize the menace of the traffic and continue to indulge.

Asserting that prohibition was here to stay, he pointed out that this fact had been given more weight by some of those who have fought most vigorously in defense of the wet. He quoted Arthur Brisbane, one of the foremost writers of the country, and admitted a supporter of light wines and beer, as saying that despite the fight against the Eighteenth Amendment, it was here to stay and it would take centuries to eliminate it from the Constitution.

He used as his subject, "Living in God's Country," and brought out the fact that people living in this country should endeavor to abide by its laws and use their influence in its development.

He pointed out the important part which Christian Endeavor is playing in the life of the young men and young women of today, and said the necessity for expansion of this work is becoming more evident all the time.

He believed the churches should give more time to these organizations, and in that way interest the (Continued on page three)

Bill Providing For Gross Income Tax on Businesses and Profession- and Graduated Sales Tax Introduced in The General Assembly This Morning: Both Houses Pass a Few Local Bills and Adjourn Until Monday Night: Hearing on Appropriations Begins January 20th.

Raleigh, Jan. 17.—(AP)—Revenue bills designed to raise sufficient money to allow the state to take over full operation of the constitutional six months school term and relieve land owners of school taxes, including a gross income tax on businesses and profession and a graduated gross sales tax on businesses, were introduced in the General Assembly today.

Both houses got a measure by Senator Baggett and Representative Young of Harnett to tax the gross sales income of wholesalers and retail businesses of the state also the gross receipts of corporations and the gross income of professional men and women which the authors said would raise \$20,000,000 to \$30,000,000 annually.

In the House of Representatives Day sent up a bill to provide a graduated gross sales tax on retail merchants.

Both houses passed a few local bills and adjourned to meet Monday night.

During the week the Neal bill to postpone the quadrennial revaluation of property was passed in both Houses but as the date on which work is to start was amended by the Senate the measure must go back to the House for concurrence before it can be ratified. It is generally believed that date will be March 15, as set by the Senate, instead of April 1, as passed by the House.

The Campbell waterways bill to provide a right-of-way for the inland canal from Southport to the South Carolina line was enacted into law Monday night as the first public measure to be approved.

The joint appropriations committee, after receiving the administration appropriation bill, voted to hold public hearings at which all state agencies and institutions will be allowed to present their request for money. The hearings will start January 20.

Vague threats that measures might be given the Assembly to provide a state ad valorem tax on land to provide school support were heard in both Houses during the week and the matter was discussed at an executive session of the finance committees but no definite action was taken.

The Jefferson bill making it unlawful to slander Building and Loan Associations passed the House and action on the Cherry bill relating to funeral directors and embalmers was deferred until next week.

The privileges taxes levied under the Young bill would be in addition to all other taxes levied by the state on the various businesses. Mining and lumber companies would pay a tax of 42 of one percent of their gross income.

Stone and sand quarries would pay 21 on one percent of their gross income.

Those engaged in selling property (except stocks, bonds, and other evidences of indebtedness) would pay two-tenths of one percent, except wholesalers and distributors, who would pay one-twentieth of one percent. This would affect every merchant in the state.

All manufacturers would pay 21 of one percent of the gross value of their manufactured goods regardless of whether it was sold in inter-state or foreign commerce.

Banks would pay 3 of one percent of their gross income. Railroads and pipe lines would pay one percent of their gross income.

Telegraph, telephone, express, electric light and power companies would pay three-fifths of one percent, and other public service companies would pay two-fifths of one percent.

Theaters, dance halls, pool rooms miniature golf courses and other amusements enterprises would pay one percent.

Lawyers, doctors, dentists, optometrists chiropractors and osteopaths would pay one-twentieth of one percent of their gross income.

Finally, the bill provides that all other businesses would pay three-tenths to one percent of their (Continued on page three)

TWO REVENUE MEASURES TO LIFT TAX ON LANDS GO TO THE LEGISLATURE

gross incomes. The only exceptions to the bill are insurance companies paying a tax on their premiums, mutual savings, labor and agricultural societies, cemetery companies, fraternal benefit societies, mutual Building and Loan Associations, religious, charitable, and educational institutions, and business leagues or Chambers of Commerce.

The bill provides for collection by the commissioner of revenue, and for payment in quarterly installments. The money would be kept by the state treasurer, in a separate fund known as the public school fund, and used for schools

during the constitutional six month term, only.

Those making false statements concerning their gross income would be fined not more than \$1,000 and imprisoned not more than one year. Representative Young state that he thought his proposed bill would prove much less burdensome on the state than a sales tax, and that it would be easier to collect. He advocated it as the best way to reduce taxes on land, and to enable the state to take over the schools.

Representative Day of Onslow sent up the measure to have a graduated gross sales tax. He said his plan was based on one now in use in Kentucky.

The schedule would tax as follows:

Gross sales on less than \$400,000 one-twentieth of one percent. Gross sales of \$400,000 to \$500,000 two-twentieths of one percent.

Sales from \$500,000 to \$600,000 four-twentieths of one percent.

Sales from \$600,000 to \$700,000 eight-twentieths of one percent. Sales from \$700,000 to \$800,000 twelve-twentieths of one percent.

Sales from \$800,000 to \$900,000 sixteen-twentieths of one percent.

Gross sales over \$900,000 one percent.

The money made by the tax would be used to operate the schools and relieve lands of taxes. Under customary procedure the bills of a statewide measure were only introduced as the House, by agreement, only considers local bills at Saturday session.

COTTON MARKET

New York, Jan. 17.—(AP)—Cotton opened steady today, unchanged to 3 points higher on covering and trade buying promoted by the steadiness of Liverpool in the face of the Lancashire lockout.

No southern selling was reported here, but there was enough realizing or liquidation from local or commission house sources to supply the early demand and prices eased off slightly during the early trading. March declined from 10.23 to 10.19 and May from 10.08 to 10.03 with the market ruling about net unchanged to 2 points lower at the end of the first half hour.

Liverpool cables said that hedge selling had been taken by continental buying and trade calling in that market and that the lockout in Lancashire was disregarded.

British home trade in cotton goods was said to be somewhat better and fair auction sales were reported at Shanghai with prices higher. The amount of cotton on shipboard at U. S. ports awaiting clearance at the end of the week was estimated at 108,000 against 149,000 bales last year.

STOCK MARKET

New York, Jan. 17.—(AP)—The stock market skidded in the last half hour of trading today and closed around the week's lowest levels.

The slow rally of the previous session continued during the first hour but trading slackened so close to a standstill that professional traders itching for action dropped heavy selling orders in the late trading, and the list closed with a weak tone, 1 to 4 points lower. Transfers for the two-hour session were only about 650,000 shares.

Chemicals were again under pressure. Allied broke 4 points and DuPont and Air Reduction more than 2. Westinghouse Electric and Vanadium lost 2 and issues closing a point or more down included U. S. Steel, American Can, Eastman, Goodyear, American Telephone, American & Foreign Power, General Electric, and American Smelting. National Biscuit was a firm feature closing up a point.

The market recorded numerous temporary gains of a point or more during the early trading. The rails displayed group strength, presumably reflecting brokerage house gossip to the effect that a favorable decision on valuation is expected from the Interstate Commerce Commission shortly.

Announcement of a price reduction by Ford Motor Company may have been a factor in the selling, although such a move was not unexpected, and Edsel Ford, in making the announcement spoke optimistically of the outlook, saying reports from dealers and branches throughout the world "lead us to believe automobile business will show a steady improvement."

The weekly mercantile reviews said the more cheerful feeling in industry was being maintained, and sales and cold weather were making for a fair volume of retail trade.

Average Over Sixty Bushels of Corn to Acre in This State

Charlotte, Jan. 17.—(AP)—Fifty-four Piedmont North Carolina farmers last season produced 11,836 bushels of corn on 191 acres, an average of 62.4 bushels an acre. The average production cost was 57 1-2 cents a bushel.

These figures were made public here yesterday by J. M. Osteen, of Troy, district supervisor of vocational education, in announcing that Lester Elrod, of Oakboro, of Stanley county, had won the 1930 Piedmont District corn growing contest.

Elrod bettered the average of the 54 farmers by a good margin growing 299 bushels on three acres, an average of 99.2 bushels an acre. His cost per bushel was 53 cents.

HONOR MAN EMPHASIZES GRID ACTION

Columbus, O., Jan. 17.—(AP)—Far from feeling that college football is being over-emphasized or that its effects are detrimental to the athletic, Wesley Fesler, Ohio State All-America ace and honor student credits the game with helping him to maintain a high scholastic standing.

"As a matter of fact," remarked this young man who in four years has the record of never having flunked a class or missed a tackle, "it can almost be said that football is under-emphasized, from the Student's point of view."

"Take myself for instance. I love to play football. My college career would have been incomplete without the hard mental and physical training I got on the gridiron. Oh, I was tired when I came home from a hard day at practice, or after a stiff game. But a good meal, a good shower, and my mind was clearer. Studying was easier and I got more out of what I studied."

"The hard knocks you get in the game are more than compensated for in the satisfaction of winning—or even of putting up a hard losing battle."

Fesler admitted he hadn't thought a great deal about the commercial emphasis placed on the game. So far as he knew, that phase of the issue never got as far as the locker rooms or the practice field.

"We never thought about whether winning or losing would bring in more or less money at the gate," he said. "That wasn't what we were there for. We were playing for Ohio State—to win if we could but lose if we lost. We knew it wasn't because we didn't try; maybe we didn't get the breaks; maybe the other team did; anyway we did our best."

Wes doesn't recall any one game that meant more to him than any way. But he admitted with a broad grin, "that game we took from Pitt last fall was a p.a.ch. Maybe it was sweet revenge. I guess I did feel a little that way about it. But then, Pitt has a big name, and I got a kick out of kicking them."

Fesler doesn't believe that a subsidized football player can be a big success on a college team. "He's too much for himself and not enough for the team."

Byrd Detained For Highway Robbery

Durham, Jan. 17.—(AP)—Bowling Byrd, 19, who drew a pistol and threatened to shoot it out with officers in a crowded Durham street, was under arrest today, charged with highway robbery and assault with a deadly weapon.

After a chase through the business section of the city, Byrd was seized yesterday in connection with the robbery and wounding of T. M. Fields, N. C. State College student a few weeks ago. Fields last night identified the youth as one of his assailants.

When the Durham officers overtook Byrd, the youth whipped out his pistol and threatened to shoot them and citizens who were aiding them in the chase. Instead of exchanging shots, the officers took Byrd's gun away from him, and placed him under arrest.

Raymond Duke was arrested here several days ago on a charge of robbing and shooting Fields near Raleigh as the student was hitchhiking his way home for the holidays. He is in jail in Raleigh where Byrd was to be taken today.

JACK DEMPSEY SEES ANOTHER WEIRD FIGHT

New York Jan. 17.—(AP)—Jack Dempsey, in his modern role of referee, manages to get himself into more weird jams than he ever did as a fighter.

The old Manassa Mauler was third man in the ring of Madison Square Garden last night when Tom Heeneey was knocked from the ring in the third round of his ten round match with Max Baer and then was counted out when he least expected it and least needed it.

Old Tom had cuffed the cocky California youngster around the ring in the first two rounds charging in with both fists flying and generally making it embarrassing for Baer. The third round had barely got under way when the two battlers got themselves all tied up in a wrestling match along the ropes.

A few light punches sent Tom off balance and he sailed through the ropes into the press box. Apparently unhurt, Tom clambered back into the ring and rested on one knee, all set to take a little time to get his bearings before resuming the struggle.

The knockdown time-keeper, Arthur Donovan, momentarily forgot he had counted two while Heeneey was outside the ring and counted up to eight. Then Donovan remembered, added eight and two and found they made ten, and waved Heeneey from the ring.

There was nothing Dempsey could do. He was just as surprised as the 8,000 cash customers and Heeneey at the queer ending of the bout in which the veteran New Zealander had put up a much better fight than anyone had expected him to.

Dempsey was in the ring the night Otto Von Porat and Phil Scott clashed for charity and Scott went down in agony and crying "four" from a punch to the hip. On Thursday night Dempsey refereed a bout at Newark which ended in a foul and it was only a few days ago that he felt called upon to wallop a pugilistically inclined wrestler down in Texas.
