OFFERS BILL TO LEGALIZE BEER IN U. S.

Senator Bingham Presents Measure As Substitute for the Howell Bill

Washington, Jan. 24.—(AP)—A bill to legalize 4 per cent beer was offered in the Senate today by Senator Bingham, as a substitute for the pending Howell measure giving a drastic prohibition enforcement act to the capital.

The Connecticut Republican's proposal brought the first promise for a showdown in the Senate on modification of the Volstead Act. He would have his substitute amend the Volstead Act, thereby making the 4 per cent beer legal throughout the nation.

Wets admitted there was no chance of the Bingham proposal winning Senate approval.

"The statement in the law that the liquor containing one half of one per cent alcohol is intoxicating is untrue and one of the most misleading statements ever made in any law," Bingham said.

Included is an appropriation for salaries of the new power commissioners, upon which a fight was threatened in the Senate after President Hoover declined to re-submit the nominations of three of the commissioners.

Meanwhile, Senator Wheeler, started a new attack in the Senate's controversy with President Hoover over the power commission. While a resolution to bring a court test over the president's refusal to resubmit the nominations awaited action, the Montana Democrat proposed an investigation of circumstances surrounding the dismissal of the commission's solicitor, Chas. A. Russell, and its accountant, William V. Klig. The latter was reinstated.

The Senate Campaign Funds committee went forward with its inquiry into campaign expenditures of Senator Davis, whom Chairman Nye wants to unseat. Witnesses against Davis was a "popular candidate" in Pennsylvania upon whom expenditure of large amounts was unnecessary.

The War Department appropriation bill was reported to the Senate by the appropriations committee, which added \$494,286 to the \$446,024,150 contained in the bill as passed by the House.

Senator Reed said a \$200,000 item for experimental work in connection with a metal-clad airship had been stricken from the House bill at the request of the War Department.

"This was to have been used to start work on a metal-clad dirigible which the army doesn't need and doesn't want," he said.

"It would cost \$4,000,000 or \$5,000,000 to build and take a lot of men to operate. If the airship should be built at all the navy ought to build it."

Captain Emerson, Noted Yachtsman, Dies in Maryland

Baltimore, Md., Jan. 24.—(AP)—Captain Isaac E. Emerson, organizer of the Maryland naval reserves, internationally known yachtsman and founder of the drug company that bears his name is dead at the age of 71. A complication of diseases terminated an illness of two months duration.

With him when death occurred late yesterday afternoon at his home in Brookland Wood, Green Spring Valley, where he had entertained prominent guests from all parts of the world, were his wife and daughter.

He was a native of North Carolina, a graduate of the state university there, and built himself a great business from a humble beginning. He started as a clerk in a drug store and here compounded a headache formula that later made him famous. He marketed it first on a small scale and later on a commercial basis.

Captain Emerson maintained three estates: one at Narragansett Pier, Rhode Island; one on the Waccamaw river in South Carolina, and one in Baltimore.

He was twice married. His first wife was a daughter of W. F. Askew, of Raleigh, North Carolina. She was a widow and had two children and divorced him in 1911. He then married Mrs. Anne Preston McCormick, of New York, who survives him. His daughter is now Mrs. Charles Minot Amory, who as the wife of Alfred Gwynn Vanderbilt, was a social leader in New York and Newport. He also is survived by a brother and two sisters.

The manufacturer of Bremo Seltzer gave liberally to charities in the city and to educational institutions. He came to the city in 1891. The funeral arrangements have not been completed but it was indicated today the service would be held tomorrow.

LEGION CALLS MASS MEETING FOR THURSDAY

Payment of Compensation Certificates to Be Discussed At the Court House

A mass meeting will be held in the court house here Thursday night at eight o'clock to discuss the bill now pending in Congress for the payment of adjusted compensation certificates to veterans of the World War. The meeting will be held under the auspices of the Pitt County Post of the American Legion, and all men who served in the World War are not only invited but urged to attend. The public is also invited to be present.

Discussing the proposed payment of compensation certificates this morning, J. S. Elliott, post commander, had the following to say: "The veterans of this county like veterans of all others are very much interested in the action of Congress on the bill now pending, in which the United States is asked to pay off the adjusted compensation certificates in full at once. This will be the best way immediately to relieve the depressed condition of all business at this time, and with the conditions as they are, every man who is entitled to an adjusted compensation certificate will welcome the passage of such a bill."

"Congress at present is more or less unfavorable to the passage of this bill, and certainly will not pass it unless the man power of the veterans is mustered into an organization that will be heard by Congress, and the American Legion is the organization that will get such action when it can present the facts to the Congress with individual membership enough behind it to demand such action."

"This present session of Congress will adjourn on March 4 of this year and it is necessary that the full strength of the Legion be mustered and go into action this week, and for the convenience of many veterans who have not heretofore been connected with the Legion, four divisions of our post will cover the county during the week beginning Monday morning to give every man who served in the army, navy or marine corps during the period from April 7, 1917, to November 11, 1918, a chance to do his part to bring enough pressure to bear on Congress to pass the bill now pending. Your chance to help get this bill passed will be to enroll in the American Legion during this week."

SMOKERS INCREASE THEIR CONSUMPTION

Washington, Jan. 24.—Smokers of the world increased their consumption of American tobacco during 1930 while international usage of practically every other product of this country's industry and agriculture diminished.

The Commerce Department today announced leaf tobacco exports for 1930 of 579,704,000 pounds in 1929. Due to the general price fall in commodities, however, the 1930 exports were valued at \$145,609,000 against \$146,083,000 the previous year.

Aristide Briand Offered Premiership of France By President Doumergue

Observers Believe That Should He Refuse the Position Will Be Tendered to Pierre Flandrin, Pierre Laval or Louis Barthou; Briand Now Representing France At Sessions of League of Nations

Paris, Jan. 24.—(AP)—President Doumergue today telegraphed to Aristide Briand at Geneva offering him the premiership of France.

Political experts had expected this development since the fall of the Steeg cabinet on Thursday, but there was a general belief that Briand would decline the task of forming a new cabinet if he were asked to do so.

He has refused the post three times in the past eighteen months in the belief that he is more valuable to the nation as foreign minister, continuing his task of building a permanent peace for Europe.

Briand has been at Geneva for nearly two weeks, attending sessions of the League of Nations council and of representatives of 26 European nations examining his project for a Pan-European federation. Observers thought that if Briand should decline to become premier the president would turn to Pierre Flandrin, Pierre Laval or to Louis Barthou.

Jury Fails To Agree And Judge W.A. Devin Orders Mistrial In Fancher Case

Jurors Considering Embezzlement Charge Against Convict Superintendent Dismissed Shortly Before Six O'clock After Becoming Hopelessly Deadlocked; Court Adjourns

After the jury had become hopelessly deadlocked, Judge W. A. Devin, of Oxford, late yesterday afternoon ordered a mistrial in the case of C. B. Fancher, county convict superintendent, charged with embezzlement of county funds.

The case went to the jury yesterday about one o'clock, and twice the foreman reported to Judge Devin that they were unable to agree. Each time they were ordered back to the jury room to try again, but shortly before six o'clock Judge Devin ordered the jurors to come into the courtroom and then dismissed them.

The case came up for consideration on Thursday, and was featured by the introduction of a considerable amount of testimony dealing with the activities of the county convict head, who aside from being charged with embezzlement, also faces charges of bribery and cruelty to prisoners.

Fancher was indicted on all three charges by the grand jury in a previous session of criminal court. He vigorously denied the charges at the time, declaring they were the outgrowth of ill feeling on the part of political enemies.

He was alleged to have sold gold and oil assigned for use at the camp and to have misappropriated the proceeds.

On the stand yesterday morning, the road boss vigorously denied that he had applied the county funds to his own use. He admitted having sold gold and oil, but asserted that the money derived from the sales has been used in the county fund. He said the charges came from sources that had attempted to oust him from office.

Numbers of witnesses testified to the good character of Fancher, who has been in charge of the convict camp over a period of several years.

Miller Wins Suit Against Tom Mix

Eric, Pa., Jan. 24.—(AP)—Colonel Zack Miller, owner of the 101 Ranch shows, was awarded \$90,000 in his breach of contract suit against Tom Mix, movie cowboy, by a jury here today.

Miller had sued Mix for \$325,000 charging that the actor had broken a promise to appear as a circus rider in the 101 Ranch show. Mix denied an agreement had been made. The show owner claimed Mix joined the Sells-Floto circus at the time he had agreed to appear with the 101 Ranch outfit in 1929.

State Co-ed Held In Death of Man

Raleigh, Jan. 24.—(AP)—Miss Lorena Brinson, co-ed senior at N. C. State College, was under \$500 bond today in connection with the death of Edward F. Pescud, 76-year-old Raleigh man, who was struck and killed by an automobile driven by Miss Brinson.

The young woman, whose home is at Kenansville, told Coroner L. M. Warren she did not see the aged man in time to avoid the fatal accident.

The accident occurred last night at Pescud was crossing a street near the college campus.

Former Stenographer Heads Armour Co.

Chicago, Jan. 24.—(AP)—The firm of Armour & Company, packers, today was headed by T. George Lee, a former stenographer, whose election to the presidency was followed almost immediately by the resignation of Philip D. Armour, III, first vice-president and member of the company's board of directors.

Third executive control of Armour & Company, which for 63 years has had some member of the famous family in an official position, passed completely into the hands of others.

The third Philip is a grandson of "Old P. D." Armour, the founder. Armour's withdrawal as an executive was the fourth resignation among members of the Armour family within the past few years. Lester Armour, also a grandson of the founder, resigned as a vice-president in March of 1929, and Laurence H. Armour resigned as a vice-president in 1926. Laurence and A. Watson Armour, however, remain as directors.

Armour announced his severance of nearly 17 years of association with the company in a brief statement in which he said that "under the circumstances there was no alternative," adding that his action was the "greatest disappointment" of his life. He declined to amplify the statement, but it was learned that he had looked forward to becoming president of the concern after the death of P. D. Armour.

"This," said Armour, "is my swan song. I haven't anything to add to it."

White was killed January 15 when he fell from the seventh floor window of his home.

WILL APPEAL DECISION IN STEEL CASE

Youngstown Sheet Company to Carry Merger Fight To Higher Court

Youngstown, Ohio, Jan. 24.—(AP)—Youngstown Sheet and Tube company officials announced at a directors' meeting today that they would appeal the recent court decision enjoining the company's proposed merger with Bethlehem Steel Corporation.

Announcement of the decision was made by Walter Meub, secretary-treasurer of Youngstown Sheet and Tube, who emerged from the meeting long enough to say:

"We're going to appeal. That's all we are giving out."

Meub at once returned to the meeting, without answering reporters' questions.

It was assumed that the directors present, of whom six were pro-merger and four were allied with the Cyrus S. Eaton anti-merger faction, had approved the decision. The time limit for an appeal from the injunction, handed down December 25 by Judge David G. Jenkins, expires next Tuesday.

The merger contract expires the same day, but in the light of today's action undoubtedly it will be extended. It provides for extension by agreement between the president or chairman of the companies.

The meeting today was the first directors' meeting of Sheet and Tube since the court decision was handed down. It also was the first meeting since James A. Campbell, 75-year-old chairman of the company, and Cyrus Eaton since they began their bitter battle over the future of the Youngstown company.

MANY CASES DISPOSED OF DURING WEEK

Total of Sixty - Seven Actions Handled In One Week of Criminal Court

The criminal term of Pitt County Superior court, which came to a close in this city yesterday afternoon, disposed of a total of sixty-seven cases, according to records made public this morning by Solicitor D. M. Clark.

In thirty-four of these cases, the report indicated, the defendants received prison and road sentences covering a period of forty years and four months. Sentenced ranged all the way from four months to ten years.

Of the jail cases disposed of, twenty-five were for breaking and entering or larceny, three for second degree murder or manslaughter, two for assault with deadly weapon, three for handling of whiskey, and one for bigamy.

The next term of criminal court, the solicitor stated, will begin on April 13 and continue for two weeks. All cases remaining on the docket will be disposed of at that time.

In Craven county the preceding week, Mr. Clark said, twenty-five defendants were sentenced to the penitentiary for a total of sixty years and four months. Practically all of these cases were for breaking and entering and larceny, only one being for second degree murder.

Rutherfordton Men Go On Trial Today

Rutherfordton, N. C., Jan. 24.—(AP)—Eight prominent Rutherfordton men are scheduled to go to trial here February 2 for irregularities in connection with bank failures in this area last February.

Those who have been indicted, all facing one or more counts of accepting deposits knowing their institutions to have been insolvent, are: J. L. Taylor, president of the defunct Rutherford County Bank and Trust Co.; W. B. Walker, now of Hickory, cashier; T. F. Oats, former cashier of the Commercial Bank here; K. S. Tanner, manufacturer and bank director here and at Forest City; S. E. Elmore, textile manufacturer and former bank director here and at Forest City; E. E. Elmore, director; R. B. Doggett of Forest City, vice-president and chairman of the board of directors of the defunct Farmers Bank and Trust company there; L. C. Cobb of Monroe, former cashier of the Chimney Rock Trust Company; and D. M. Clark, director of the Chimney Rock institution.

General Assembly Holds Brief Session Today And Then Quits Until Monday

Only Bills of a Local Nature Considered During the Morning Hours; Groundwork Already Laid for Acceptance or Rejection of the McLean School Bill When Solons Go to Work Next Week

Raleigh, Jan. 24.—(AP)—Both Houses of the General Assembly brought their third week of work to a close today with brief sessions at which only local bills were considered.

During the week way was cleared for definite action Monday and Tuesday of the first phase of the educational program of the body.

By sitting the MacLean substitute bill for special order in the House Monday night and in the Senate Tuesday the groundwork was ready for acceptance or rejection by the Assembly of the proposal to have the state fully maintain and operate the six months school term by means other than ad valorem taxes.

The bill, a substitute for two introduced by Representative Young of Harnett and Senator Lindsey of Brunswick, would commit the General Assembly to the policy of state support but the finance committee would have to raise the means.

During the past week the joint appropriations committee has heard representatives of nearly all state institutions and departments present requests for increased appropriations over the budget commission allowance and will close these hearings Tuesday.

The Congressional district joint committee held one short meeting, long enough to get a motion to re-district and one to have the 11th Congressmen elected at large, and adjourned until the chairman calls another session.

Most of the other committees have begun to work holding hearings or considering bills.

Governor Gardner was on record today as reiterating his belief that "all salaries or none" should be cut 10 percent. In reply to a letter of Dr. A. T. Allen, asking the opinion of the governor on the bill of Representative Thomas of Anson, only cut teachers salaries, the Chief Executive replied at length that the salary of every officer and employee of the state and its divisions should be cut or none should be cut.

Today the two Houses each got one new bill and the lower division passed ten local measures. Both will meet at 8 o'clock Monday night.

Important measures given the General Assembly this week included the administration revenue bill, bills to abolish the state highway patrol and to provide for state maintenance of all county roads and measures to require the licensing of drivers of all motor vehicles and to insure added safety on public highways.

The Senate passed a joint resolution to memorialize Congress to pay World War veterans certificates immediately.

A measure to require reading of the Bible at the opening of public school each morning found its way into the legislative mills.

LEAF MARKET TO CLOSE HERE FEBRUARY 6

Report of Supervisor Shows Sales to Be Near the Seventy Million Mark

Greenville tobacco market will ring down the curtain on this season's activities February 6th, it was stated today in the weekly report of K. W. Cobb, supervisor of sales. In the meantime farmers will be urged to rush the remainder of the crop to market.

The report of the supervisor showed that seasonal sales had reached 69,660,576 pounds. For this amount the market paid out a total sum of \$9,082,082.13. The general market average was given as \$13.85.

For the week just closed the market sold 808,810 for \$91,420.27 at an average of \$11.30 per hundred pounds.

KIWANIS CLUB WILL SPONSOR WEEKLY CLINIC

Intensive Campaign Inaugurated In Behalf of Undeprived Children

If the Kiwanis club of Greenville has its way about it, the underprivileged children of the community are going to receive more attention in the future than in the past.

The club last night adopted recommendations of M. L. Wright, chairman of the objectives committee, that the organization sponsor the establishment of a weekly clinic, with a committee to assist in working out plans for the clinic, which would be held one time a week.

Mr. Wright declared that members of the medical profession here had offered to co-operate in such and President J. J. Summerell approved of the plan. He said Dr. McGeehy, director of the Pitt county health department, had offered his offices for use as a clinic, and also volunteered every other service in his power.

Mr. Wright pointed out that this made it possible to conduct such a clinic at small expense, and said the results would be more far reaching than under the old plan of handling such cases.

He declared the services of other organizations would also be a contributing factor to the success of the enterprise, and every effort will be used to get them to aid in the work.

Dr. T. M. Watson, formerly of Wilmington, told of the clinic of the Kiwanis club in that city, and said it had obtained good results. If properly controlled, a clinic, he said, should be a vital force in improving the condition of underprivileged children.

President Summerell expressed belief that the committee should be able to realize its ambition for intensification of its activities among children of the poor. He appointed the following as members of a committee to look into possibilities of the clinic, and to make it an actuality: Dr. T. M. Watson, Dr. H. M. Bonner, K. T. Futrell, Dr. M. B. Massey, Dr. McGeehy, Dr. L. Wright and Mrs. W. I. Wooten, president of the Woman's club.

President Summerell urged the Kiwanians to strive to increase the membership of the club during the present year. He also called attention to the campaign for relief of unemployment, and urged members of the club to contribute as liberally as possible to the cause. He told of the suffering and abject misery existing among the poor as result of unemployment and said immediate action was necessary to mitigate the situation.

Aside from the usual supper and song program, the Kiwanians were treated to a solo number by Mrs. John Karanac, accompanied at the piano by Mrs. Ray Tyson. An instrumental solo was also rendered by Miss Rabb, member of the student body of East Carolina Teachers College. Other guests of the club were Miss Best, of the college, and Herbert Stuckey, Boy Scout leader of the Wilson area.

It was announced that the next meeting of the club would be held at the Woman's club and the program will be in the form of "ladies' night."

RIVAL GUNMEN SHOOT IT OUT IN NIGHT CLUB

Charles Sherman, Club Owner, Reputed Gambler, Dangerously Wounded

New York, Jan. 24.—(AP)—In the Velvet Curtain club, on one of the hot spots of Broadway's night life, two rival "mobs" of gunmen shot it out before dawn this morning.

Police who got to the place after the shooting was over and the place deserted found Charles Sherman, night club owner and reputed gambler, near death on the floor.

He had many bruises and several wounds believed to have been caused by bullets, but his most serious injuries were stab wounds.

The interior of the club was a shattered wreck. Broken chairs, splintered tables, bullet-pierced walls and many bloodstains led police to the belief that two gangs had translated their enmity into a free-for-all battle with revolvers, knives and fists.

Sherman was said to have been engaged in the night club business at one time with Frankie Marlow, slain racketeer, and Larry Fay, regarded as a gambler of the "plunger" type, he was said by police to have been a close friend of the late Arnold Rothstein, whose killing remains one of New York's unsolved mysteries.

Mavis King, cigarette girl who said she found Sherman in front of the club and took him to a hospital in a taxicab, was detained.

Identifications in the heavy crimson rug indicated to detectives that at least two persons were hurt. A watch was set on all hospitals. The police ballistic squad took charge of two revolvers found on the floor.

Questioned briefly at the hospital, Sherman insisted he was attacked by two men outside the club. He said he was standing on the sidewalk awaiting the arrival of his girl "Lorraine" when two men came along, drew knives and "gave him the works."

"What's the girl's last name?" a detective asked.

"Don't bother me," exclaimed Sherman. "Can't you see I'm in agony?"

Prisoners Marched To Safety As Fire Wrecks Ala. Prison

Wetumpka, Ala., Jan. 24.—(AP)—While fire consumed the 92-year-old main building and left wing of the institution, 235 women and 337 men prisoners marched rapidly from the state prison here early today without loss of life or injury.

The flames were discovered near midnight on the third floor of the main building, housing a garment factory, and had gained headway before the Wetumpka and Montgomery fire departments could get sufficient water pressure to fight the fire.

When the alarm was sounded in the prison, the fire was in the main building. All prisoners were aroused and directed into the yard, where they huddled under guard, while the flames roared through the old building.

The north wing housing the women's cell blocks and the main building both burned, but after more than two hours, the flames were checked and the south wing in which youthful male prisoners were confined was saved.

Deputy Warden Frank Boswell and all extra guards, from Kilby prison at Montgomery, 20 miles distant, came here to aid in keeping the prisoners under control, but except for a few hysterical shrieks from women prisoners, the convicts were orderly.

Captive Mexican Lion Kills Child

San Antonio, Tex., Jan. 24.—A captive Mexican lion slew Viola Friesen, 2 years old, at her home here last night, betraying confidence built up in hours of play, staked out in the yard at the home, while her sister, Sarah, 15, and a brother Harry 15, took clothes from a line.

The animal owned by C. Coley, operator of a jungle show in winter quarters here, sprang as she approached. The other children were unable to beat him from her throat. Coley, attracted by their screams, slew the lion with a hammer.

Viola, her jugular vein severed, died in a hospital. Coley was booked on a charge of negligent homicide.

ABOUT TOWN

This section of the state, like
other parts of the nation, is faced
by a serious unemployment situa-
tion and scores of people are suf-
fering from pangs of hunger and
cold.

Attempting to provide for the
situation, a relief committee has
been organized to solicit funds and
attempt to mitigate the suffering as
much as possible. The hungry peo-
ple will be fed from a commissary
which will begin operation on next
Tuesday, and those worthy of help
will not have to worry any longer.

The plan is the same tried out by
the city last year, and it worked
with such unmistakable success that
it was decided to give it a trial
again this year.

Persons in need of aid have to
apply to the county welfare office
for a requisition for the amount of
goods they need and this will be
honored at the commissary. This
eliminates the possibility of any
one being served not deserving help,
and will enable the committee to
render a distinct service to those
who are actually in want and dis-
tress.

The committee is going to need
\$2,000 in cash and a similar amount
in food and clothing to meet the
insistent demand of the men, wo-
men and children walking the street
in quest of work and it is hoped
the public will contribute more
generously than it has ever con-

It is simply a case of carrying
relief to suffering humanity, and a
nobler cause cannot be imagined.

Automobile license tags are one of
the sources of revenue which the
city has to depend upon to meet its
obligations, and it is nothing but
fair that people should recognize
the fact and provide tags for their
cars.

The sale of licenses has moved
along so slowly that Mayor Lanier
has been forced to instruct police
to keep a keen lookout for those
without tags and then bring them
into court.

The public will be properly warn-
ed, of course, before they are car-
ried before the mayor, and people
who receive such warning should
provide themselves with licenses at
once and in that way eliminate the
possibility of the embarrassment of
being hauled into court.

The Red Cross is busy at this time
trying to raise the sum of ten
million dollars for relief of the
drought sufferers. Just how long it
is going to take to raise the fund
cannot be estimated, but if the
moneyed interests of the country
would contribute as they should,
the amount ought to be appropri-
ated in short order.

With the prospects of a million
people needing aid by the first of
the month, it is at once evident
that the organization must speed
up the raising of this fund as much
as possible. Only about two mil-
lion dollars had been donated up to
yesterday afternoon, and the cam-
paign has been in progress several
days.

The people of the nation had an
opportunity to hear about the seri-
ousness of the situation when prom-
inent men and women including
the President spoke over the radio
Thursday evening. They attempted
to impress upon the public the
necessity of liberal giving, and will
continue to use their influence in
this direction.

The problem of the various com-
munities of the state in taking care
of the unemployment situation, and
the fate of the Red Cross fund is
going to rest largely in the hands
of men and women of affluence and
prestige. Should they give as they
should, the organization will be able
to take care of the situation in a
way that will command the appro-
bation of the entire country.

BERG WINS FIGHT OVER GOLDIE HESS

Chicago, Jan. 24.—(AP)—Jack
Kid Berg of London sat tighter
than ever on his junior welter-
weight thrown today while Bat-
tallino, king of the feather-
weights, felt his scepter slipping.
The champions fought in the
two feature bouts at the Chicago
stadium last night and the fortune
of choice smiled on them. Berg,
who staked his crown, won a de-
cision over Goldie Hess of Los An-
geles after ten furious rounds that
had the crowd of 12,898 spectators
cheering from start to finish. Bat-
tallino, who risked nothing but his
reputation, dropped a decision over
the same distance to Eddie Shea,
pride of Chicago's West Side, after
a disappointing exhibition.

Berg's match with the freckle-
faced challenger from the Pacific
Coast was as pleasing as the Bat-
tallino-Shea fight was disappoint-
ing. Suddenly reversing his usual
slow-starting tactics, Hess swarm-
ed all over Berg in the first round.
Battered him with long swinging
lefts and right uppercuts and dazed
the Briton.

But the champion weathered the
stirring attack and, except for an-
other Hess assault in the eighth, he
handed the challenger a neat shel-
lacking.

It was Berg's first fight since his
return from England and after-
wards he announced that he would
do everything possible to force the
champions in the welterweight and
lightweight division to risk their
titles against him.

Berg weighted 138 1-4 pounds to
Hess' 137 3-4 last night.
A bad eye, tightly closed during
the final four rounds, helped take
the steam out of Battallino. Both
fought a cautious fight as the crowd
boomed their efforts, opening up in
spurts only.

Chile Starts New Commerce Policy In French Treaty

Santiago, Chile.—(AP)—Negotia-
tion of a reciprocal commercial
treaty with France, soon to be con-
summated, is the first major step
in the foreign trade policy of the
government of president Carlos
Ibanez.

Consideration is being given to
the possibility of similar contracts
with other European countries. An
attempt to get such a pact with the
United States came to an indefinite
halt about a year and a half ago.
The French treaty is a short-term
affair and does not contain the
"most favored nation" clause. Chile
has virtually given up that clause
as a matter of policy, deeming
short-term treaties better because
trade conditions change so quickly.

Under the new pact, each country
agrees to reduce import duties on
certain products of the other. For
France this means an outlet here
for some of her specialized manu-
factured goods; for Chile it means
a favored market for nitrates and
other natural products.

"BROILING"

Recipe No. 2

Broiling is the method used in cooking tender beefsteaks and lamb or mutton chops. Sliced bacon and sliced ham may be broiled. Pork chops and veal steak or chops cannot be broiled because these cuts require longer, slower cooking in the presence of some moisture to bring out their flavors to the full extent.

In broiling in an oven the meat should be placed two or three inches below the broiling unit and the oven door left wide open.

A steak for broiling must be cut at least one inch thick, better still, one and one-half inches thick.

After the steak is seared the temperature should be reduced some and the steak turned now and then until cooked as desired. Seasoning should be added after the steak is cooked.

Before putting in stove to broil, just wipe steak with a damp cloth then wash the edges, that is cut through the edges in about three places so that the steak will not curl up.

STOCK MARKET

New York, Jan. 24.—(AP)—The stock market ended a week of almost steadily advancing prices today with a mild setback.

A vigorous effort to extend the rally by bidding up the automobile group was less successful than similar efforts have been in the rail issues of late, whatever may be the effects of motor competition in the field of transportation.

The market reflected week-end profit taking at the start, but in the middle the session, stiffened with a rise of 1 to 4 points in motor and accessory issues. The upturn was only used to liquidate industrials and utilities, however, and the list closed irregularly lower with much of the advance in the motors lost. Rails were quiet and steady.

Total sales for the two-hour session were only about 1,150,000 shares. The improved tone of the bond market was reflected as favorable.

Tobacco was selling targets in the final transactions. It appeared that bears selected these issues for attack, on the basis of retail cigarette price-cutting, although manufacturers prices have not been changed, and their profits may be increased by the stimulus of consumption.

American Tobacco B dropped 5 points, and closed off 4, net. Liggett and Myers issues lost 2 and 3 points. Allied Chemicals was again a wide mover, dropping 7 points, and closing near the bottom.

Westing Electric, Air Reduction, and consolidated Gas lost about 2 points, and issues closing off a point or so included American Water Works, Woolworth, Sears Roebuck, American Smelting, and Electric Power and Light.

Reports from the steel industry, indicate that seasonal improvement has been partially checked. Operations in the Youngstown area, which serves much of the motor industry, next week are scheduled for about 40 percent of capacity.
