MANY STATES ADOPT PLANS FOR ECONOMY

About Half Of State Governments Attempt To Find Ways To Cut Expenses.

New York, Jan. 30.—(AP)—With a composite budget of approximately \$2,000,000,000 from which to trim tax-dollar savings, several thousand state legislators are at work in at least half the 48 states trying to devise means of reducing local government expense.

The force of the economy movement varies geographically from hot intensity to deliberate caution. The saving campaign is most intense in the middle west—in Iowa, Nebraska, South Dakota, Kansas and Oklahoma—in territory where the burden of local taxes for out-weights that of federal taxation.

In some states, notably those of greatest population, like New York, Ohio and Pennsylvania, no prospects for local tax reduction are reported. California, with a normal state budget of \$265,000,000 reports anticipated increases, including \$5,000,000 for the state building fund to provide jobs for unemployed. Georgia looks for an increased budget and so do Connecticut and Tennessee.

Pennsylvania reports that Governor Pinchot, pledged to a policy of no increase, hopes to hold the budget to normal. Oklahoma leads in proposals for drastic reduction. Governor "Alfalfa" Bill Murray has promised to cut out ad valorem taxes 50 per cent by July 1, through wholesale reductions of salaries and trimming and consolidation of governmental bureaus.

In Nebraska Governor Bryan has reduced the salaries of a number of appointive state officials without legislative action. Governor Green of South Dakota has proposed a schedule of salary cuts ranging from 10 to 25 per cent for all state employees and officials.

In Wisconsin Governor Diefenbaker is sponsoring abolition of personal and real property taxes amounting to \$4,000,000 a year, and the substitution of additional income, inheritance and special tax. In North Carolina to relieve taxes on lands, a state luxury tax, a gross receipts tax and a retail sales tax are proposed. North Carolina is also memorializing Congress to rebate more than \$50,000,000 of the \$265,000,000 federal tobacco tax which is collected in the state.

Legislators' salaries have been attacked in some states. In Nebraska it has been proposed to cut the solons' pay from \$800 to \$600 for a session. In Maine an attempt to eliminate an allowance to legislators of 50 free long distance telephone calls within the state during the session was unsuccessful.

Intentional payment of taxes has been proposed here and there as in North Carolina, and in Indiana there is a proposal to suspend the 10 per cent penalty on delinquent taxes for this year.

"Old Ironside" To Visit Wilmington

Wilmington, Jan. 30.—(AP)—"Old Ironside," her tattered ensign kept flying by Oliver Wendell Holmes and her timbers renovated a few years ago by contributions from school children of the nation, is expected here soon.

Louis T. Moore, who conducted the renovation campaign here has been advised by navy officials that the ancient vessel, pride of America's revolutionary war fleet and officially registered as the frigate Constitution, would come in the spring.

Likes Bishop.

New York—George W. Wickersham, whose commission has had a lot of headlines, and Bishop Manning, who received much attention after Ben Lindsey visited the cathedral one Sunday, spoke at the annual dinner of the Church Club of New York. Said Mr. Wickersham: "I have great sympathy for Bishop Manning because of the treatment of message to which he has been subjected recently and I more recently. I'm glad to be associated with him, however, even as a punching bag."

THIS DIOCESE TAKES LEAD IN CONTRIBUTIONS

Eastern Carolina Episcopalians Outstrip 27 Other Dioceses Of The Church.

The Episcopal Diocese of Eastern North Carolina leads all the other 27 dioceses of the church in contributions and number of persons confirmed during the year.

The number of persons confirmed in the Diocese during the year was more than five percent of the number of communicants. Rev. Stephen Gardner, chairman of the committee on the state of the church reported yesterday at the closing session of the church body's annual session.

The percentage for the church as a whole for the year was three per cent, he said. The committee chairman reported the Eastern Carolina division of the church also outstripped the other dioceses in contributions during the year.

The Diocese voted to hold its 1932 convention at St. Paul's church, Edenton, in January. The second day of the convention began with the annual corporate communion of the women of the diocese this morning at 7:30. Rt. Rev. Thomas C. Darst, D. D., bishop of the diocese, celebrating, assisted by Rev. W. A. Lillycrop, rector of the parish. At this service the bishop fund, given by the women of the diocese, was presented and amounted to \$700.

Mrs. Henry J. MacMillan of Wilmington, president of the Woman's Auxiliary of the Diocese of East Carolina, presided over the meetings of the auxiliary which were held in the library of the Greenville high school. Delegates from all over the eastern part of North Carolina were present for both the meetings of the convention and the woman's auxiliary in larger numbers than ever before. For many years the convention of the diocese and the annual meeting of the woman's auxiliary have been held in the same place and at the same time. Resolutions were made by both bodies to meet at different times in the future.

Dr. John W. Wood, general secretary of the church, who had given the missionary talk at the mass meeting the night before, addressed the women on the aspects of the missionary life in foreign lands.

The high light of the woman's meeting was reached in the talk of Mrs. Andy Manning Taylor on "Christian Social Service." Laying stress on the fact that anybody can give material aid, but what matters most is giving Christ with that aid, Mrs. Taylor said "Christian social service is helping for the present those who are in need as well as for eternity."

Other speakers at the auxiliary meeting were Capt. Turner of the church army, who told of the 23 missions he had conducted in the diocese during the year, using the motor van given by the auxiliary; Mrs. Cartawan of Columbia, who showed the growth of the rural work for the past year and Rev. David R. Covell, field secretary of the national council of the church, who presented the program of the church which included a teaching mission to be conducted by every parish and mission in the diocese next fall.

St. Andrew's church, Columbia, was admitted as a parish by the convention of the diocese. In presenting the report of the committee on the state of the church (Continued on page six)

LEGION POST ASKS PAYMENT OF CASH BONUS

Go On Record At Meeting Here Favoring Immediate Payment of Certificates.

The Pitt County Post of the American Legion went on record last night as favoring immediate payment by Congress of the adjusted compensation certificates, a question that is uppermost in the minds of World War veterans in every section of the country at this time.

Action was taken at a mass meeting at the court house at which time the proposed payment of service certificates was discussed at considerable length by various members of the organization. Numbers of legionnaires from all sections of the county attended the meeting, and evinced much interest in the "bonus week" program celebrated generally throughout the state this week.

The former veterans voted unanimously to urge the State Commander, endorsing immediate payment of the certificates and urging him to do everything in his power in favor of the measure.

The post at a previous meeting had adopted resolutions favoring payment, and copies were mailed to the various members of Congress and given due publicity in this section.

Commander J. C. Elliott, presided, and after debate on the bonus, called attention to the membership drive which the post voted to conduct at the last meeting. Numbers of veterans paid their dues last night, and placed themselves in position to take an active part in the campaign to bring about an improvement in post activities.

Commander Elliott expressed gratification at the splendid interest manifested by the legionnaires in the membership drive and said he hoped it would be the most distinct success of any similar campaign in years.

DEMOCRATS TO GO THE LIMIT FOR RELIEF

Decision Reached At Meeting Of Senate Members During The Morning Hours.

Washington, Jan. 30.—(AP)—Senate Democrats decided at a party meeting today to go to any limits necessary to obtain their relief programs.

Senator Robinson of Arkansas, minority leader, was strong in support for a finished fight with President Hoover and the Red Cross for his \$25,000,000 relief appropriation.

The party also determined to insist upon the appropriation of 20,000,000 bushels of Farm Board wheat; the fund of \$3,000,000 for medical supplies in the drought area; and the \$5,000,000 appropriation for organization of relief corporations.

All of these proposals have been voted by the Senate but the House has acted on none.

The Democrats made it clear after their conference that they are willing to force an extra session of the new Congress in the spring if necessary to win their program although the party leaders have expressed themselves as opposed to an extra session unless forced into it.

"No compromise" was the ultimatum which the Senate Democrats determined to serve.

Including also in the program was the \$2,500,000 revolving fund for re-loans to farmers in the flood stricken areas of North Carolina, South Carolina, Georgia, Florida and Alabama.

The Senate has approved this proposal, but the House was not. Notice also was given by Senator Caraway, Democrat, Arkansas, that he intended to renew his fight for the \$15,000,000 food loan fund which the House rejected.

The measures included in the Democratic relief program have been incorporated in three separate appropriation bills—those for the Interior and War Departments, and the first deficiency measure.

Unless these bills are enacted into law before March 4, an extra session of the new Congress in the spring is regarded as imperative.

Appropriations for these departments are exhausted on July 1 and the fund carried by the measure will be necessary to permit the departments to function next year.

Illness of Juror Causes Deferment Of Maxton Case

New York, Jan. 30.—(AP)—The illness of a juror who has the flu resulted today in the third postponement of the trial of James Matthew Maxton, Jr. son of the Protestant Episcopal bishop of Tennessee, who is accused of beating David Paynter to death in a drunken brawl in a West side rooming house last April.

The flu victim, Arthur W. Hutchins, one of the vice-presidents of the Irving Trust Company, is expected to be well by Monday, when the trial is scheduled to proceed. Previous postponements were caused by delays in the trial proceeding Maxton's on the court calendar.

General Sessions Judge Donnellan said after adjournment of court that if the sick juror does not return on Monday, he will be replaced by one from an incoming panel.

De Priest and Wife Attend Reception at The White House

Washington, Jan. 30.—(AP)—Oscar De Priest, negro representative from Illinois, and his wife, last night attended President Hoover's annual reception to members of the House.

They took a place about midway of the line waiting to receive Mr. and Mrs. Hoover's greetings, shook hands with the President and the first lady and then repaired to the east room.

There Speaker Longworth approached and shook hands with them. Mrs. Longworth, the former Alice Roosevelt, did not attend the reception.

The reception is one of the regular series given for government officials and diplomats.

Wide publicity was given shortly after Mr. Hoover entered the White House to Mrs. De Priest's attendance at a tea given by Mrs. Hoover.

BUTLER ASKS LEONARD TO DEFEND HIM

Former Major Of Service Will Act As Counsel Pending Court Martial.

Washington, Jan. 30.—(AP)—Major General Smedley D. Butler of the marine corps has asked Major Henry Leonard, U. S. M. C., retired, an old friend of his service days during the Boxer rebellion, to act as his counsel during the pending court martial.

Revealing the step, Major Leonard said he probably would accept. He expects to confer with Butler before the day is over.

The court martial was ordered yesterday after Butler had submitted to Secretary Adams an explanation of a recent Philadelphia speech in which he was quoted as retelling a story by a friend about Premier Mussolini running over a child and paying no attention to the accident. An apology to the Italian premier was made yesterday as a result.

Since retiring from the marines in 1911, Leonard has practiced law in Washington. At one time he was assistant judge advocate general of the navy.

He and Butler served together in the Boxer rebellion in China. The general once was saved from possible death by Leonard during a campaign at Tientsin. Leonard's left arm was shattered by gun fire as he effected the rescue of Butler, himself badly wounded.

Washington, Jan. 30.—(AP)—Congress heard its first recitation from the court martial ordered for Major General Smedley D. Butler today while preparations for his prosecution and defense went ahead.

Premier Mussolini cabled the Italian Ambassador here, saying he considered the incident closed and had "forgotten."

The court martial was ordered because of derogatory remarks about the Italian leader repeated by Butler in a Philadelphia speech as having been told him by an unnamed friend. An apology to Mussolini was made, and it Duce said in his cable gram he had felt assured of such "just and prompt redress."

WILL CANVASS FOR CLOTHING ON SATURDAY

Scouts to Cover City In Trucks Collecting Garments For Unemployed.

The campaign to provide clothing for the unemployed people of the community will get underway in real earnest here tomorrow when Boy Scouts, directed by members of the local relief organization, will collect the town with trucks to collect clothing for the poor.

The Scouts will begin the tour of collection at 9 o'clock, and hope to be able to complete the work at the earliest possible moment. People desiring to give to this movement are urged to prepare their bundles tonight and have them in readiness when the Scouts visit their homes tomorrow. All bundles should bear the inscription, "For Relief Committee" so that other packages may not be confused as gifts.

If the truth happens to miss anybody desiring to contribute, he is urged to call the Daily Reflector, and somebody will be sent for the bundle immediately.

Members of the committee stated today they hoped the gifts would be liberal in every sense of the word. Although every type of clothing is needed, the demand for women's and children's clothes was said to be more pronounced in every section of the community.

An investigation of conditions here has revealed the fact that suffering is more severe than at first thought, and it will become more accentuated in the negro districts when tobacco factories close down throwing hundreds out of employment.

The citizenship has been urged to go on a tour of exploration into closets and garrets and bring out anything that will protect the emaciated forms of the poor, and then tag them for the visit of the trucks tomorrow morning.

J. L. Kilgo Again Heads Tobacco Board of Trade Old Officers Re-elected

Interesting Talks Mark Annual Meeting of Organization At Shamrock Dining Room Last Night; Appointment of a Supervisor of Sales Deferred Until a Later Date; Raise Fund For The Unemployed.

J. L. Kilgo, was re-elected to the presidency of the Greenville Tobacco Board of Trade at the annual meeting of that organization at the Shamrock Dining room last night. The meeting was attended by practically one hundred members of the tobacco industry and was marked by several timely talks dealing with the past season and the season to come.

C. W. Shuff, was re-elected to the vice-presidency and H. A. Best, as secretary and treasurer. President Kilgo presided.

Among the speakers of the evening, and there were many, was Mayor J. C. Larier, who expressed his appreciation of what the tobacco market meant to the town, and predicted progress for the future. He said he thought prospects for development of the industry were just as bright as they have ever been before and urged tobaccoists to go to it and attempt to surpass all previous records.

W. H. Woodard, vice-president of the Greenville Banking & Trust Company, said he was fully aware of what the market had done toward making Greenville one of the outstanding towns in this section of the country. He expressed belief that the present period of depression would not handicap the tobaccoists to any great extent in their ambition to shatter previous marks in the days to come.

He assured his hearers that the banking interests of the county were in sympathy with the expansion movement, and promised they would do everything in reason to convert present dreams into realities.

J. H. Waldrop, cashier of the Greenville Banking & Trust Company, said he was looking forward to better days despite the damper brought about through depression, and expected the market to show pronounced growth next season.

C. B. Rowlett, W. S. "Billy" Brown, "Slick" Lee, J. E. Winslow, W. W. L. Mark Turrage, W. M. Scales and Simon Moya also spoke of the work of the market and expressed their pleasure of the interest manifested in continued expansion.

The latter part of the meeting was devoted to a general discussion of the industry and many matters connected with the operation of the market were discussed and ironed out.

FEUD LEADER PASSES AWAY AT POUND, VA.

"Bad" John Wright, Leading Figure In Mountain Feuds, Dies At Age Of 92.

Pound, Va., Jan. 30.—(AP)—"Bad" John Wright, 92, died at his home here at 2:30 o'clock this morning.

For years he was a leading figure in mountain feuds in this section and it was definitely known that nine persons were killed by him. Reports credit him with killing 36.

He is survived by a large number of relatives. "Bad John" Wright, who furnished the inspiration for the character "Devil Judd" Toller in John Fox's "Trail of the Lonesome Pine" had been in ill health for a number of months and grave fears were expressed when he became ill last fall.

Courageous, of gigantic stature, and acquainted with his native Cumberland as well as any man of his day, the noted mountaineer as an officer of the law gained a wide reputation. This reputation was that of an officer who "got his man" and was won in a day and a section when this depended to a large extent upon a quick eye and an equally alert trigger finger. "Bad John" had both.

All of Wright's peace officer casualties were the result of fugitives refusing to surrender. Earlier in life "Bad John" participated in the famous Wright-Hall feud in which a large number of men were killed. It was never established whether "Bad John" added any notches to his gun stock in this feud and in later years he refused to talk about it.

Although he did not know the exact year of his birth in Letcher county, Kentucky, near the Virginia line, Wright guessed 1843 was the year. Those who knew him said he was at least ten years older.

Wright, whose enormous stature also had given him the nickname of "The Tall Sycamore of the Elk-horn" was a guard at the Wise county, Va., jail, when Fox knew him. The novelist and Wright became fast friends and Wright's experiences as drawn out by Fox furnished the color of the "Trail of the Lonesome Pine."

Money In Whaling.

Cardiff, England.—There's money in whaling. J. C. Gould was reputed to have made \$12,000,000 in shipping during the war. He lost it and in 1925 owed several millions. Then he organized several British-Norwegian groups in the whaling industries. He has informed his friends that he has come back.

Measure Introduced By Senator Whedbee Of Perquimans As Proponents Celebrate Victory Of McLean Bill Providing For State Support Of Schools Passed Last Night.

Raleigh, Jan. 30.—(AP)—While proponents of the MacLean school bill providing that the state take over full operation and maintenance of the six months school term were jubilant over its passage by the General Assembly Senator Whedbee of Perquimans today introduced a bill calling for a 20 cent state ad valorem tax for support of the six months schools.

The MacLean bill, approved by both houses, provides that the revenue to run the schools must come from sources other than an ad valorem tax.

The Senate and House both passed state-wide measures as they cleared calendars today, including the Jeffress bill to make it unlawful to slander building and loan associations and the Jones measure to give power to recommendations of mercy by juries in capital cases.

The House approved the measure of Representative Upchurch of Wake to make it unlawful for city-owned automobiles to be used for private purposes.

Both houses will meet at 10 o'clock Monday night. Only local bills are considered on Saturday. Senator Whedbee's bill calls for a 20 cent ad valorem tax and the other funds to come from the state general fund.

Under its provisions the state would operate all schools from the first through the eleventh grade for six months, with no allowance made for the 12th grades.

A central purchasing agency for all schools of the state be created and county boards of education would spend no monies except for extended terms and additional courses besides those prescribed by the state boards of education and equalization, which would administer the provisions of the bill.

A state-wide revaluation to be completed by May 1932 is provided for in cities, counties and towns would not be allowed to levy an ad valorem tax of more than 20 cents to meet expenses of an extended term.

Standard scales for salaries of teachers are provided.

It is estimated that \$18,000,000 will be needed for the state support of the six months term.

The Senate gave its approval after nine hours of oratorical fight in two day and two night sessions. The House passed the measure on Tuesday by a three to one majority.

The law instructs the finance committee to provide ways and means for financing the project and the education committee to map out plans for an equalized state system of schools.

Most mentioned as probable sources of revenue are a sales tax and a tax on stock in foreign corporations. There are several measures providing for "luxury" taxes now before the assembly.

Opposition to a sales tax was one of the main objections of opponents to the bill. Proponents argued they came to Raleigh to reduce land taxes and the one way to do it was for the state to take over and maintain the schools even if a sales tax were necessary. They estimated the state supported school would relieve land of \$12,000,000 annually in taxes.

The fight for the schools started early in the session and has held the spotlight from the time it hit committee.

Senator Lindsey of Brunswick and Representative Young of Harnett introduced the original bills in the two respective Houses.

The joint education committee overwhelmingly approved the substitute for the Lindsey-Young bills authored by Rep. A. D. MacLean of Beaufort. MacLean combined the (Continued on page six)

Niagara Falls To Vanish As Rocks Crumble

By HOWARD W. BLAKESLEE (Associated Press Science Editor) Ithaca, N. Y. (AP)—The self-destruction of Niagara Falls already is written on its rocks.

They slope the wrong way, between the Falls and Buffalo, dipping back from the brink downward instead of upward.

So, when a section of the cap rock breaks off, as did the big V on the American falls, the new brink, formed a step behind, is also a fraction of a step lower. This geologists say, means finally turning the falls into rapids.

Part of the proof for this prediction goes back 25,000 years in evidence that the Falls at that time stood at Lewiston, seven miles below their present position. They have cut their way up-river since but 25,000 years is too long a period to cause much concern.

However, proof of a more immediate nature, promising disturbingly rapid changes in the present, is on file in the records of Dr. H. Ries, head of the department of geology at Cornell University.

These records cover the 161 years, ending in 1923. They show that the falls in that time receded 820 feet, nearly one-sixth of a mile. They show also that the average annual rate of cutting back has been more than five feet. From 1905 to 1925 the recession was 110 feet, just under six feet a year.

This rapid retreat is on the Canadian side, in the Horseshoe where the bulk of Niagara runs.

Why continuation of the cutting means a future rapids instead of a mere moving backwards of the Falls as in the past, is explained by another geologist, Dr. Chester A. Reeds, of the American Museum of Natural History.

The cap rock is at fault. This is the hard stuff that forms the brink. It is fairly thin compared with the great height of the falls, and it slopes slightly downhill backward from the present brink.

On top of this cap rock, upstream the river bed is upon softer rock, which is expected to wear down into rapids as the cap rock retreats deeper and deeper with the recession. It is estimated that four or five miles of further recession will bring the rapids into existence. Can man make efforts prevent the erosion? Ries and Reeds made no answer to the question. The means are not now in sight.

Transport Arrives With Dead Marines

Norfolk, Va., Jan. 30.—(AP)—The naval transport Vega, with the bodies of five marines killed by Nicaraguan bandits several weeks ago, docked at Hampton Roads naval operating base this morning.

The bodies were brought ashore, and taken to the naval hospital, at Portsmouth, for disposition in accordance with the wishes of relatives.

Seventeen Injured As Fire Destroys Broadway Building

New York, Jan. 30.—(AP)—Dancing flames levelled a six-story building on upper Broadway early today, driving more than 200 persons into the cold, injuring 17 others and throwing the great white way into a turmoil.

Of the injured, two firemen were gravely burned when the fourth floor collapsed, catapulting an entire hook and ladder company to the floor below. Two newspaper photographers were dangerously hurt a block from the fire when flashlight powder prematurely exploded, mangle the left hand of one and possibly blinding the other.

Most of the tenants, occupying 190 apartments on the upper five floors, scurried to safety via elevators, fire escapes and metal bridges leading to adjoining buildings. Others were helped to safety by firemen and fellow lodgers. The majority were artists and theatrical folk and many were elderly.

The scene was the Lincoln Square building, known also as the Miller building, which is located at the corner of 66th street and Broadway. It houses an arcade leading to Loew's Lincoln Square theatre, in a separate structure, and shops on the ground floor. The construction is of wood and brick.

Starting on the third floor about midnight, the fire spread rapidly in a steady wind.

Some 400 firemen fought the flames from every conceivable vantage point. From the streets, nearby elevated structures and adjoining buildings, they poured tons of water into the inferno.

The theatre building, a movie house, was not damaged and all its patrons had departed before the blaze.

Meanwhile Broadway was in the throes of the greatest excitement in years. Thousands flocked to the scene from all parts of the city and police were forced to rope off an area four blocks square to restrain them. All elevated and street traffic was suspended.

Angier Dismissed At Harvard For Throwing Fruit

Boston, Mass., Jan. 30.—(AP)—The Boston Post says that James S. Angier, a New Haven, Conn., Harvard student and son of Professor Russell Parker Angier of Yale, was dismissed from Harvard University by the faculty today. The dismissal, the Post adds, followed a series of escapades which ended last Thursday night, when grapefruit were hurled at Rudy Vallee by three students at the Metropolitan theatre.

Angier, the Post says, was one of three Harvard boys taken to the Le Grange street police station in connection with the grapefruit episode. The fruit was hurled at the radio singer from the balcony.

Ships Duplicate Race in Hearing Of Rum Runner Case

New York, Jan. 30.—(AP)—The discovery that the Canadian rum runner Josephine K is a slower craft than their east guard cutter which shelled her last Saturday night, killing her master, stirred up trouble in international waters today.

At the suggestion of Gerald Campbell, British consul general, the two boats played a return engagement yesterday in the lower bay and at the finish mark it was determined that cutter No. 145 averaged 11.15 knots, while the rum-runner lagged at 9.55 knots.

Over a three mile course between West Beach light and Old Orchard light the vessels duplicated the race in which Captain William P. Cluett was fatally wounded. With the same crew that manned her before, the cutter steadily narrowed the gap between the Josephine K, operated this time by a coast guard personnel, under a 20-minute handicap, a before, the cutter had gained nearly a half mile when the race was over.

Boatswain Karl Schmidt, commander of the cutter, had contended before the board of inquiry that he was forced to fire on the rum-runner because she was drawing away from him toward the open sea and he feared she would escape.

At the close of the demonstration, Commander John R. Bryant, head of the board, refused to comment but said the complete findings would be forwarded today to Rear Admiral Frederick C. Billard, commandant of the coast guard, in Washington.

Woman Continues Alienation Suit

Winston-Salem, Jan. 30.—(AP)—Mrs. Kathleen Alexandra B. Hankins, who claims her wealthy father-in-law ridiculed her Irish ancestry to turn her husband away from her, today continued her \$150,000 alienation of affections battle in Forsyth county court.

Mr. and Mrs. J. R. Hankins, rich and well known Winston-Salem residents, are the defendants.

The 28-year old wife of James Hankins, their son, charges they maliciously poisoned her mind against her and brought about a separation early last year.

Yesterday, as she neared the end of two days on the witness stand she denied the \$150,000 suit resulted from a collusion between her husband and herself. She testified, under the grilling of defense attorneys, that she never thought about taking legal action until her husband on February 25, 1930, ordered her out of their Winston-Salem home.

Mrs. Hankins, mother of four children, said that before that time her husband and his father had had numerous controversies regarding her.

On one occasion, she testified, her father-in-law told his son that "of all the races in the world to pick a wife from" the Irish is the worst.

J. R. Hankins who at one time was pastor of the First Baptist church at Charlotte and at another time was superintendent of schools at Dawson, Ga., is widely known as a mathematician and linguist.

Crowds of former strikers gathered today at employment offices of the mills seeking old jobs, but only a few were taken back. The greater part of the number were told that the mills were now operating with no vacancies.

Danville, Va., Jan. 30.—(AP)—Danville's four month's old textile strike was at an end today and 3,600 union workers prepared to take the mills for reinstatement.

The strike ended yesterday by a vote of the workers. Today would have begun a fifth month of the controversy had action not been taken.

C. S. Garrison, public relations representative of the American Federation of Labor, said that might be understood this mills could re-employ from 800 to 1,000 of the strikers immediately and that others could be added as machinery was put in order. There were 3,600 members on the union rolls, he stated, defections numbering approximately 300. He said all those who had continued on strike would proceed at once to obtain their former jobs.

The strike ended suddenly and apparently without negotiations between the union and the mill management.

union organization and yesterday the workers balloted. Two hours before the voting place was closed, Garrison announced the strike was over, stating the vote overwhelmingly favored a return to work.

Francis J. Gorman, vice-president of the United Textile Workers of America, in a prepared statement, said that recent actions and statements of the mill management indicated there would be no discrimination against union workers. The strike was called, he said, because of a belief that such discrimination was being practiced.

All attempts at mediation during the controversy failed. Governor John Garland Pollard, first to offer his services in bringing the disputants to agreement, was met with a reply from H. R. Fitzgerald, president of the mills, that "there was nothing to mediate."

Similar efforts by Secretary of Labor James J. Davis, and his successor, William N. Doak, as well as the offer of arbitration on the part of the union through William Green, president of the American Federation of Labor, elicited similar replies from the mill.

The mills management steadfastly maintained that there was no argument between employer and employee but that outside labor leaders had misled the workers.

The strike was punctuated by bombings of homes of several non-union workers and of a church and by several demonstrations. Troops were sent to the scene by Governor Pollard on November 26, after a disturbance in Schofield the night before and were still on duty today. The time of their withdrawal was unannounced pending a report of conditions in the strike area by Adjutant General S. G. Waller to the governor, who is on vacation in Florida.

As the strike drew to an end, it was announced from union headquarters that there were 1,500 cases of influenza among members of families of strikers. It was also learned that 250 non-union employees of the mill were absent from work with the disease.

must get busy and settle up as
many accounts as possible and in
that way enable the merchants to
be more liberal with credit.

Two Condemned Men Receive Executive Clemency At Raleigh

Raleigh, Jan. 30.—(AP)—Two
men sentenced to be electrocuted,
Hazy Jackson of Rowan and Jeff
Morrow of Craven, were given
commutations to life imprisonment
by Governor Gardner today.

Both men were convicted of
Statutory crimes and in both cases
the trial judges and solicitors re-
commended clemency.

Mrs. Sarah Holmes, convicted in
Richmond county in September 1925
of murder in the second degree and
given 15 to 20 years, was paroled.
The statement set forth "there has
always been a great deal of doubt
surrounding the guilt of this pris-
oner" and added she had made a
splendid prison record.

Others paroled were: Joe John-
son, Catawba county, sent to prison
in February 1930 for two years for a
statutory crime; J. B. Hicks, con-
victed in McDowell in June 1930 for
violation of the prohibition law and
given 18 months; John W. Gregory
sentenced in Mecklenburg in July
1930 to 10 years for storebreaking
and larceny; E. C. Wiley and Oliver
Hauser, sentenced in Forsyth in
March 1930 for storebreaking, lar-
ceny and receiving to serve 18 to
24 months each; Allen Dills, sen-
tenced to 17 to 20 years in April
1929 in Macon for manslaughter;
Harry Ross, convicted in Randolph
in April 1928 for breaking and en-
tering and sentenced to five to seven
years.

The annual meeting of the To-
bacco Board of Trade last night
showed how determined are the to-
baccoists of this city to make the
city the greatest tobacco market in
the country.

Plans looking in this direction
will be pushed forward in every
branch of the industry during the
summer months, and when the mar-
ket opens next season it will find
warehouses and factories in better
shape than ever before to care for
the enormous offerings of the
farmers of this, the largest tobacco-
producing country in the world, and
the very heart of the bright
leaf industry.

The end of the present season will
witness the realization of the goal
of seventy million pounds of to-
bacco which the market set as its
goal the first of the season. It is
more tobacco than has been sold
here except one year, and shows
what can be done when a deter-
mined body of men start out to do
something.

Each season has seen develop-
ment in both warehouse and fac-
tory facilities until this market
ranks with the largest of the world,
and it is certain the next season
will bring forth just as many im-
provements. It is the spirit of
Greenville people to go forward
even under extraordinary circum-
stances, and they are going to con-
tinue to mount the ladder to fame
in the tobacco world despite hard
times, financial depression, and the
little discussions which sap at the
life of every thriving community.

Pitt county men who fought in
the world war are of the opinion
they should use the cash from their
adjusted compensation certificates,
and have taken action to let Con-
gress know about it.

The matter was talked to the
satisfaction of the major part of
the veterans at a bonus night pro-
gram at the court house last night,
and the sentiment of the meeting
was for immediate passage by Con-
gress of the measure providing for
payment of service certificates.

Resolutions to this effect were
adopted at a recent session of the
Legion, but not content with this,
they talked the matter over again
last night, hoping to bring to bear
their influence in behalf of the
compensation movement.

These men didn't ask anything
about how much they were going to
be paid for offering their lives upon
the altar of war; they didn't expect
anything big when they came
back home, penniless and without
jobs, but now there is a chance to
be paid for their services while
they are able to enjoy it, they are
demanding payment.

Secretary Mellon says the pay-
ment of the bonus would disrupt the

Fourteen Colleges To Continue Spring Football Practice

New York, Jan. 30.—(AP)—The process of defating football has begun.

Of thirty-four eastern colleges and universities, queried by the Associated Press, only fourteen have definitely decided to continue spring football practice. Eleven plan no drills in the spring while nine have not yet disposed of the question.

Elimination of spring practice has been suggested as one means of reducing alleged over-emphasis of the game.

Among colleges which will retain the spring training idea, curtailed in some instances, are the Navy, Rutgers, Dartmouth, Cornell, Villanova, Syracuse, Colgate, Pittsburgh, Washington & Jefferson, Duquesne, Penn State, Bucknell and Temple.

Dropping this feature entirely will be the Army, Carnegie Tech, Lafayette, Maryland, Rider College of Trenton, N. J., Delaware, Haverford, Swarthmore, Penn Military, Allegheny and Geneva.

Yale, Harvard, Princeton, Columbia, New York University, Fordham, Brown, West Virginia and Pennsylvania have not yet decided whether spring practice will be held. Several of these are expected to join the group which has abandoned the early practice sessions.

Definite steps toward curtailing football practice was taken at the football meetings here in December. The national football SSMF, The National Football Coaches' Association adopted a series of resolutions, offered by Bill Roper, former Princeton coach, which opposed "compulsory spring practice" or the start of "organized fall practice" before Sept. 15.

**TO PROBE CHARGE
OF GRID PROSELYTING**
Washington, Jan. 30.—(AP)—Charges that West Point authorities have permitted proselyting of football players are to be investigated by the military academy.

Such an inquiry was demanded by Representative Fish, Republican, New York, late yesterday. General Douglas MacArthur, the chief of staff, said the charges would be forwarded to the academy for investigation.

Specifically, Fish asked an investigation of the activities of W. T. Wrightson, a member of the Army Athletic association, and of Paul Carroll, a cadet, in connection with alleged efforts to induce Kenneth Goff, star Rhode Island State football player to enter the academy.

ENGLAND IS GIVING MUCH TIME TO GOLF

By FOSTER BAILEY
New York, Jan. 30.—(AP)—Golf in England and along the Atlantic seaboard flourished like the green bay tree during 1930 and prospects for 1931 are no less bright.

In the thickly populated eastern states golf is in the nature of big business, with millions invested in property and clubhouses and a weekly payroll that runs into hundreds of thousands of dollars.

The Massachusetts Golf Association lists 117 member clubs, with 32 belonging to the national organization. 51 clubs belong to the Philadelphia organization. Fifty-three clubs in New York State hold membership in the United States Golf Association, the largest representative of any state; 27 are listed from New Jersey, 25 from Pennsylvania, 12 from Connecticut, 10 from Delaware, and four each from Rhode Island and New Hampshire.

President Aalbot C. Chase, president of the Massachusetts body, estimates that 3,000 men are on the payroll of the Bay State clubs and that the payroll runs above \$50,000 a week. As a result of an appeal made by him on behalf of the Massachusetts unemployment situation, 60 per cent of the clubs kept their workers through the winter, doing repair work on the various courses.

Construction work in Massachusetts, it is estimated, will cost more than \$1,000,000 this year, with \$500,000 of that amount being spent on two new courses in the Boston area. The Connecticut Golf Association reported play was greatly increased last year on the courses of its 60 member clubs and similar reports were received from the 29 private clubs and 20 semi-public courses in Maine.

New Billiard Champion
Chicago, Jan. 30.—(AP)—Arthur Thurnwald of Chicago, who thought he could play billiards because he was a good geometry student, is the new three-cushion champion of the world.

The lanky Swede captured the title worth between \$20,000 and \$30,000 by defeating another Chicagoan, Allen Hall, 50 to 43 in 53 exciting innings last night in the final match of the 1931 championship tournament.

SPORTS SLANTS

By ALAN GOULD

(Associated Press Sports Writer)
The banishment of the so-called "sand wedge" as a legal instrument in the royal and ancient game has served at least one every excellent purpose—as a warning to implement makers not to turn out any trick tools for the trade before getting the sanction of the powers that be, otherwise the United States Golf Association.

"We have had some reaction of course, to the abolishment of this wedge," Herbert H. Ramsay, the new chief executive of the U. S. G. A., told me recently. "I understand the manufacturers feel a bit harsh but there is no question this implements comes under the heading of a 'convenience'."

"Someone got the idea we had tactically decided to do nothing about the wedge; in effect to let it use go along. As a matter of fact the association's executive committee did not consider the question until a meeting late last year. The decision then was clear-cut."

"That's all there was to it. Since then, I have had a visit from a man representing a firm intending to make a variation of the wedge. It just dawned on them that before they put it on the market it would

be a good idea to find out before hand whether it would be legalized by those in control of the game. So the warning, at least, has been fruitful."

The U. S. G. A. has about definitely decided to hold the new sectional qualifying competition for the National Amateur championship in the same strategic centers now serving the purpose of qualifying grounds for the open tournament. They cannot, however, be held concurrently because of the difference in dates the open being played in July and the amateur finals in September.

President Ramsay says: "The only objection I have heard voiced the new sectional plan for the amateur is that we cannot find 150 players qualified for this championship event. This objection might be made under any circumstances. It probably is based on the fact but what we are mainly interested in is giving every good golfer a chance to qualify."

"The sectional preliminaries will be a step toward accomplishing this without altering for the time being the championship tournament itself. As a matter of fact the field will be about the same size at Beverly this year as it was at Merion last September—about 150."

"By a more selective preliminary process, we will give more opportunity to a bigger number of players. Medals will go to the winners of the 20 sectional qualifying events so that some further distinction will

be attached to the competition. "We will in his way, develop championship talent more quickly. As to whether, in the future, we may alter the finals to eliminate the much-discussed 18-hole matches, I cannot say. That may come. Now we consider the combination of medals by 18 hole and then 36 hole match play as the best all-around test."

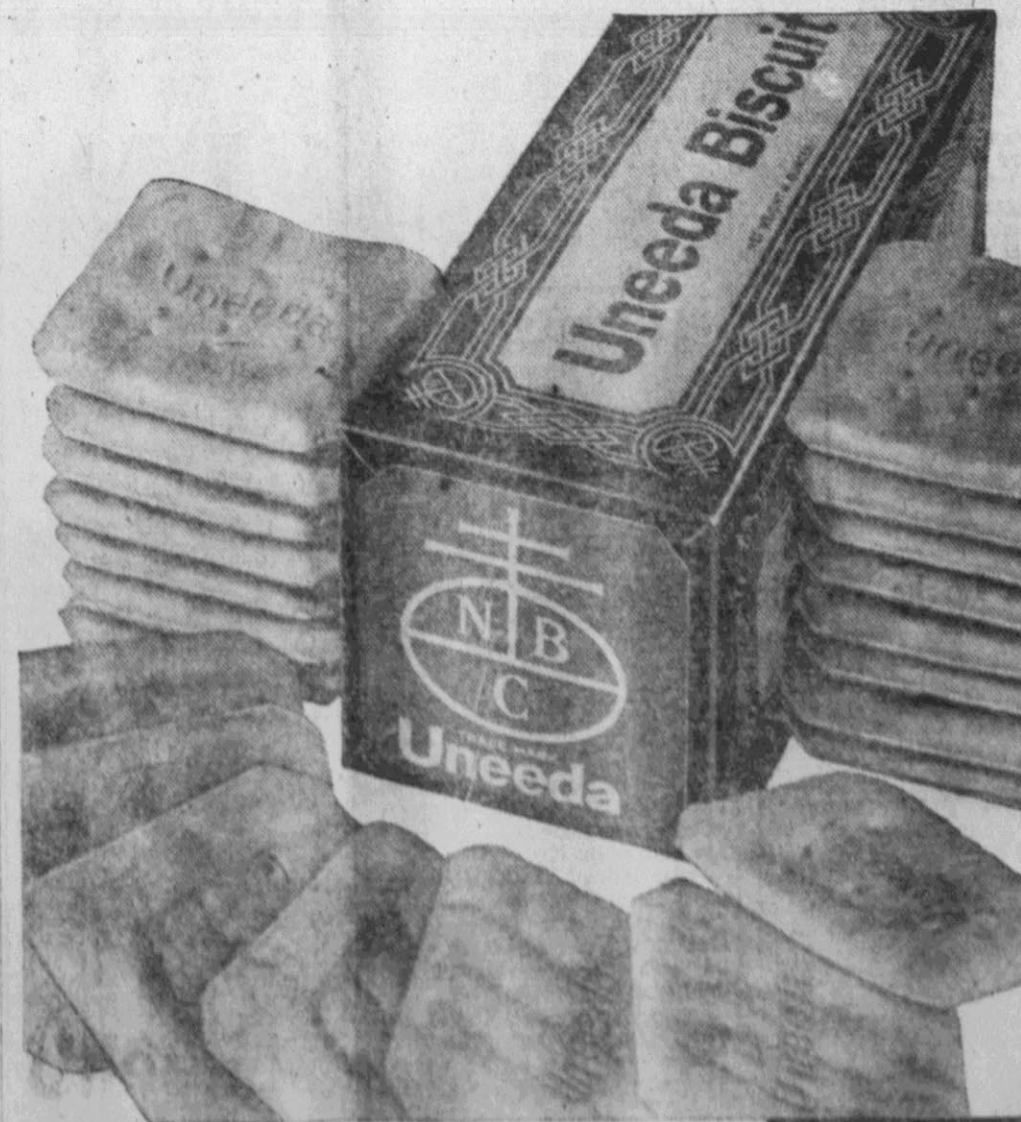

STOCK MARKET

New York, Jan. 30.—(AP)—Professional traders diverted themselves by pinching the bears in a handful of issues in today's stock market, while the financial community was primarily absorbed with annual earnings statements.

The share market maintained a strong tone, but trading was light and highly professional if a little more active than yesterday. The hearings in Washington regarding redemption of the veterans' certificates continued to inject an element of uncertainty into the security market outlook, and in the bond division the government obligations were again rather soggy. Share prices eased off from their best levels after midday, but trading turned extremely dull on the decline.

Auburn Auto shot up nearly 9 points, then reacted. Worthington shot up 8, but slipped off a little. Issues making extreme gains of 2 to 4 included Westinghouse Electric, Dupont, Loews, Grand Silver, Coca Cola; Corn Products; American Water Works; International Business Machines; Johns-Manville; Case; Byers; Lambert and Foster Wheeler. Bethlehem and the American Tobacco issues rose nearly 2, and such shares as U. S. Steel, General Electric, American Can, Radio, Radio Keith, Fox; General Theatres and Woolworth moved up a point or so. Sears Roebuck slipped off a point or so and the Southwestern Rails were under pressure. Store and Webster dropped 3 to a new low.

The Bethlehem Steel report appeared to have been somewhat better than expected or at least thoroughly discounted and traders who had gone short on the theory that only a few cents a share in the final quarter would be unsetting, hastened to cover. Sears Roebuck's 1930 net was less than half that of 1929, but the management expressed the opinion that price levels had about reached bottom, and profit margins in 1931 would be more satisfactory.

STOCK MARKET

New York, Jan. 30.—(AP)—Professional traders diverted themselves by pinching the bears in a handful of issues in today's stock market, while the financial community was primarily absorbed with annual earnings statements.

The share market maintained a strong tone, but trading was light and highly professional if a little more active than yesterday. The hearings in Washington regarding redemption of the veterans' certificates continued to inject an element of uncertainty into the security market outlook, and in the bond division the government obligations were again rather soggy. Share prices eased off from their best levels after midday, but trading turned extremely dull on the decline.

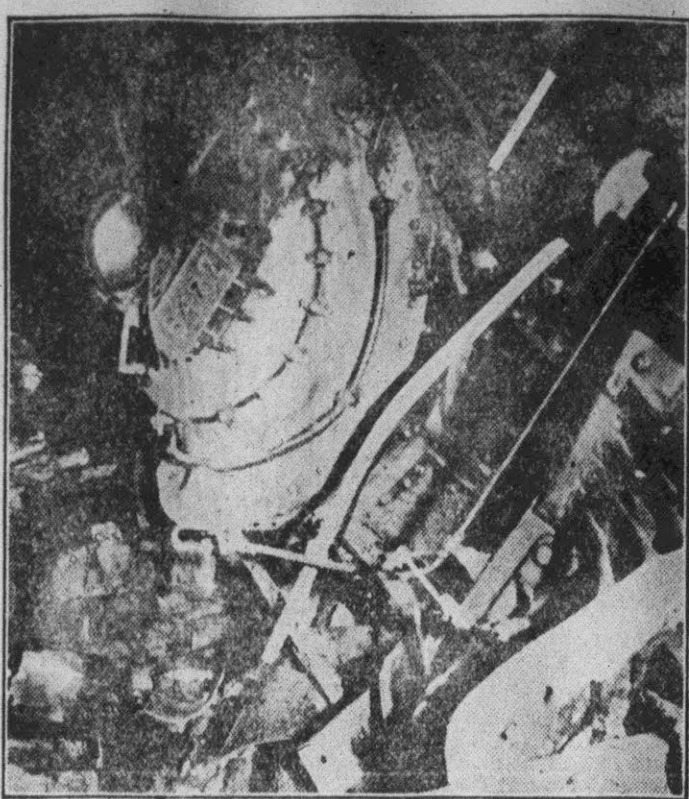
Auburn Auto shot up nearly 9 points, then reacted. Worthington shot up 8, but slipped off a little. Issues making extreme gains of 2 to 4 included Westinghouse Electric, Dupont, Loews, Grand Silver, Coca Cola; Corn Products; American Water Works; International Business Machines; Johns-Manville; Case; Byers; Lambert and Foster Wheeler. Bethlehem and the American Tobacco issues rose nearly 2, and such shares as U. S. Steel, General Electric, American Can, Radio, Radio Keith, Fox; General Theatres and Woolworth moved up a point or so. Sears Roebuck slipped off a point or so and the Southwestern Rails were under pressure. Store and Webster dropped 3 to a new low.

The Bethlehem Steel report appeared to have been somewhat better than expected or at least thoroughly discounted and traders who had gone short on the theory that only a few cents a share in the final quarter would be unsetting, hastened to cover. Sears Roebuck's 1930 net was less than half that of 1929, but the management expressed the opinion that price levels had about reached bottom, and profit margins in 1931 would be more satisfactory.

SENATE PASSES APPROPRIATION BILL

Washington, Jan. 30.—(AP)—The \$446,000,000 War Department appropriation bill was passed today by the Senate, carrying authorization for distribution of 20,000,000 bushels of Farm Board wheat for relief purposes.

consulted over his defense. The expectation that his counsel would be headed by John W. Davis, former Democratic Presidential nominee, was expressed by them later.

Washington, Jan. 30.—(AP)—Washington today wondered if Major General Smedley D. Butler's spectacular and dramatic career in the Marine Corps, capped by an official State Department apology to the Italian government, had been ended by resignation.

Rumors to this effect crept persistently into the capital's discussions of Butler's present difficulties, caused by a speech in which he made remarks considered derogatory of Premier Mussolini.

Meanwhile, the veteran campaigner, under technical arrest, was confined to the marine post at Quantico, awaiting a general court martial. Its date had not been set and until specific charges are filed, corps officials were reluctant to speculate on the possible penalty.

In Atlanta, S. Russell Bridges, southern manager of Lyceum Bureau, insisted Butler had signed a lecture contract effective February 1, and, preparatory to going on a tour had submitted his resignation.

Secretary Adams said no resignation had yet reached his office. Butler himself could not be reached, but his aide, Lieut. Lucian C. Whitaker, said he was certain no resignation had been submitted.

Butler's speech, by no means the first to bring him into conflict with his superior officers, was made in Philadelphia, January 19. He was quoted as saying Mussolini had run over a child with his automobile and driven on. He gave an unnamed friend as his authority.

The Italian embassy protested, the State Department asked the Navy Department for information and the latter asked Butler for an explanation. Yesterday, Secretary Stimson handed Ambassador D. Martino an official apology which was cabled at once to Rome.

Almost simultaneously, Secretary

Adams cited Butler for a general court martial.

What the official charge against Butler will be was the subject of much speculation. The regulations make no mention of remarks about officials of another government. Those familiar with military procedure were of the opinion he would be accused of "conduct unbecoming an officer and gentleman."

Rome Jan. 30.—(AP)—The annoyance of Premier Mussolini at remarks of Major General Smedley D. Butler describing him as a hit and run driver and of a war-like nature was said in official circles today to have been assuaged by an official apology from the American government.

The Duce was represented as considering now that General Butler's views were those of only one American general and not of the American people. His attitude has calmed somewhat a rising tide of popular indignation and appears to have closed what might have been an unpleasant incident.

"Full satisfaction to Italy," was the three column headline in La Tribuna today over New York and Washington dispatches relating the apology and arrest of General Butler.

two school measures, made them uniform and put teeth in his bill to see that the school would not be financed by an ad valorem tax.

In both houses, amendments were offered to remove this mandate, but all met their deaths. The Campbell amendment, voted down by the Senate last night, would have added to the unqualified phrase in the MacLean measure, "from sources other than ad valorem taxation on land," the working, "when adequate financial support can be provided without injustice to the taxpayers and a suitable administration standard has been adopted."

Proponents of the measure heralded its unannounced victory as a major step toward reduction of land taxes, committing the Legislature to relieve counties of millions of dollars in school taxes.

During the debate in both House and Senate, opponents claimed it "placed the whole burden of the schools on the wealthier counties of the state."
