SOLONS TURN ATTENTION TO VETS MEASURE

Republicans and Democrats Working Together On Relief Compromise

Washington, Feb. 7.—(AP)—Congress prepared today to carry out the compromise on the knotty relief problem as leaders turned their attention to a new measure threatening an extra session — veterans compensation funds.

The Republican-Democratic co-operation movement appeared to be in operation again, as a result of the agreement on the much disputed drought relief legislation. Leaders were working together to dispose of the vital appropriation bills which must be passed before the March 4 adjournment.

Conferees of the Senate and House were called to meet this afternoon to incorporate the compromise on relief into legislation. It provides for a \$20,000,000 additional drought loan fund in the place of the controversial \$25,000,000 Red Cross appropriation.

President Hoover and the House Republican leaders, who flatly rejected the Red Cross fund, have approved the \$20,000,000. It was advanced by Senator Robinson, the Democratic leader, and negotiated to an agreement by Senator Watson, the Republican leader, with Senator McNary, assistant Senate chief clerk.

Interest today swerved to the other dispute standing in the way of completion of business before adjournment — the legislation for money to veterans.

The Senate Finance committee agreed to defer action until next week, to give the House Ways and Means committee—which is claiming jurisdiction—an opportunity to act.

Meanwhile, Democratic Leader Garner said today the veterans compromise proposal held yesterday to be acceptable to the administration would mean advancement of about \$1,200,000,000, rather than \$500,000,000, in new loans to former soldiers.

The Texas Representative said that "as was proposed," the compromise bill provides loans up to fifty per cent of the value of veterans' compensation certificates. He said he believed it would involve raising only \$500,000,000 by new short term Treasury certificates, but the rest would be provided by converting a reserve fund of Treasury certificates now in keeping for redemption of the veterans certificates.

Representative Bacharach, Republican, New Jersey announced yesterday the compromise proposal was for allowance of as much as about 45 per cent of the maturity value of the certificates. He estimated it would cost as much as \$500,000,000.

ALDERMEN TO TALK 'BAMA' ON THURSDAY

Final Plans for Extension of City Limits to Be Considered At Special Session

Final plans looking to incorporation of the "Bama," negro district in the eastern section of the city, as a part of Greenville, have been deferred by the Board of Aldermen until a special meeting at the city hall next Thursday night when citizens interested in the taking over of the area will be allowed the privilege of expressing their opinion in the matter.

Members of the board met in special session yesterday afternoon and visited the section, but nothing definite in connection with fixing the boundary line was accomplished. A committee composed of Mayor J. C. Lanier and Aldermen T. T. Hollingsworth, J. H. Boyd and J. A. Collins was appointed to go over the district with an engineer, establish the boundary and report at the meeting of the board Thursday evening. The board decided Thursday night to extend the city limits to take in the "Bama" as a means to increase sources of taxation and at the same time to provide work for fifty or more unemployed laborers of the community.

If plans are finally perfected Thursday evening the city will appropriate approximately \$2,000 for improvement of the streets and lighting facilities of the "Bama" district, and in that way open up a source of employment which is needed most keenly by the unemployed element of the city at this time.

The decision to incorporate the "Bama" grew out of a proposal by Mayor Lanier that the city began an improvement program to provide work for the unemployed. When the aldermen began casting about for work that would prove of a profitable and permanent nature to the city, Alderman Boyd suggested the acquisition of the negro district, where several manufacturing plants are also located, as a means of increasing taxes and at the same time relieving the unemployment situation.

His suggestion received the hearty support of one of the property owners of the community who declared they would welcome the protection of the city in view of the need of the improvements and the breaking up of the criminal element which has infested the section for years, giving it the reputation as one of the roughest, toughest of the negro settlements.

As soon as the boundary lines have been established and public sentiment sounded out at the meeting Thursday night the Legislature will be asked for permission to extend the city limits to take in the new area, which is one of the most populous negro districts of the community.

The board yesterday afternoon also acted favorably on a petition from the congregation of St. Paul's Episcopal church, asking the release of taxes on the church property on Fourth street.

Bishop Cannon Produces Much Evidence To Refute The Charges Against Him

Dr. Costen J. Harrell, of Richmond, Not Present As Investigation Gets Under Way; Committee Is Tired and Wants to Go Home

Washington, Feb. 7.—(AP)—The twelve elders hearing charges against Bishop James Cannon, Jr., of the Methodist Episcopal Church, South, today continued to receive the bishop's defense. Reports coming from within the hearing indicated the investigation will last into next week.

Besides answering each of the 48 charges against him, Cannon has introduced much documentary evidence, some designed to refute charges and some in the form of assurances of his good character.

One of the men who brought the charges, Dr. Costen J. Harrell, of Richmond, was not present when the investigation began today. Why he could not be heard.

Cannon appeared on crutches but walking with more vigor than he has shown during any of the previous four days of the hearing. He was accompanied by Dr. J. Sidney Peters of Richmond, and his son, James Cannon, 3rd.

Members of the committee hearing the accusations frankly admitted they were "tired and wanted to go home." Members of the bishop's family said his physical condition apparently was improving in spite of the 15-hour sessions held each day.

As the sessions today opened Bishop Cannon expected to complete his defense before noon. The committee will immediately begin balloting on the charges, which are grouped under six heads. If eight of the 12 ministers on committee find that any one of the six has weight, the bishop will be held for trial before the general conference of the church in 1934 and suspended from duty until that time.

In view of the gravity of the charges, Bishop W. N. Ainsworth of Birmingham, Ala., who is presiding, ruled Cannon could cross-examine witnesses and present his defense against each of the 48 specific indictments contained in the six major groups.

Reports today from within the Mount Vernon Place church, where the hearings are being held, were to the effect that Cannon had presented his answers to five of the six groups. The sixth group contains charges of stock gambling, similar to those the bishop beat at the Dallas general conference of the church last summer.

Says Democrats Will Let It Be Known How They Stand on "Dry"

Miami, Fla., Feb. 7.—(AP)—Jouett Shouse, chairman of the National Democratic Executive Committee, told a gathering of party leaders here last night that states whose delegates will represent a majority in the next national convention "have already declared for some change in existing conditions and if that means going wet then I say to you that the Democratic party already has gone wet."

Mr. Shouse said the Democratic party must face squarely and honestly the prohibition question. He would not predict what position the party will take on the prohibition question. "But whether its position be for repeal, for modification or for continuing in status quo," he said, "I hope the Democratic party will have the courage to let the American people know where it stands and I don't think there is any doubt that it will."

The Democratic party will guarantee legislation dealing with unemployment at the next session of Congress unless such measures are adopted at the present short session, he said.

Mr. Shouse predicted that the five-day week for workers would be adopted in America, saying it was his view that the government should set the example by establishing a five-day week for its own employees.

State College Wins Debate

Raleigh, Feb. 7.—(AP)—Debate between women of Farmville State Teachers College, Farmville, Va., lost their first decision in two years here last night when debating men of N. C. State College won an argument on the policy of free trade by a two to one vote. Miss Elizabeth Johnson of Portsmouth, Va., and Miss Mabel Barksdale of Stuart, Va., represented Farmville and had a record of ten straight winning debates but Mr. Dwight Stokes of Denton and W. B. Amos of High Point argued the negative opposing adoption of a free trade policy and won.

W. M. HINTON DIES AT HOME OF DAUGHTER

Former Well-Known Educator Will Be Buried At Elizabeth City Sunday

Mr. William M. Hinton, aged 76, died early today at the home of his daughter, Mrs. J. B. Kittrell on East Fifth street.

He was the son of John Mott Hinton and Catherine Mildred Riddick, and was born on August 20, 1854, at the old Hinton home in the Newland section of Pasquotank county, North Carolina. He married Miss Frances L. Williams of Newland; and five children born to this union, together with one sister, survive him. The surviving sister is Mrs. B. F. Spence of Elizabeth City, who recently celebrated her 80th birthday. The children are Mrs. C. C. Parker, Elizabeth City; Mrs. J. G. Fearing, Sr., Elizabeth City; Mrs. William G. Adams, Four Oaks, and Mrs. J. B. Kittrell, of Greenville.

Mr. Hinton was engaged in educational work the greater part of his life, teaching in the public schools of Elizabeth City, Littleton, and Belhaven for a number of years. For two years he was superintendent of public instruction of Camden county, and for 25 years was superintendent of public schools of Elizabeth City and Pasquotank county.

He organized and operated the first public school for Elizabeth City. In addition to his work as a teacher and superintendent of schools he was also a writer of ability, being at one time editor of the "Littleton Herald" of Warren county. Throughout his life he contributed numerous articles to newspapers and magazines.

The cause of prohibition was dear to his heart and early in life he began to wage an effective campaign in behalf of the cause of temperance. In 1904 he was elected as a Representative of the General Assembly from Pasquotank county on a prohibition platform. For a number of years he was state lecturer for the Anti-Saloon league.

He was a life long member of the Methodist church, serving that church in various capacities of Sunday school superintendent, teacher, steward, and lay leader. The study of the Bible held a great fascination for him, and it was generally acknowledged by those who knew him that his knowledge of the book was unusual.

The funeral will be held tomorrow afternoon at 1:30 o'clock in the home of Mrs. J. B. Kittrell, Rev. E. L. Hillman, pastor of Jarvis Memorial Methodist church will conduct the services, assisted by Rev. A. W. Fleischmann of Memorial Baptist church. Following the services in Greenville the remains will be taken to Elizabeth City and interment will take place in the Hollywood cemetery. The services in Elizabeth City will be conducted by Rev. Mr. Hillman and Rev. G. W. Perry, pastor of the First Methodist church of Elizabeth City.

LEAF MARKET CLOSES FOR SEASON HERE

Records Show Increase Over Twenty Million Pounds Above Last Season

The Greenville tobacco market closed yesterday with a gain of twenty million pounds over the previous season, records of K. W. Cobb, supervisor of sales, indicated this morning.

For the entire season the market disposed of 70,457,500 pounds for a total sum of \$9,740,426.95. The general price average was given as \$13.83 per hundred pounds.

The report, the supervisor stated, does not include over two million pounds of leaves and scrap tobacco sold direct to the factory during the season. Mr. Cobb stated that they had already begun the advertising campaign for the 1931 season and this will result in the possibilities of the Greenville market being known in every section of the bright leaf producing area.

The Greenville market will open next season with five sets of buyers, it was stated.

GANDHI SAYS SETTLEMENT IS HOPELESS

Nationalist Leader Declares MacDonald's Declarations Unacceptable

Allahabad, India, Feb. 7.—(AP)—Prospects for settlement of the Indian question on a basis of Ramsay MacDonald's declarations at the round table conference are hopeless. Mahatma Gandhi told the Associated Press in an interview today.

"There is no hope of settlement," he said, "unless Sir Tej Mahadur Sapru has brought back more from the London conference than I have been able to find in the Prime Minister's declaration."

The weakened little man who is almost a god to millions of people made his announcement on the eve of a meeting with the Indian delegates to the round table conference.

"I hope," he said, "Sapru will be able to convince me. Future events alone will show whether the civil disobedience campaign must be stiffened."

"My talks with Gandhi," Sapru told the correspondent, will be on the basis of this broad question: 'Do you want Indians to assume control of India or do you want India to revert to British control?'

If Gandhi declines MacDonald's offer, he said, India will lose the greatest chance she may ever have to be free, for a successor to the Labor government is not likely to have such a generous attitude as MacDonald's.

He intends to do all he can to persuade Gandhi to accept the MacDonald offer, but he said he was skeptical of his chances for success.

Court Sustains Right of State to Condemn Land

Nashville, Tenn., Feb. 7.—(AP)—The right of the state to condemn land that the federal government will include in the Great Smoky Mountain National Park was upheld by the Tennessee Supreme Court today.

The decision was rendered in an appeal by the state from an unfavorable decision in Blount county.

John W. Oliver, a farmer and mail carrier, owns 300 acres of land in Cade's Cove, one of the beauty spots of the park. After negotiations for the purchase of Oliver's land failed, condemnation proceedings were instituted in Blount Circuit Court by the Tennessee Great Smoky Mountain Park Commission. Judge Pat Quinn held the state act, creating the park commission was unconstitutional in that the sale could not condemn lands to be turned over to the federal government for a park.

In an opinion written by Chief Justice Grafton Green, the Supreme Court held that although the land was to be conveyed to the government, the public use was common to the state and to the government. Other constitutional objections to the park statute were overruled, and the lower court's decision was reversed and the case remanded.

Counsel for Oliver had argued the taking of his land and that of others would reduce Blount county below the constitutional limit of 500 square miles.

Anti-Lynching Body Organized In This State

Greensboro, Feb. 7.—(AP)—To the end that lynching may be eradicated, the North Carolina Association for the prevention of Lynching today set about completing its organization.

The association was launched here yesterday at a meeting of a group of 15 women in the Y. W. C. A. Miss Clara I. Cox, of High Point, was elected chairman, and Mrs. H. S. Weinberg, of Greensboro, secretary.

Completion of the organization of an administrative committee of 12 was left in the hands of a special committee composed of Miss Harriet Elliott and Mrs. W. A. Newell, of Greensboro, and Miss Gertrude Weil, of Greensboro.

"For nine years our state was free from lynchings," said a resolution adopted at the organization meeting. "We bow in shame that her clean record has again been sullied by the crime. We therefore respond to the call of other southern states and pledge ourselves to co-operate with them and to educate public opinion creating agencies to the end that lynching may be eradicated."

MORE LEGAL TALENT FOR GEN. BUTLER

Three Widely Known Lawyers to Defend Marine Commander At Court Martial

Philadelphia, Feb. 7.—(AP)—The legal staff that will represent Maj. General Smedley D. Butler, U. S. Marine Corps, at his court martial here February 16, has been augmented by three widely known lawyers.

Major Henry Leonard, chief of defense counsel, has announced that they will be: Roland S. Morris, former ambassador to Japan; Colonel A. M. Holding, Westchester, Pa., and Lieutenant Colonel Jesse F. Dyer, U. S. M. C., stationed at the war college at Newport, R. I.

Mr. Morris is a member of a legal firm in this city and a former member of a legal firm in this city and a former president of the Contemporary Club, and Colonel Holding is a former President of the Pennsylvania Bar Association and a leader of the bar in Chester county, the home of Butler.

General Butler's court martial was ordered because of an address he made before the Contemporary Club last month, in which he said Mussolini driving an automobile killed a child.

Efforts to obtain official confirmation that General Pershing and other high officials may be called as character witnesses for General Butler were unsuccessful. Asked about the report Major Leonard said:

"Those matters have to develop in our conferences. I cannot state definitely now what sort of questions will be addressed to any witness in case they are called to testify."

It was understood that several members of the contemporary club who heard General Butler's talk will be asked to testify.

People Flee From Forest Fires In McDowell County

Marion, N. C., Feb. 7.—(AP)—With highways almost impassable in stops and dense fog and smoke hanging on the mountainsides, folk in two sections of McDowell county today were fleeing before forest fires which ere devastating a wide area.

The flames, roaring through gorges and up mountainsides and feeding on drought-dried pine, last night destroyed several homes which had escaped from previous fires in the past two weeks.

Volunteers were fighting the two blazes, one located north and the other south of Marion, but were making little headway, reports reaching here said.

Marion, lying in fairly open and lightly wooded country, is considered out of the forest fire danger zone.

Two Contradictory Road Bills and Beginning of An Attack On the "Brummitt Plan" for Raising Revenue Will Receive Attention of the State Lawmakers Over the Week-end; Senate Passes Three Measures and House Eight

Raleigh, Feb. 7.—(AP)—The General Assembly held its customary brief Saturday sessions today and transacted little business but over the week-end the legislators will have in store for thought and study the contradictory road bills and the saring of an attack on the Brummitt plan for raising revenue by the R. J. Reynolds Tobacco Co.

The Senate today passed three local measures and the House eight. Both bodies will meet at 8 o'clock Monday night. The Senate got a public and a local measure for its hopper and the House got five new bills.

Mrs. McKee of Jackson, introduced a Senate bill to place women on the same basis as men if charged with willful abandonment of children under 16 years of age by making them guilty of a misdemeanor.

Featuring the week's work of the Assembly were the many committee meetings; the introduction of a bill embodying the highway reorganization proposals of Governor Gardner and of another highway measure bearing a minority report contradictory to the administration bill; approval by the House and Senate committee of the barbed wire bill; passage of the Pitts bill outlawing illegal slot machines, and punchboards; exemption of Buncombe county from the absentee ballot law; introduction of three divorce bills, two to make easier securing of divorce and the other tightening the present law; and introduction of the administration bill calling for a reorganized state banking department.

Both of the highway bills given the House yesterday by Chairman Connor of the roads committee, call for an increased gasoline tax but the majority measure, embodying the Governor's recommendations, calls for abolishment of the present Highway Commission, state maintenance of county roads, a state commission organized irrespective of district lines, and the of prisoners in highway work.

The minority bill changes the present system only to the extent that with the consent of the counties road districts may be established by two or more counties for the purpose of road maintenance. No change in the present commission organization or method of money allotment would be made.

The "Brummitt plan" which proposes that the state base its franchise tax on the market value of the corporate stock rather than on the capital and surplus, would be a radical departure and is fraught with many dangers, including possible litigation to establish what would be the true market value of stocks, Clay Williams, representing the Reynolds company, told the finance committee yesterday.

House—HB 267—Braddy of Bladen, to make Robeson county tax law no longer apply to Bladen county.

HB 277—Cherry of Gaston, relating to collection of Beasemur City street assessments.

HB 170—Willis of Craven, forbidding borrowing of additional funds for highway construction in Craven.

SB 72—Lindsey of Brunswick, to create Brunswick tax collector.

HB 335—Lumpkin of Franklin, to elect Franklin county commissioners by districts.

HB 330—McDevitt of Madison, to amend law relating to Madison county auditor's report.

HB 311—Jenkins of Pasquotank, to relieve Elizabeth City residents of Senate assessments.

HB 290—Norman of Washington, to empower sheriffs of Washington and Hyde counties to sell lands in Washington county drainage district four for delinquent assessments.

The city aldermen killed two birds at one fling the other night by adopting plans to take over the "Bama" as a part of the City of Greenville.

Including this section in the corporate limits will open up a new source of taxation and at the same time enable Mayor J. C. Lanier to put into effect his plan to provide employment for scores of jobless men of the community.

When incorporation has been completed, the aldermen plan to spend approximately \$2,000 in improvement of the district. This will give the residents of the area every protection afforded by various city departments and enable them to sleep at night with a feeling of safety they have been unable to enjoy in past years because of the criminal element infesting the territory.

The aldermen will open up the streets, improve the lighting system and give the area virtually every convenience enjoyed by other outlying districts.

The city in years to come should realize good returns on the investment through increased taxes which the residents will pay into the treasury from year to year.

There is an ordinance in Greenville prohibiting the mutilation of trees and the aldermen from now on intend to see that it is fully enforced.

Reports have reached the city fathers that some of the finest trees in the city have been ruthlessly destroyed by telephone and power concerns when they could have been preserved through a little consideration on the part of employees.

There is a campaign under way in Greenville to plant more trees and preserve those already in existence, and everybody has been asked to cooperate and help make the movement a success.

There is nothing that adds more to the natural beauty of a community than shade trees, and since so many have been destroyed here in past years because of construction work, it is the idea of the Tree Planting Association to encourage more consideration of the matter.

If you have not given the tree planting campaign the attention you should, why not do so and do your part by the project looking to the beautification of the community.

The Board of Aldermen have agreed to plant trees and erect a fence along the sidewalk in front of the old library site on Fifth street in front of the high school building, and when this has been completed the Woman's club will plant running rose vines along the fence so that the view of the ravine will be completely out of range of vision of people passing along the street.

This is an improvement that will add much to one of the most beautiful sections of the city, and the aldermen are to be congratulated upon their desire to co-operate with members of the Woman's club and the Tree Planting Association in their plan to beautify the city.

The public generally should consider this improvement and then use their influence in the beautification of their own districts.

"Drive carefully" is the warning sent out to all sections of the country as safety service departments in the various states attempt to reduce the awful toll of life resulting from automobile accidents every day of the year.

How many people will take advantage of the admonition is impossible to say, but it is certain there are thousands who will continue to drive recklessly, jeopardizing their own lives and the lives of thousands of other people on the highways.

The highways are not only filled with uncounted numbers of automobiles, but thousands of people on foot. It is impossible to tell what time some of these pedestrians are going to step into the path of a speeding car and be dashed into oblivion.

This business of people walking along the highways makes it doubly important for the driver to be

eternally on the lookout for them and to employ every caution against accident.
It matters not where you may be going, don't go too swiftly when you do not have an open road before you. Accidents will happen even when the roads are clear, and they become even more unavoidable when traffic is heavy. Drive slowly and save yourself from injury and possible prosecution on a criminal charge in connection with the death of somebody else.

Salaries based on tobacco when it sold for 50 cents per pound and cotton 30 cents, cannot be paid when tobacco sells for 12-15 cents per pound and cotton 9 cents.

Yes, as some one has said, "the joy ride is over." It is all right to hope for better prices for cotton and tobacco and for better times, but it is mighty poor business to make debts based on hope to pay them. It is much safer to let reason be our guide. And reason tells us to adjust ourselves to present conditions. This means that rigid economy is no longer a choice; but an absolute necessity. The present depression is world wide and is the severest of any we have ever known. It is no more like any of the others that we have had in the last fifty years than is the fever that follows an ordinary chill like the fever in a severe case of typhoid. Optimism is fine in reason, but the kind that would cause an engineer to run his train by a red flag is foolish. Yes, "the joy ride is over." Let us reduce our expenses public and private and live within our income—"this is the only way out."

Persia to Yield Glories of Xerxes' Palace, Is Thought

Chicago.—(AP)—The glories of ancient Persia, immortalized in history by the Emperor Darius and his son, Xerxes, are to be revealed in a scientific light by a party of archaeologists from the University of Chicago.

After years of negotiations with the Persian government, the Oriental institute of the university has removed all objections to excavations on the site of Persepolis, where Darius built a magnificent capital five centuries before Christ.

The Persian expedition is the first archaeological endeavor under the new antiquities law of that country. It will be the eleventh party of excavators sent into the Near East by the university. The other 10 are in Egypt, Palestine, the Hittite country of Asia Minor and Irak.

James H. Breasted, director of the Oriental institute, is commander-in-chief of the expeditions. The Persepolis archaeologists will be at work this summer. The site of the city, marked by walls and columns rising above the plains is inland from the Persian gulf, near Shiraz.

The institute this summer also will begin excavations of four ancient Babylonian cities near Baghdad, along the old caravan route between Babylonia and Persia. This expedition will be directed from the new archaeological headquarters at Tell Asma.

Professor Breasted believes the "cradle of civilization" will be found in Asia Minor in a circle of 2,000 mile diameter, bounded by the eastern end of the Mediterranean sea, the northern end of the Persian gulf and the Red sea and the Caucasus mountains.

Persepolis, built by Darius in the fifth century before Christ, was noted chiefly for its "Palace of the King of Kings," built by Xerxes. Xerxes was murdered in one of his palaces in 465 B. C. and in 331 B. C. Alexander the Great burned Persepolis in retaliation for Xerxes' destruction of Athens a century before.

Xerxes is linked with the epochal Greek defense at the Thermopylae pass where Leonidas and 1,400 Thebians, Thebians and Spartans died holding back the Persians. It was on that expedition that Xerxes burned Athens.

The Oriental institute hopes to remove the debris of centuries from the palaces, which time has not entirely buried. But more important, said Dr. Breasted, will be the unearthing of sculptures and other works of art. Archaeologists have found many specimens of ancient Persian art, but none from the dim past that Darius and Xerxes glorified.

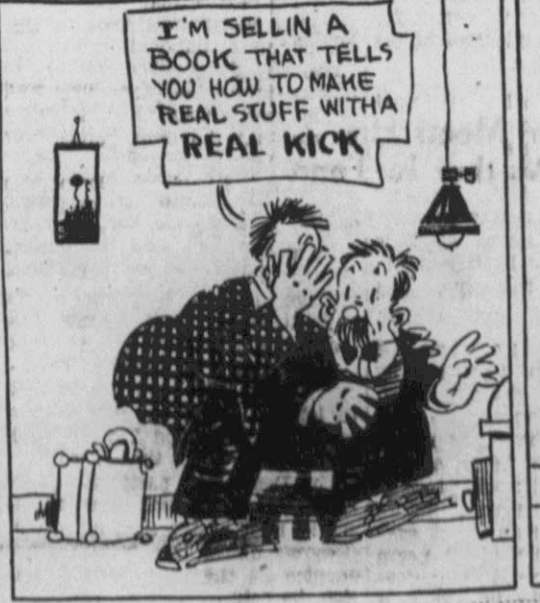
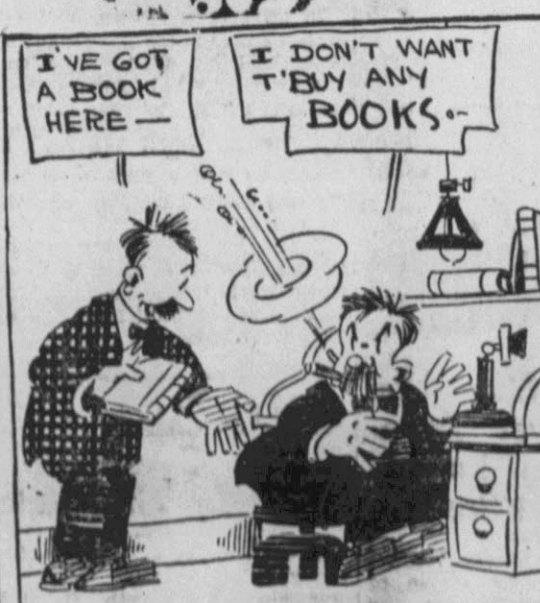

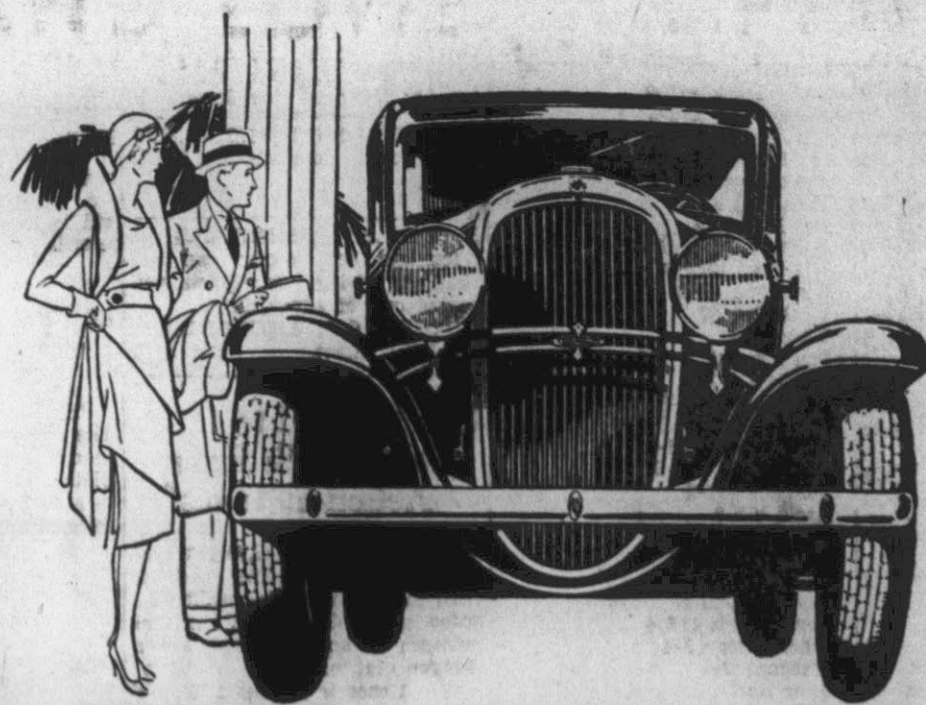

COTTON MARKET

New York, Feb. 7.—(AP)—Cotton opened steady today at an advance of 3 to 5 points on overnight buying orders which included some commission house demand and further covering as well as buying for trade account.

March sold up to 10.70 and October to 11.49 but the market met considerable week-end realigning and some southern selling at these prices. This supplied the initial demand and prices later sagged off 6 to 8 points with the active months ruling about 1 to 3 points lower at the end of the first half hour.

Liverpool cables reported that hedging had been absorbed by rein buying covering and trade selling in that market and reported moderate sales of cotton lots to South America and Africa. The amount of cotton on shipboard waiting clearance at end of the week was estimated at 71,000 bales against 129,000 last year.

Fertilizer tag sales in southern states for January were 72 percent of last year and 76.1 percent of January sales two years ago, according to reports published here this morning.

Atlanta, Feb. 7.—(AP)—The boxing Calavers of Virginia, who with a four day period trounced both the 1930 Southern Conference champions and runnersup, tonight face what appears to be their most formidable opponent of the season. At Chapel Hill, the Virginia biffers battle the veteran pugilists wearing the colors of the University of North Carolina.

Virginia and Carolina divided the conference boxing titles for several years until Florida crashed the victory gates last year.

Starting with Virginia Military, which was but a step behind Florida in the titular tourney last February, the Cavaliers punched their way to a decisive 6 to 1 decision and three nights later bowled over the defending champions by a 5 to 2 count.

The Tar Heels, who finished fourth in the Dixie meet in 1930, also have gone unbeaten this year and stand as a real threat to again capture the loop title they lost to Florida. The Chapel Hill glove-swingers have hung up three conference victories.

Coach Rowe's Carolina ring men beat South Carolina 5 to 2 and Virginia Polytechnic and Virginia Military by the same verdict, 6 to 1. The only comparison between the teams is afforded by the 6 to 1 manner in which both disposed of the V. M. I. Cadets.

Six members of the Carolina squad are personally unbeaten for their three matches thus far, but Virginia's punchers also have impressive records and a closely fought series of matches are anticipated.

New York, Feb. 7.—(AP)—Thanks to the same deadly left hand that made him king of all the light weights, Tommy Loughran, Philadelphia dancing master, had stepped back into the heavyweight picture today.

The biggest crowd of the indoor season—12,000 persons—saw the Philadelphia jab his way to a ridiculously easy ten round decision over Max Baer, willing but clumsy California youngster, in Madison Square Garden last night.
